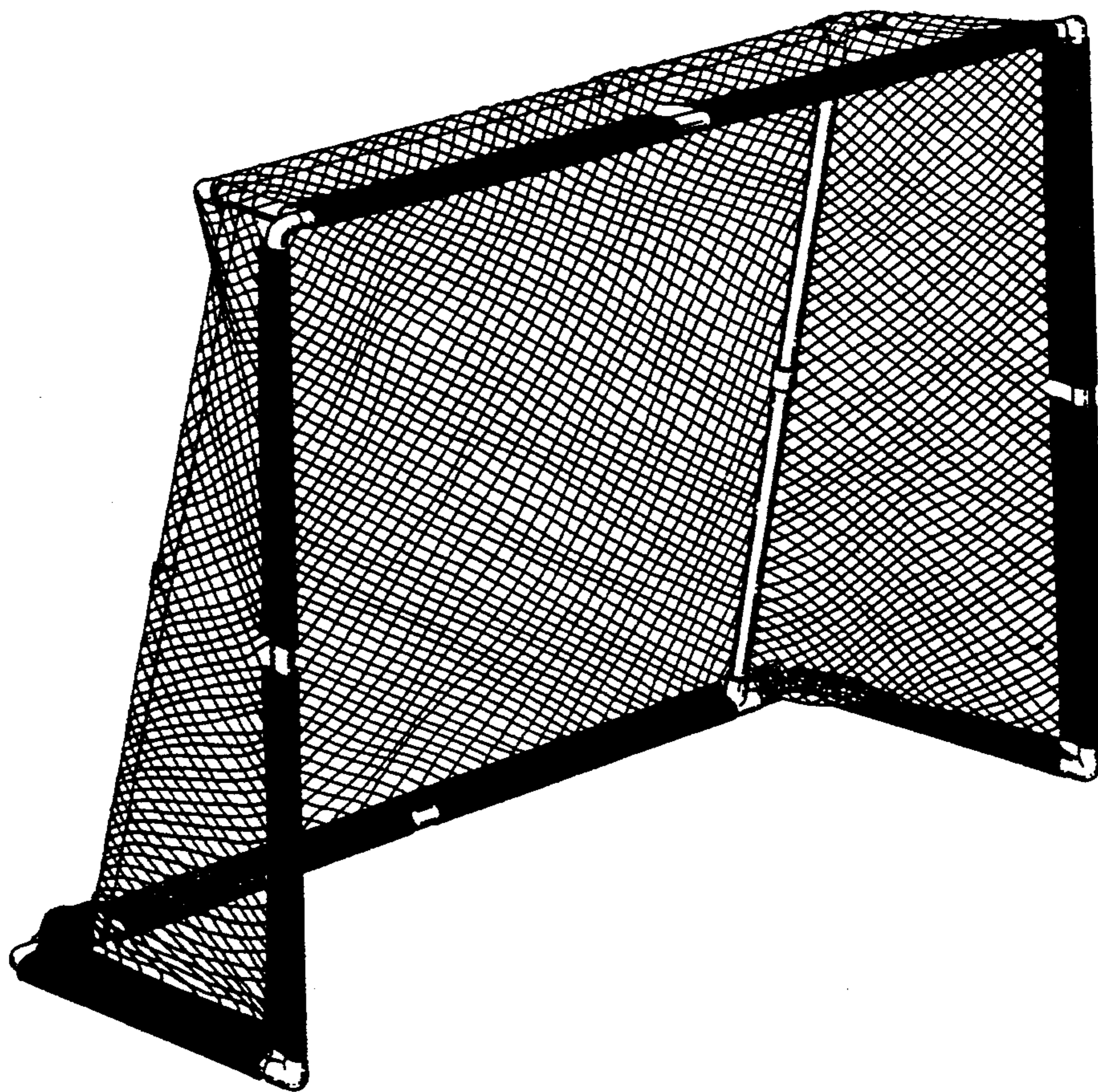

FIG. 6 is a rear elevation.





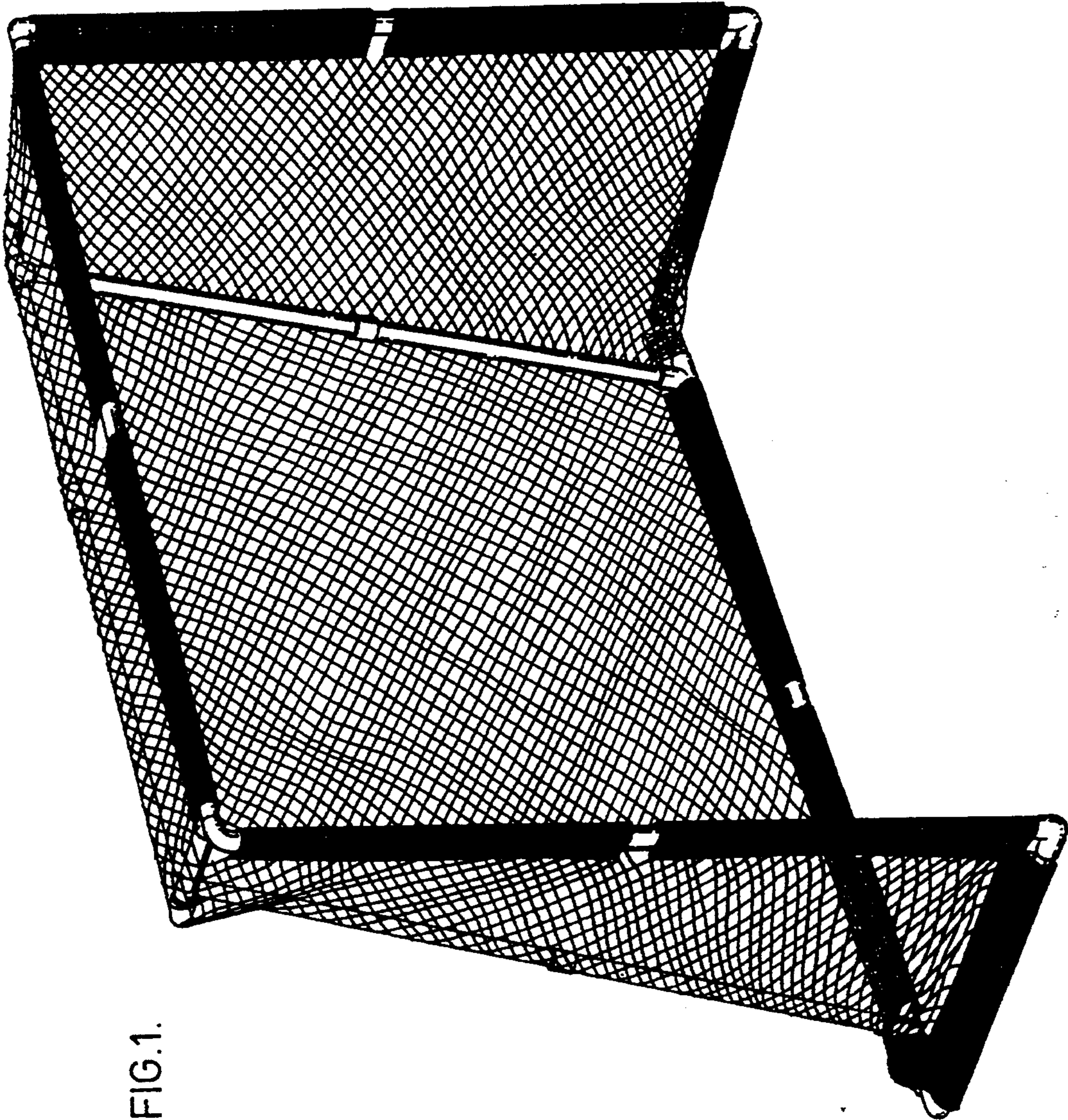

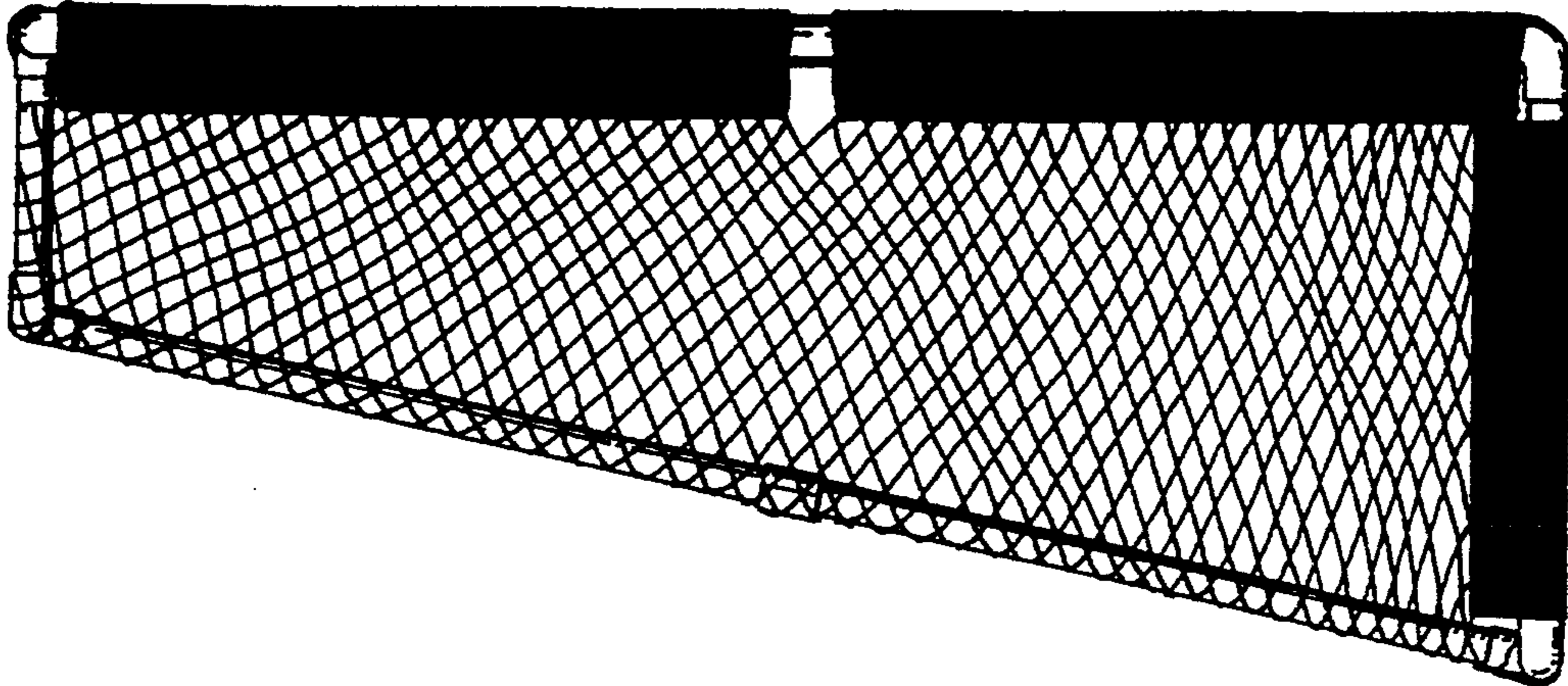

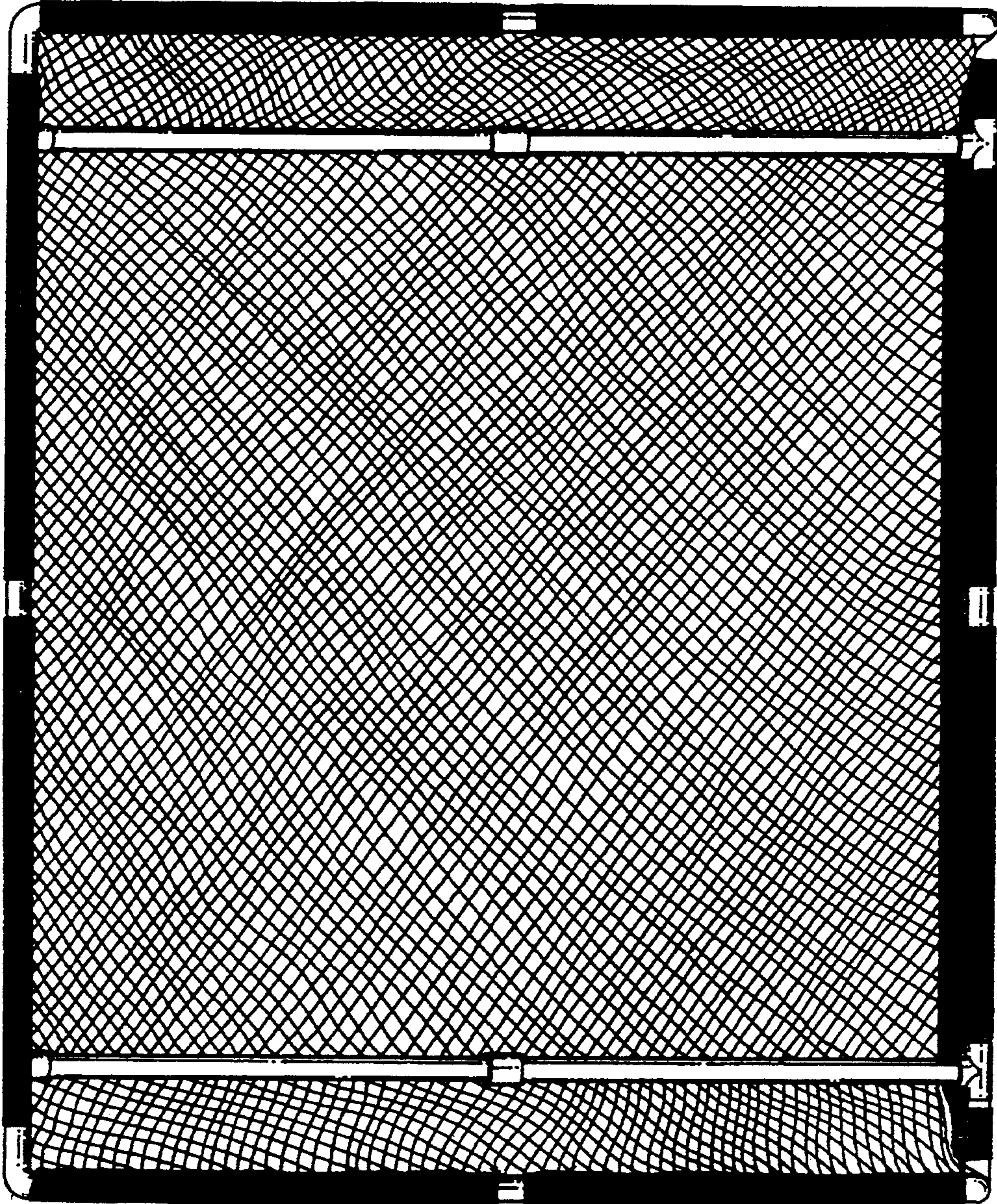

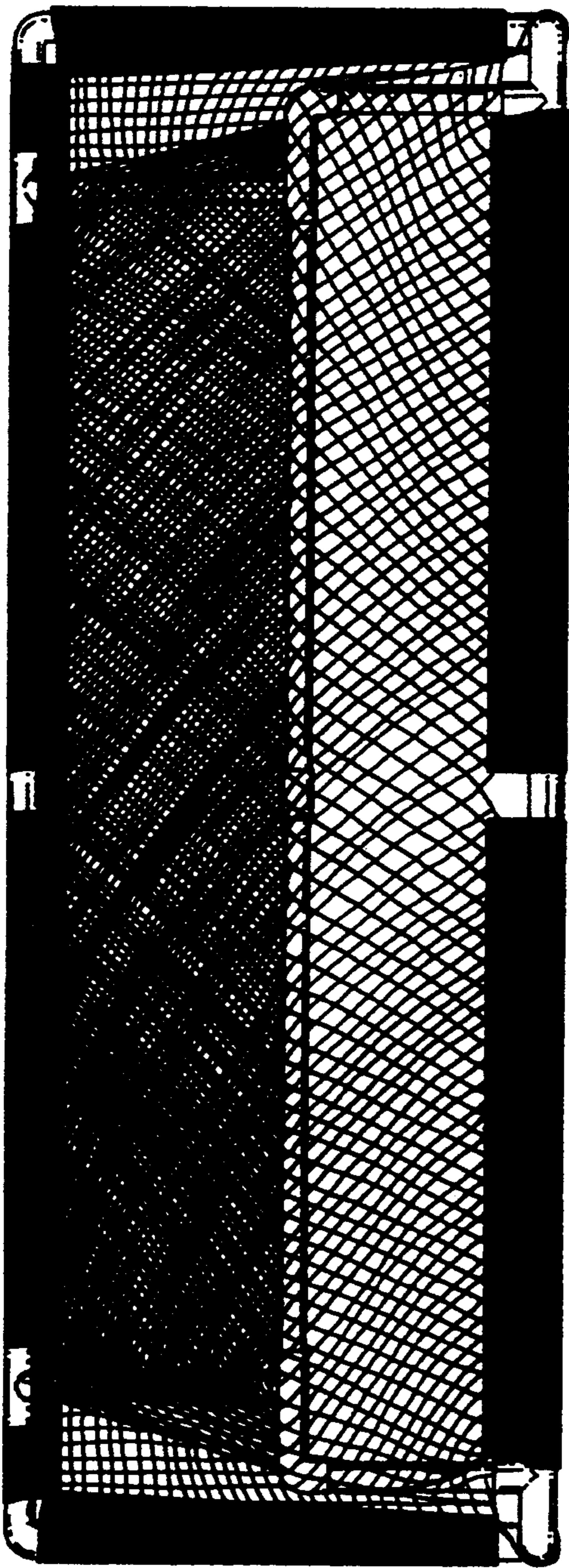
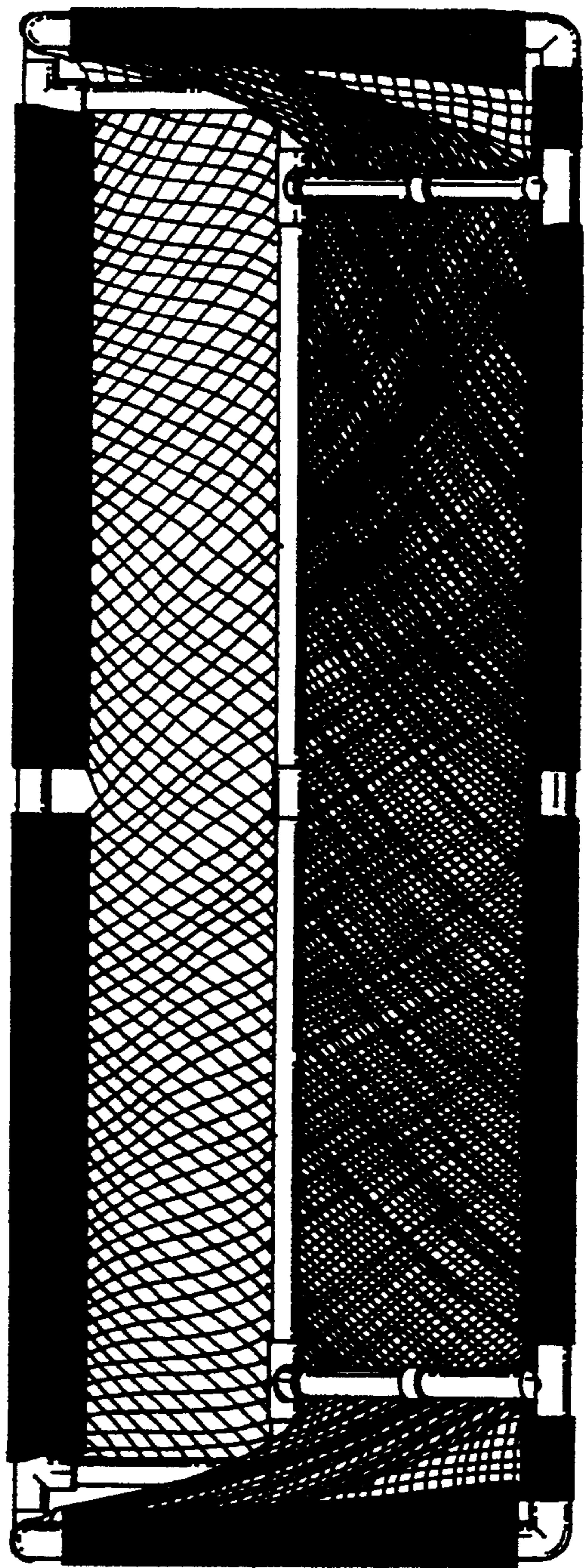

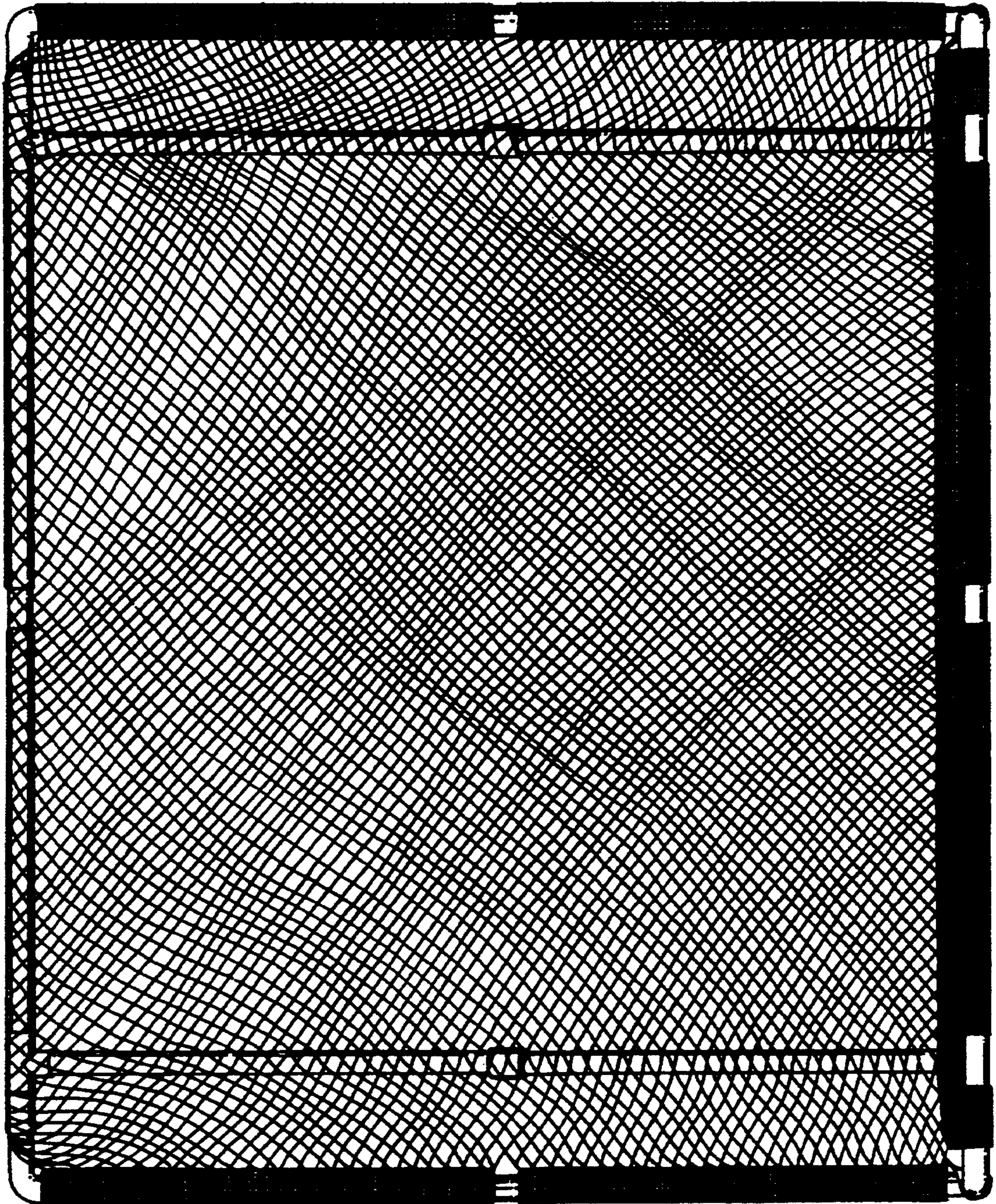
