[57] **CLAIM**

The ornamental design for a golf practice mat, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective of a playing mat of our new golf practice mat;
- FIG. 2 is a plan view thereof;
- FIG. 3 is a right side view thereof, the left side view being a mirror image;
- FIG. 4 is a front elevation thereof;
- FIG. 5 is a rear elevation thereof;
- FIG. 6 is the bottom plan on a reduced scale thereof;
- FIG. 7 is an exploded view of two elements making up the new design;
- FIG. 8 is a perspective of an alternate embodiment thereof;
- FIG. 9 is a top plan view of the embodiment of FIG. 8;
- FIG. 10 is a right side elevation thereof; the left side elevation being a mirror image thereof;
- FIG. 11 is a bottom plan thereof;
- FIG. 12 is a front elevation thereof;
- FIG. 13 is a rear elevation on a reduced scale thereof; and,
- FIG. 14 is an exploded perspective thereof.

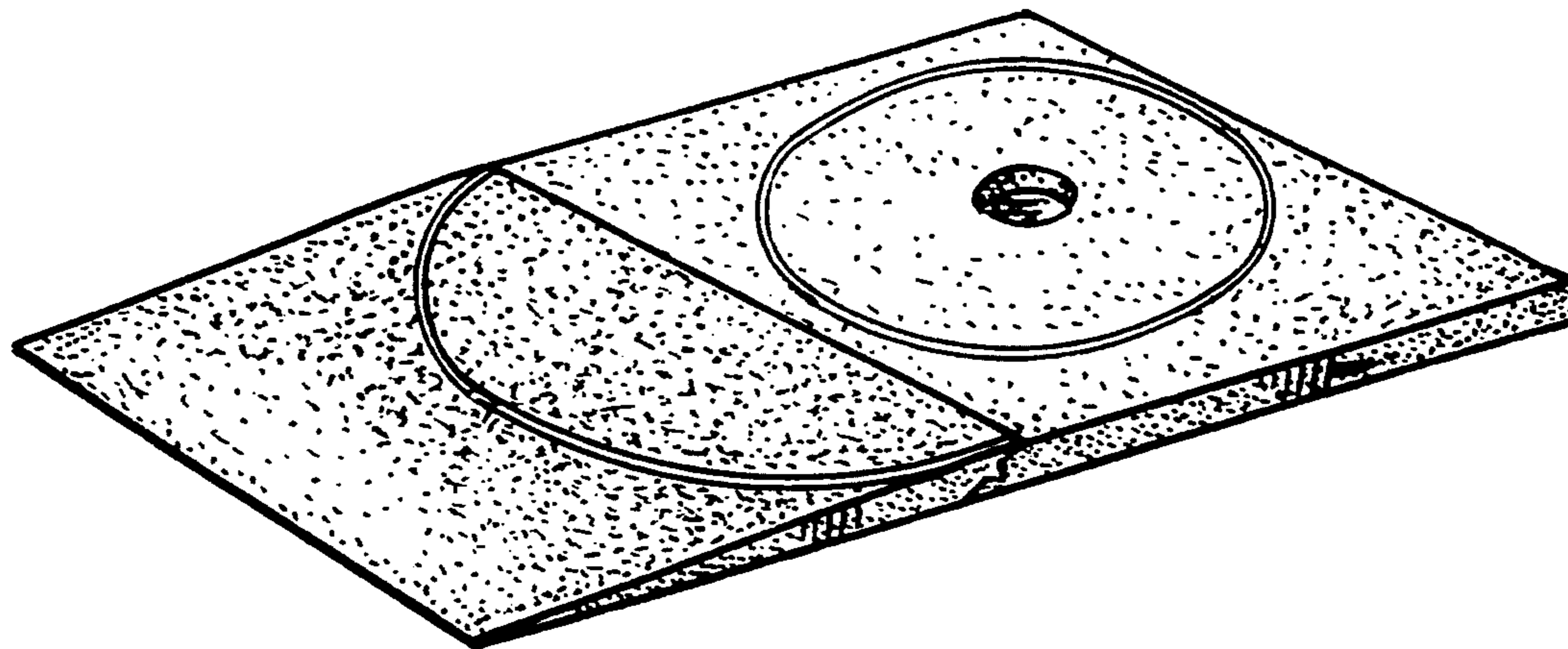

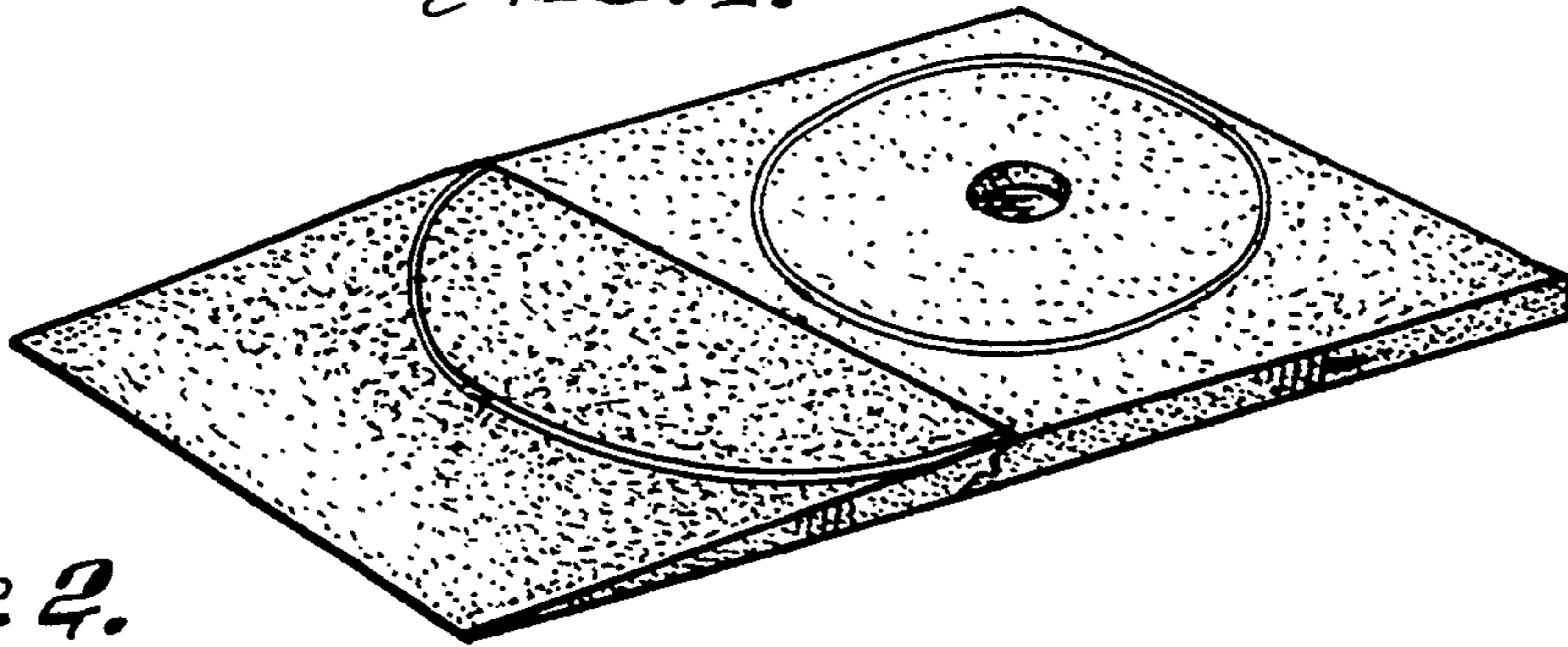

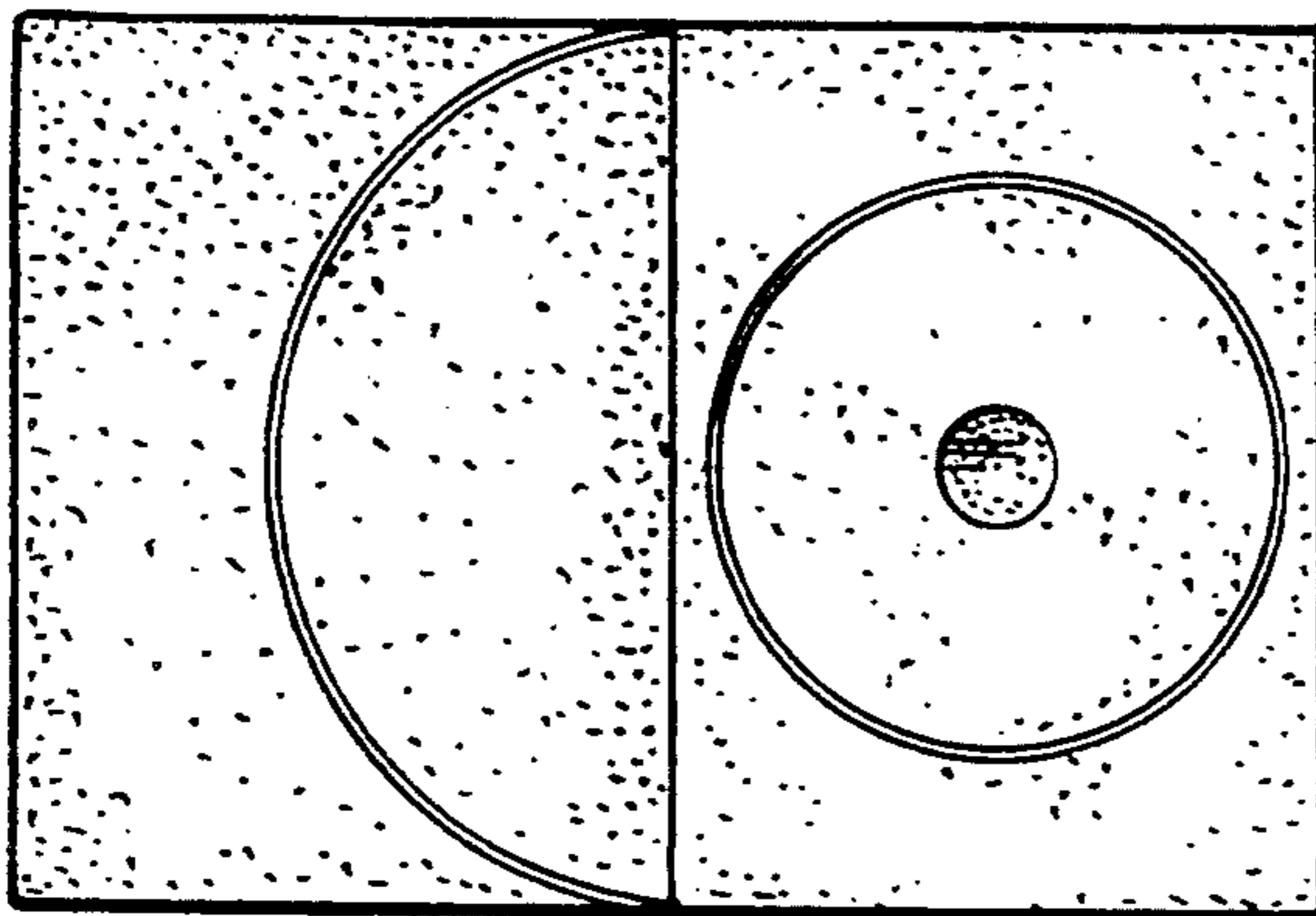

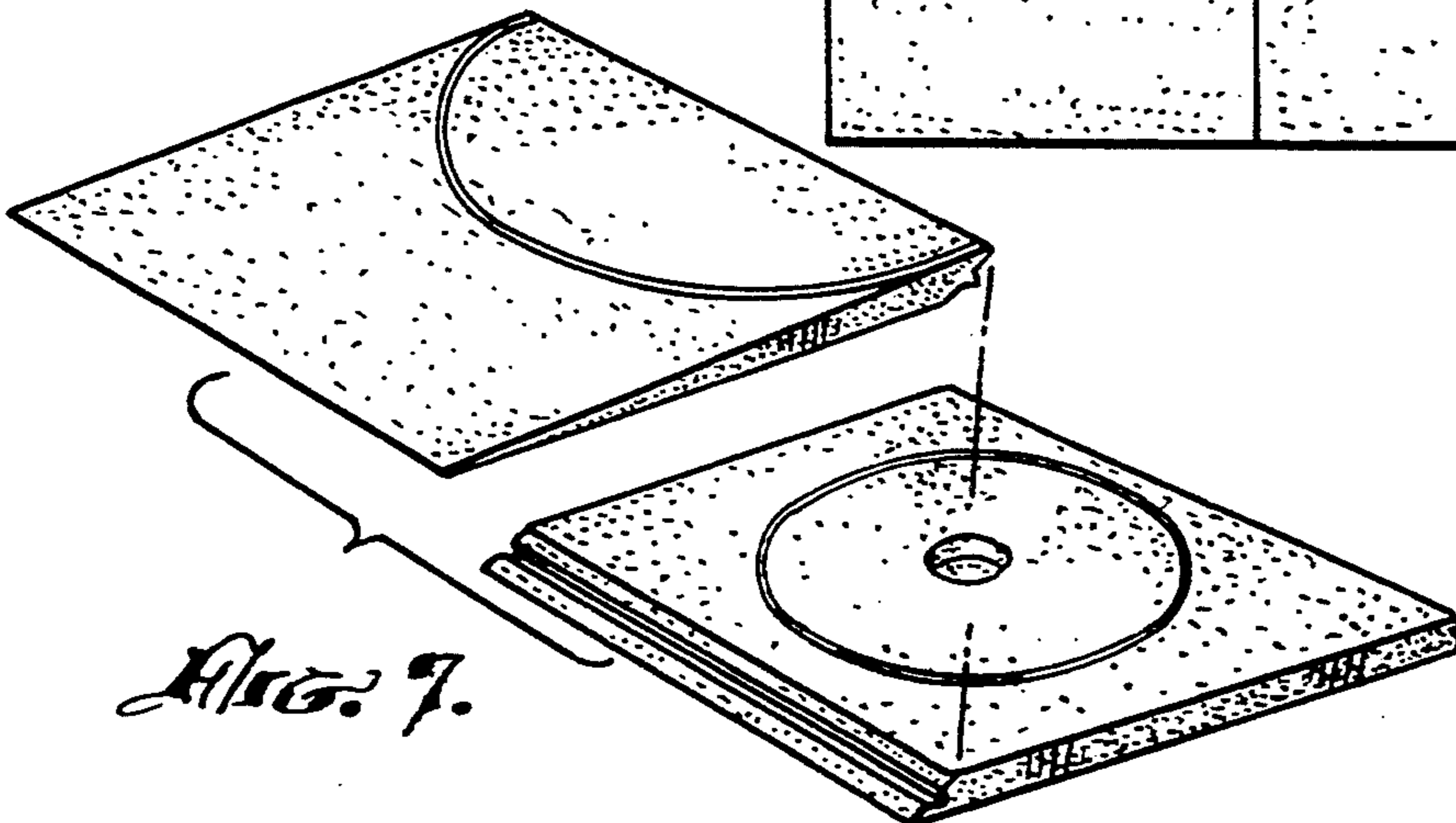
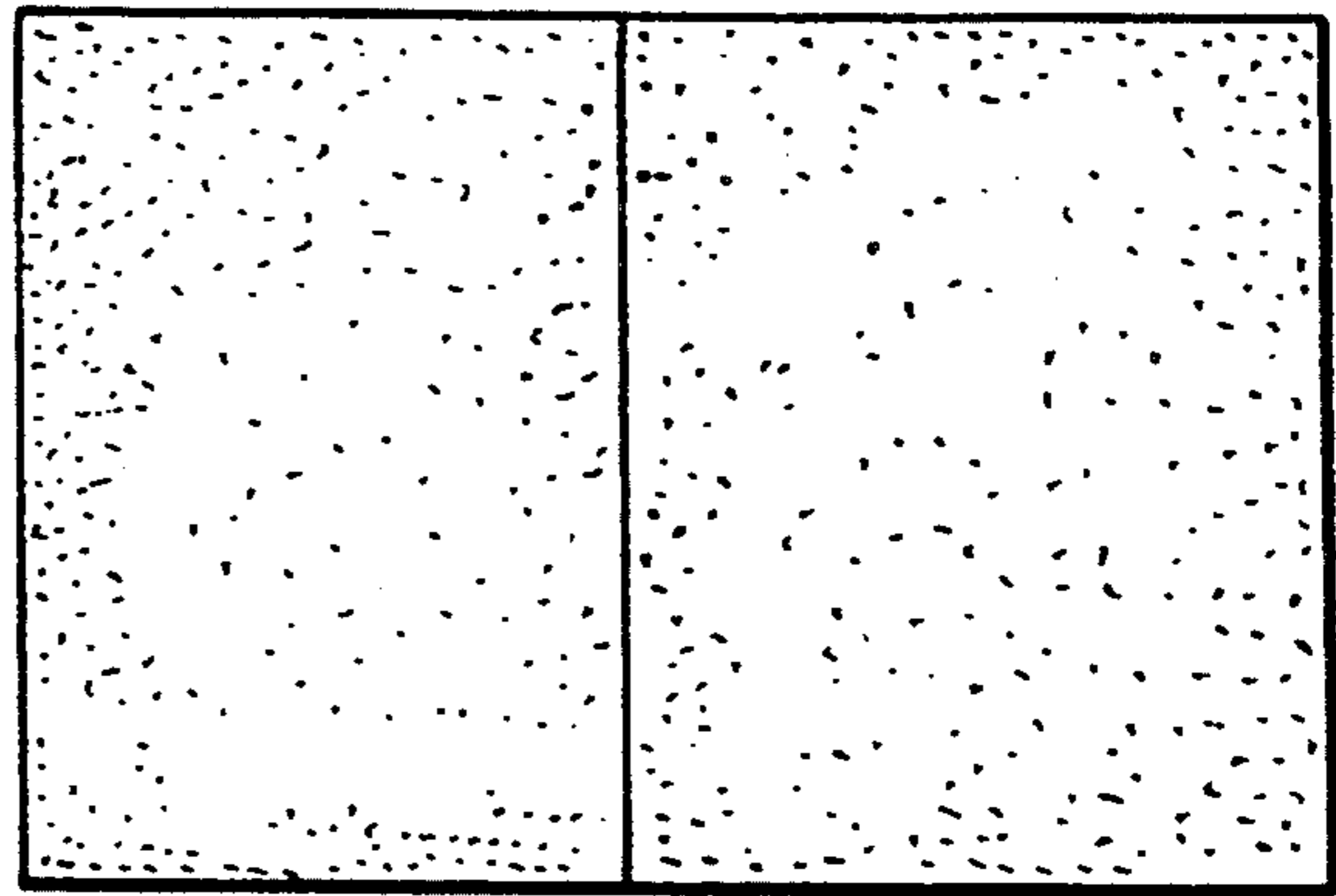
