## [57] CLAIM

The ornamental design for a water closet, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and left side of a water closet embodying our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof, the left side being a mirror image of the right side;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a perspective view taken from the top, front and left side of a second embodiment thereof;

FIG. 8 is a right side elevational view of FIG. 7, the left side being a mirror image of the right side;

FIG. 9 is a perspective view taken from the top, front and left side of a third embodiment thereof; and,

FIG. 10 is a right side elevational view of FIG. 9, the left side being a mirror image of the right side.

The broken line representations of holes in FIGS. 1, 2, 4, 7, and 9 are for the purpose of illustration only and form no part of the claimed design.

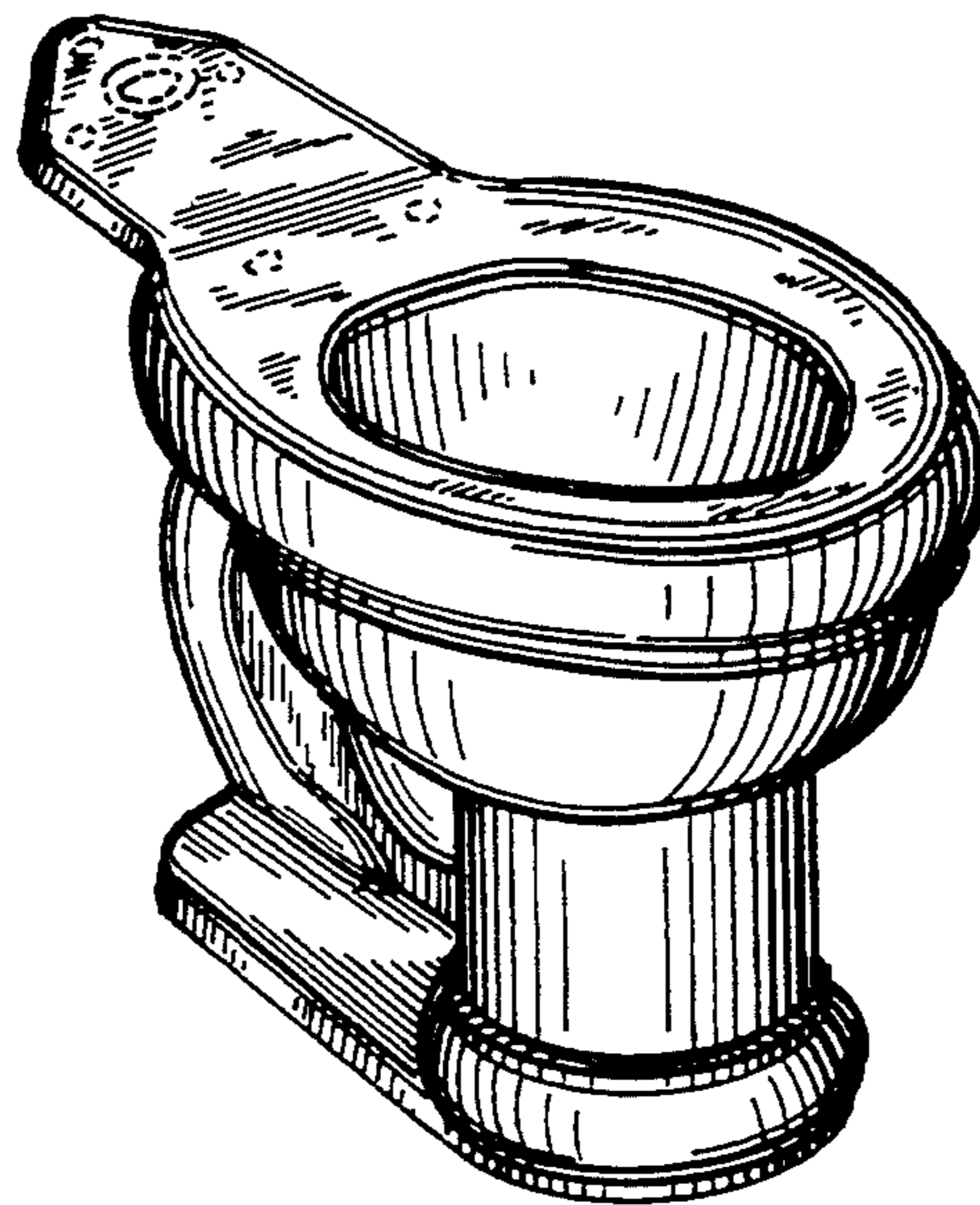

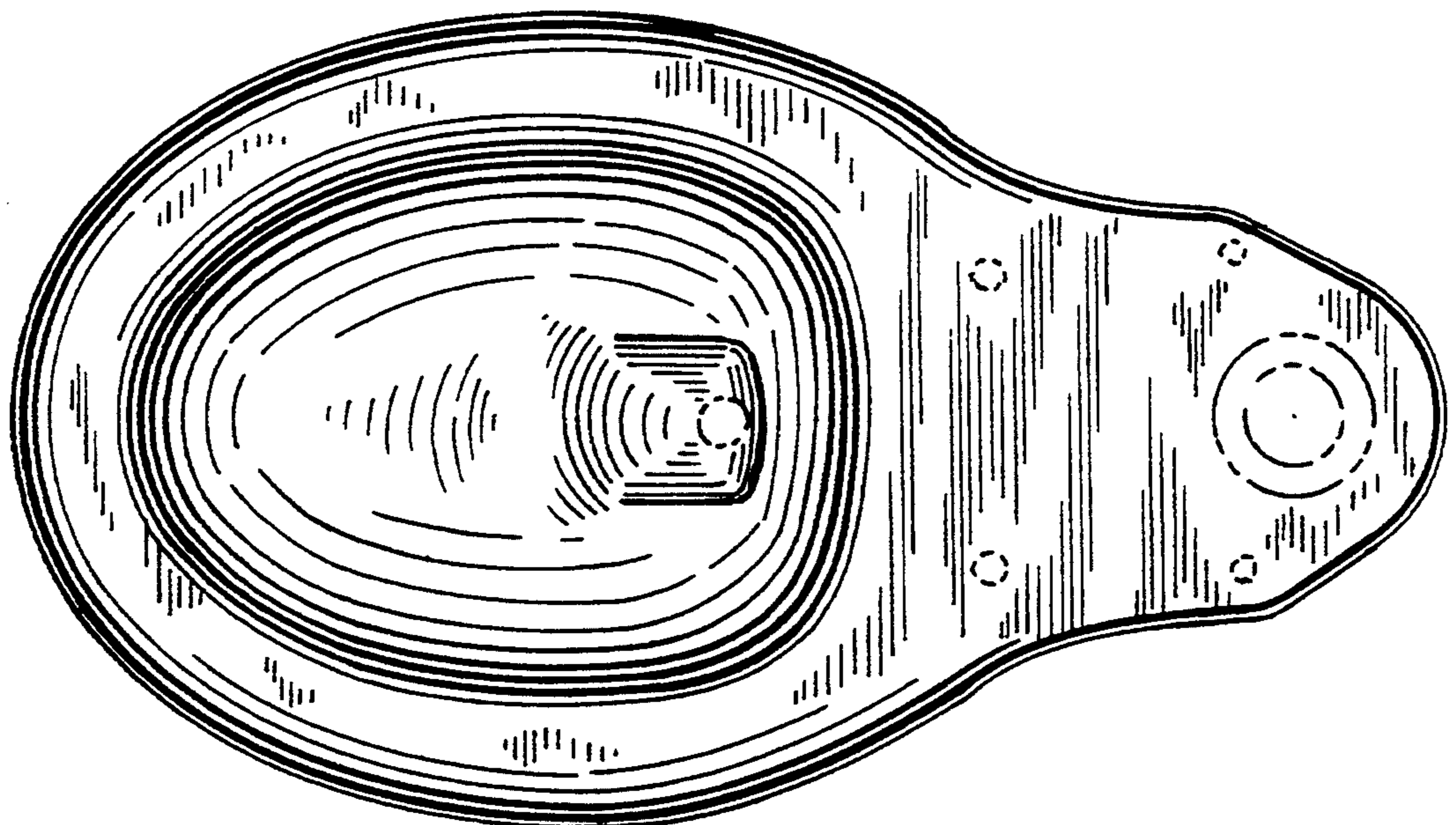
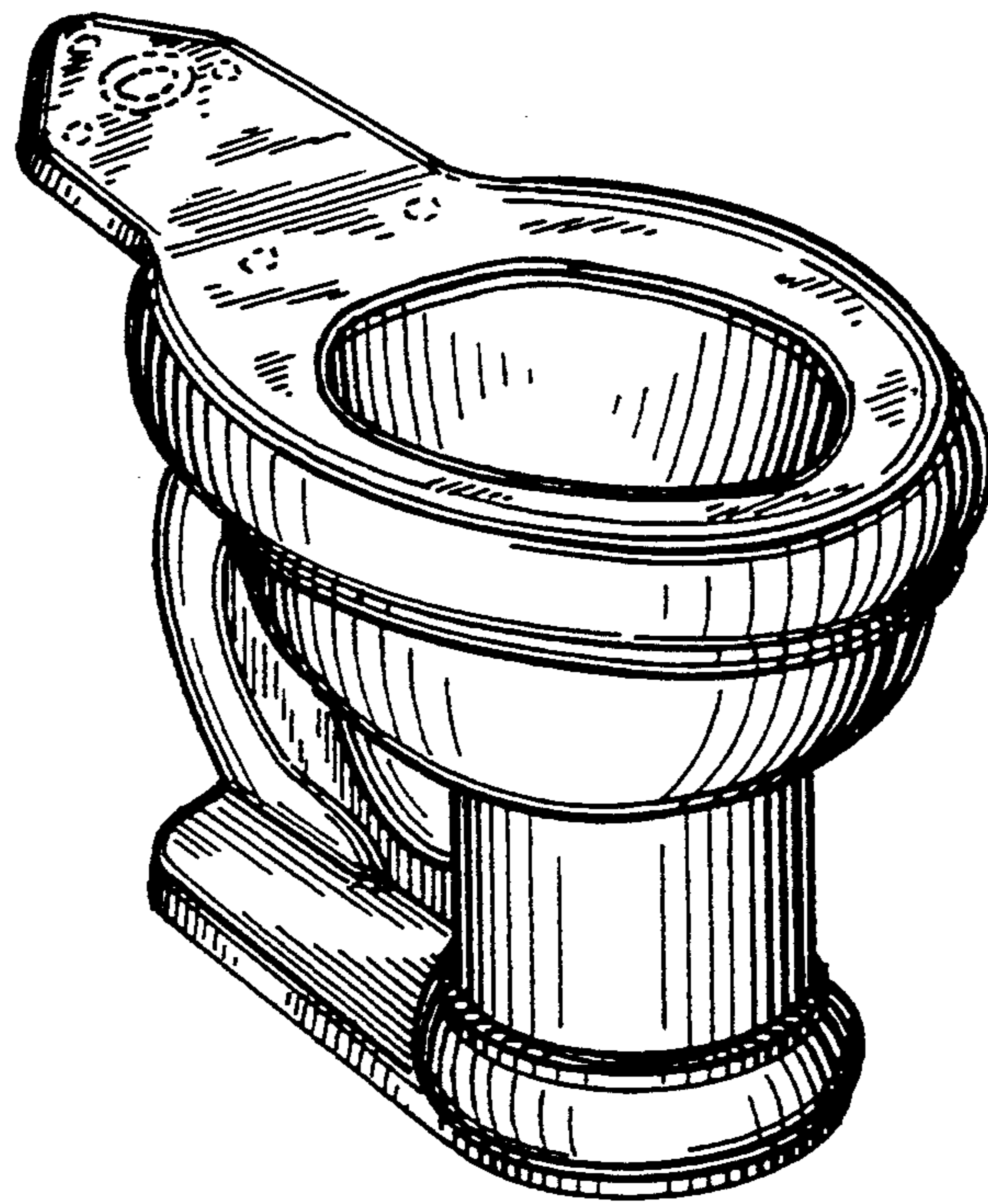

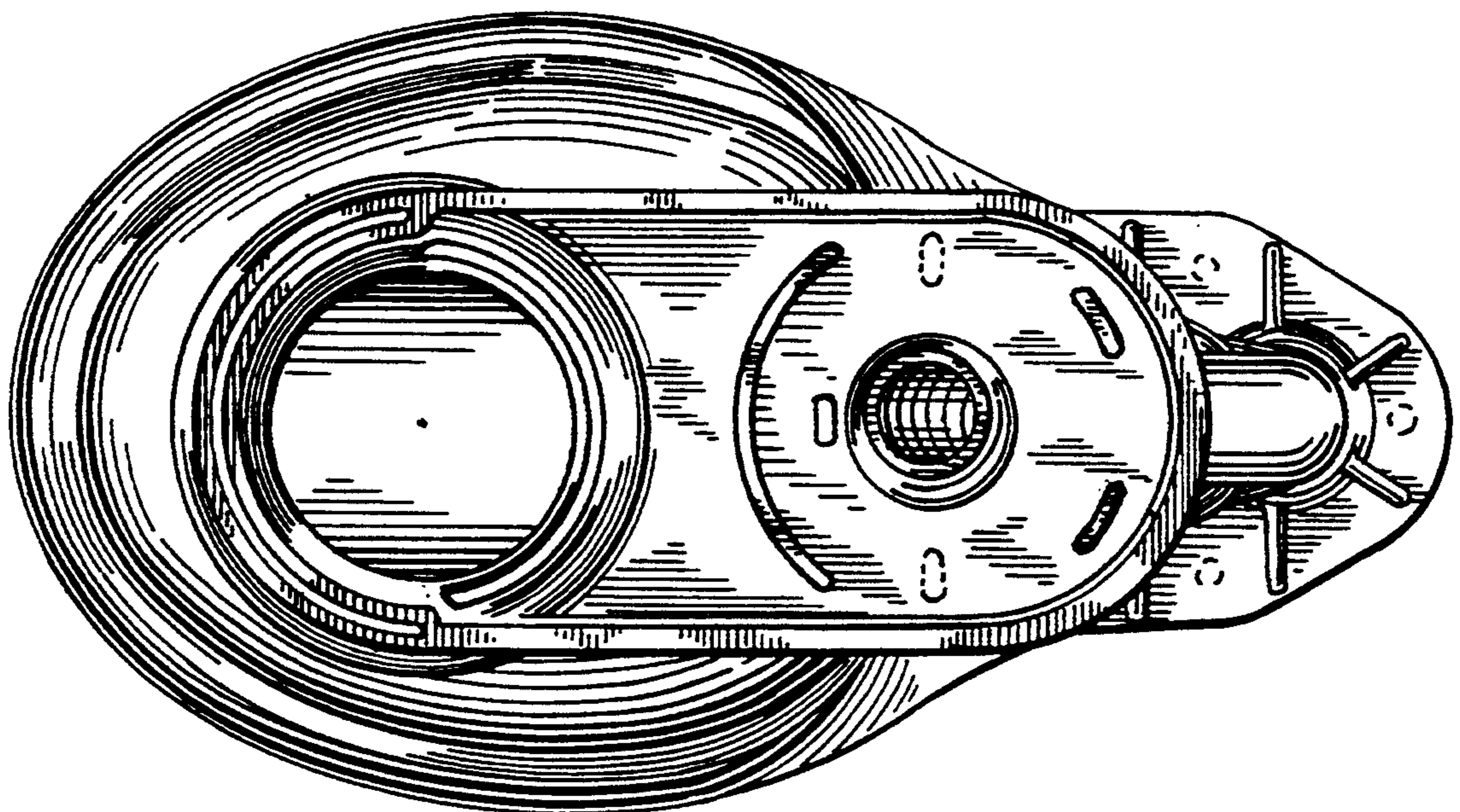
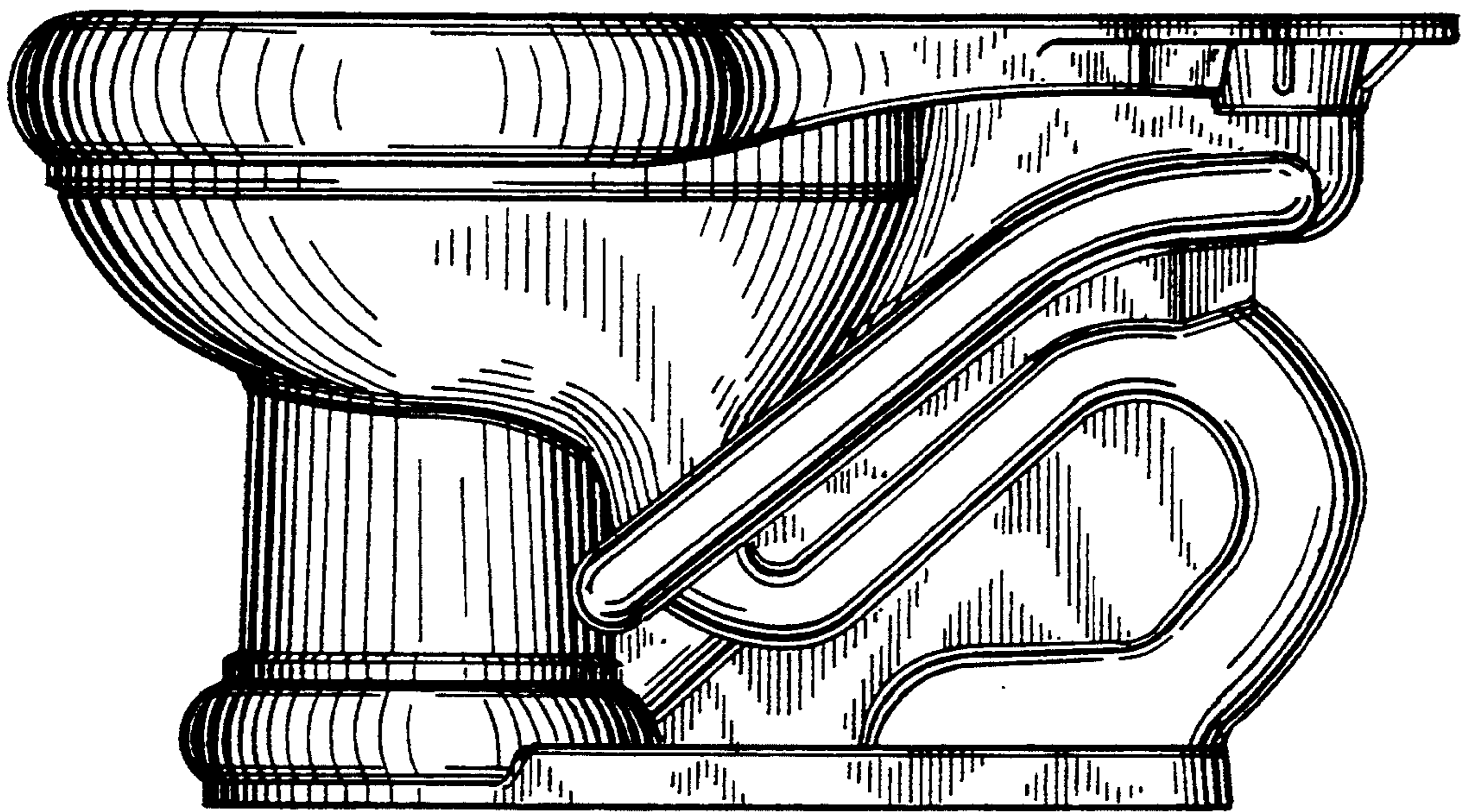

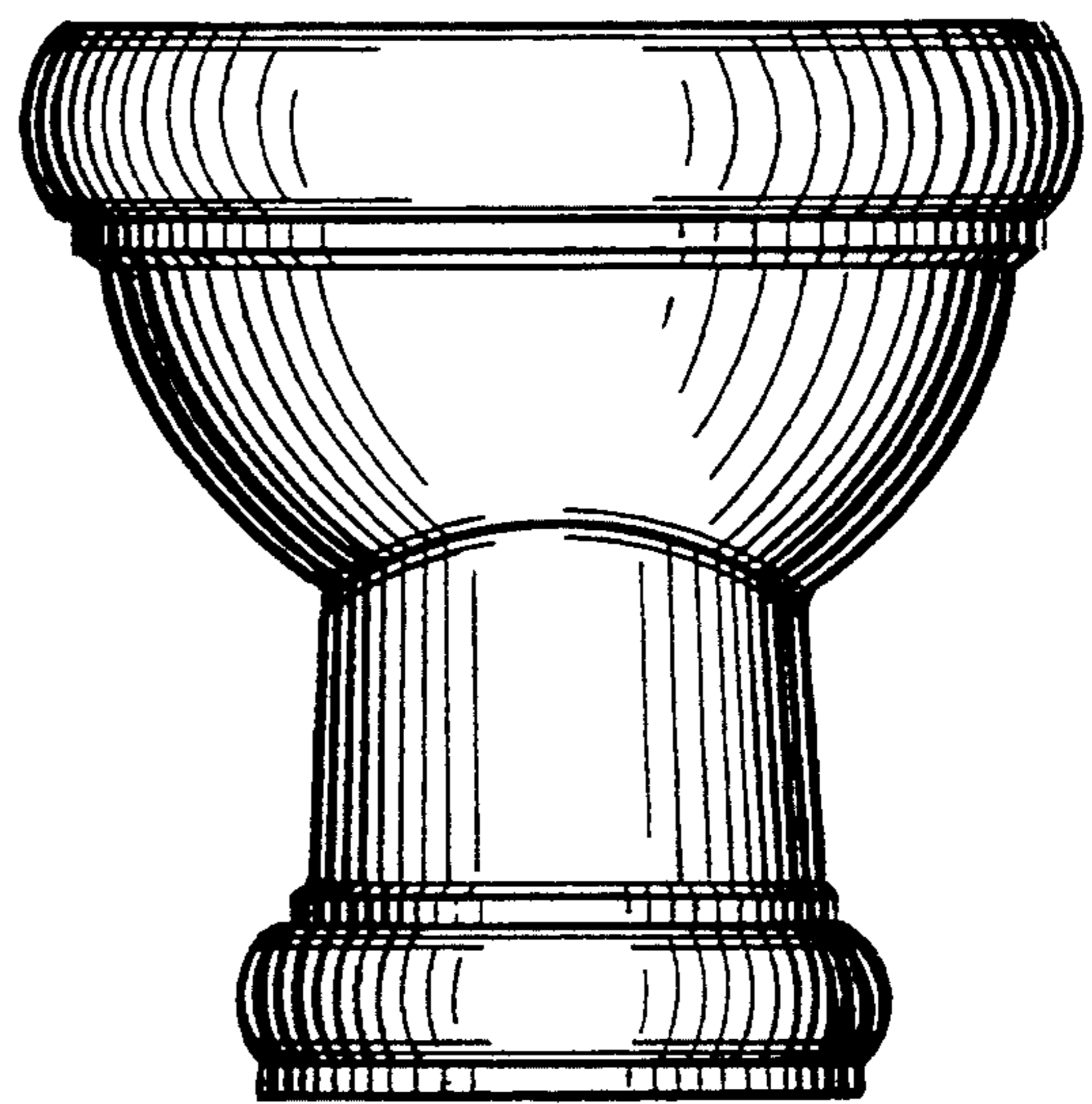
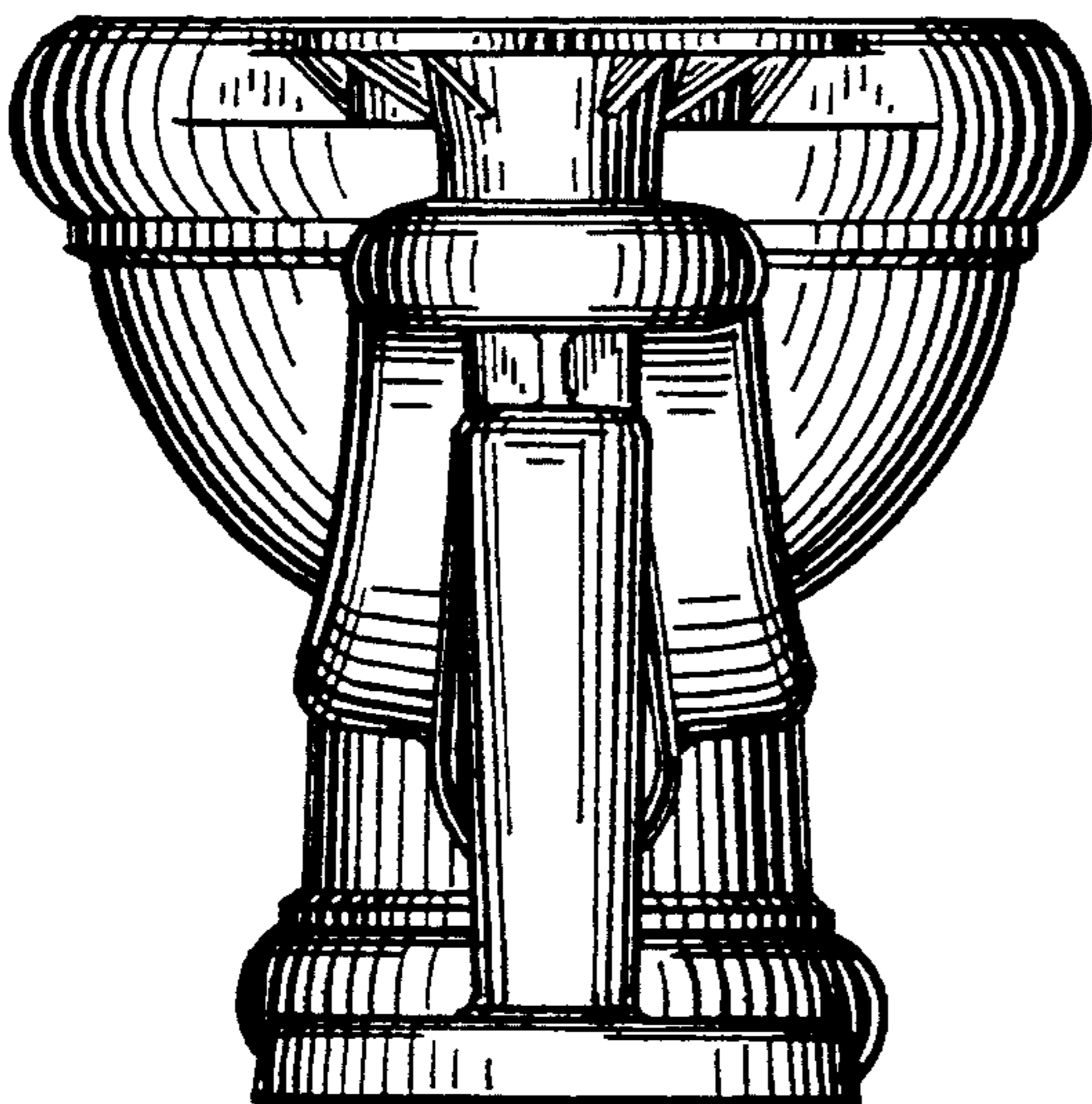

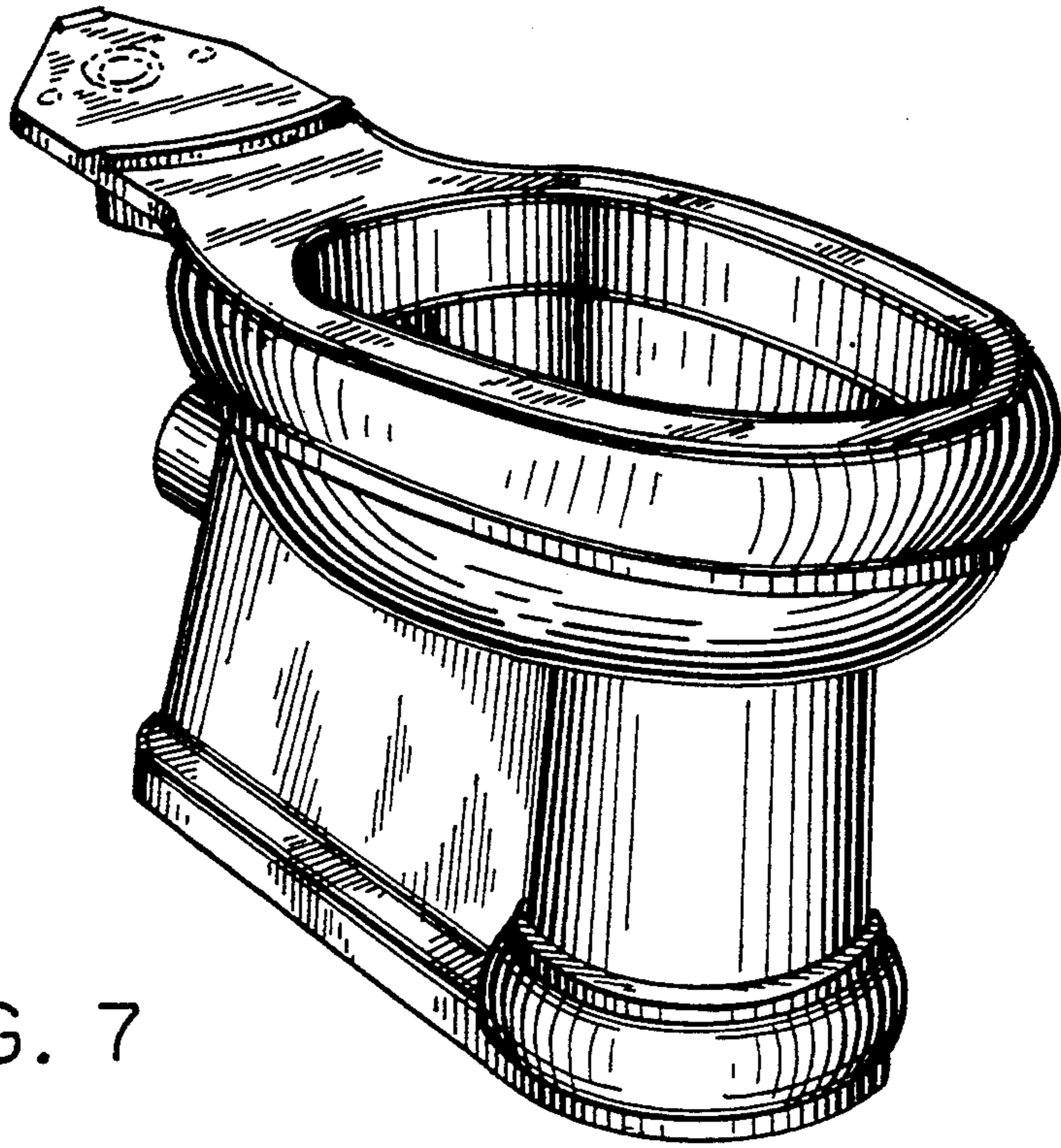

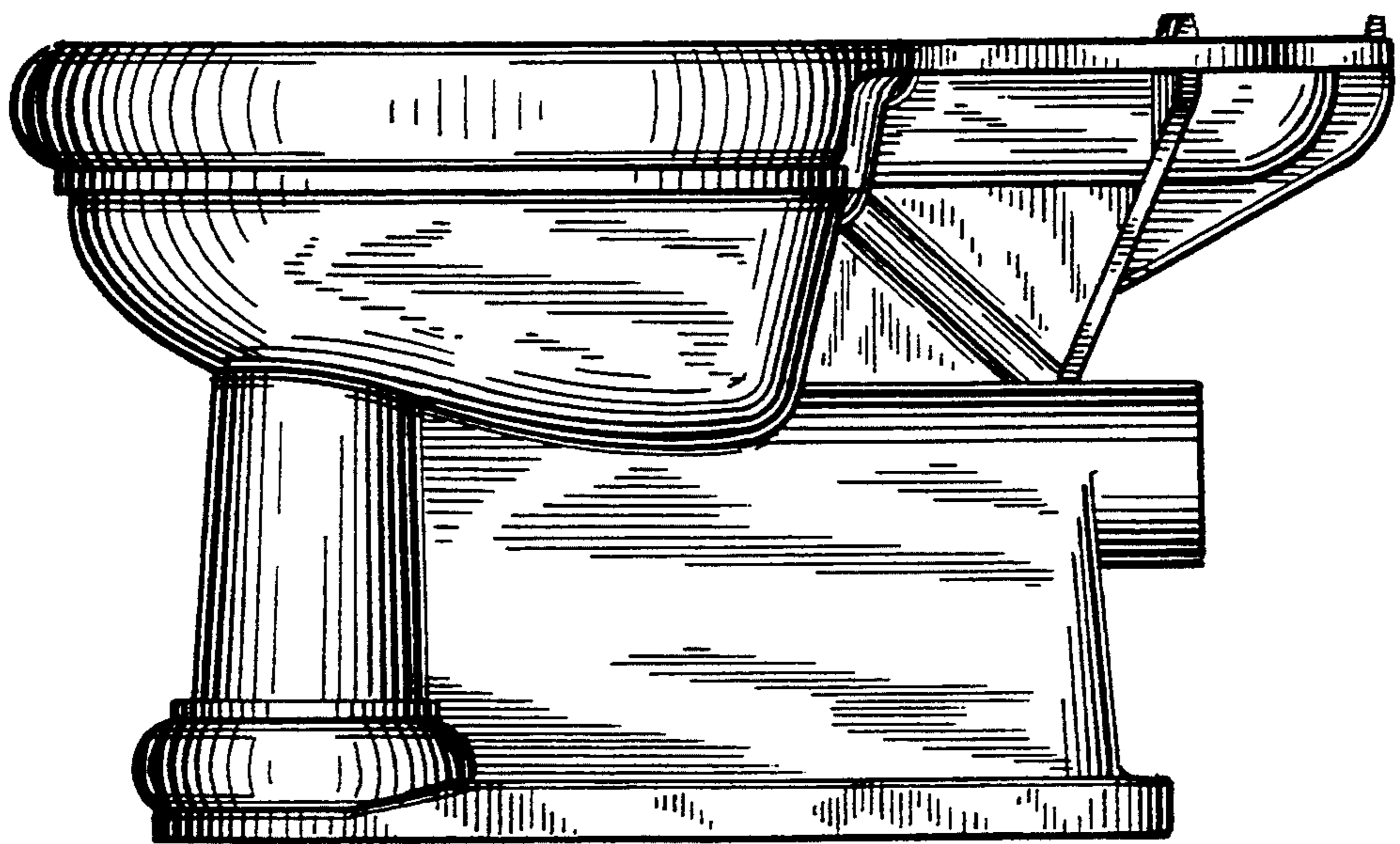

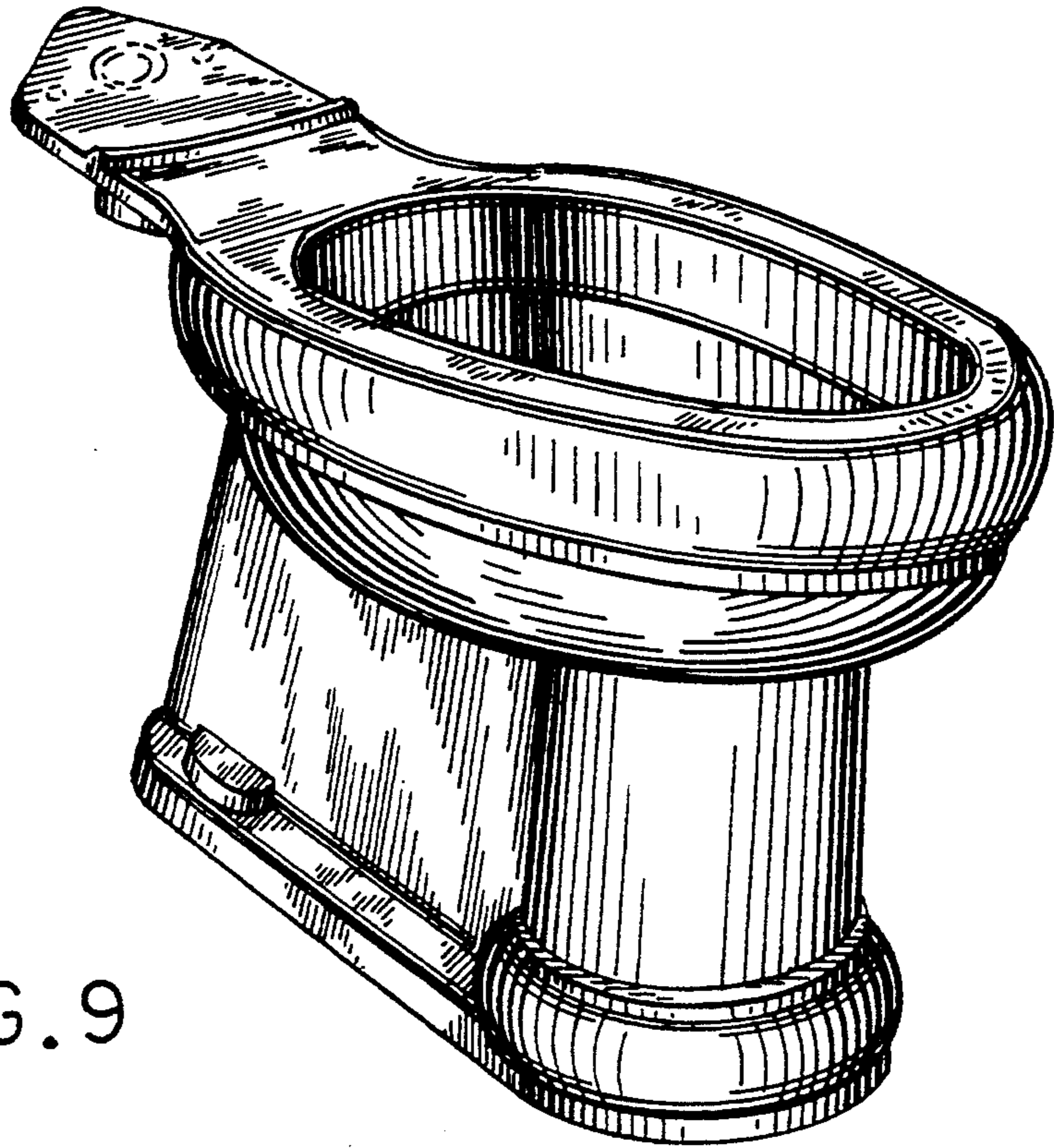

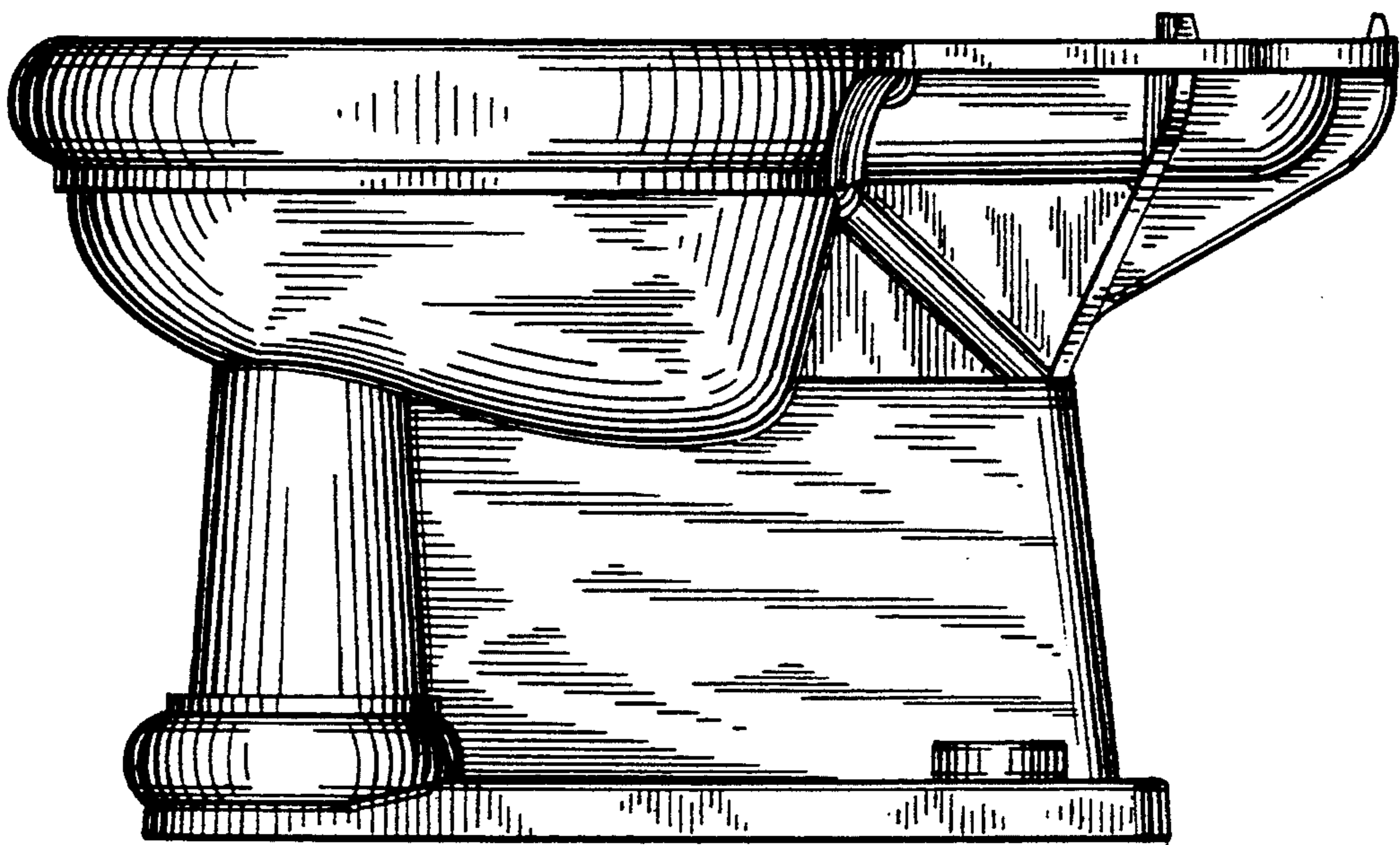
