[57] **CLAIM**

The ornamental design for a sterile splicer for connecting medical tubing, as shown and described.

DESCRIPTION

FIG. 1 is a top, front left side perspective view of a sterile splicer for connecting medical tubing showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view being identical threto; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.
