[57] **CLAIM**

The ornamental design for the slimline floor-mounted protective rail, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the top and front of the design for the slimline floor-mounted protective rail, illustrating the design for the end cap, the center module with leg assembly and protective strip;

FIG. 2 is an elevational view of the front side of the design for the slimline floor-mounted protective rail;

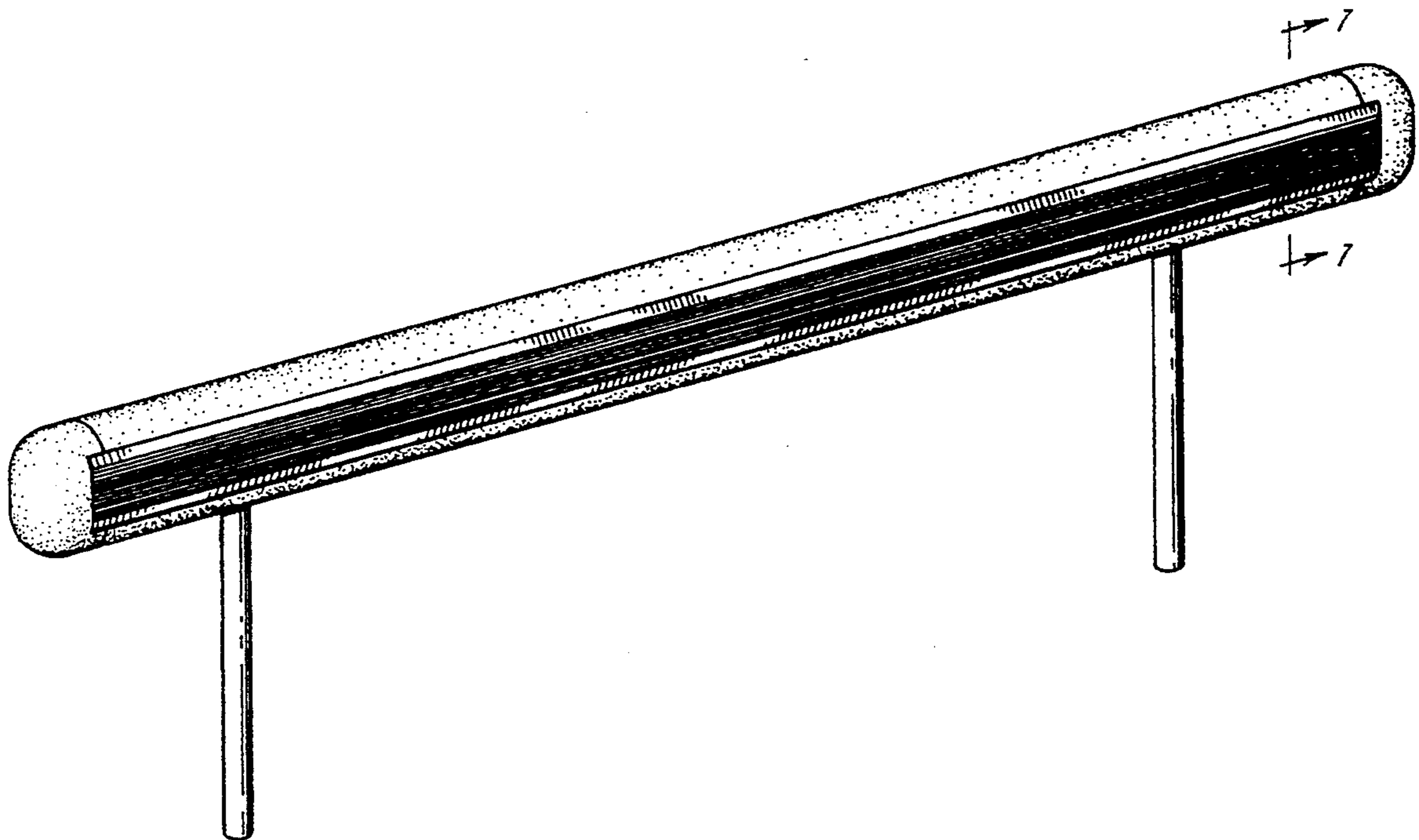
FIG. 3 is a plan view of the top of the design for the slimline floor-mounted protective rail, illustrating the end cap, and the center module;

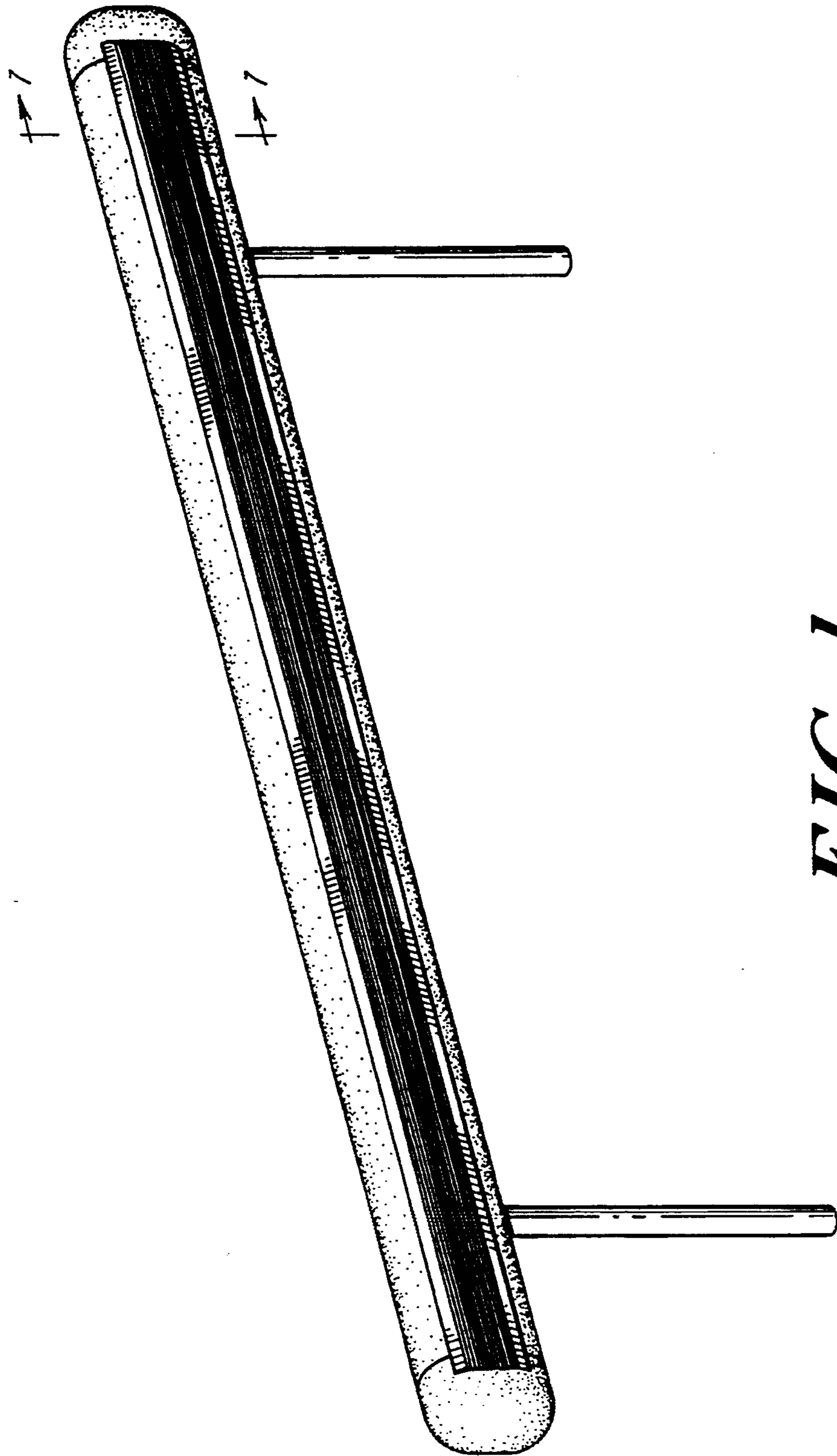
FIG. 4 is an elevational view of the rear side of the design for the slimline floor-mounted protective rail;

FIG. 5 is a plan view of the undersurface of the design for the slimline floor-mounted protective rail;

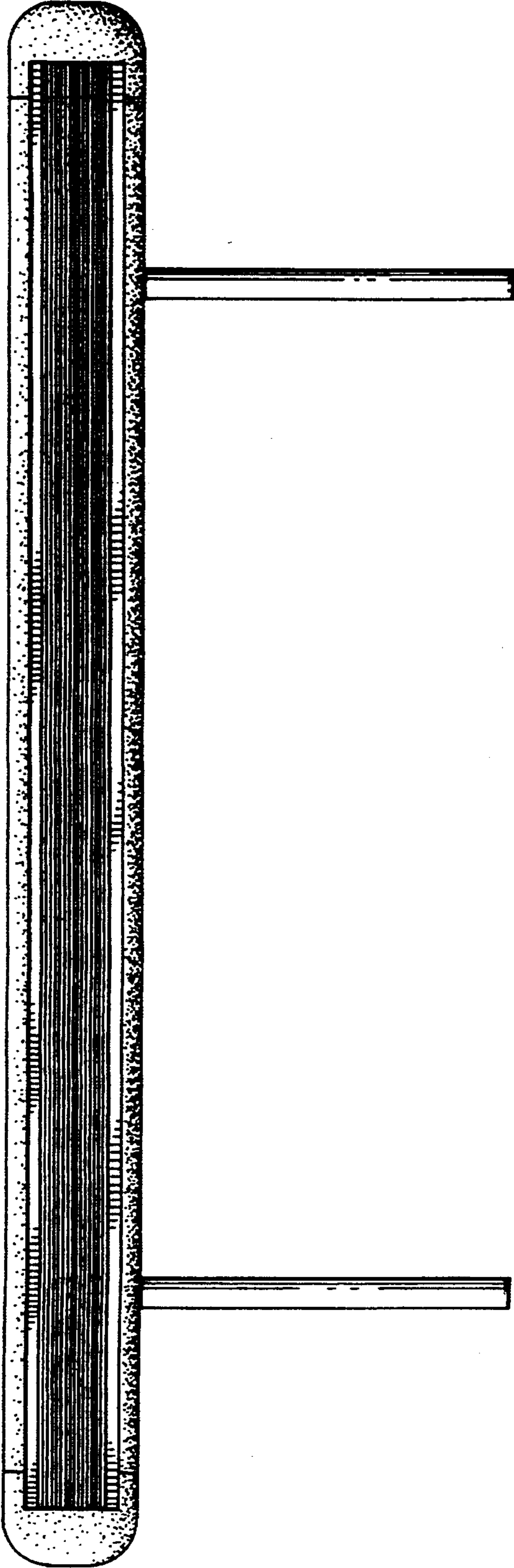
FIG. 6 is an end view along the horizontal axis of the slimline floor-mounted protective rail, illustrating the leg assembly and end cap; and,

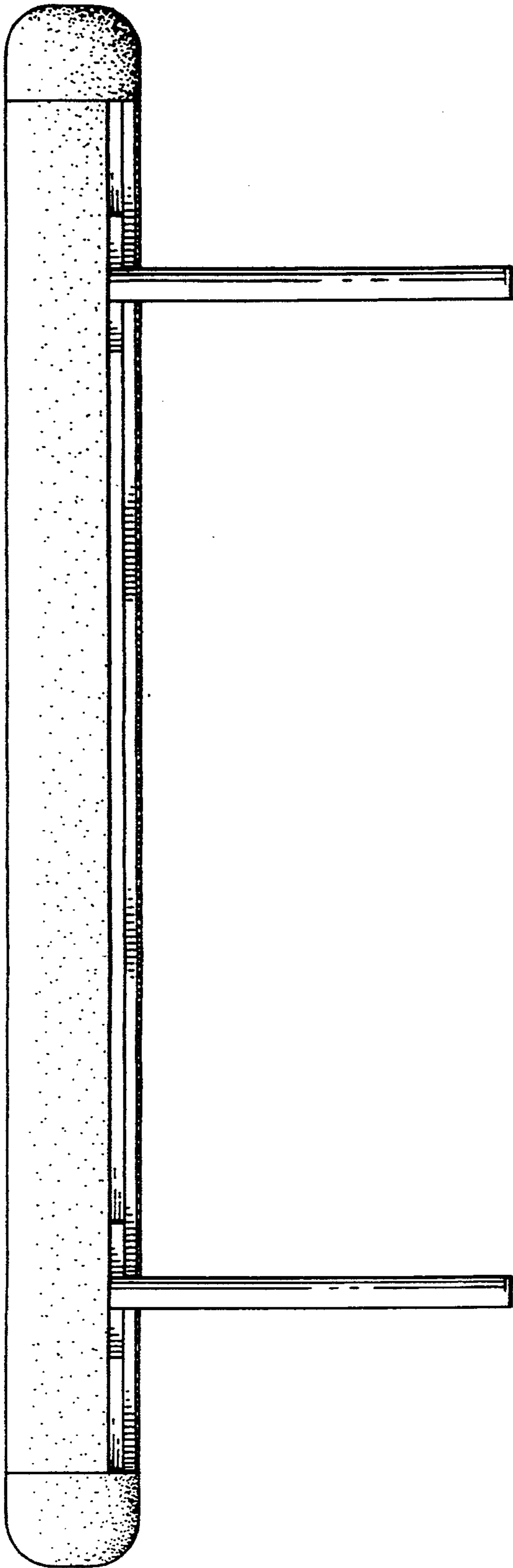

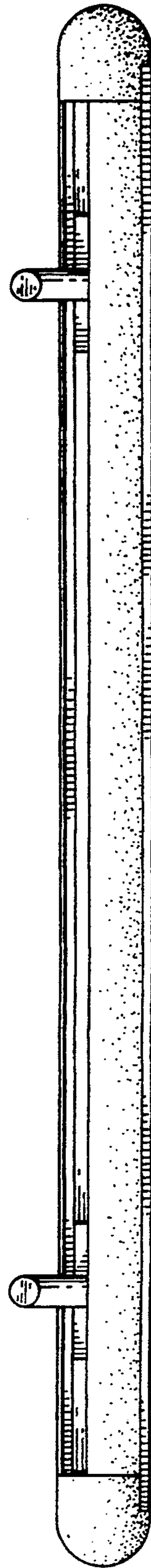

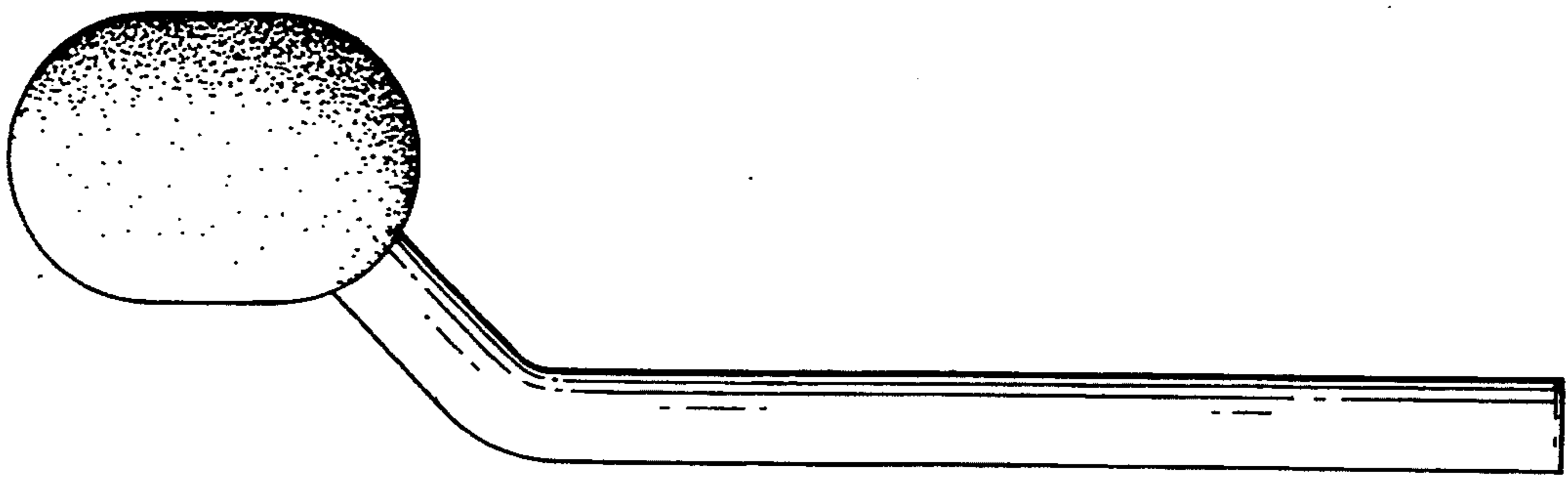




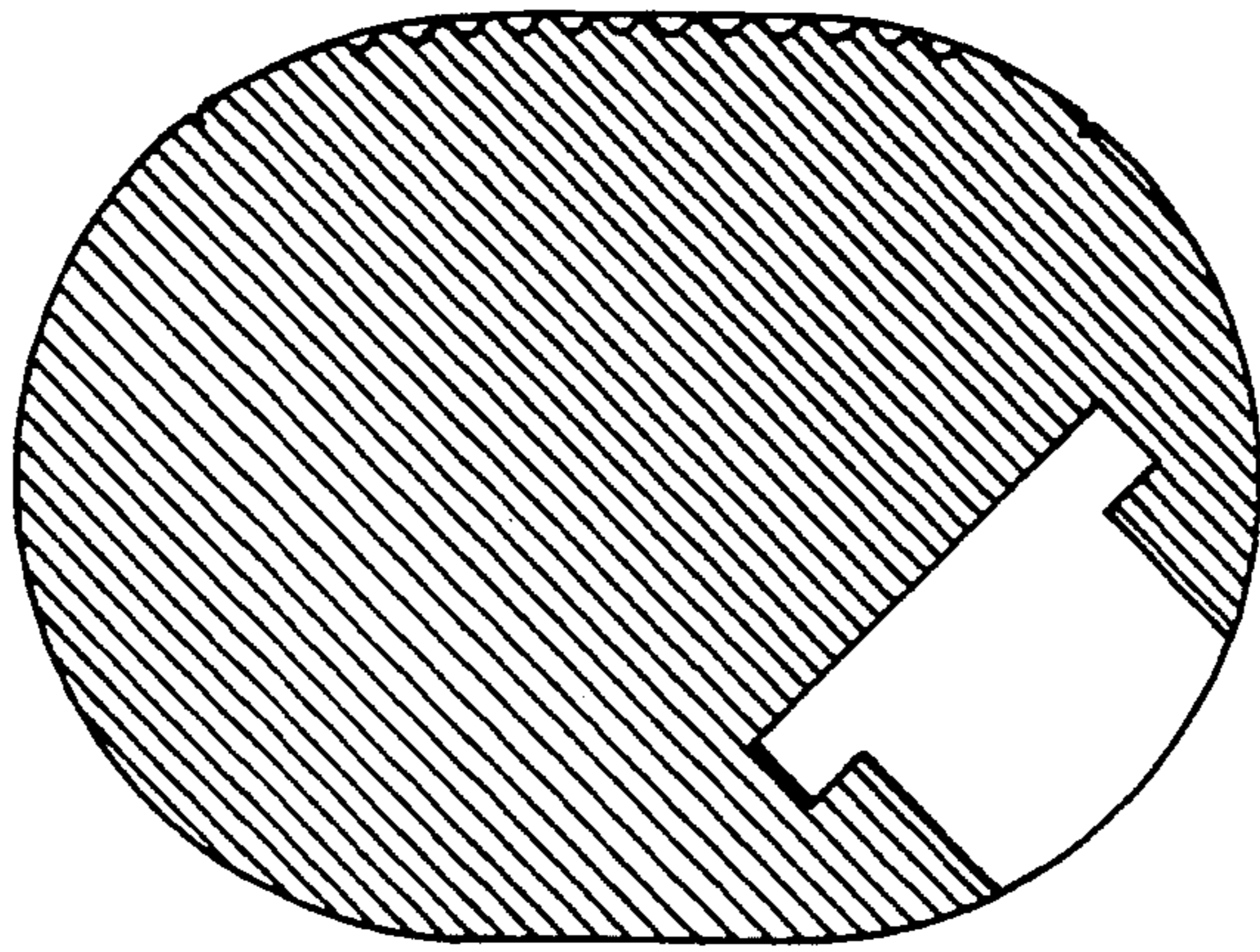
