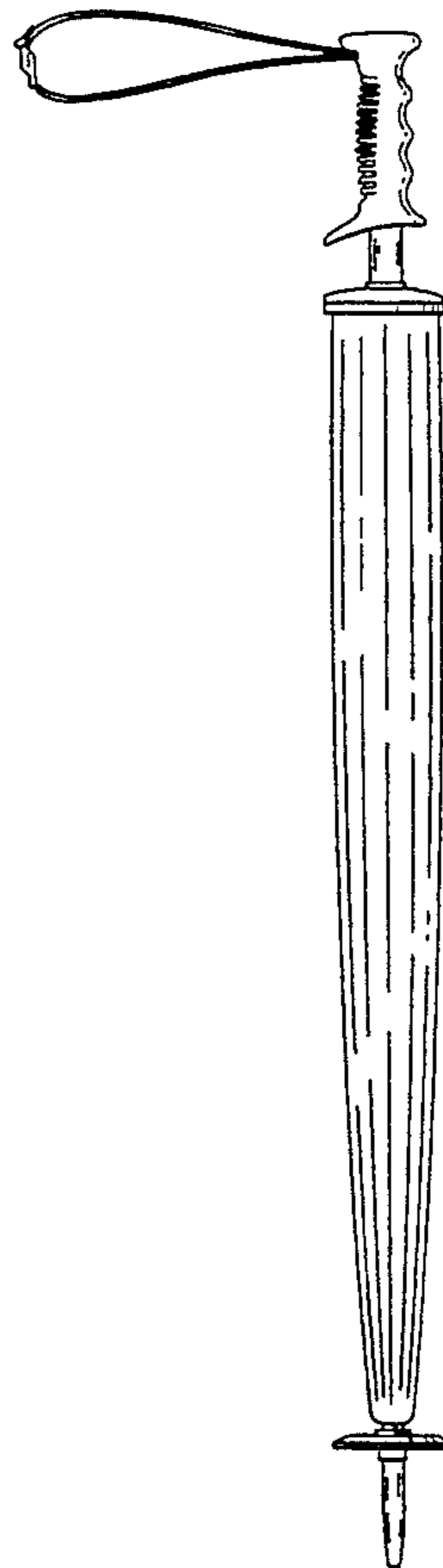

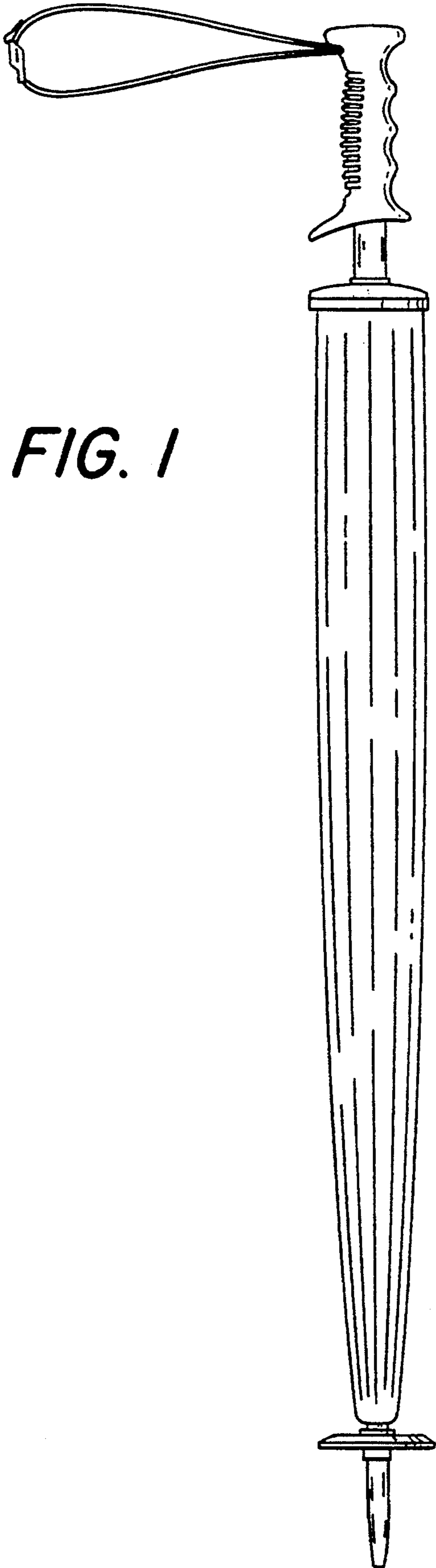
[57] **CLAIM**

The ornamental design for an umbrella, as shown.

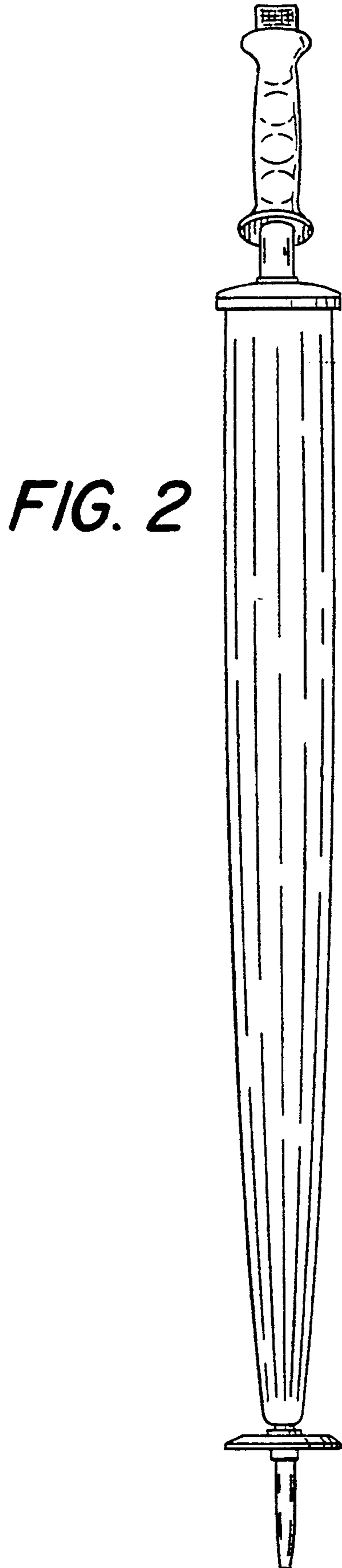
**DESCRIPTION**

FIG. 1 is a side elevational view of an umbrella embodying the invention taken from the left side thereof; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a fragmentary front elevational view of an alternate umbrella embodying the invention, all portions not shown being like the umbrella shown in FIGS. 1 through 5; FIG. 7 is a side elevational view thereof; FIG. 8 is a rear elevational view thereof; FIG. 9 is a top plan view of the alternate portion thereof; FIG. 10 is a bottom plan view of the alternate portion thereof; FIG. 11 is a fragmentary rear elevational view of a second alternate embodiment of an umbrella embodying the invention, all portions not shown being like the umbrella shown in FIGS. 1 through 5; FIG. 12 is a front elevational view thereof; FIG. 13 is a top plan view of the second alternate portion thereof; and, FIG. 14 is a bottom plan view of the second alternate portion thereof.



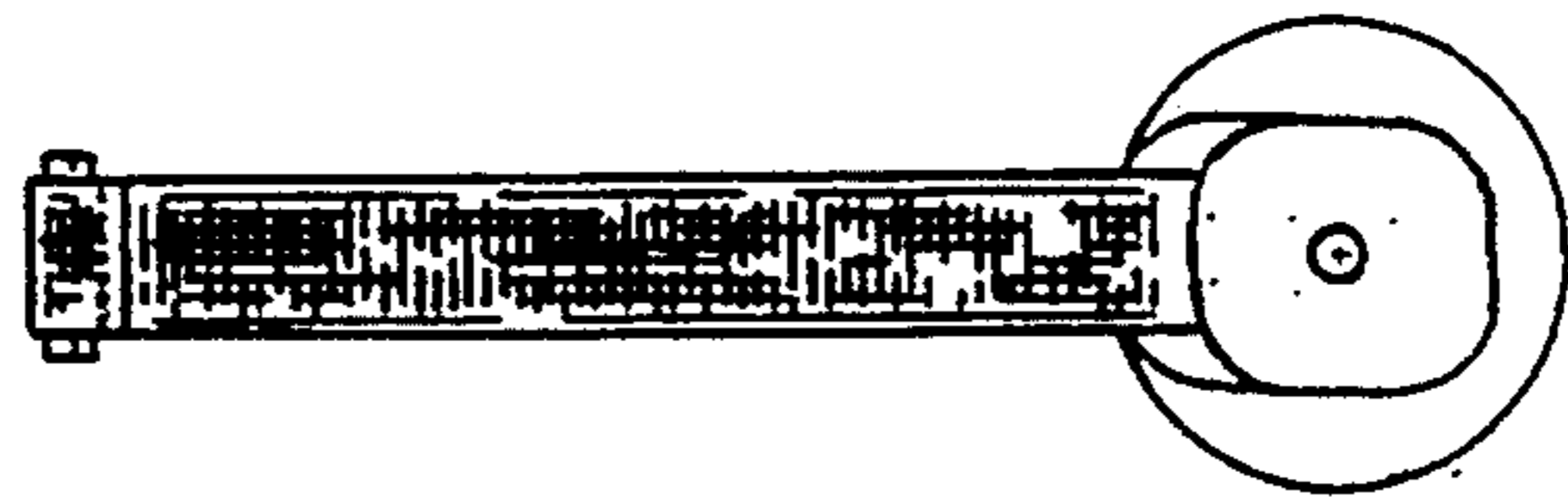
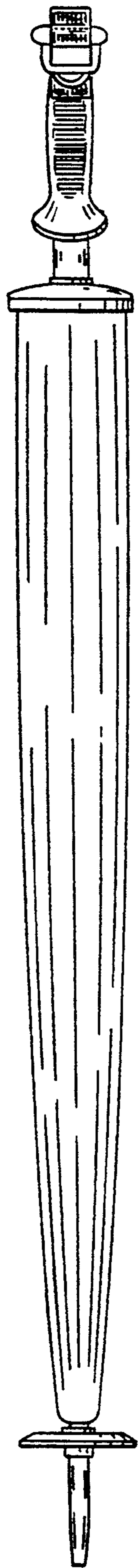

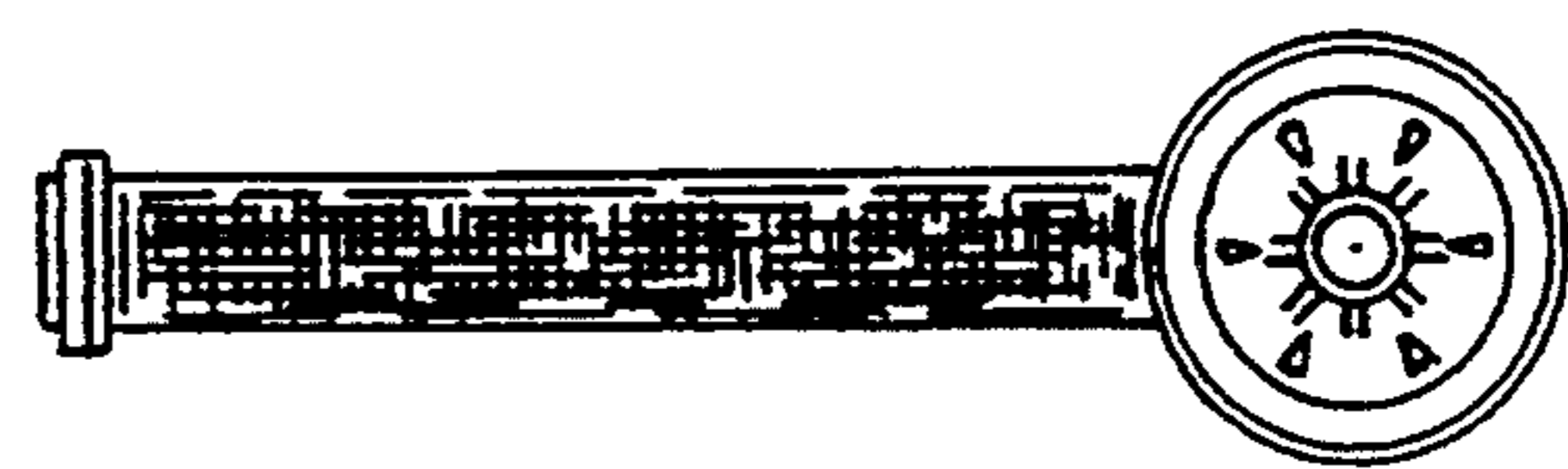

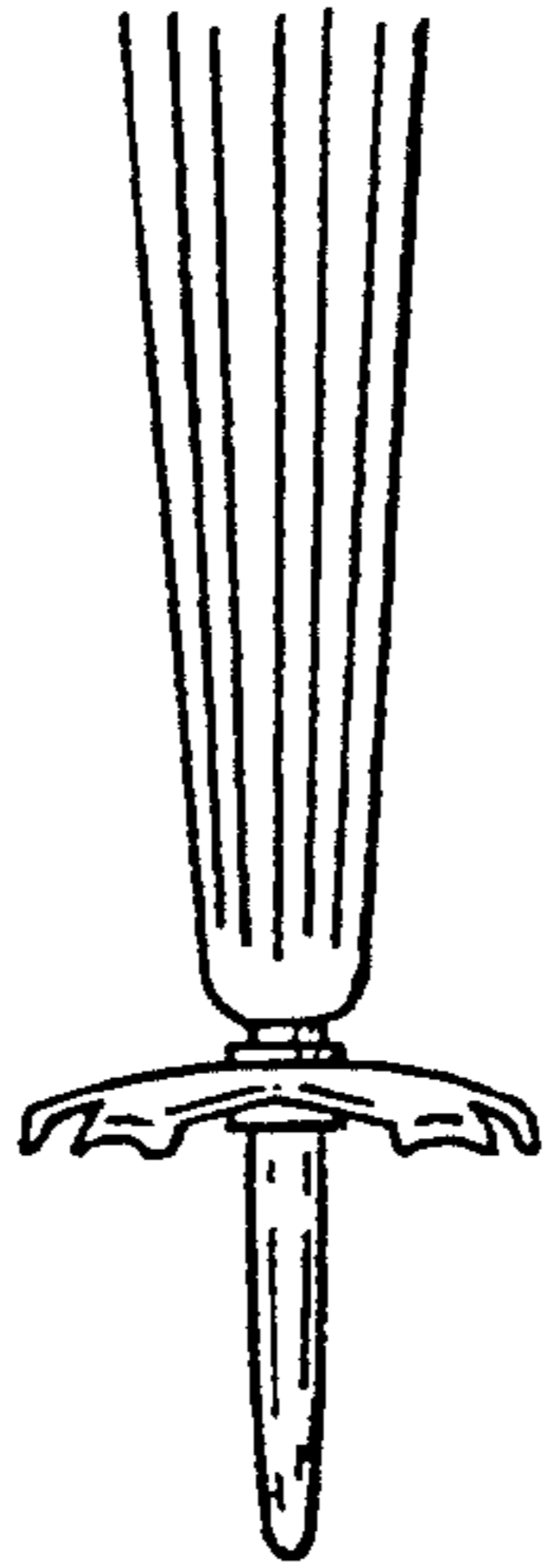

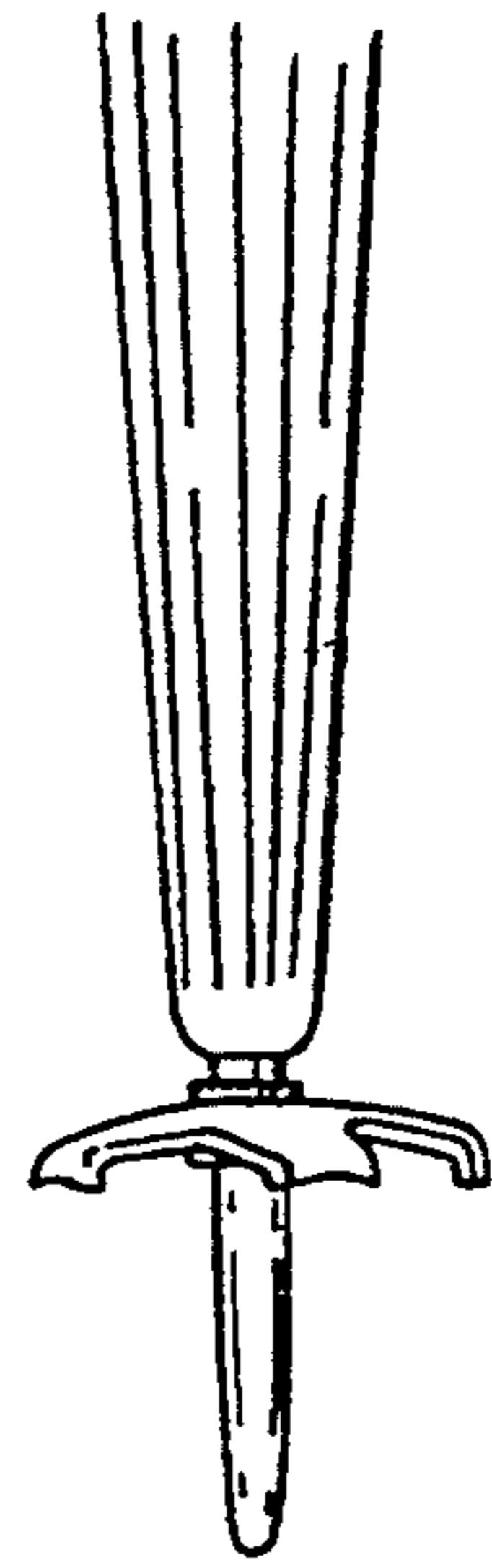

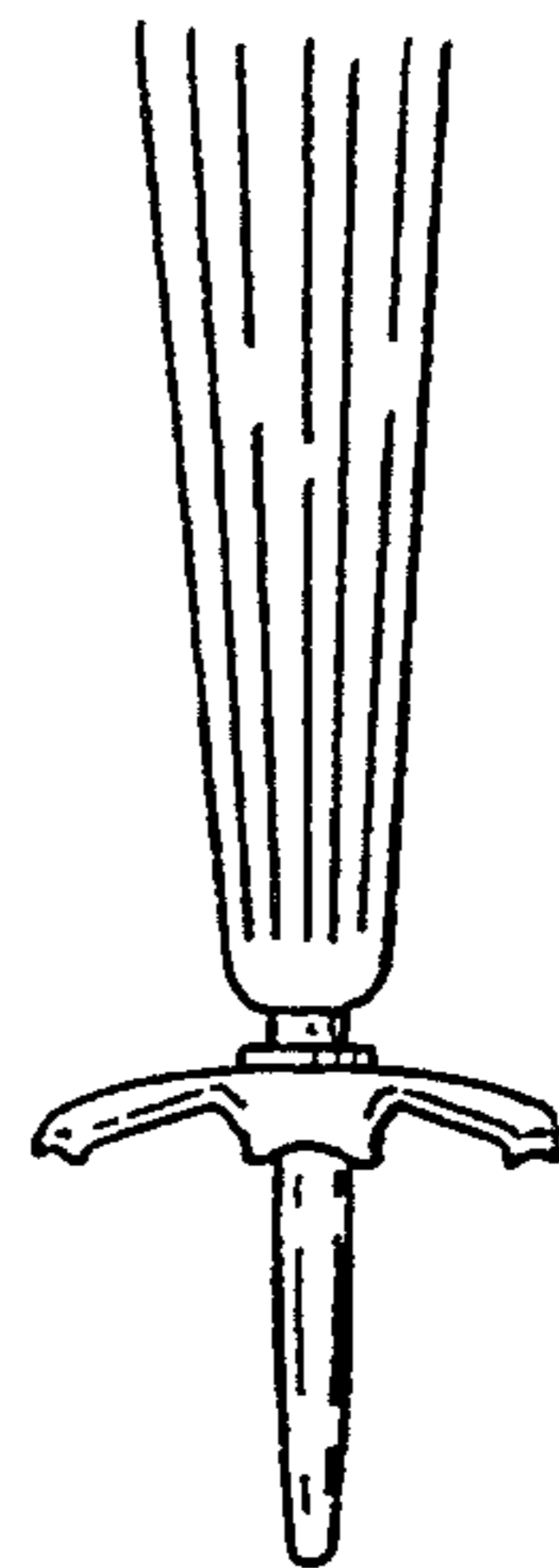

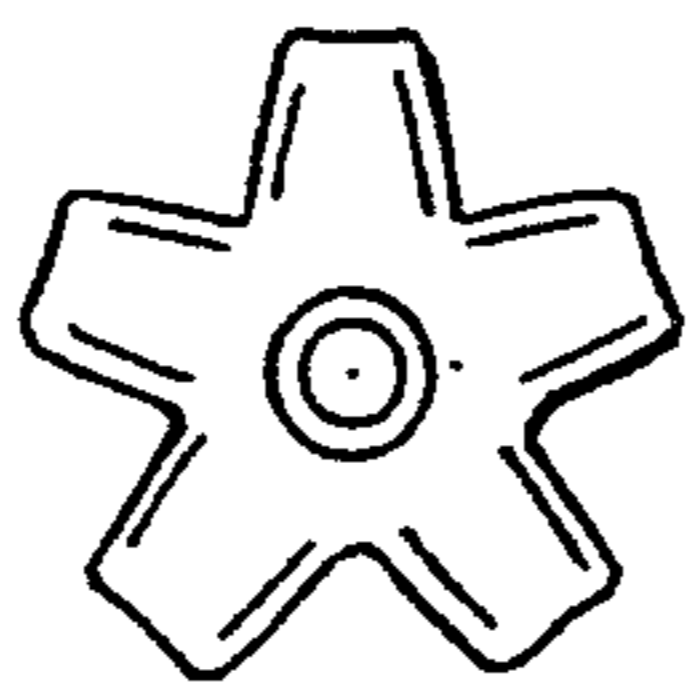

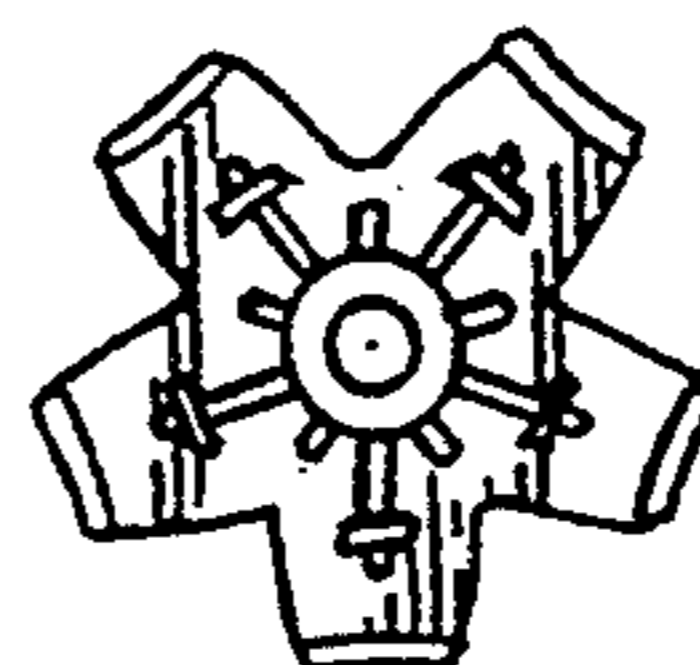
