The ornamental design for a personalized watercraft propeller, as shown and described.

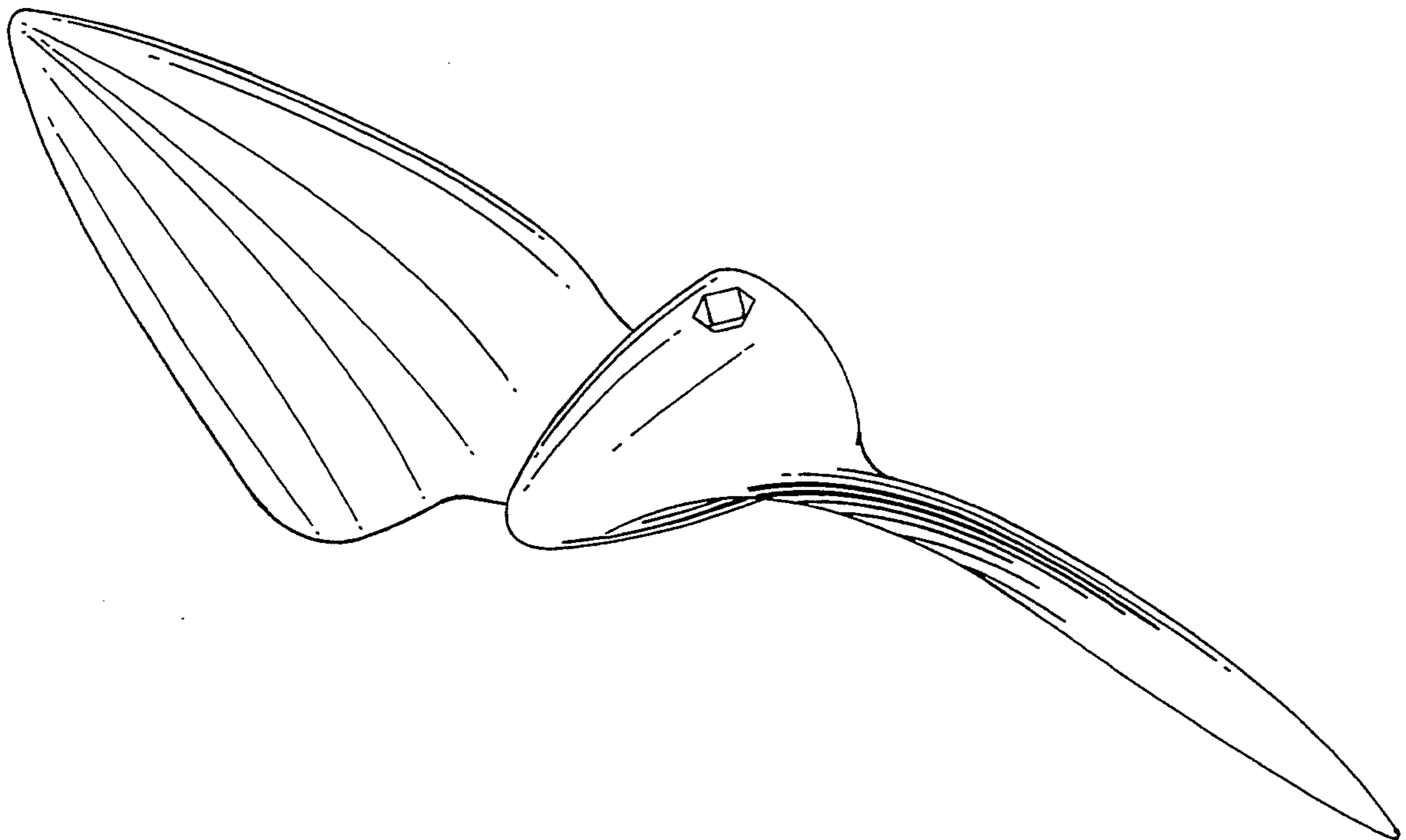
### DESCRIPTION

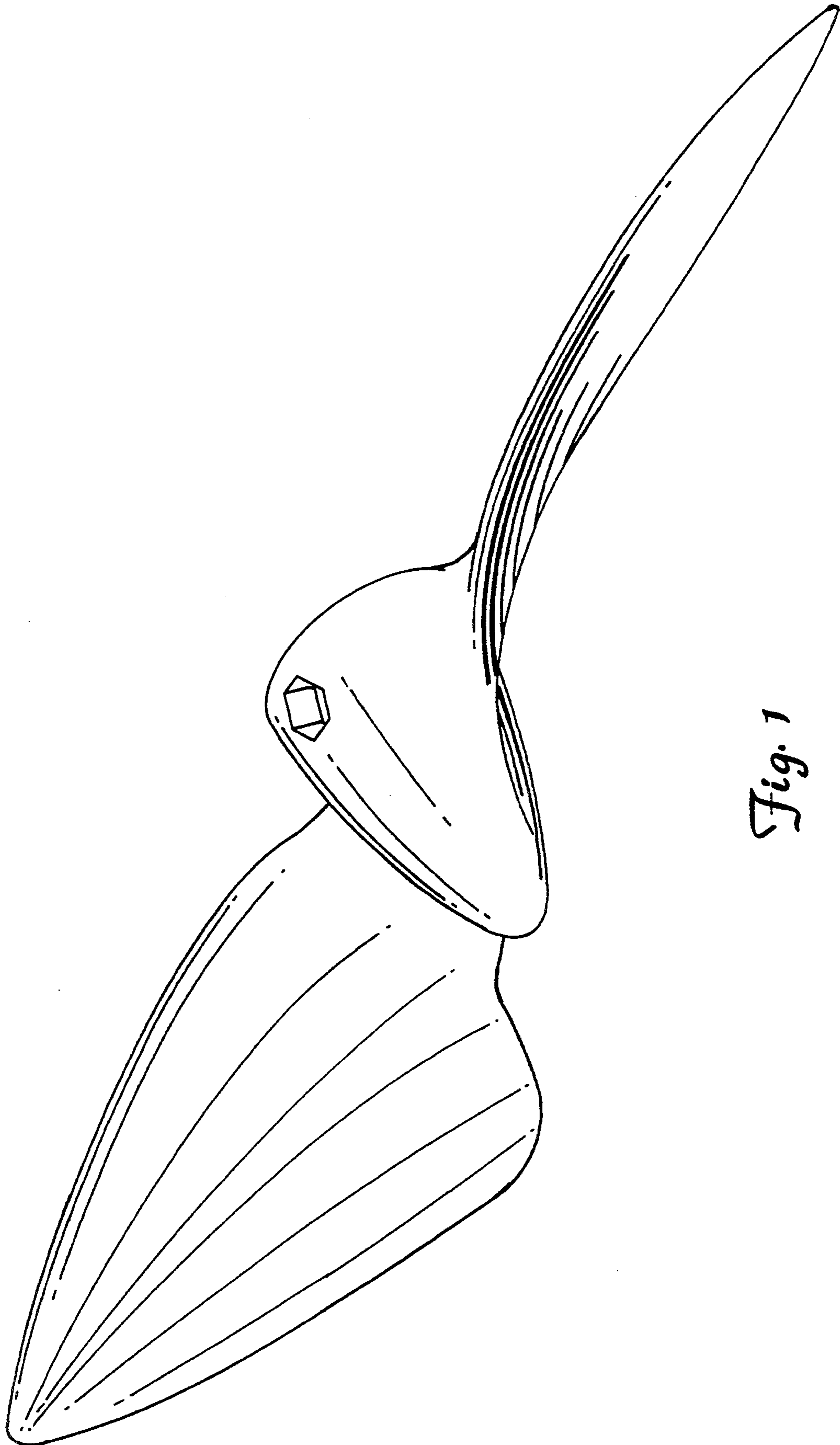
FIG. 1 is a rear perspective view of a personalized watercraft propeller showing our new design;

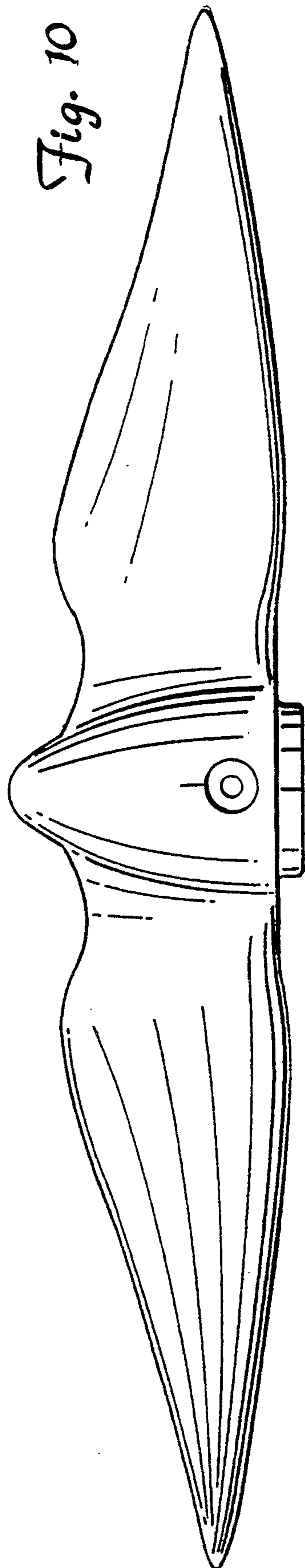
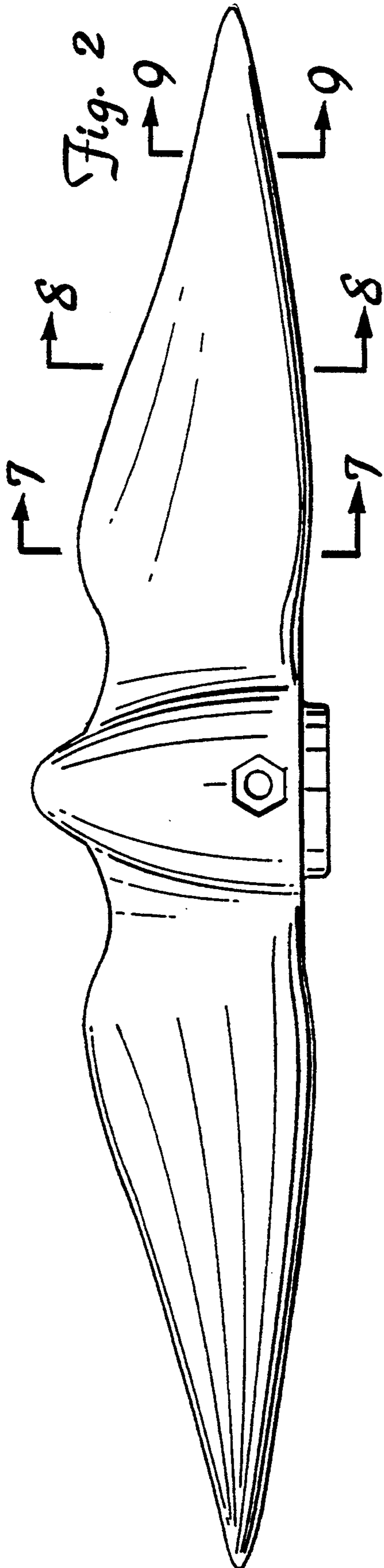

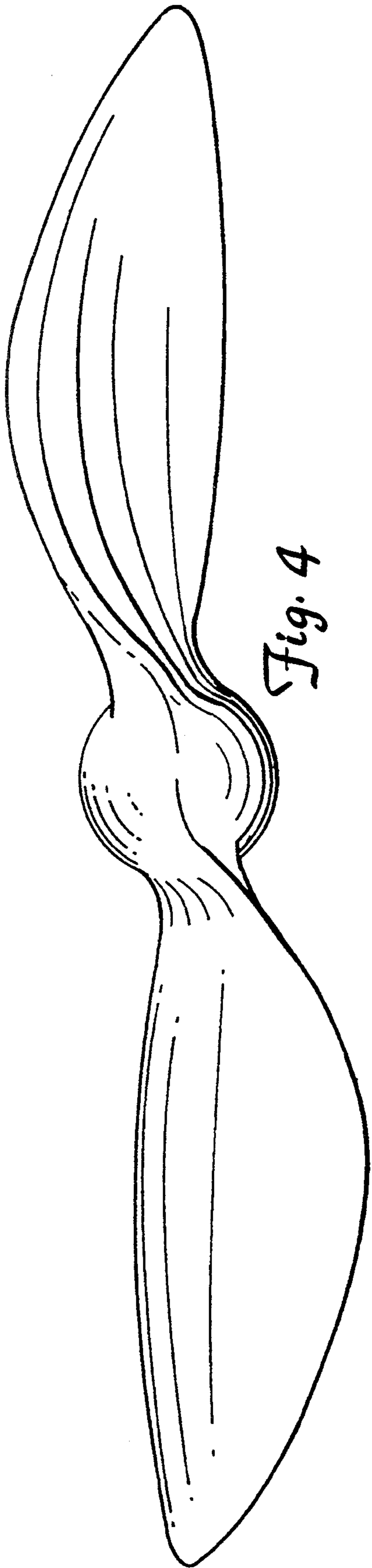

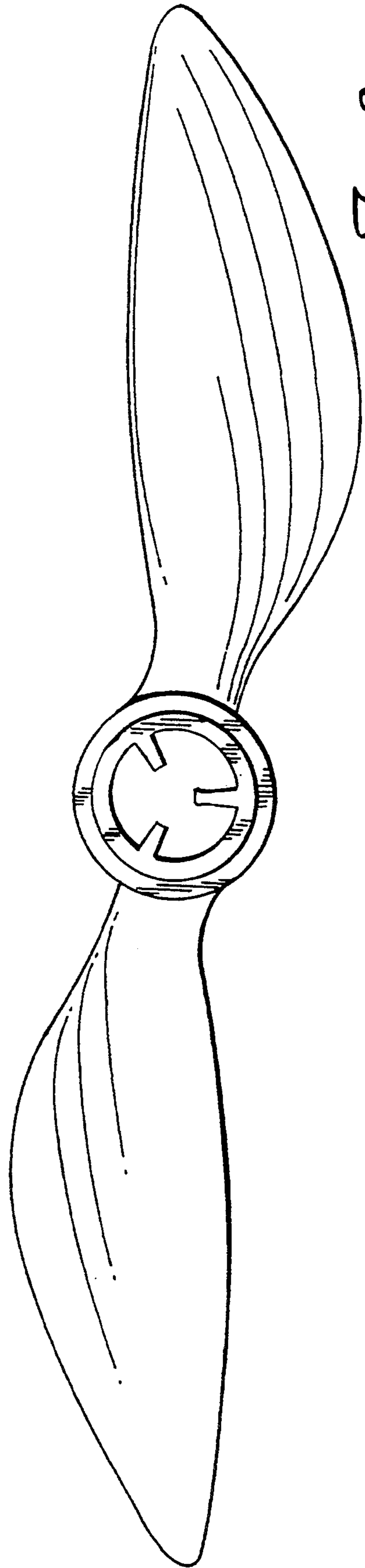

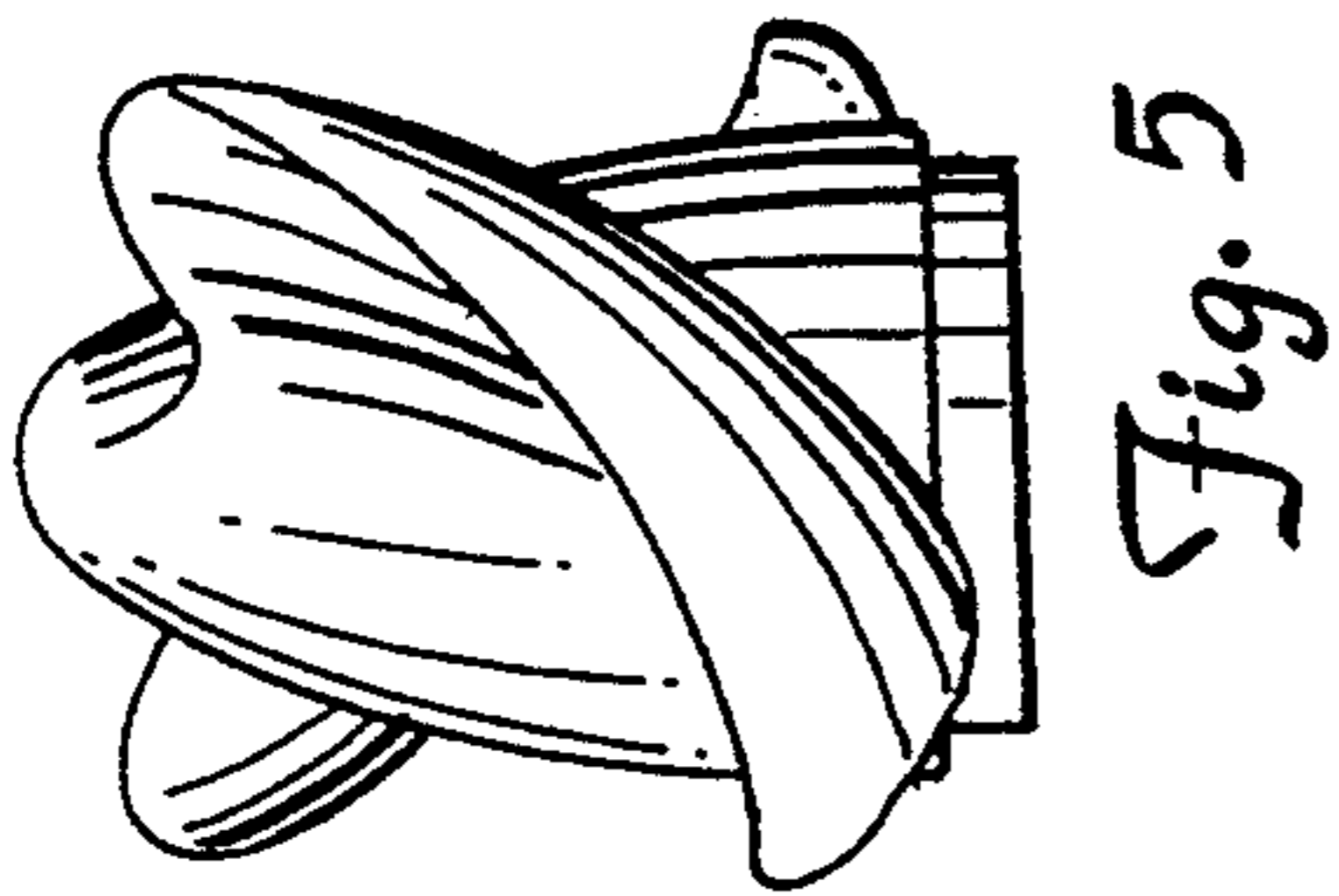

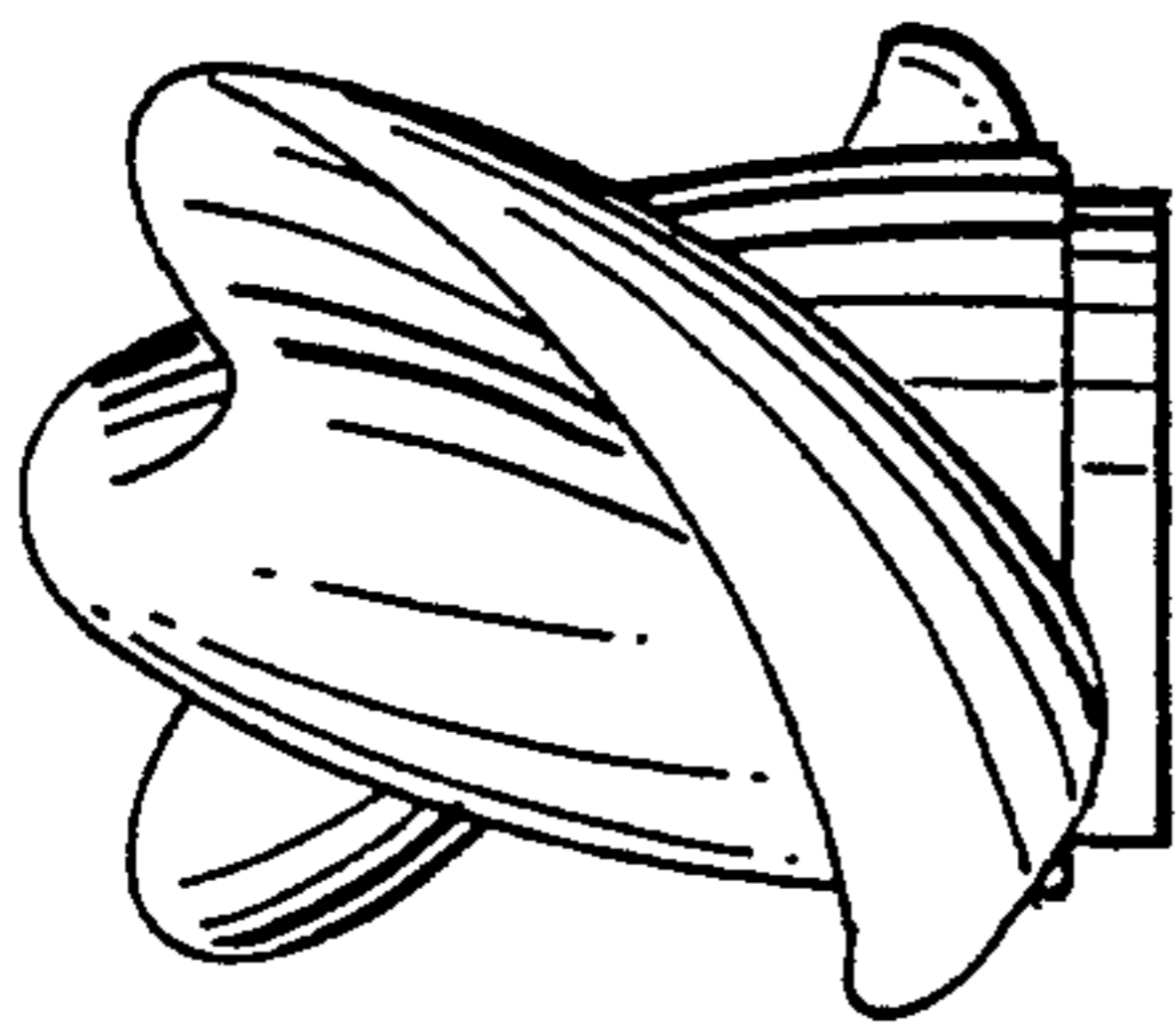

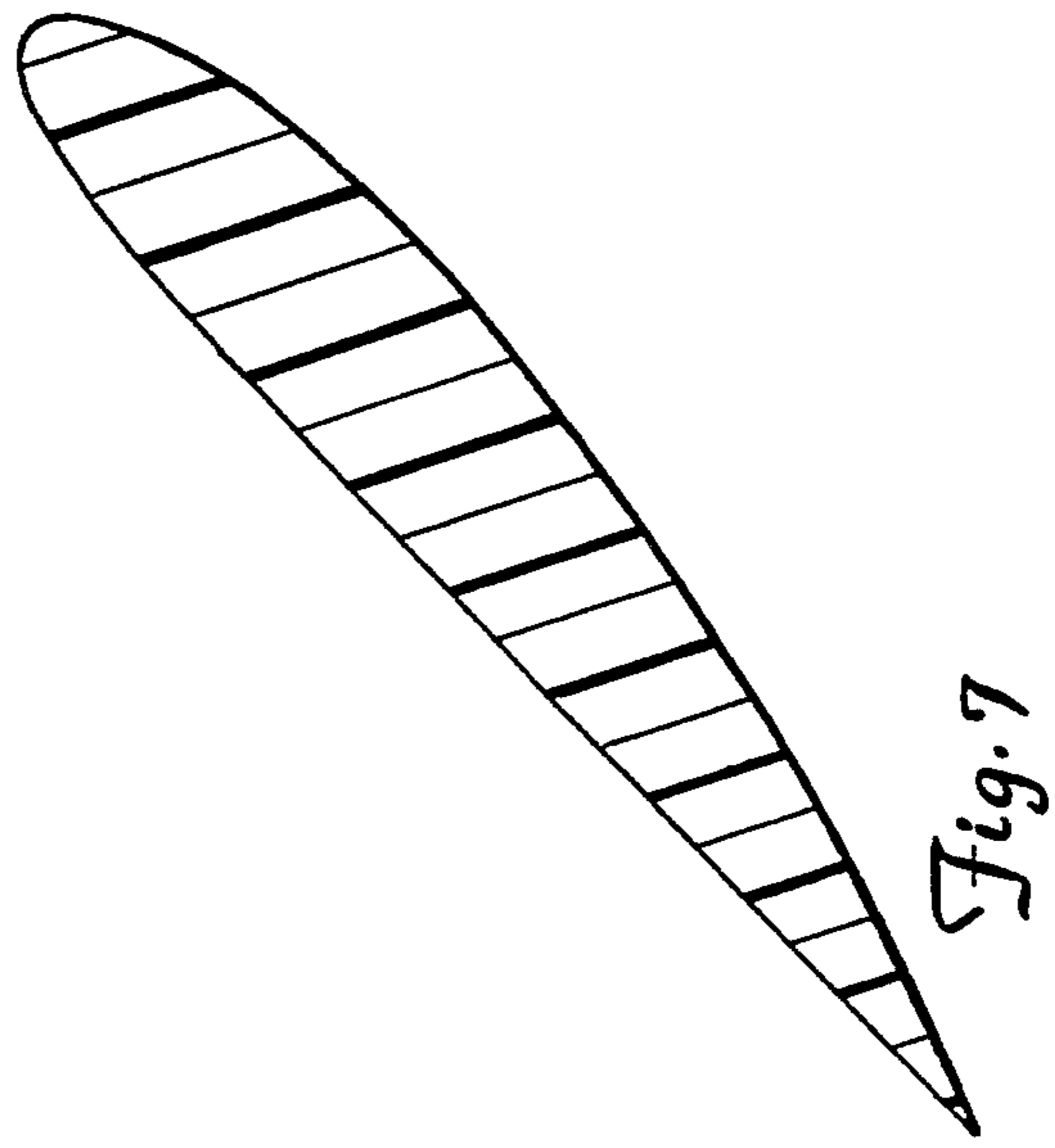

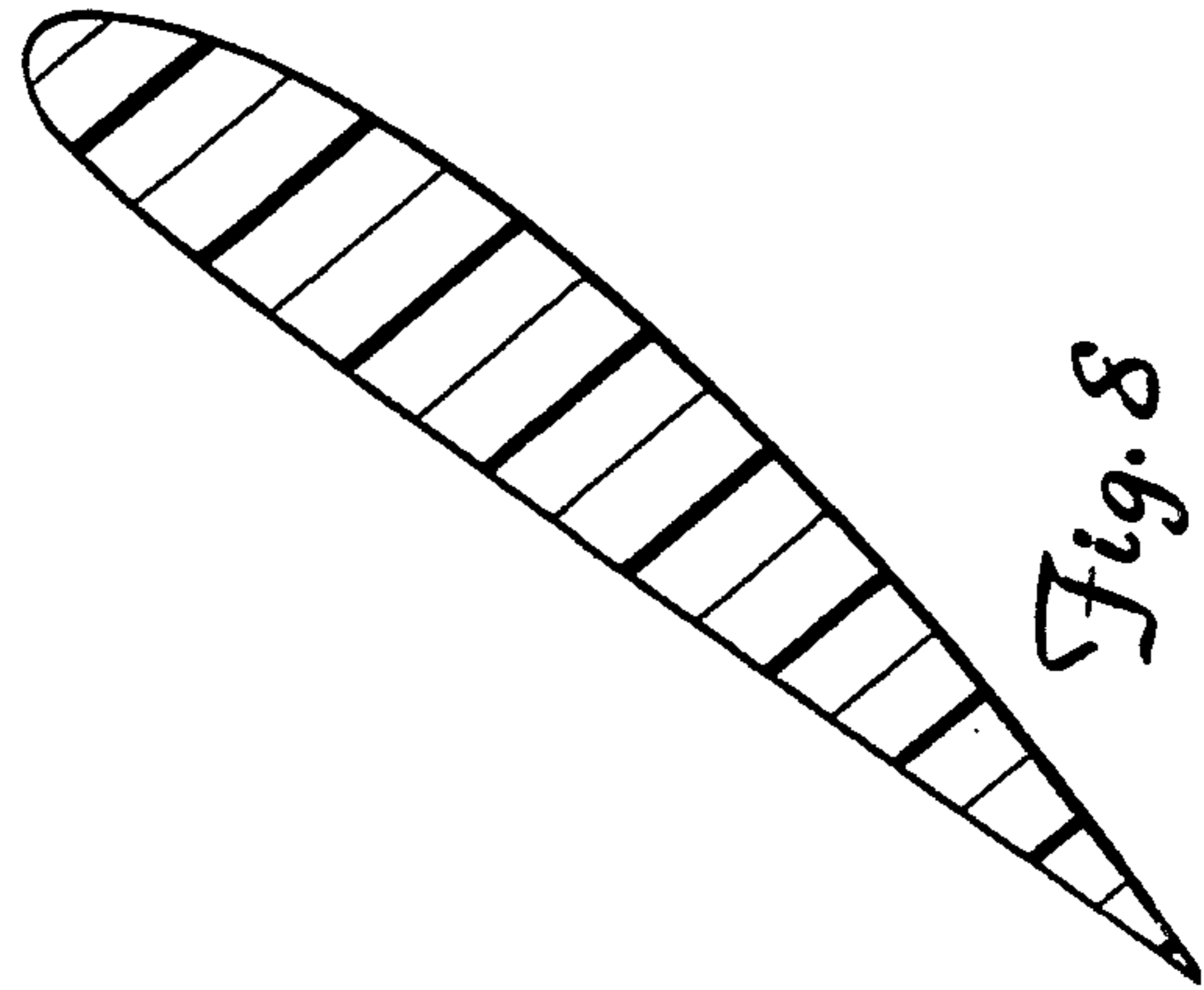

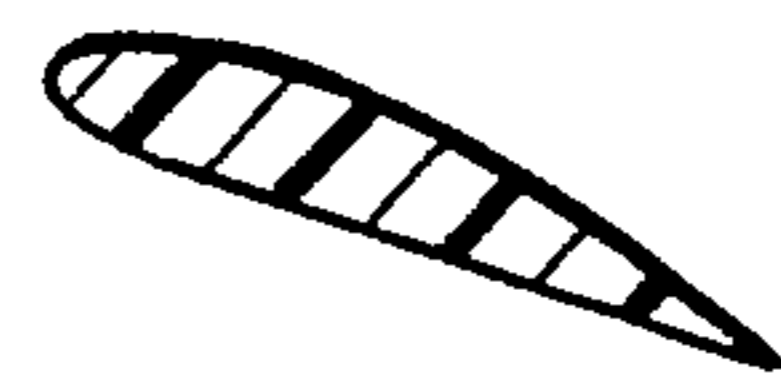
