FIG. 2 is a top plan view of the power station;

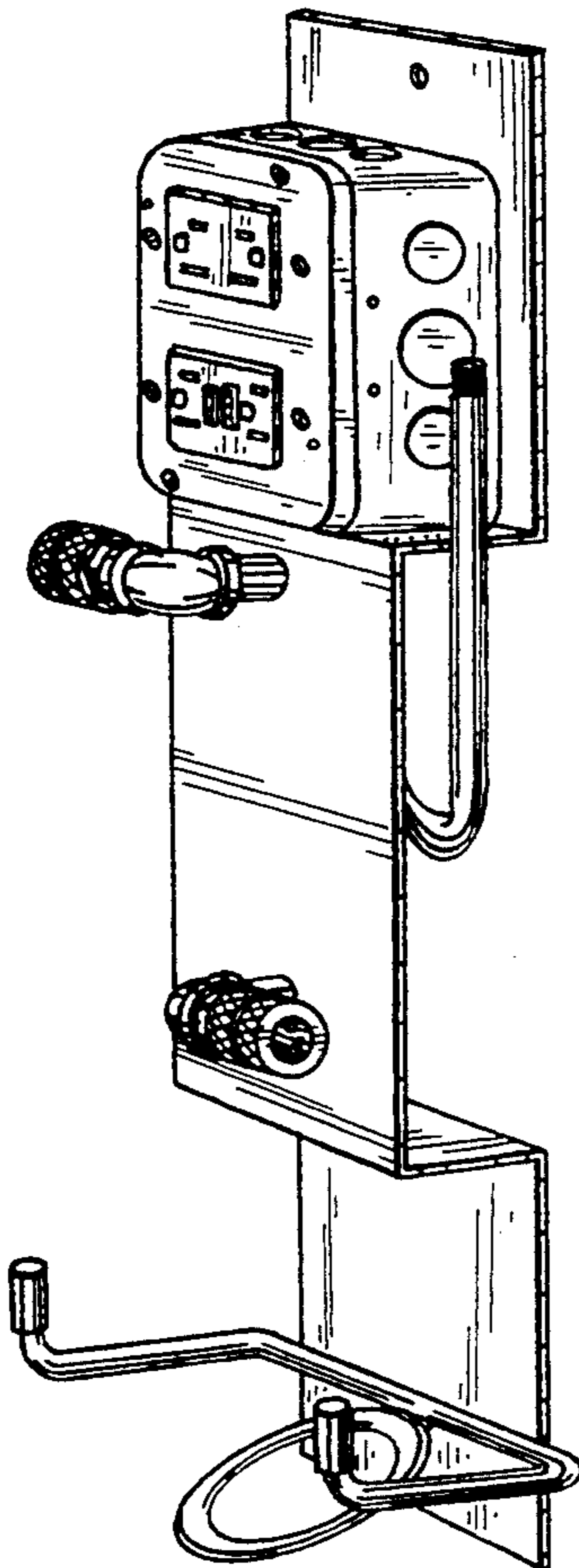
FIG. 3 is a front elevational view of the power station;

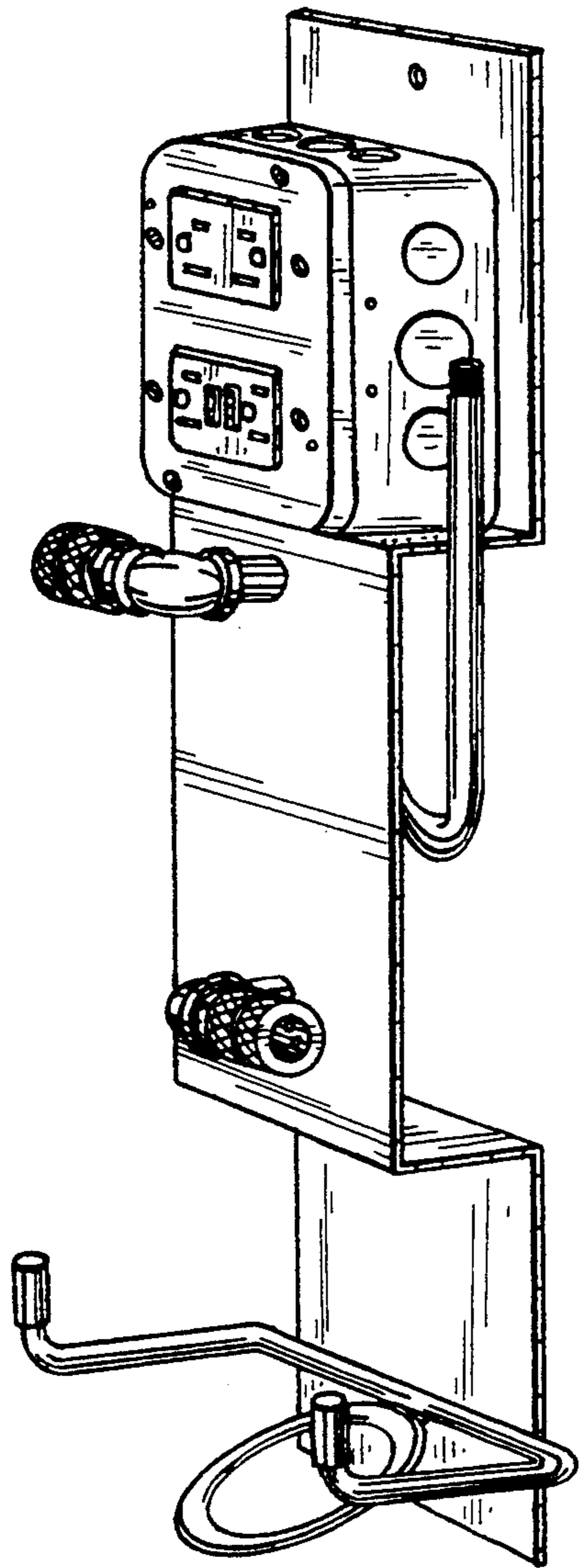
FIG. 4 is a right side elevational view of the power

FIG. 5 is a rear elevational view of the power station;

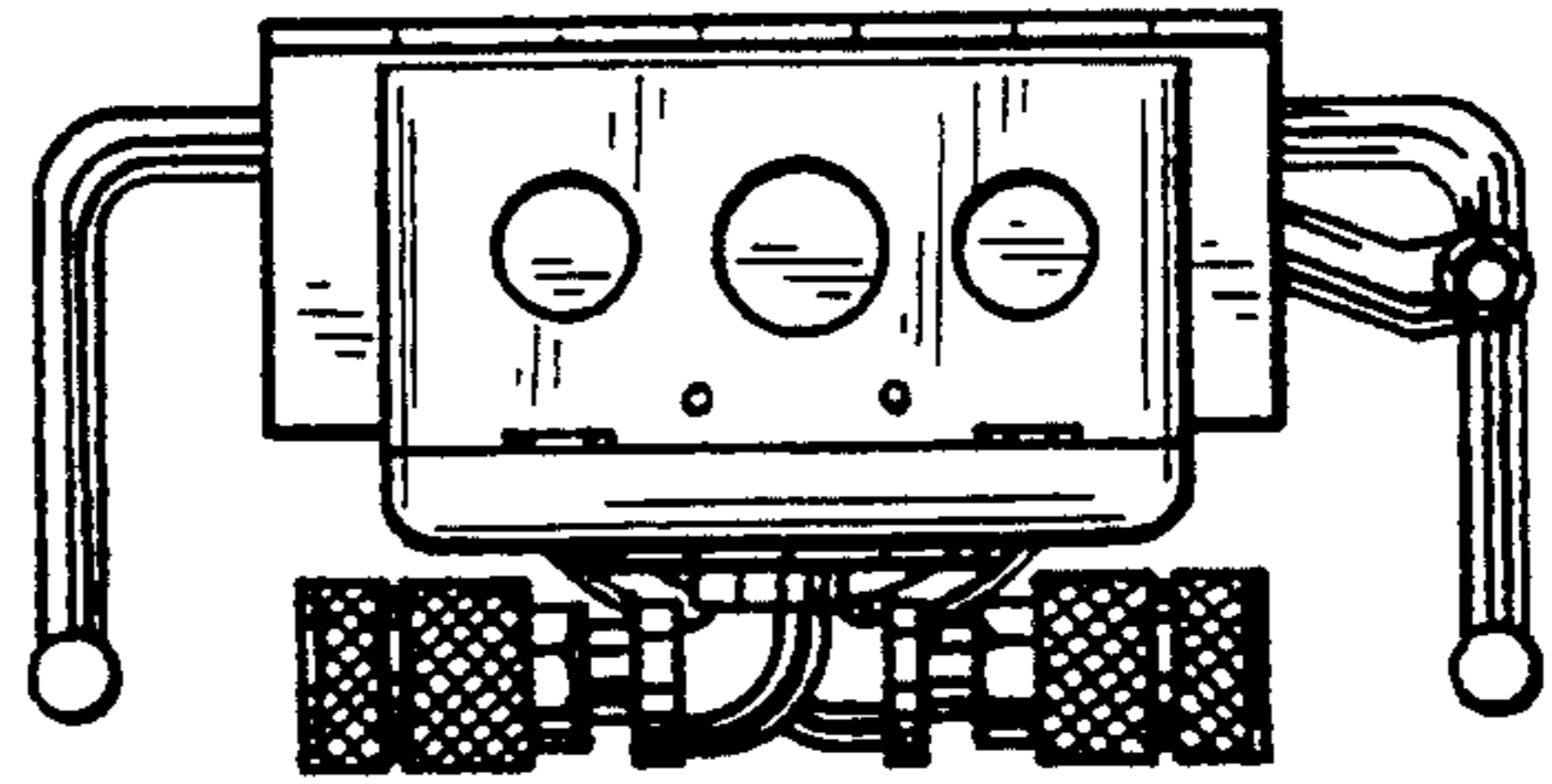
FIG. 6 is a left side elevational view of the power sta-

FIG. 7 is a bottom plan view of the power station.

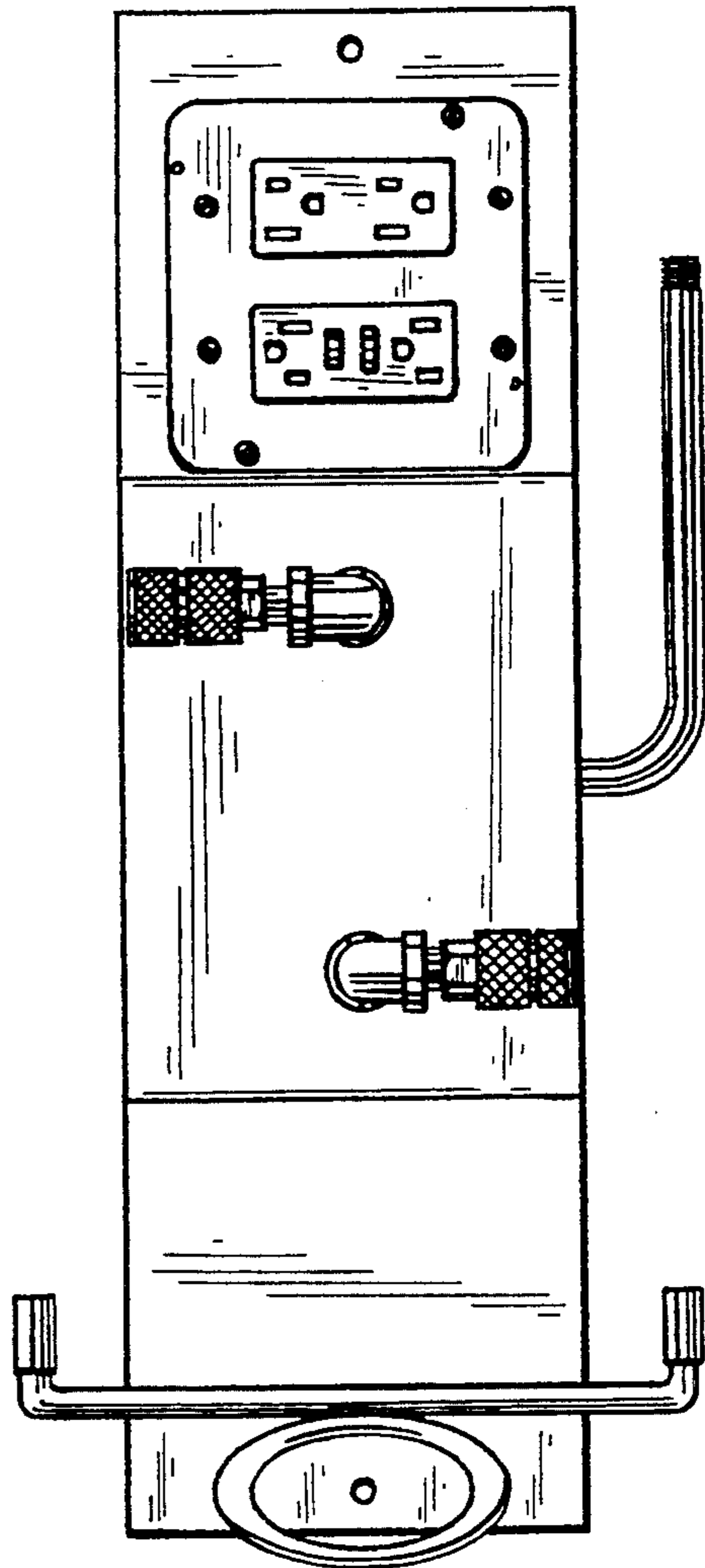




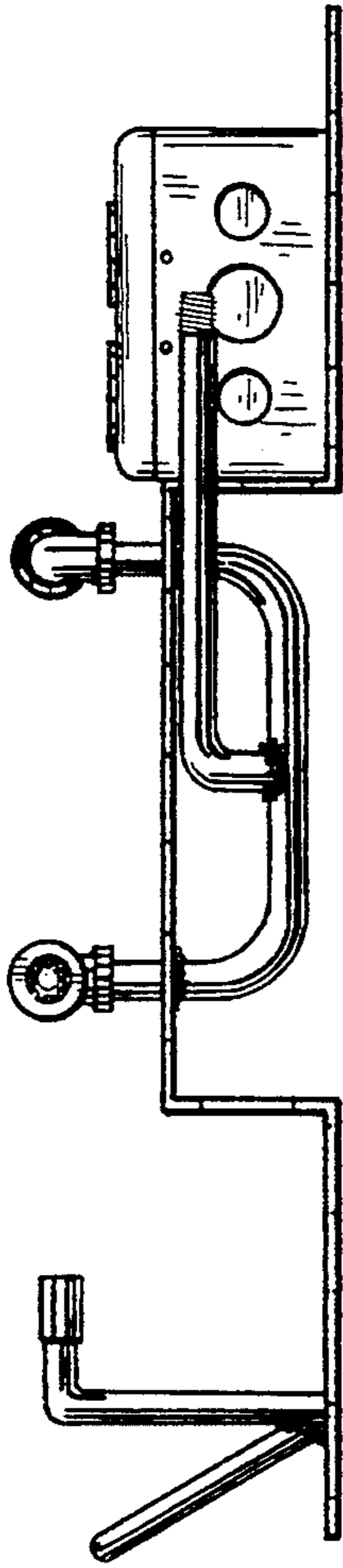

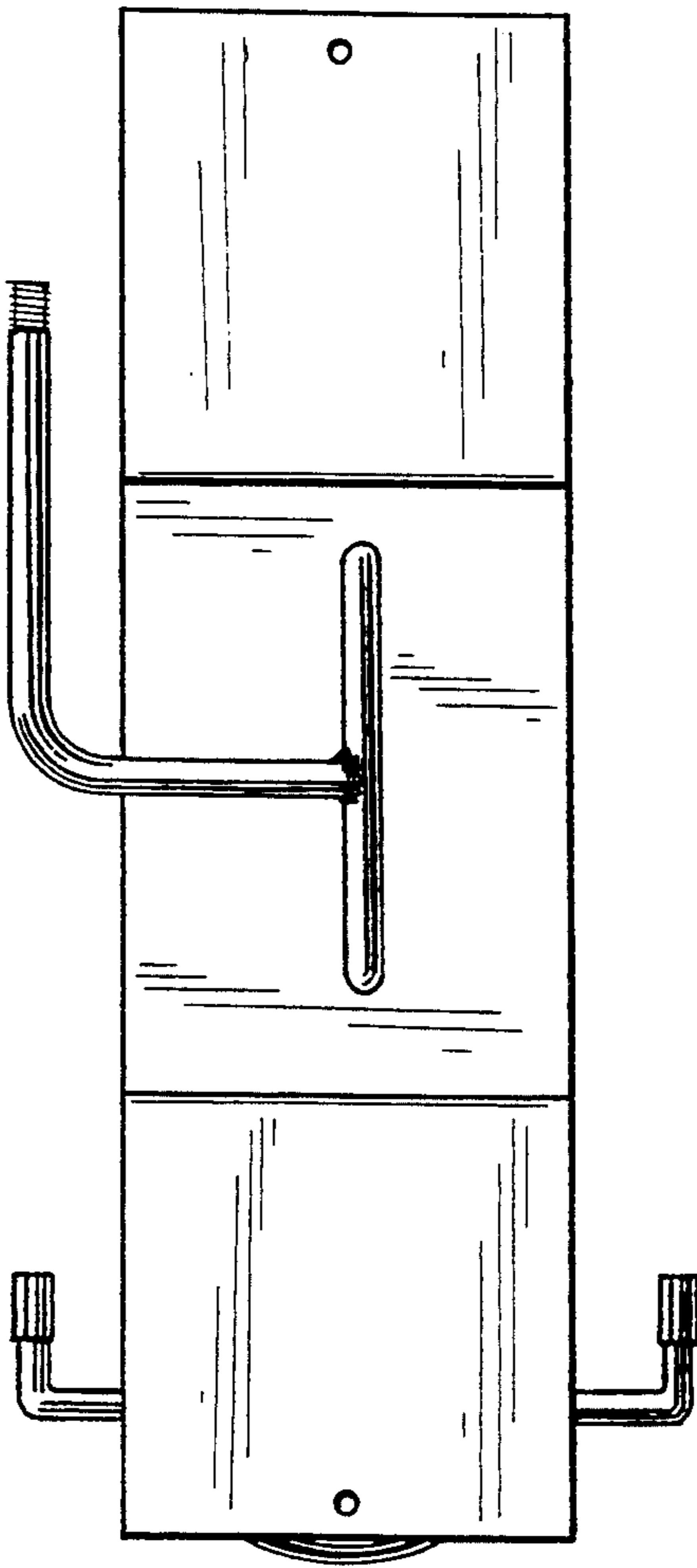

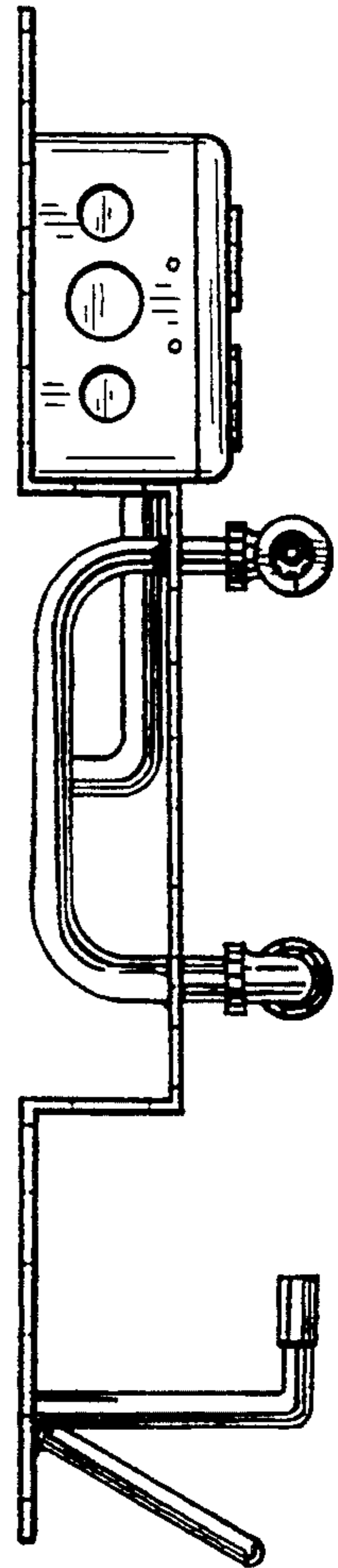

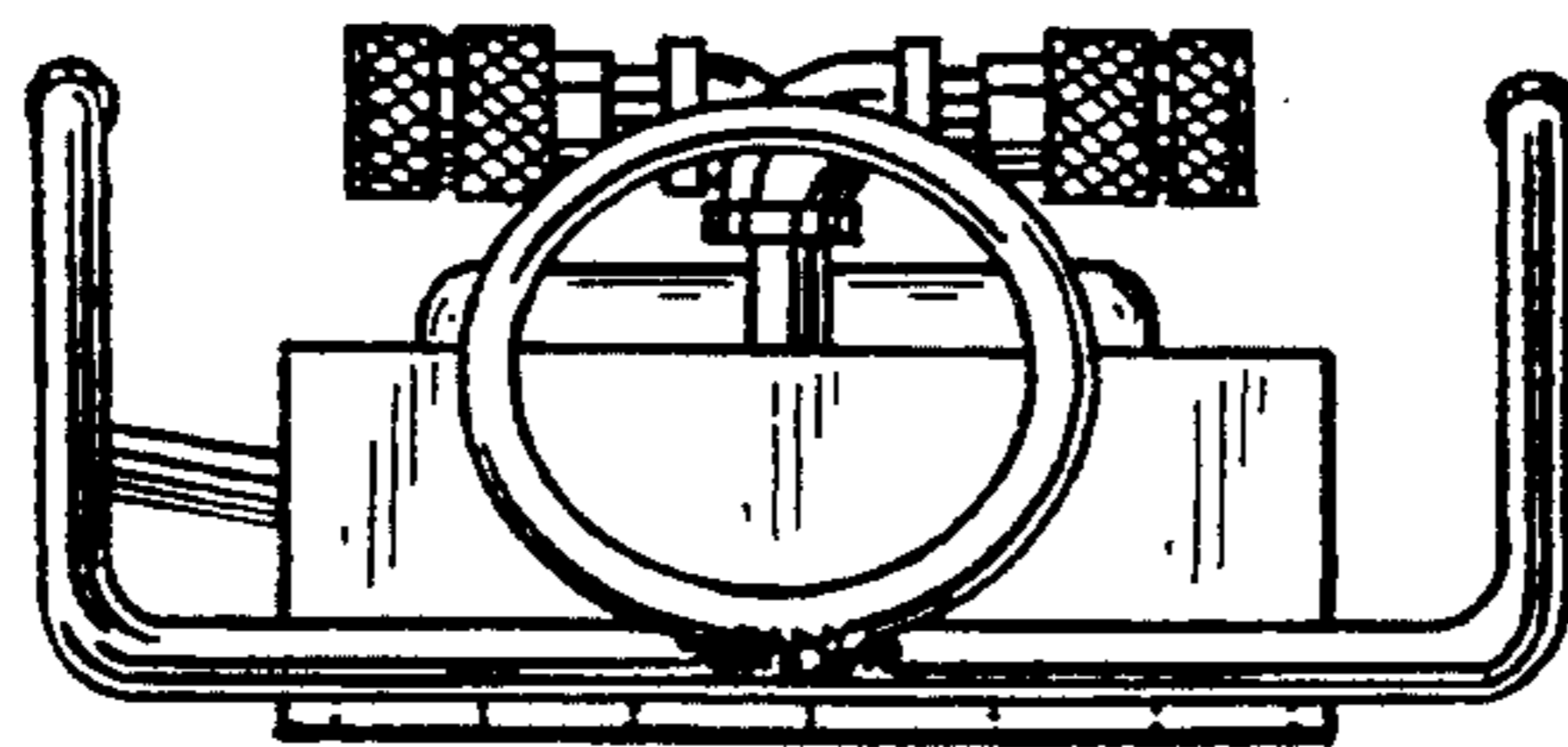
