[57] **CLAIM**

The ornamental design for an exercise step, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an exercise step showing my new design, in a first position; FIG. 2 is a front elevational view thereof, the rear view of the exercise step being a mirror image of the same; FIG. 3 is a side elevational view thereof, the opposite side view of the exercise step being a mirror image of the same; FIG. 4 is a bottom plan view thereof; FIG. 5 is a perspective view of the exercise step of FIG. 1 shown in a second position; FIG. 6 is a front elevational view thereof, the rear view of the exercise step being a mirror image of the same; FIG. 7 is a side elevational view thereof, the opposite side view of the exercise step being a mirror image of the same; FIG. 8 is a bottom plan view thereof;

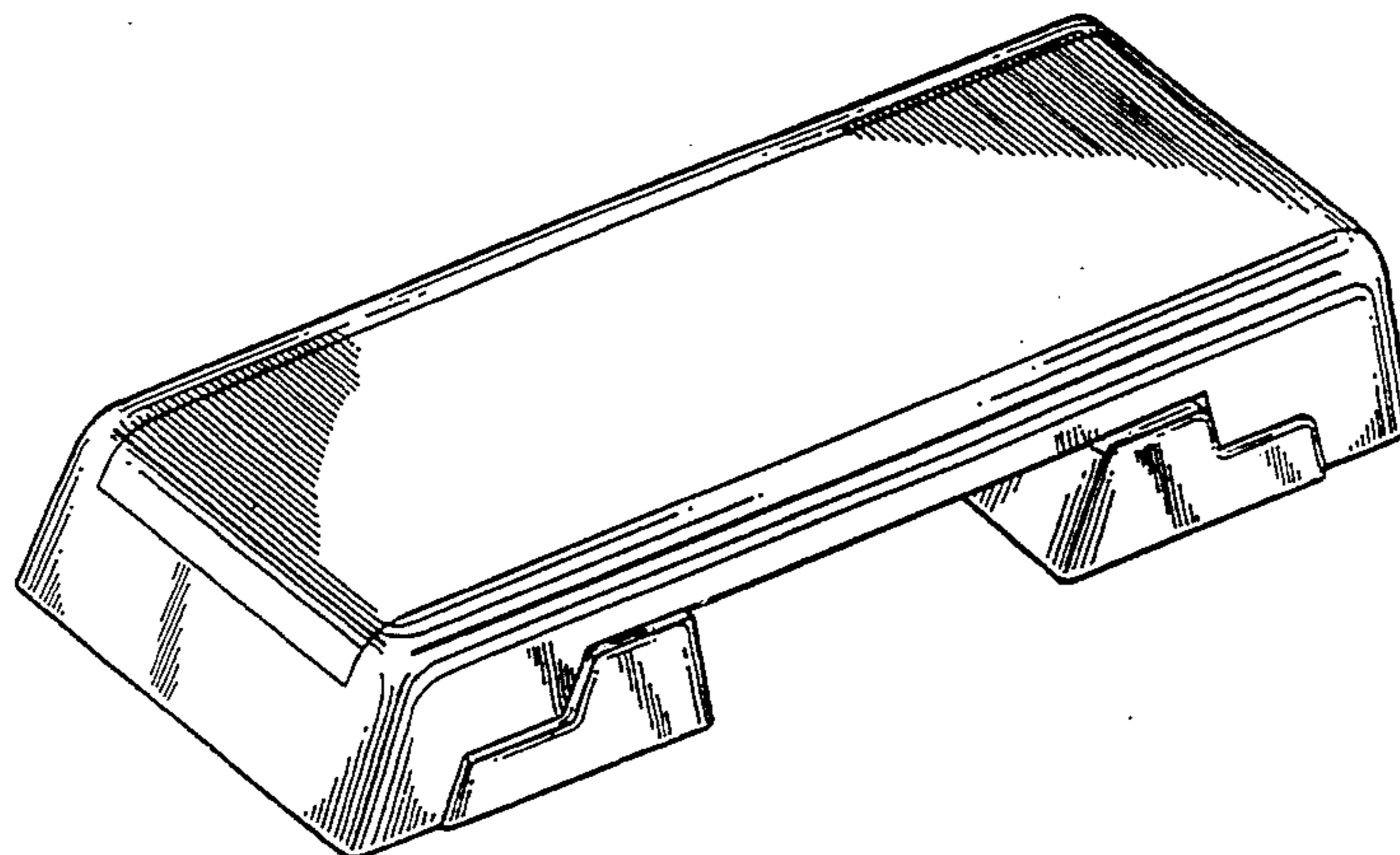


FIG. 9 is a perspective view of the exercise step of FIG. 1 shown in a third position;

FIG. 13 is a perspective view of the bench component of the exercise step of FIG. 1 shown separate for clarity of illustration;

FIG. 14 is a front elevational view thereof, the rear view of the bench component being a mirror image of the same;

FIG. 15 is a side elevational view thereof, the opposite

side view of the bench component being a mirror image of the same;

FIG. 16 is a perspective view of the leg component of the exercise step shown in FIG. 1 shown separate for clarity of illustration;

FIG. 17 is a front elevational view thereof;

FIG. 18 is a rear elevational view thereof;

FIG. 19 is a side elevational view thereof, the opposite side view of the leg component being a mirror image of the same;

FIG. 20 is a top plan view thereof; and,

FIG. 21 is a bottom plan view thereof.

The broken line showing of the connectors of the leg component in FIGS. 16-21 is environmental only and forms no part of the claimed design.

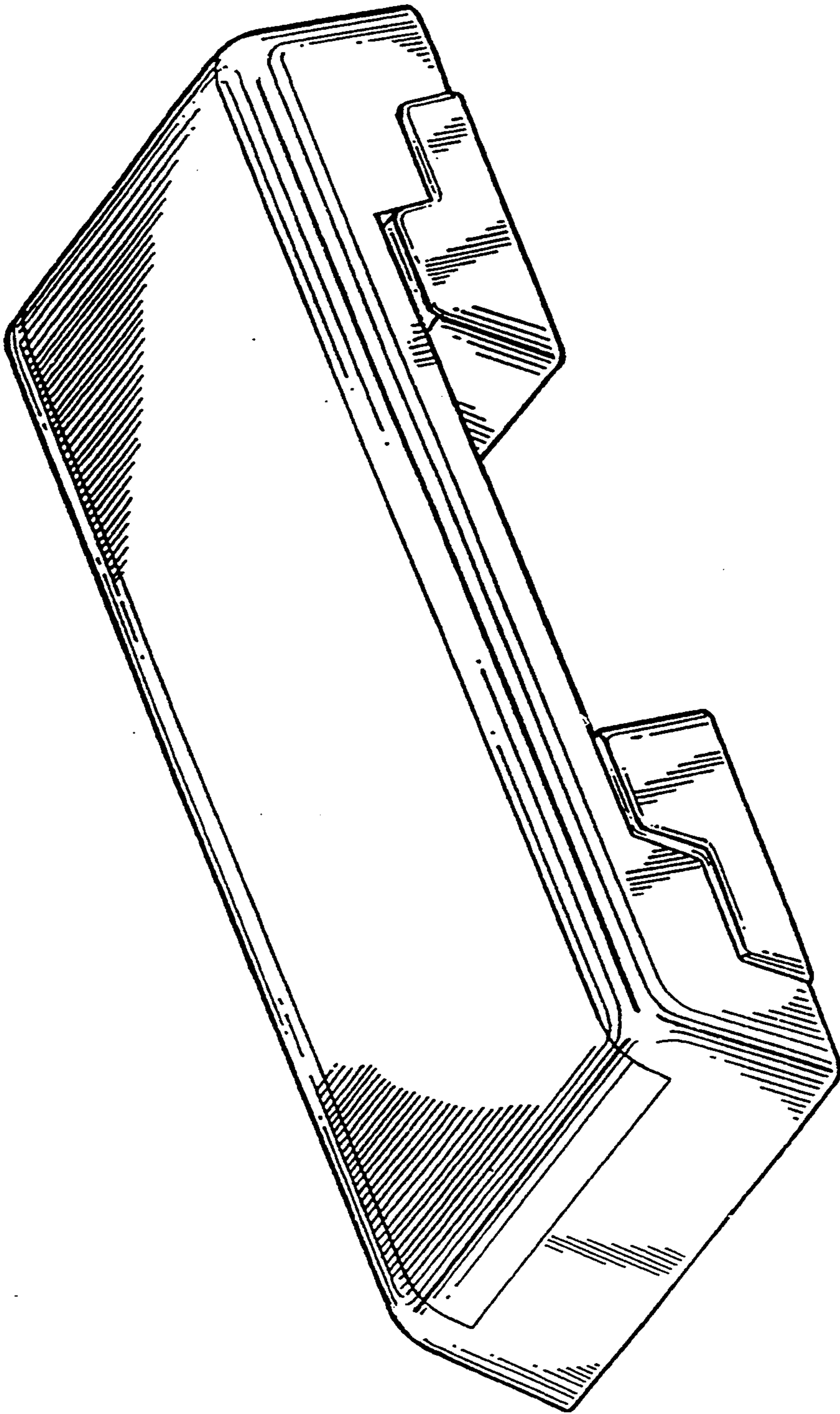

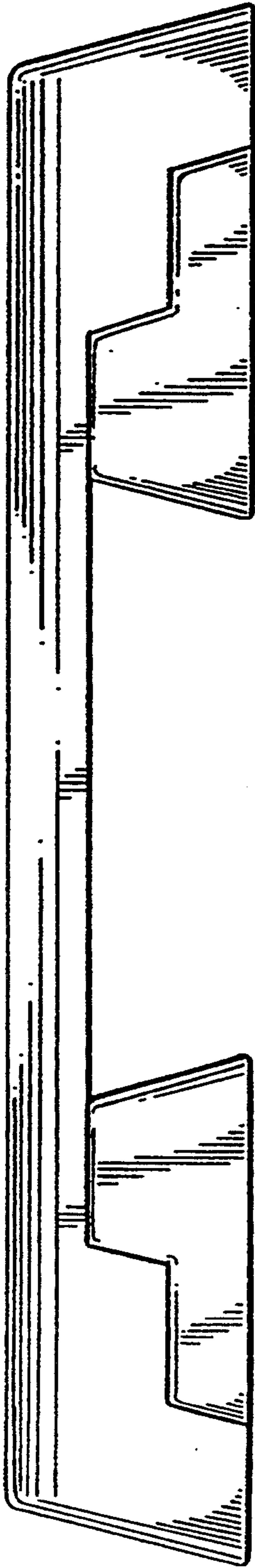

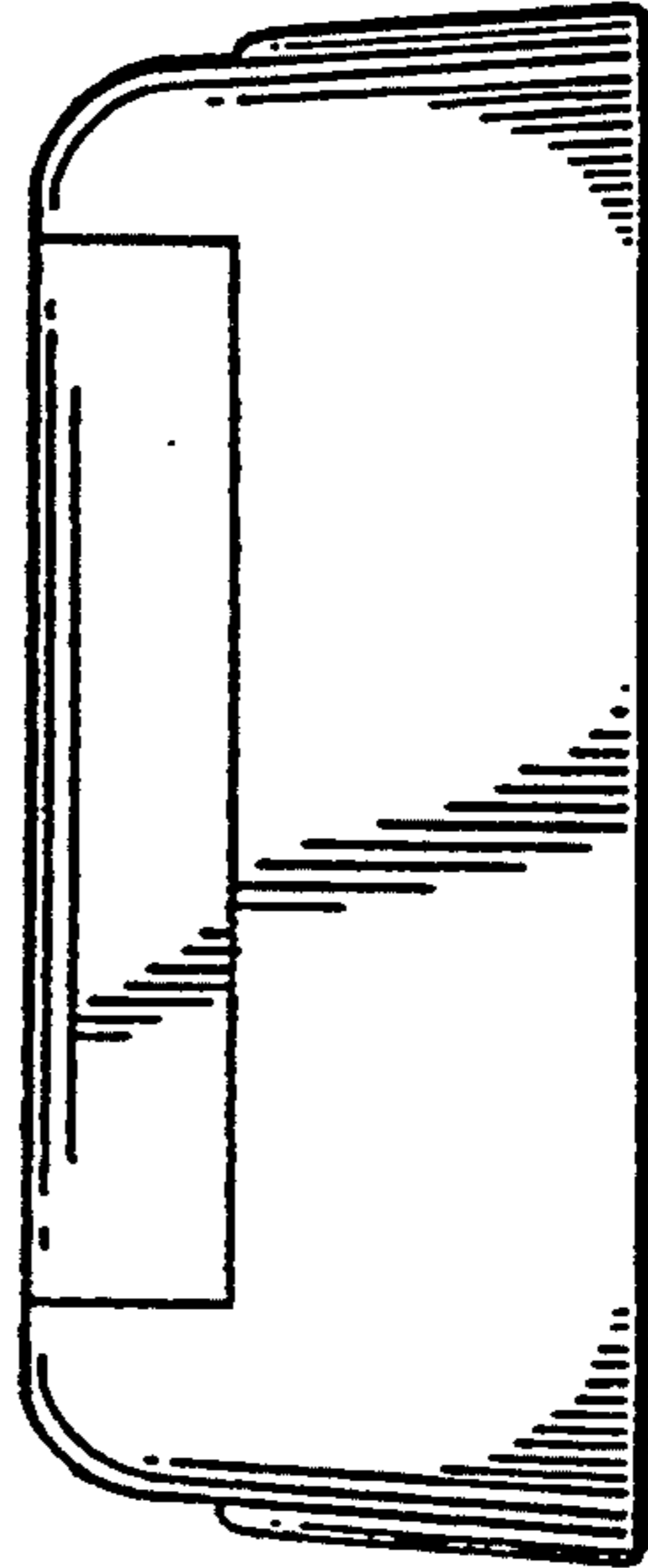

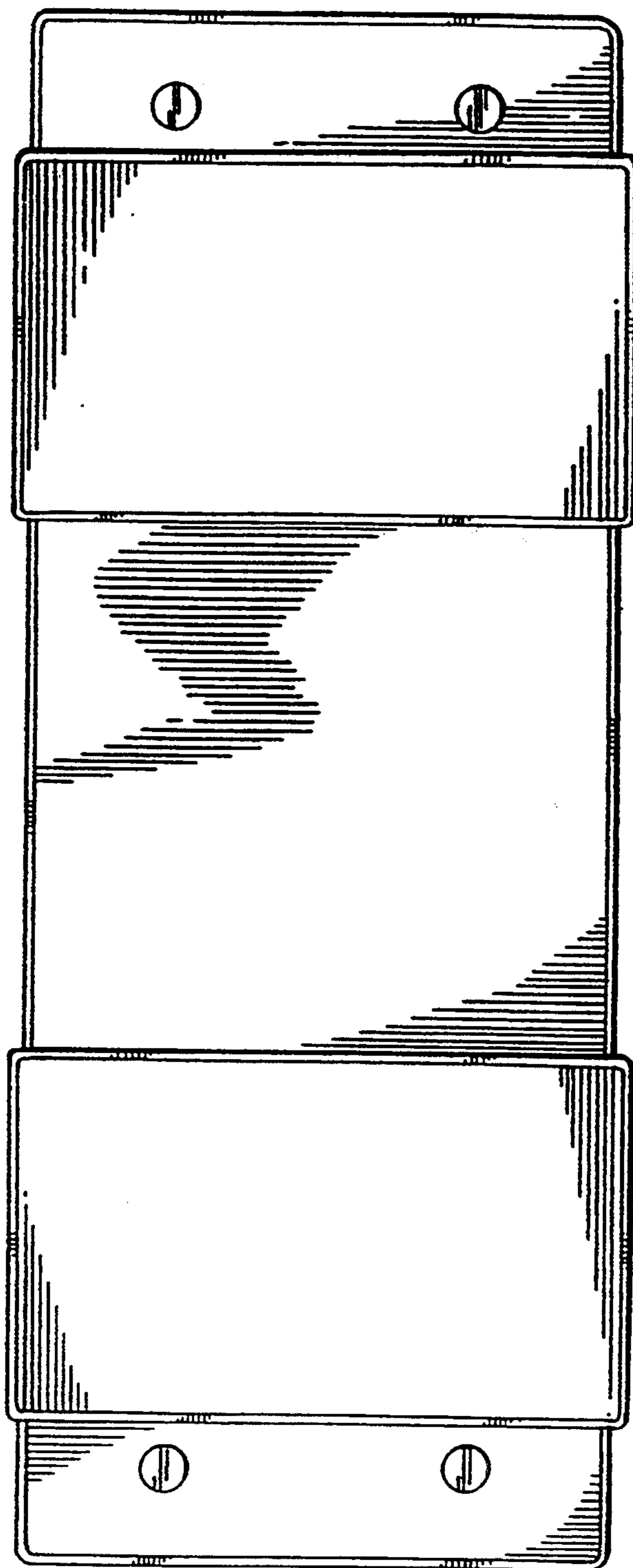

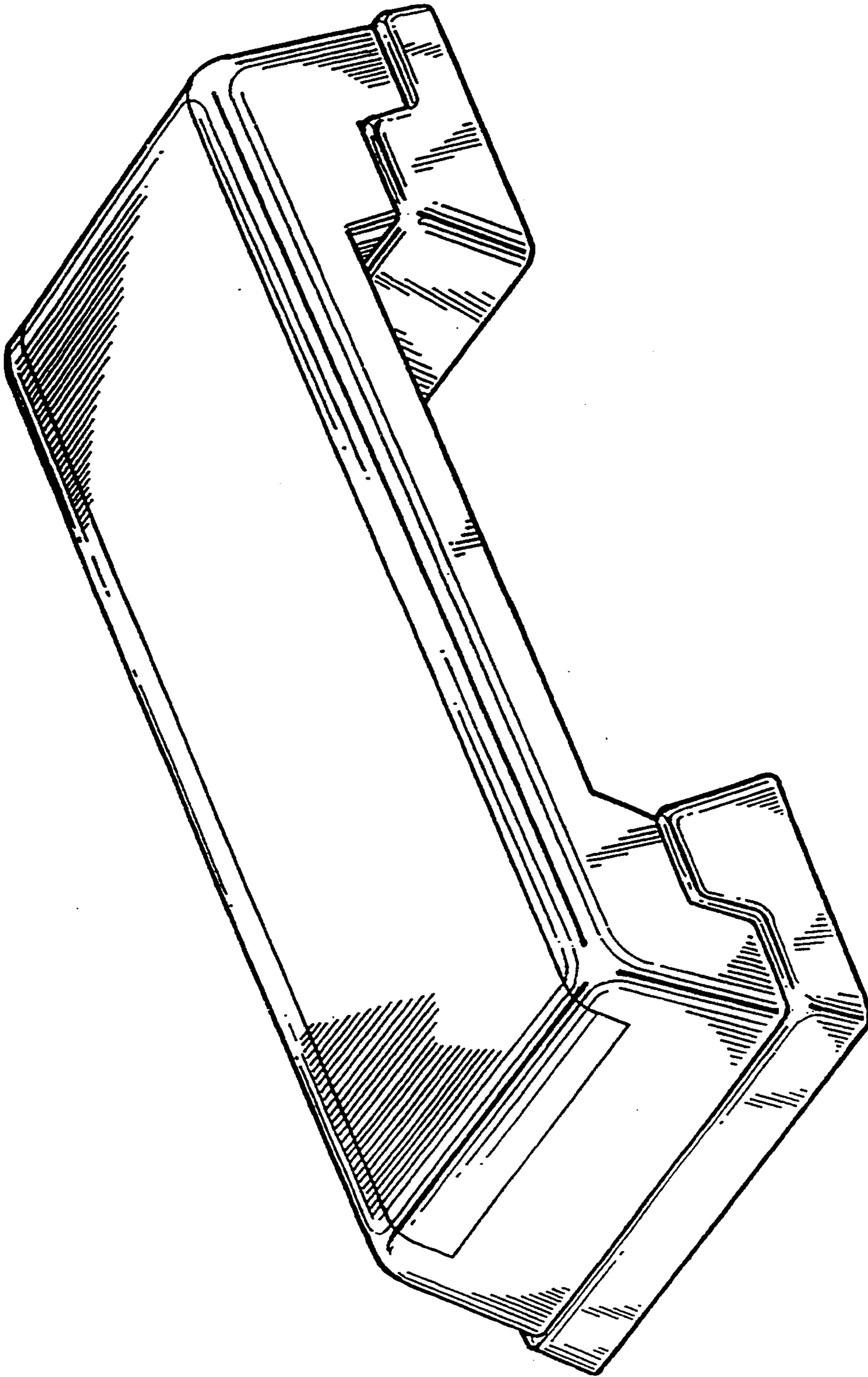

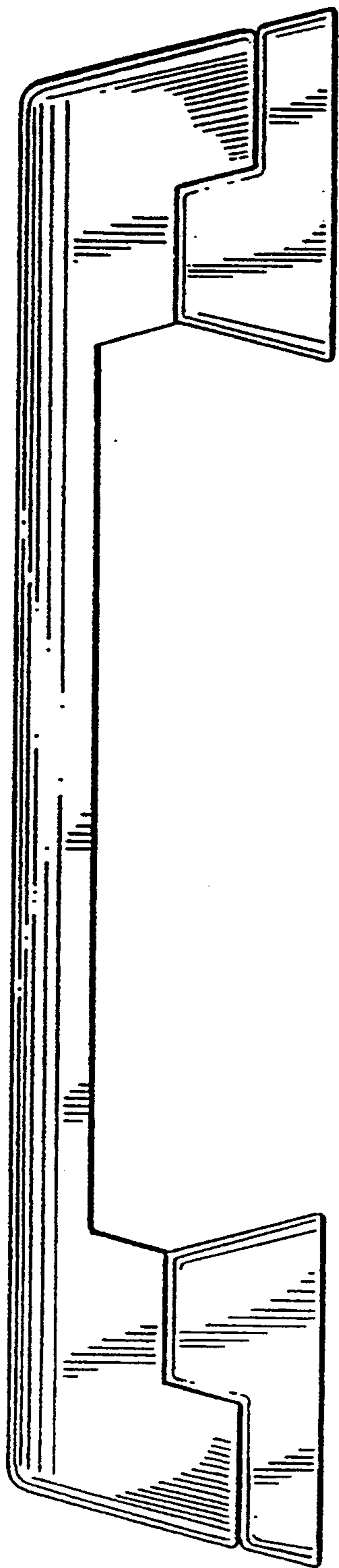

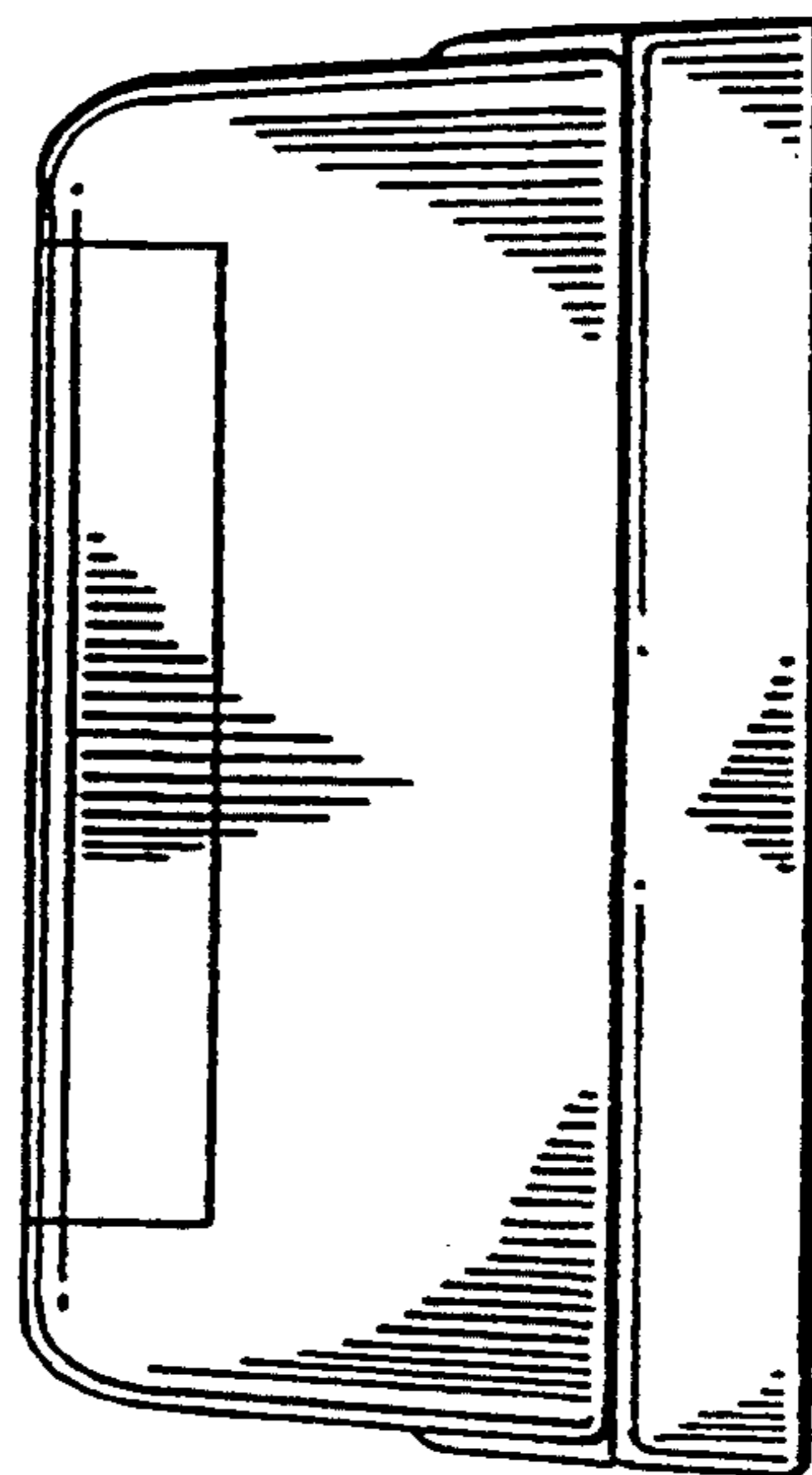

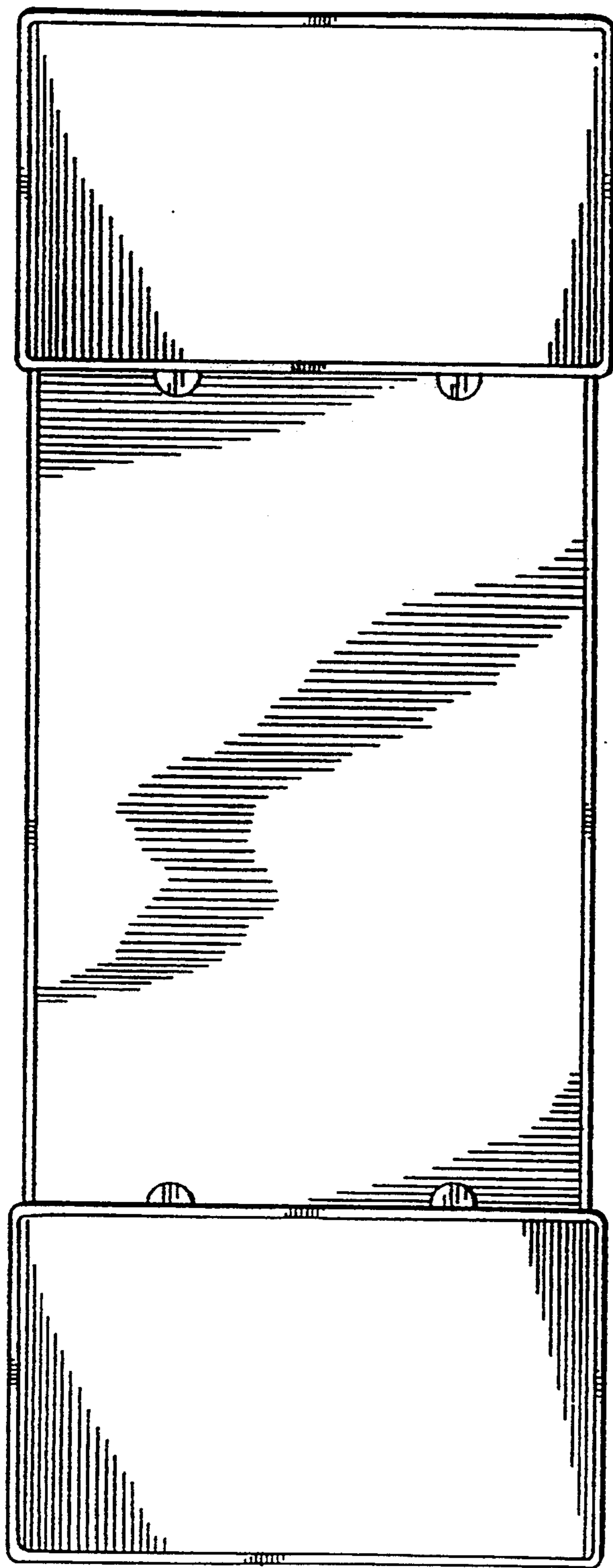

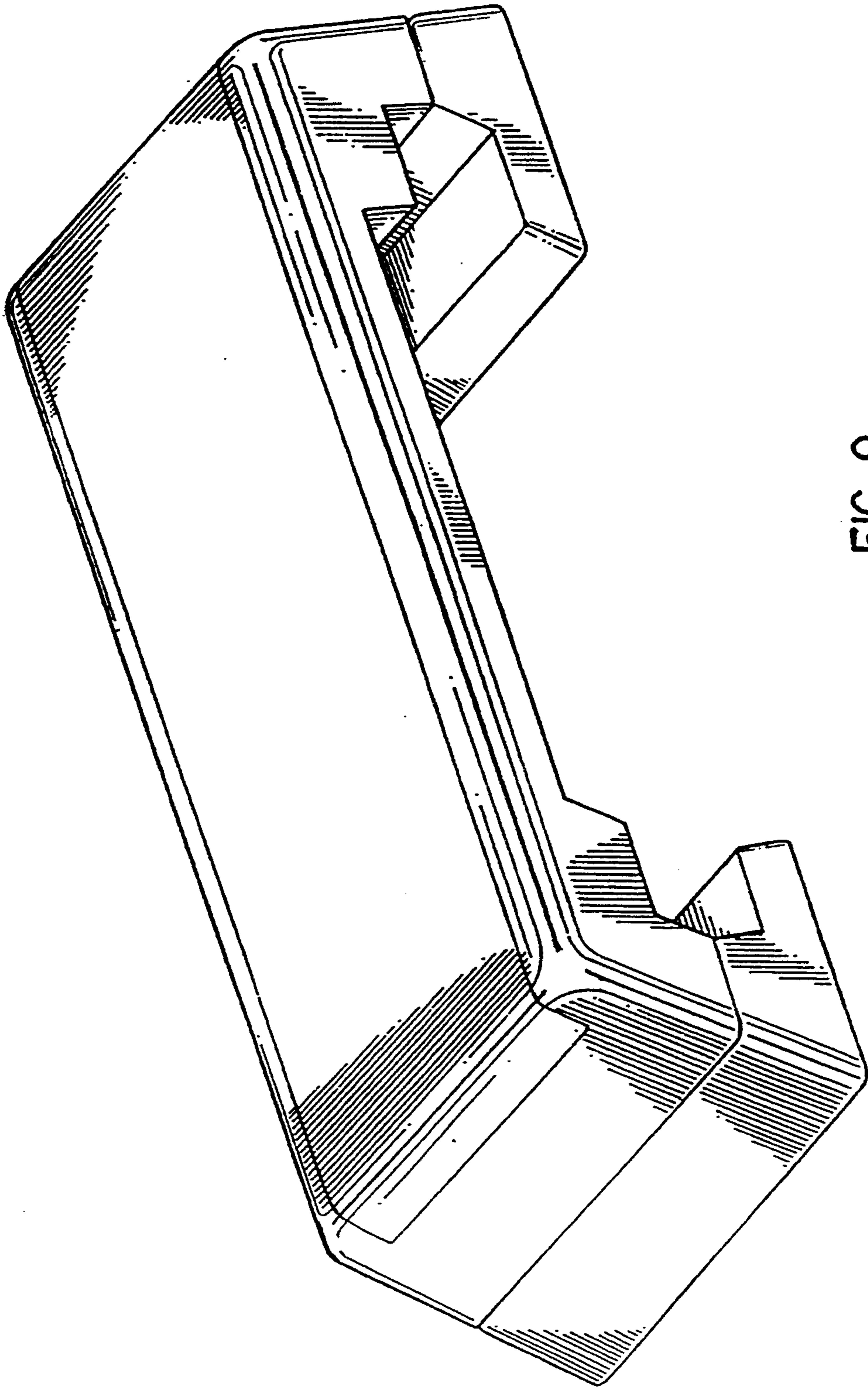

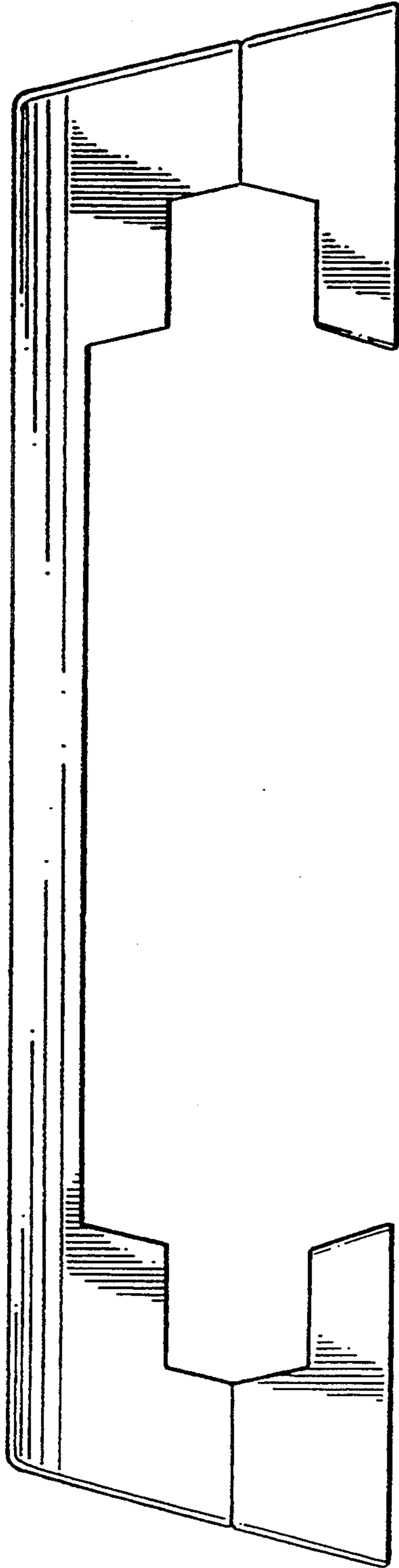

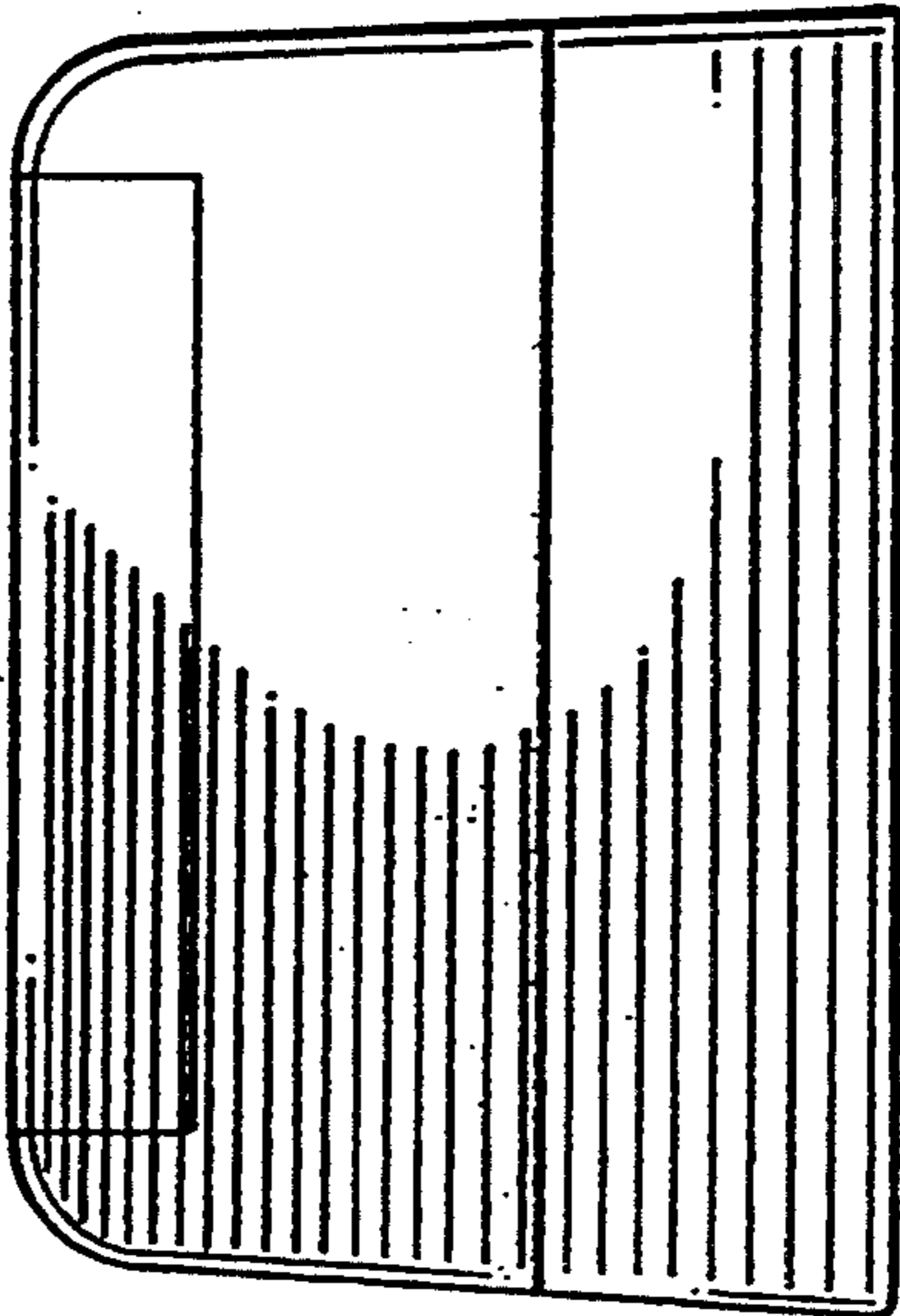

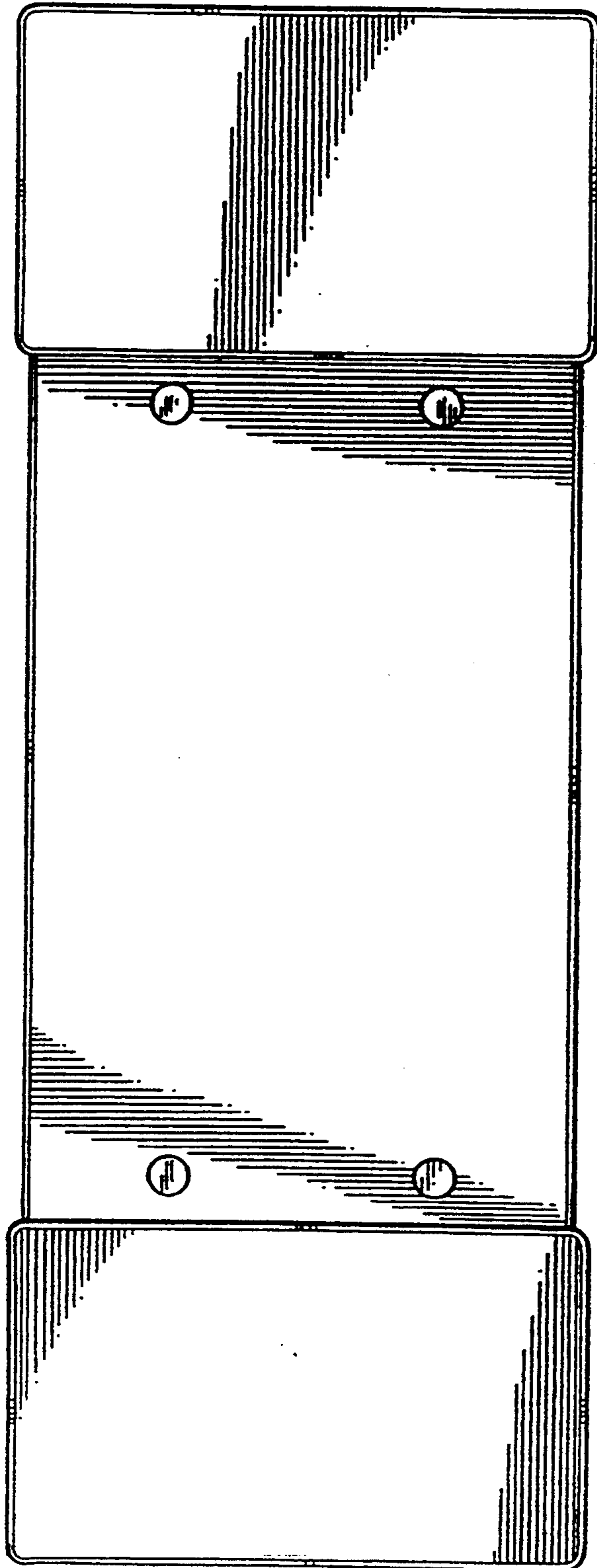

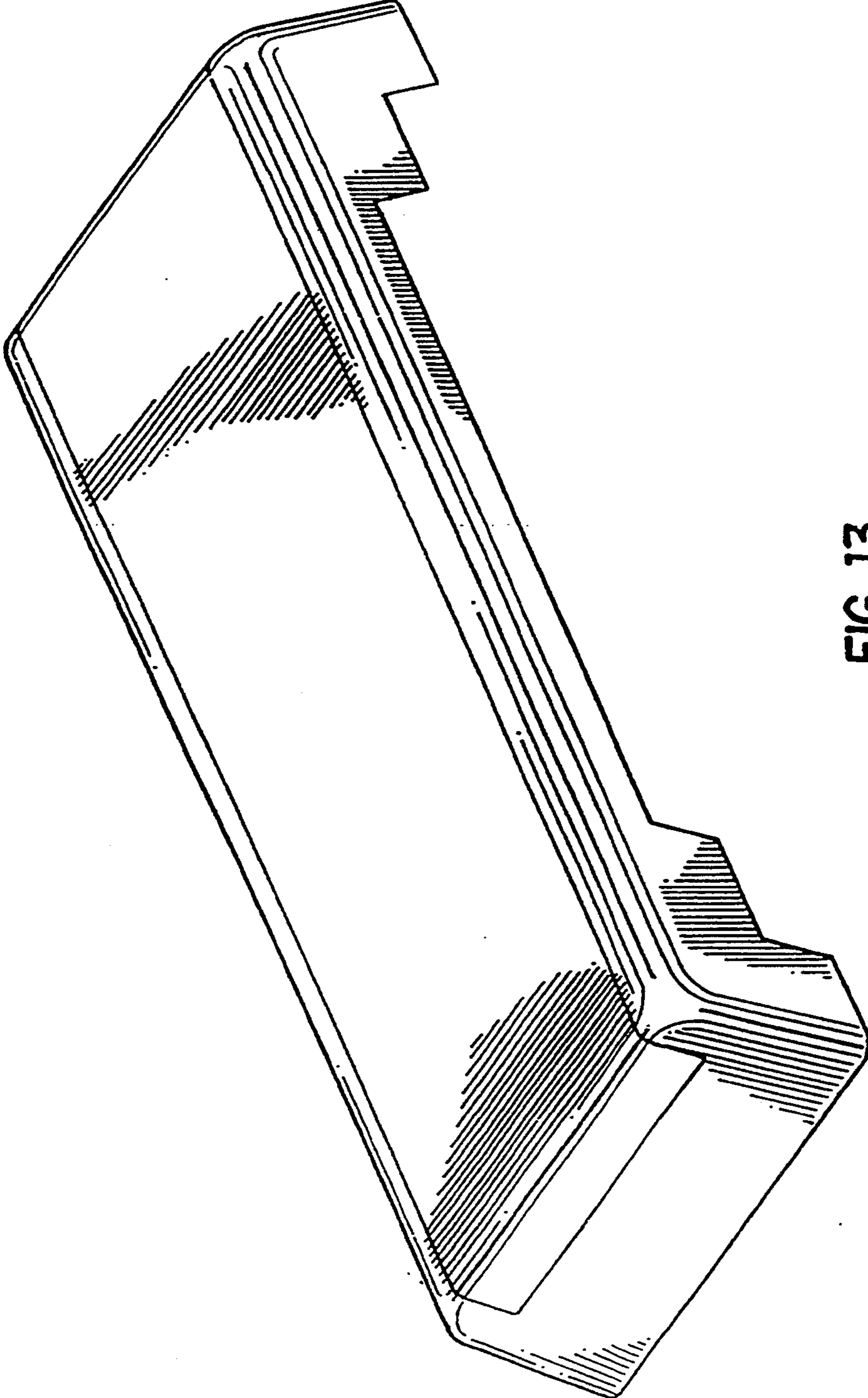

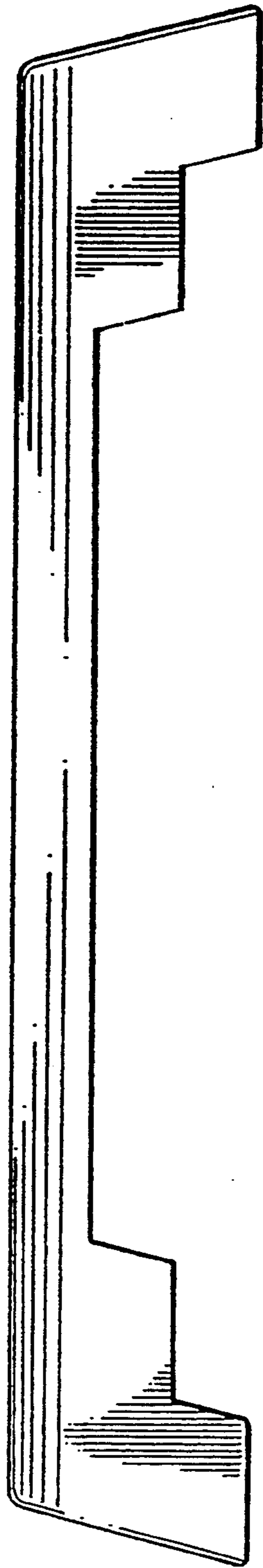

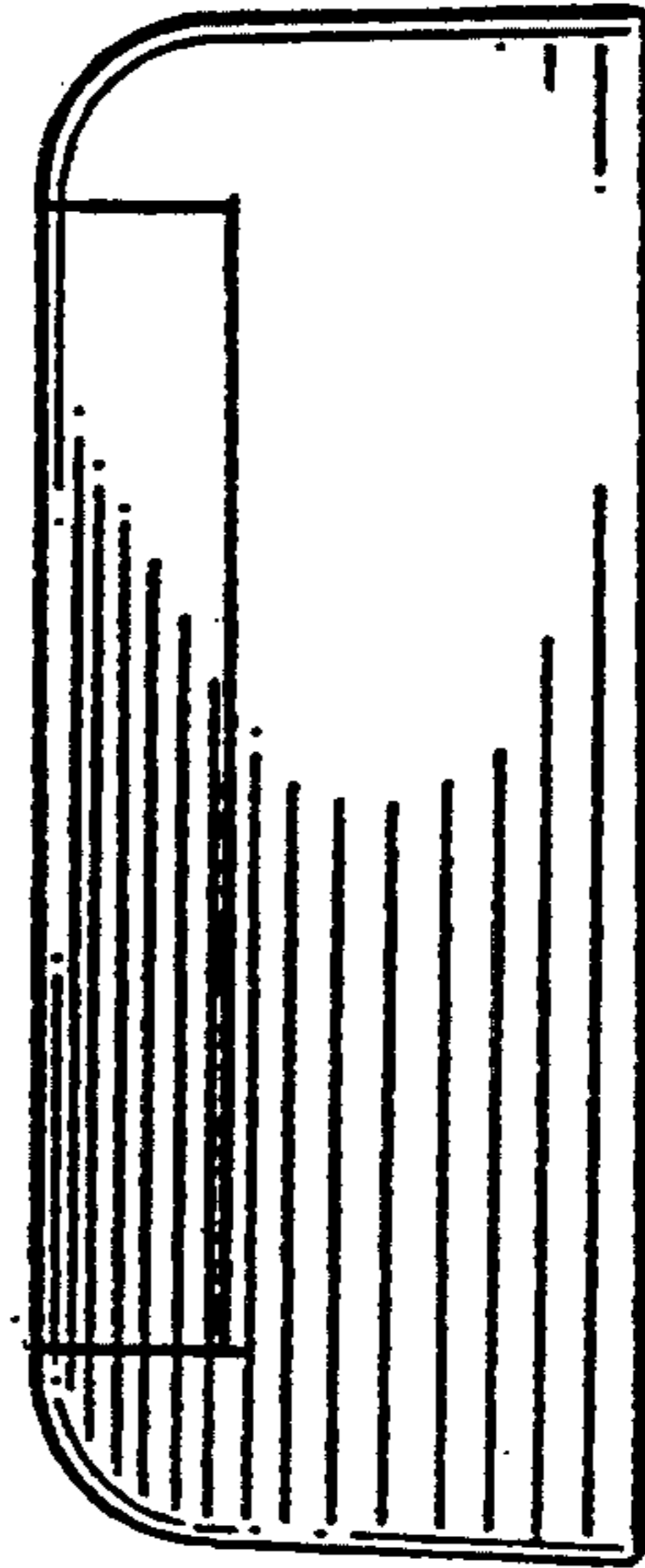

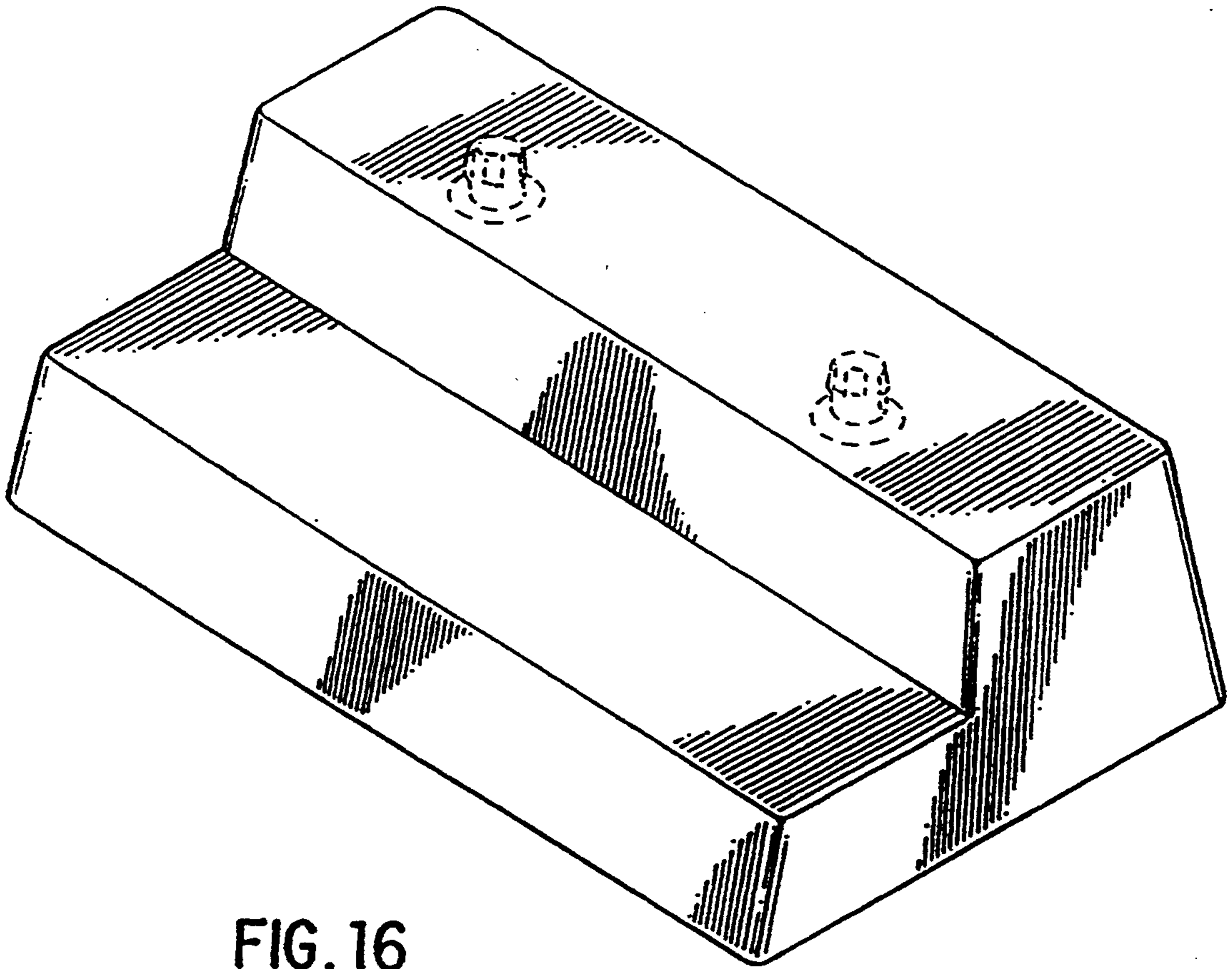

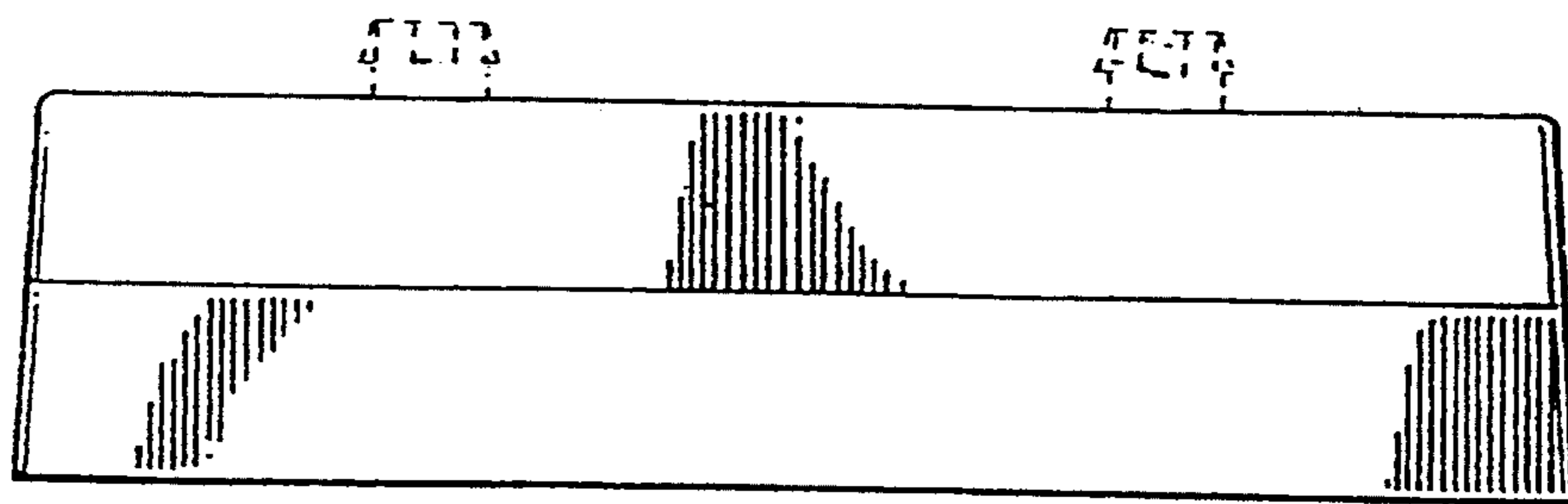

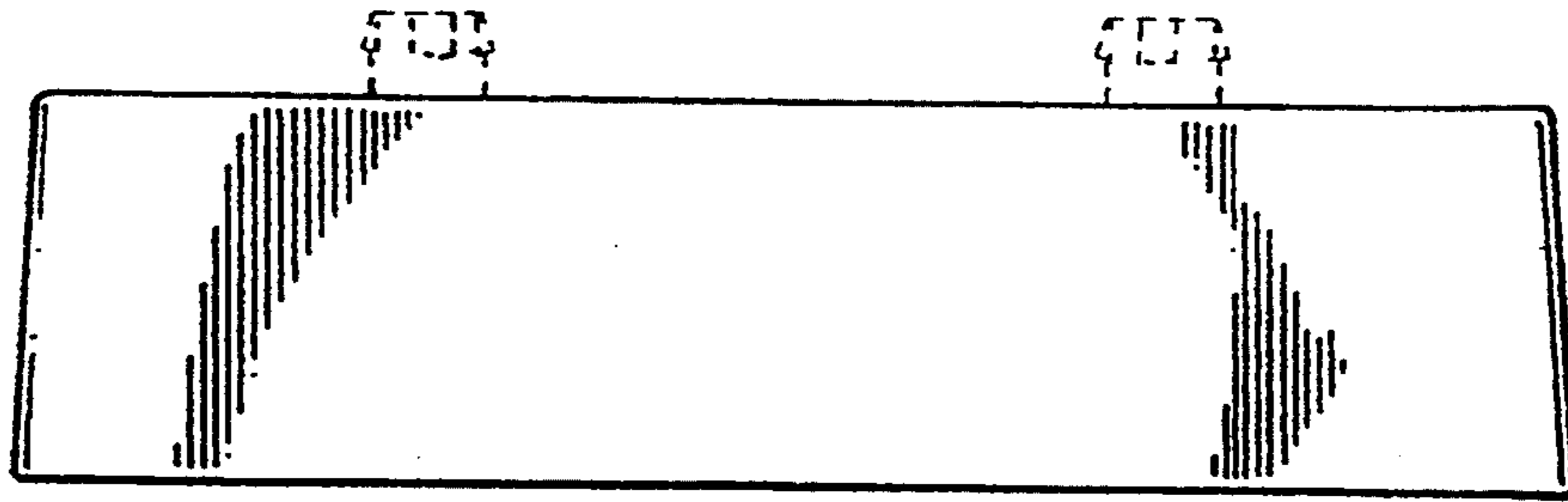

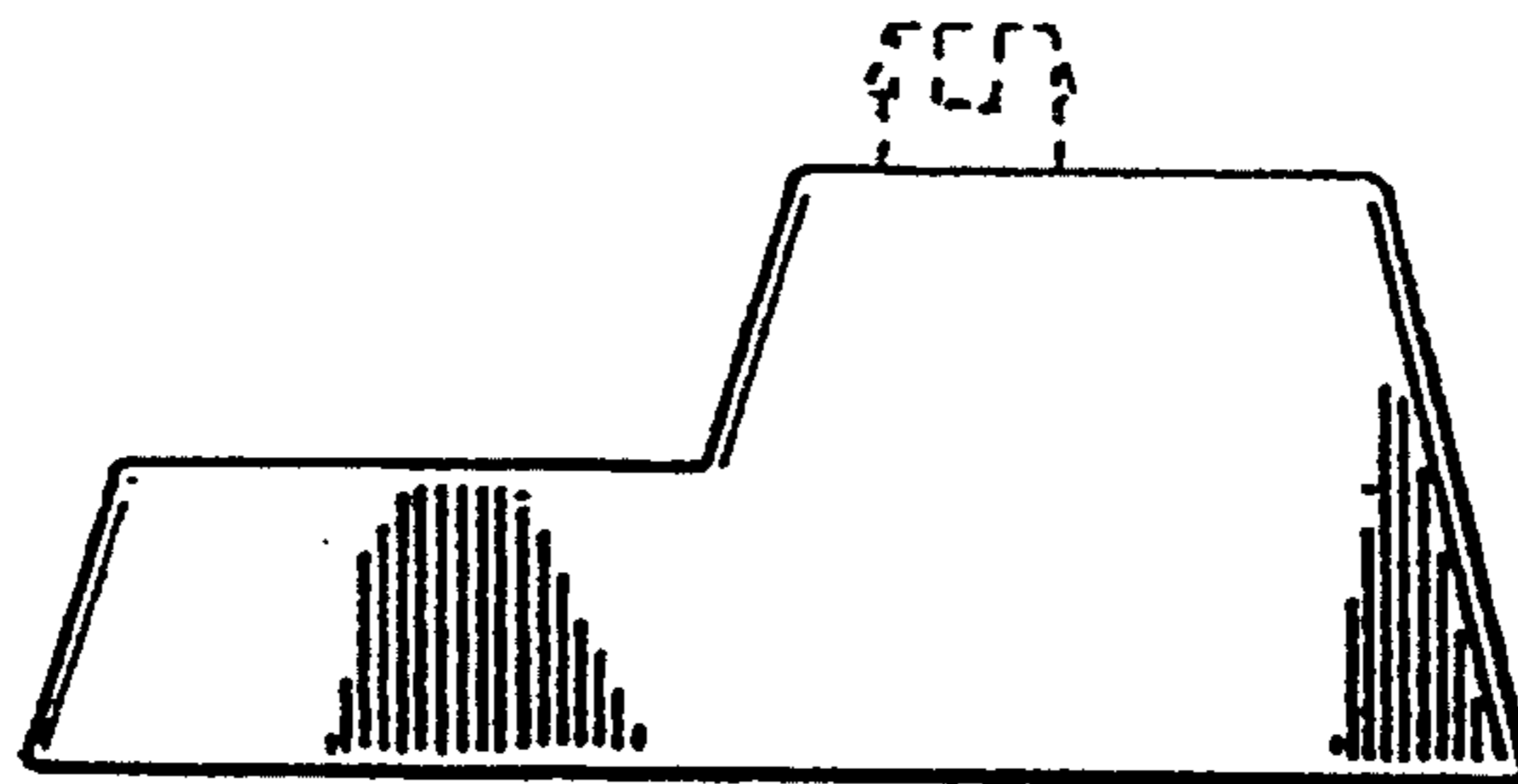

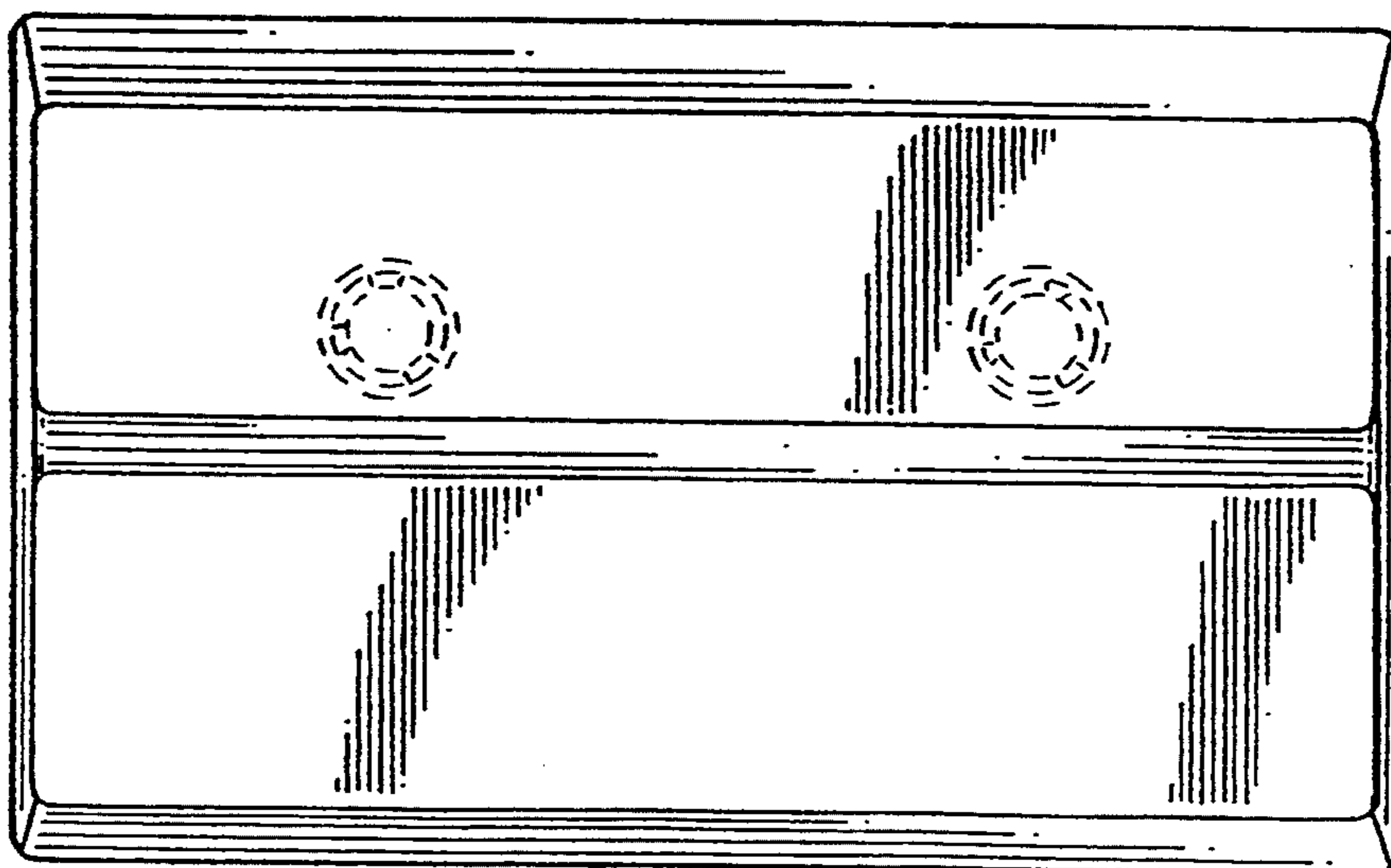

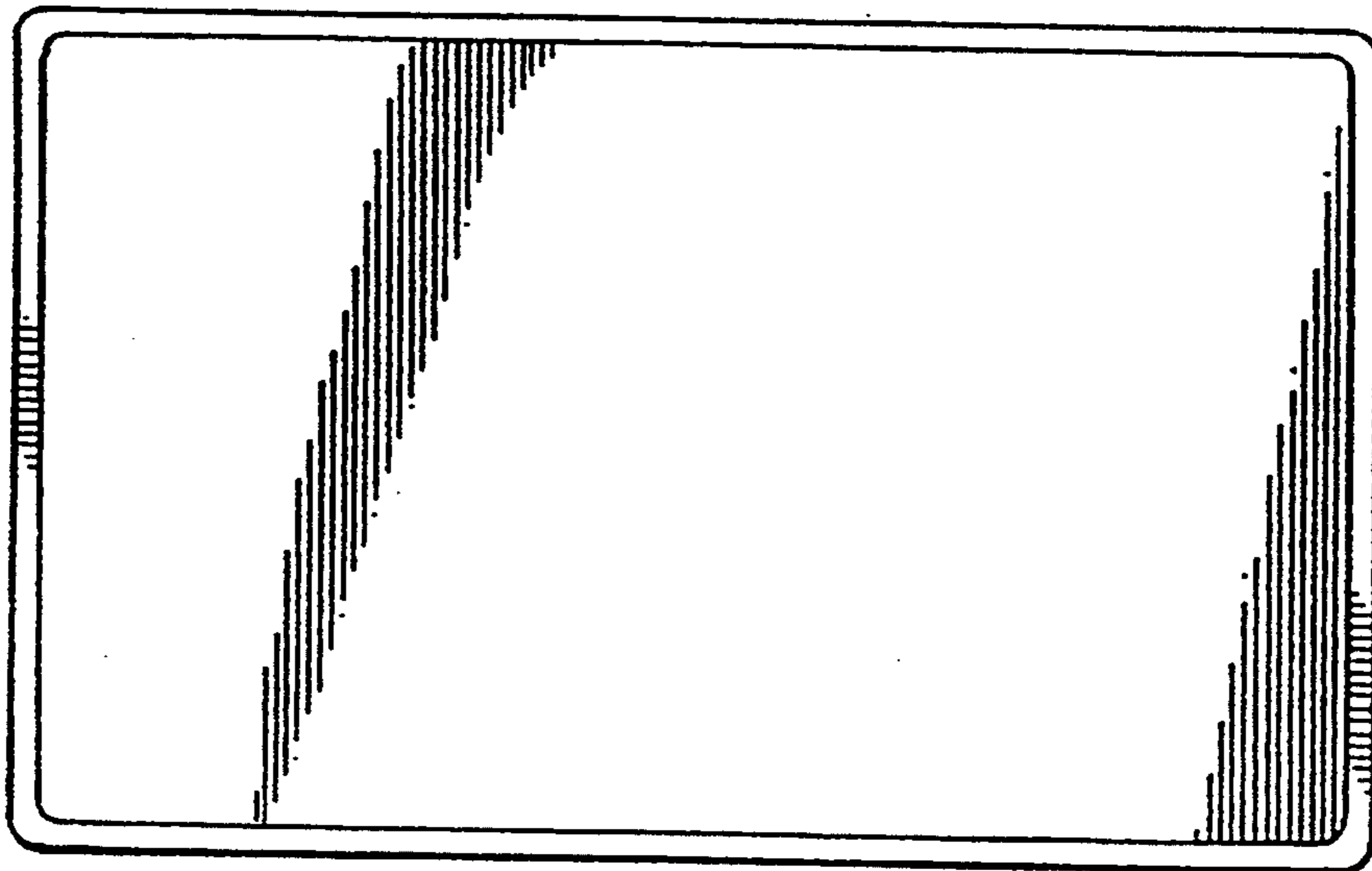
