The ornamental design for a heater fan, as shown.

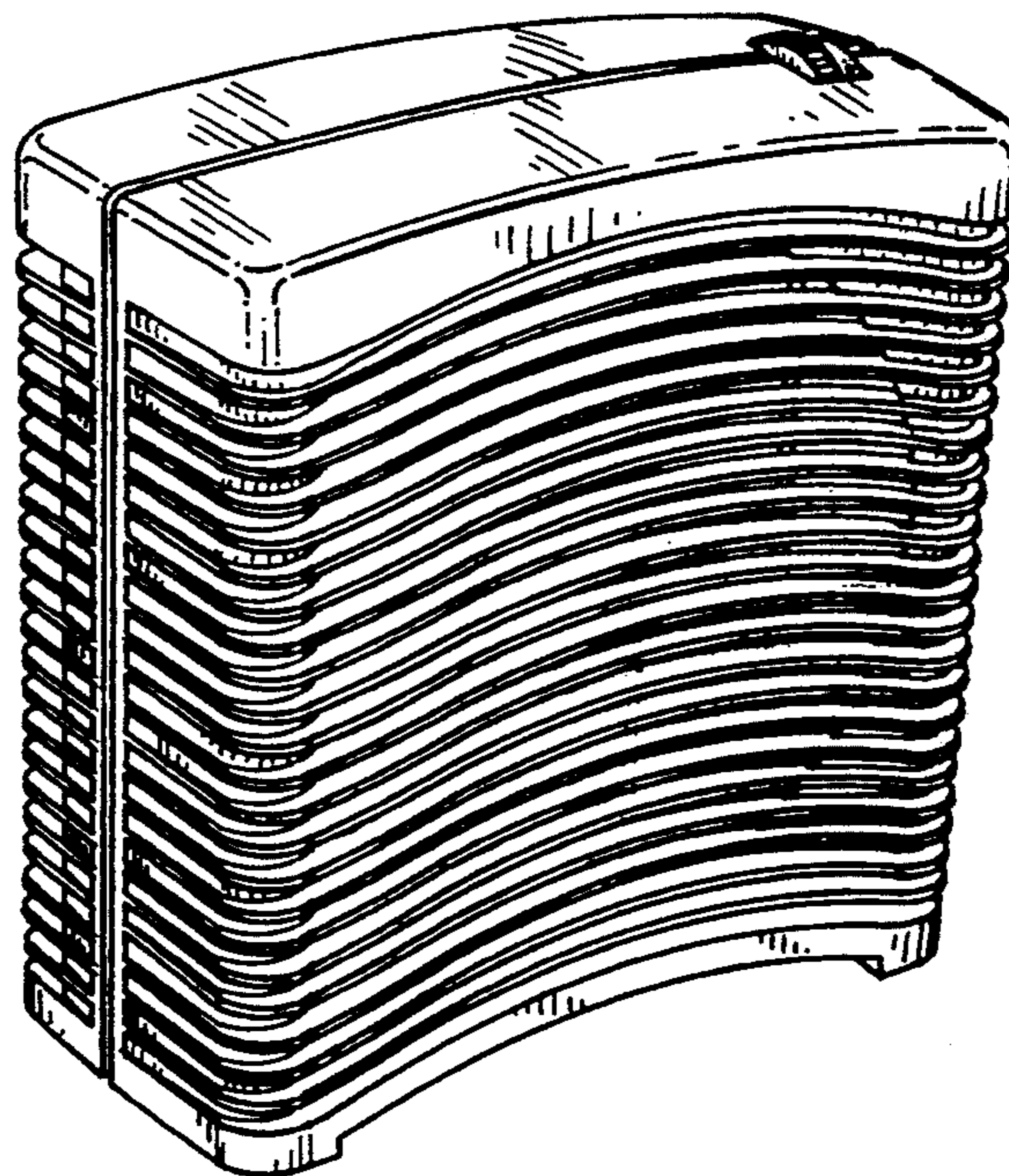
DESCRIPTION

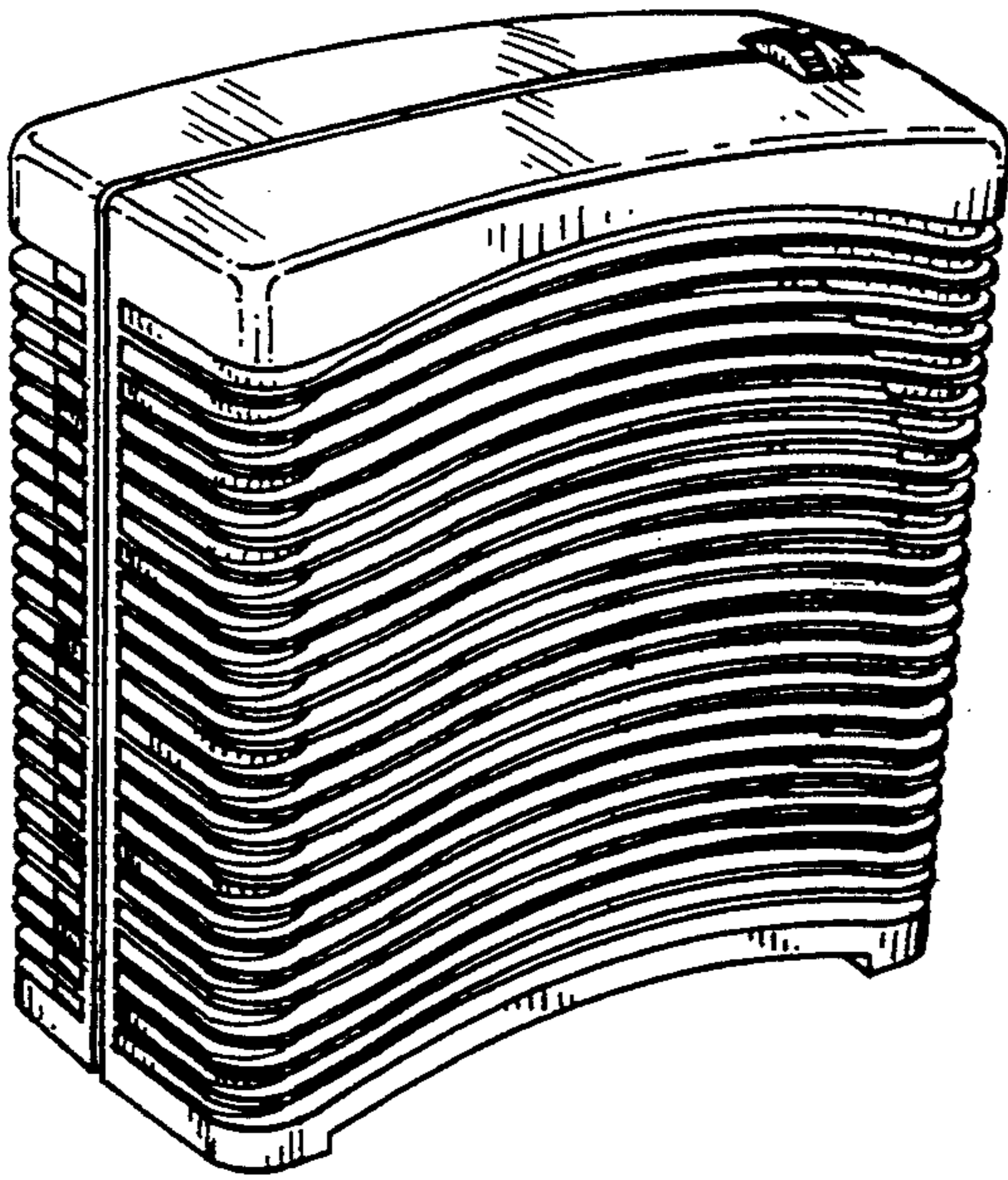

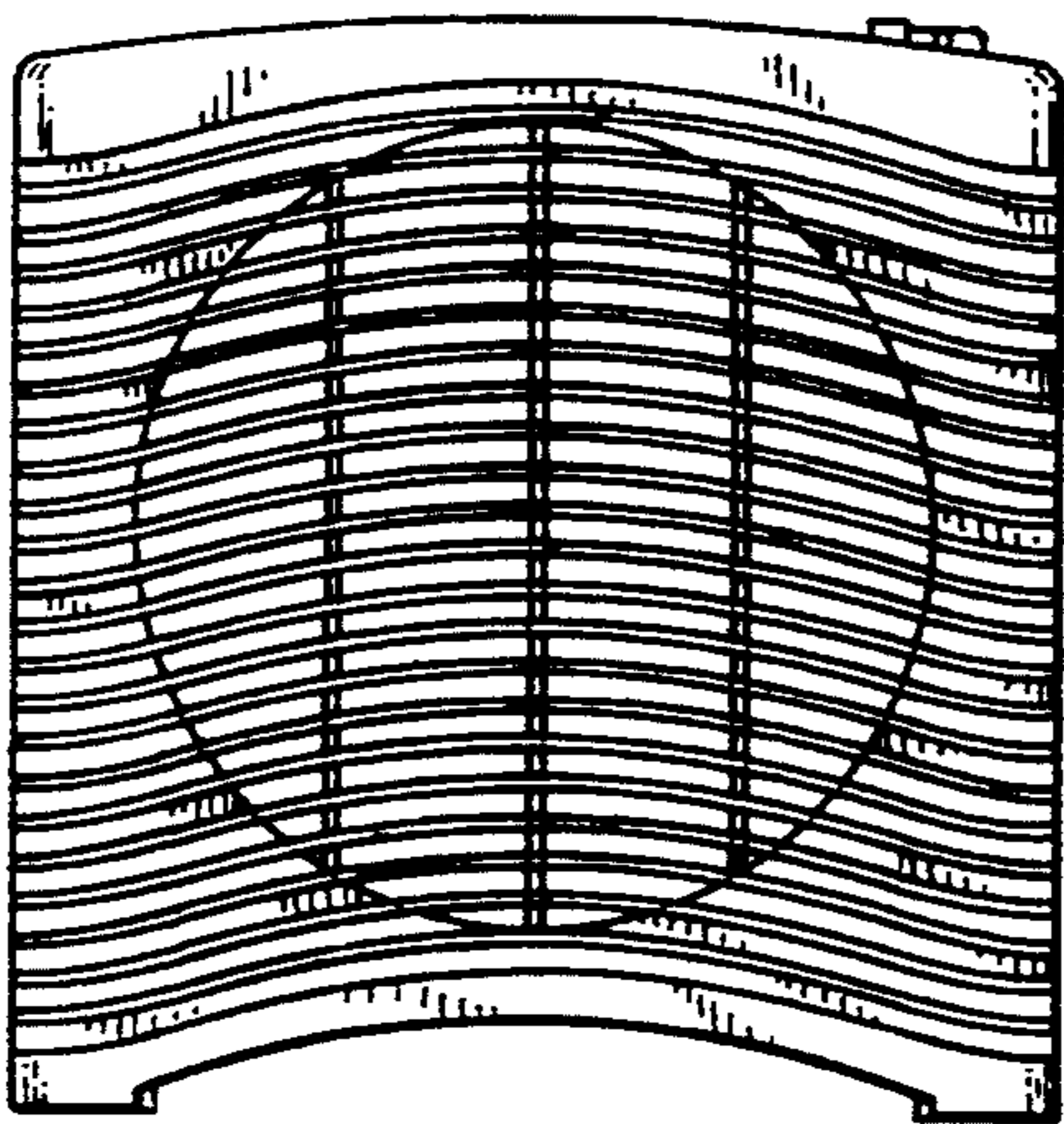

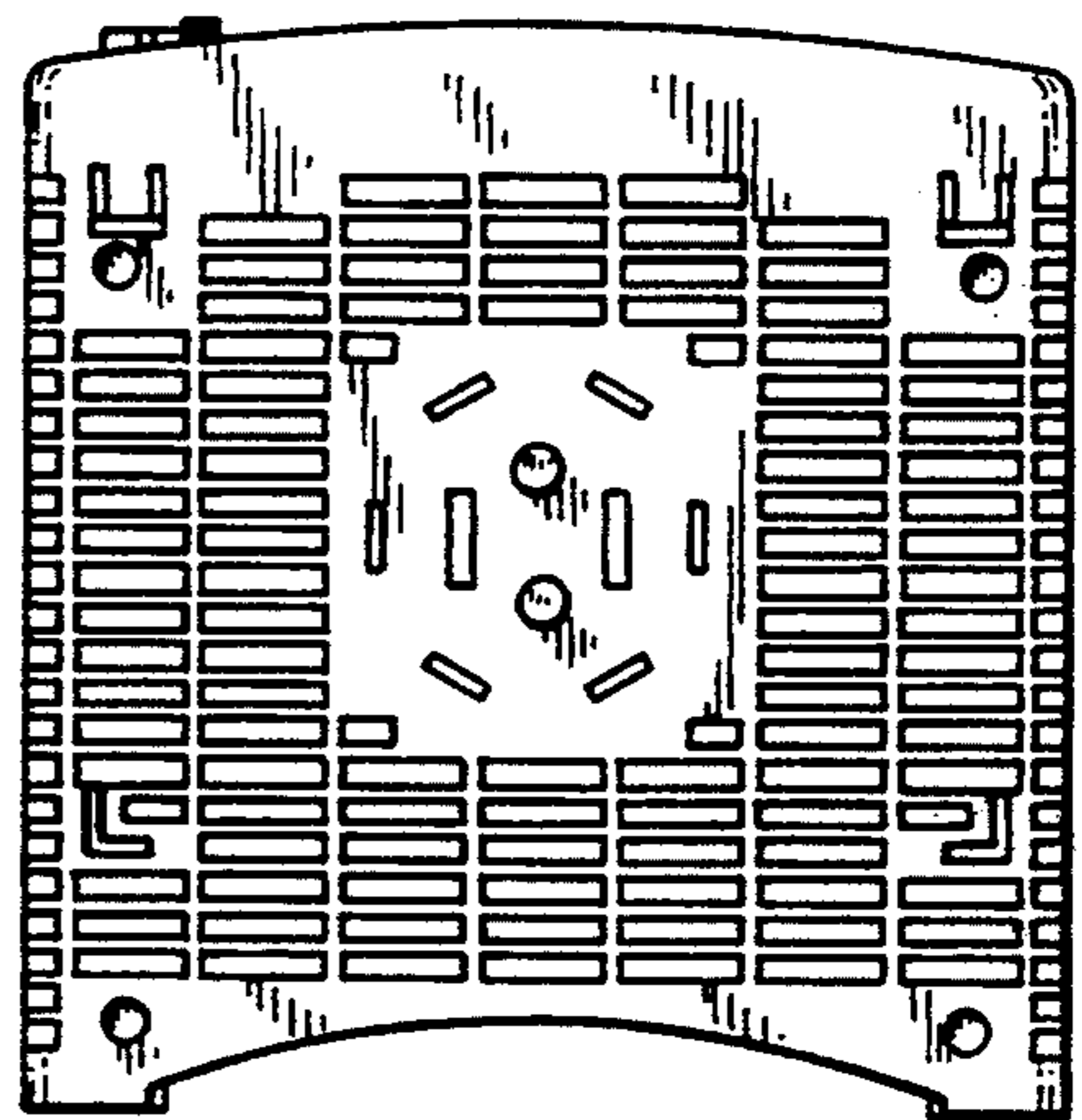

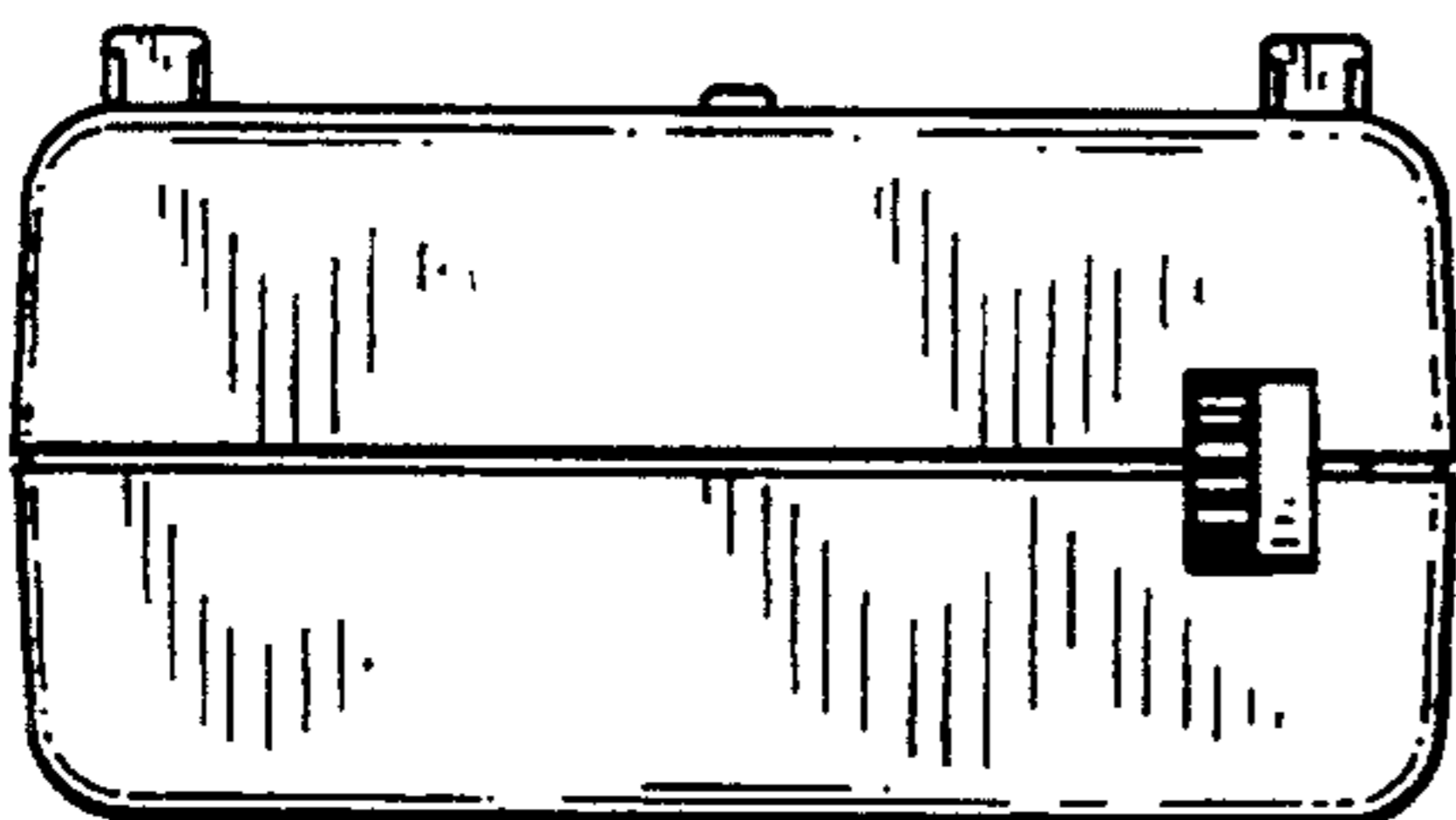

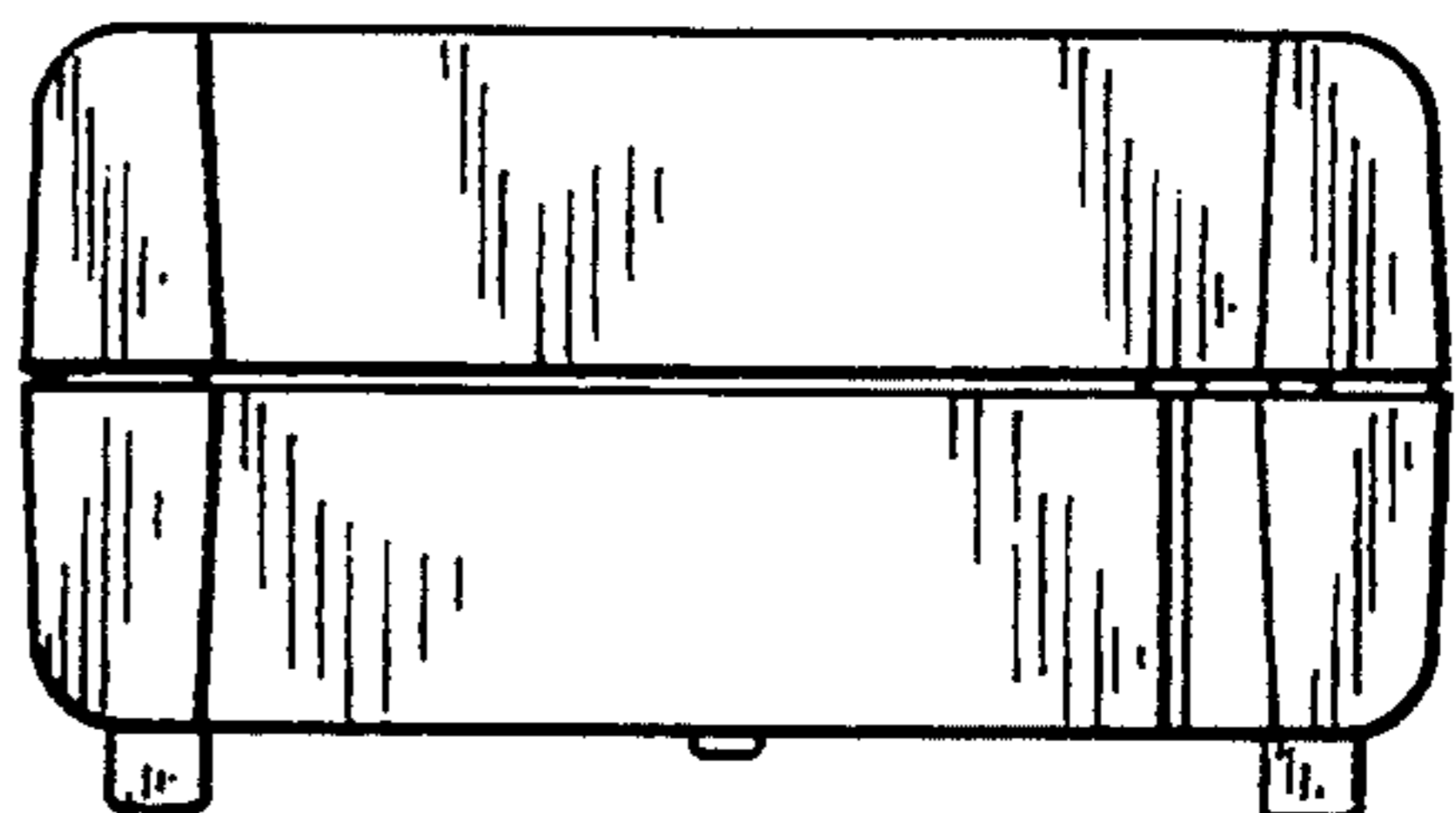

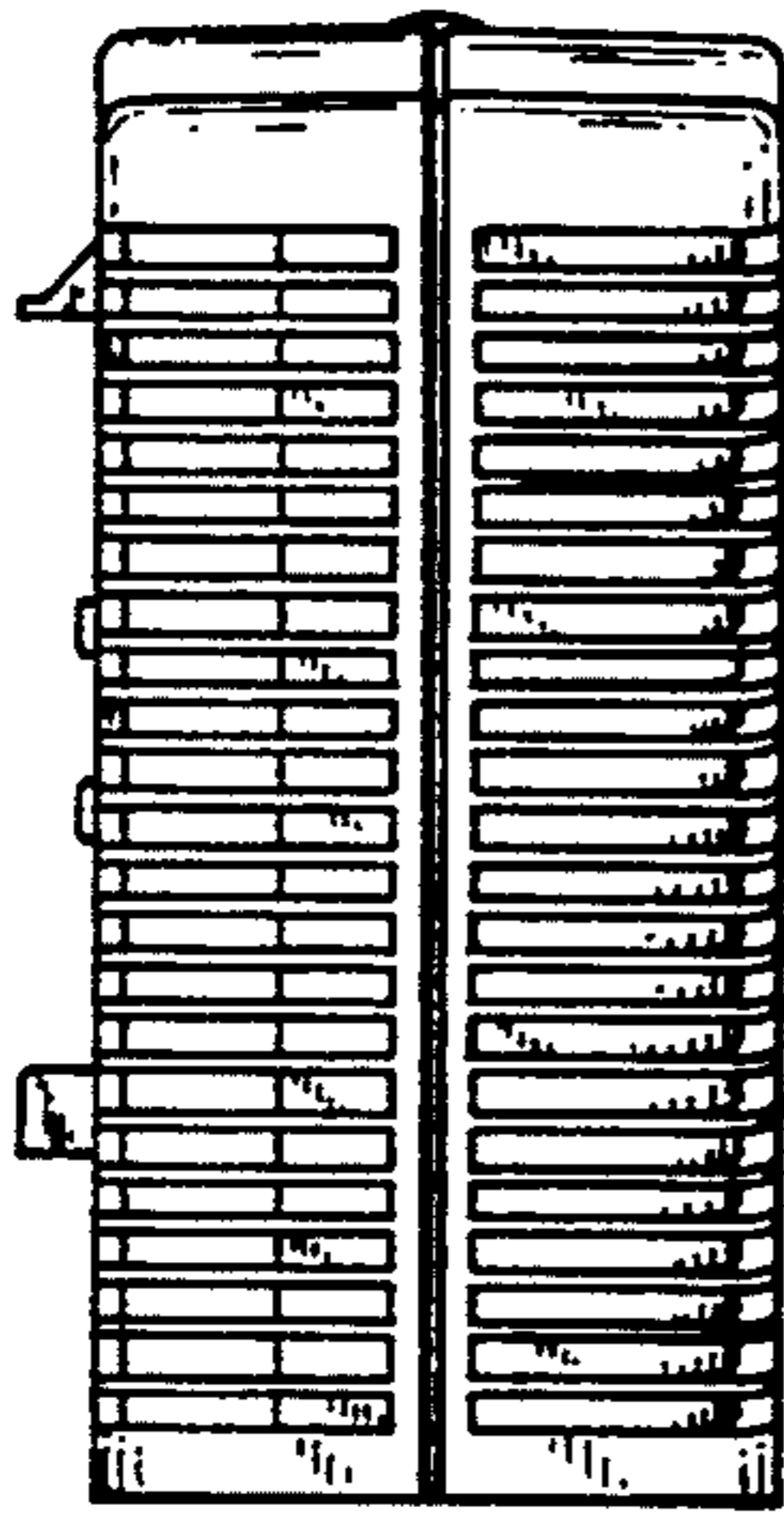

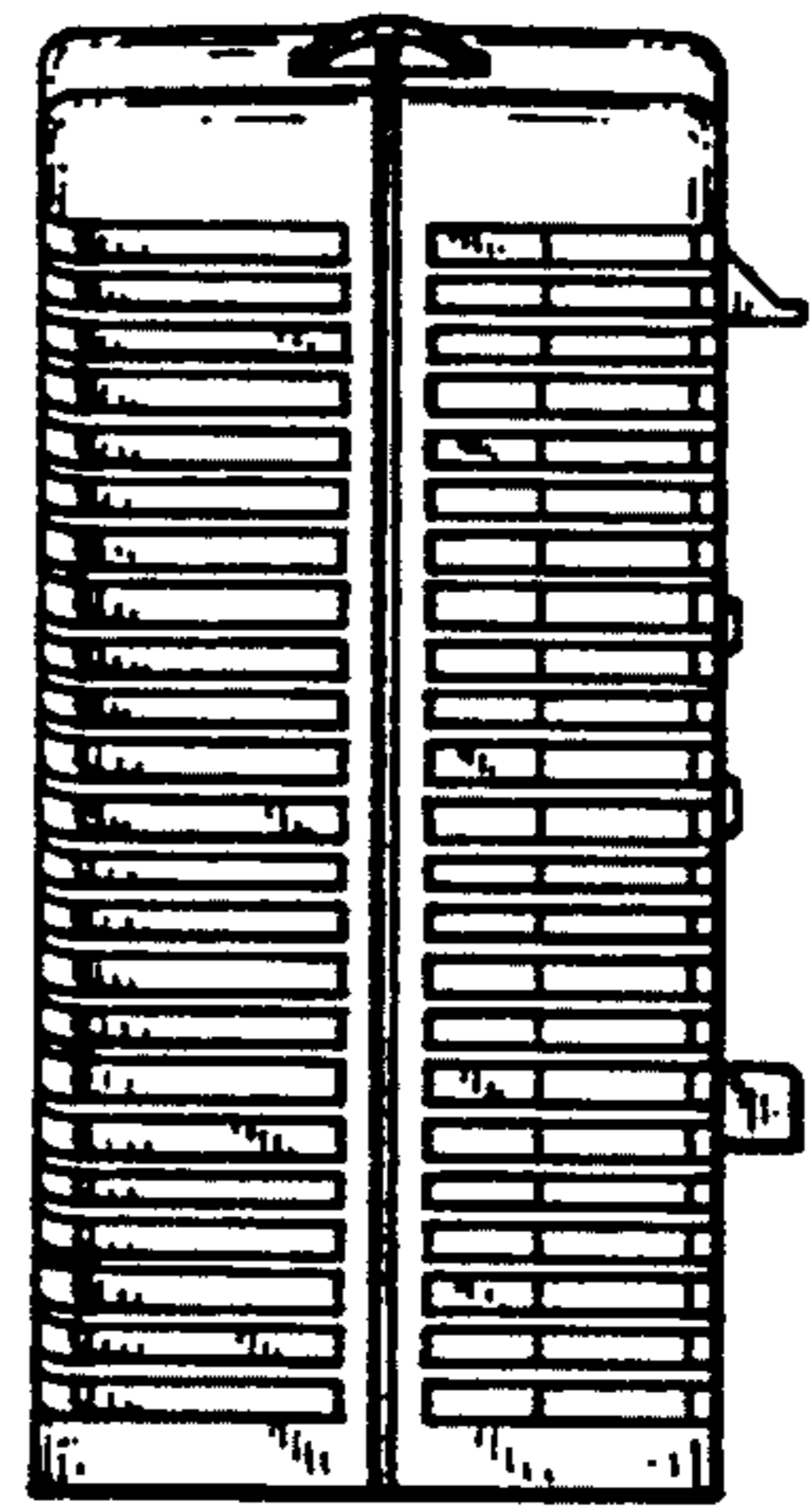
