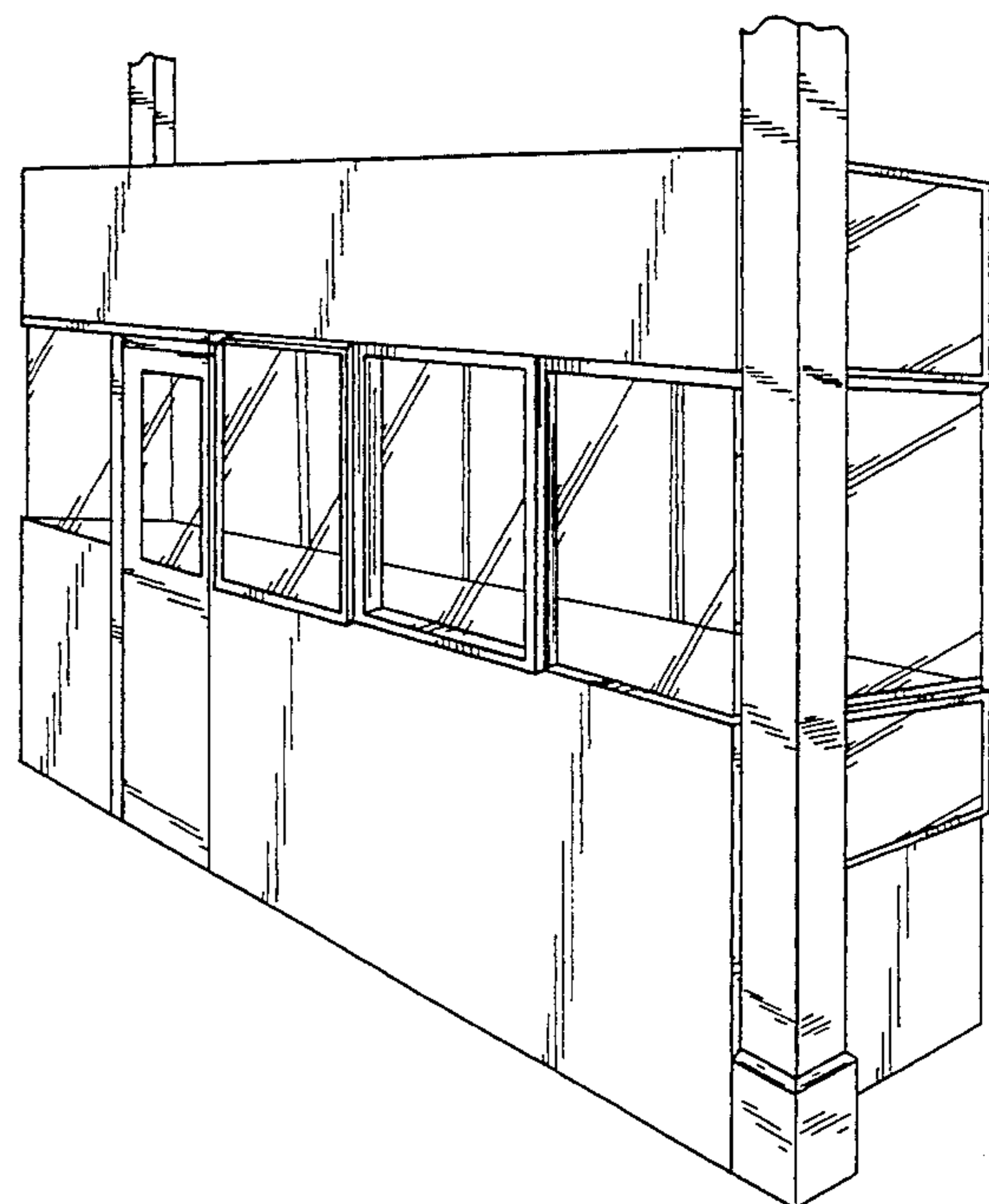
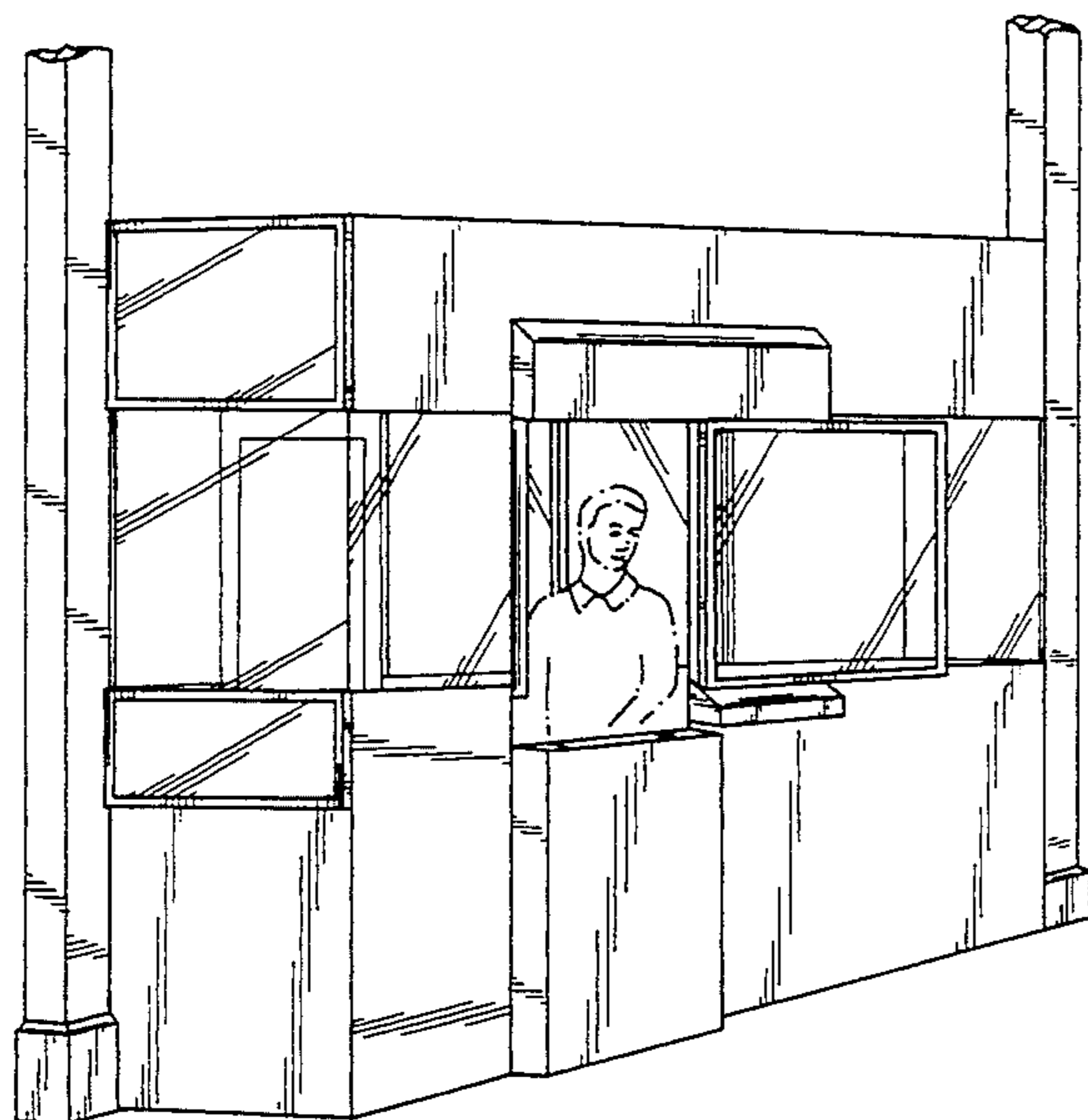

[57] CLAIM

The ornamental design for a highway toll booth, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the driver's side of the booth;
 FIG. 2 is a perspective view of the passenger's side of the booth;
 FIG. 3 is an end elevational view of the booth, the opposite end being identical;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a side elevational view of the driver's side of the booth; and,
 FIG. 6 is a side elevational view of the passenger's side of the booth.
 The broken lines in FIG. 1 are for illustrative purposes only and form no part of the claimed design.



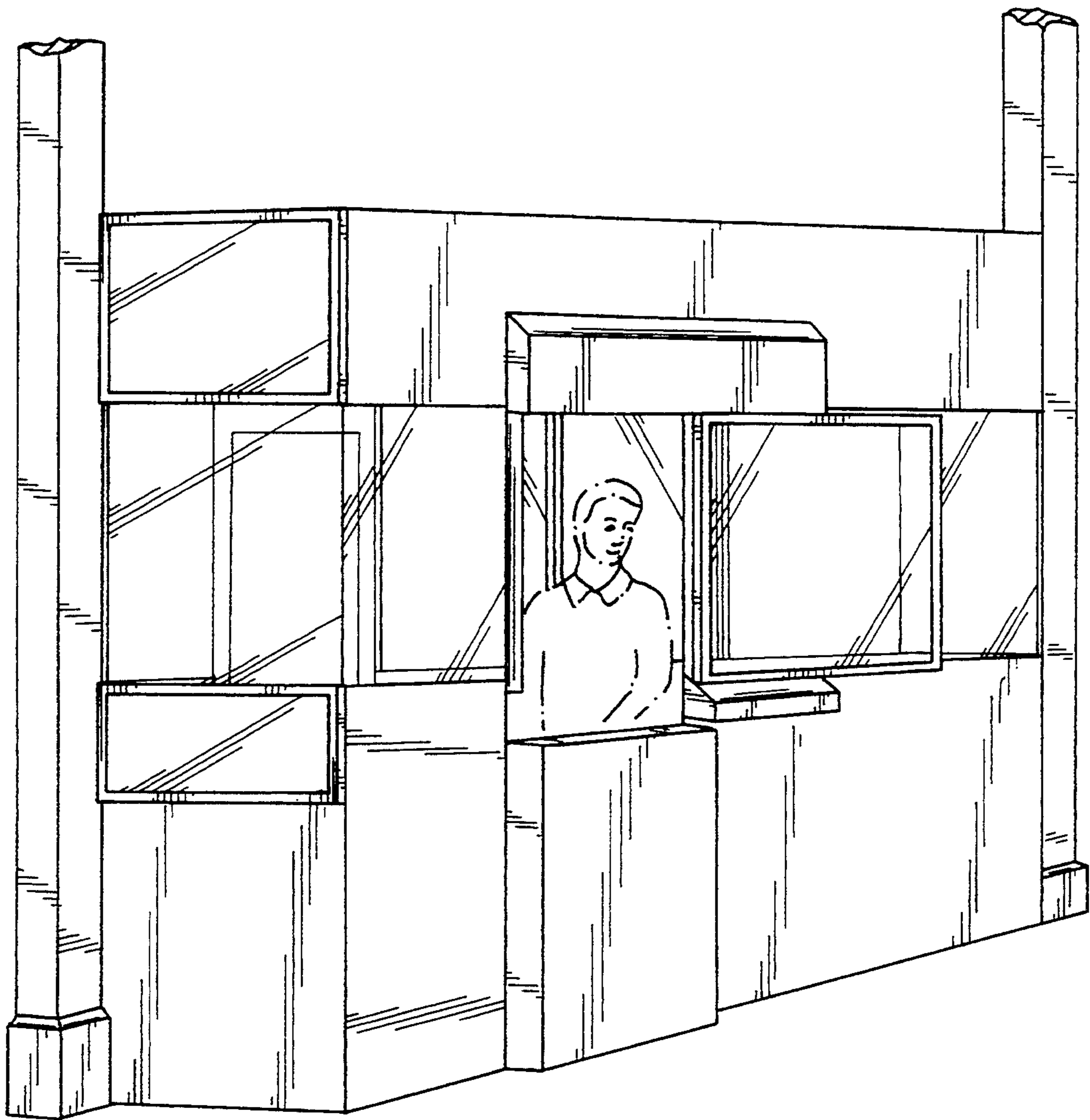

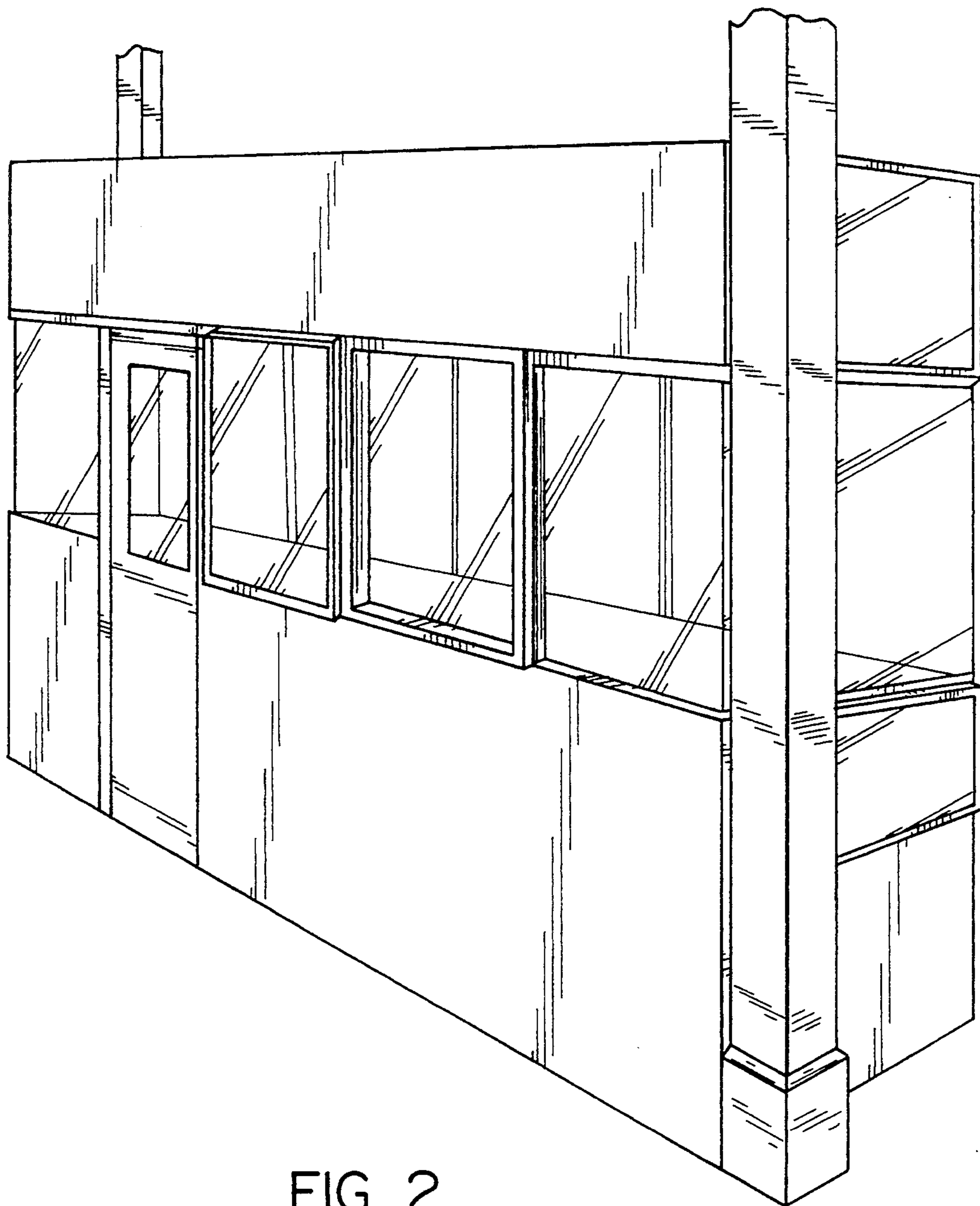

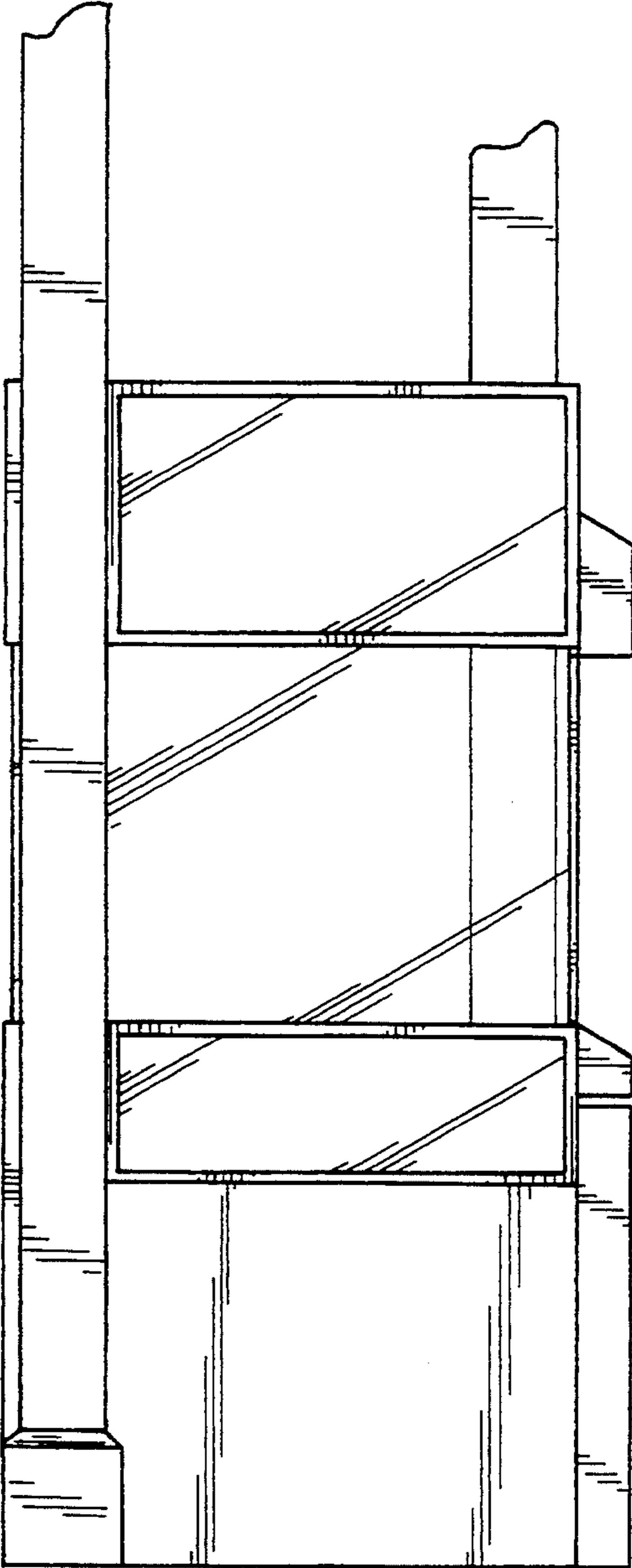

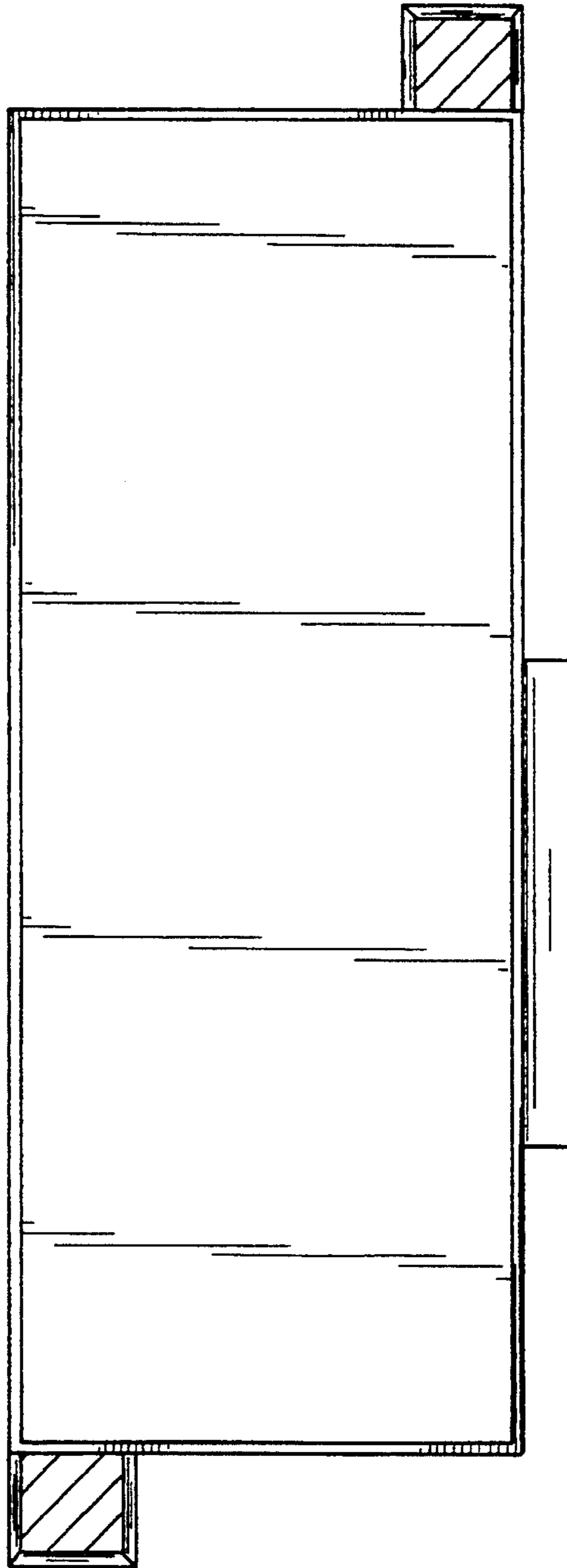

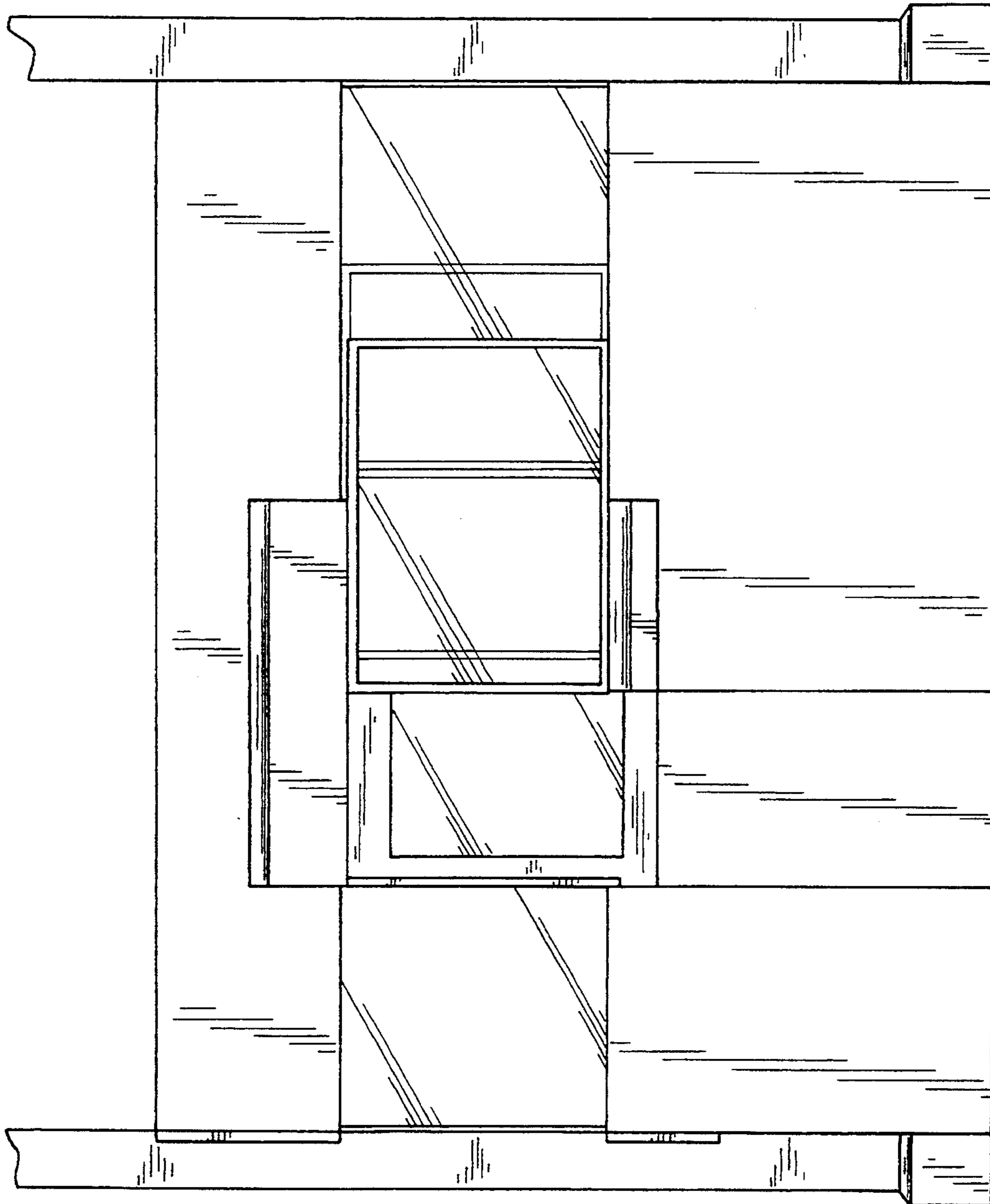
