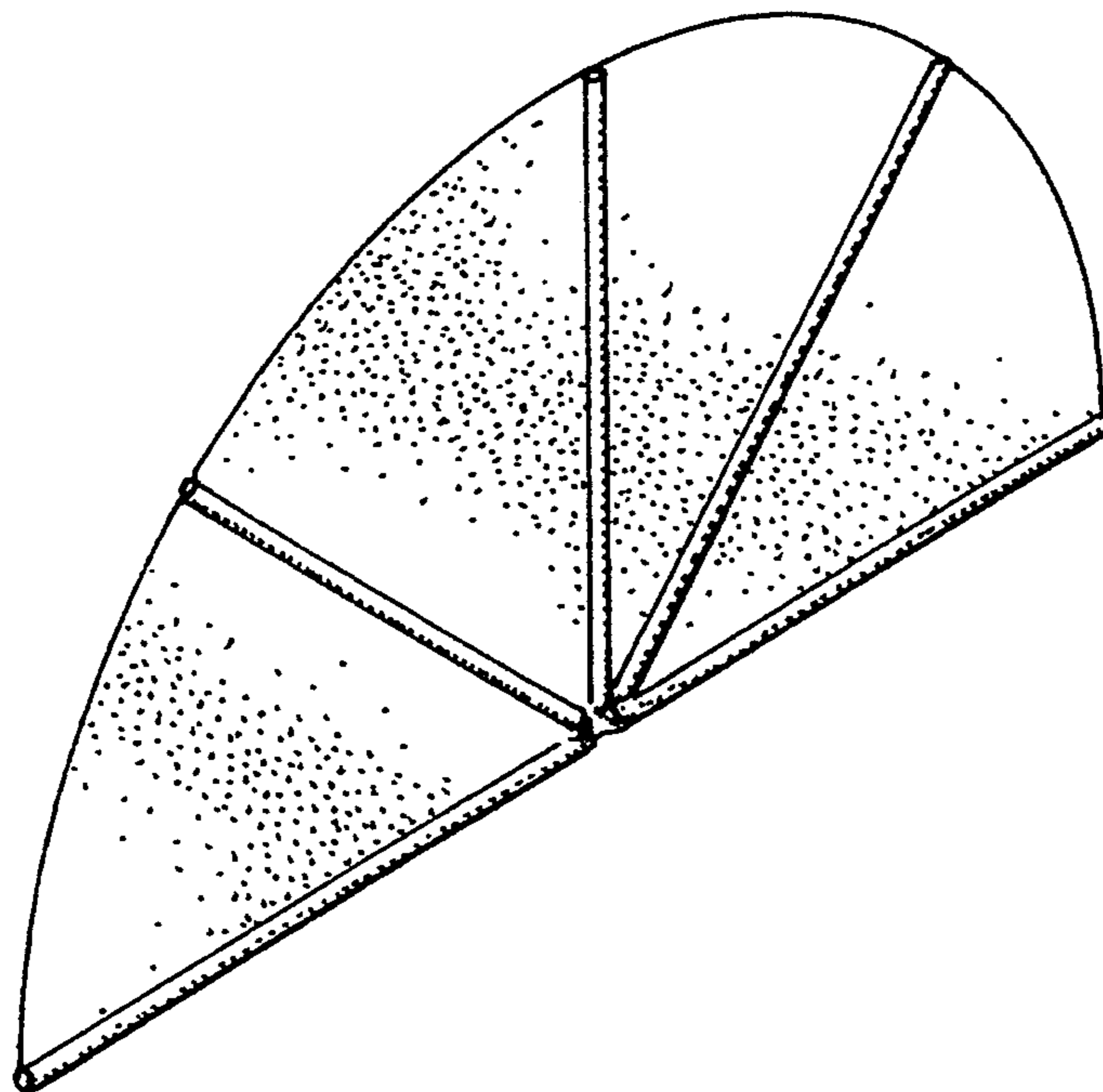

The ornamental design for a window shade, as shown and described.

### DESCRIPTION

FIG. 1 is a front left perspective view of a window shade showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof; and,  
 FIG. 6 is a rear elevational view thereof.



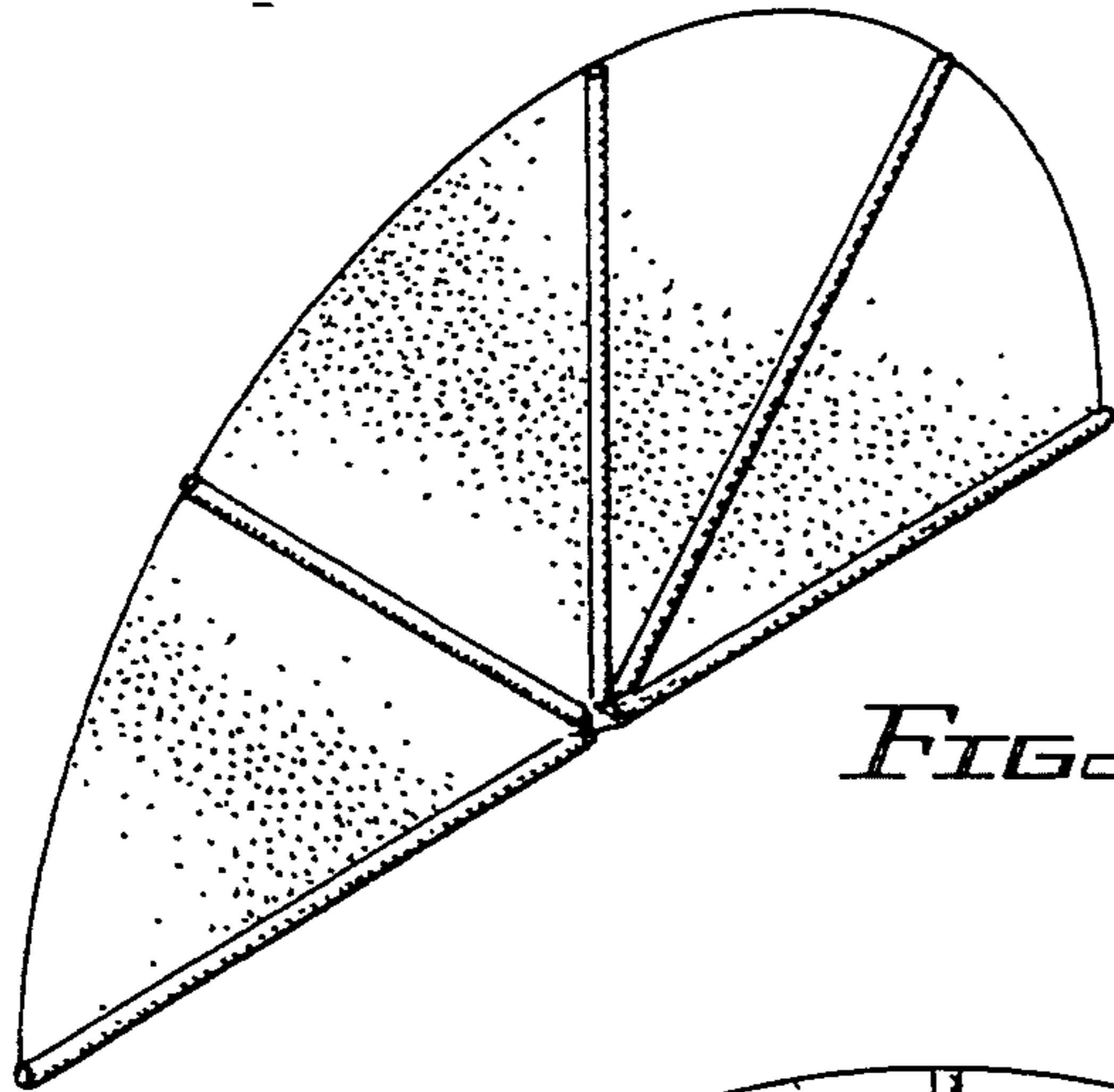

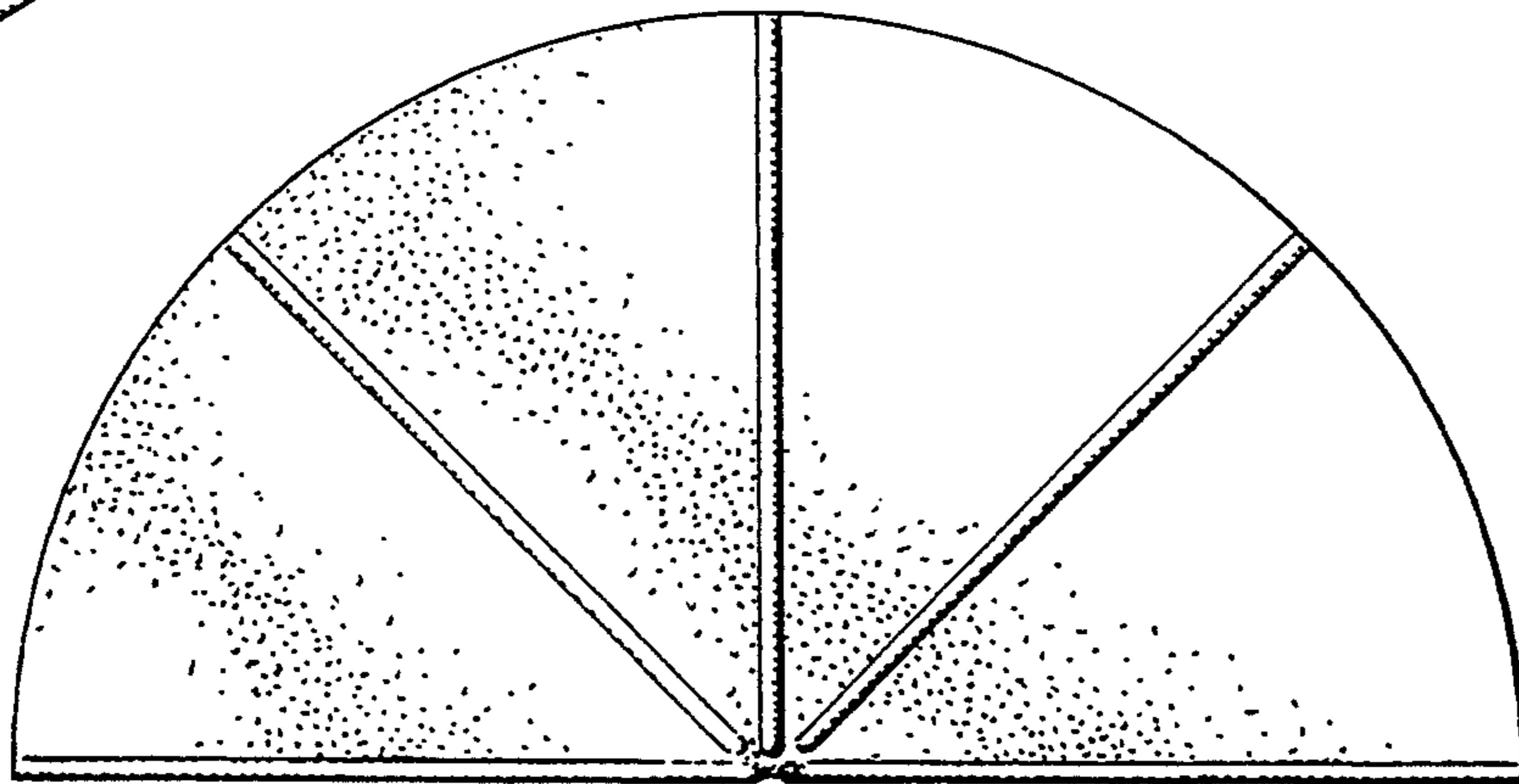
