[57] **CLAIM**

The ornamental design for a hammerhead, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hammerhead showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is an end elevational view thereof from the striking face end;  
FIG. 4 is an end elevational view thereof from the claw end;  
FIG. 5 is a side elevational view thereof, the opposite side being a mirror image; and,  
FIG. 6 is a bottom plan view thereof.  
The broken line showing of the handle in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

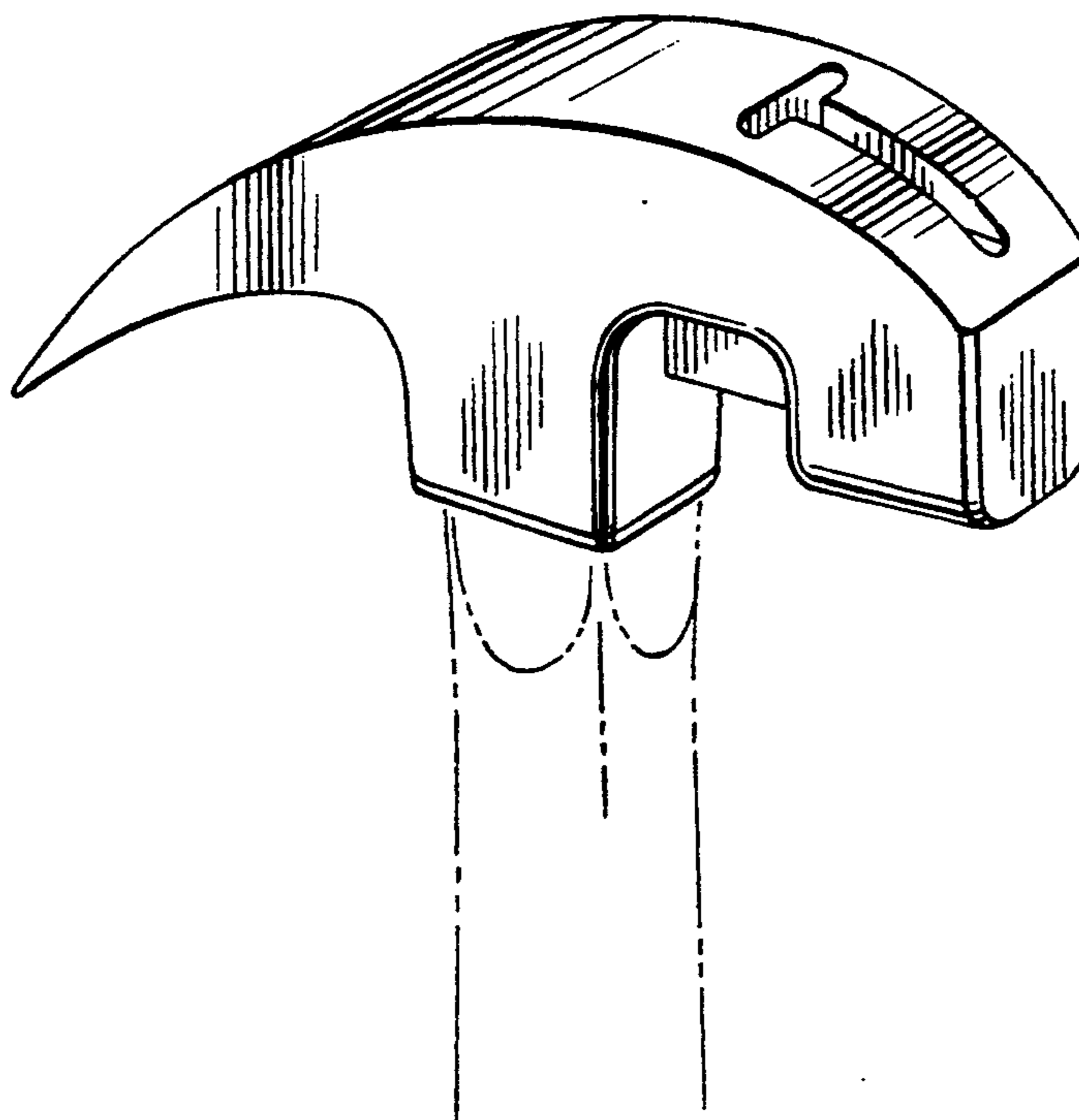

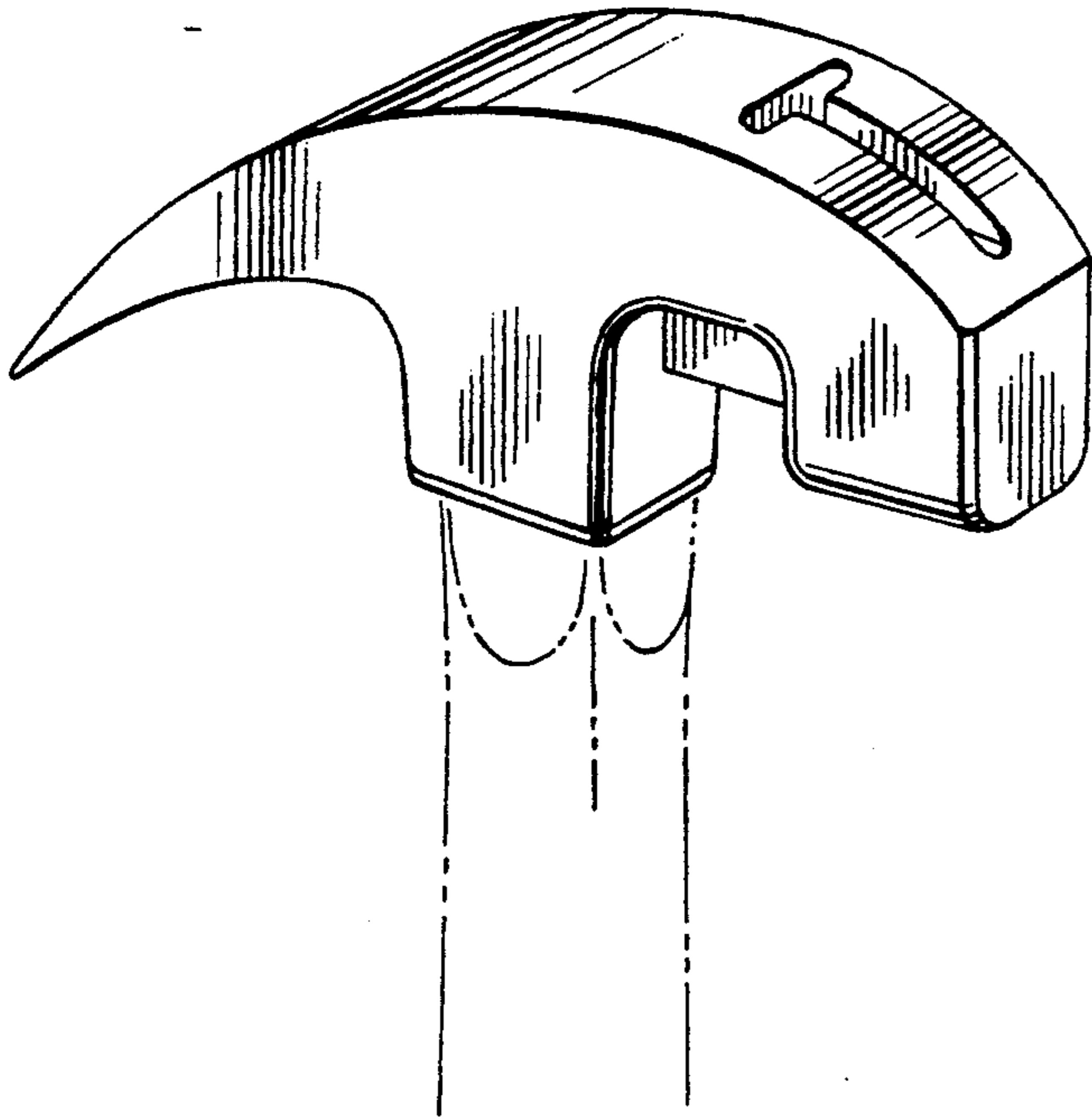

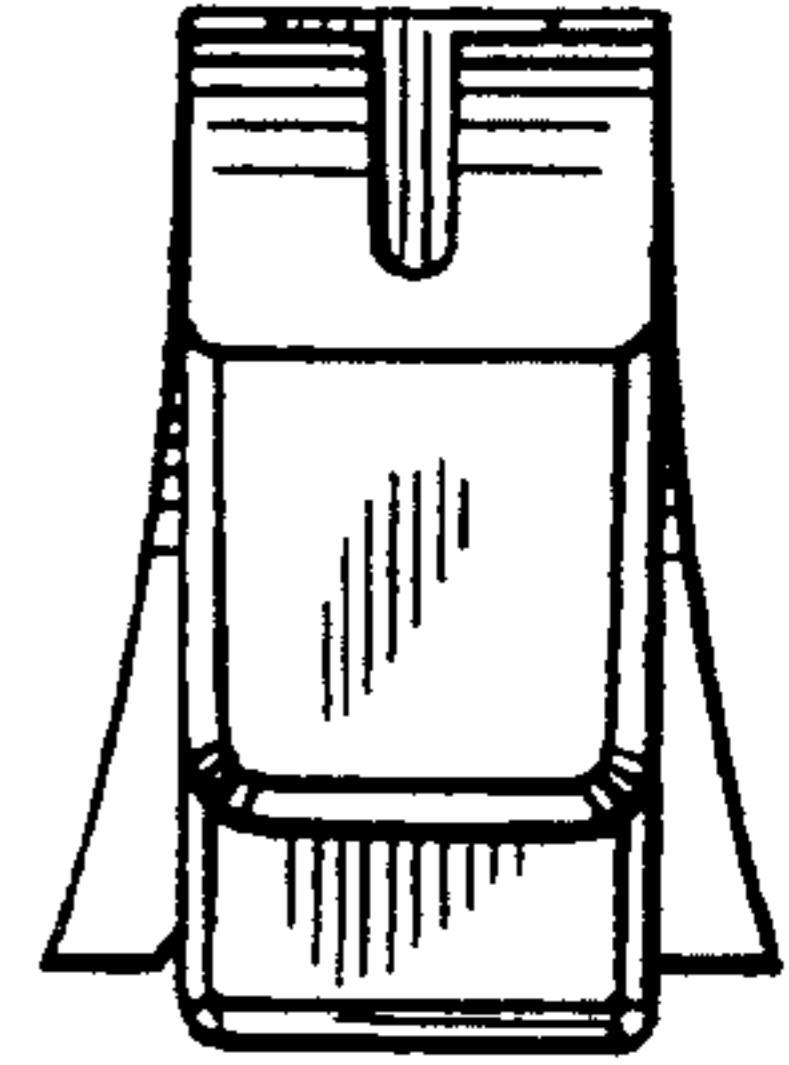

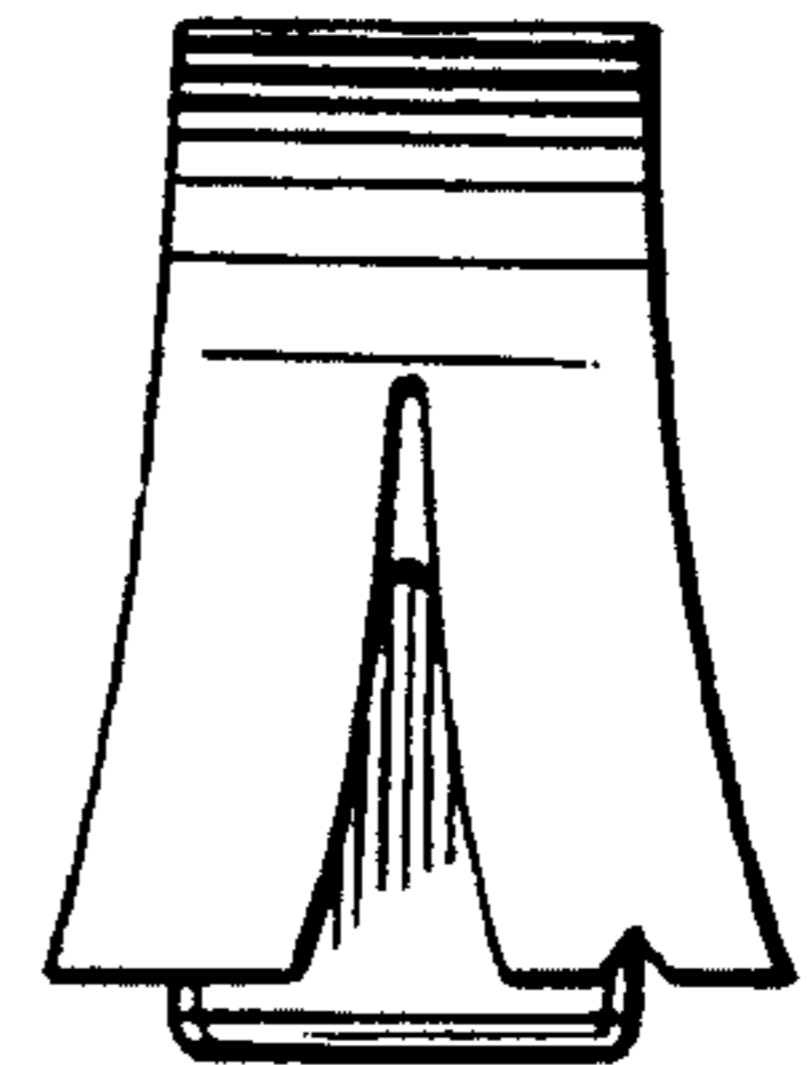

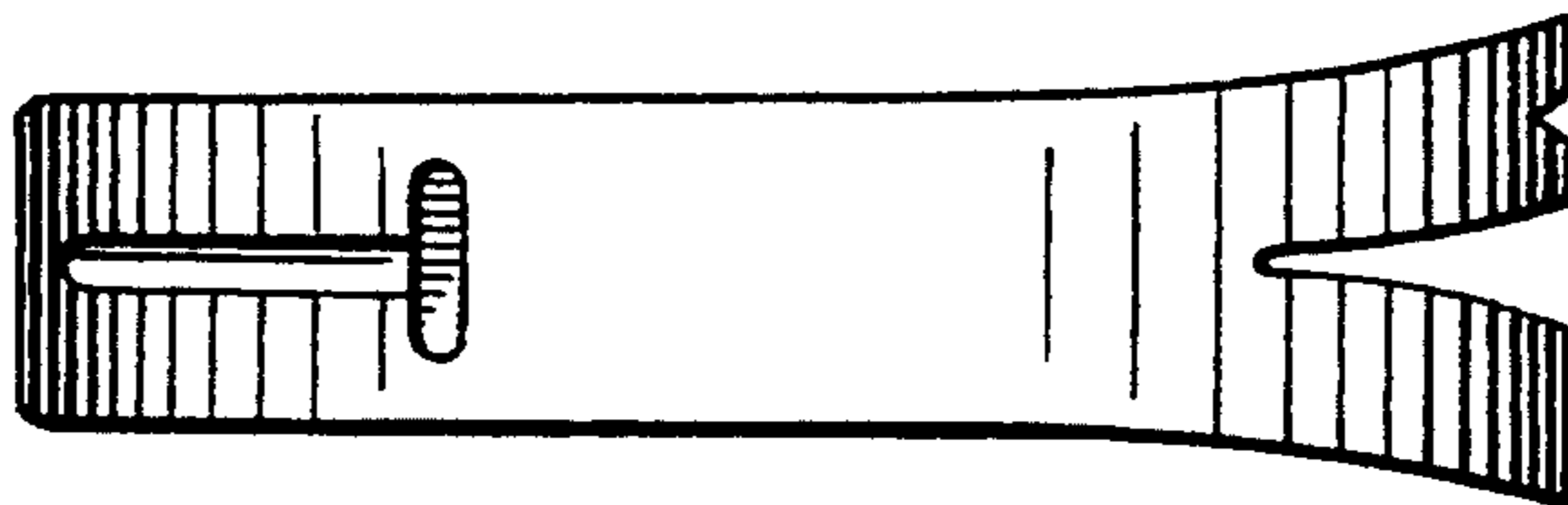

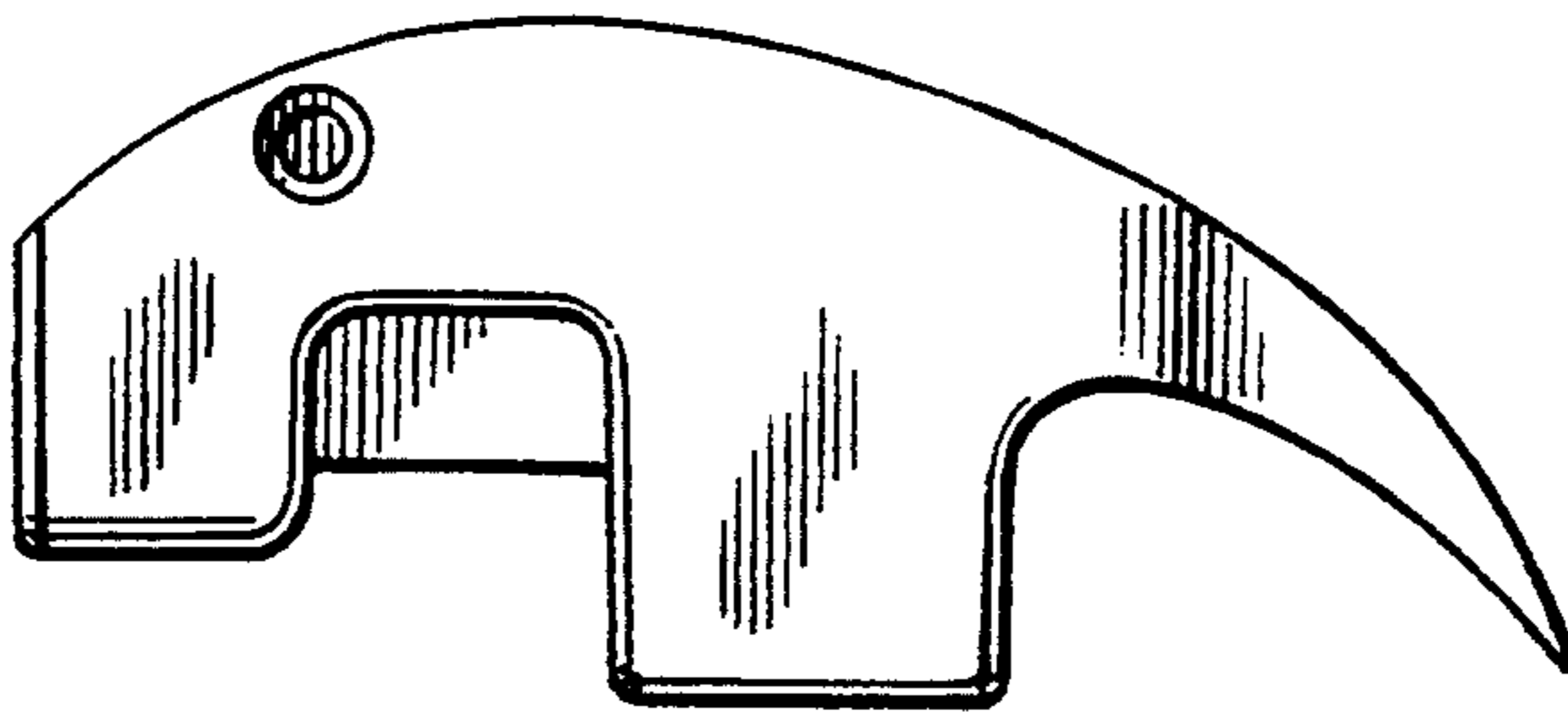
