[57] CLAIM

The ornamental design for a plant guard, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the plant guard; FIG. 2 is a side elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a front perspective view thereof; FIG. 5 is a rear perspective view in an inverted position; FIG. 6 is a bottom plan view thereof; FIG. 7 is a bottom plan view thereof showing the plant guard in an unfolded condition; and, FIG. 8 is a front elevational view thereof in an unfolded condition.



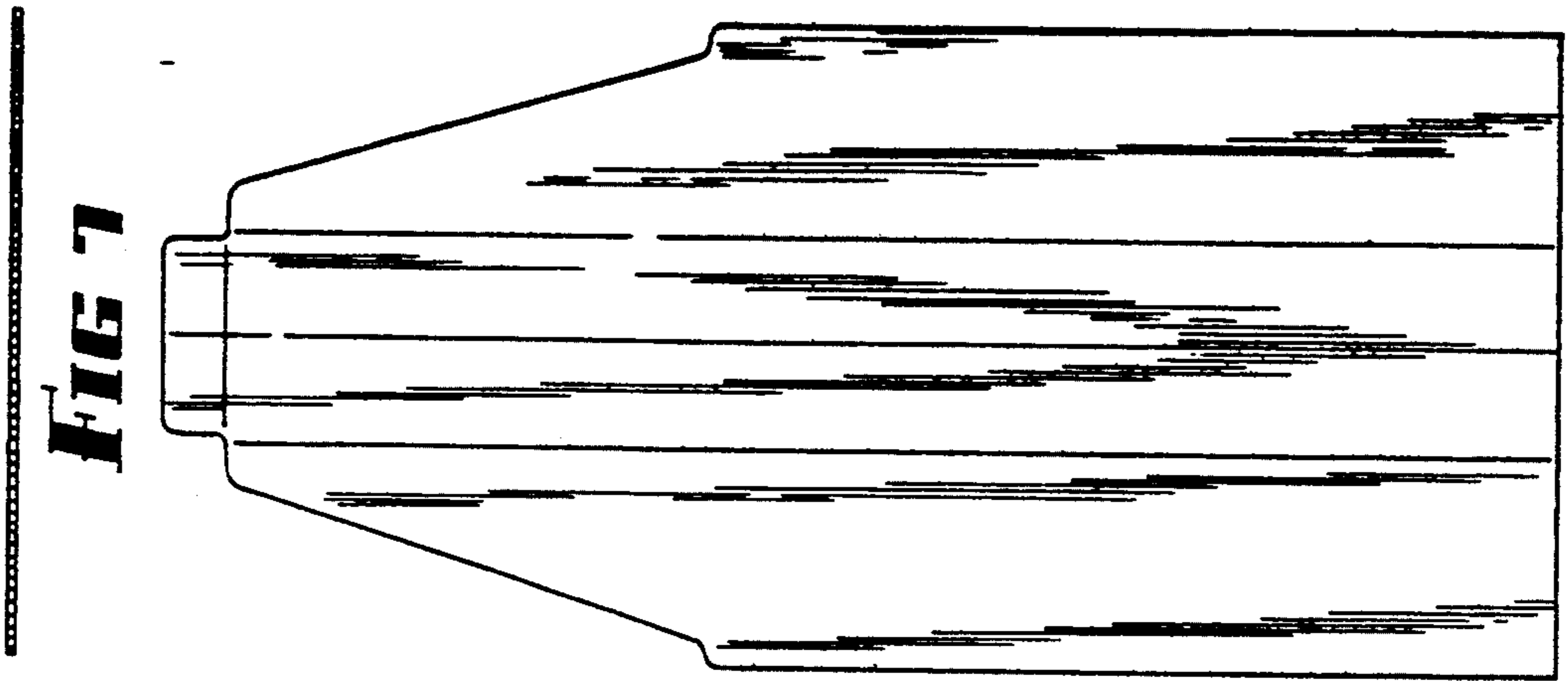

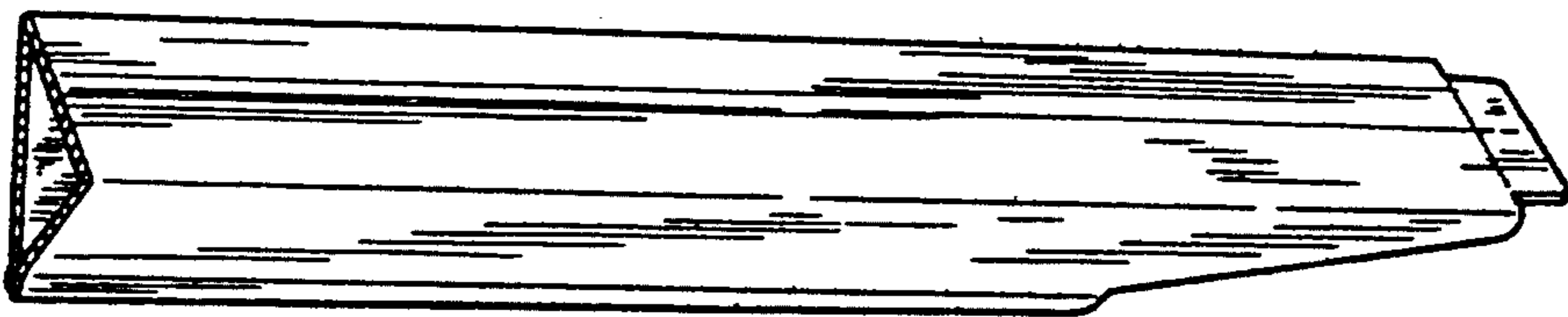

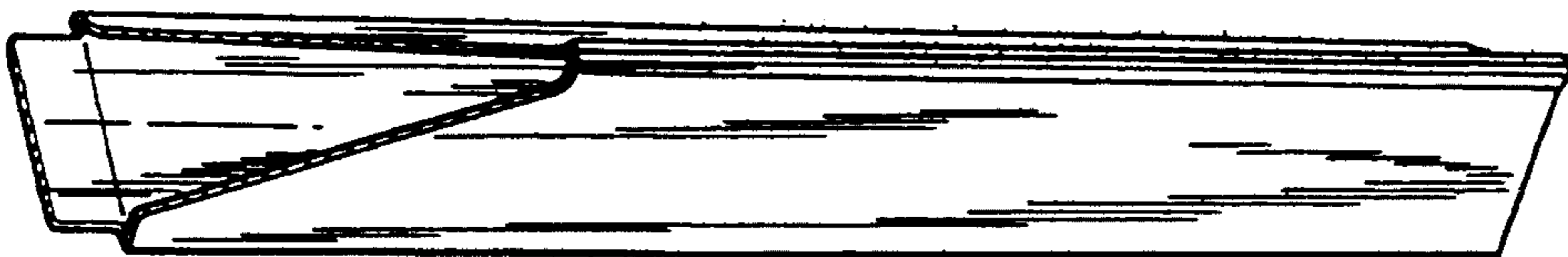

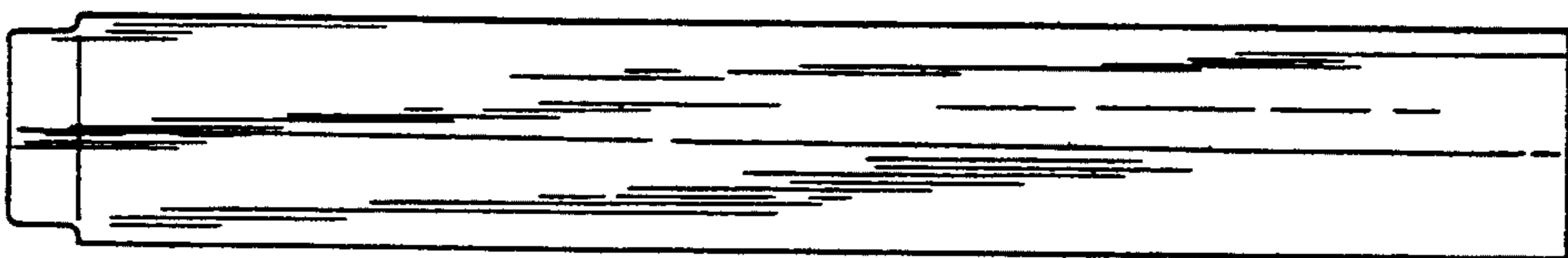

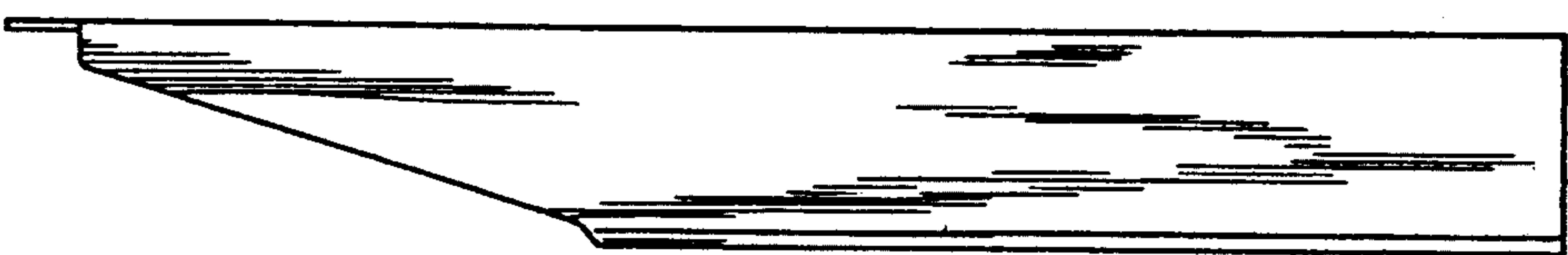

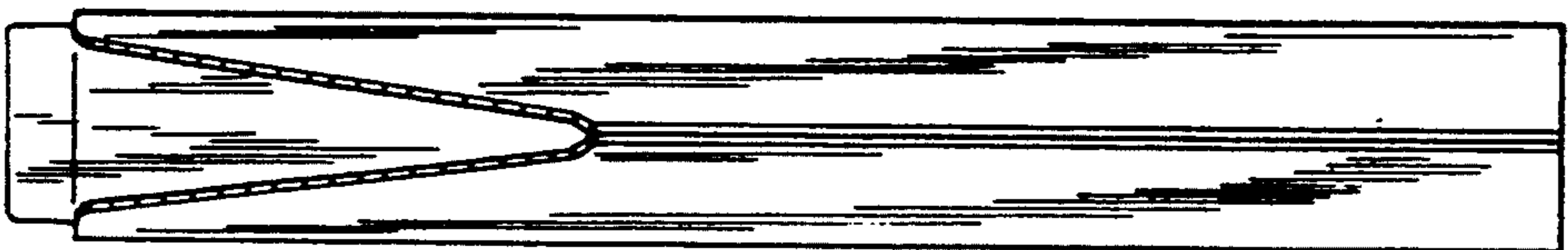

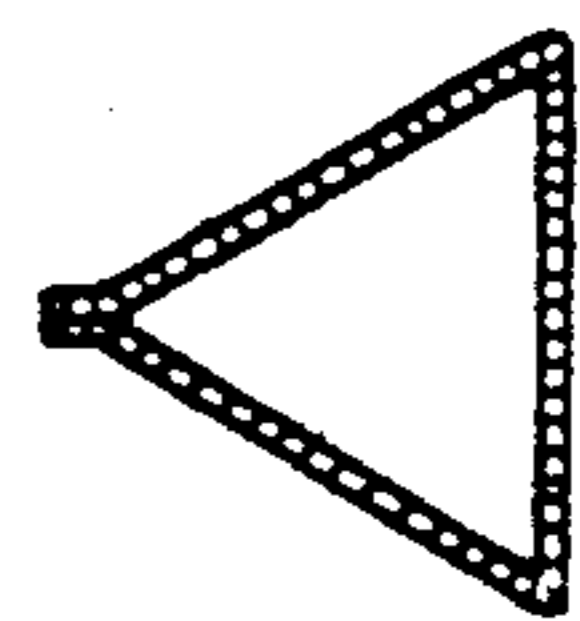
