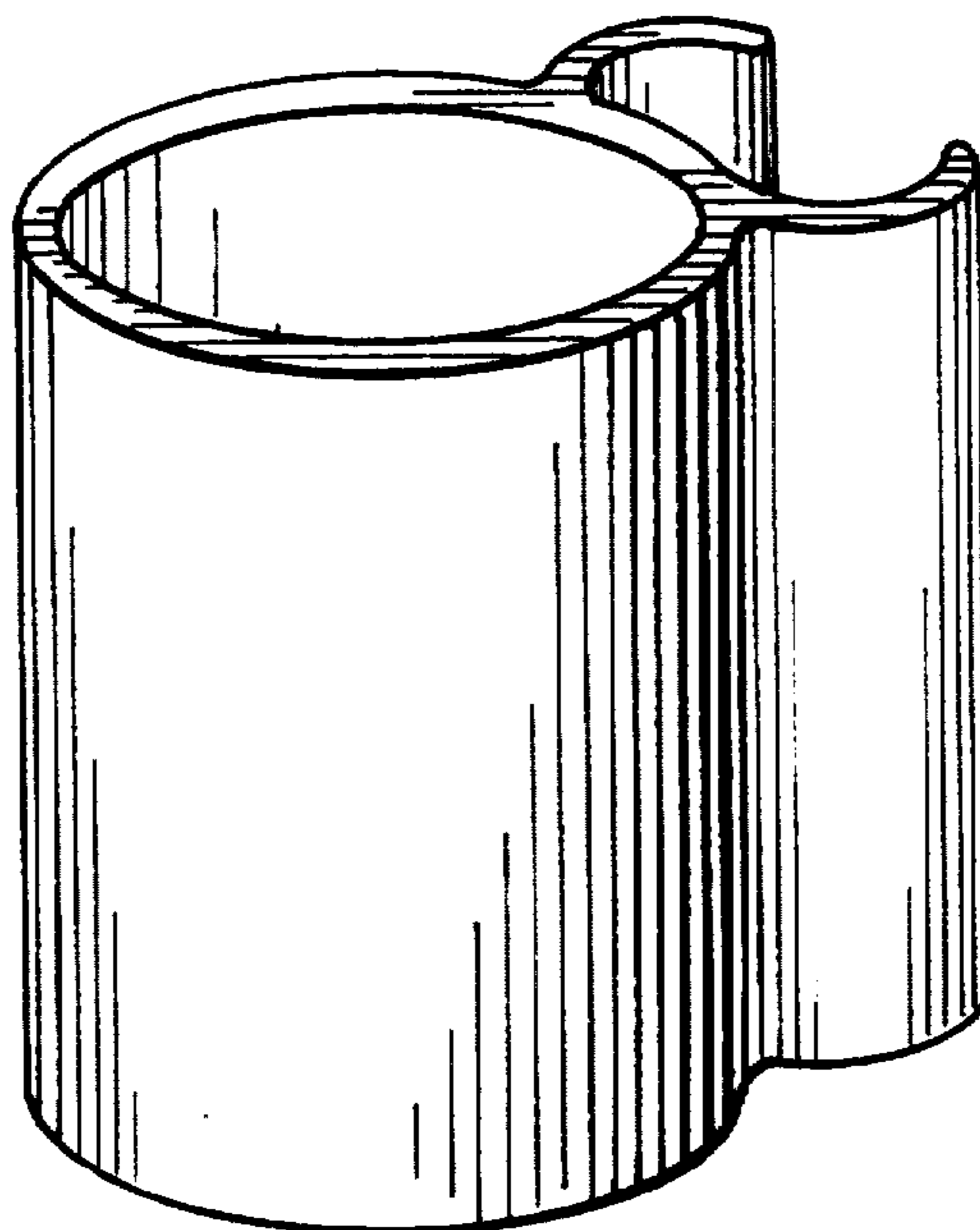

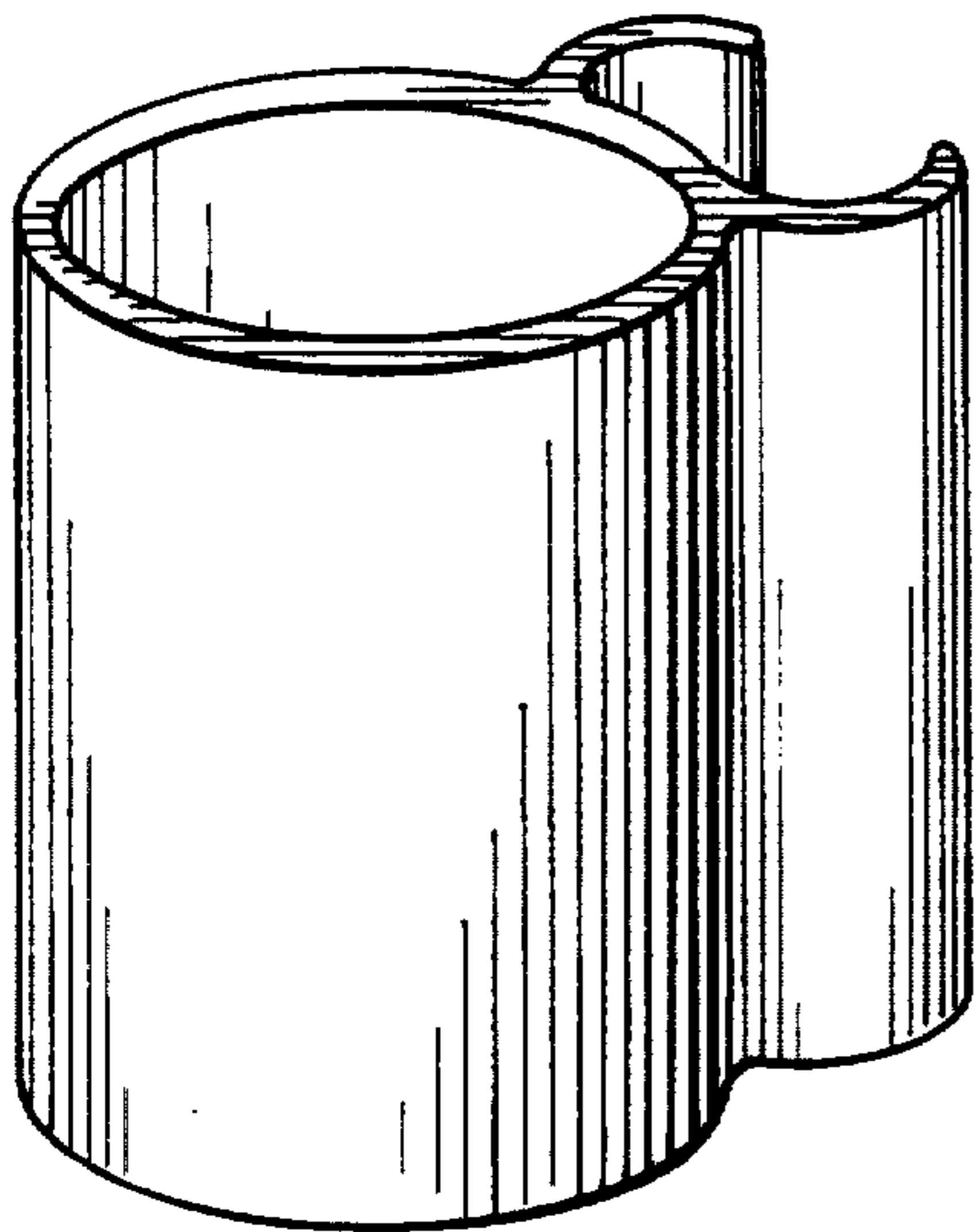
The ornamental design for a writing instrument container for display stand, as shown and described.

**DESCRIPTION**

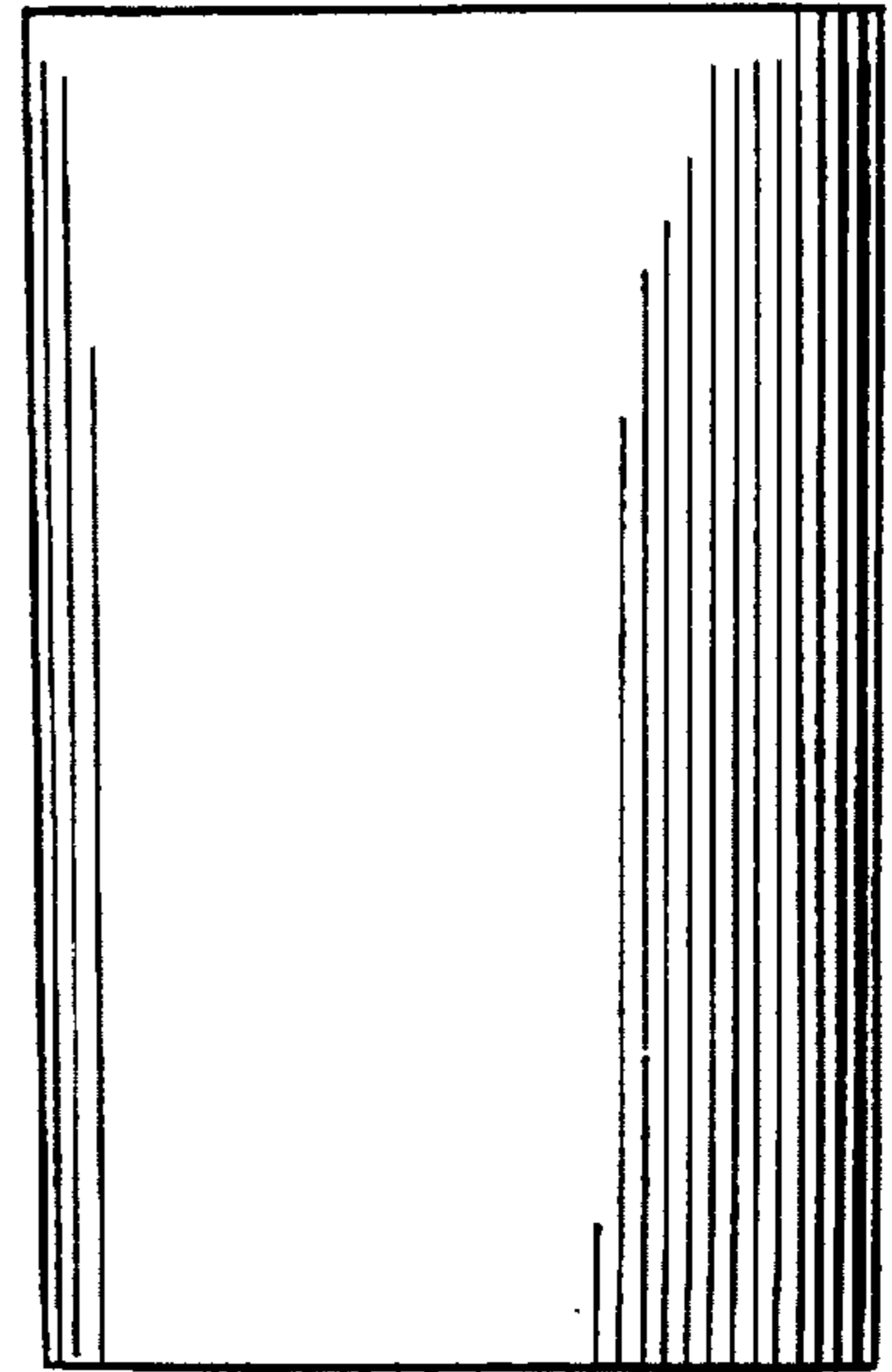
FIG. 1 is a top perspective view of the writing instrument container for display stand showing our new design;

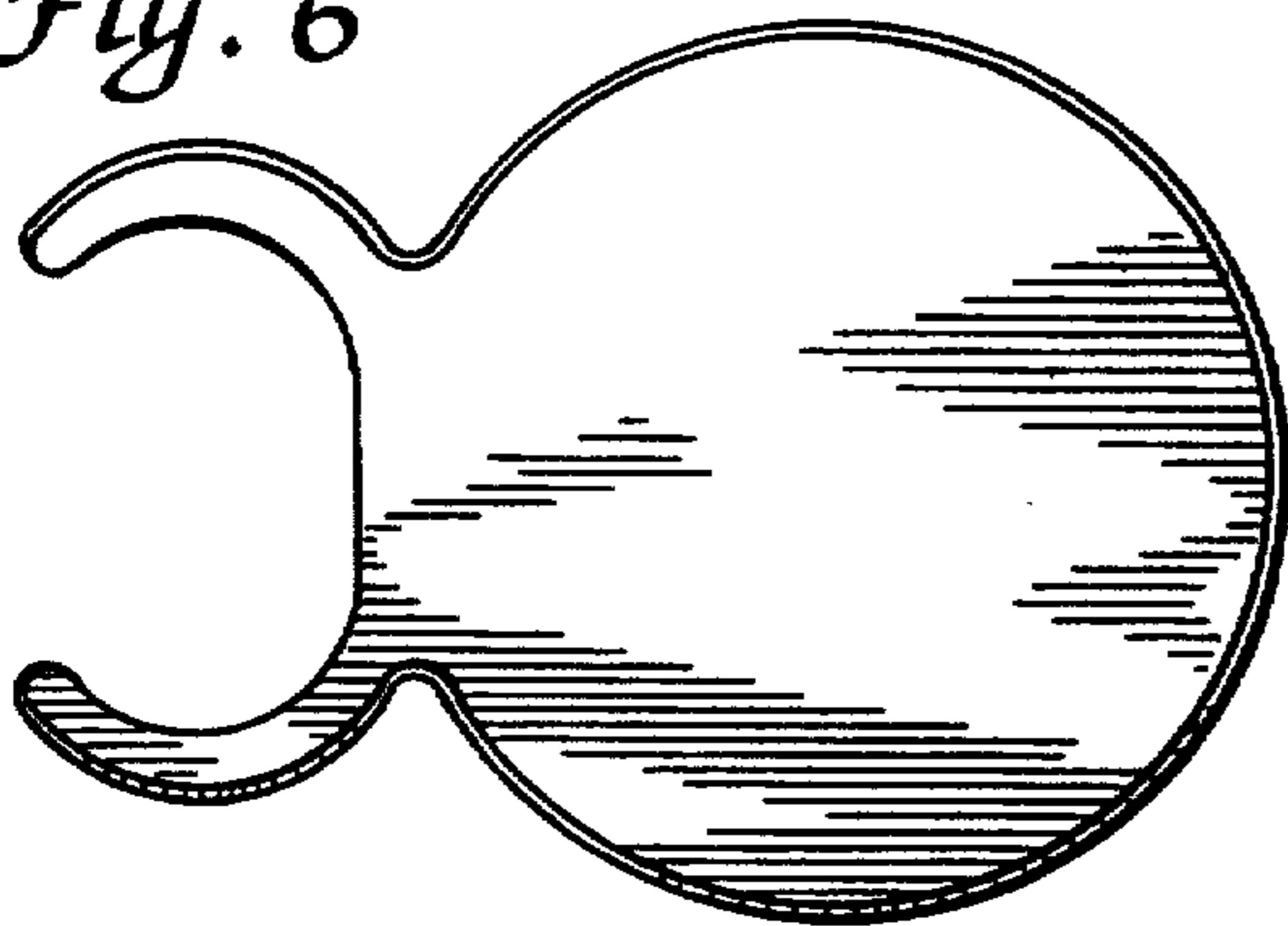

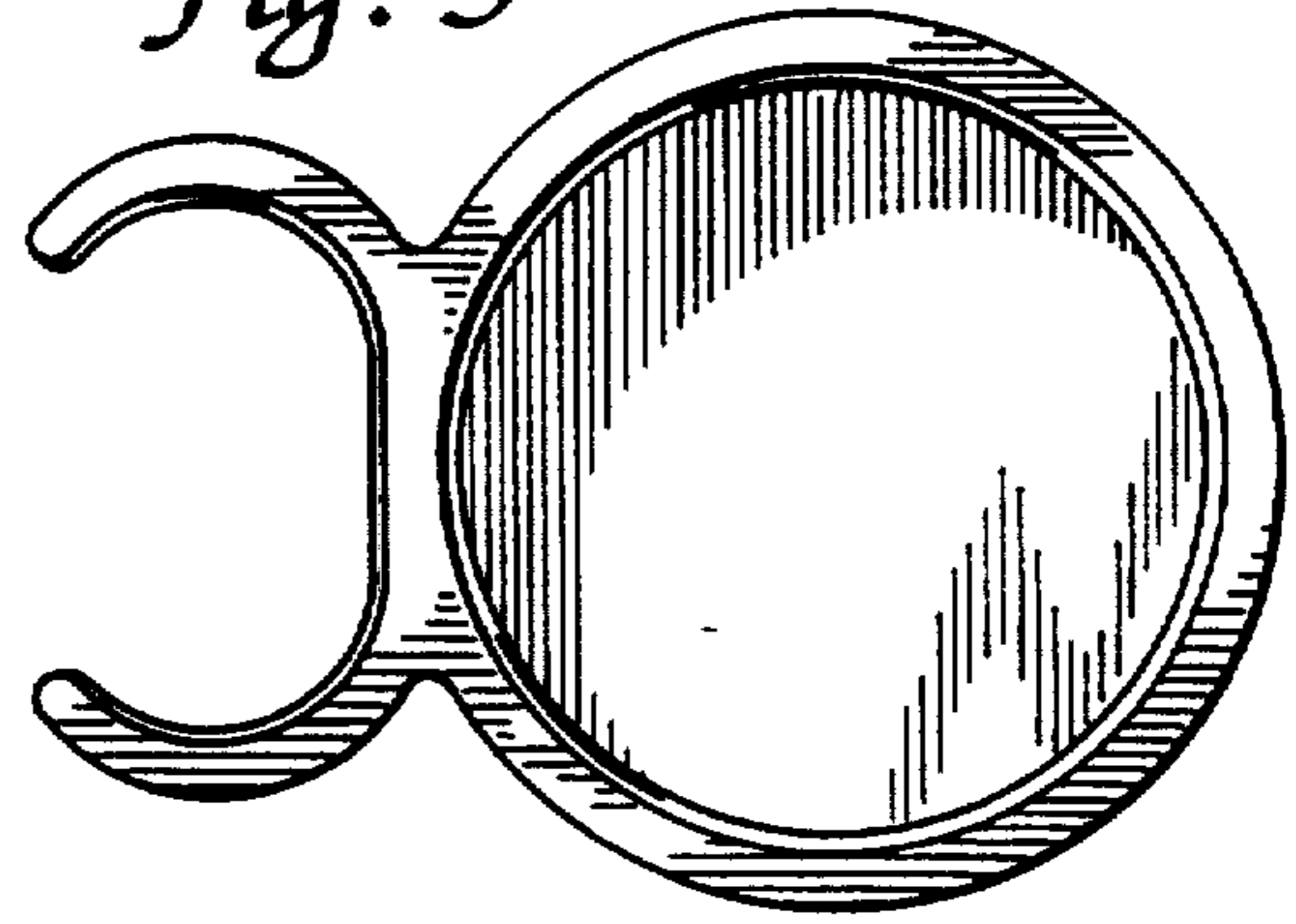

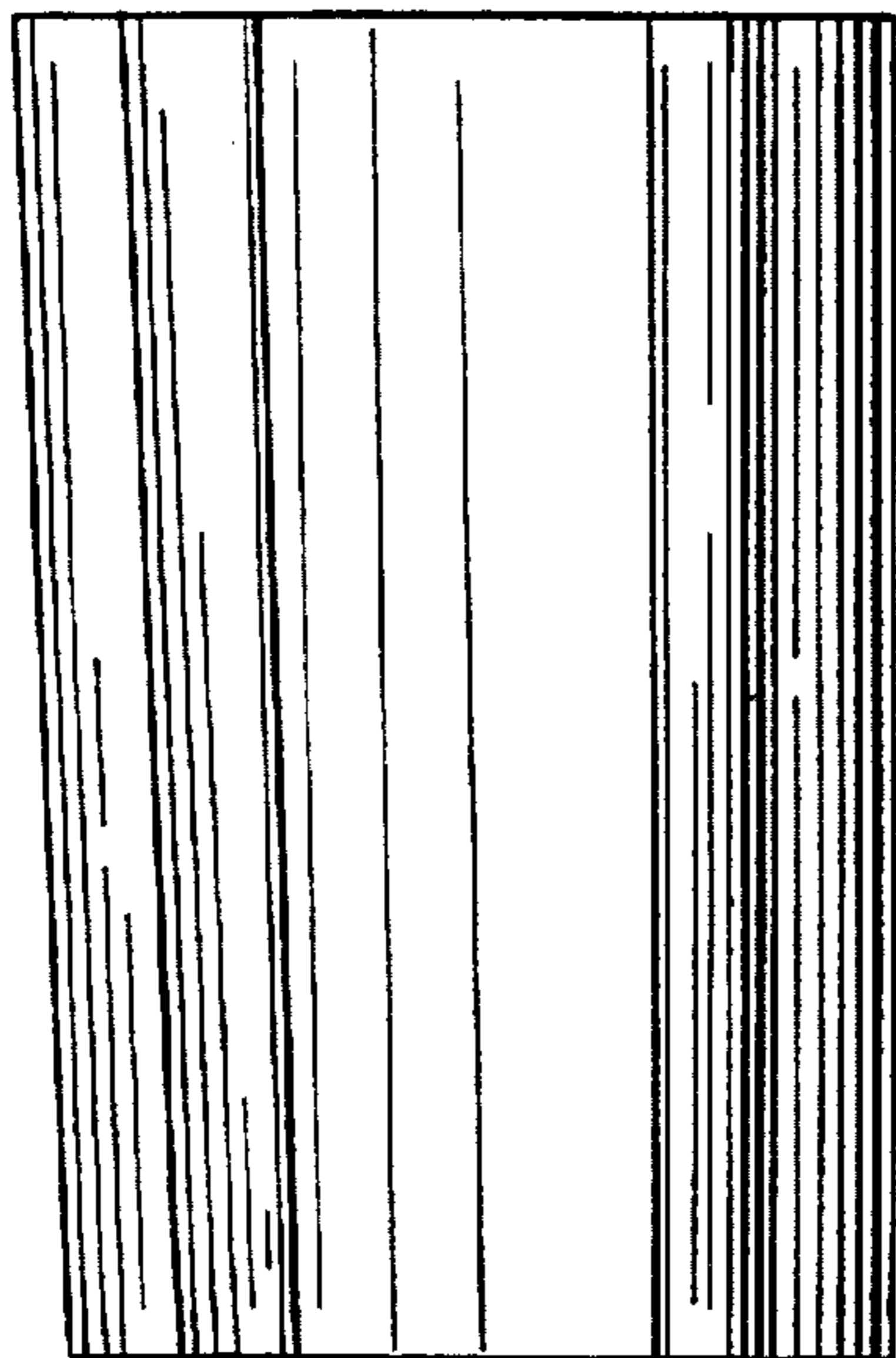

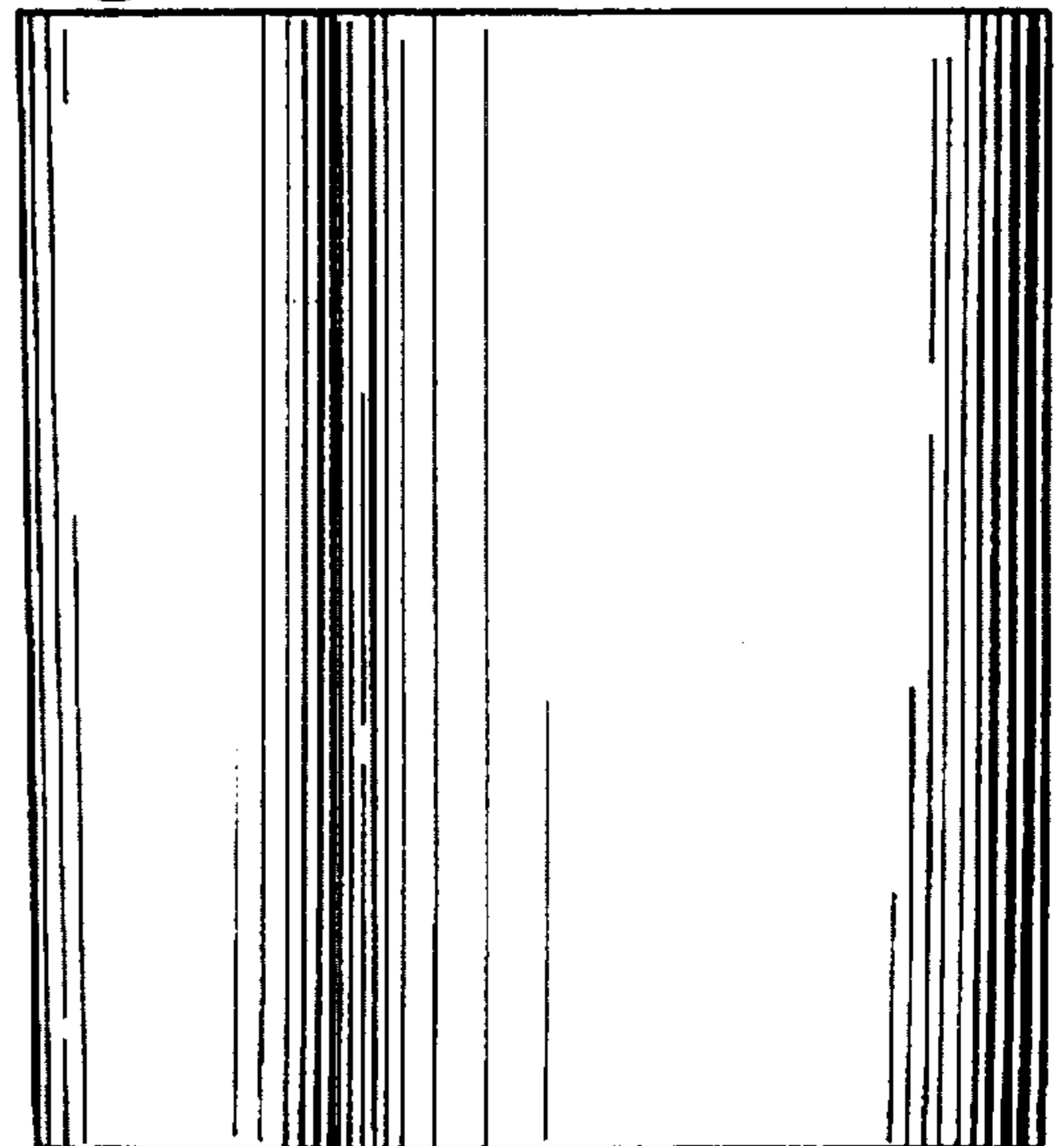

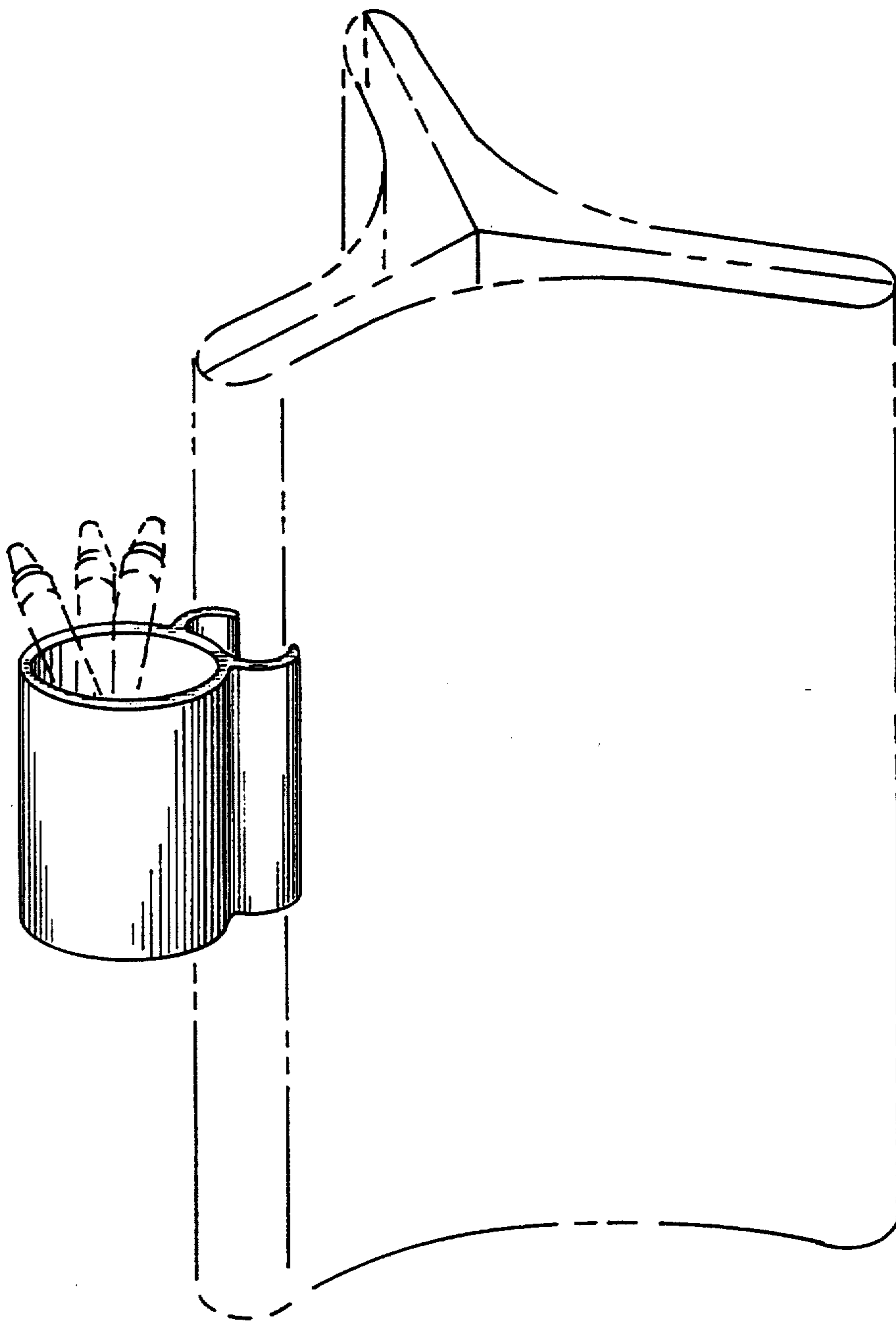
