FIG. 1 is a top left front perspective view of a base for playground structure showing our new design;

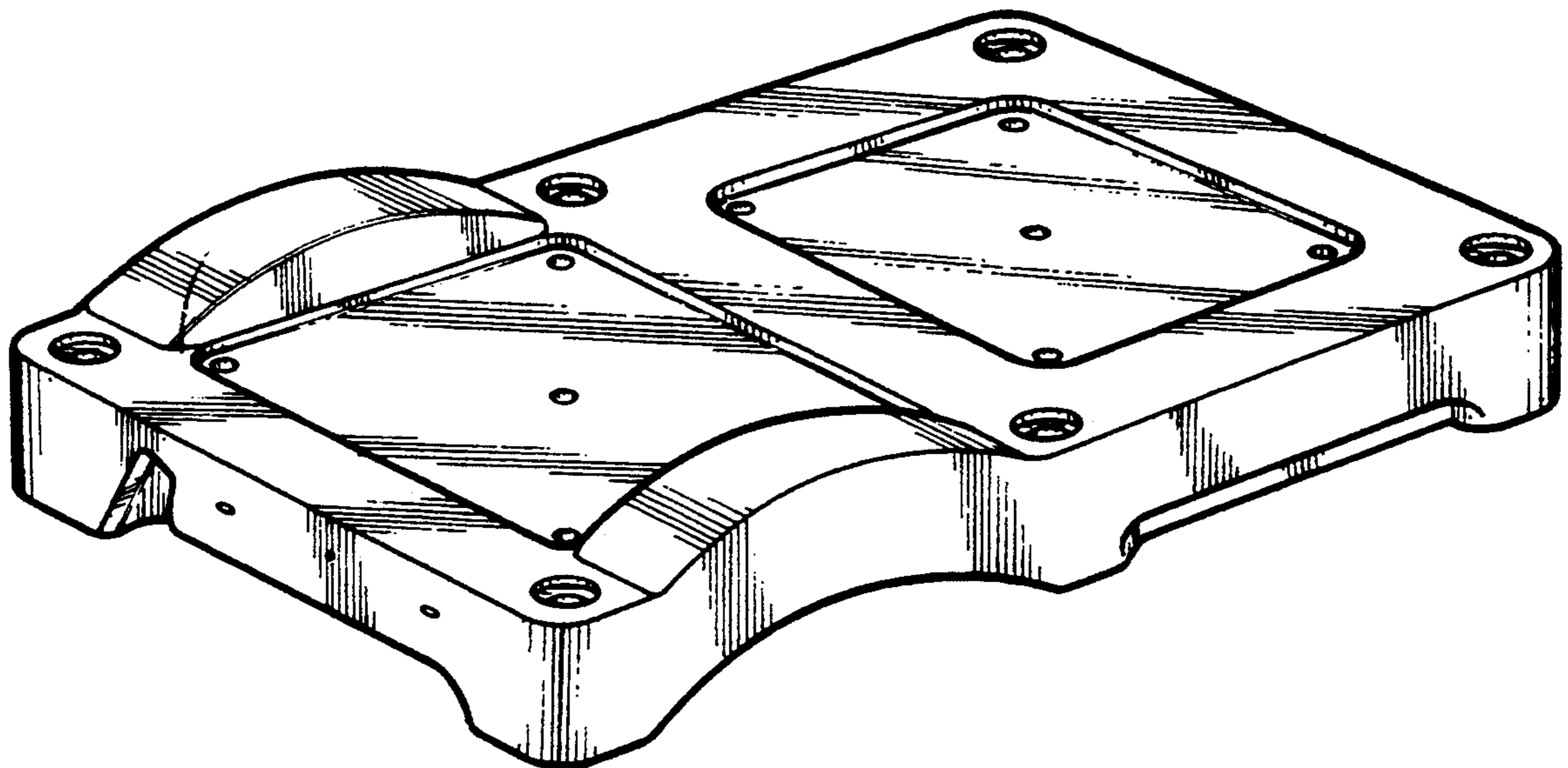
FIG. 2 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof.



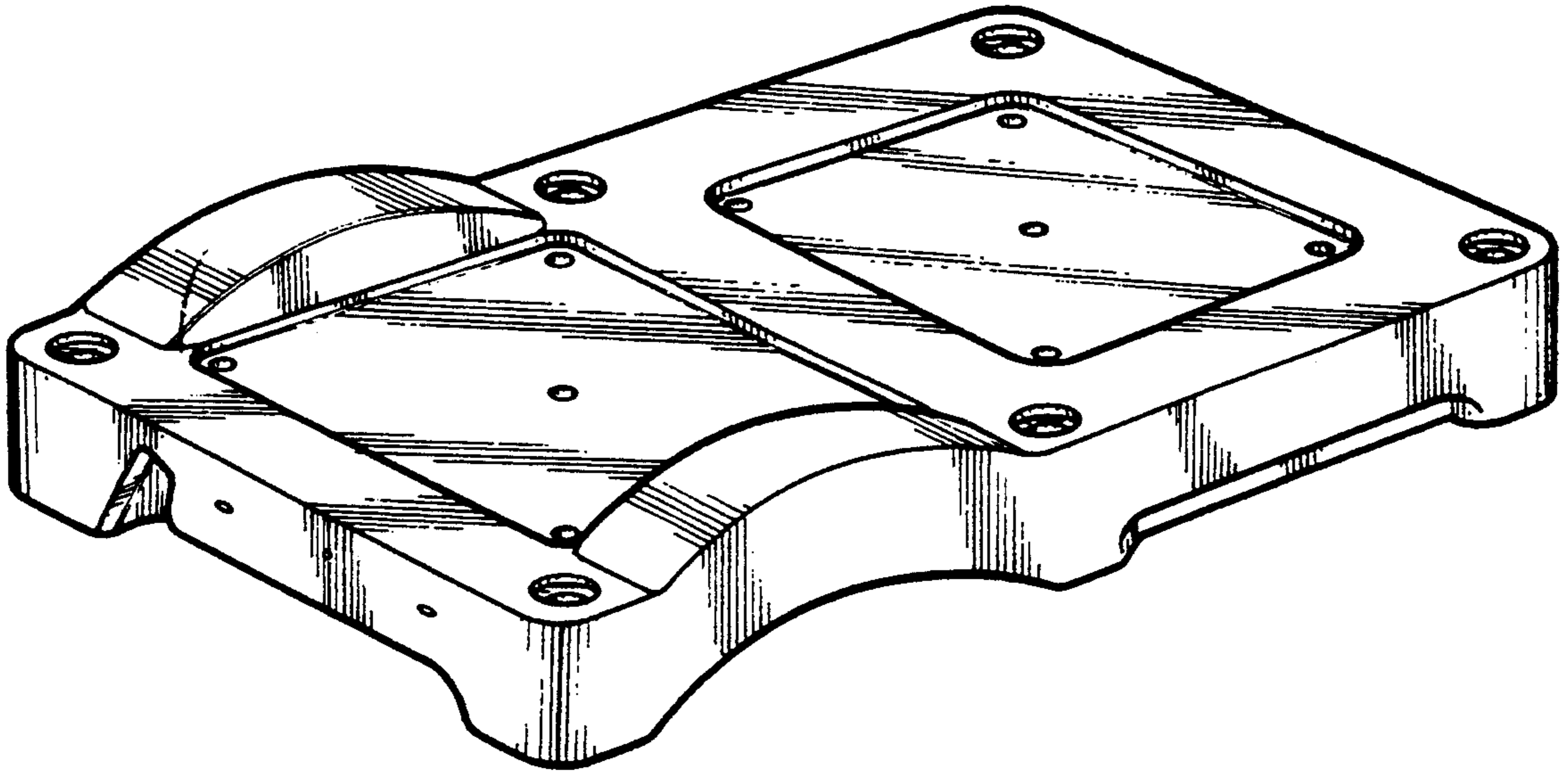

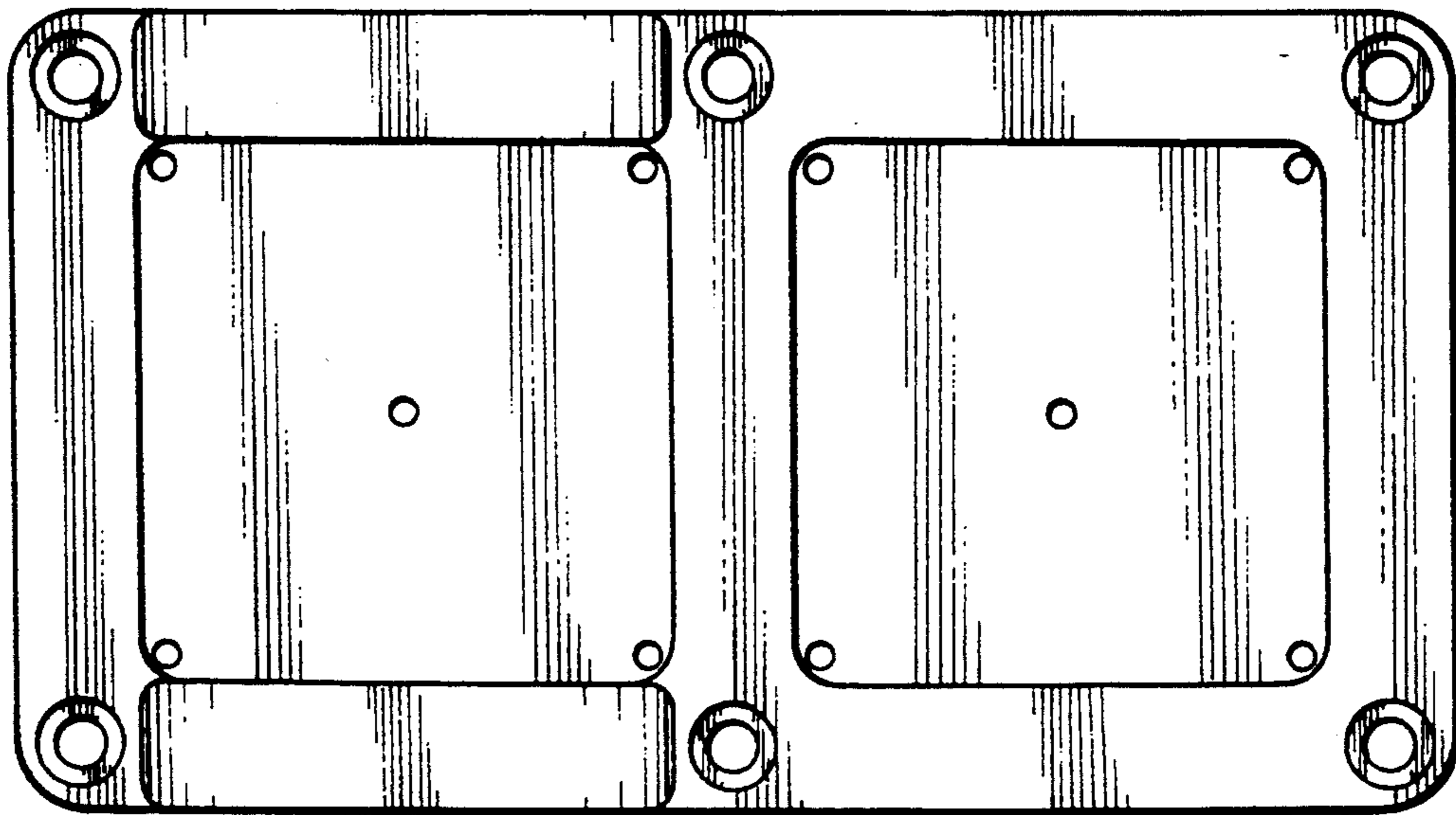

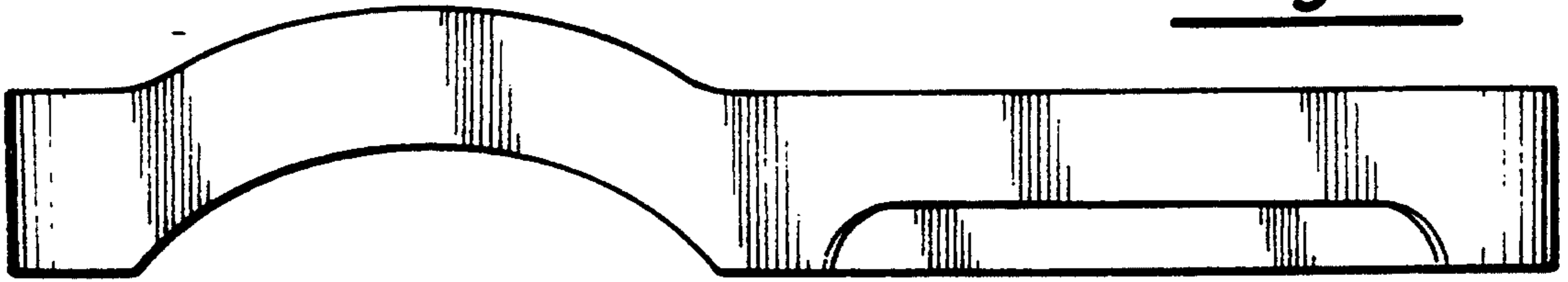

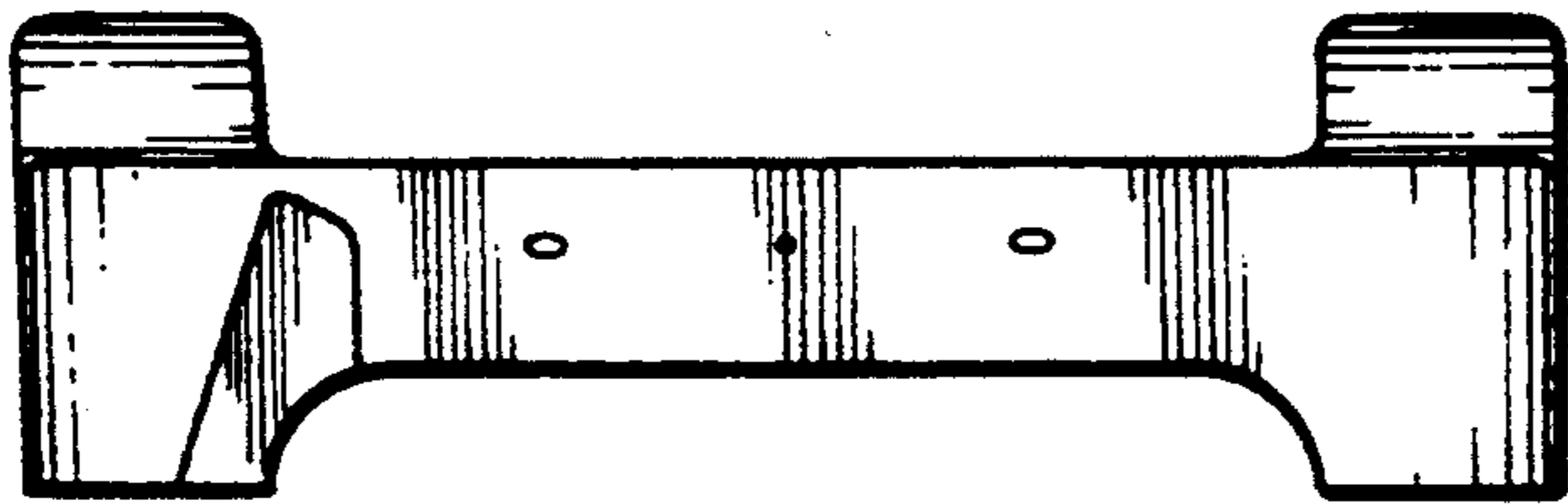

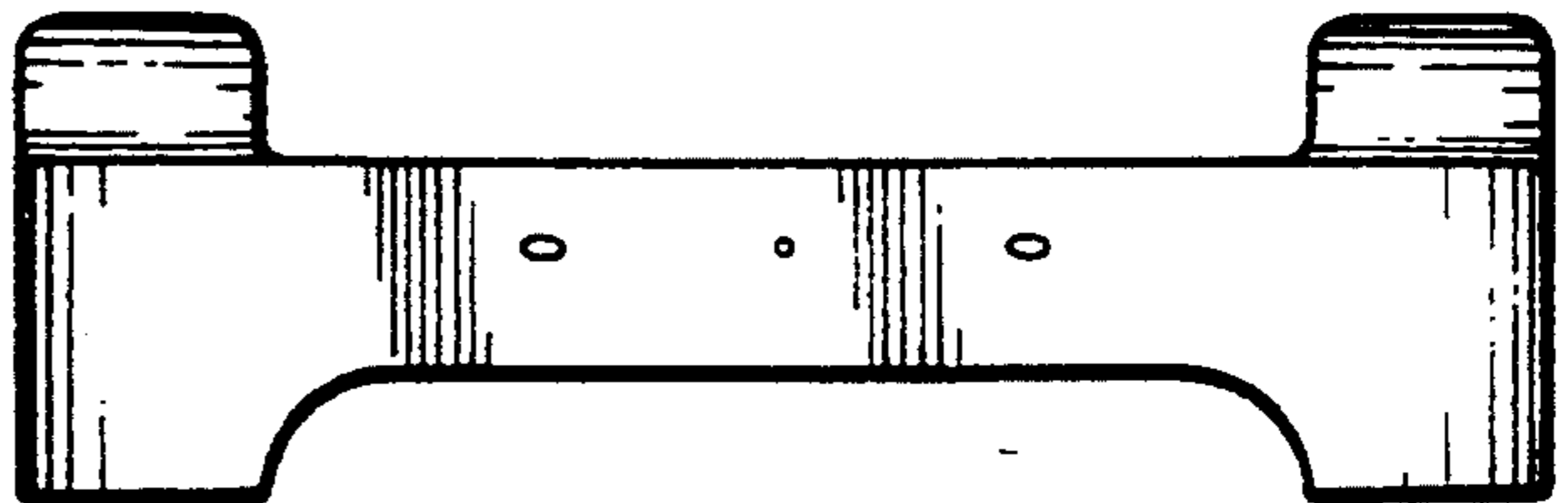
