The ornamental design for a tub spout, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and right side of a tub spout showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 9 is a top plan view of FIG. 8;

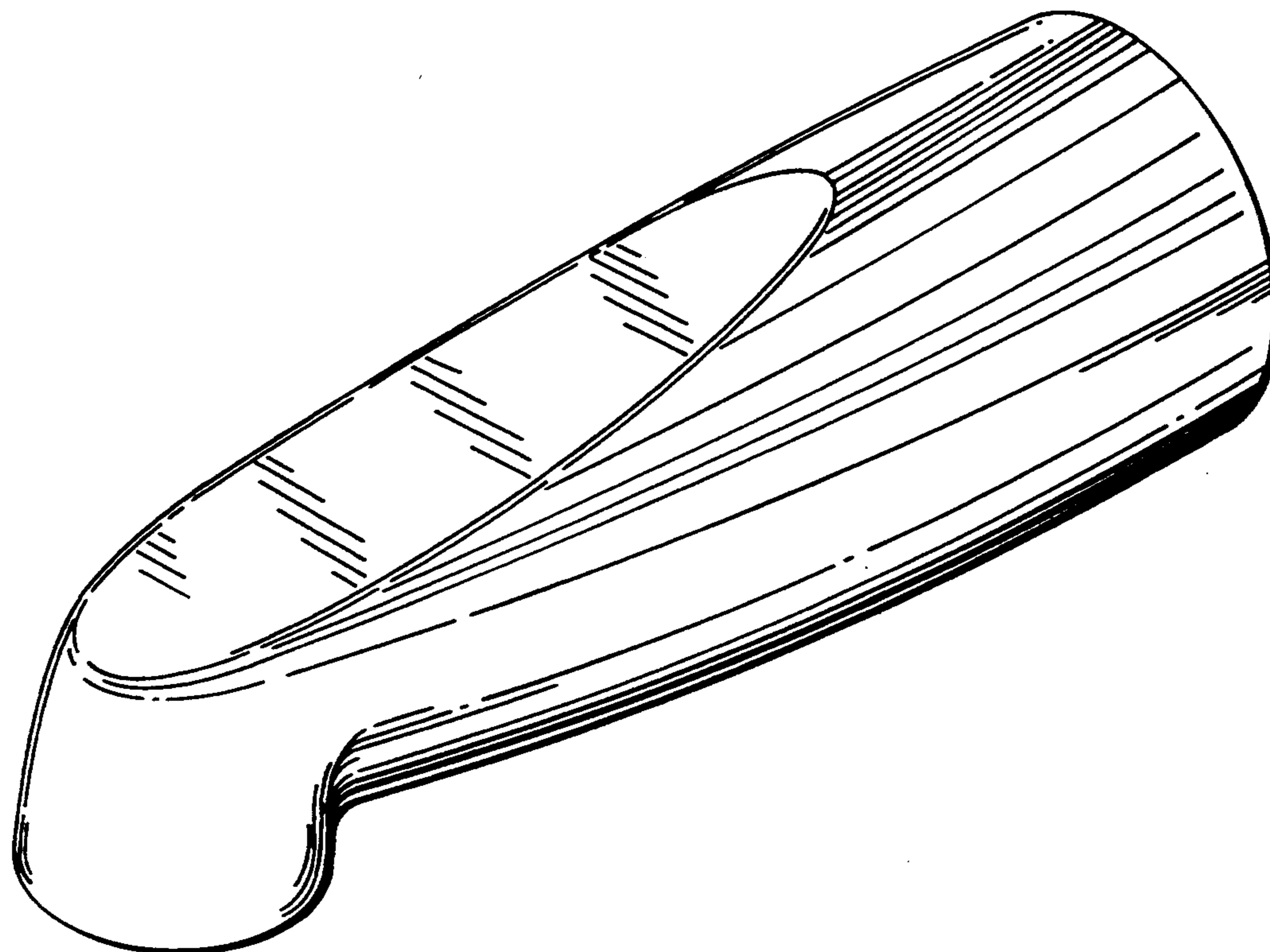
FIG. 10 is a bottom plan view of FIG. 8;

FIG. 14 is a rear elevational view of FIG. 8.



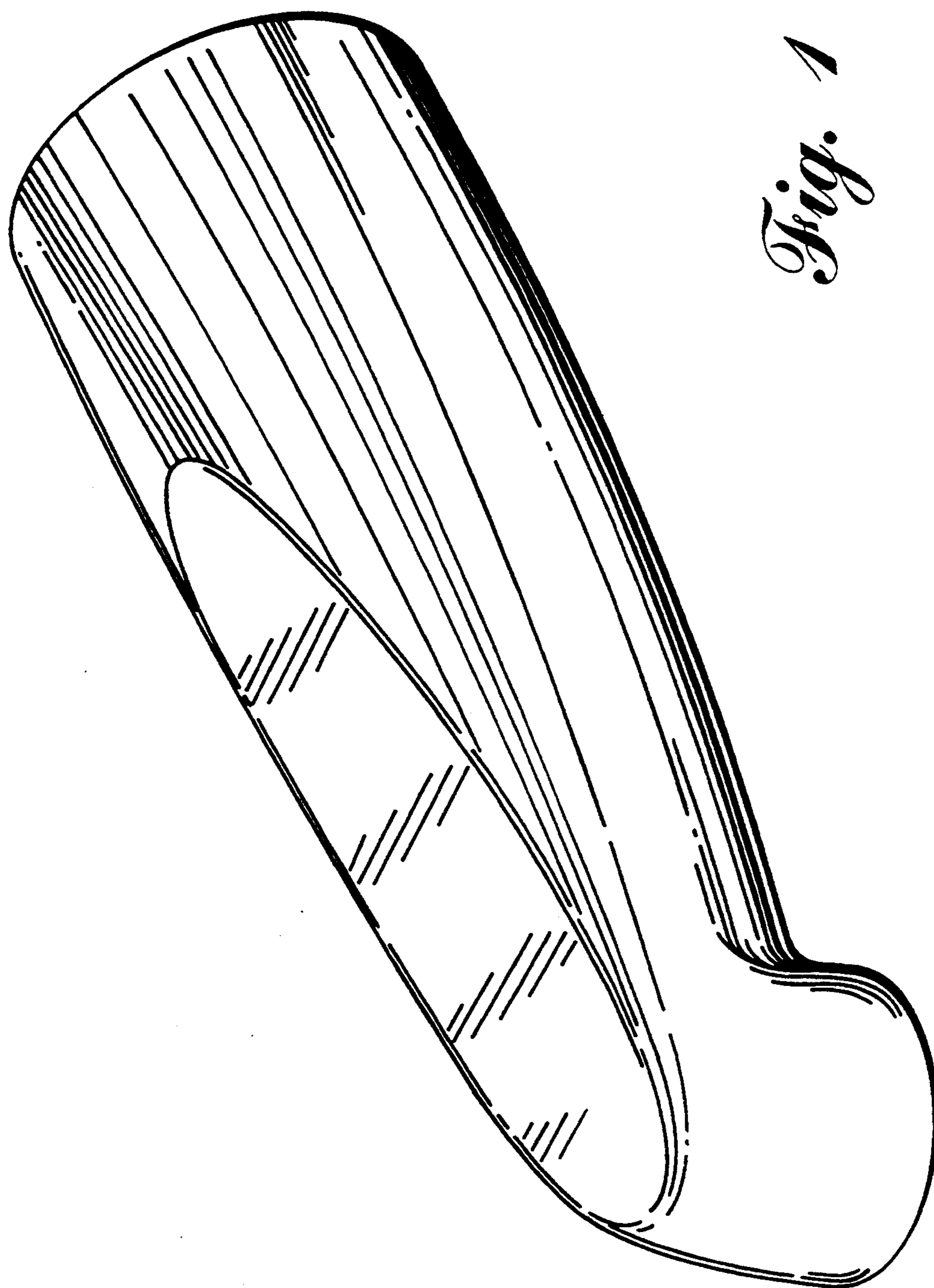

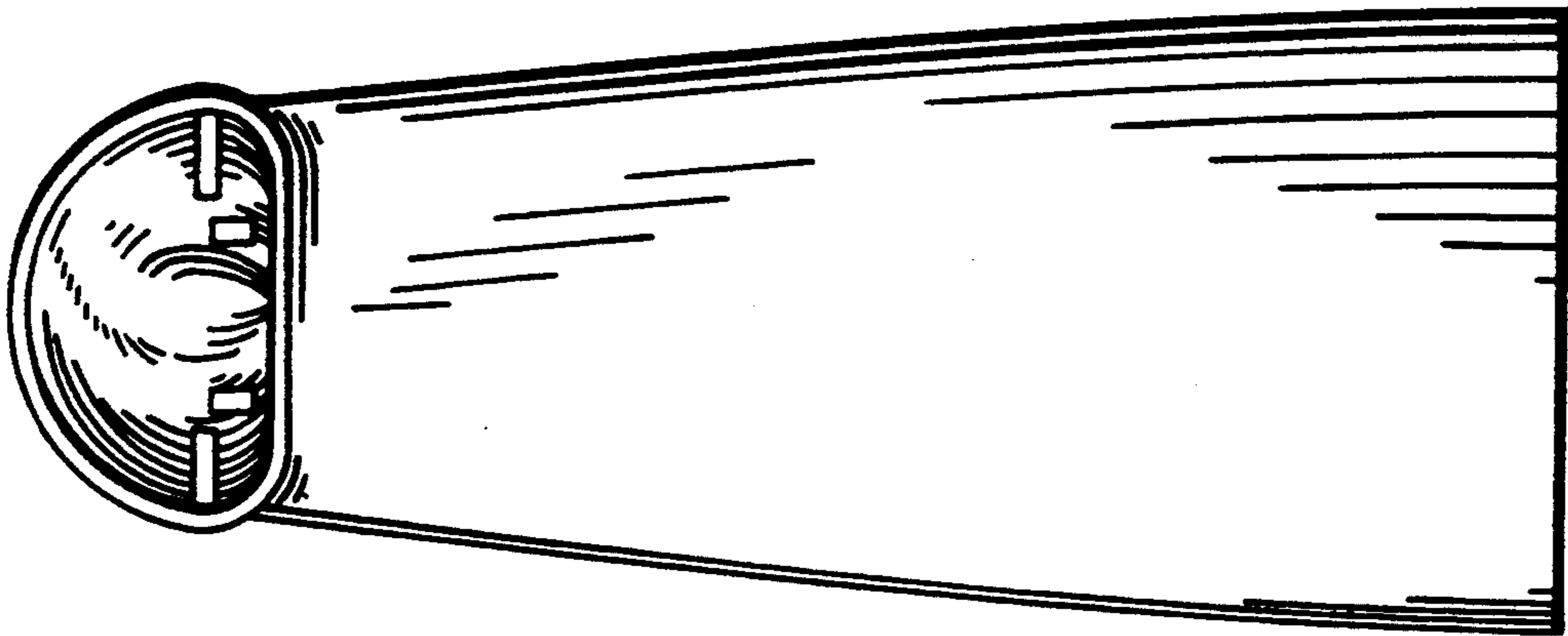

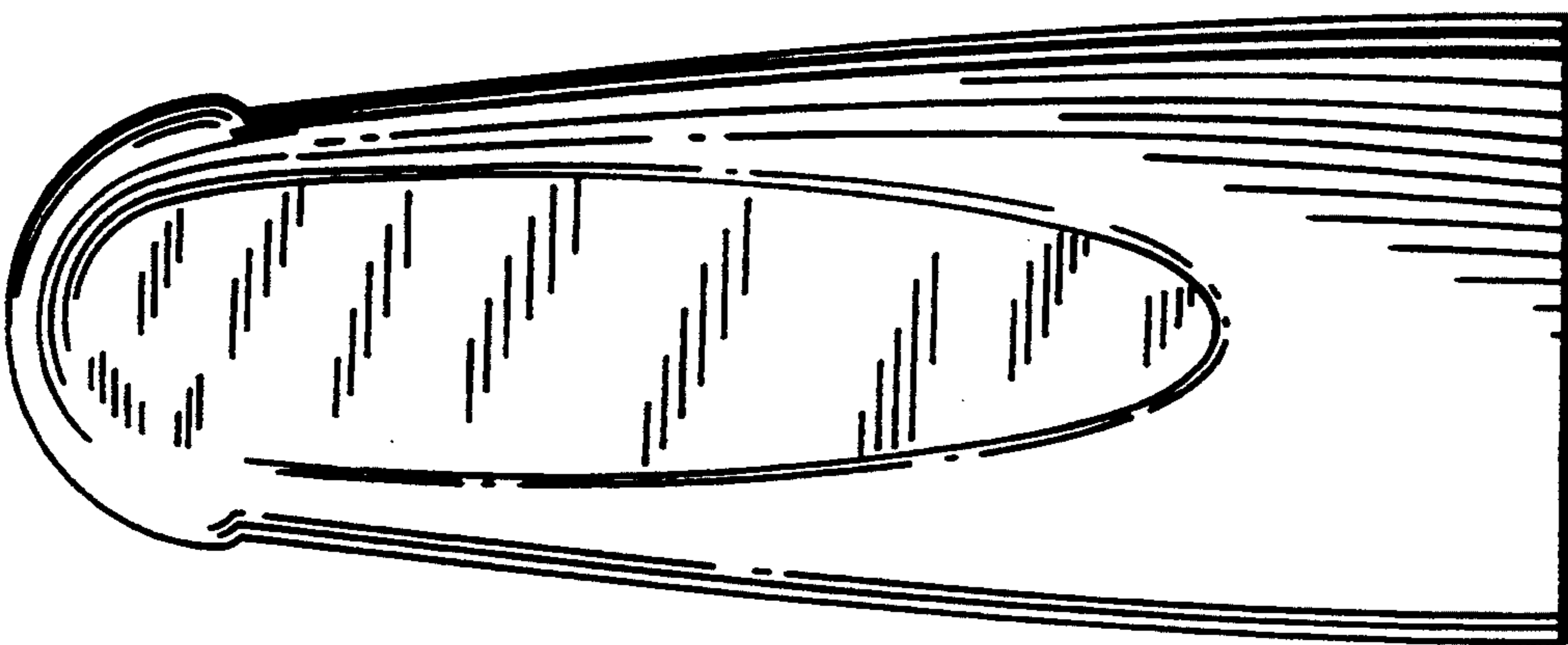

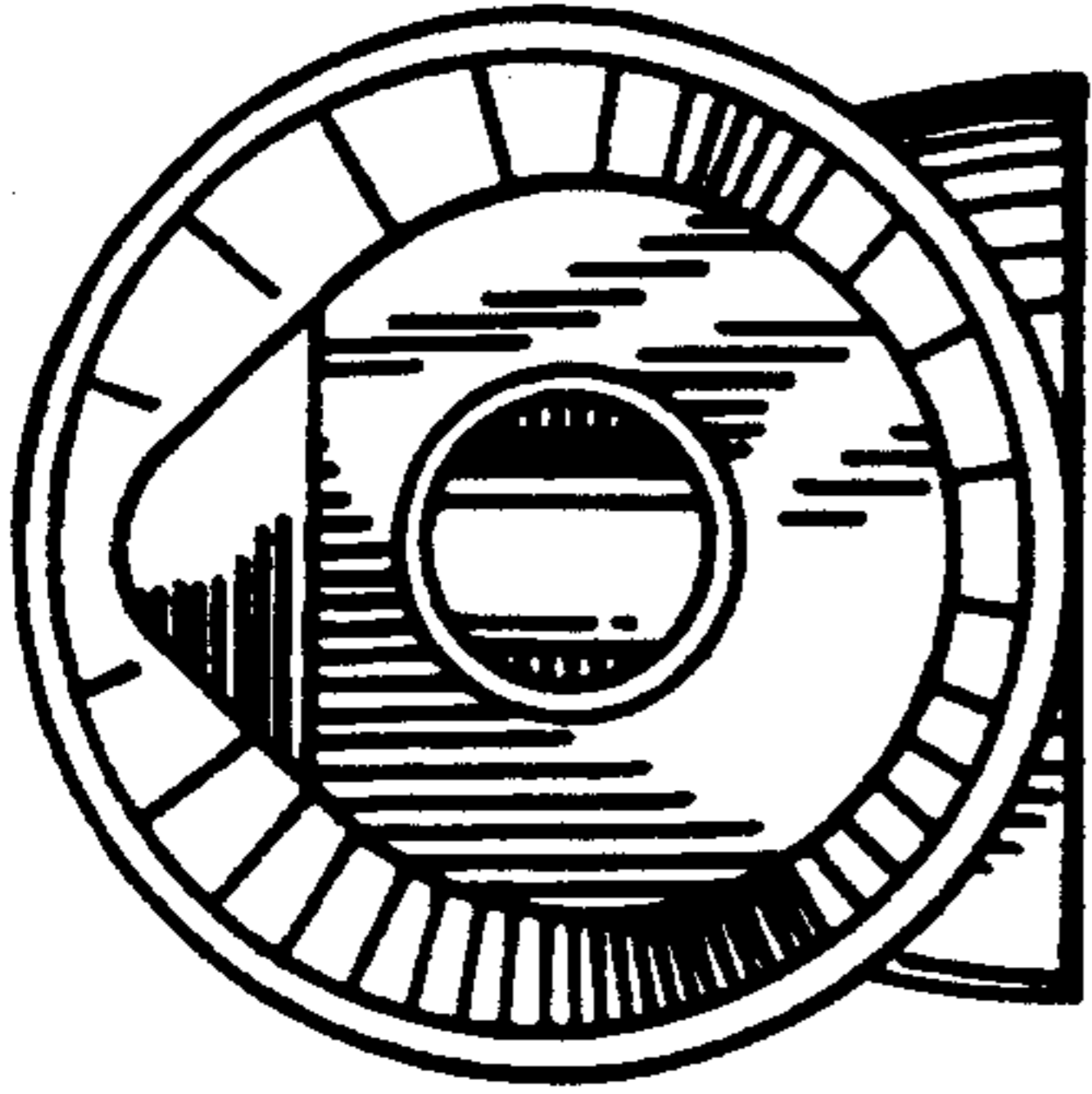

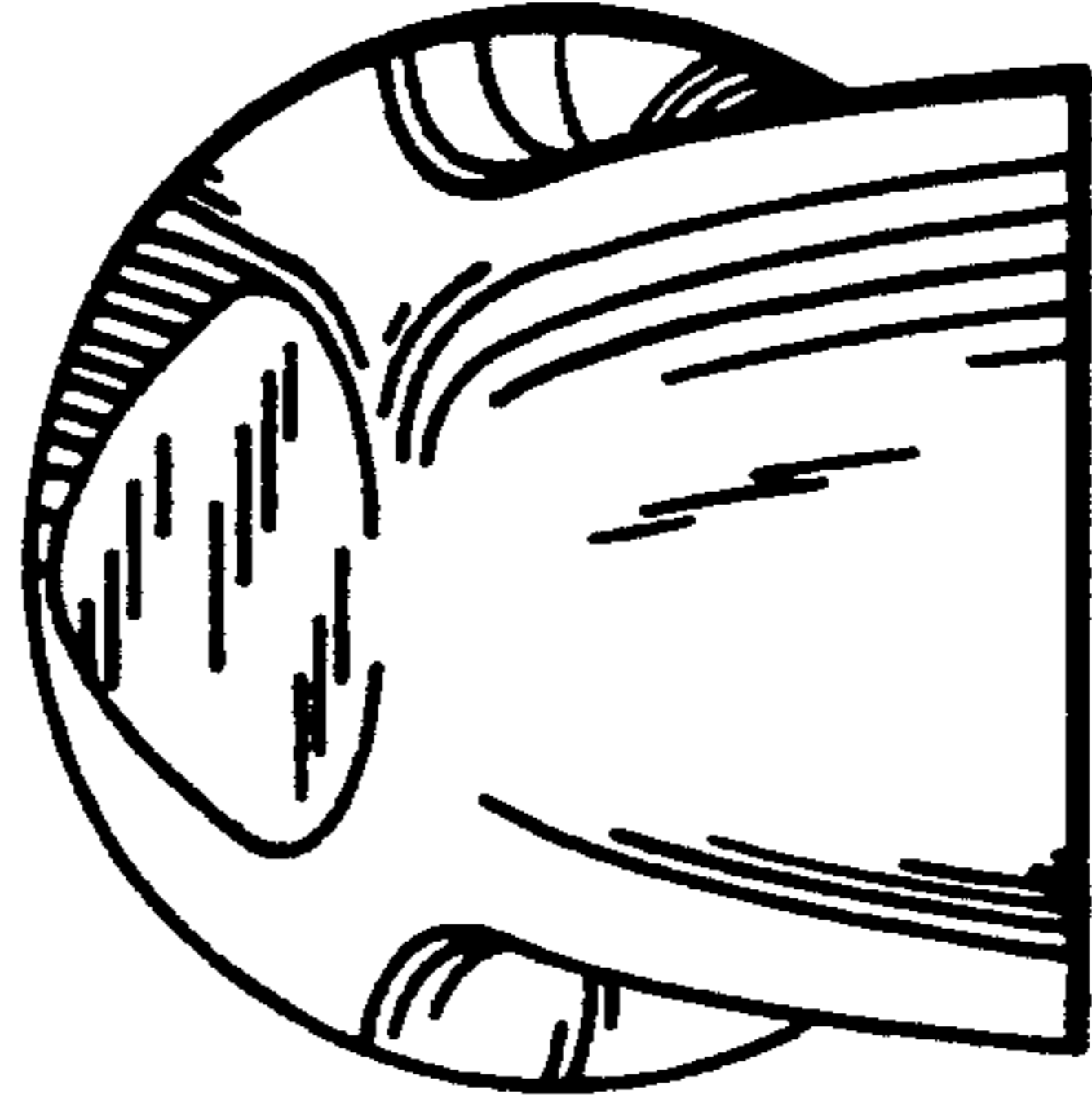

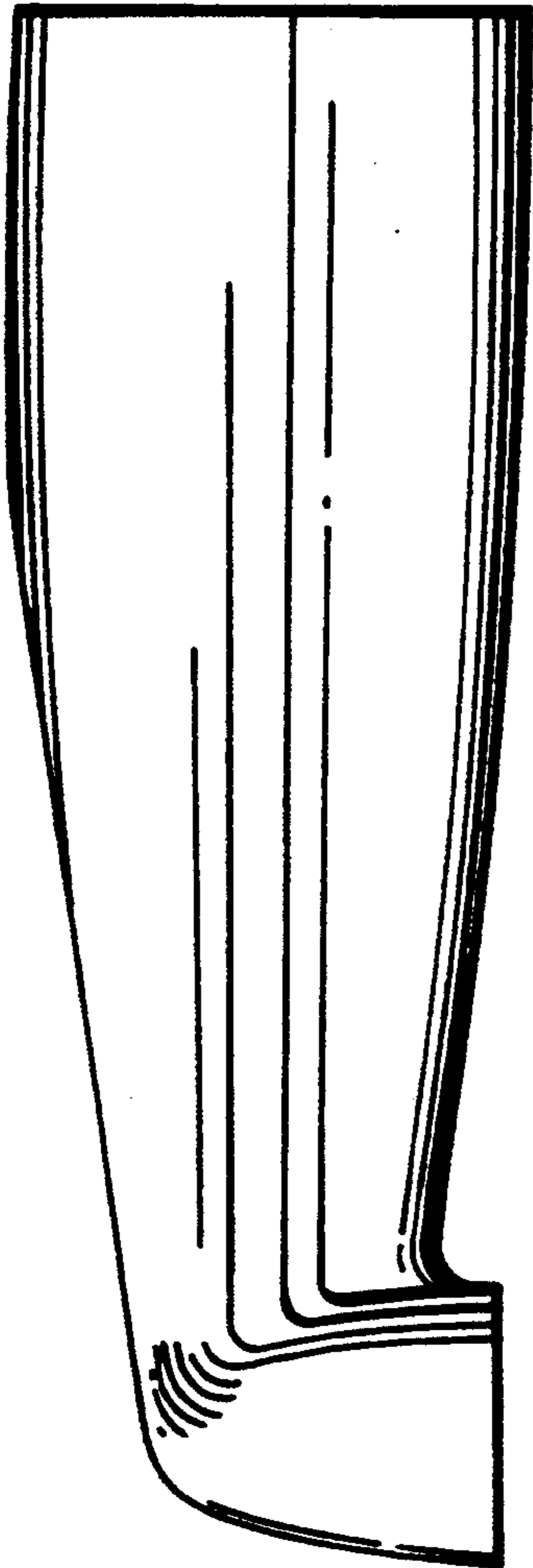

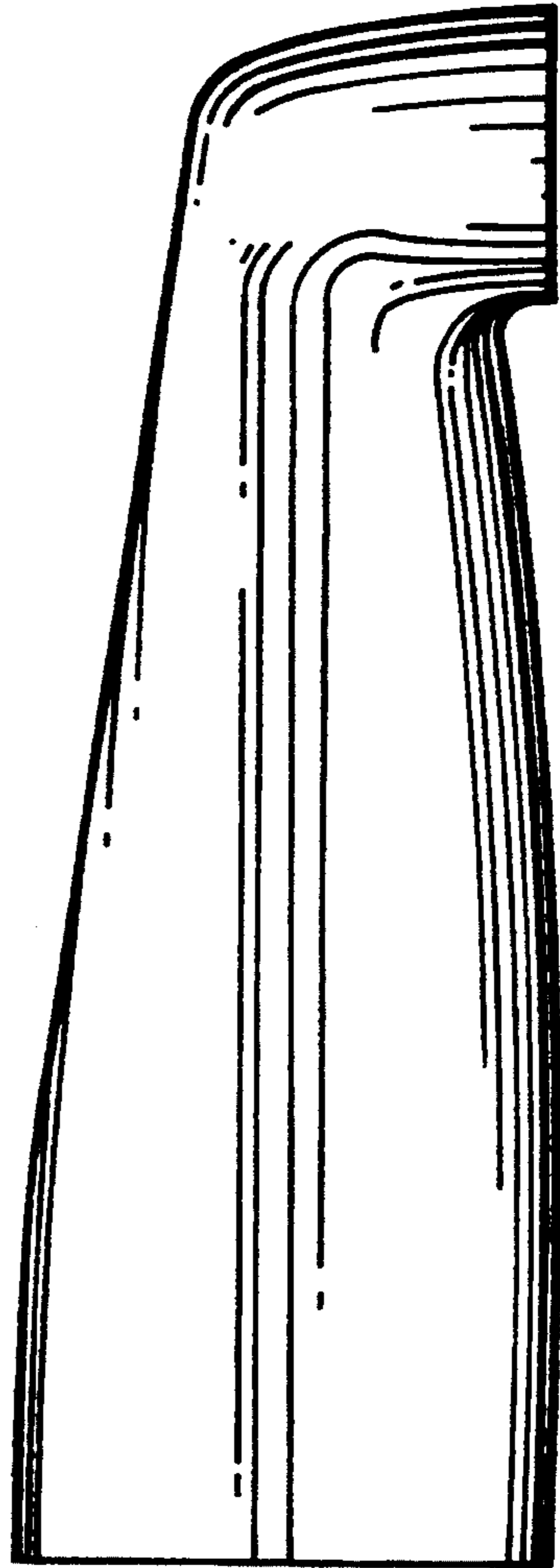

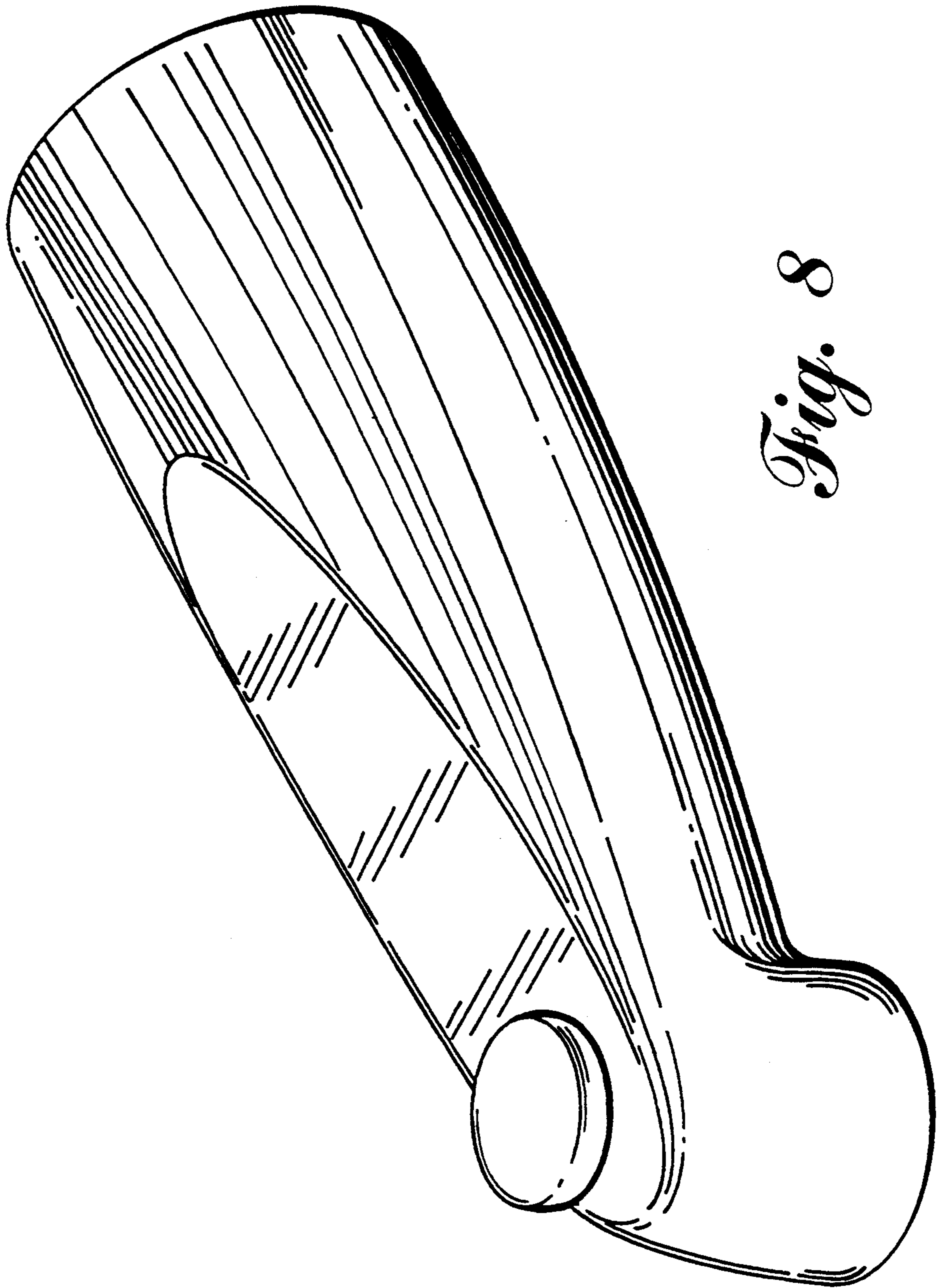

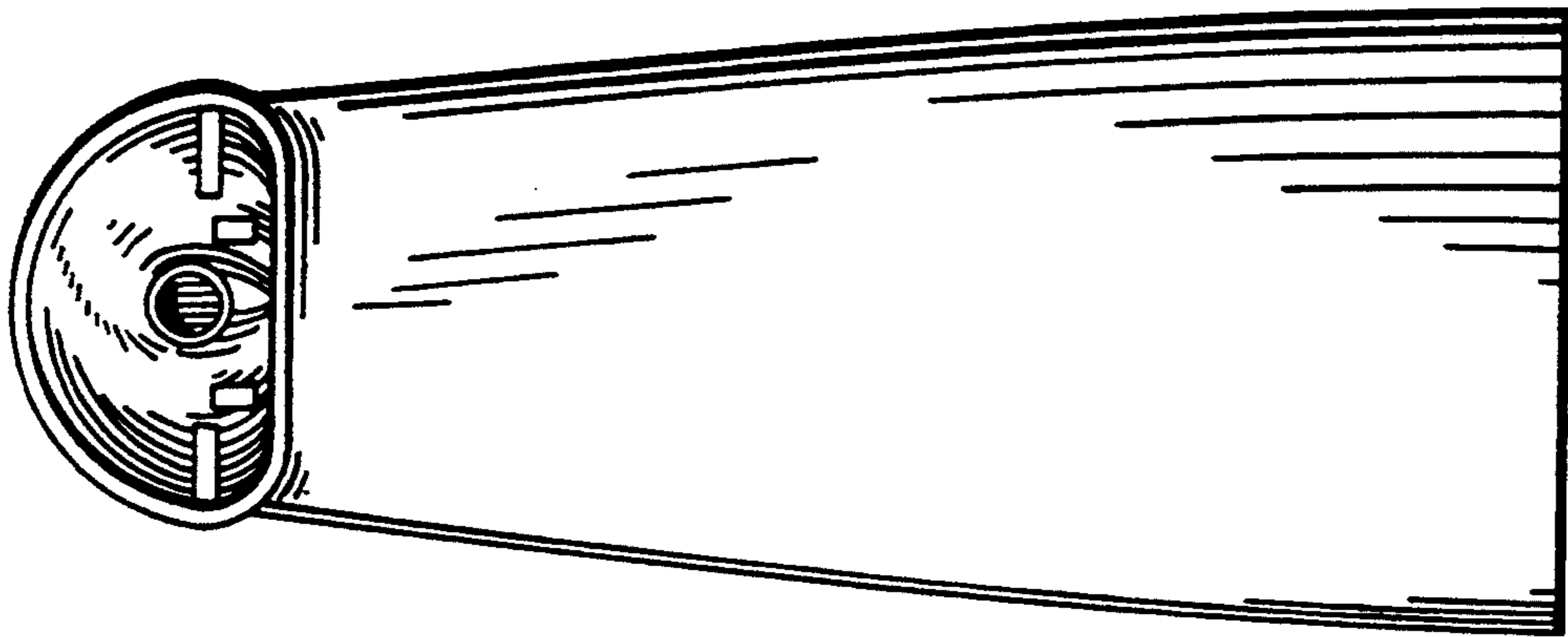

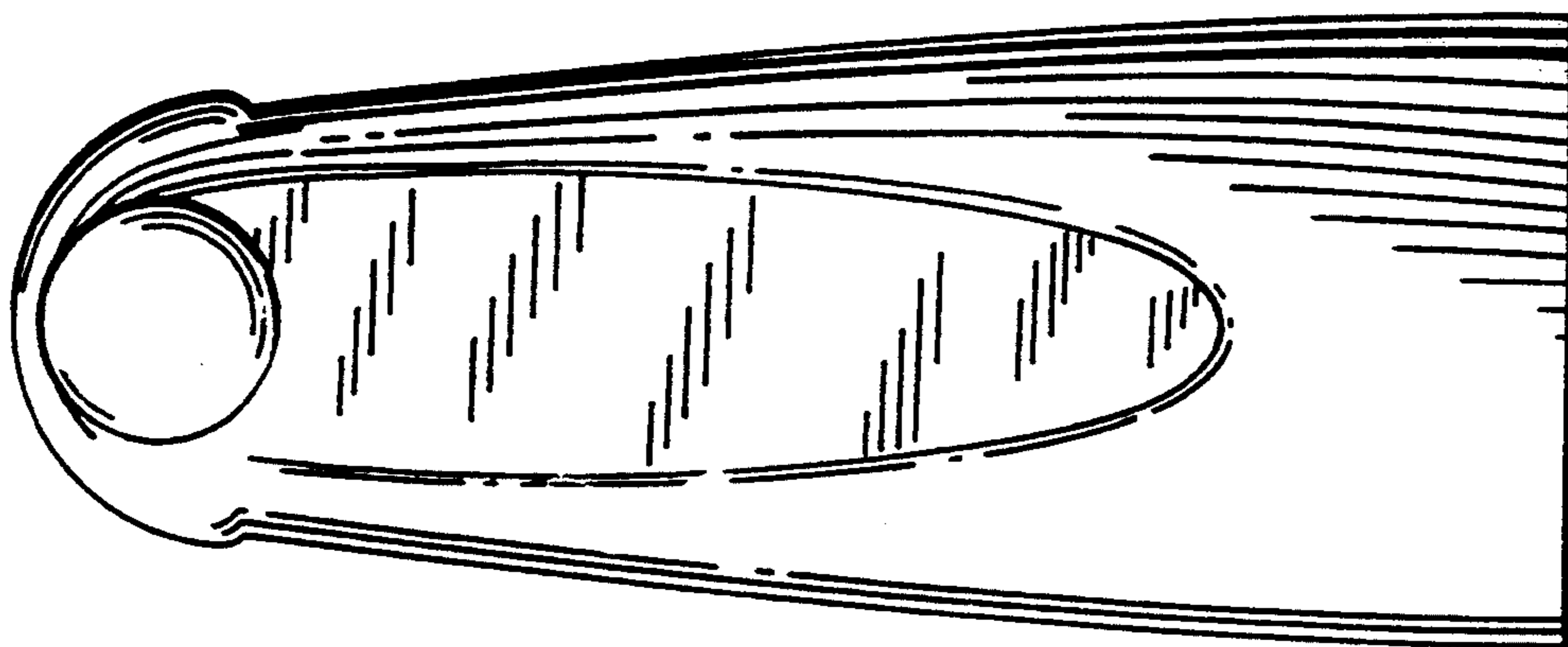

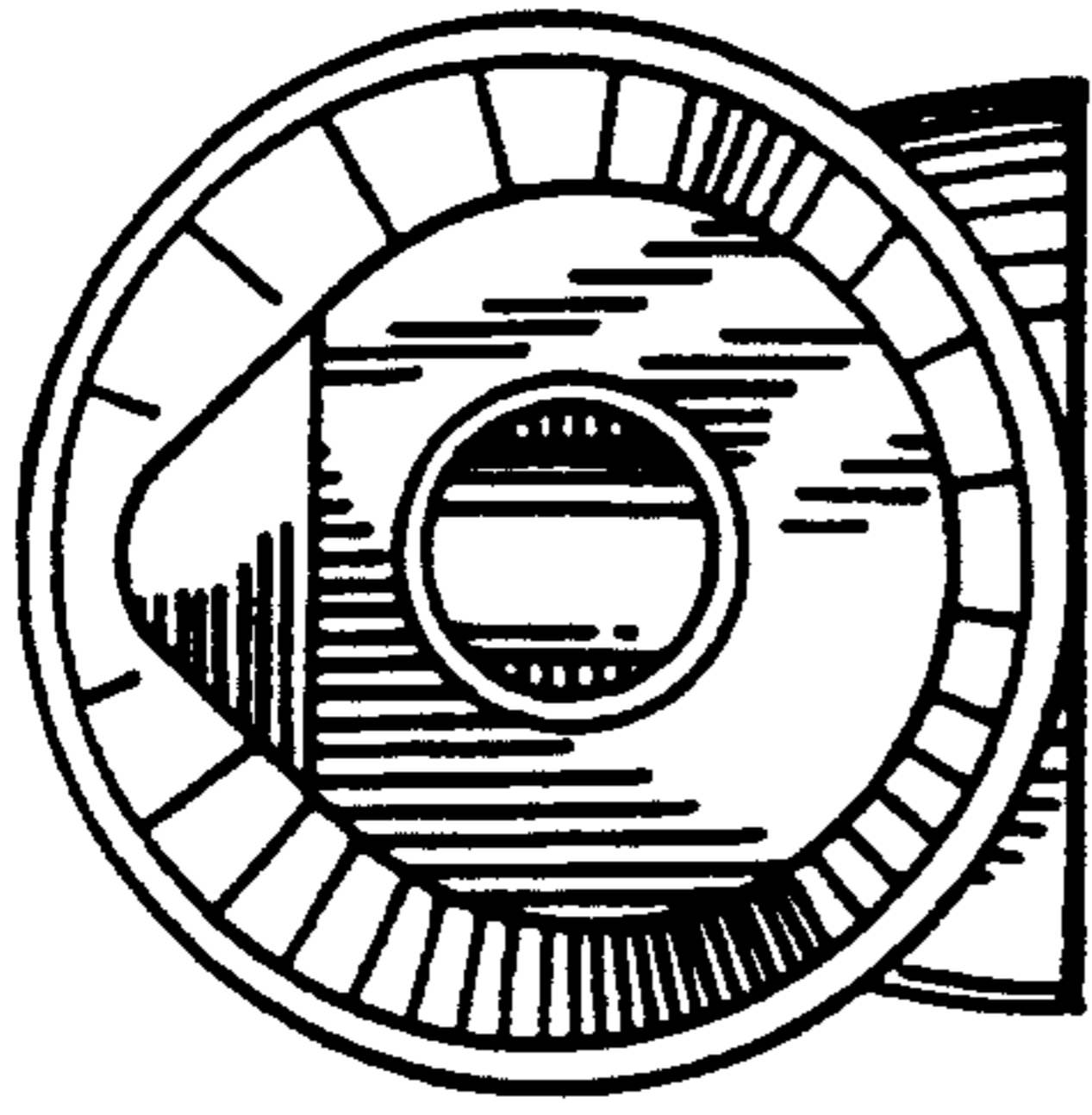

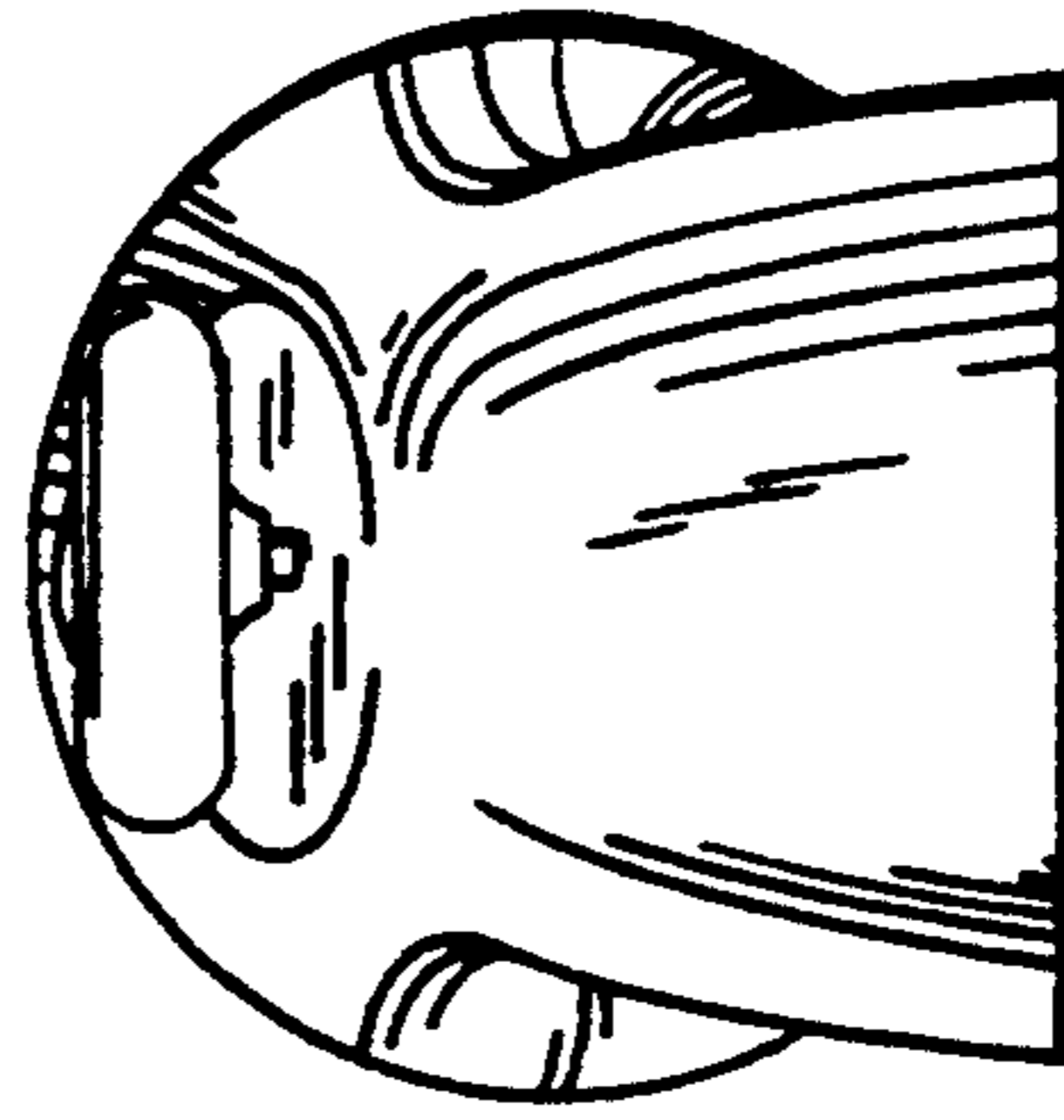

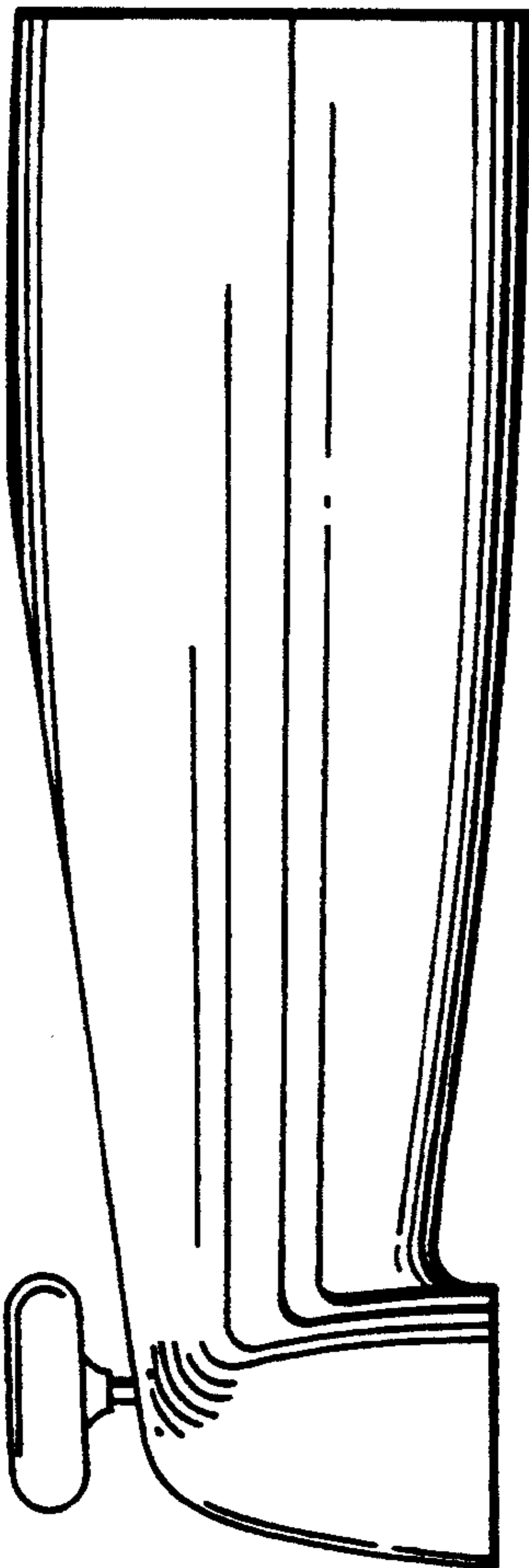

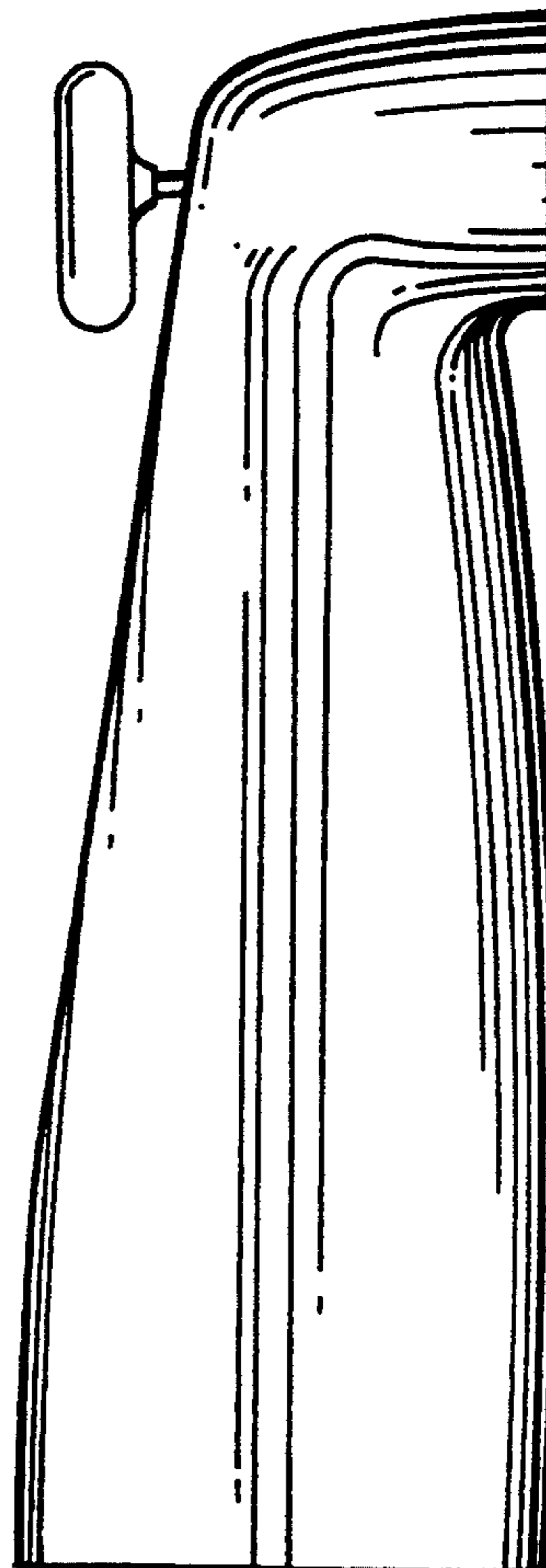
