[57] **CLAIM**

The ornamental design for a lamp cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a lamp cover showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevational view thereof showing the right hand side, the left hand side being a mirror image;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a top, front, right side perspective view thereof;

FIG. 7 is a right side, back, bottom perspective view thereof;

FIG. 8 is a horizontal cross sectional view thereof taken on the line 8—8 in FIG. 2;

FIG. 9 is a vertical sectional view thereof taken on the line 9—9 in FIG. 3;

FIG. 10 is a vertical sectional view thereof taken on the line 10—10 in FIG. 2, and,

FIG. 11 is a front elevational view of the lamp cover shown mounted on a base, which is shown in broken lines for illustrative purposes only;

The lamp cover is transparent.

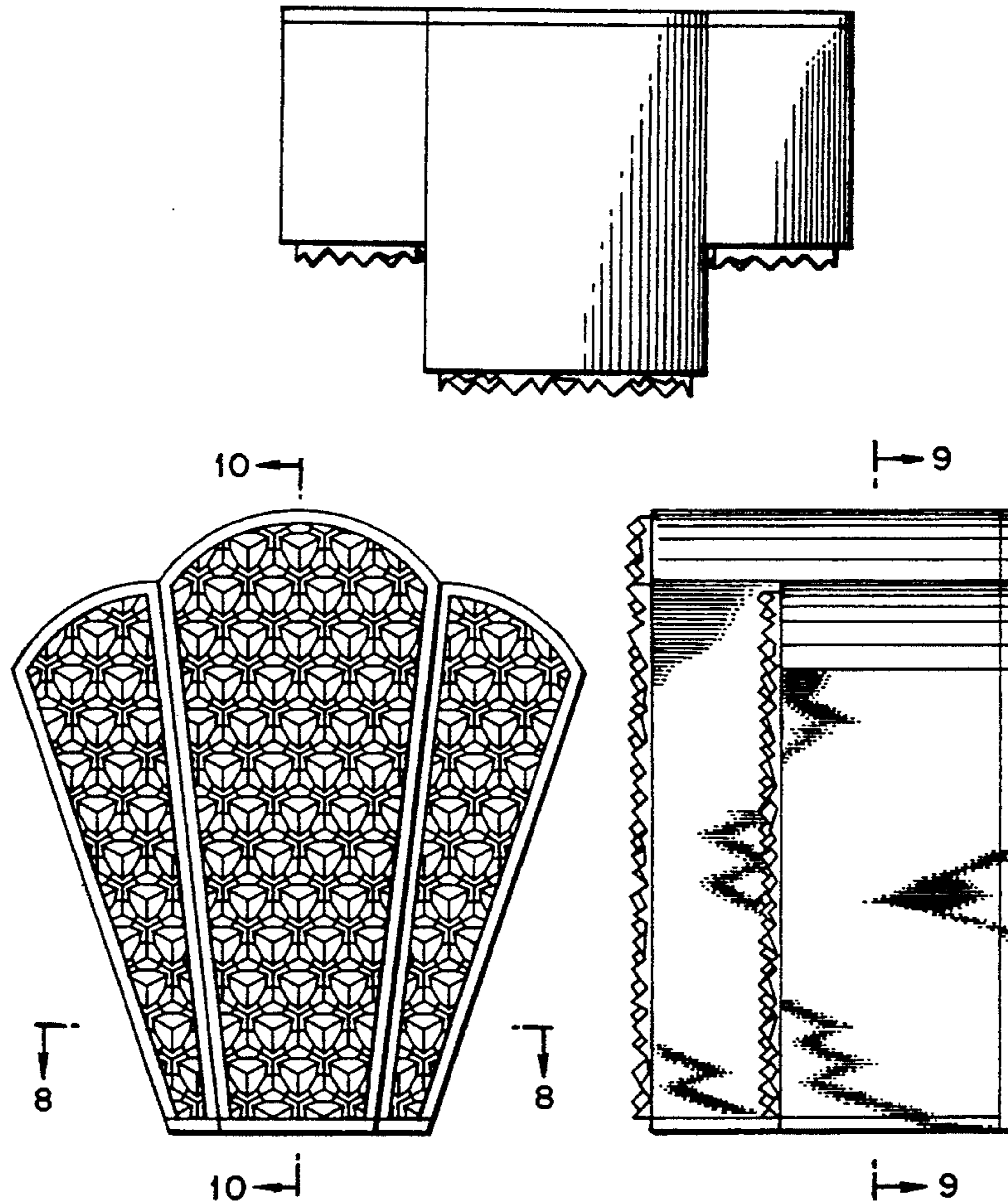

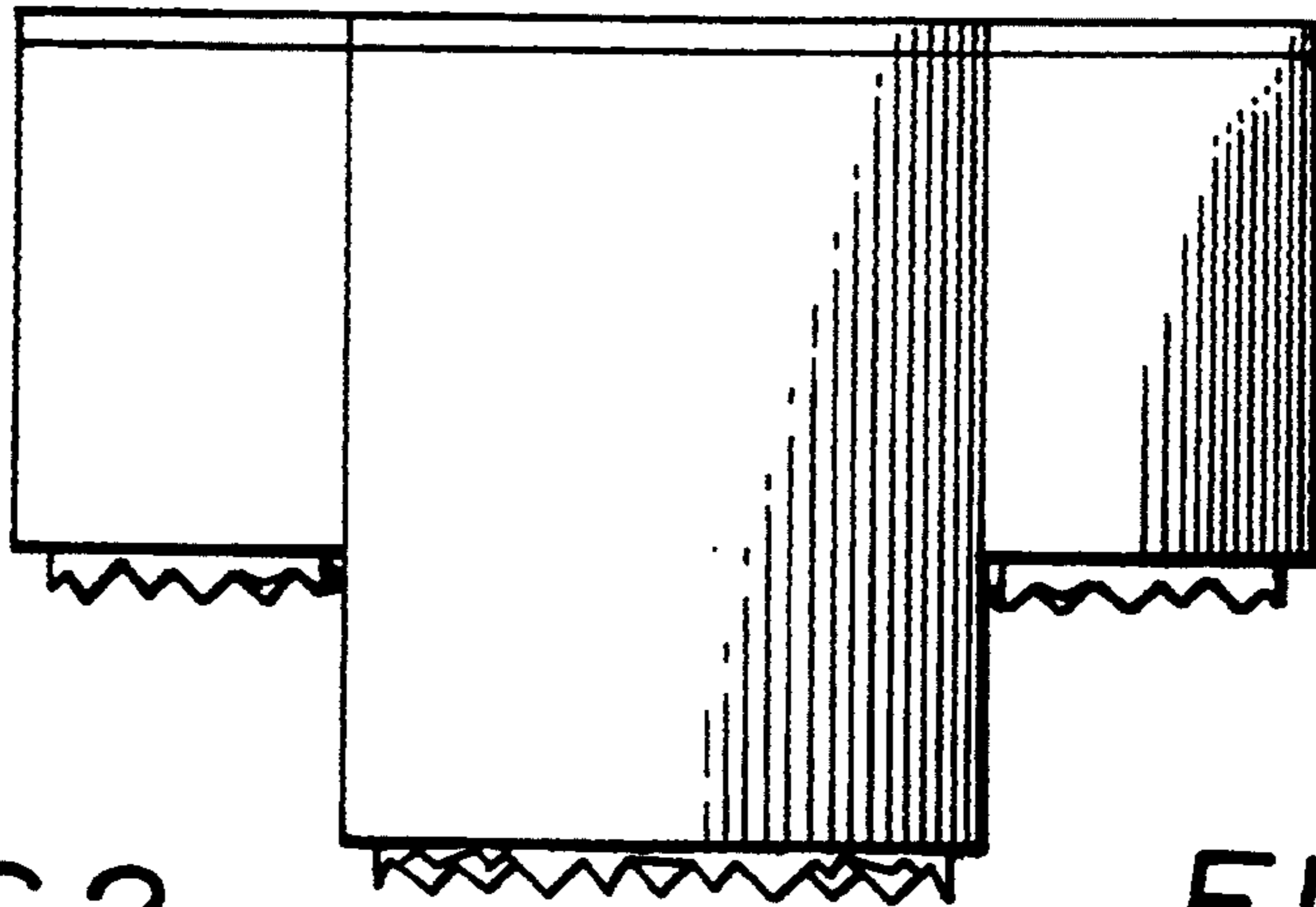
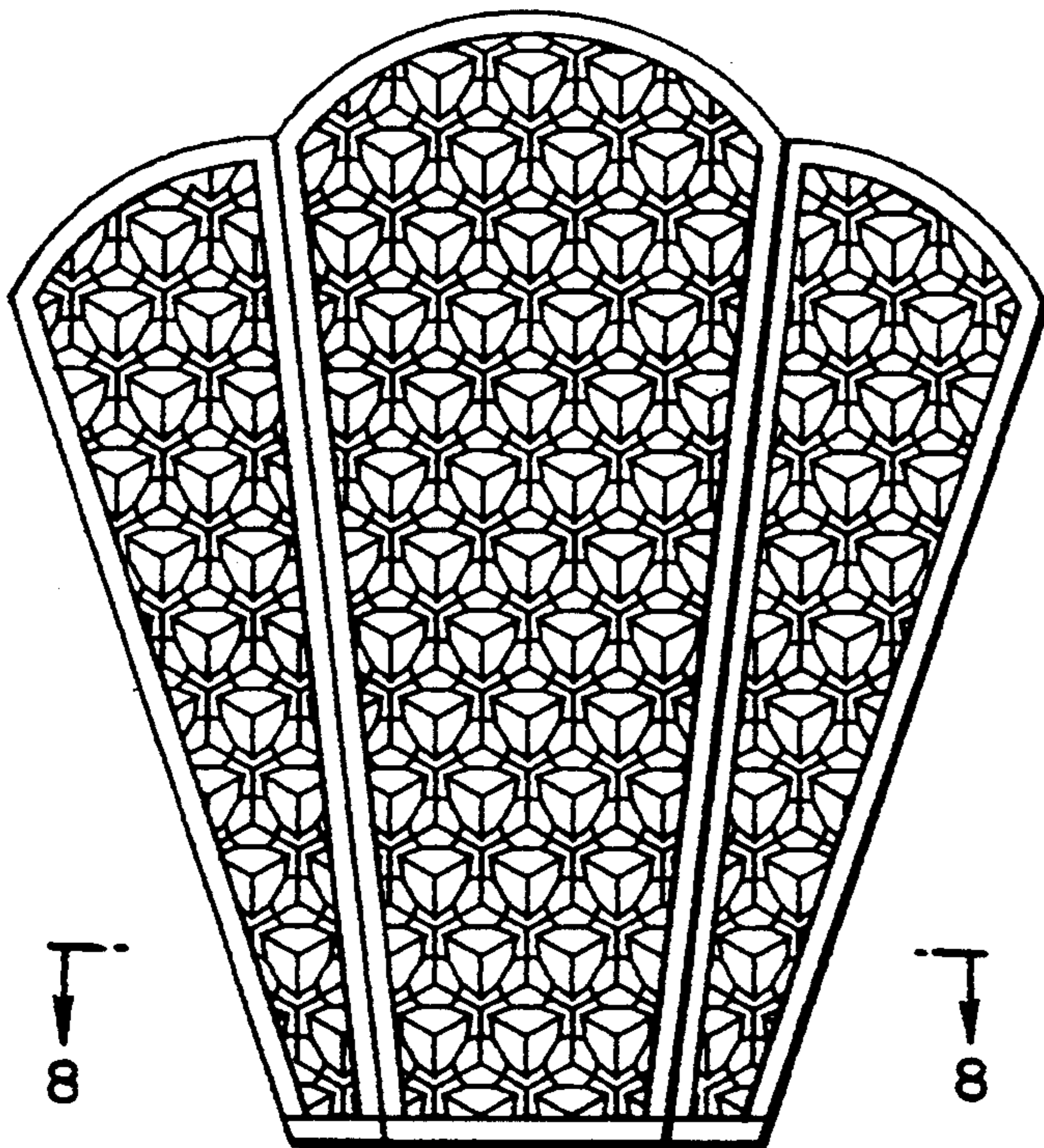

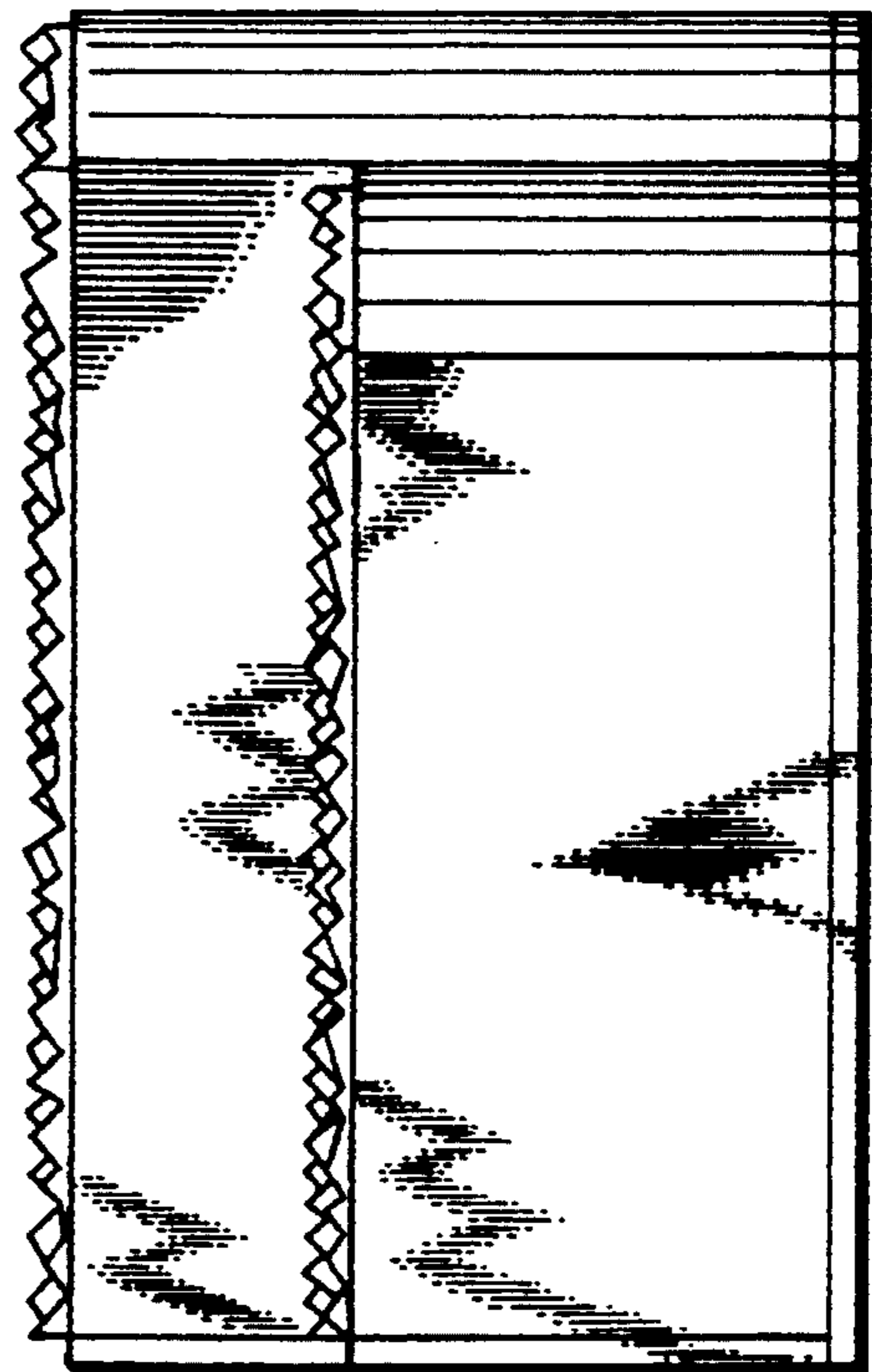

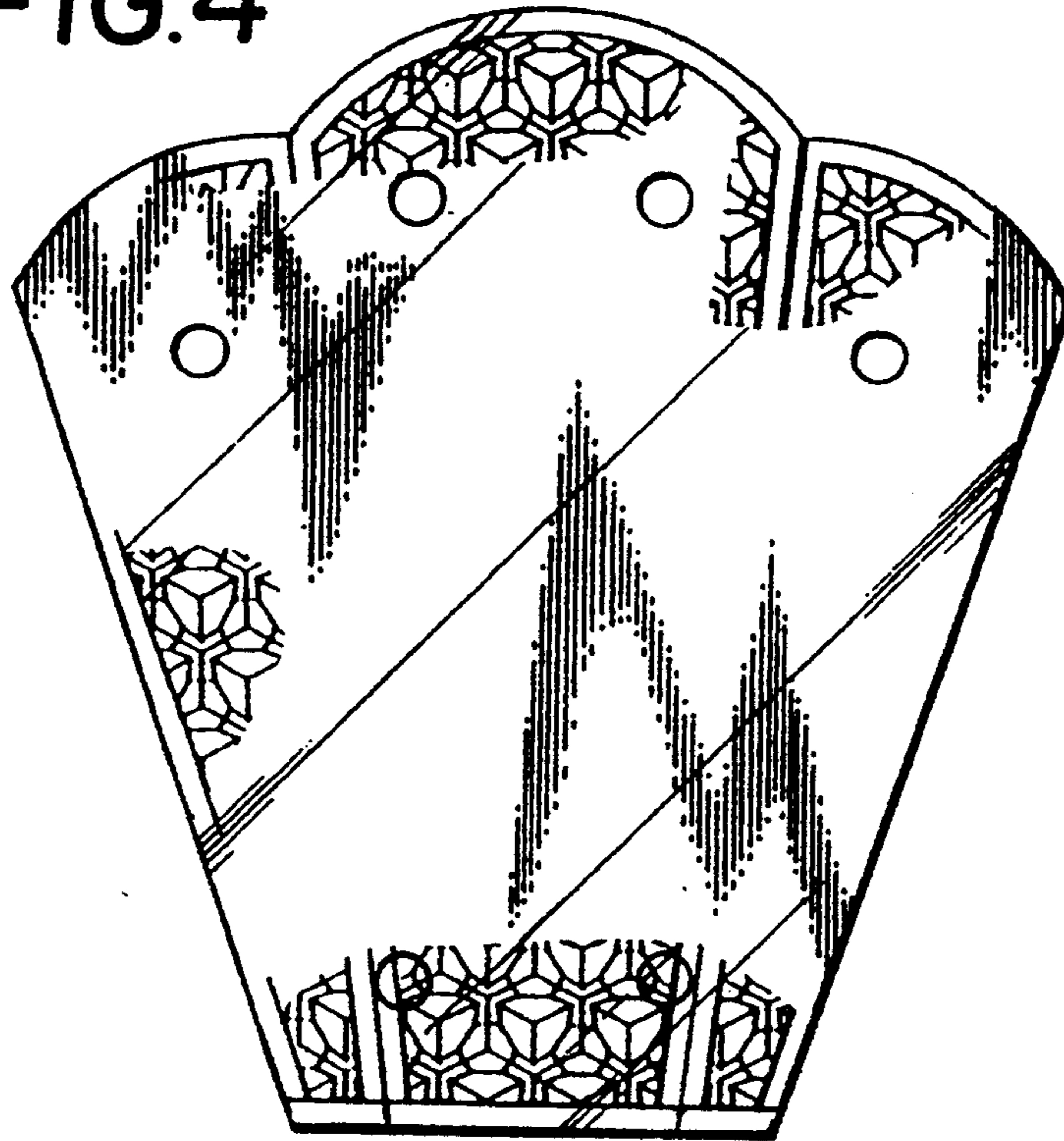

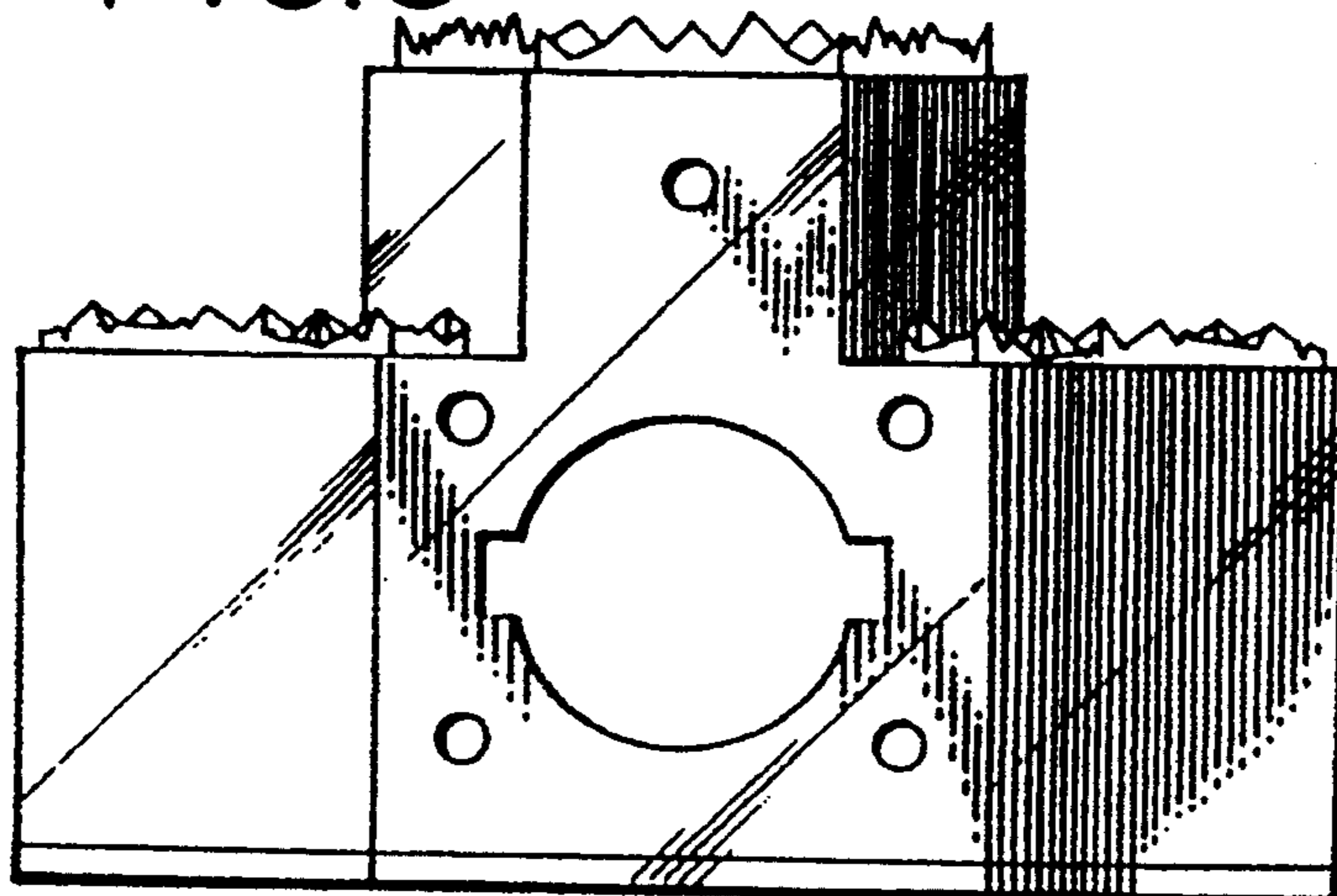

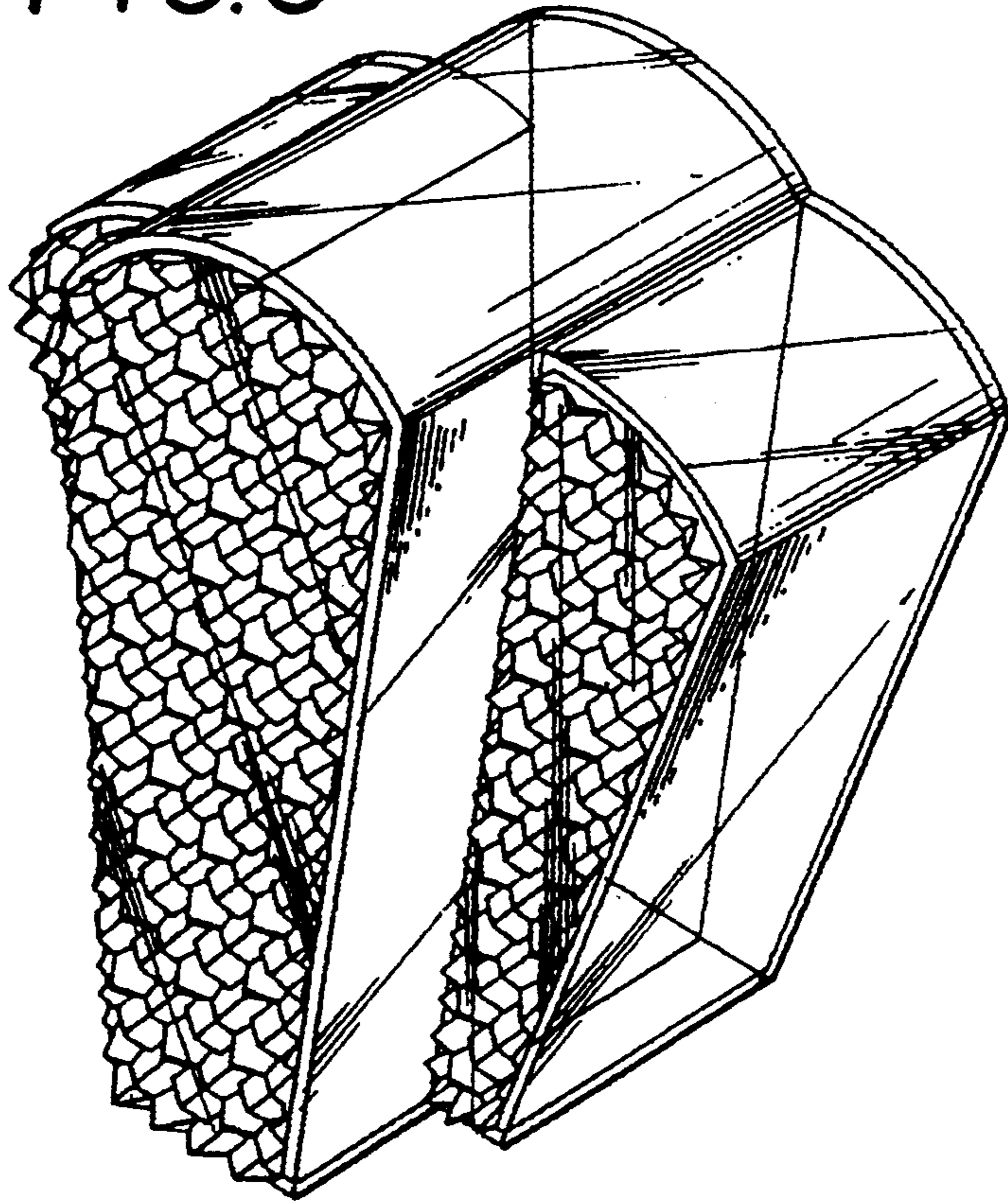

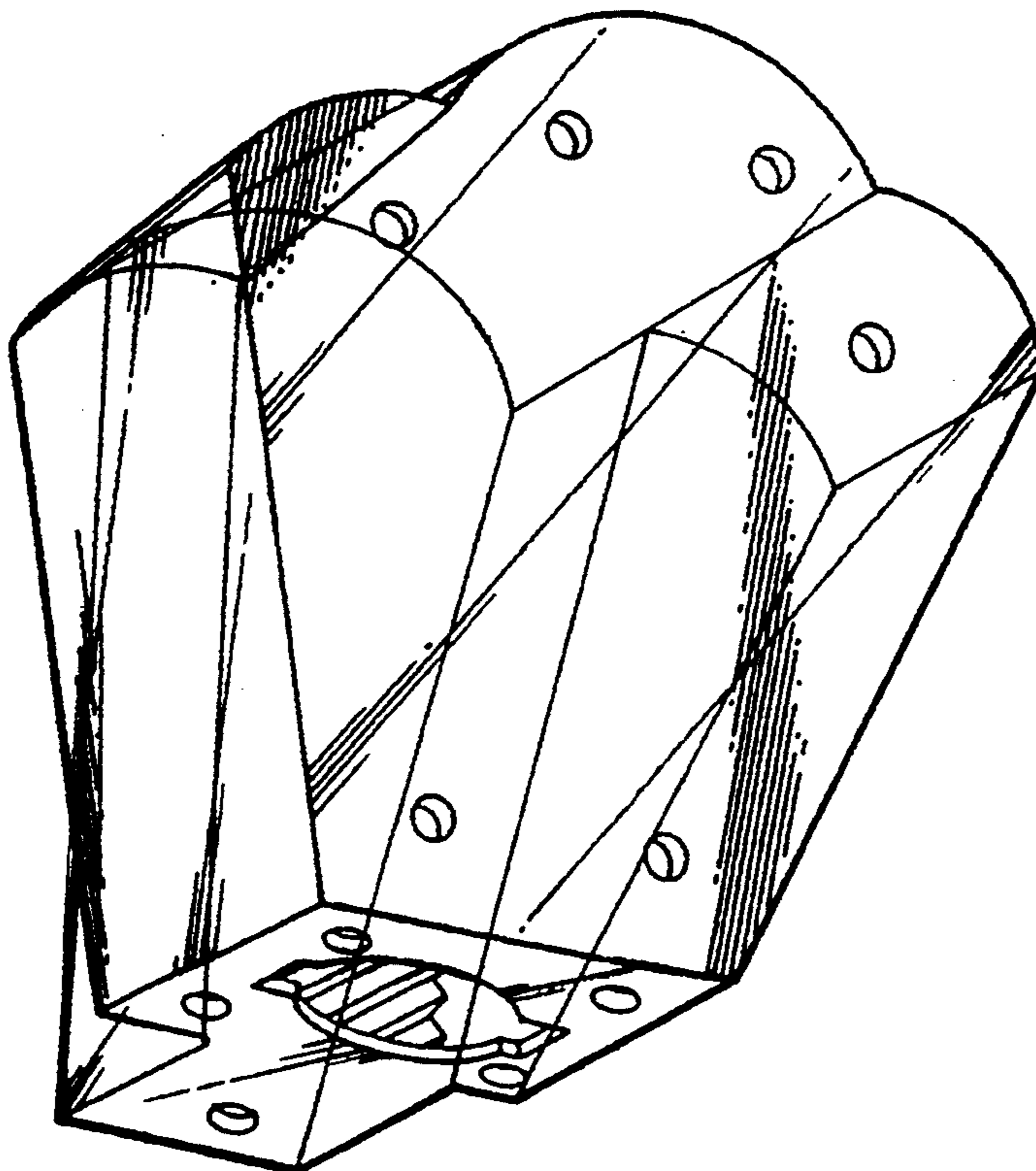

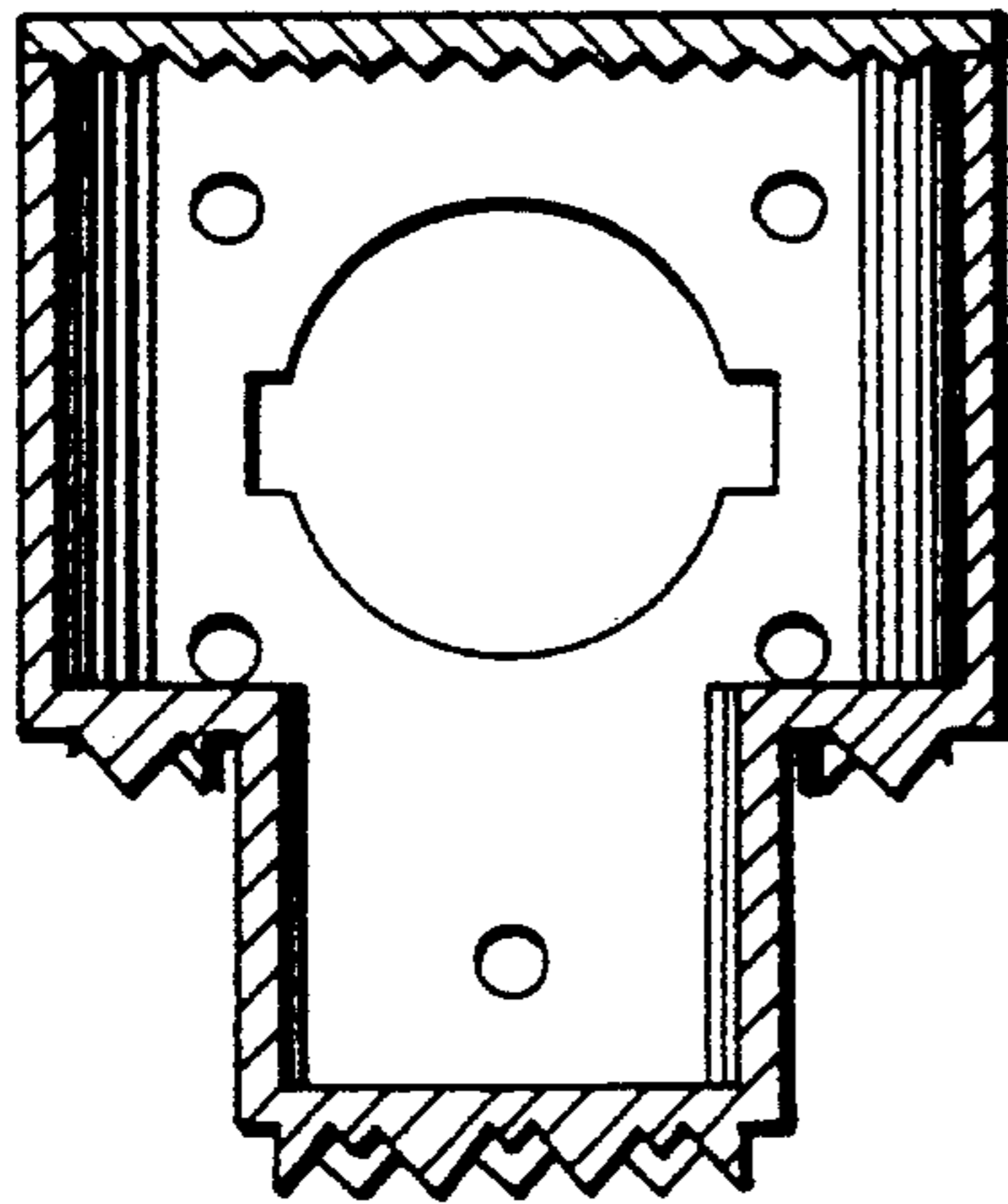

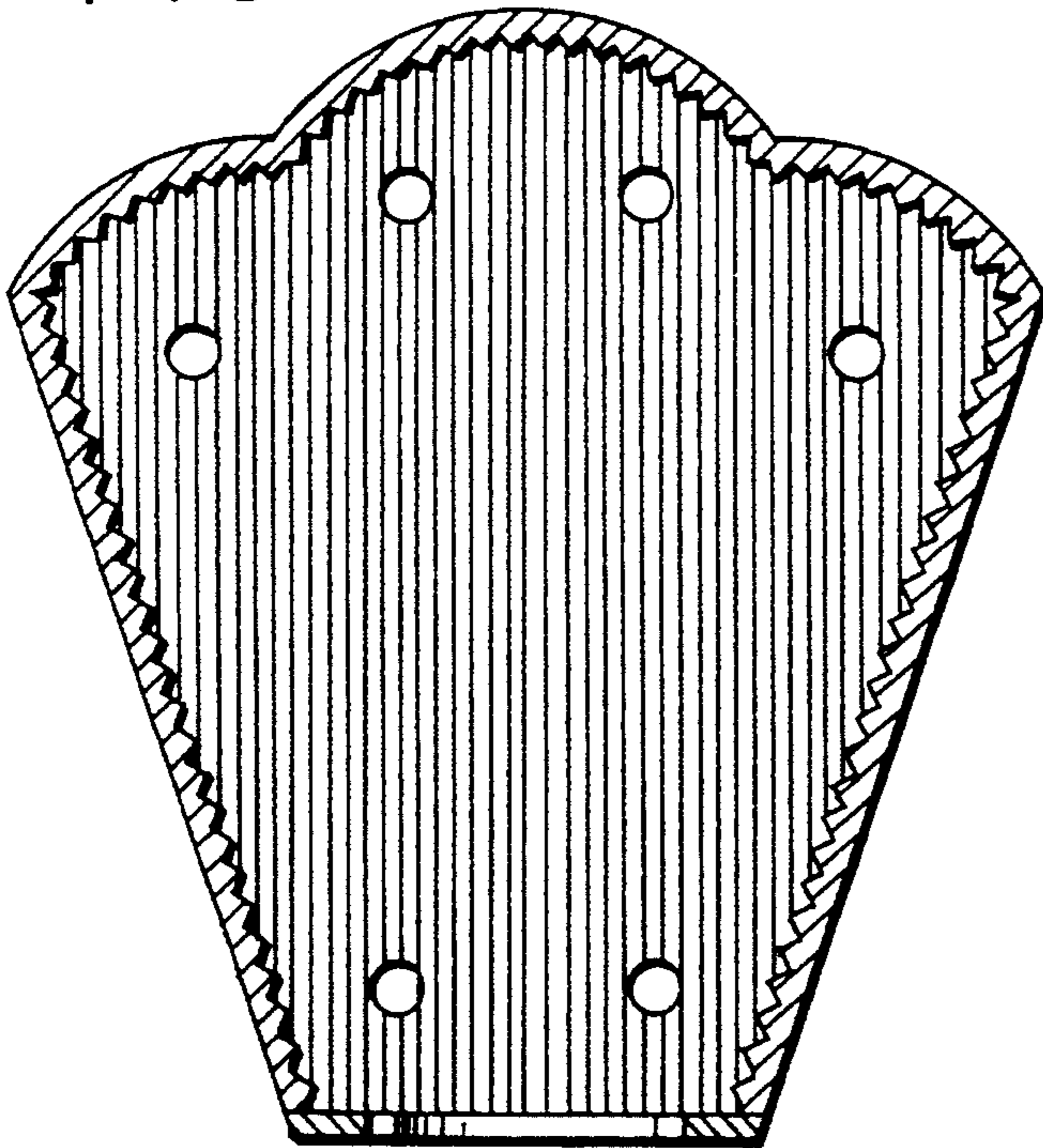

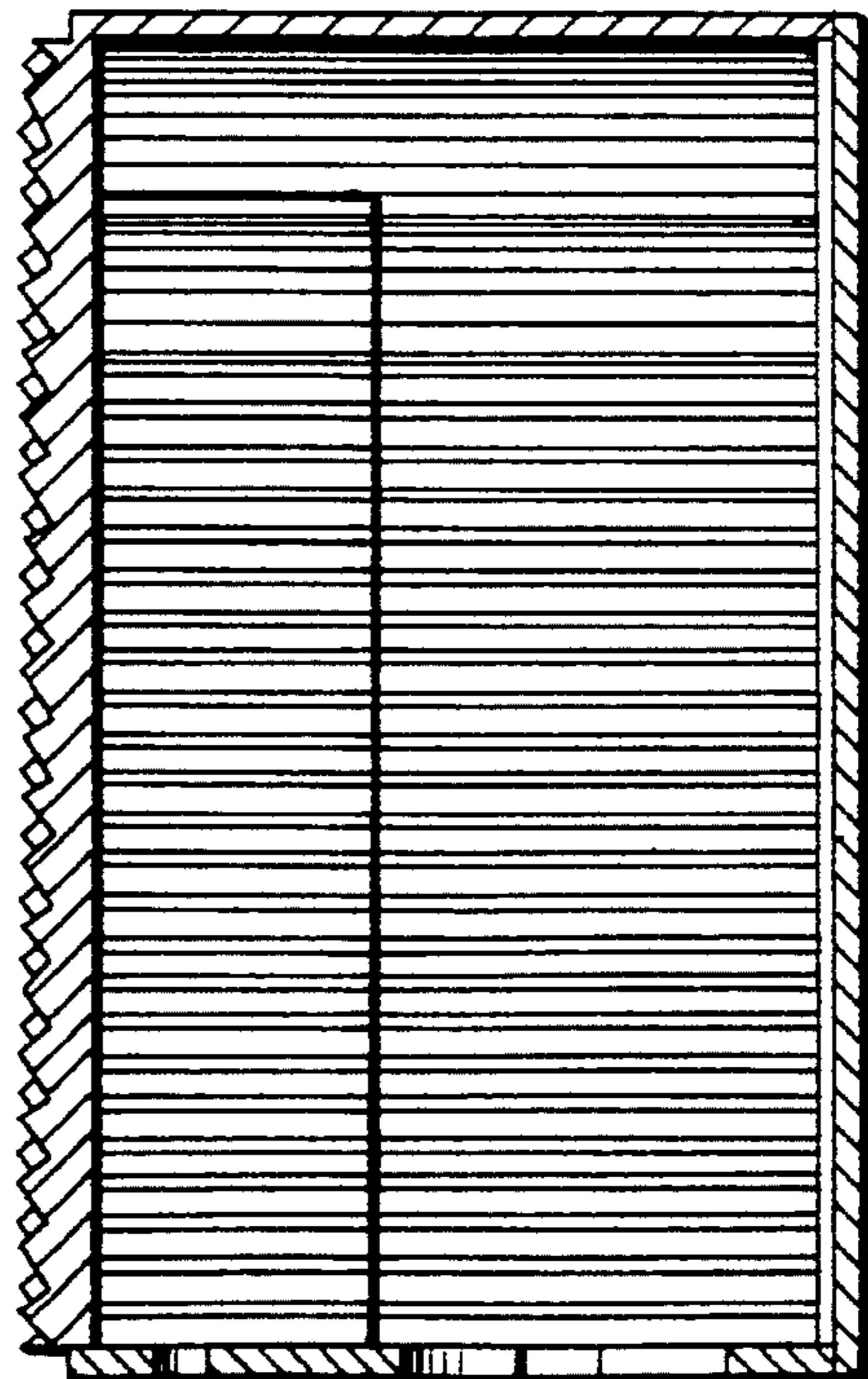
