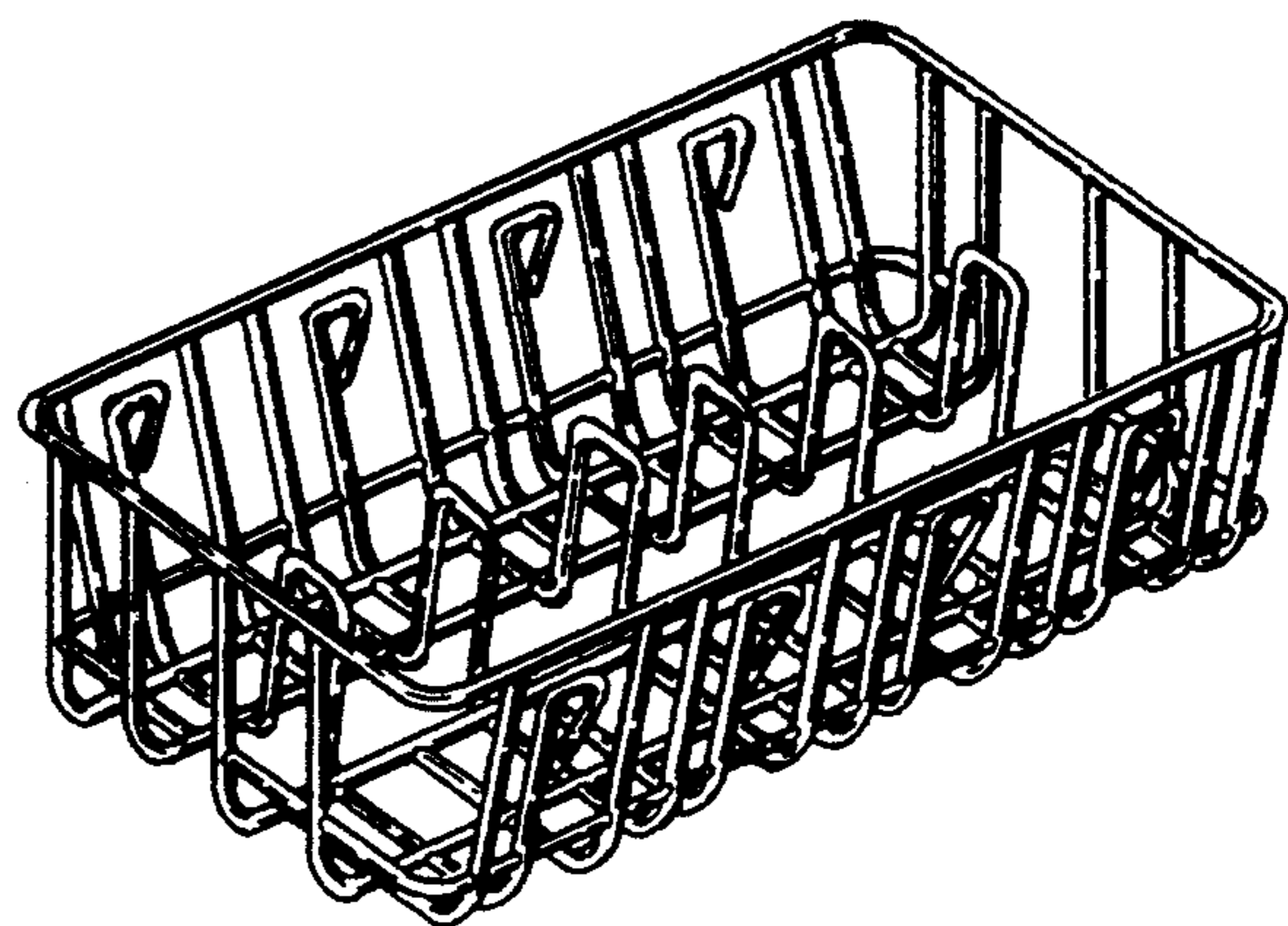
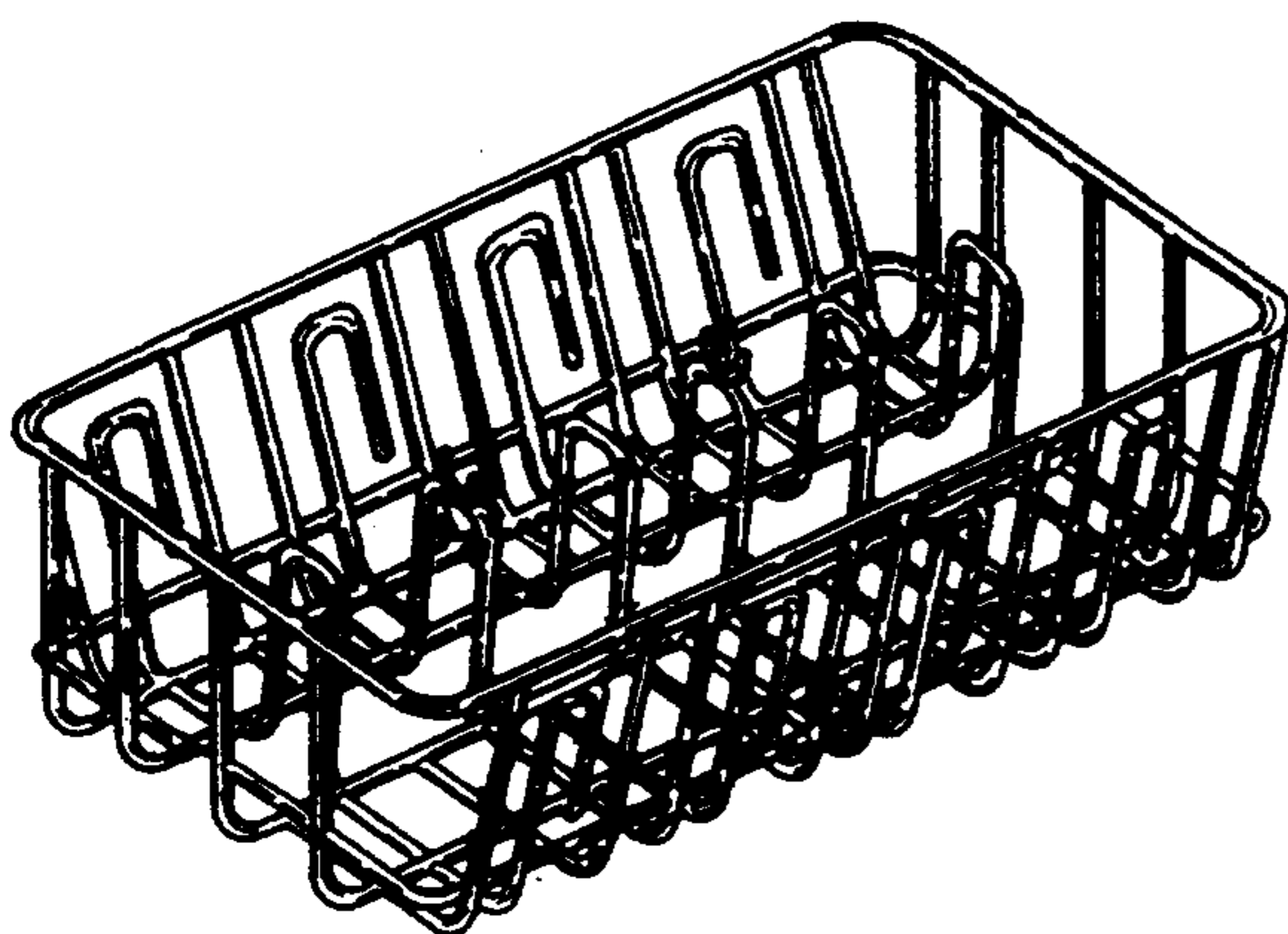

[57] **CLAIM**  
The ornamental design for a dish drainer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dish drainer showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is an end elevational view thereof, the opposite end being a mirror image;  
FIG. 4 is a side elevational view thereof, the opposite side being a mirror image;  
FIG. 5 is a perspective view of an alternative embodiment of a dish drainer showing my new design;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is an end elevational view thereof, the opposite end being a mirror image; and,  
FIG. 8 is a side elevational view thereof, the opposite side being a mirror image.



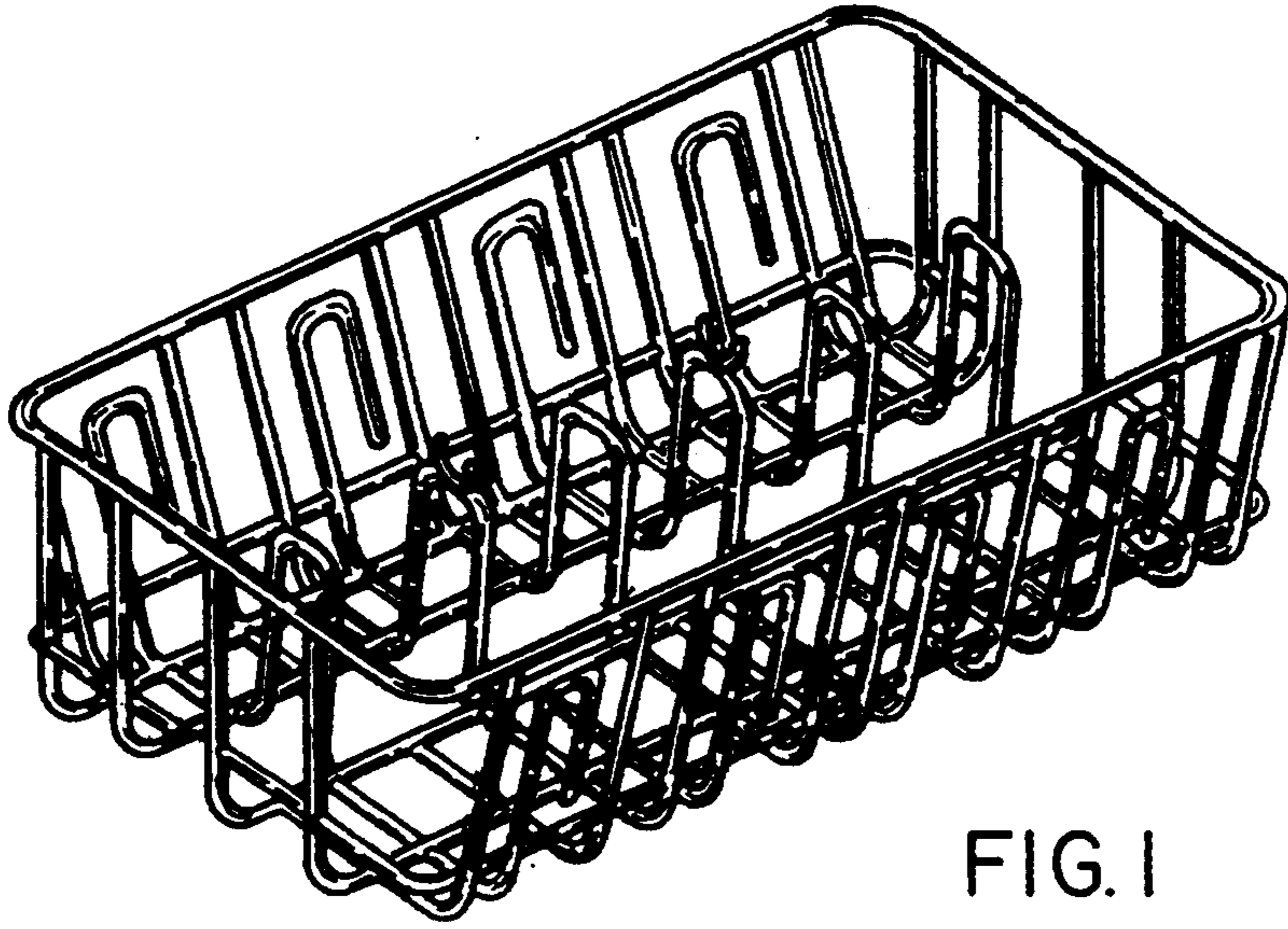

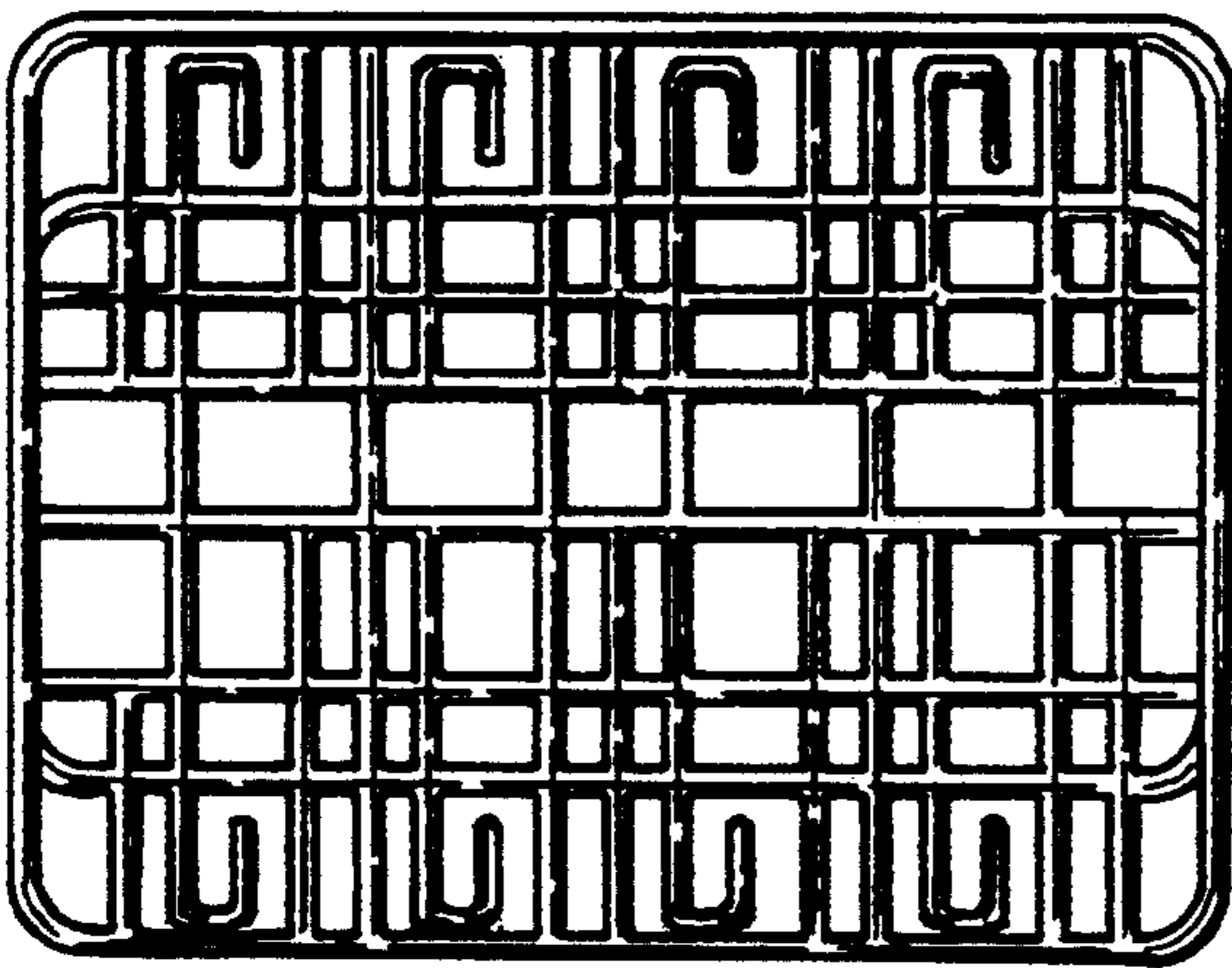

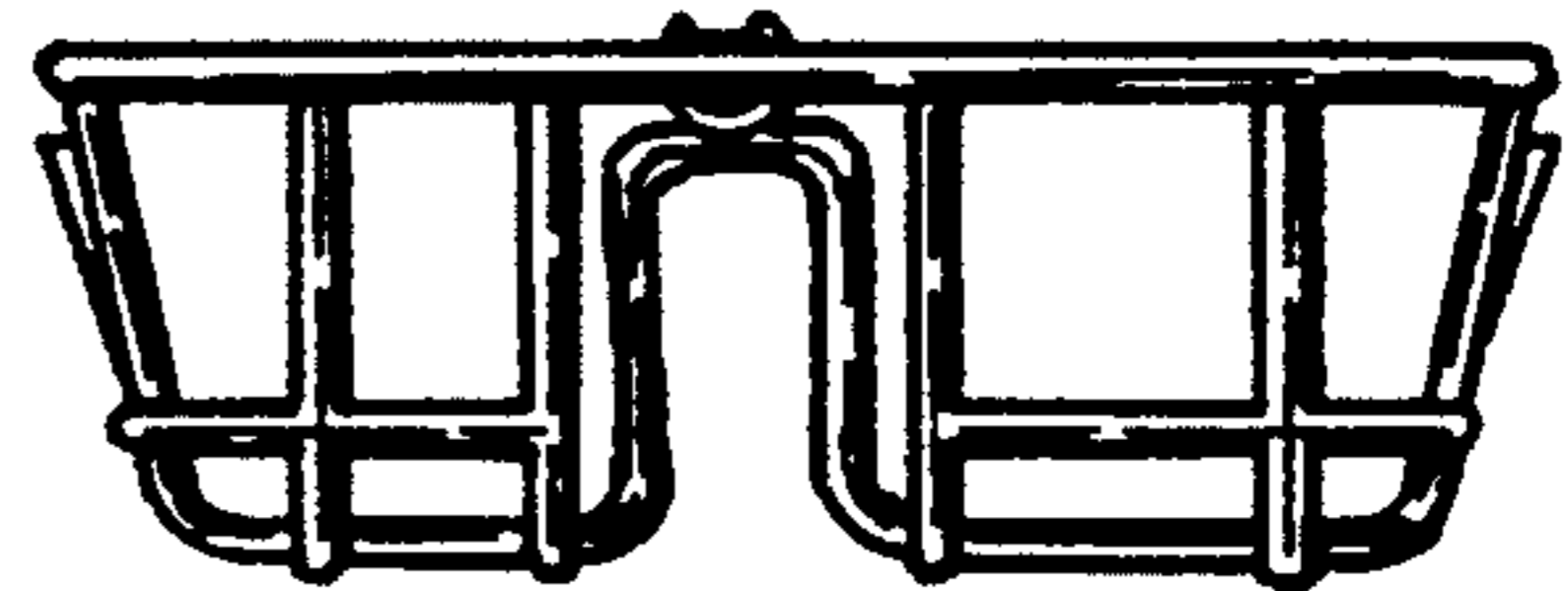

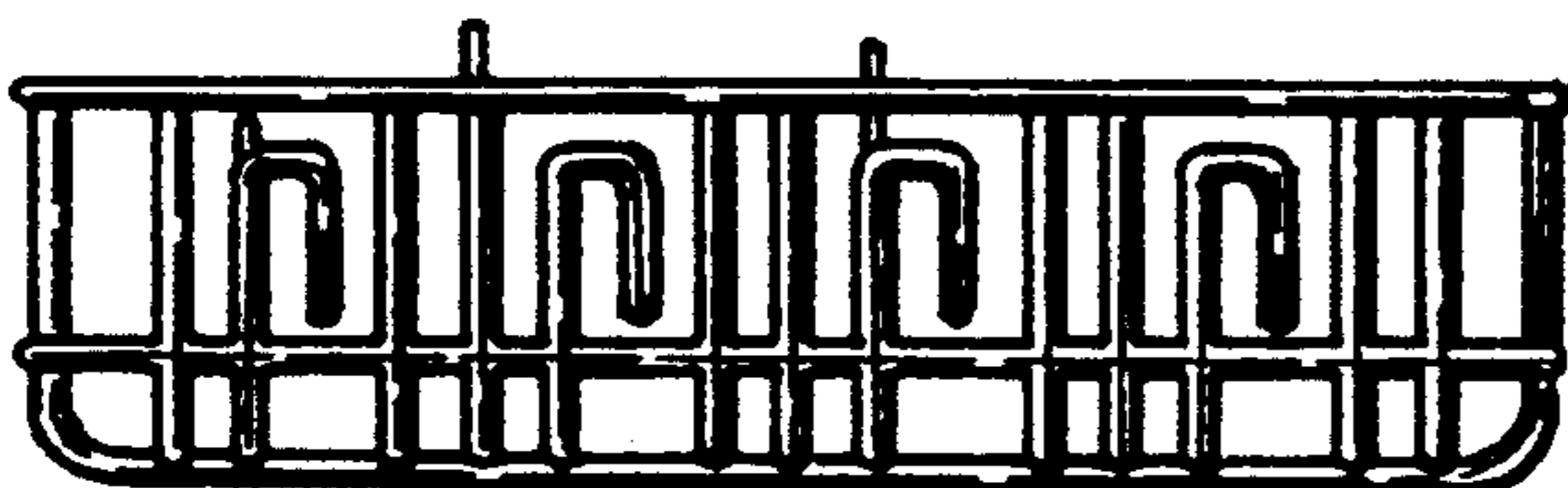

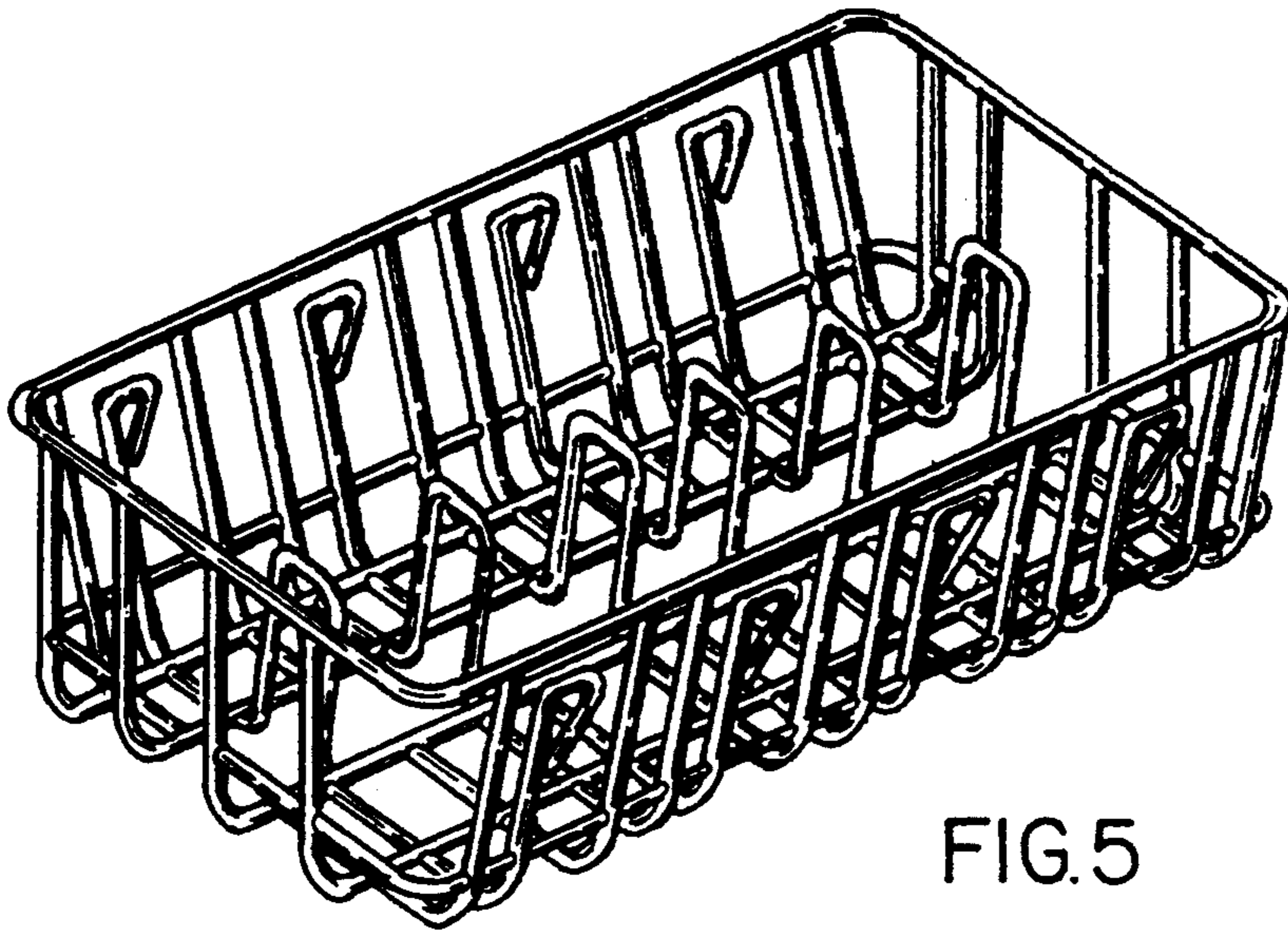

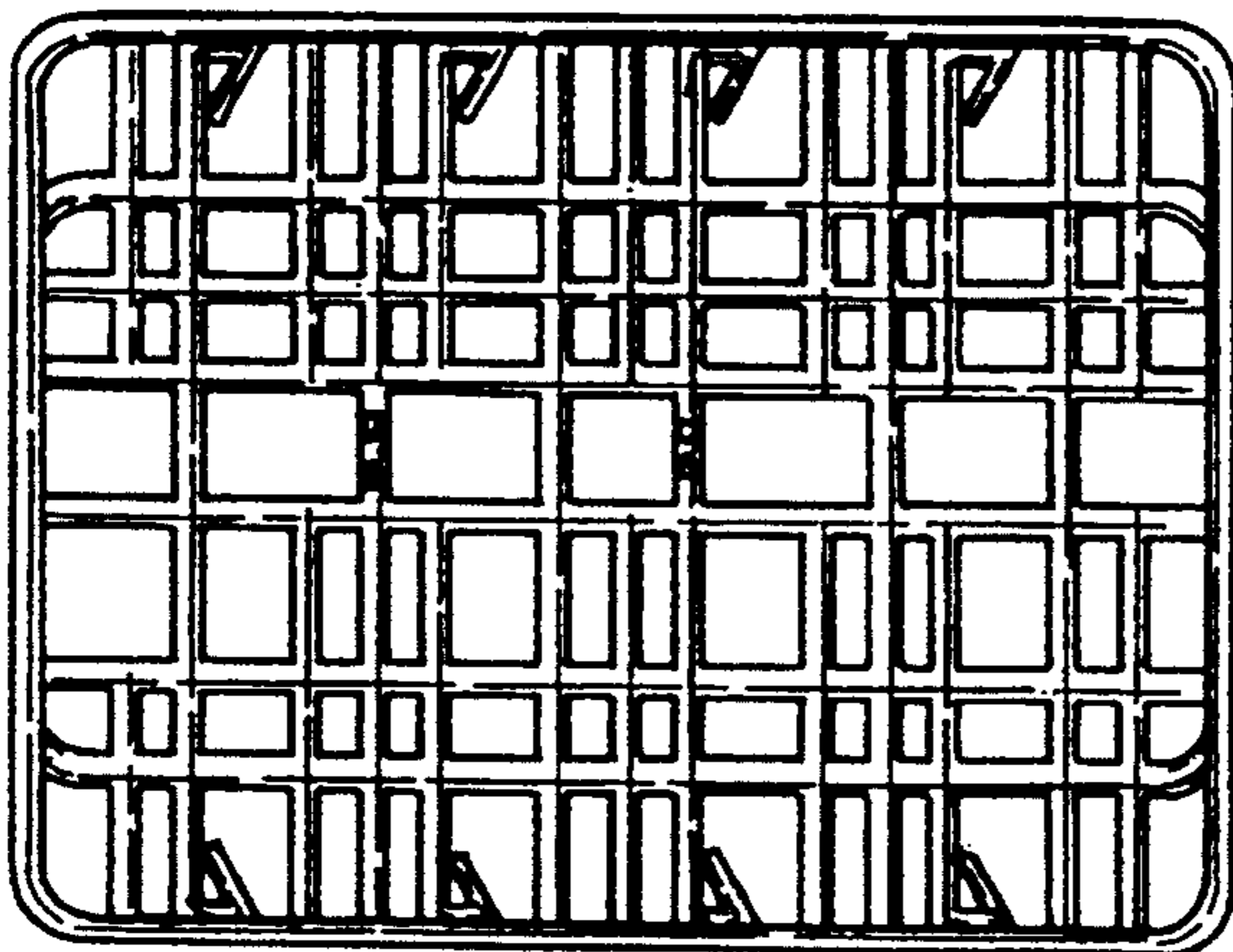

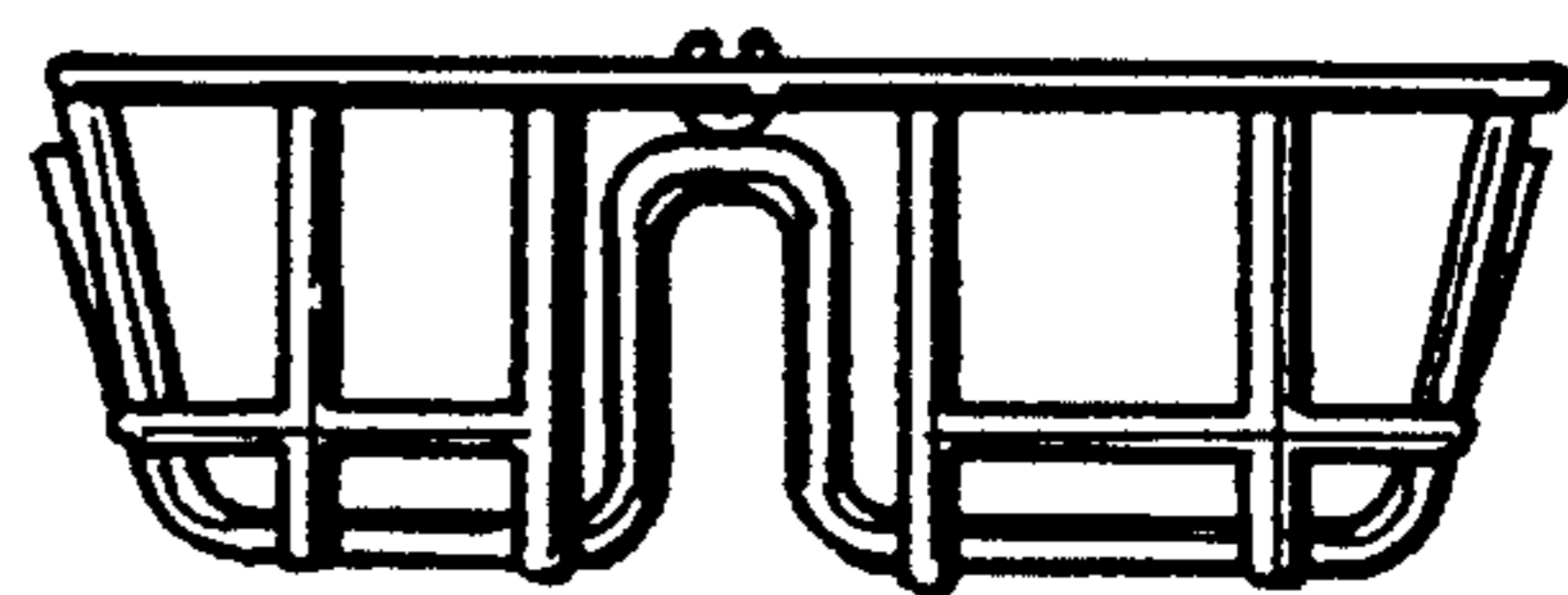

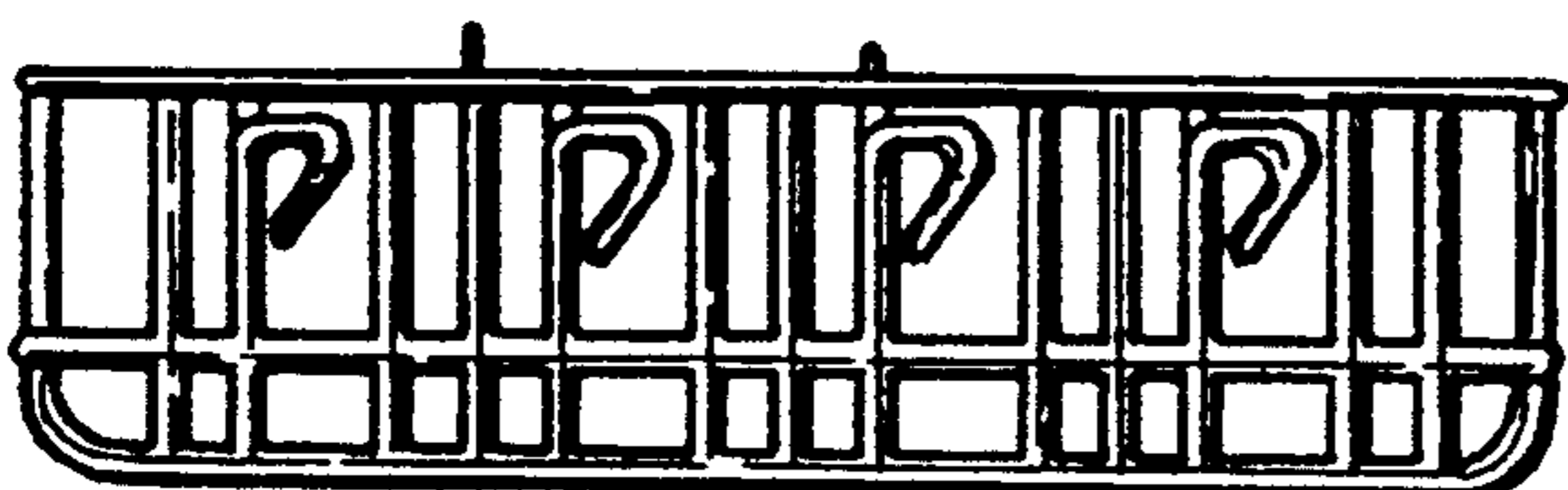
