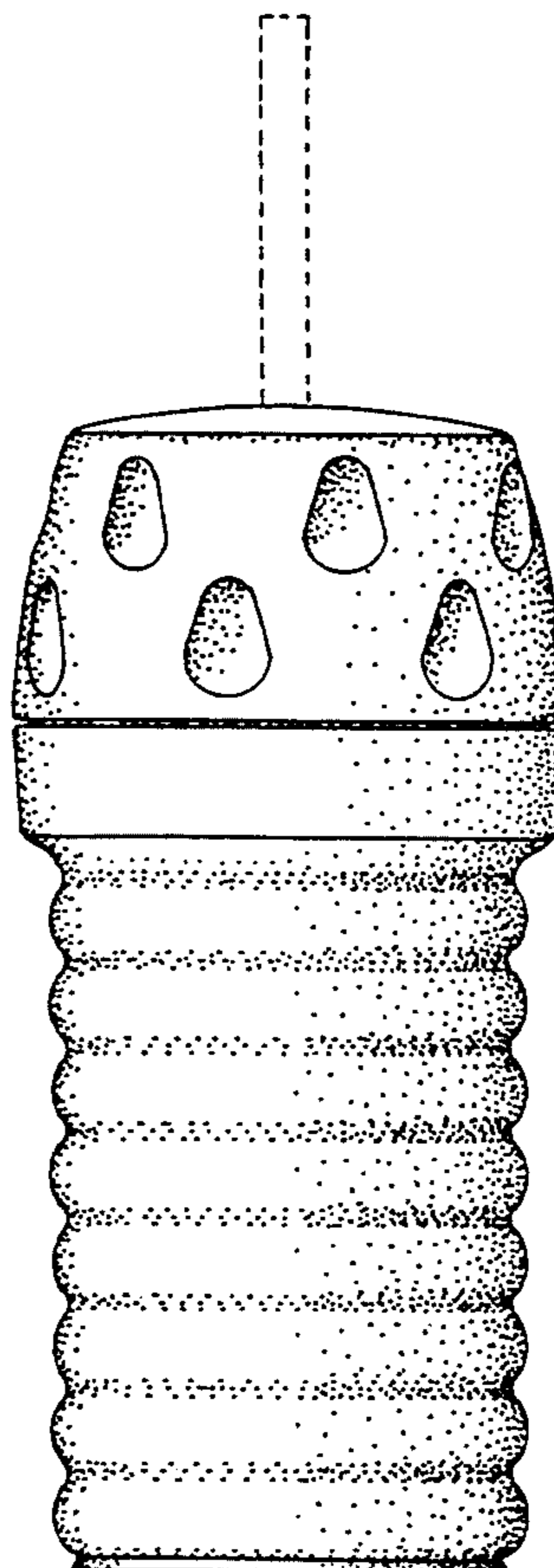

DESCRIPTION

 The broken line showing of a drinking straw in FIGS. 1 and 2 is for illustrative purposes only and forms no part of the claimed design.



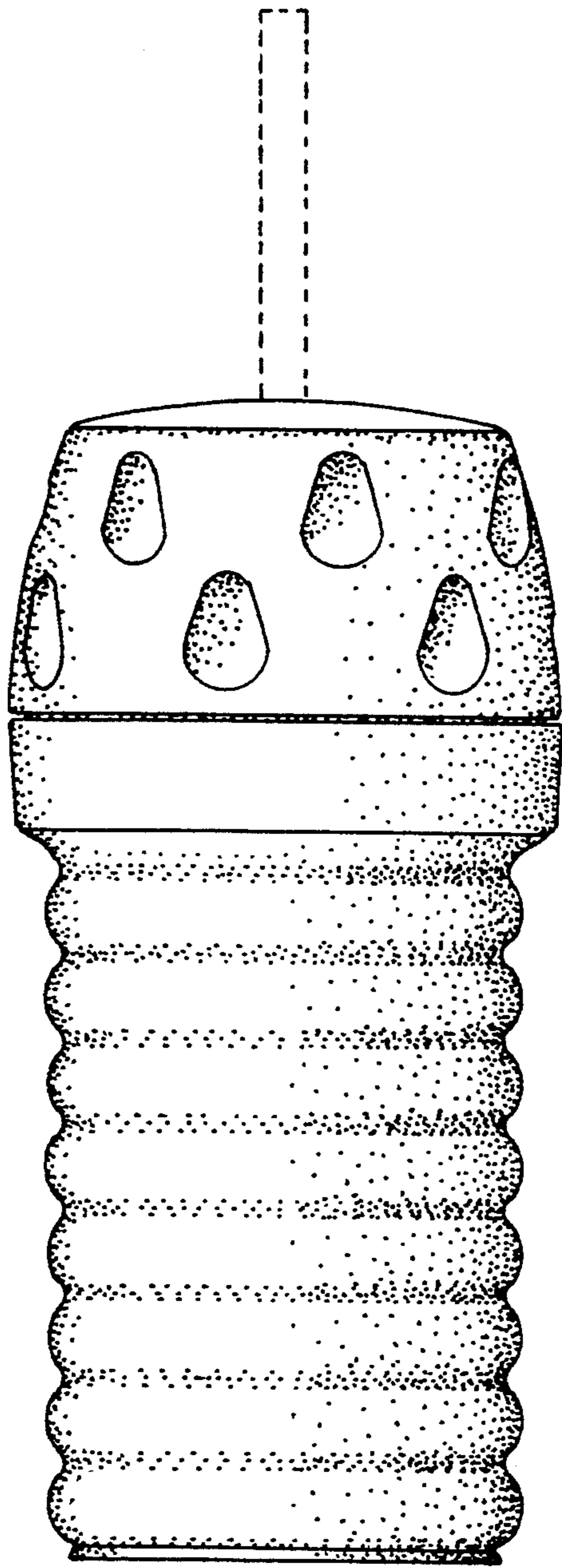

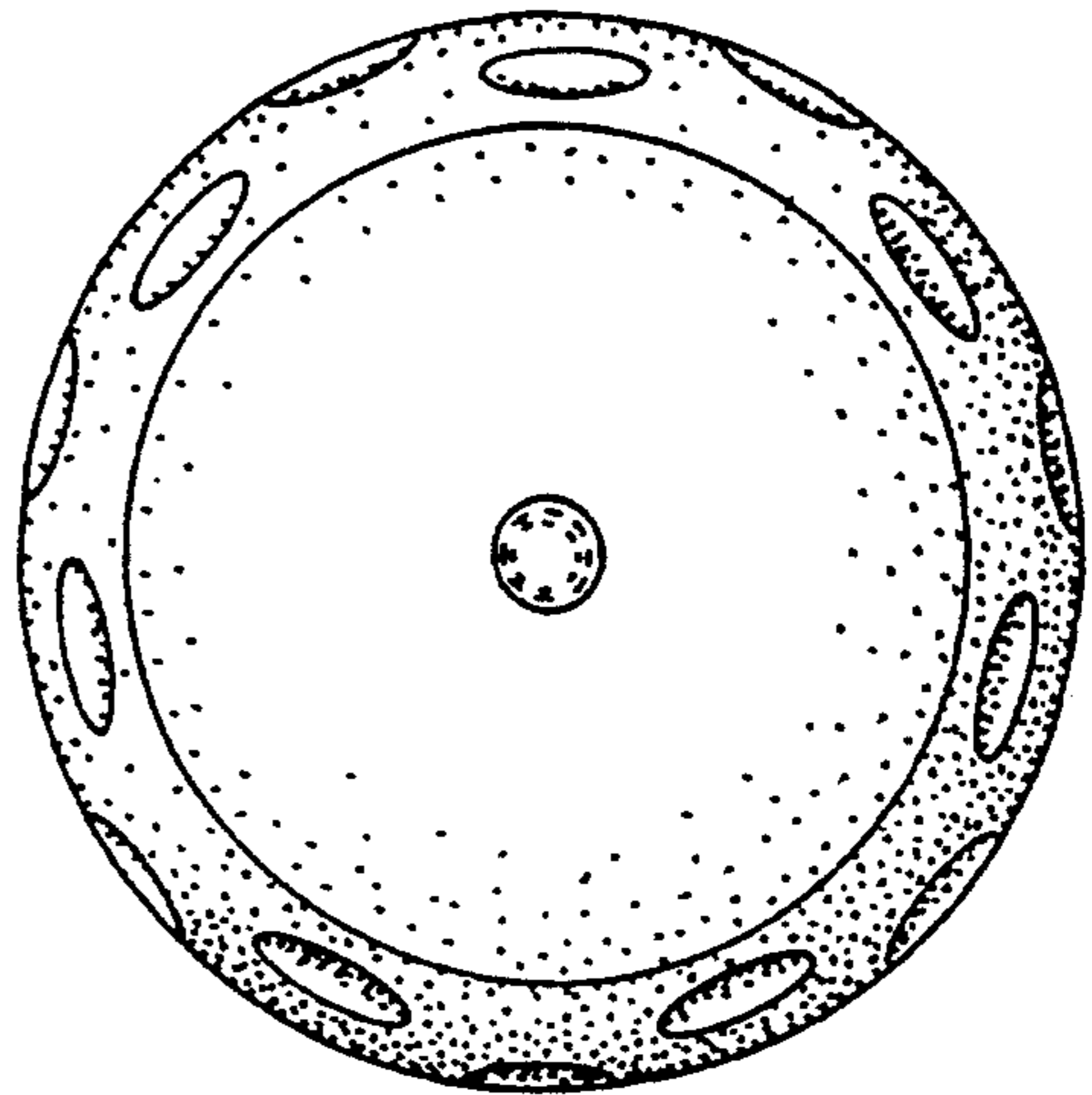

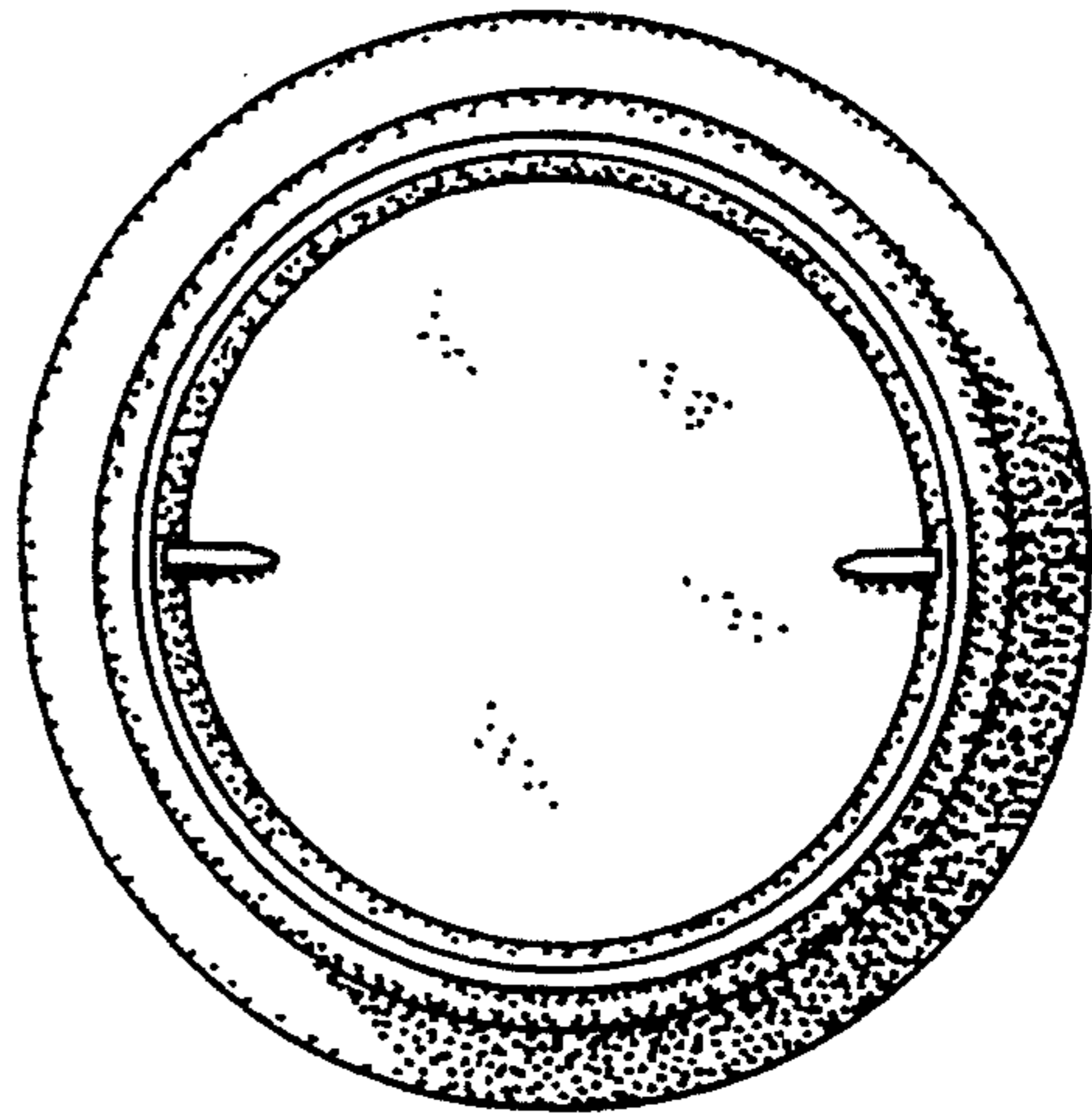
