[57] CLAIM

The ornamental design for a power cable retainer, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a power cable retainer showing my new design, the bottom plan view being a mirror image;

FIG. 2 is a front elevation view thereof, the rear elevation view being identical;

FIG. 3 is a side elevation view thereof, the opposite side elevation view being identical;

FIG. 4 is a top plan view of a power cable retainer showing a second embodiment of my new design, the bottom plan view being a mirror image;

FIG. 5 is a front elevation view thereof, the rear elevational view being identical;

FIG. 6 is a side elevation view thereof taken from the right side of FIG. 4;

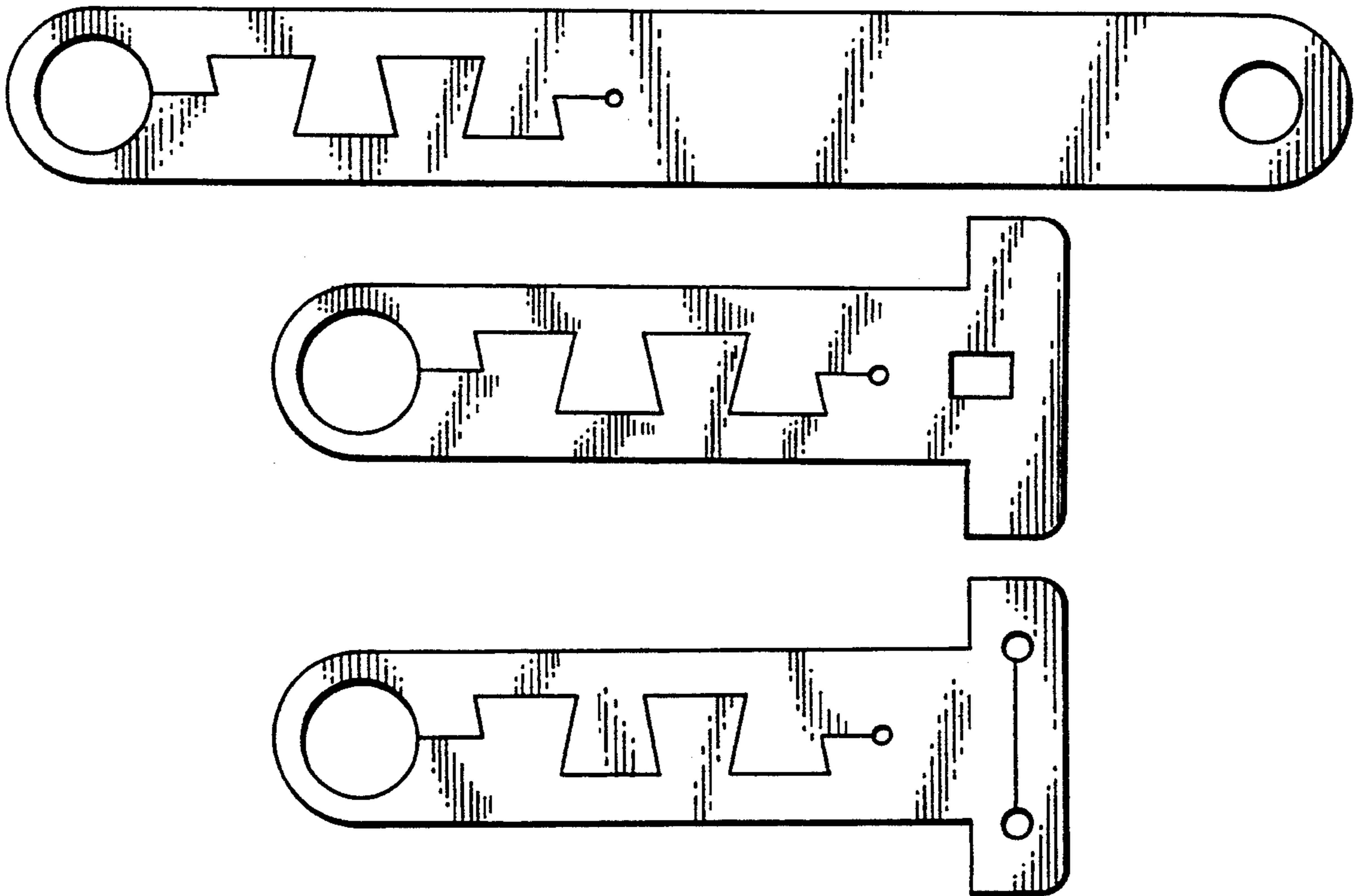
FIG. 7 is a side elevation view thereof taken from the left side of FIG. 4;

FIG. 8 is a top plan view of a power cable retainer showing a third embodiment of my new design, the bottom plan view being a mirror image;

FIG. 9 is a front elevation view thereof, the rear elevation view being identical;

FIG. 10 is a side elevation view thereof taken from the right side of FIG. 8; and,

FIG. 11 is a side elevation view thereof taken from the left side of FIG. 8.



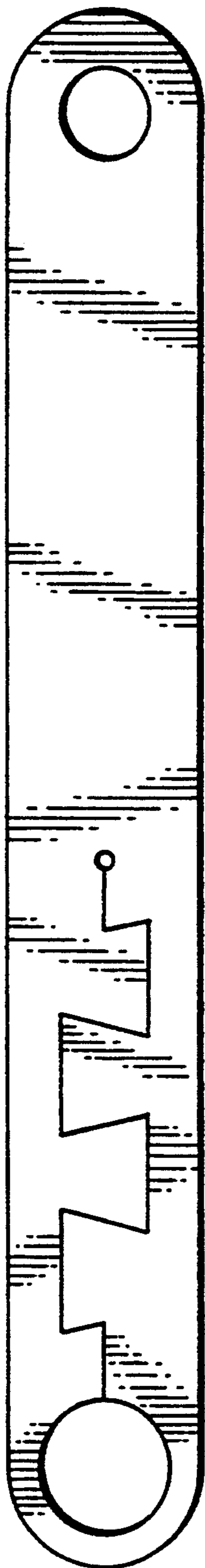

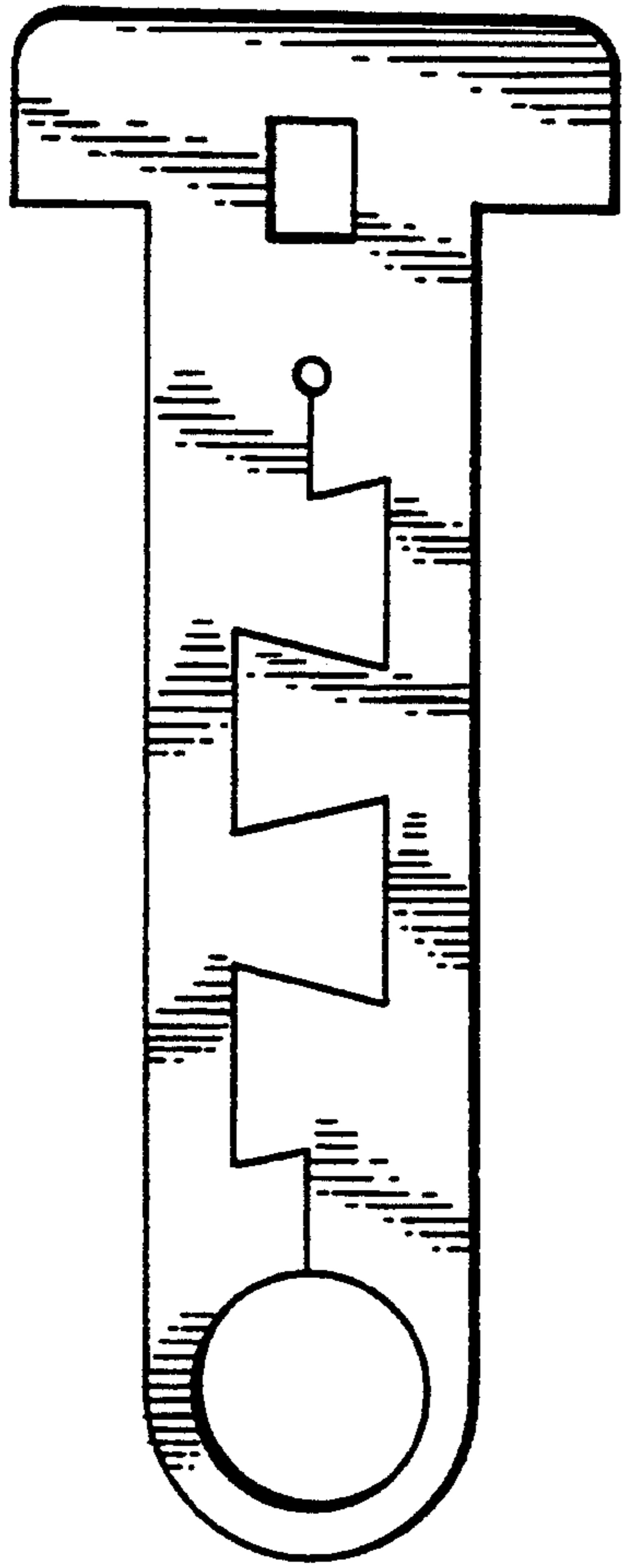

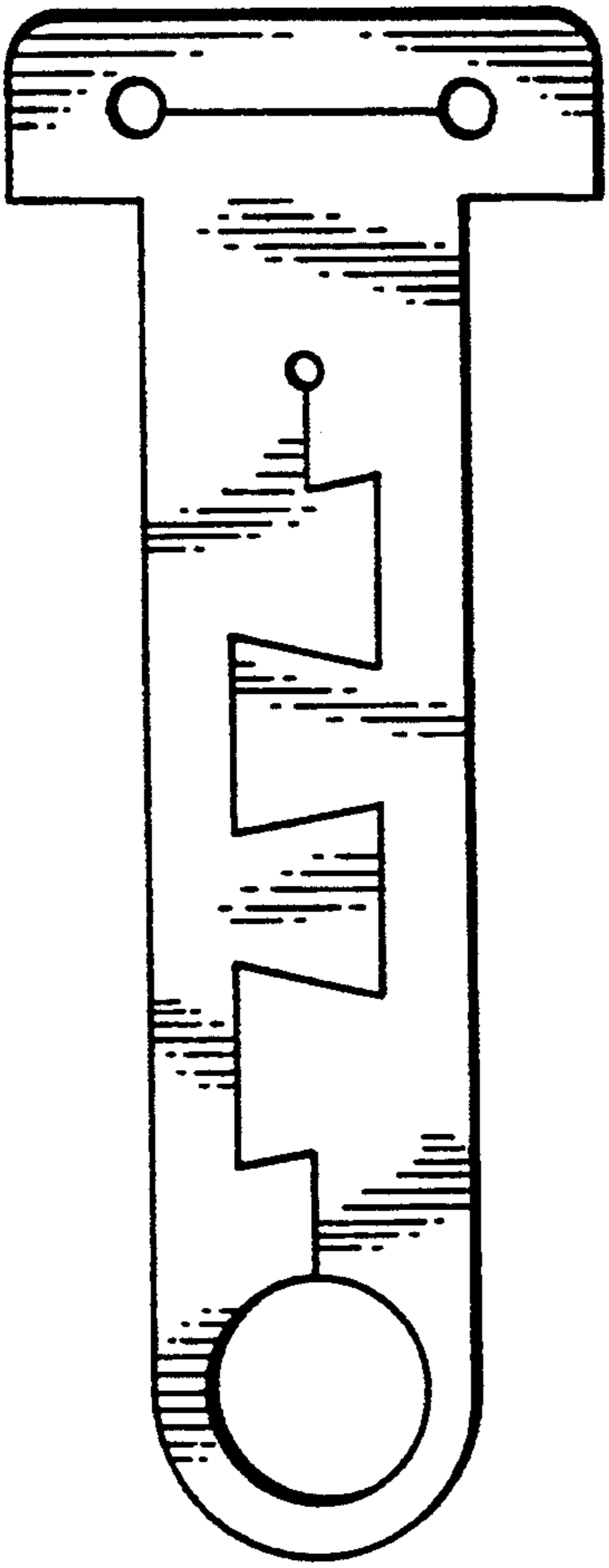
