[57] **CLAIM**

An ornamental design for a pump bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pump bottle showing a first embodiment of my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a left side elevational view thereof, the undisclosed opposite side being a mirror image;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a perspective view of a second embodiment of the pump bottle shown in transparency;
 FIG. 8 is a top plan view of the embodiment of FIG. 7;
 FIG. 9 is a front elevational view of the embodiment of FIG. 7;
 FIG. 10 is left side elevational view of the embodiment of FIG. 7, the undisclosed opposite side being a mirror image;
 FIG. 11 is a rear elevational view of the embodiment of FIG. 7;
 FIG. 12 is a bottom plan view of the embodiment of FIG. 7;
 FIG. 13 is a perspective view of a third embodiment of the pump bottle shown in translucency; and,
 FIG. 14 is a top plan view of the embodiment of FIG. 13.

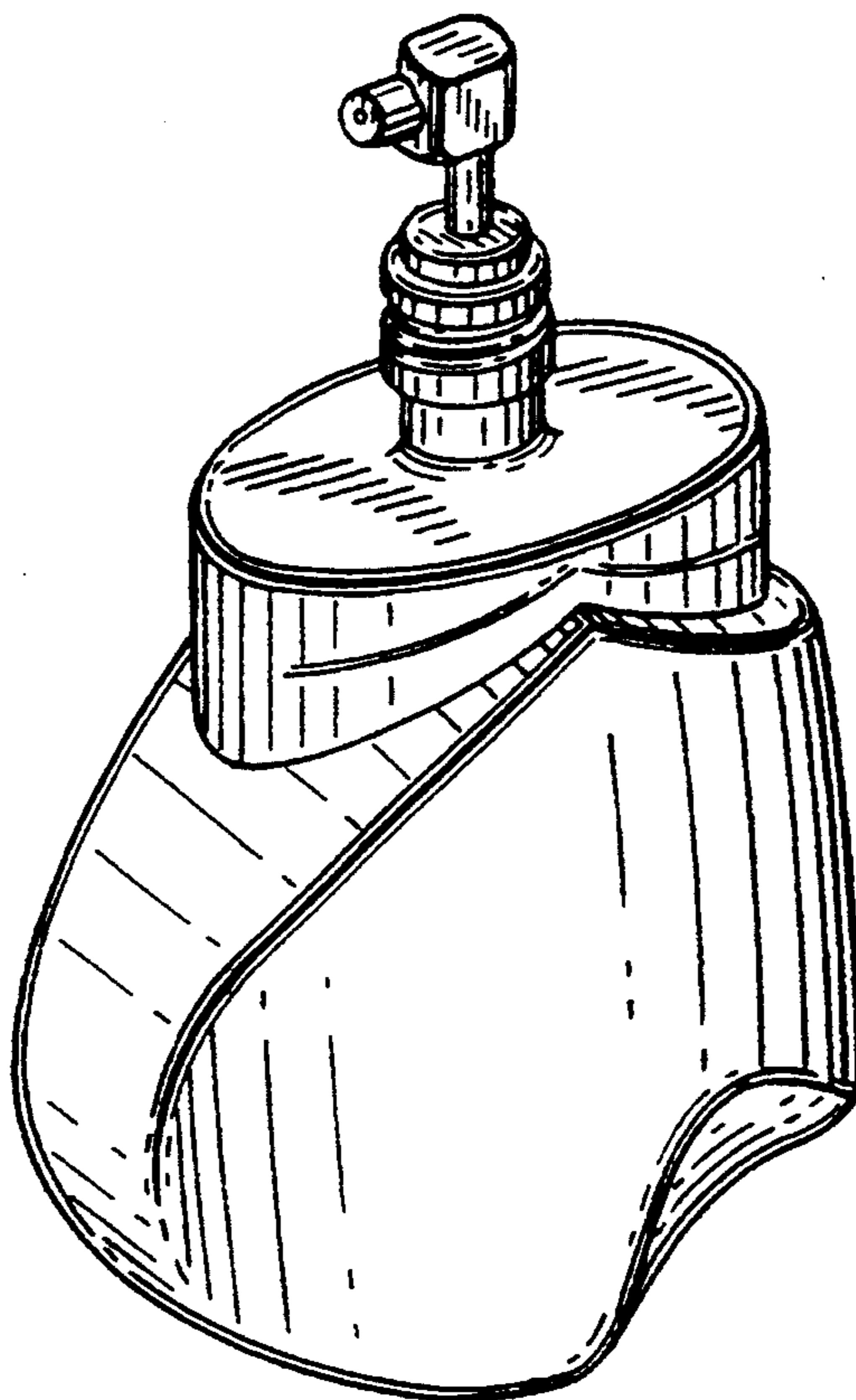

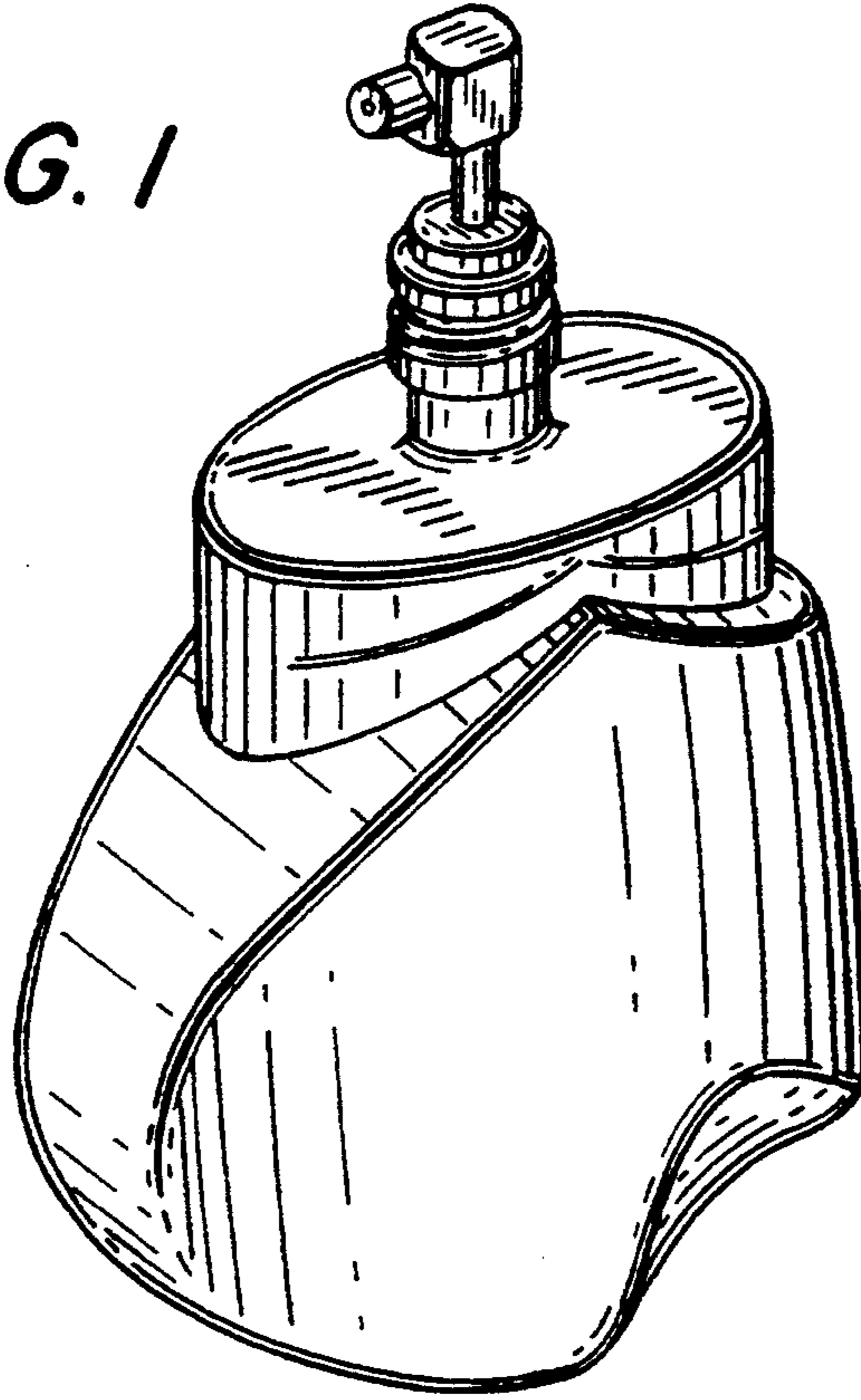
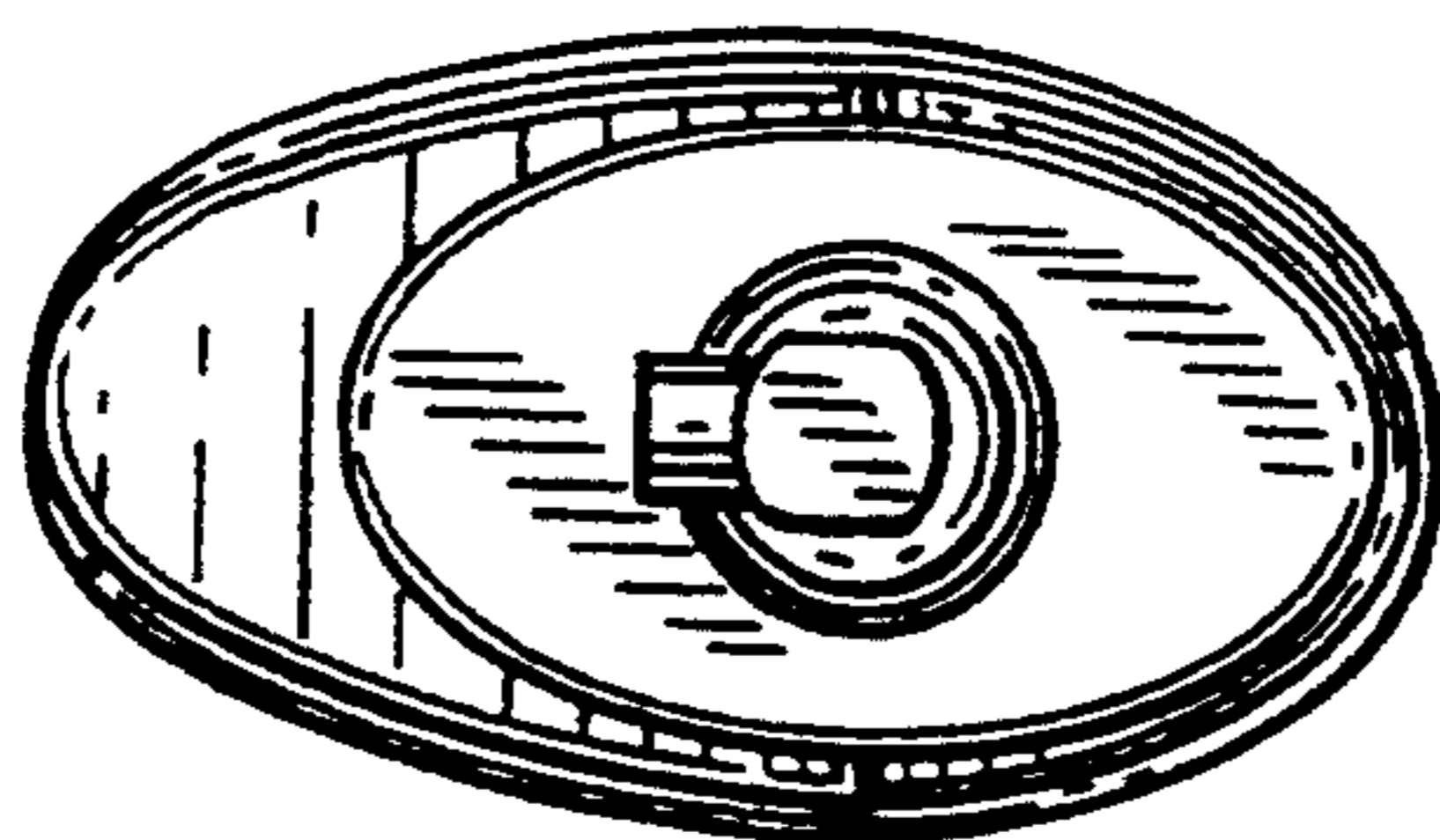

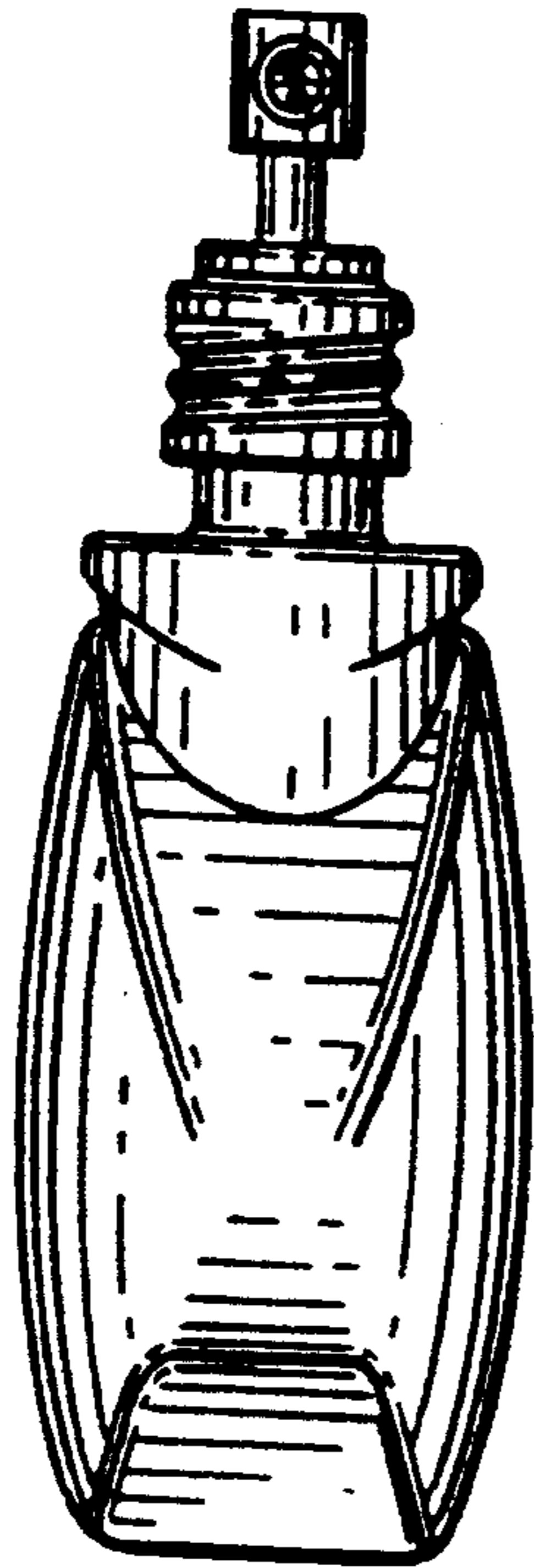

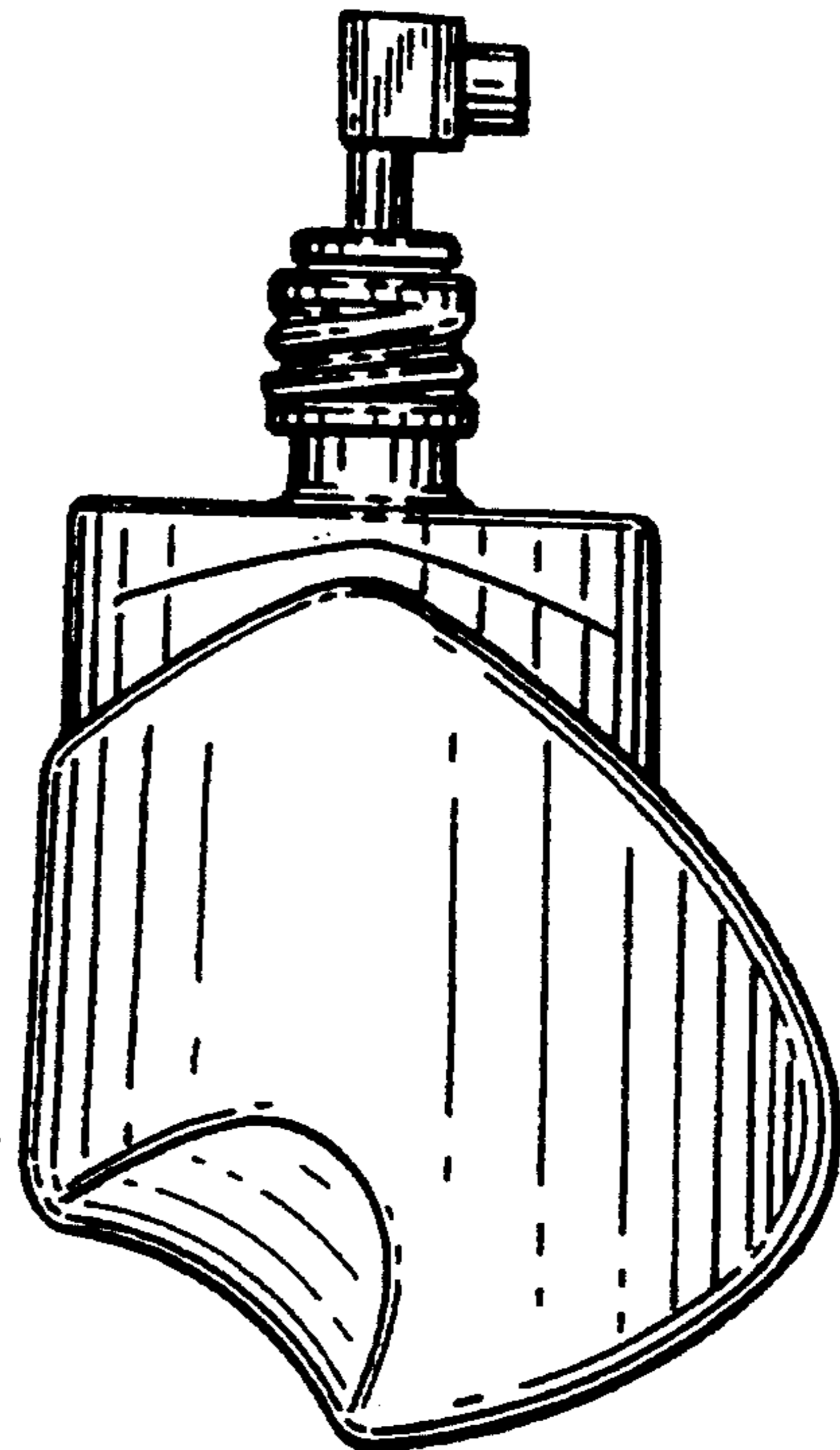

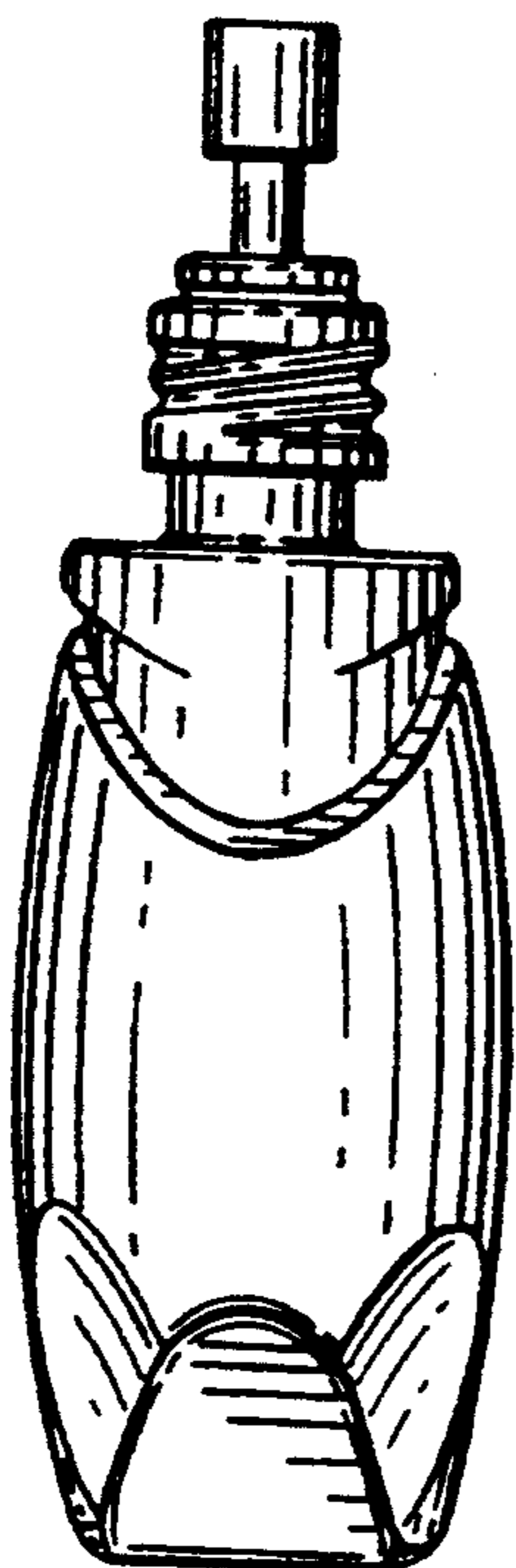

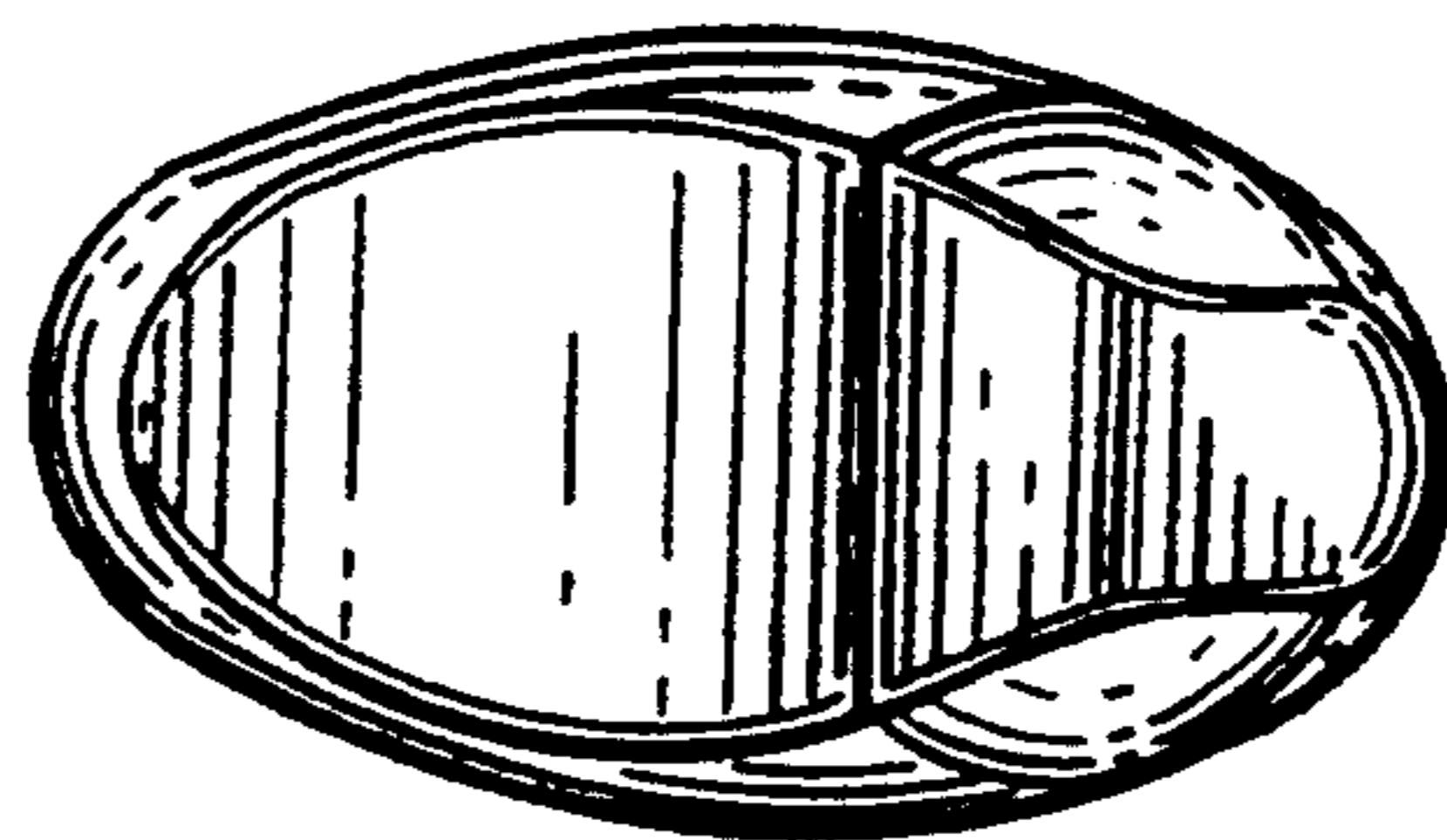

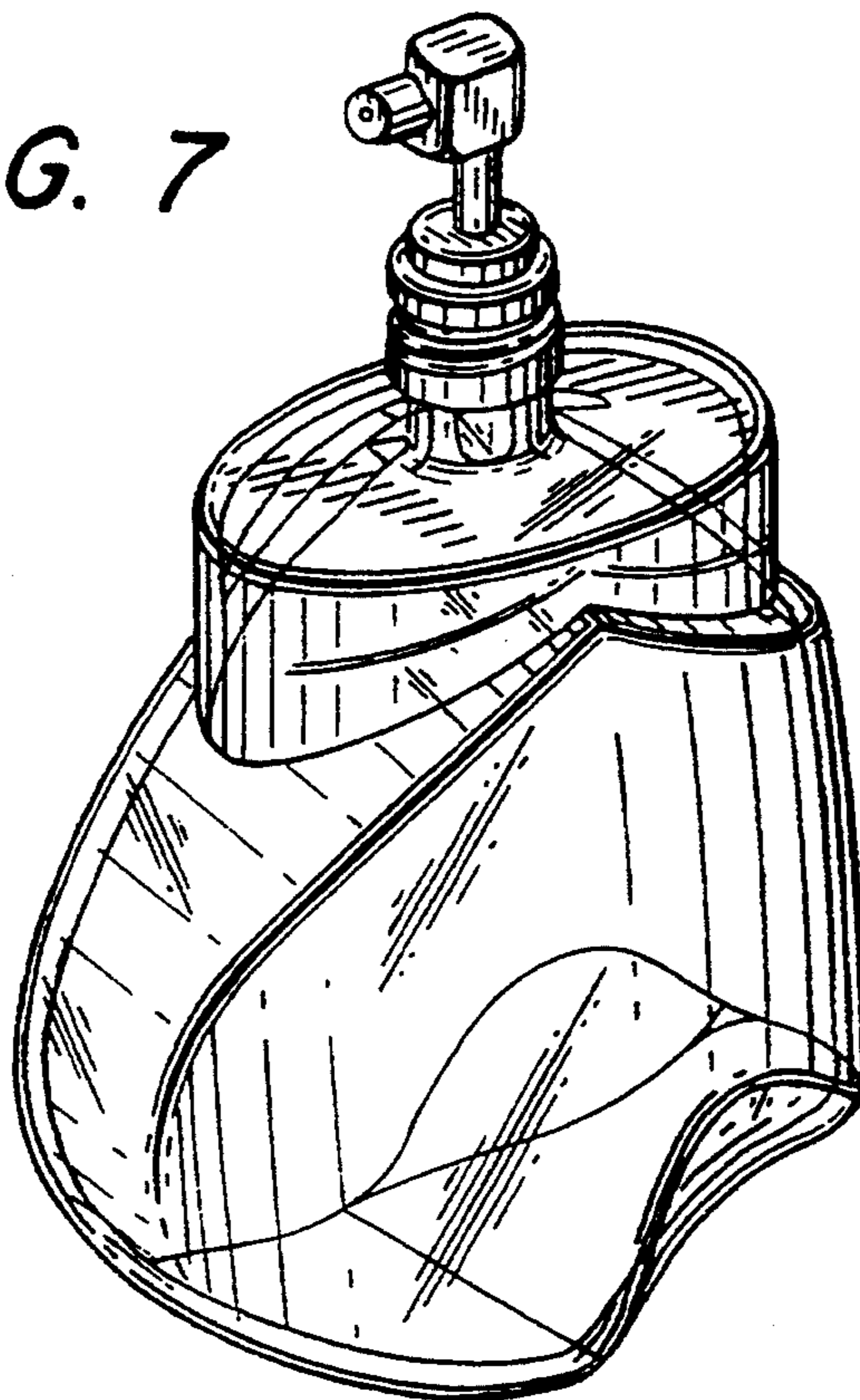
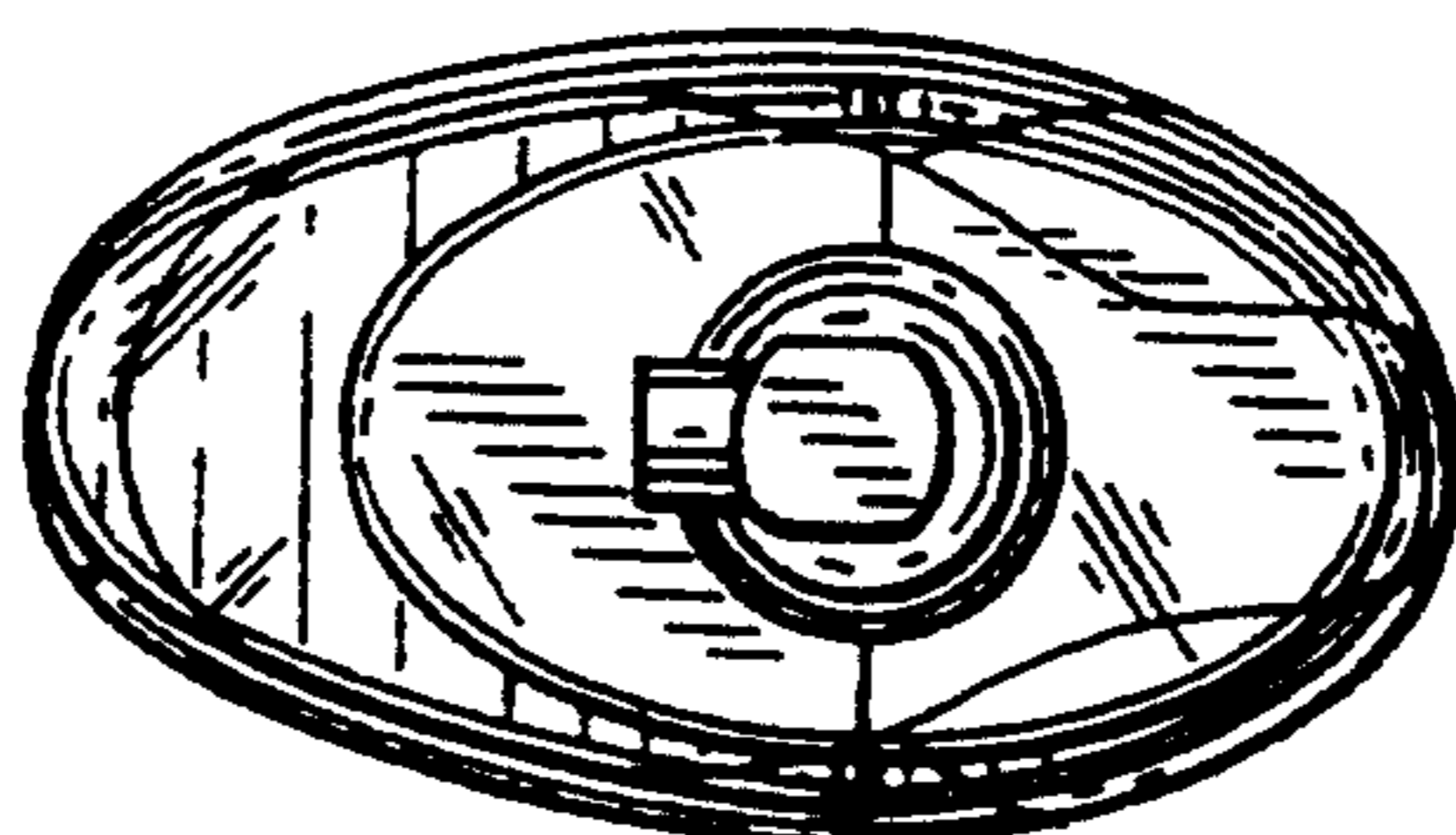

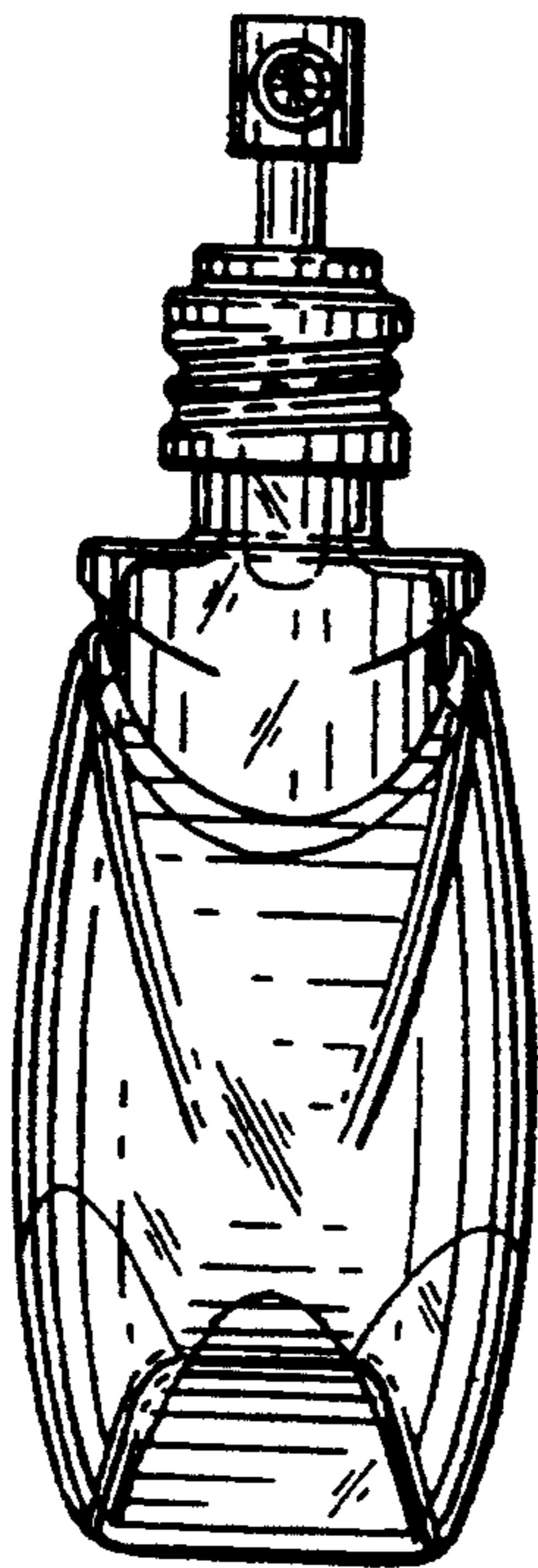

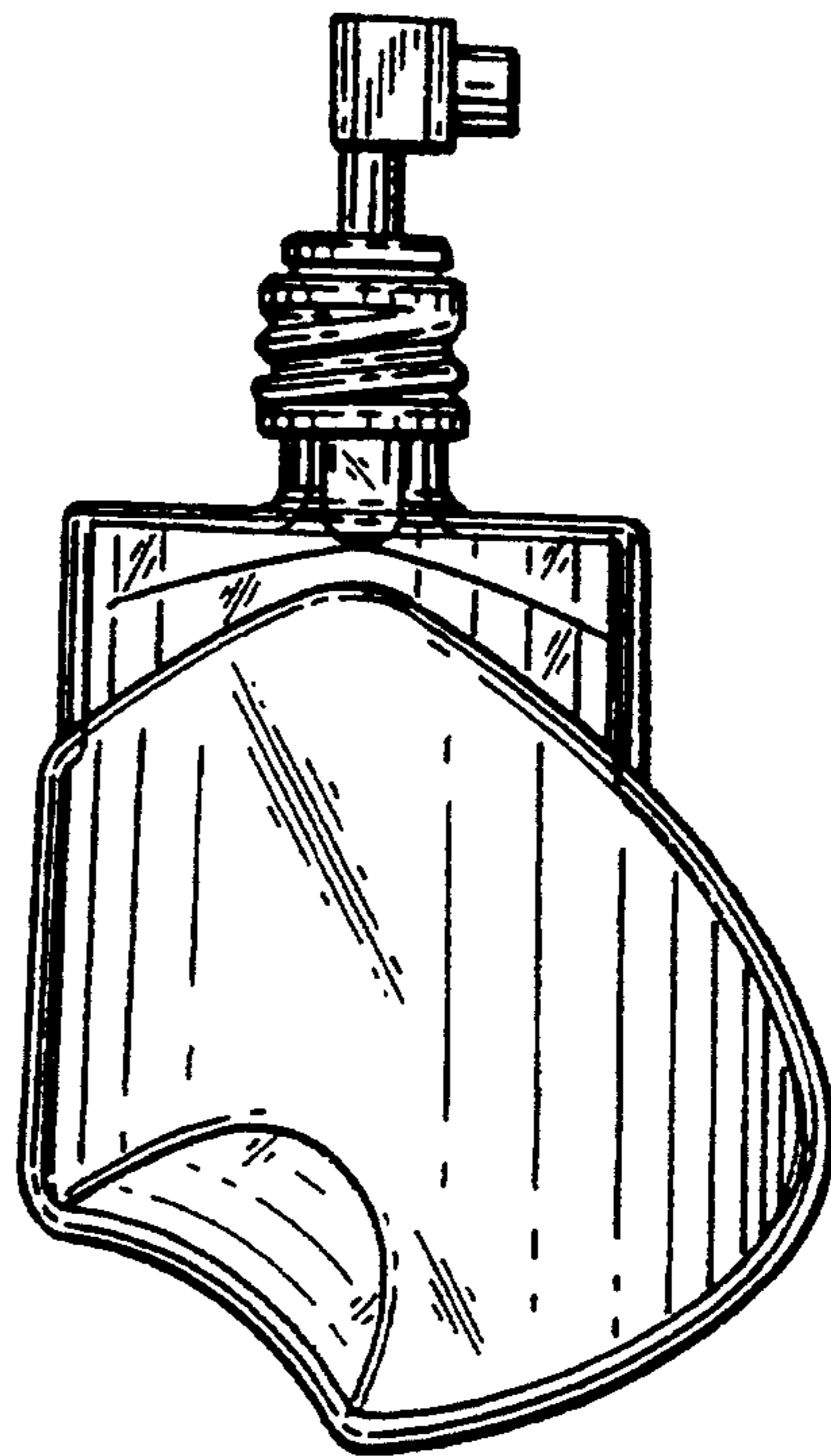

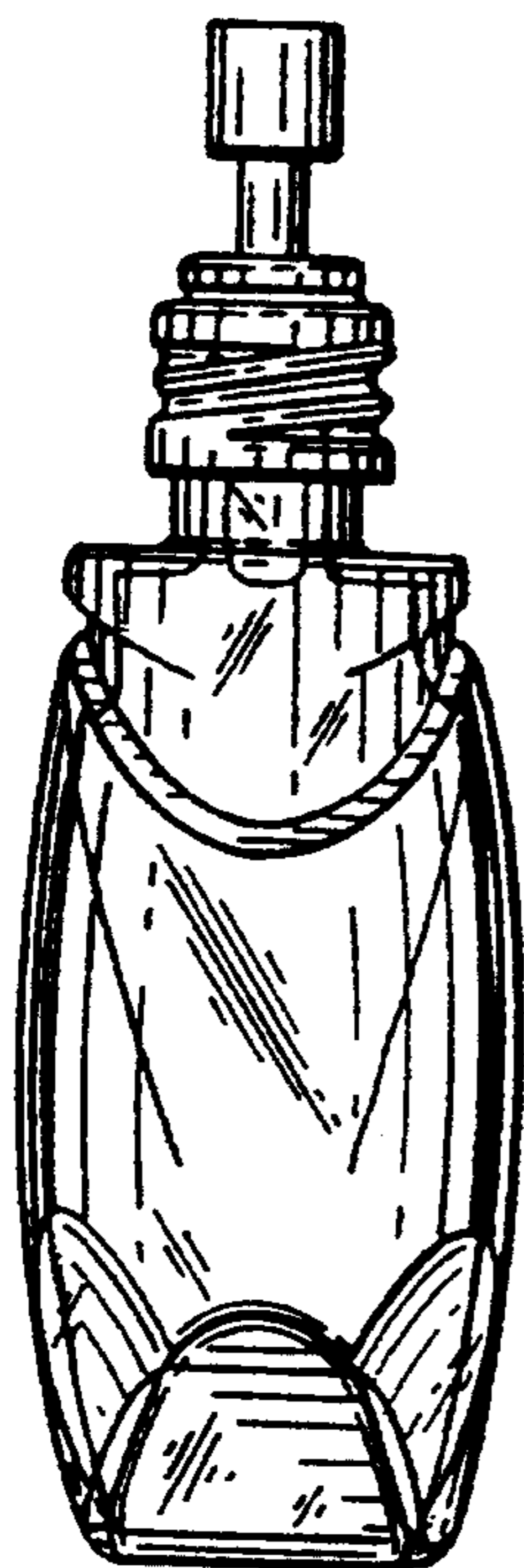

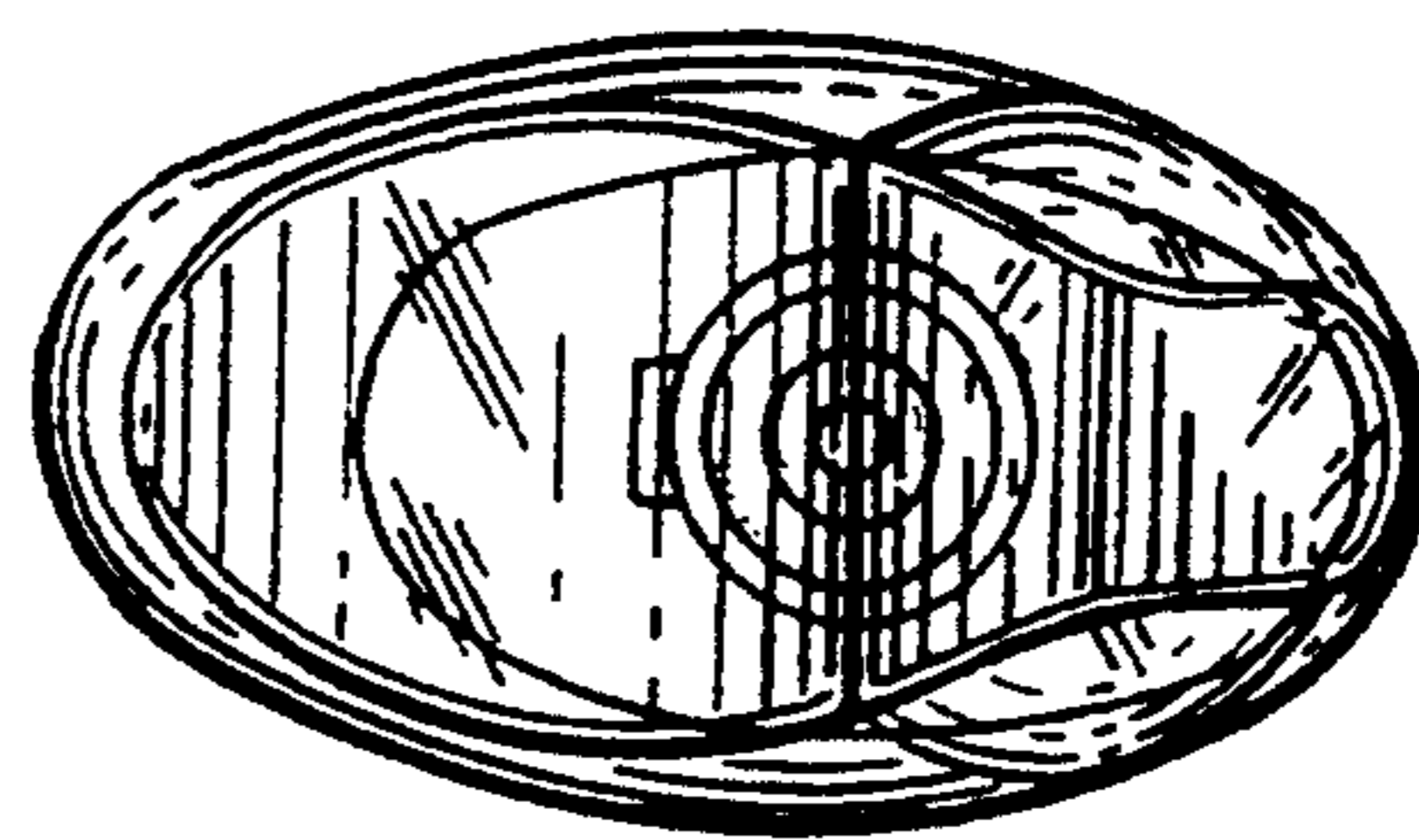
