FIG. 1 is a reduced top right front perspective view of a combined keyholder and message holder showing our new design;

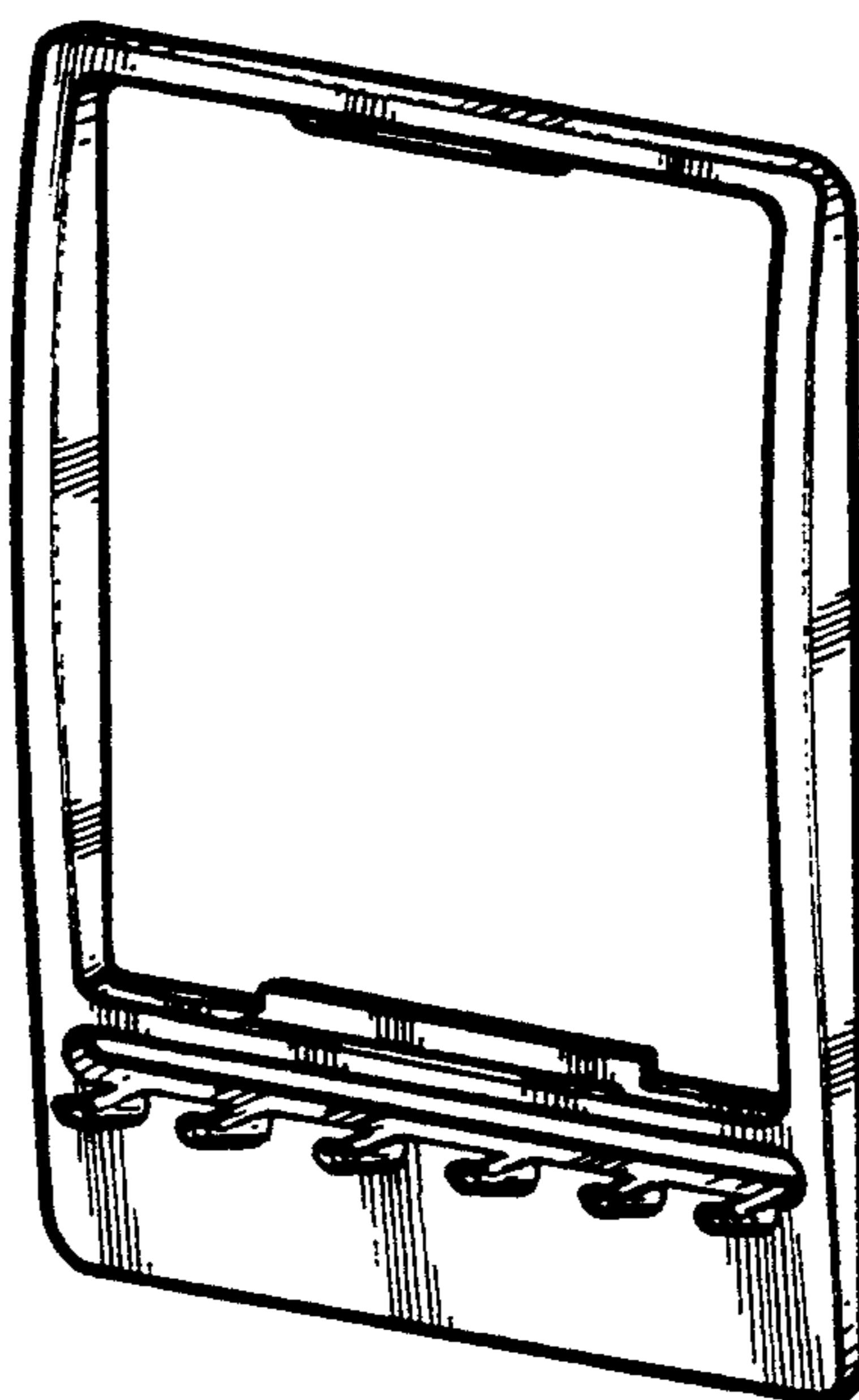
FIG. 2 is a front elevational view thereof;

FIG. 6 is a bottom plan view thereof.



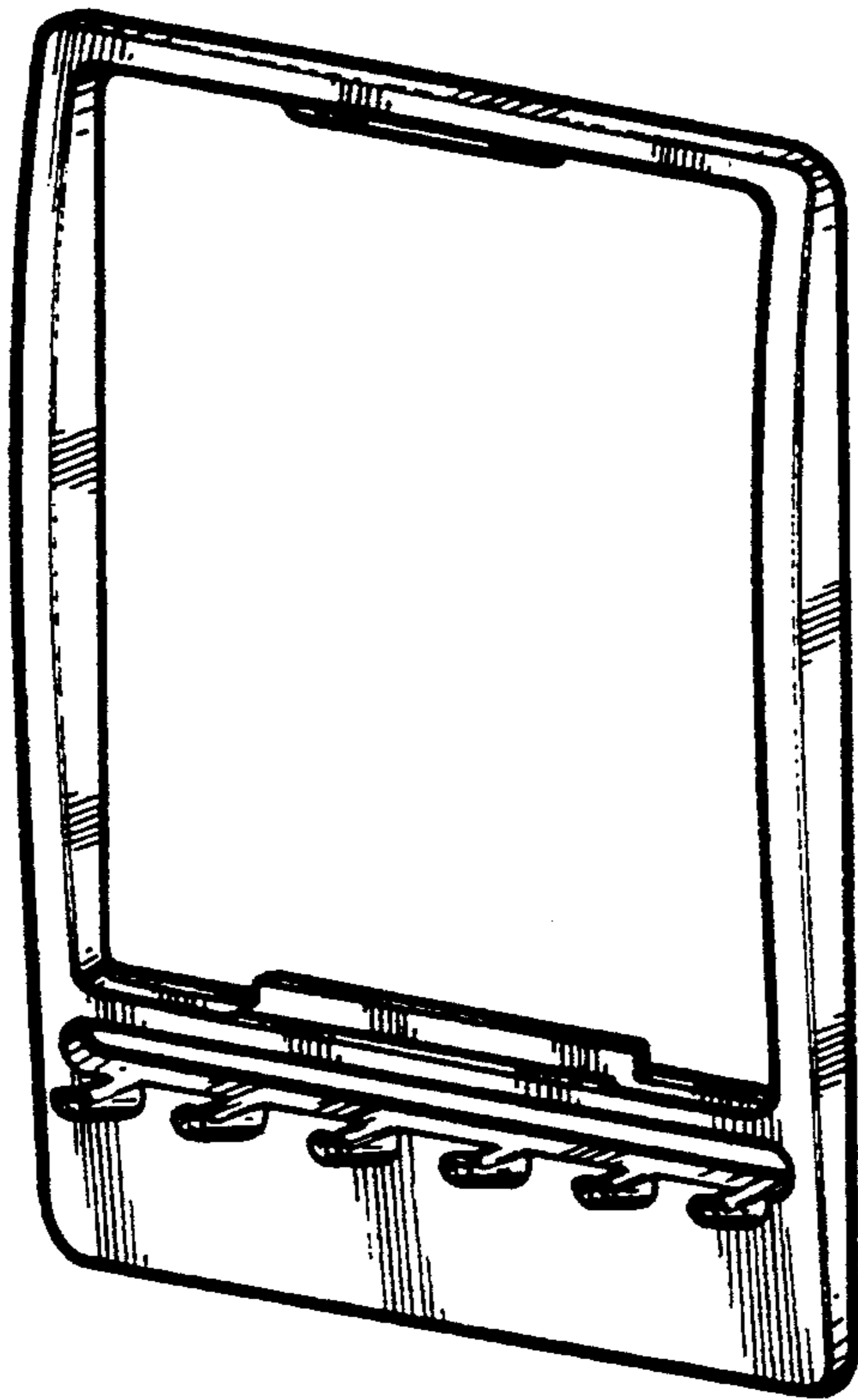

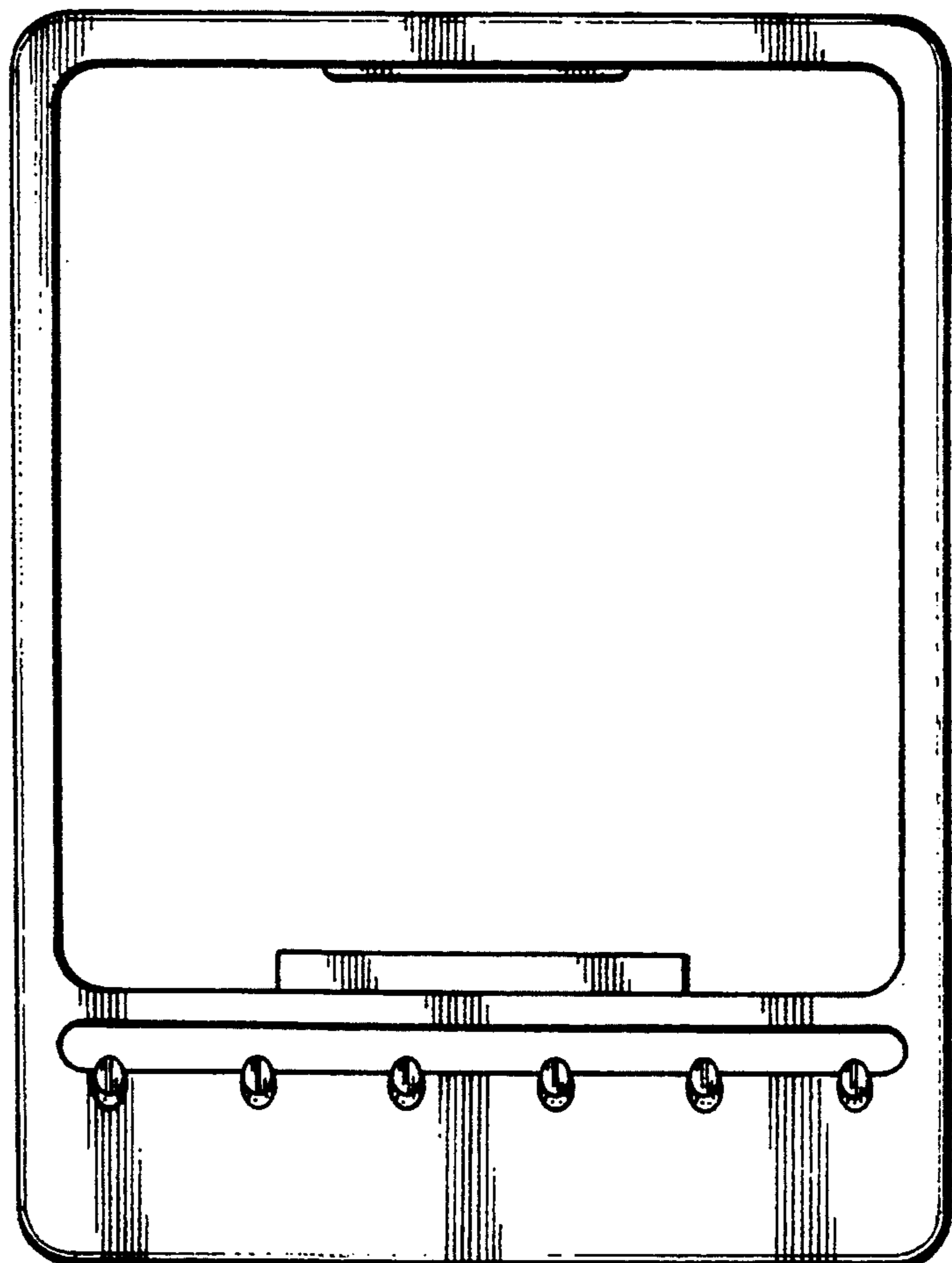

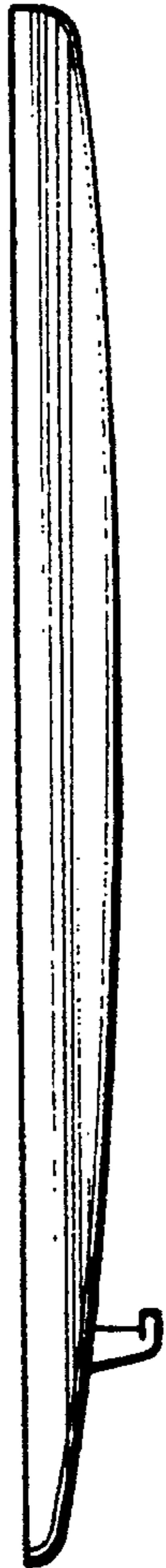

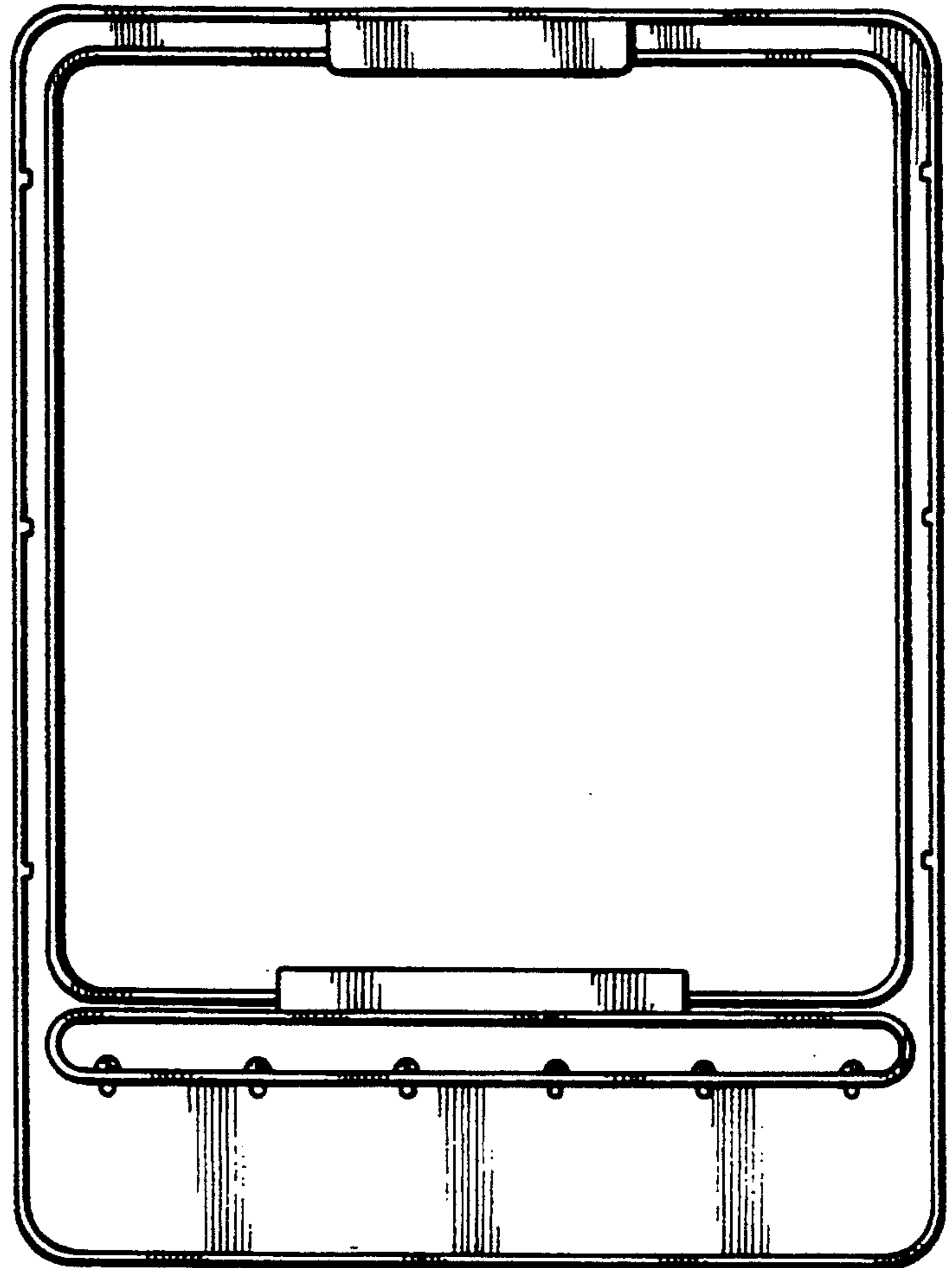

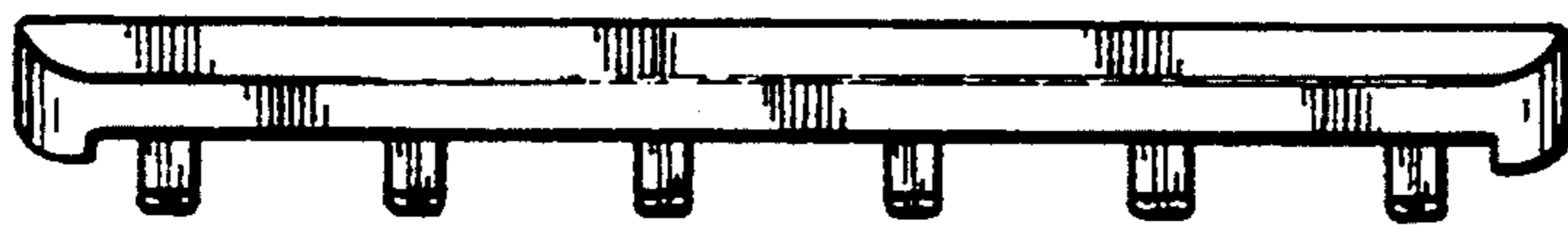
