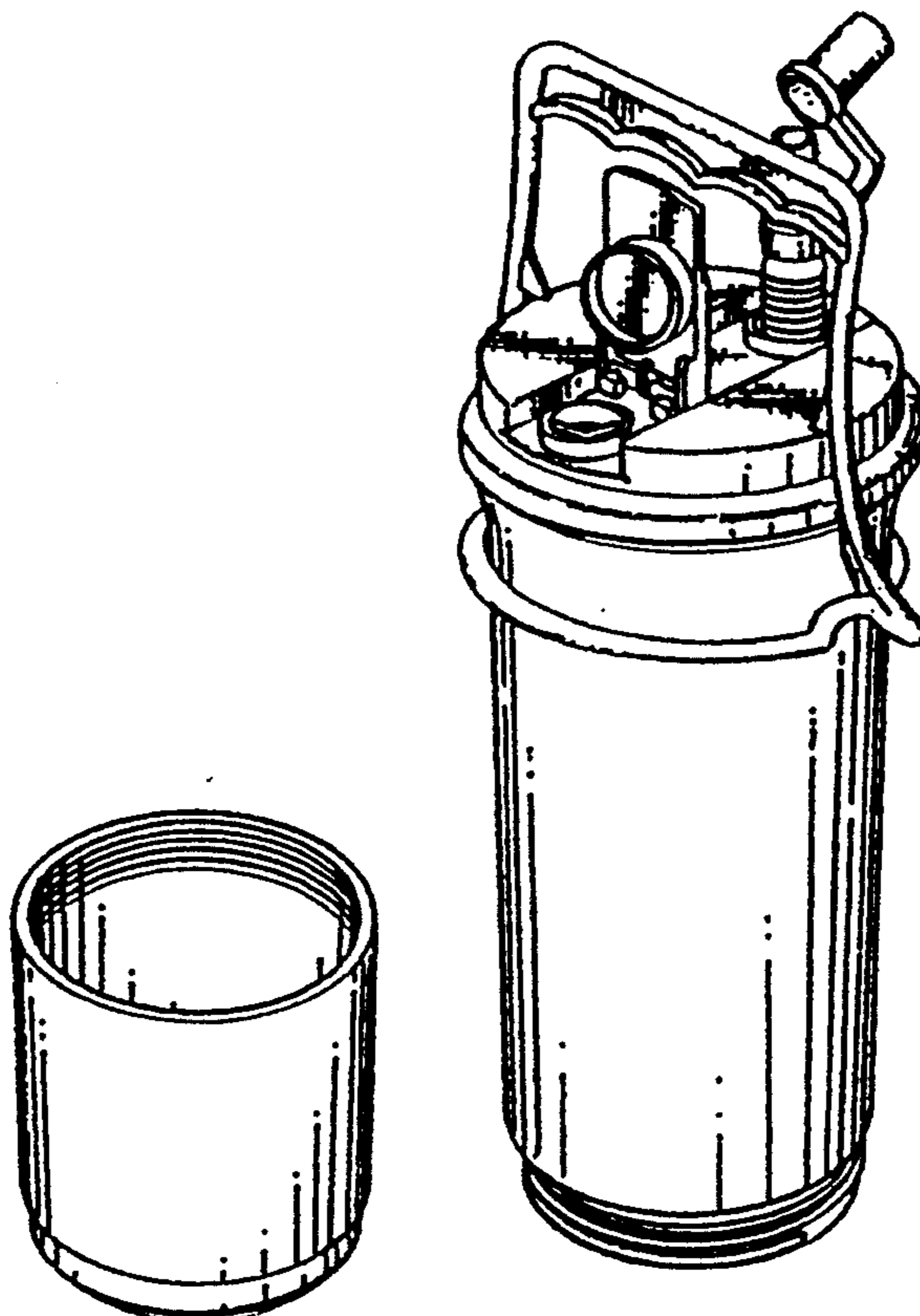

[57] **CLAIM**

The ornamental design for a kettle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a kettle showing our new design;  
FIG. 2 is a front elevation view of a kettle showing our new design;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is the right side elevation view thereof, and left side elevation view is the same as the right one;  
FIG. 5 is the top plan view thereof;  
FIG. 6 is the bottom plan view thereof; and,  
FIG. 7 is an in use top perspective view thereof with detachable cup placed adjacently.



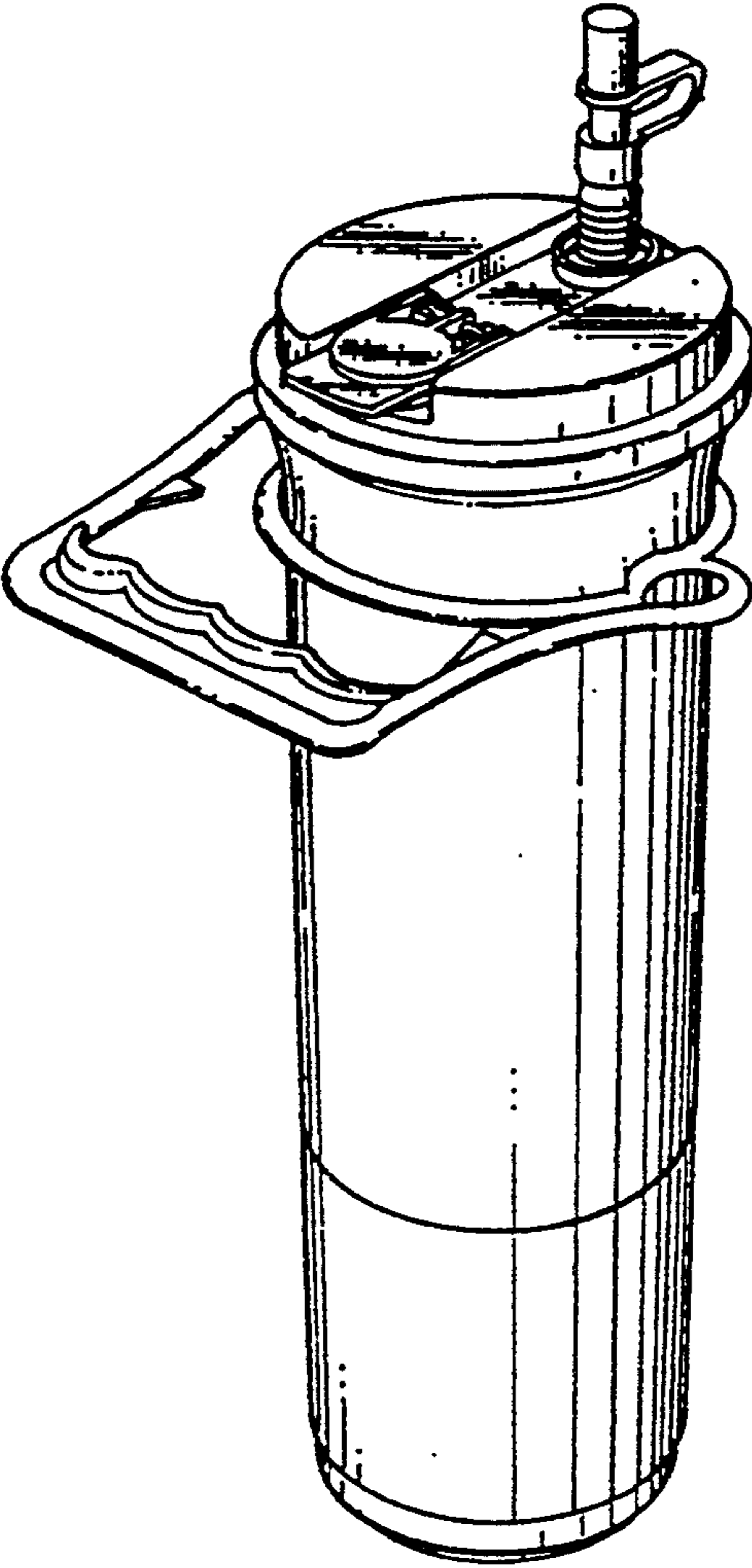

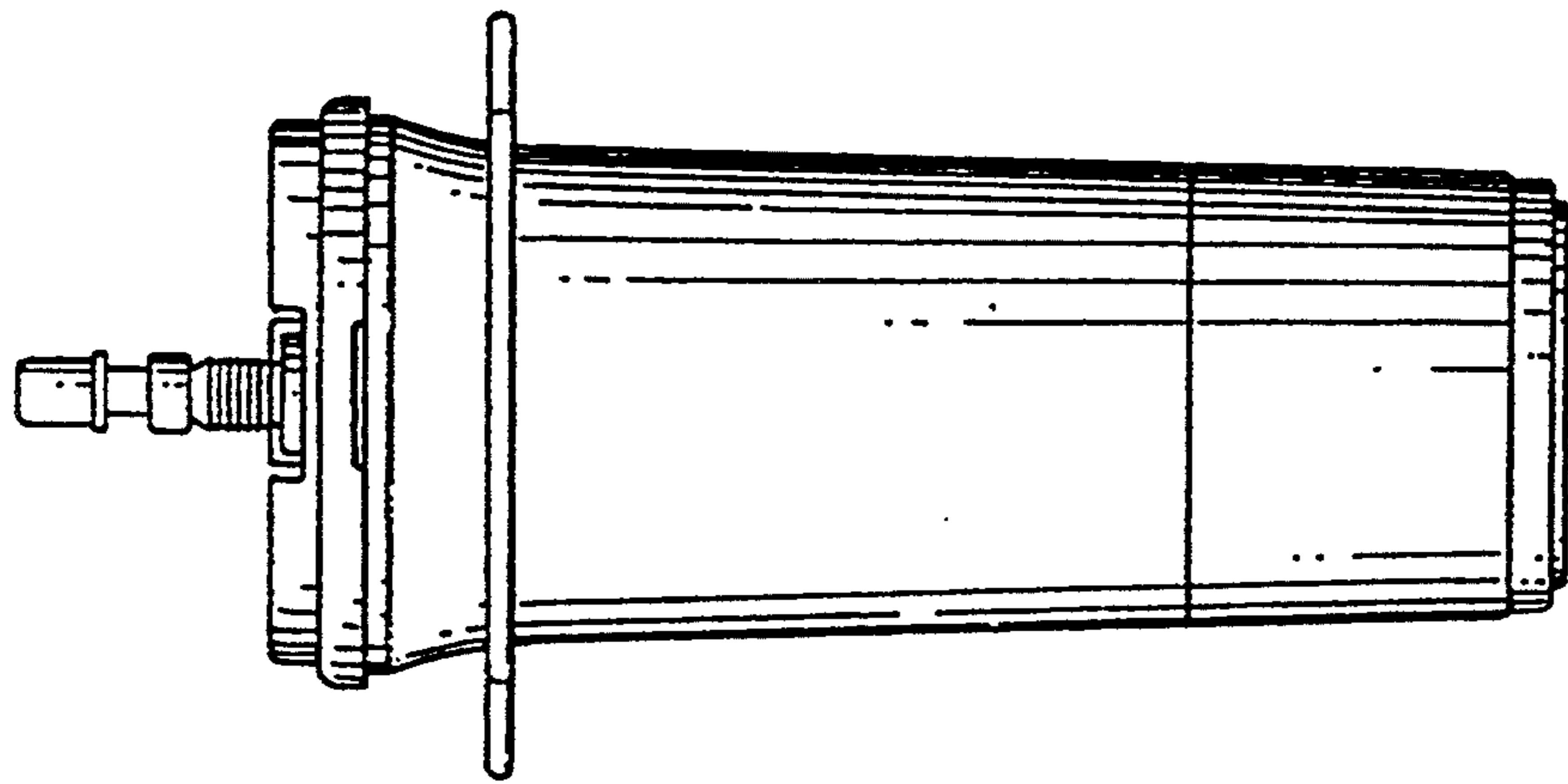

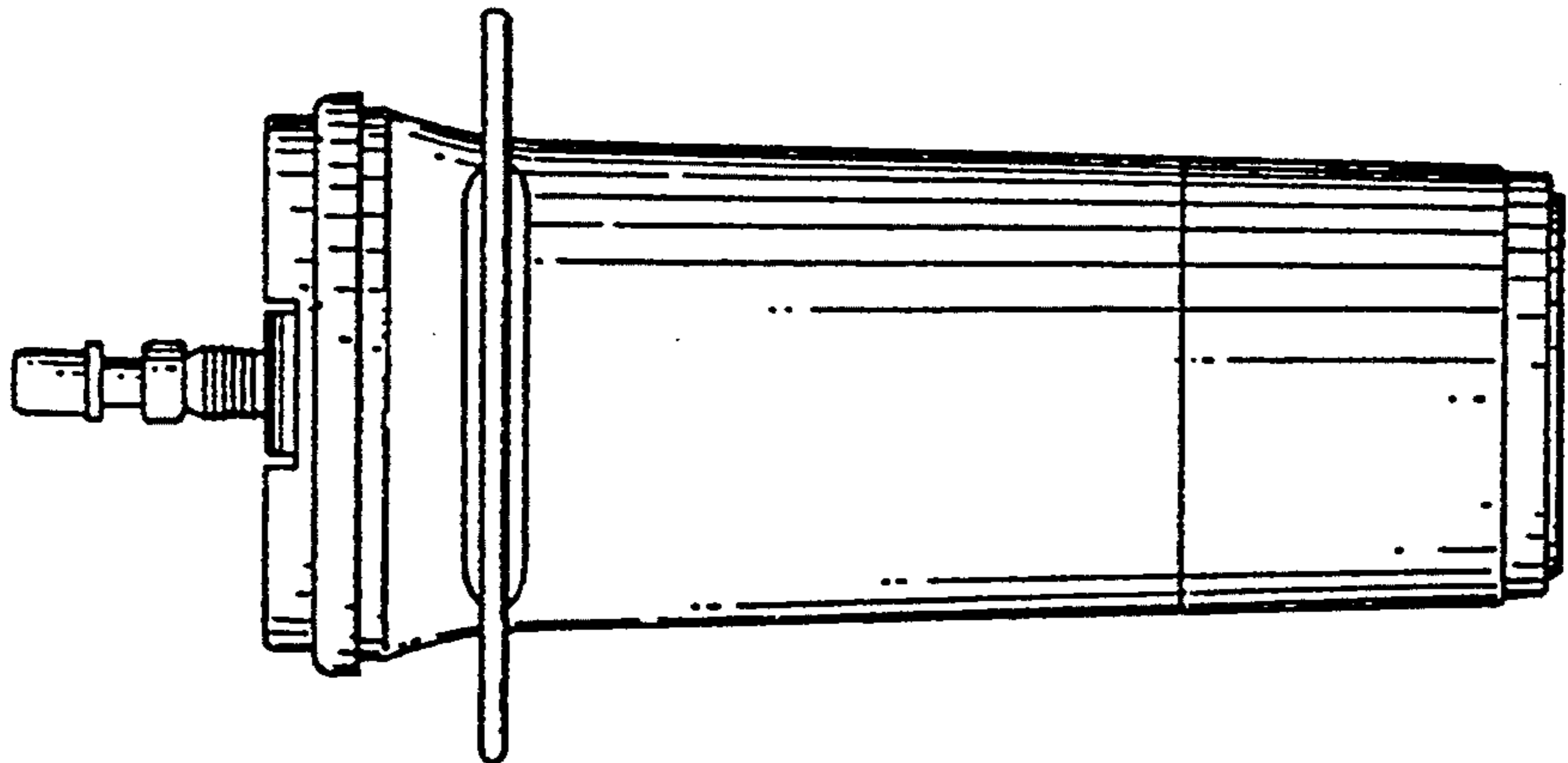

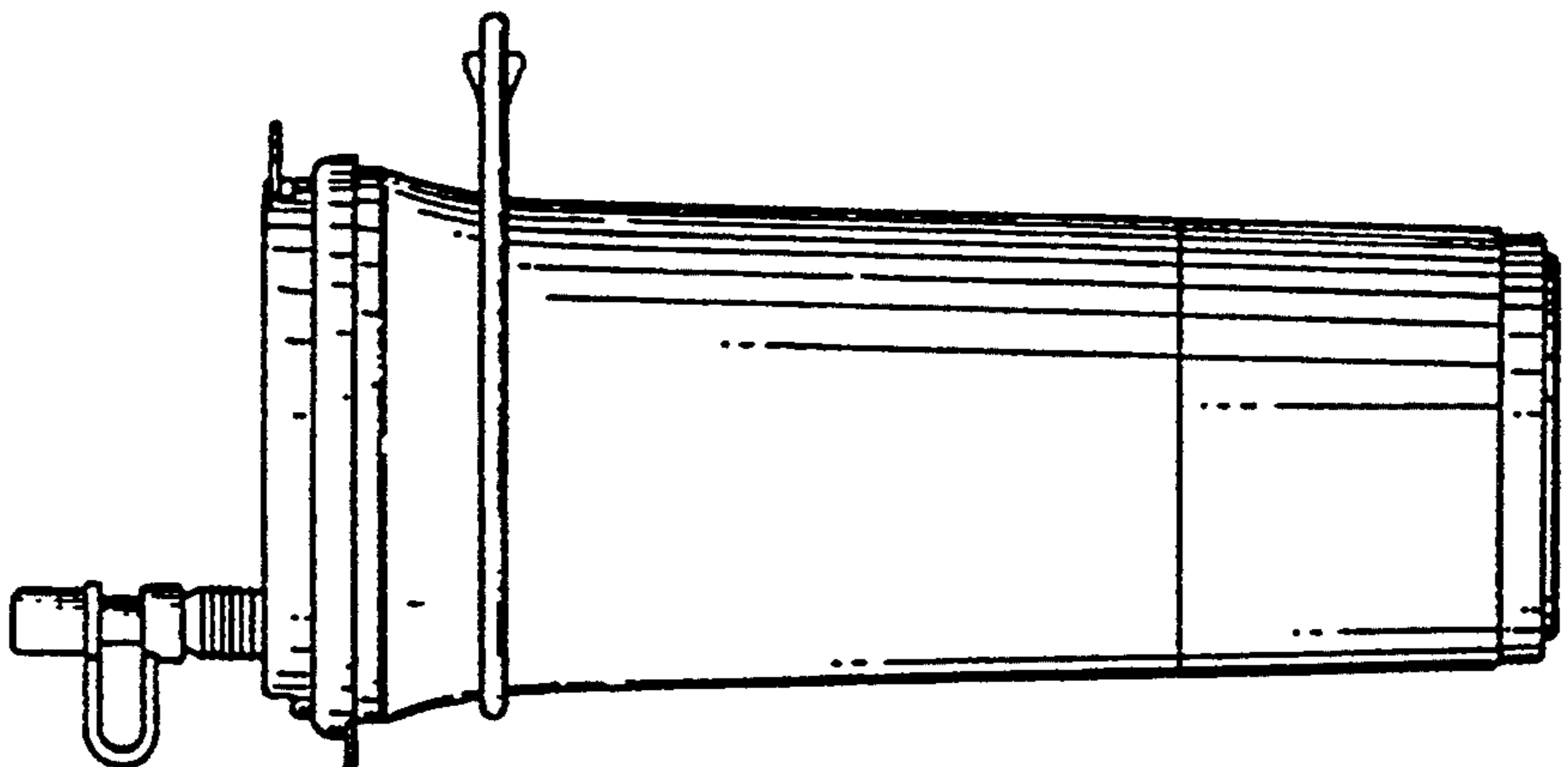

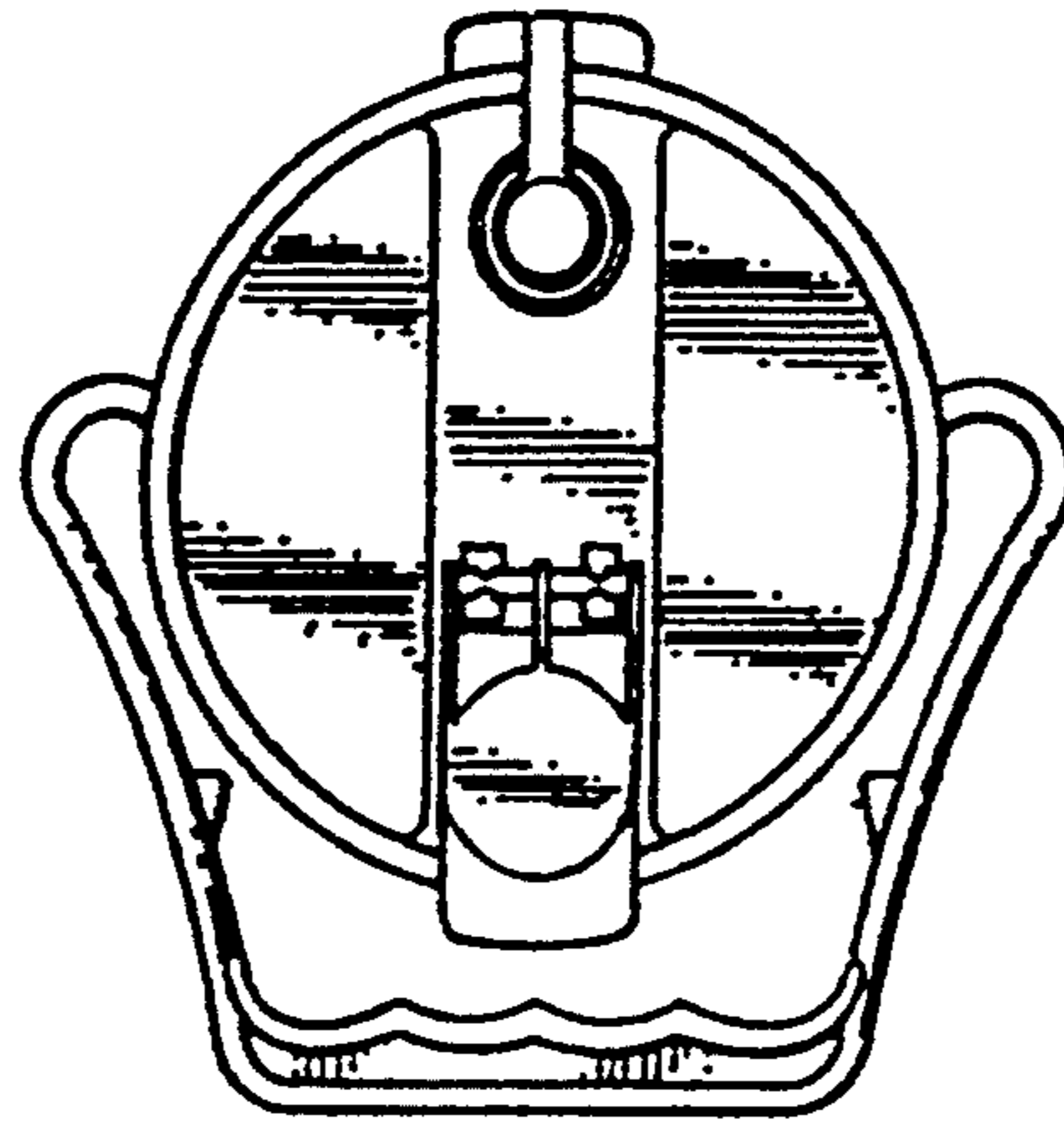

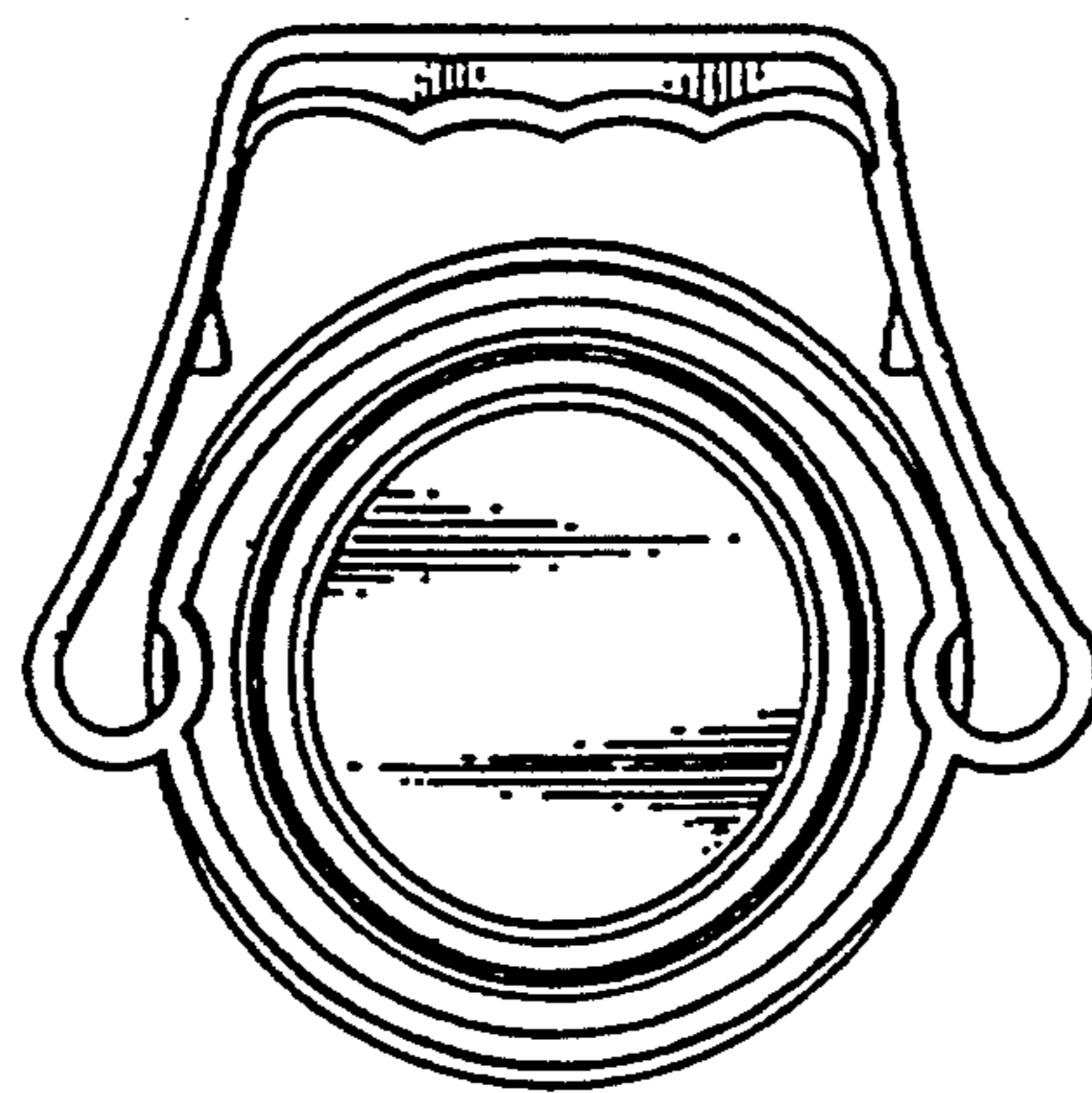

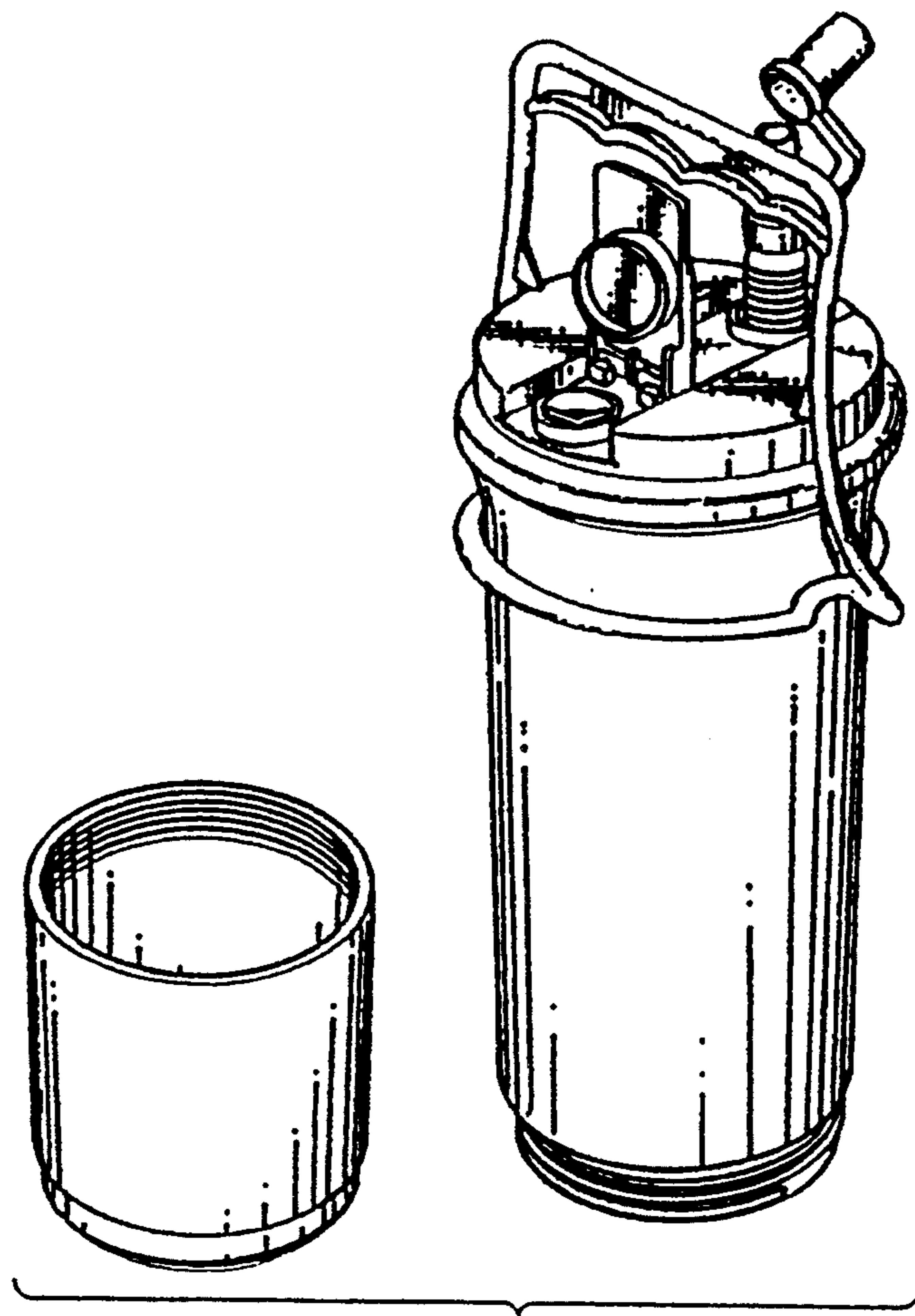
