### [57] CLAIM

The ornamental design for a trigger sprayer, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of a trigger sprayer showing my new design;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a right side elevational view thereof;  
 FIG. 6 is a bottom plan view thereof; and,  
 FIG. 7 is a top perspective view thereof, the broken line drawing of the nozzle tip and neck attachment are for illustrative purposes only and form no part of the claimed design.

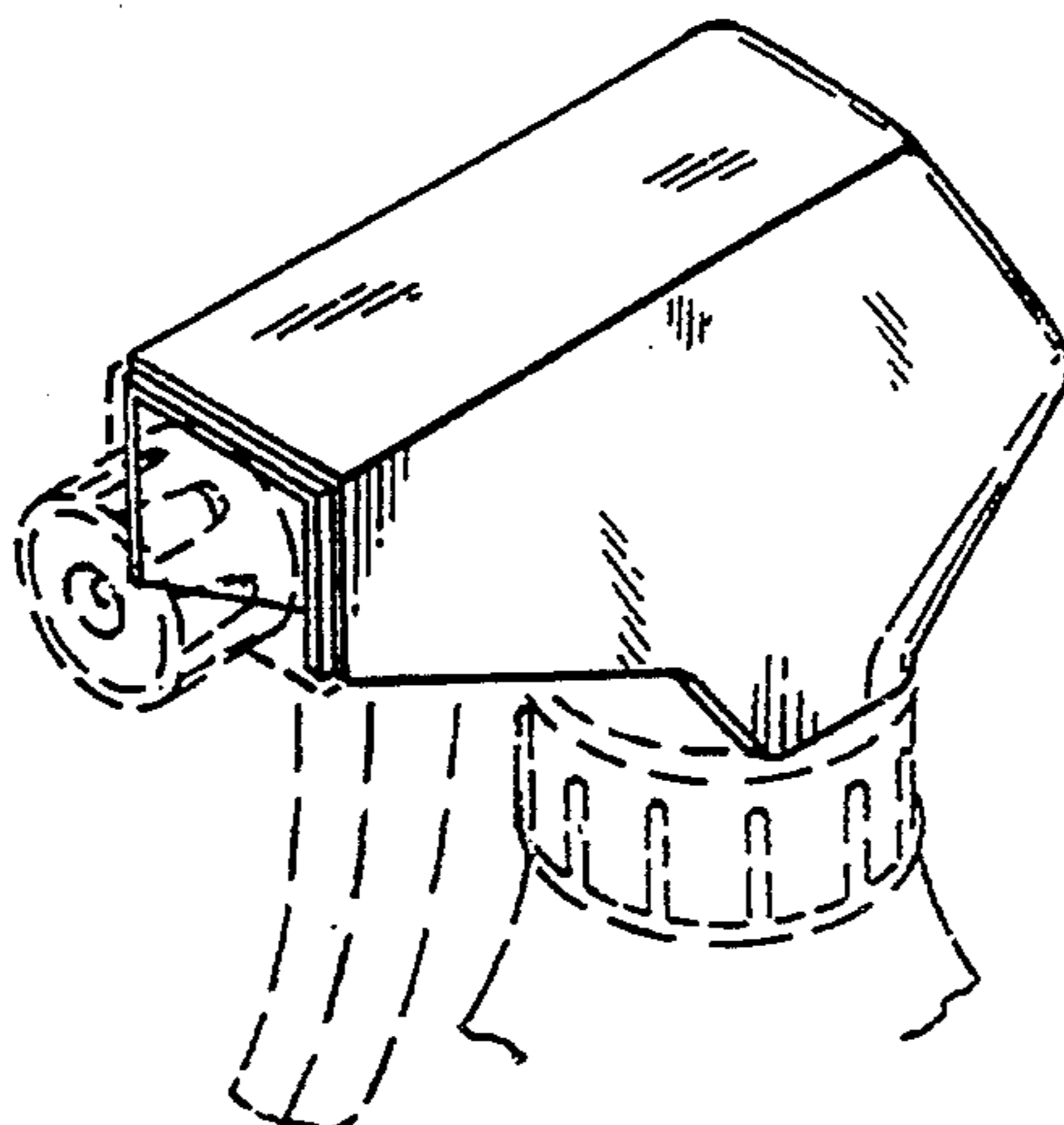

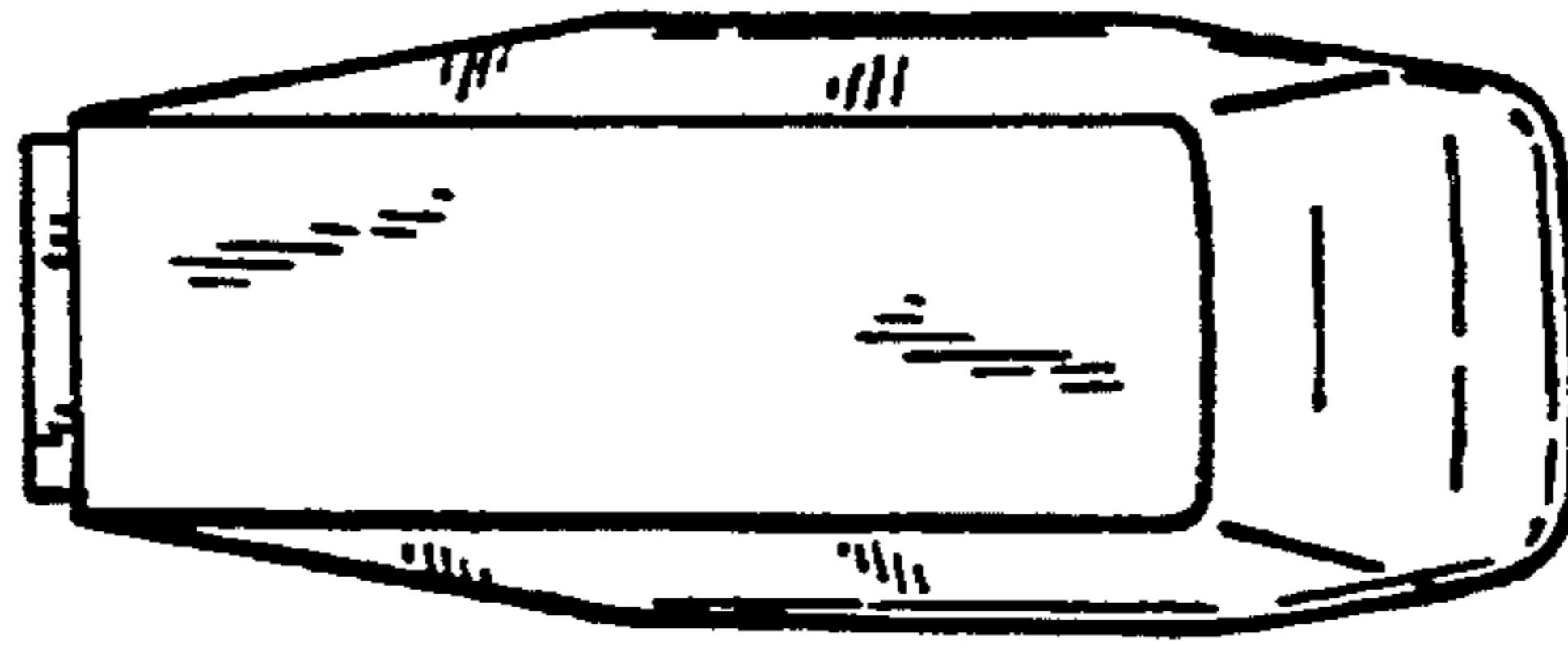

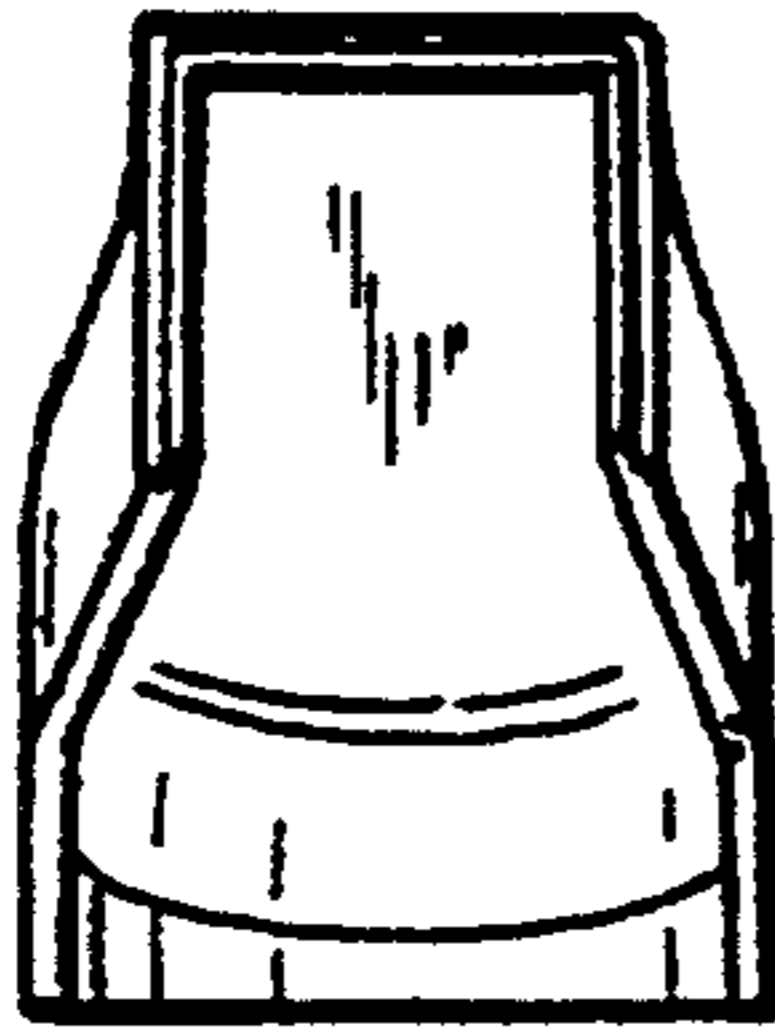

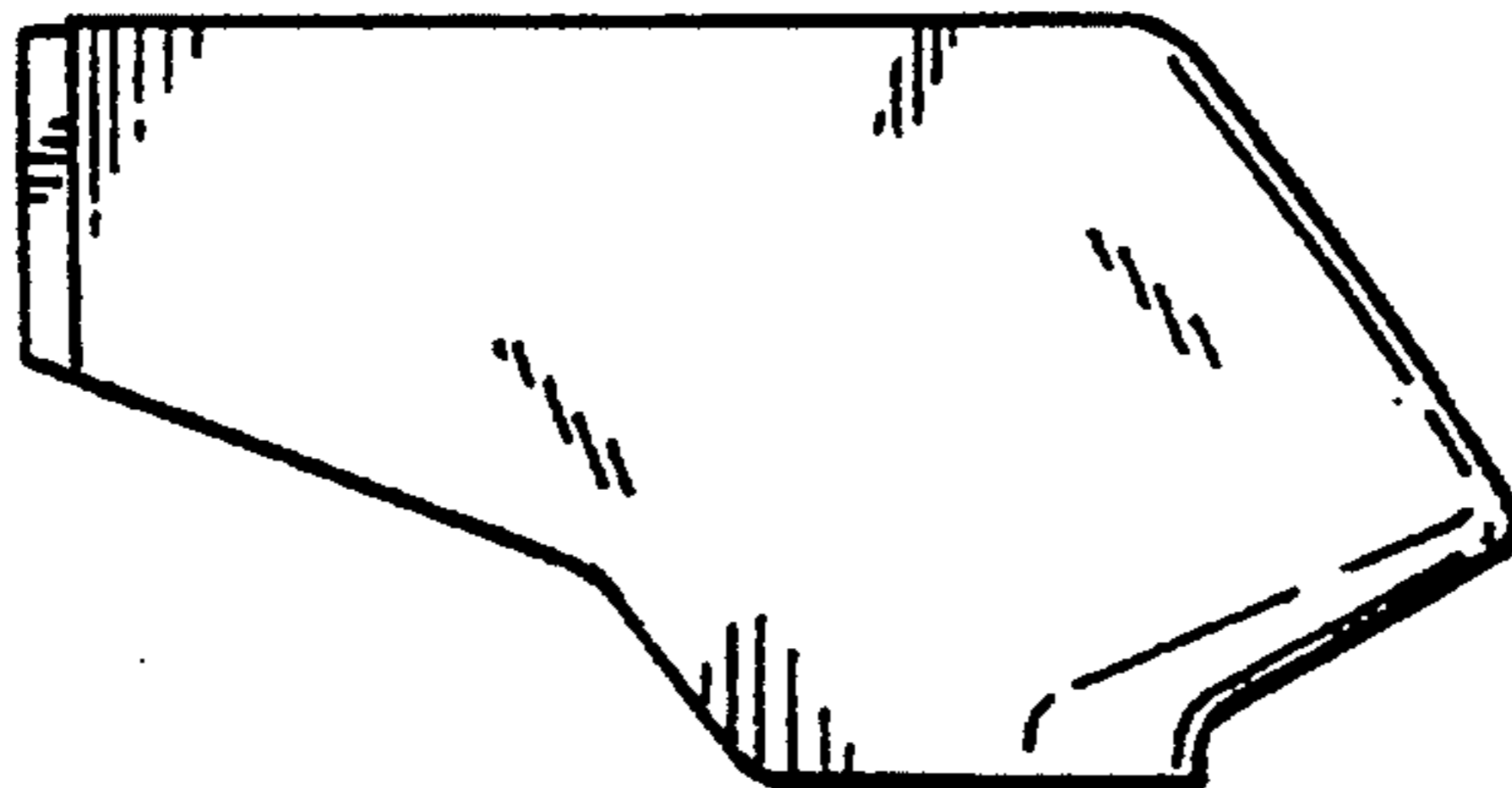

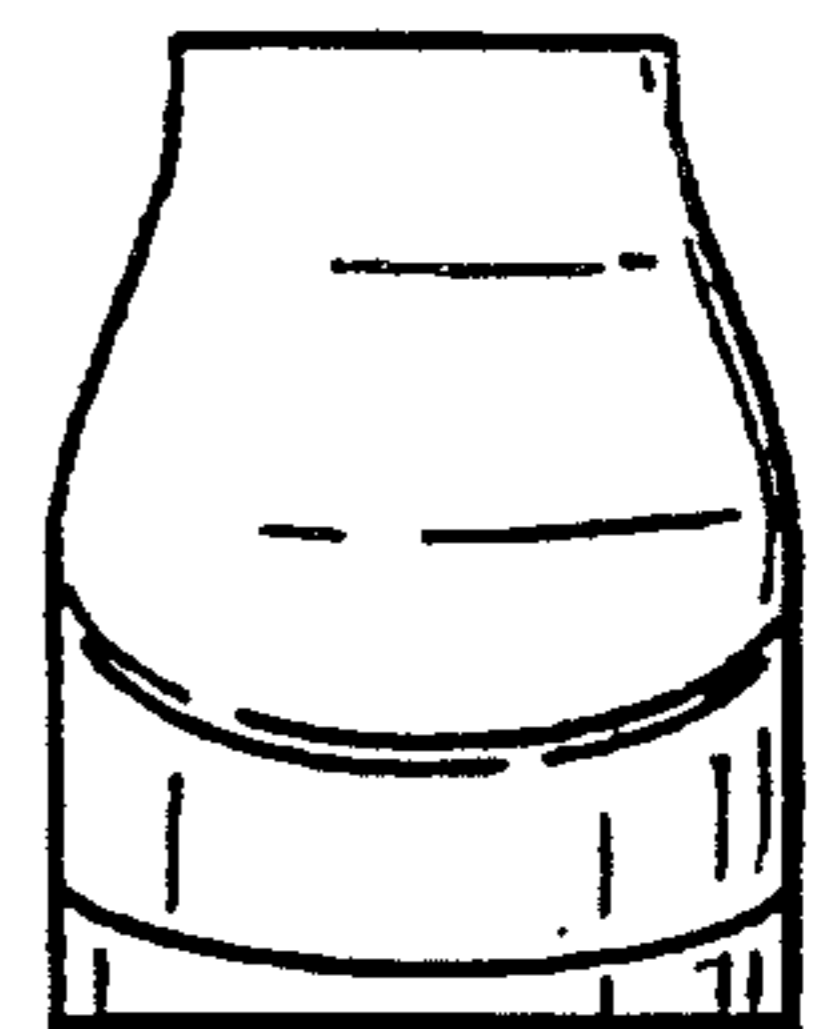

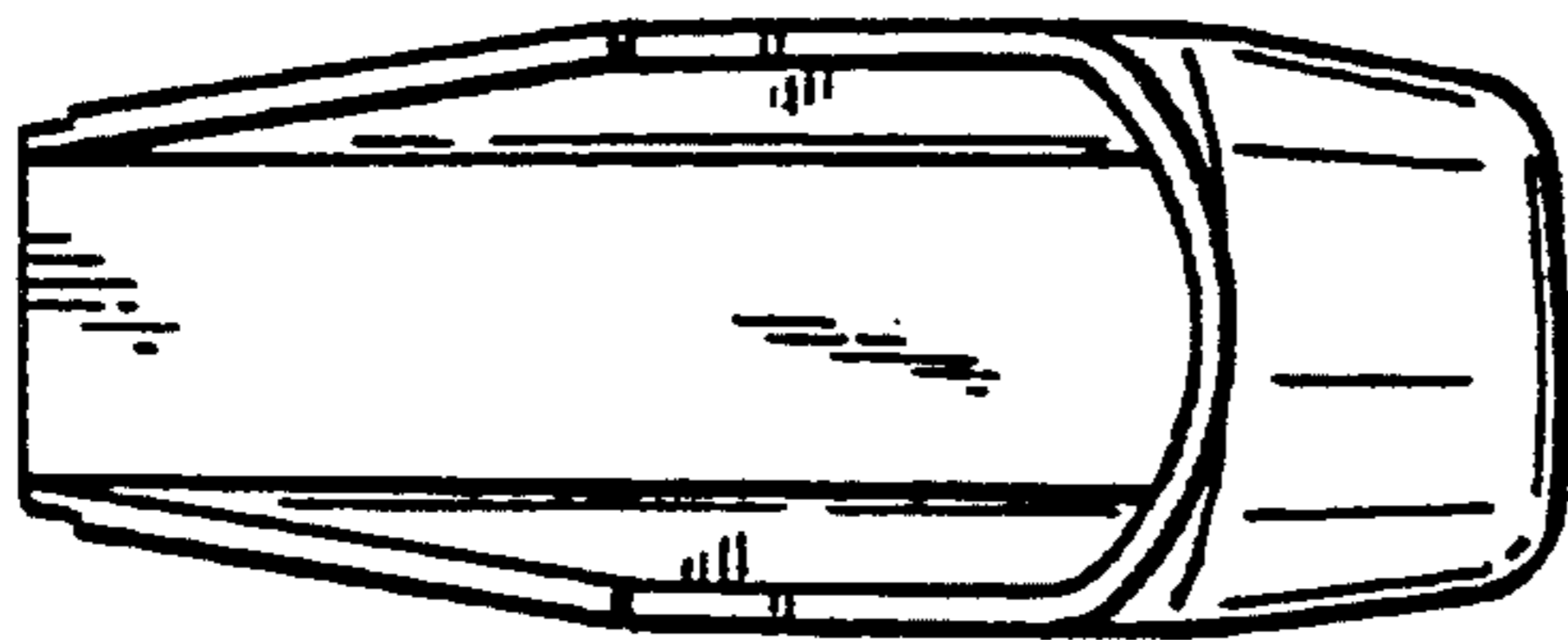

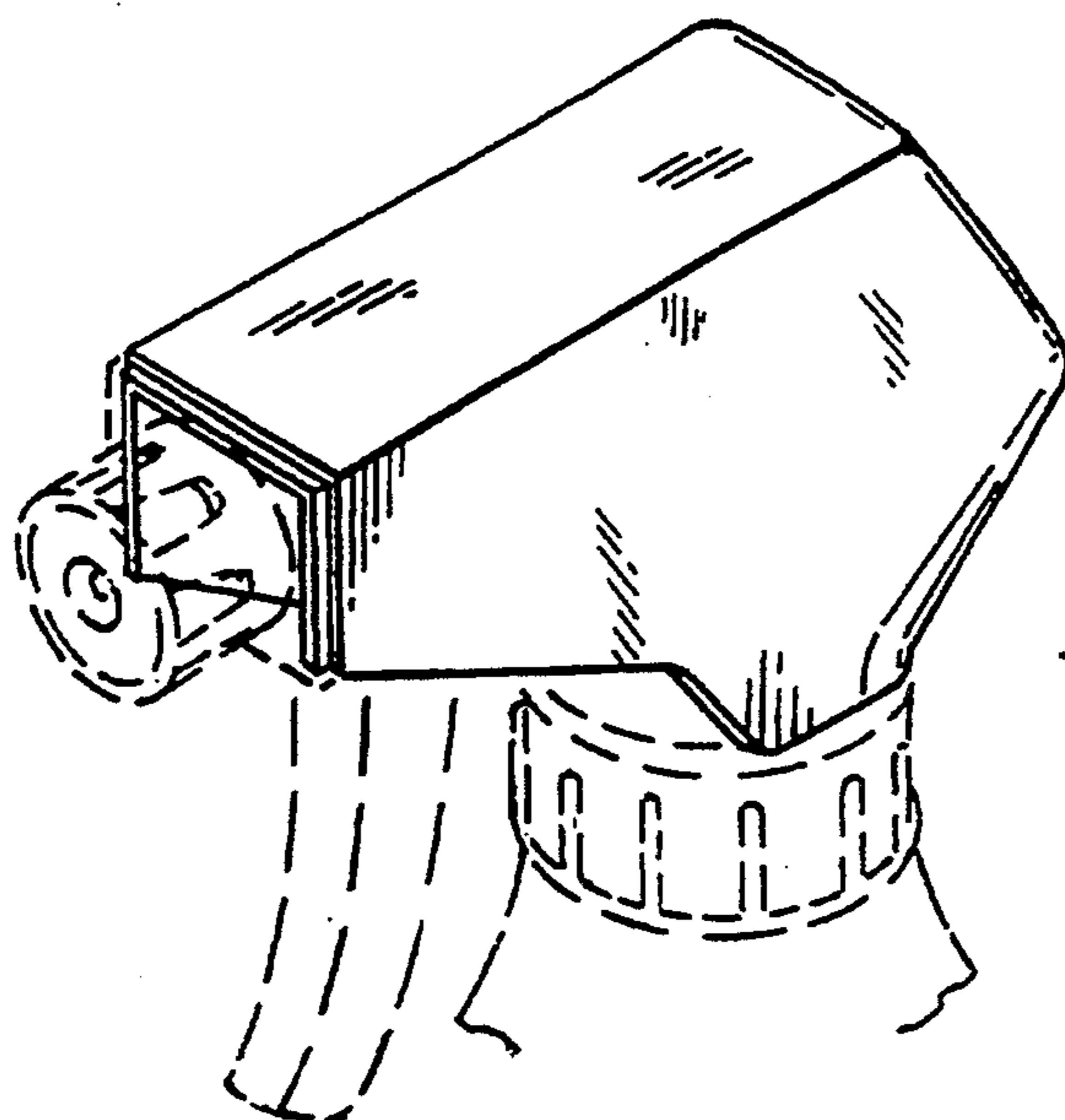
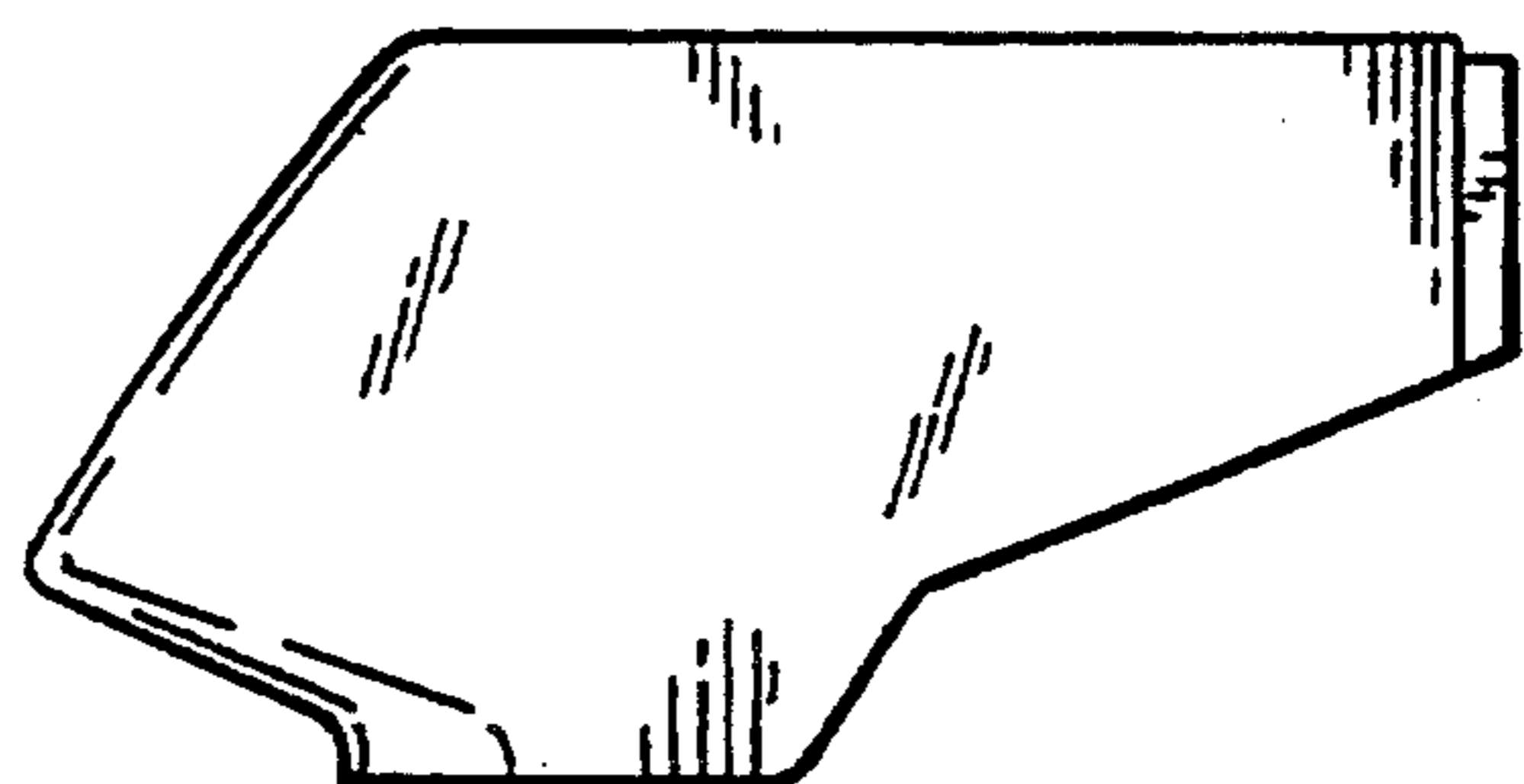
