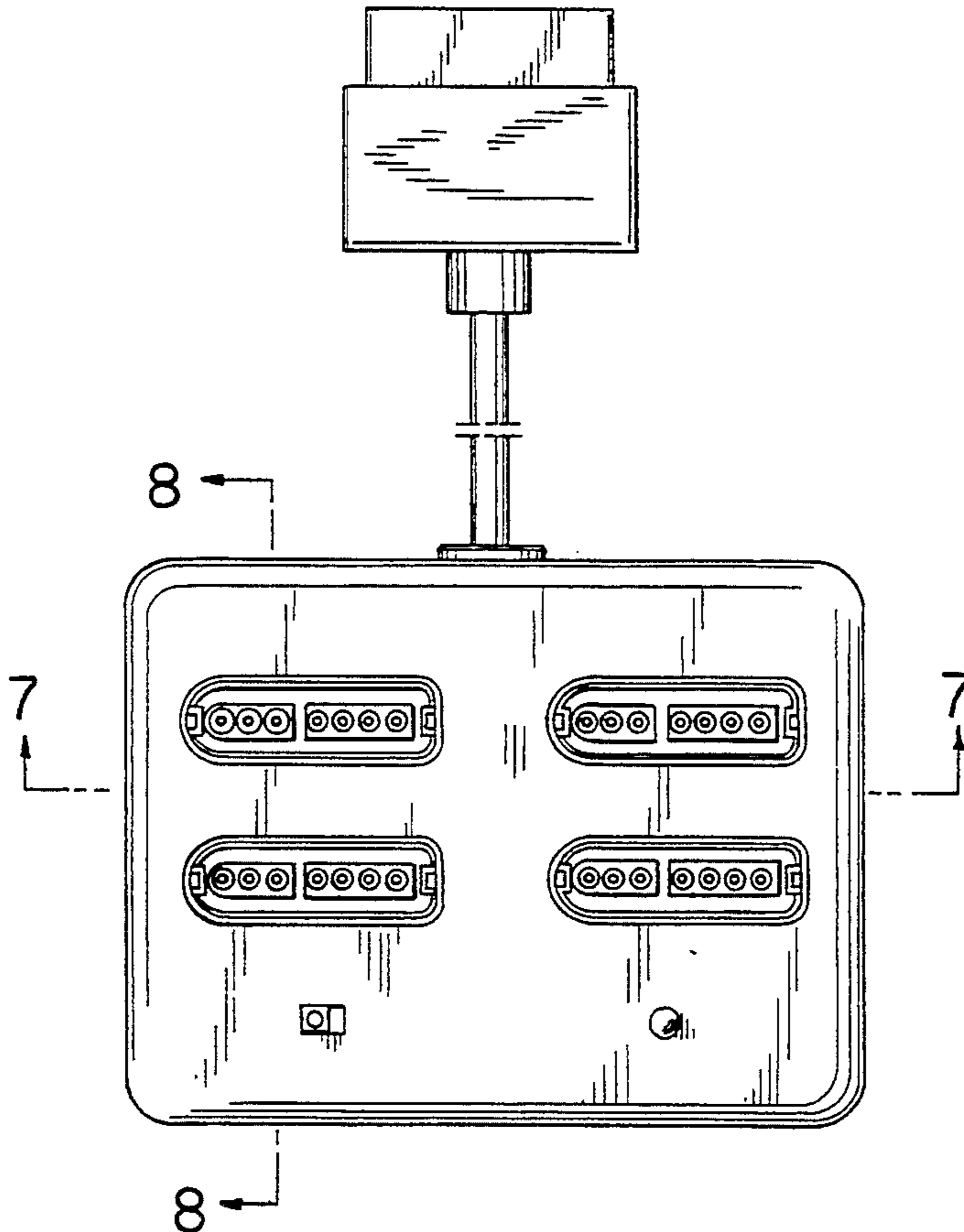

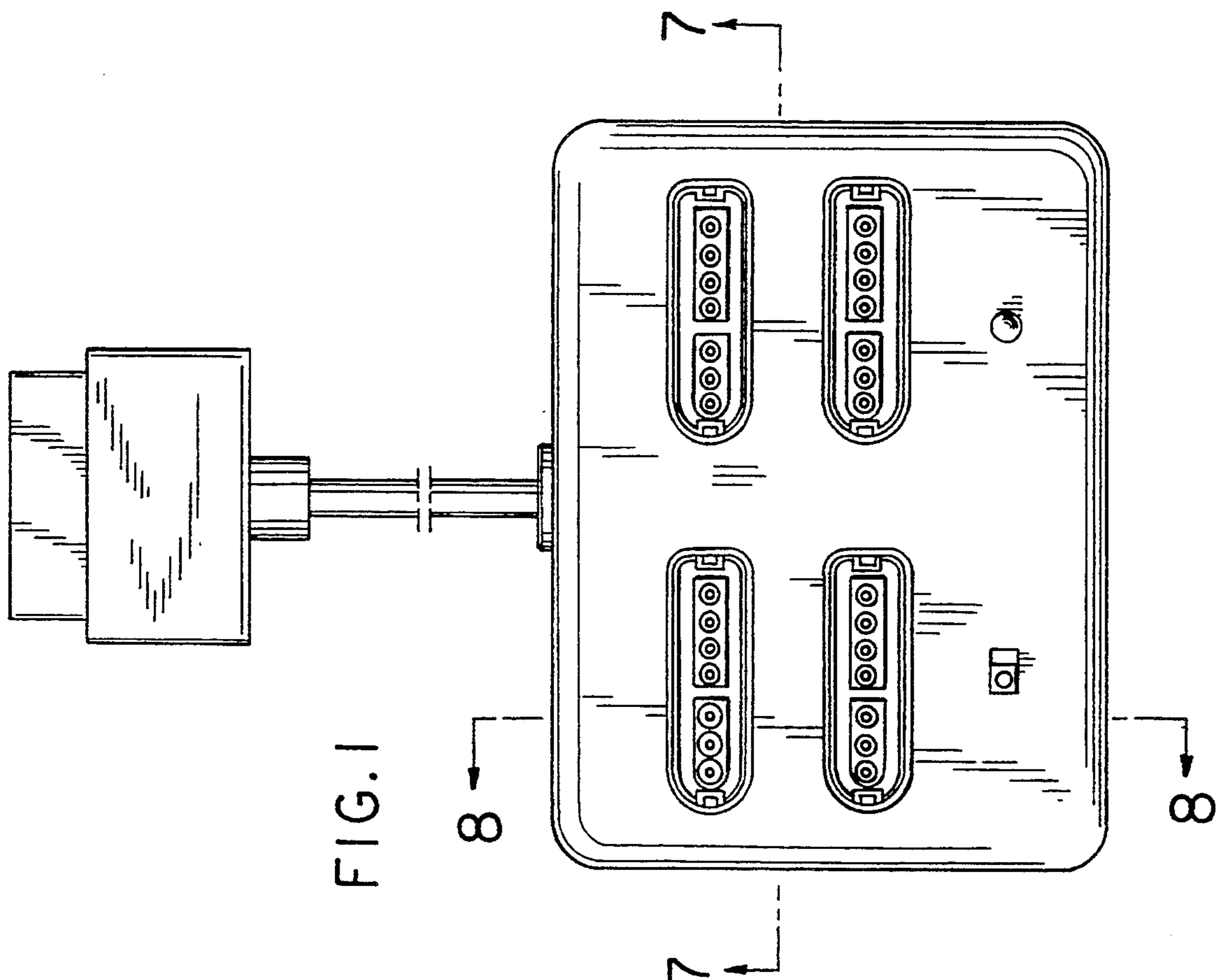
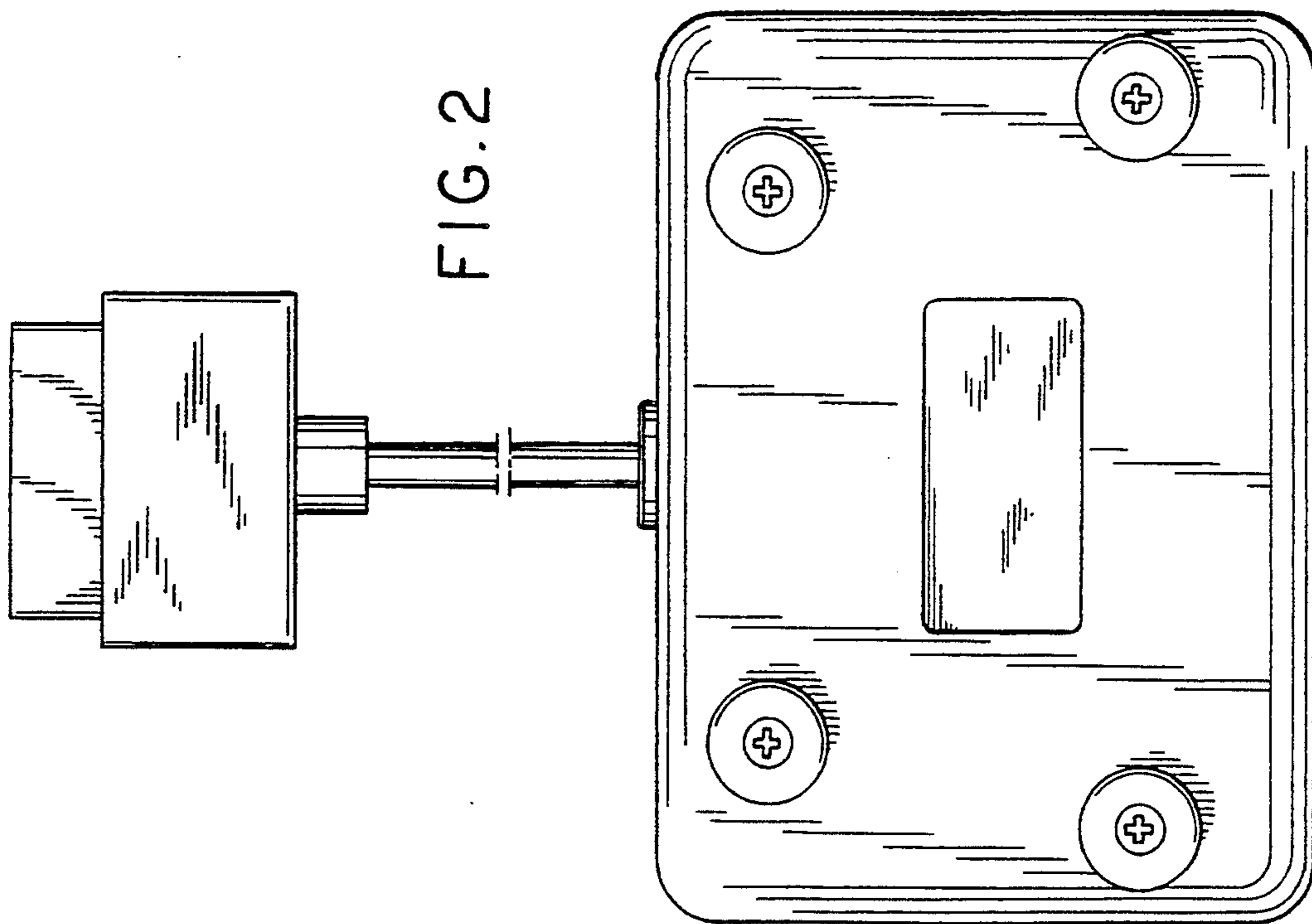
The broken lines showing hand held controllers, video game control and conduits in FIG. 9 is for illustrative purposes only and forms no part of the claim.

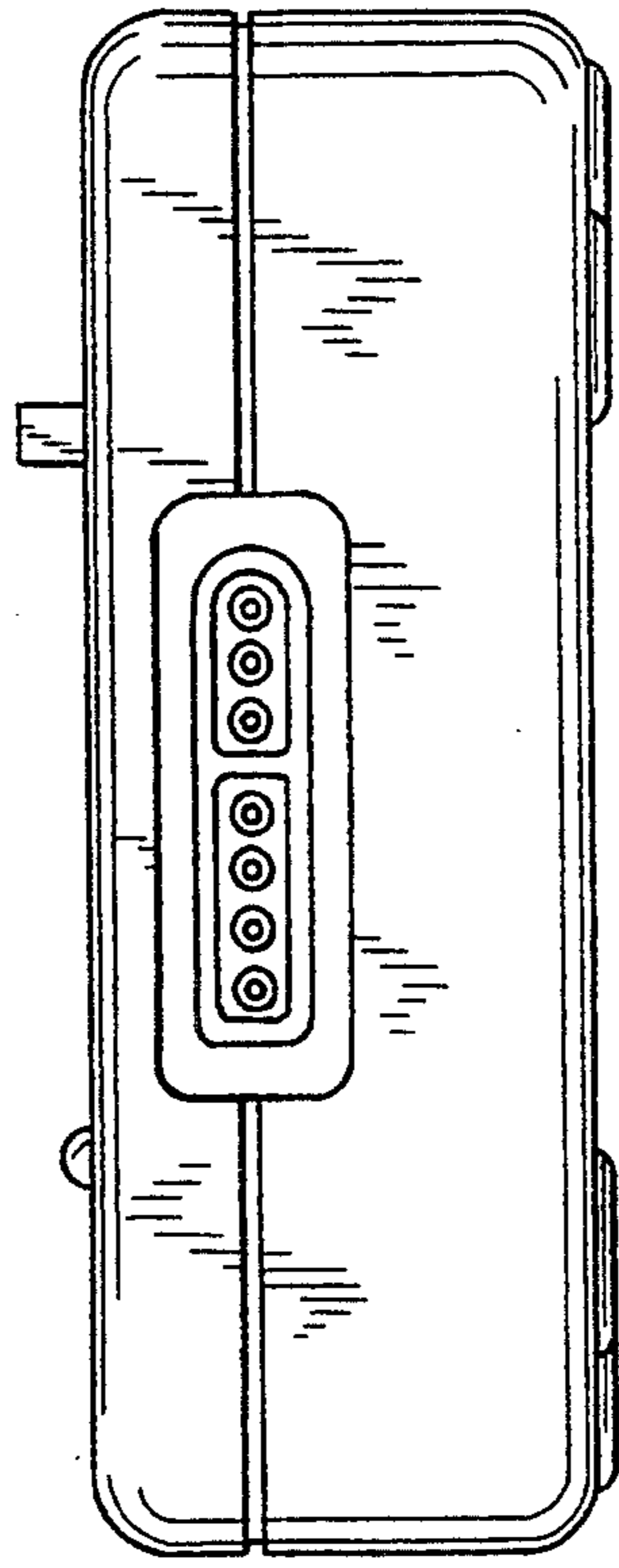

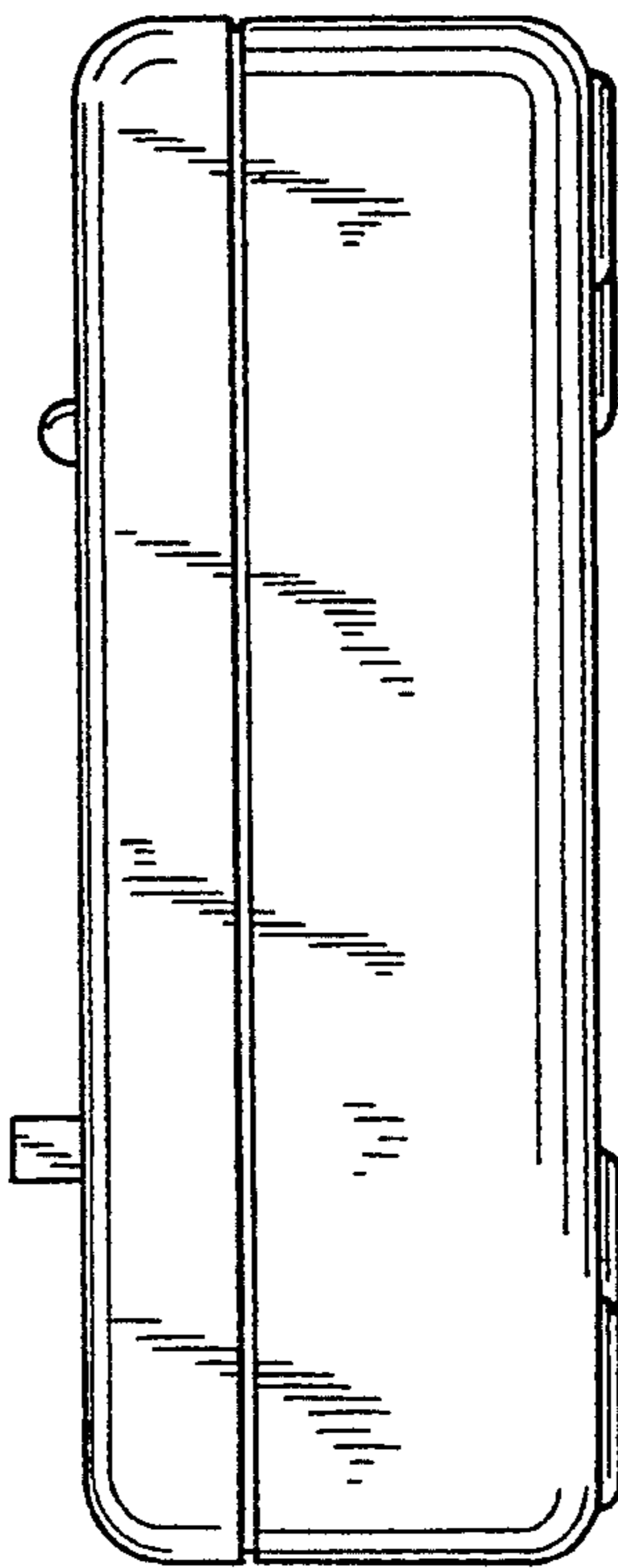

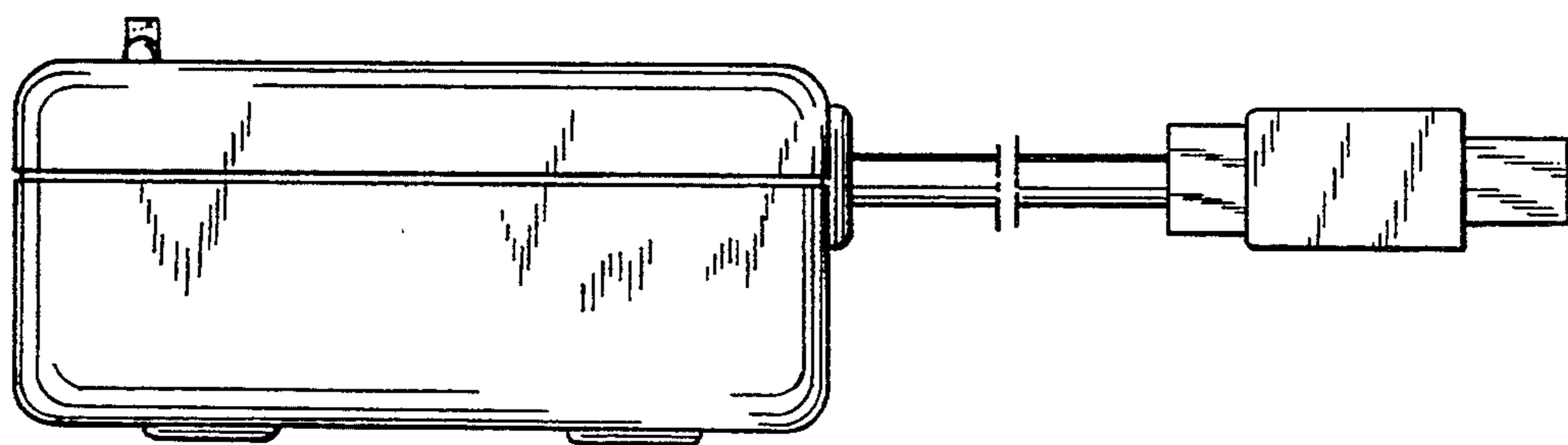

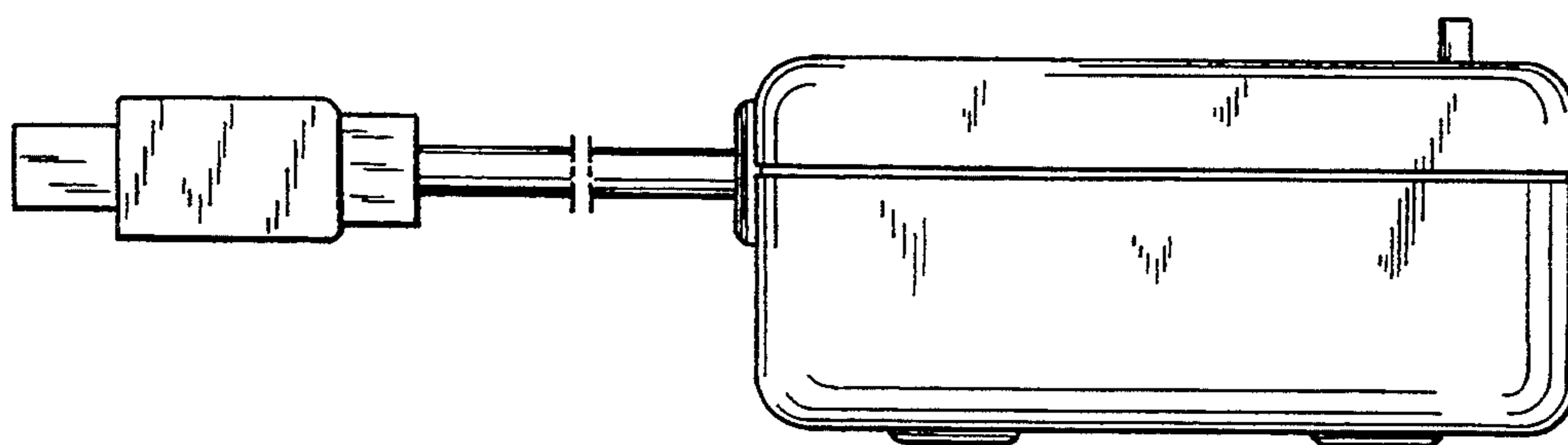

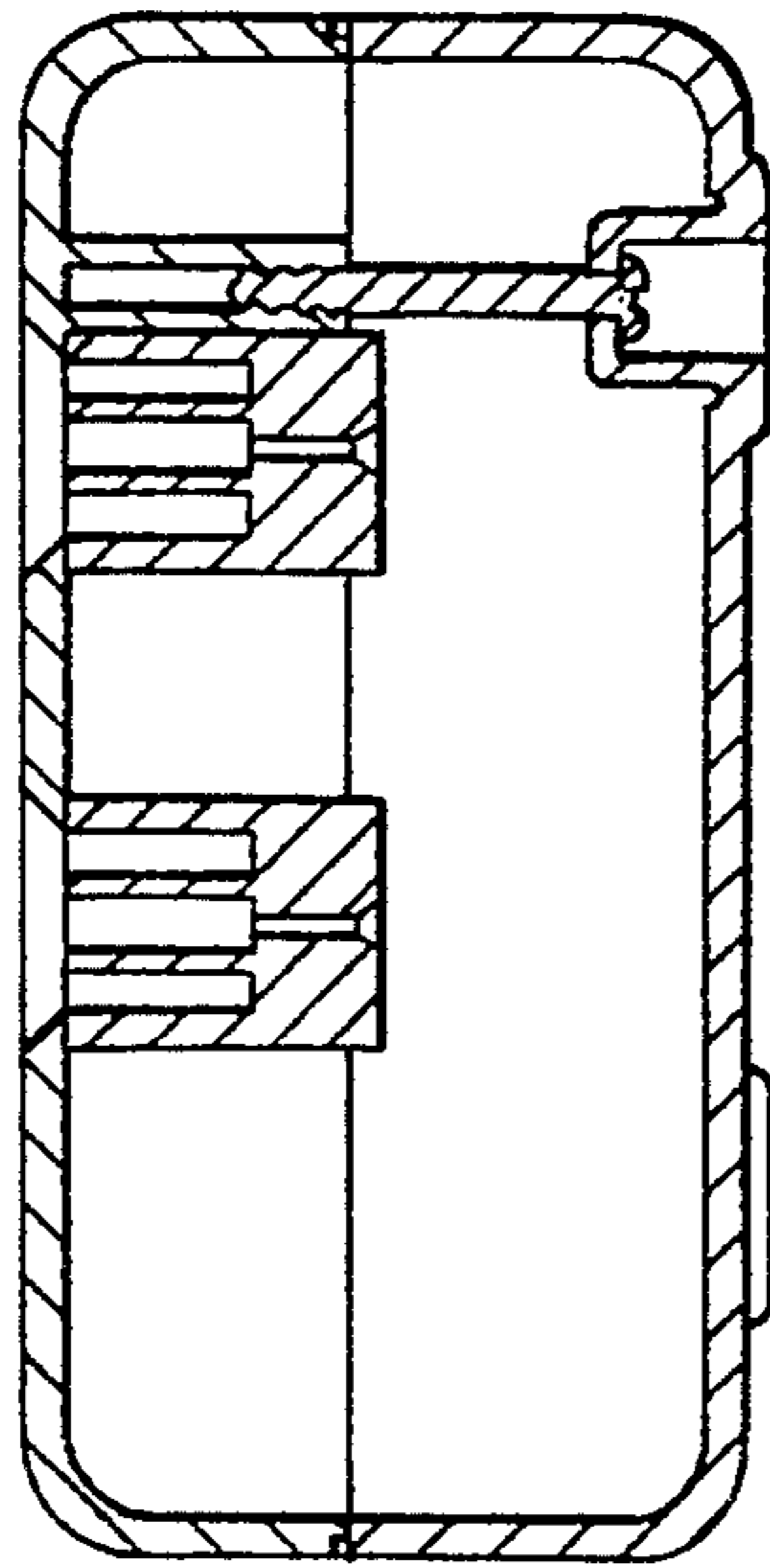

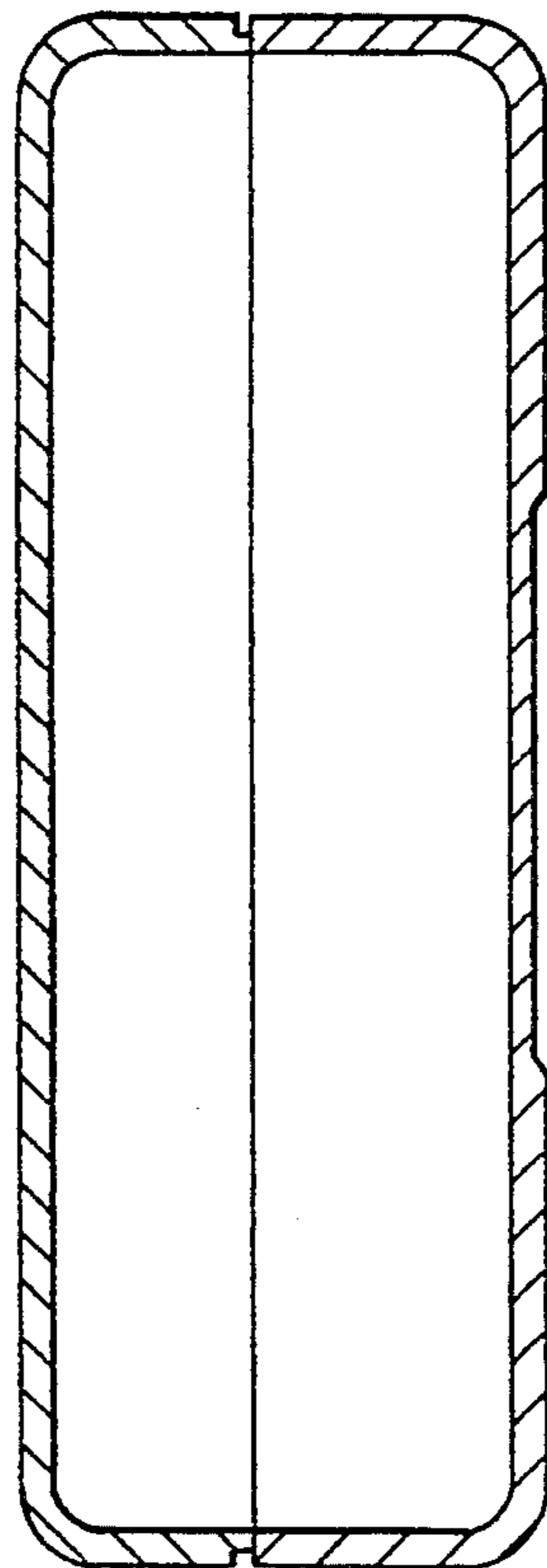

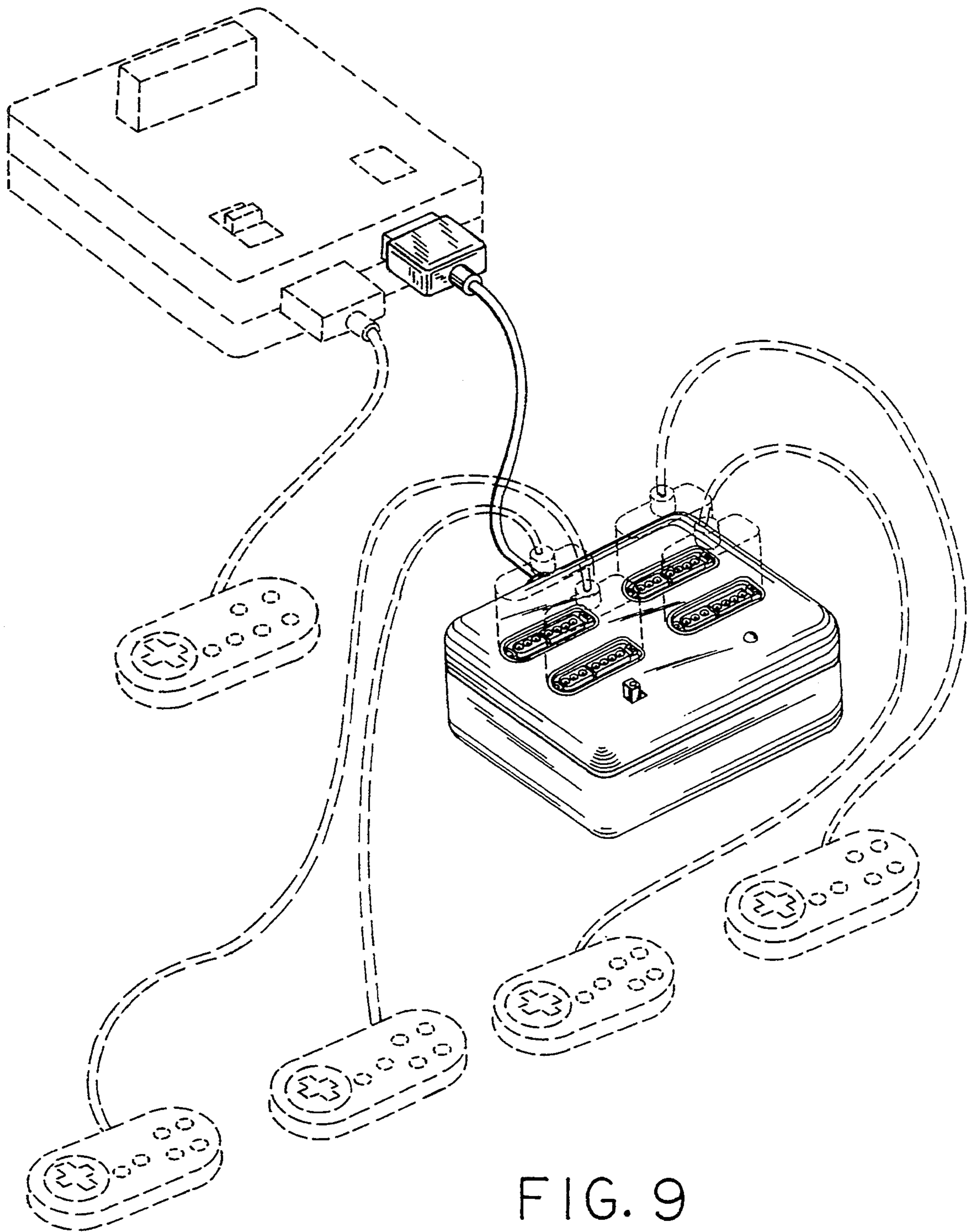
