FIG. 6 is a rear elevational view of the embodiment of FIG. 1;


FIG. 7 is a top, front and right side perspective view of a second embodiment of a postal scale showing my new design;


FIG. 8 is a top plan view of the embodiment of FIG. 7; FIG. 9 is a front elevational view of the embodiment of FIG. 7;

FIG. 12 is a rear elevational view of the embodiment of FIG. 7.




















