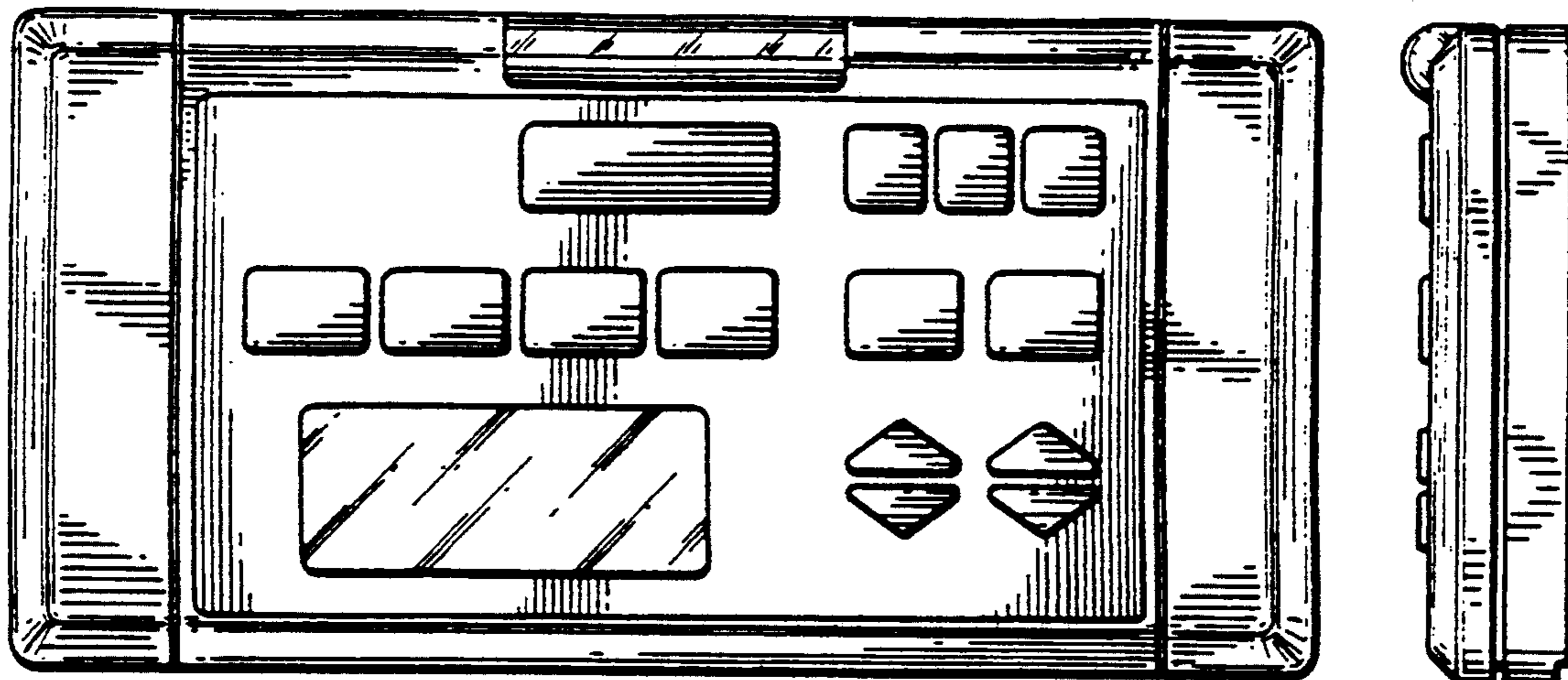

[57] **CLAIM**

The ornamental design for the remote controller for a toilet, as shown and described.

DESCRIPTION

FIG. 1 is a rear elevational view of a remote controller for a toilet showing our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side elevational view thereof, the left side elevational view thereof being a mirror image thereof;
 FIG. 6 is an enlarged front elevational view thereof;
 FIG. 7 is another enlarged front elevational view thereof;
 FIG. 8 is a third enlarged elevational view thereof, showing the right side panel in an open position;
 FIG. 9 is a top plan view of FIG. 8; and,
 FIG. 10 is a bottom plan view of FIG. 8.
 The broken line representation of indicia in FIGS. 7 and 8 is for purposes of illustration only and forms no part of the claimed design.



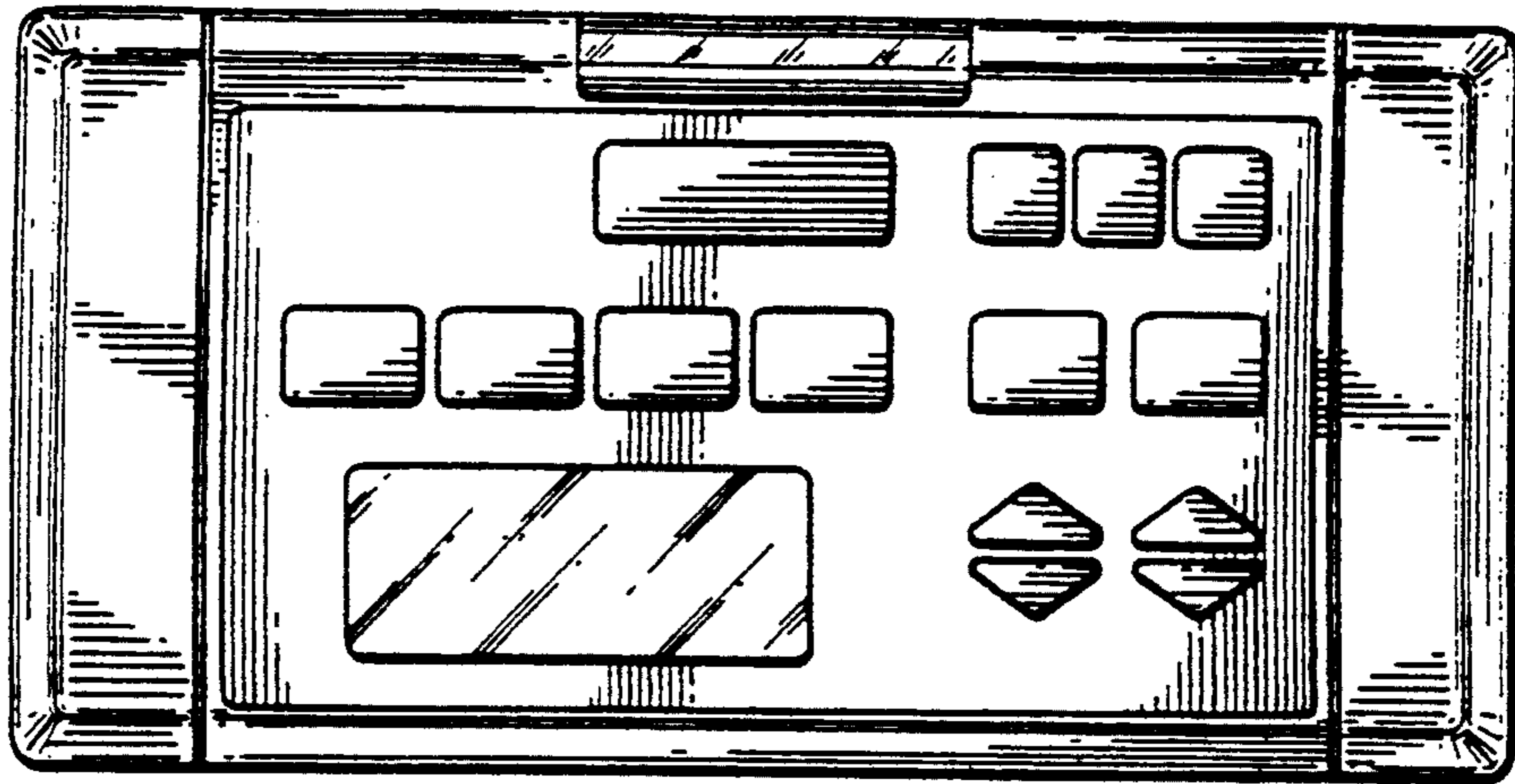

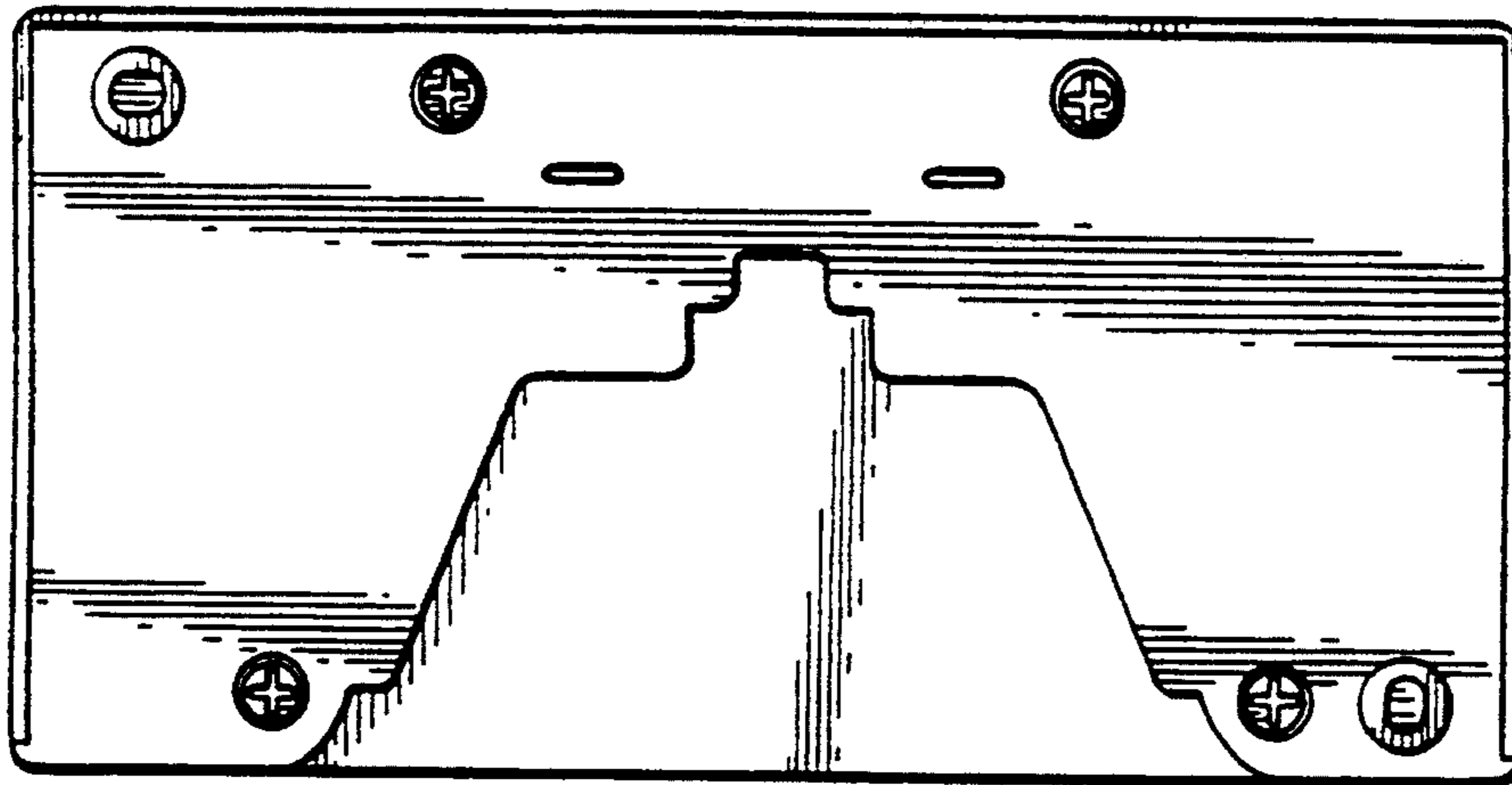

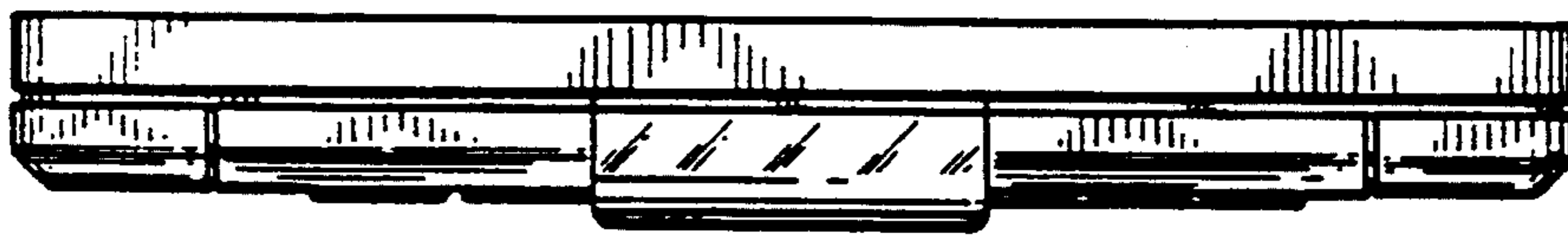

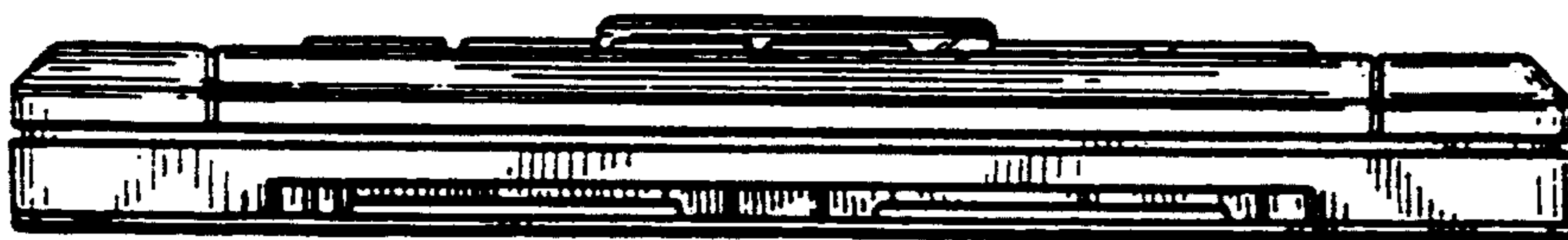

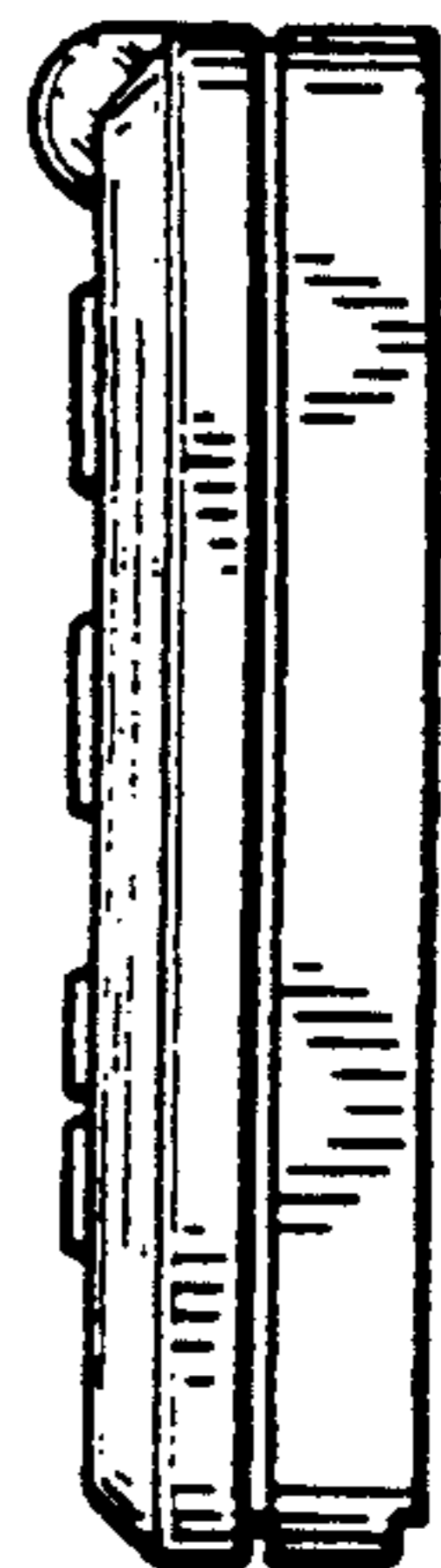

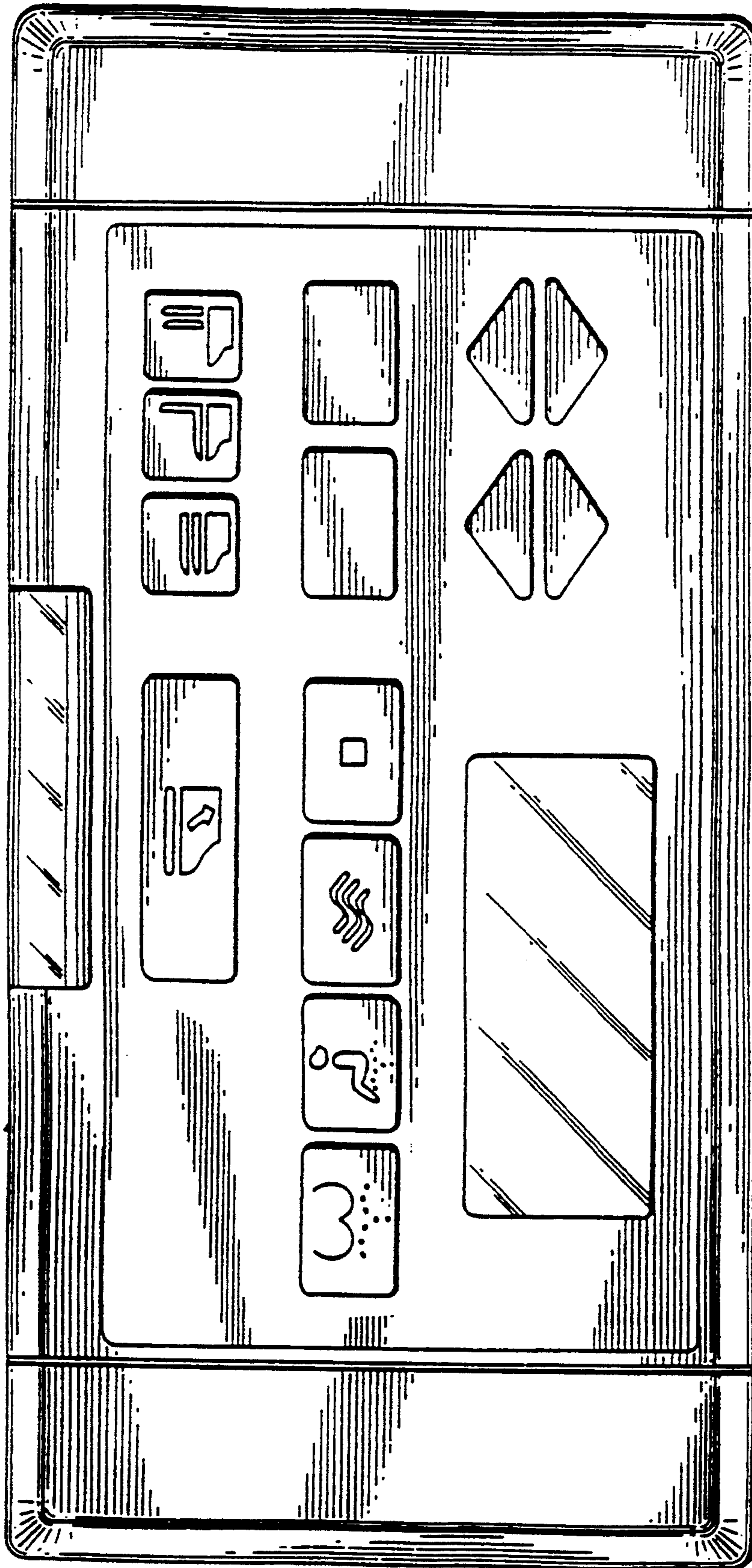

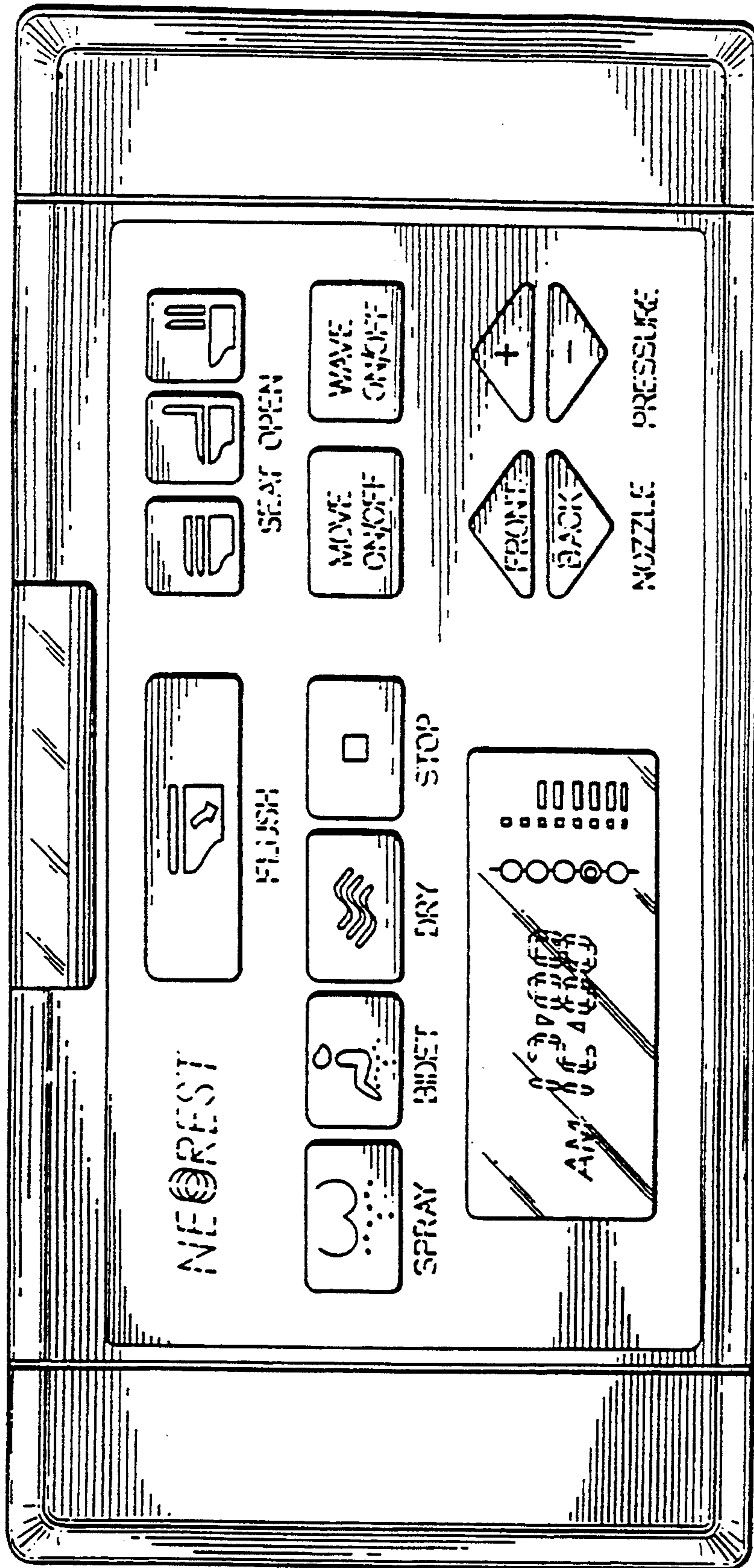

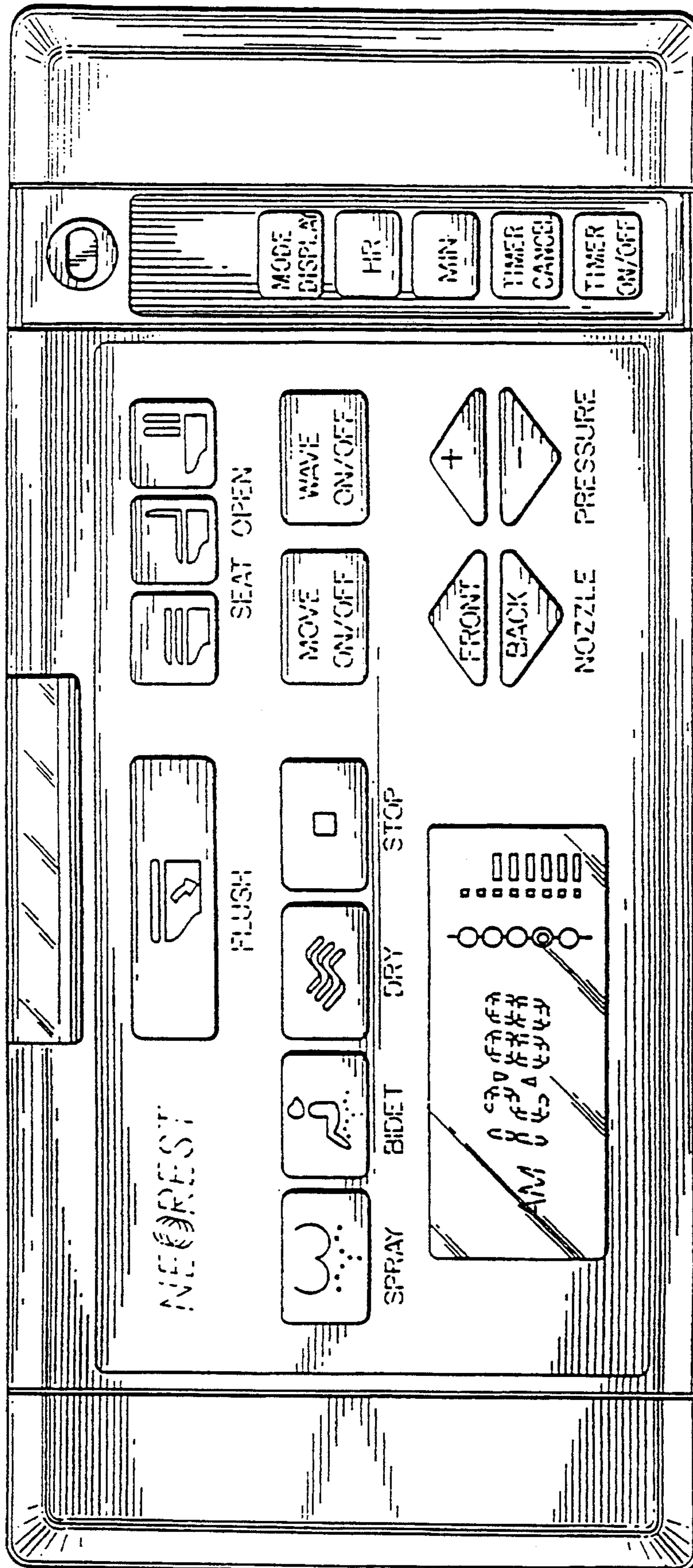

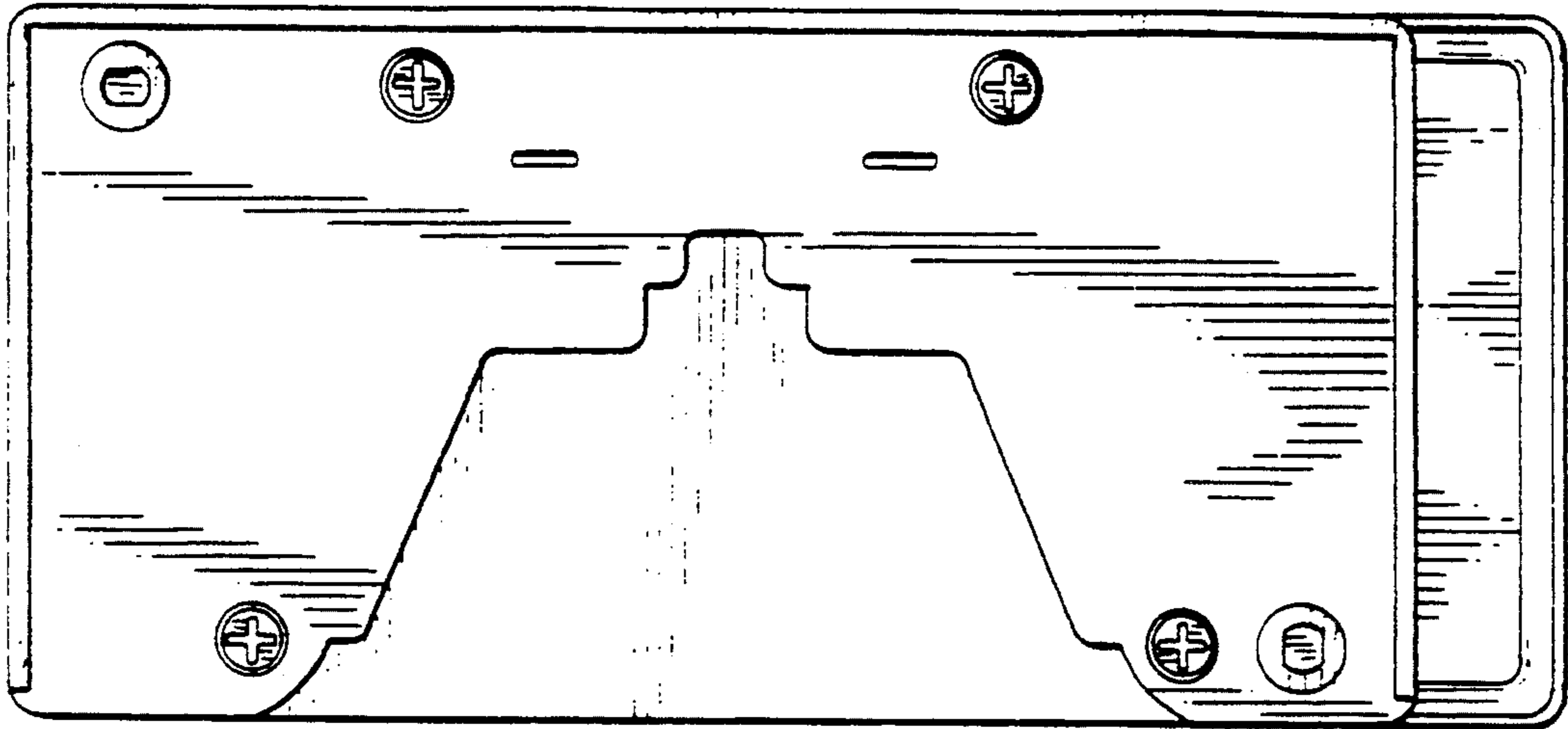

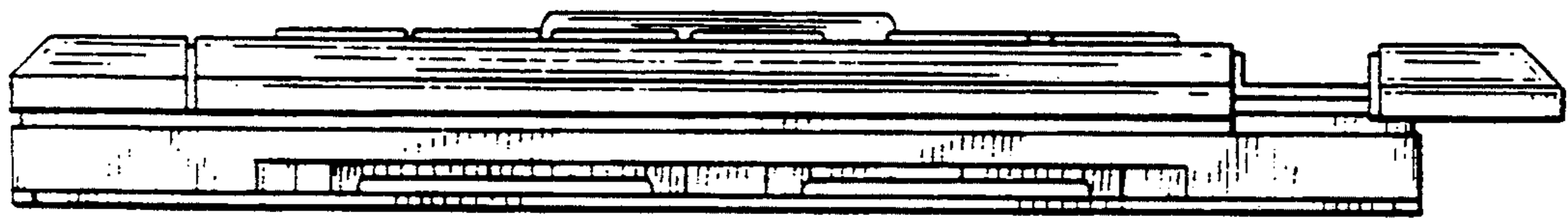
