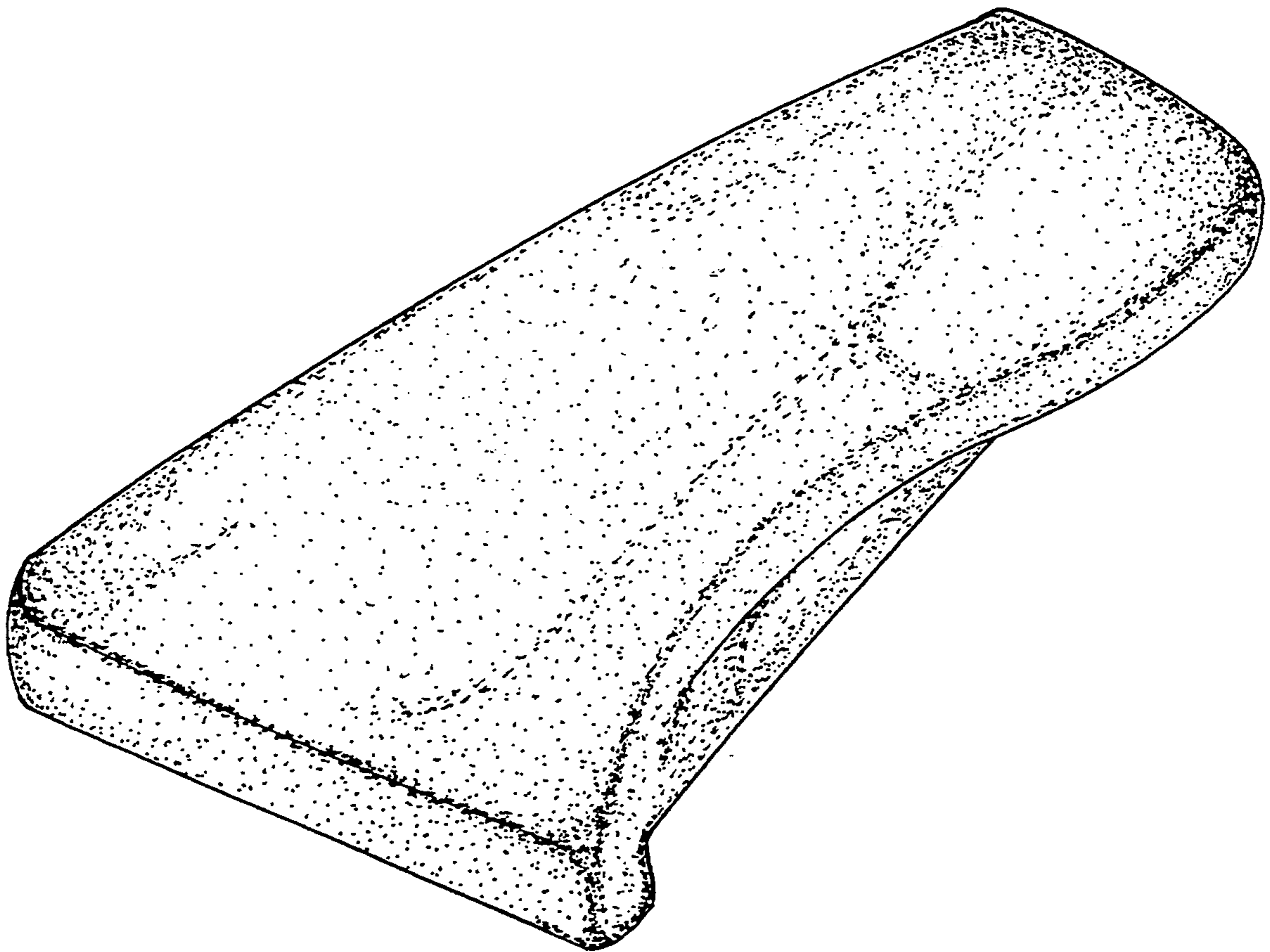

The ornamental design for microscope armrest, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of microscope armrest showing our new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a right side view thereof;  
 FIG. 6 is a left side view thereof;  
 FIG. 7 is an enlarged perspective view taken from the top, front and right side thereof; and,  
 FIG. 8 is a perspective view taken from the bottom, rear and left side thereof.



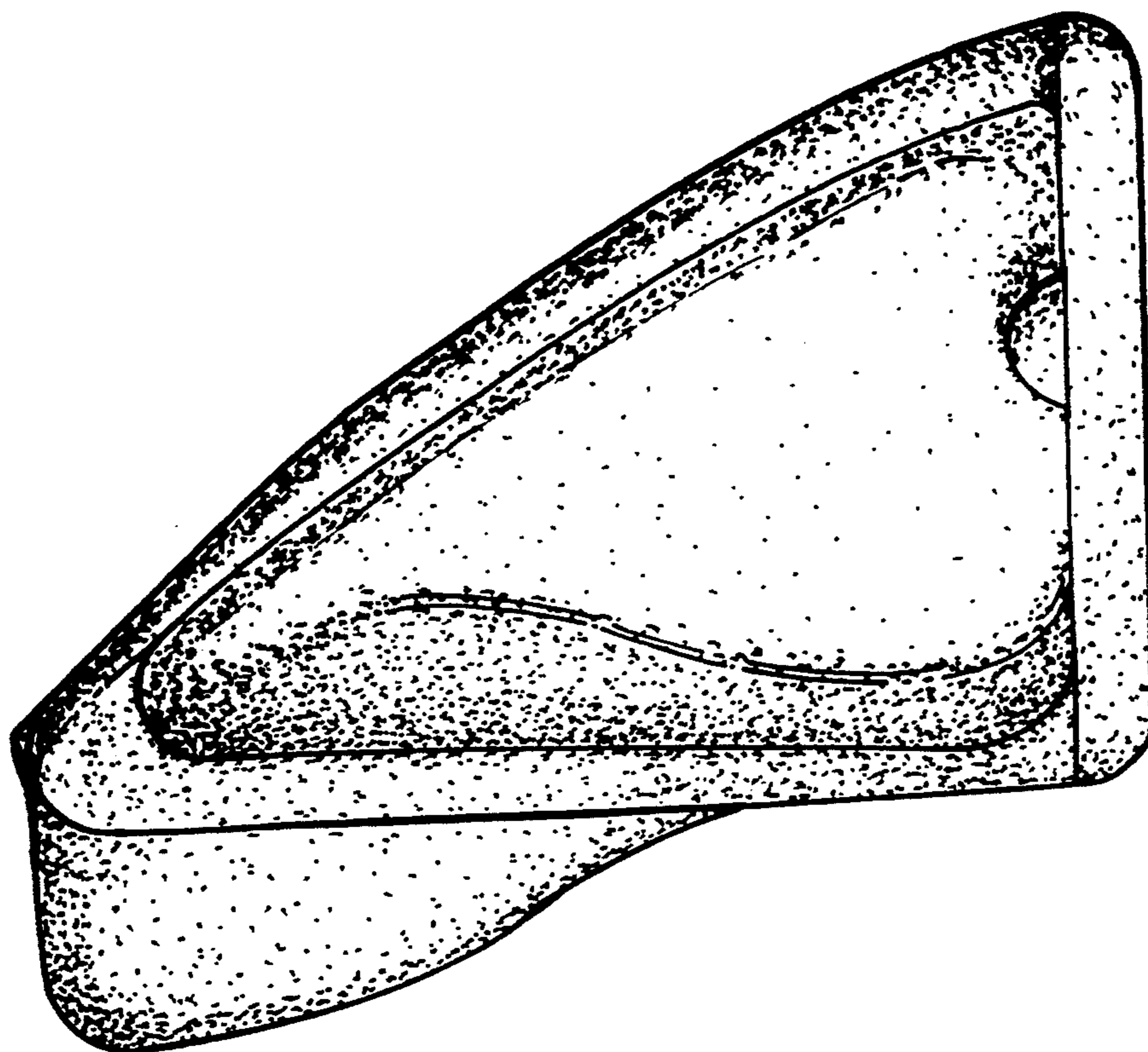

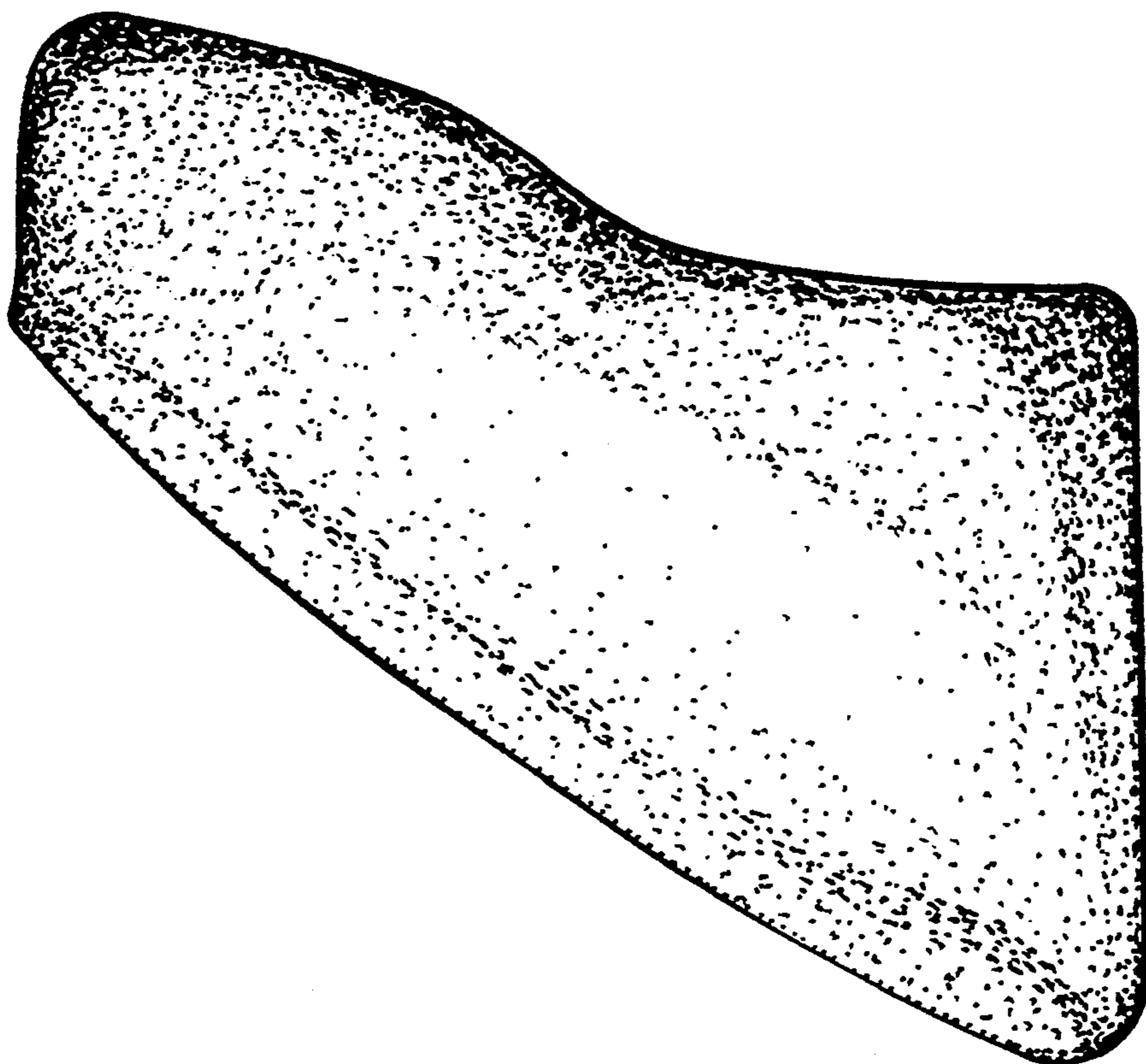

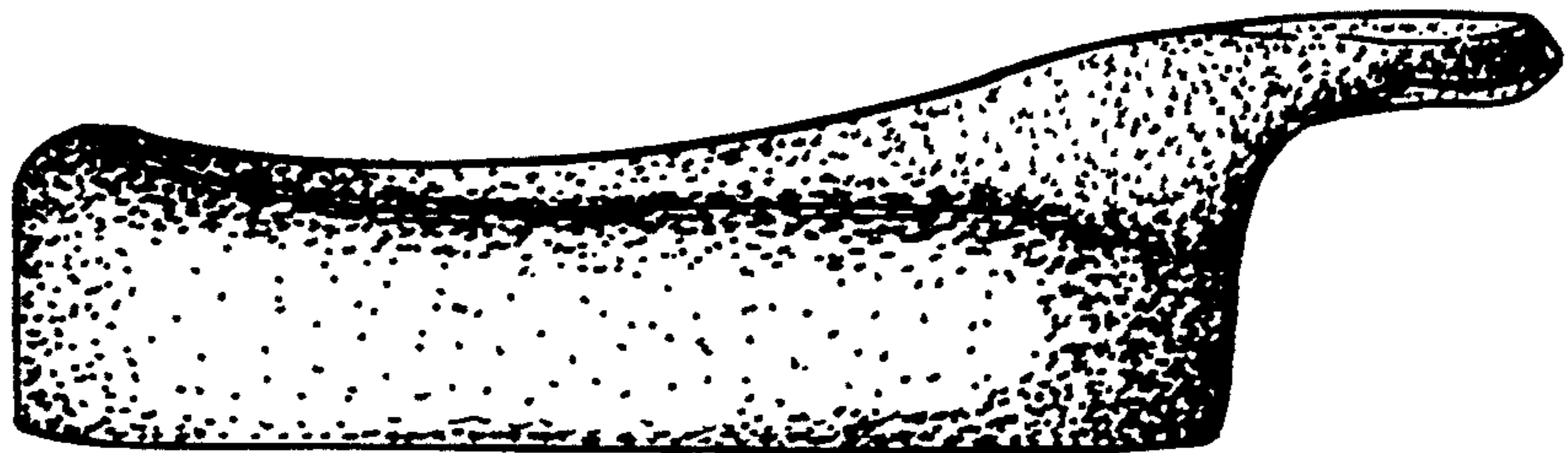

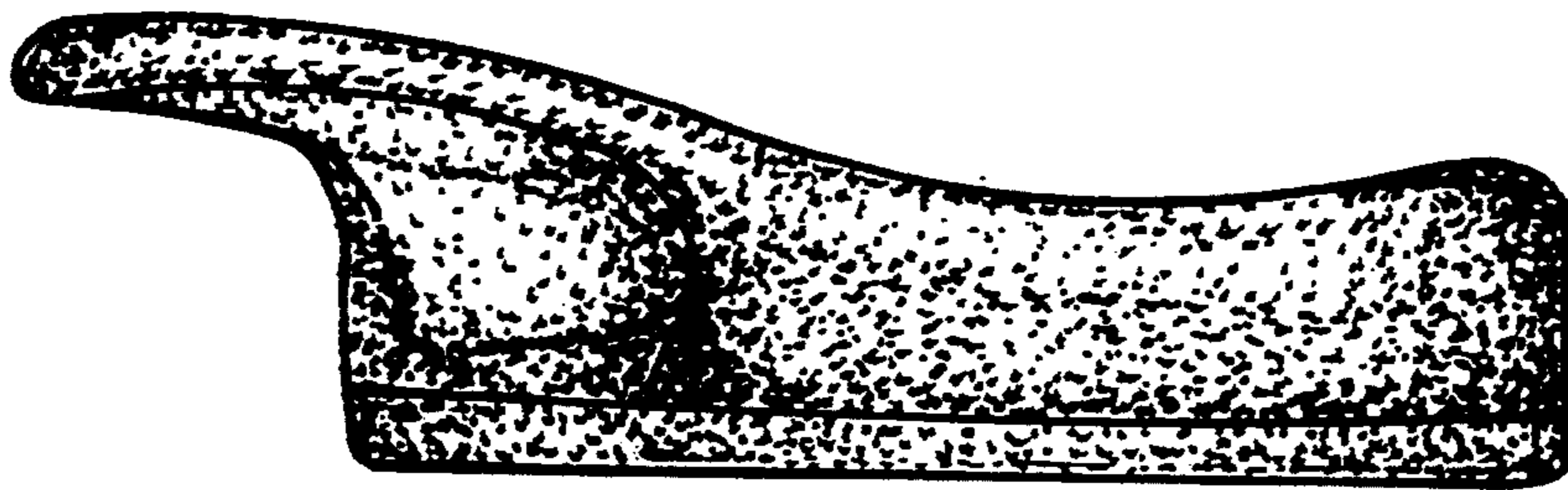

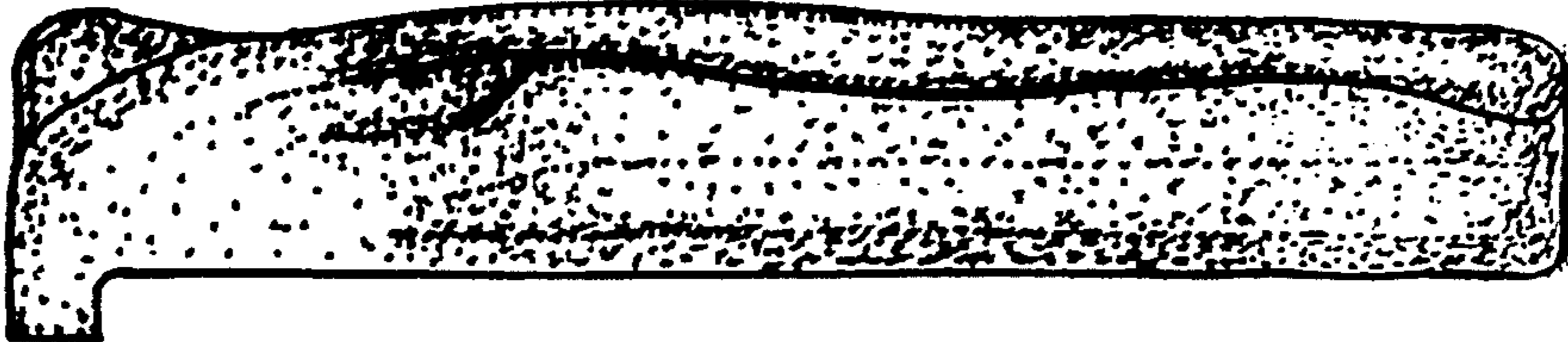

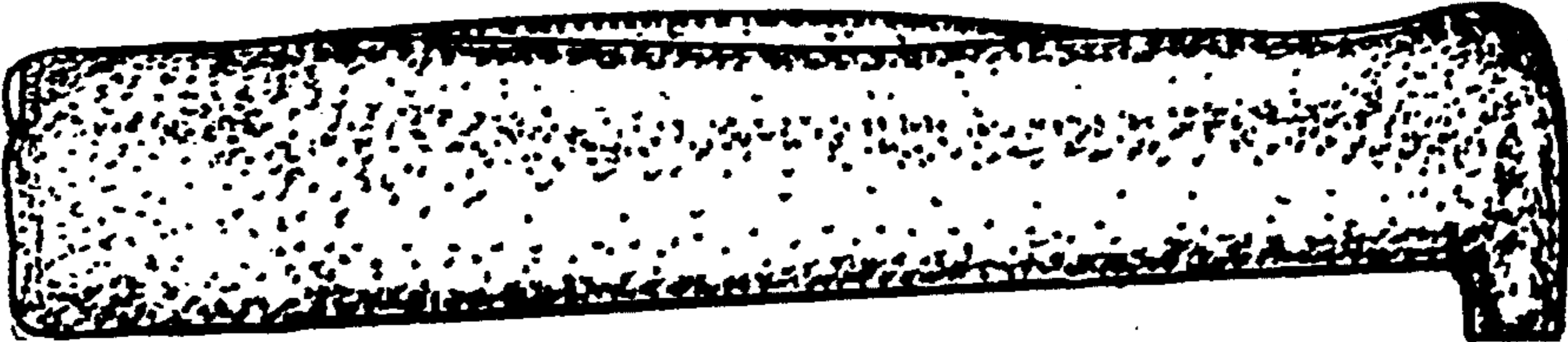

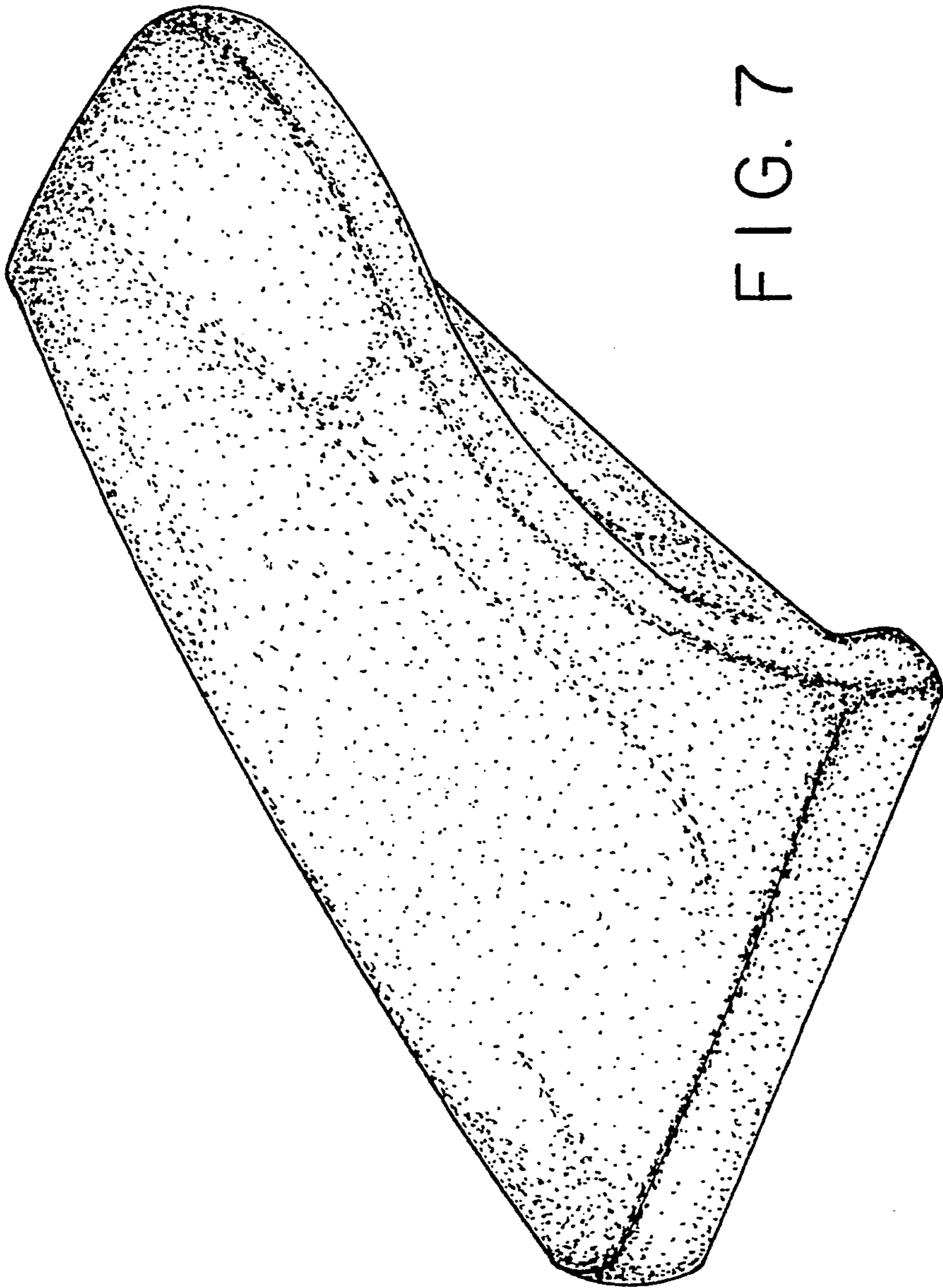

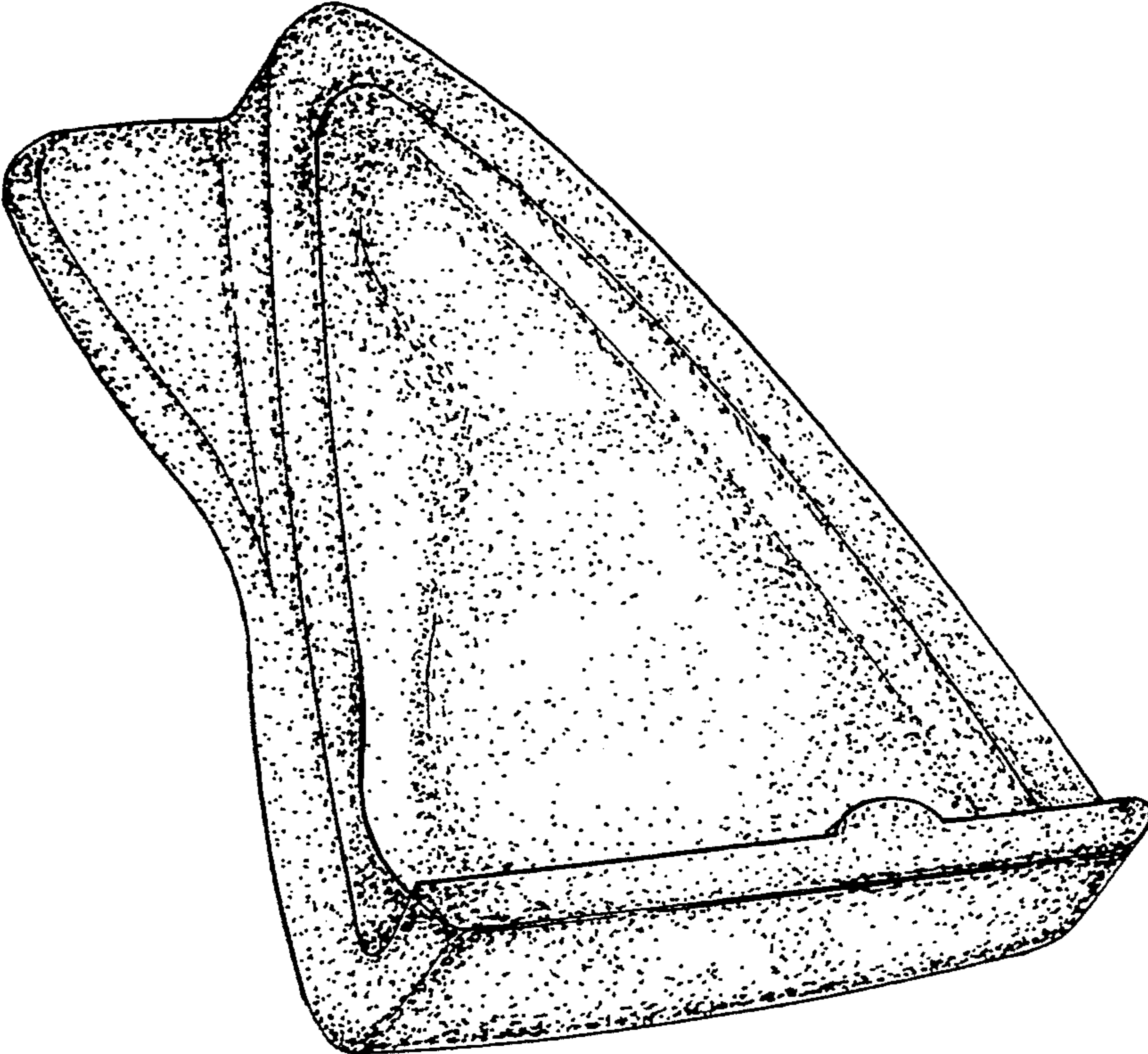
