[57] CLAIM

An ornamental design for a baby bottle package, as shown and described.

DESCRIPTION

FIG. 1 is perspective view of a baby bottle package showing my new design;
FIG. 2 is a right side elevational view thereof; the left side elevational view being a mirror image thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken line showing of bottle is for illustrative purpose only and forms no part of the claim.

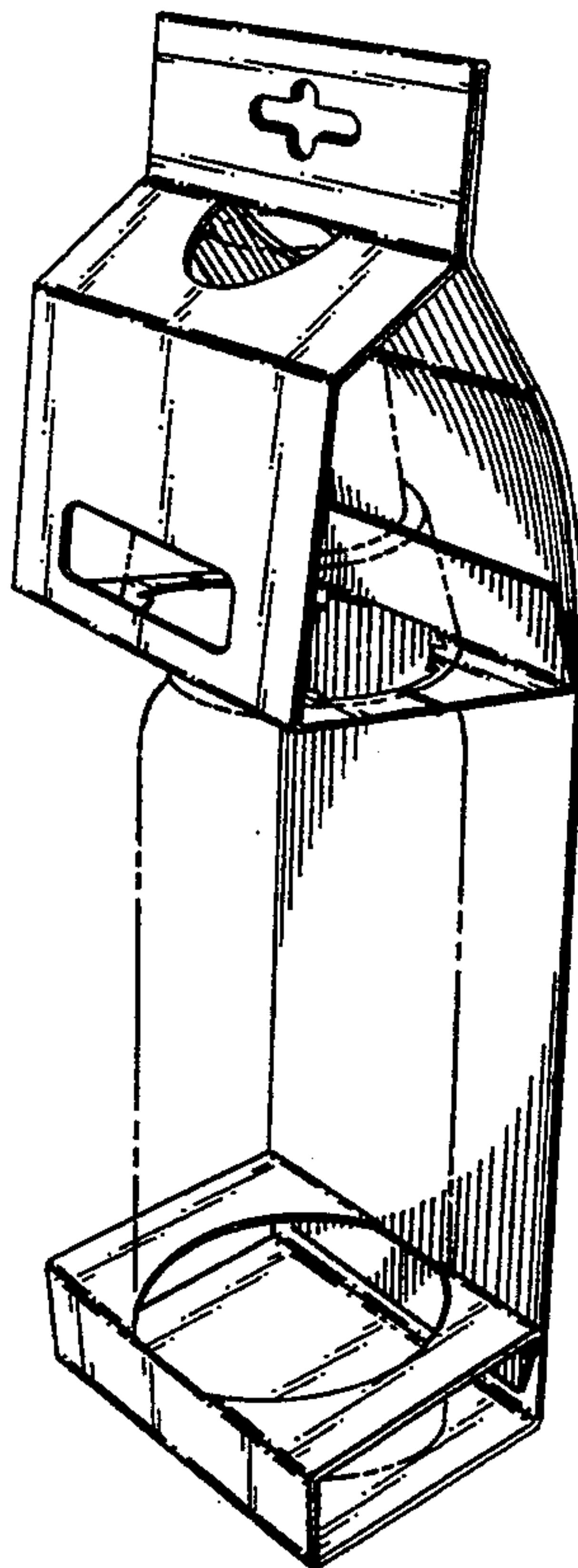

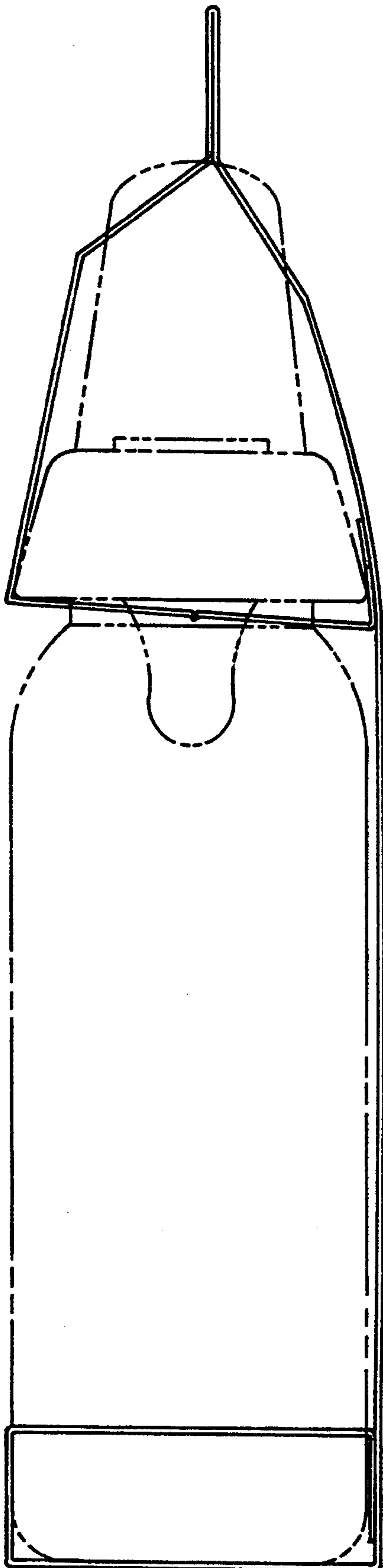

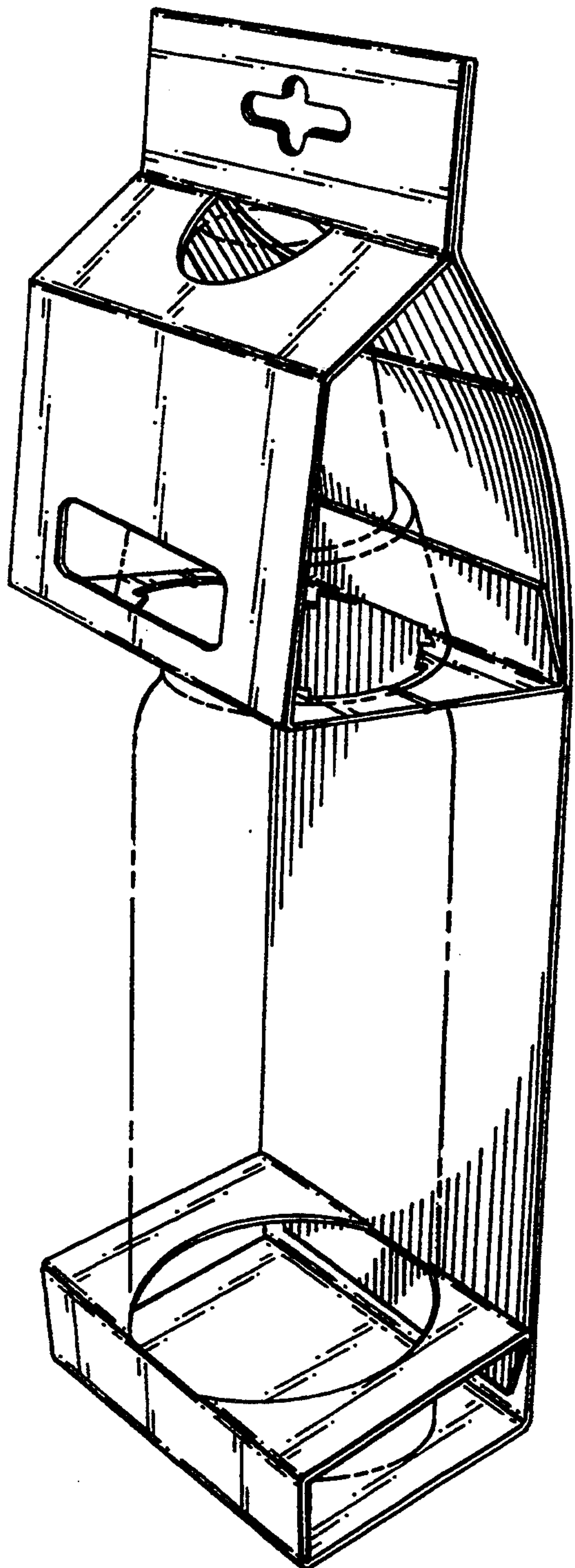

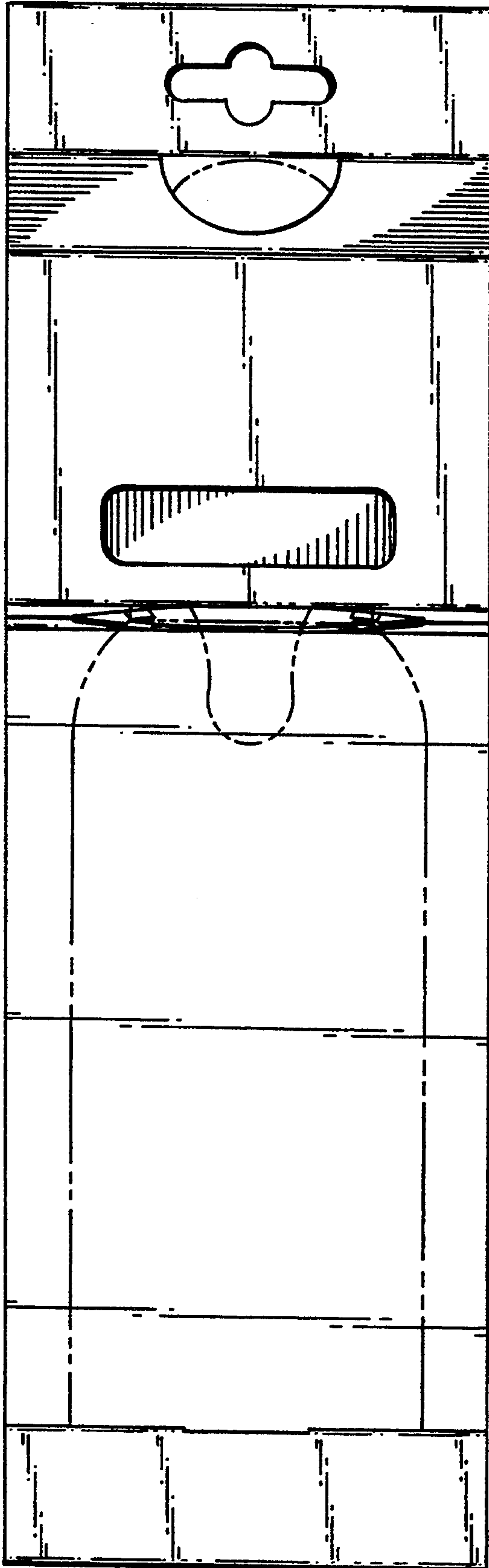

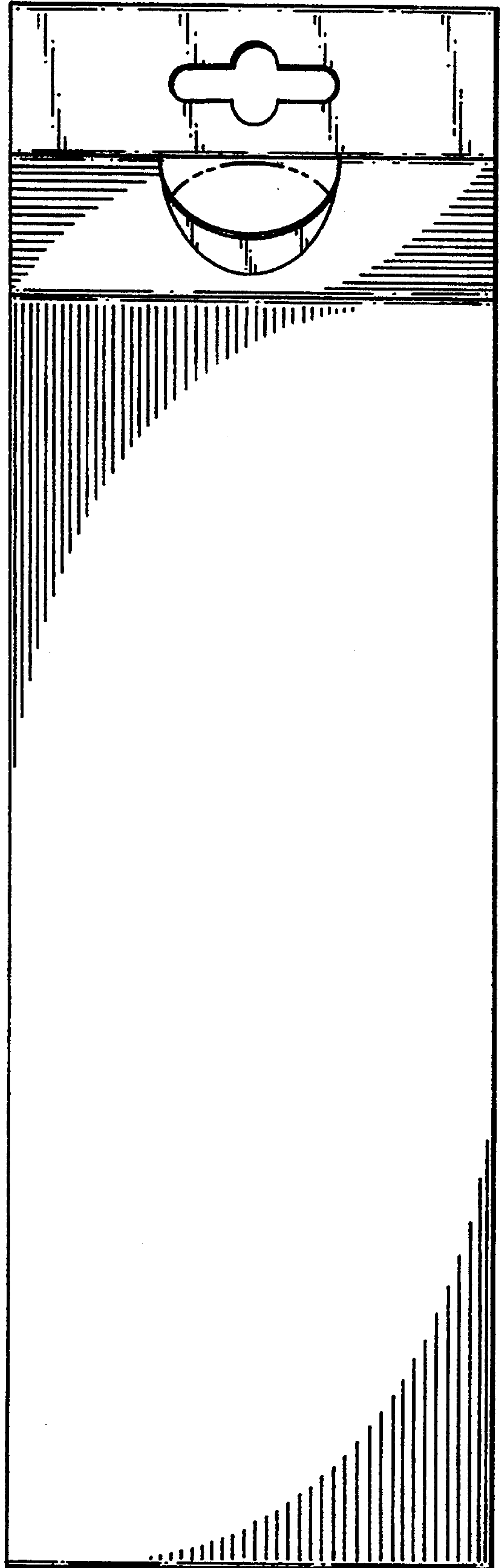

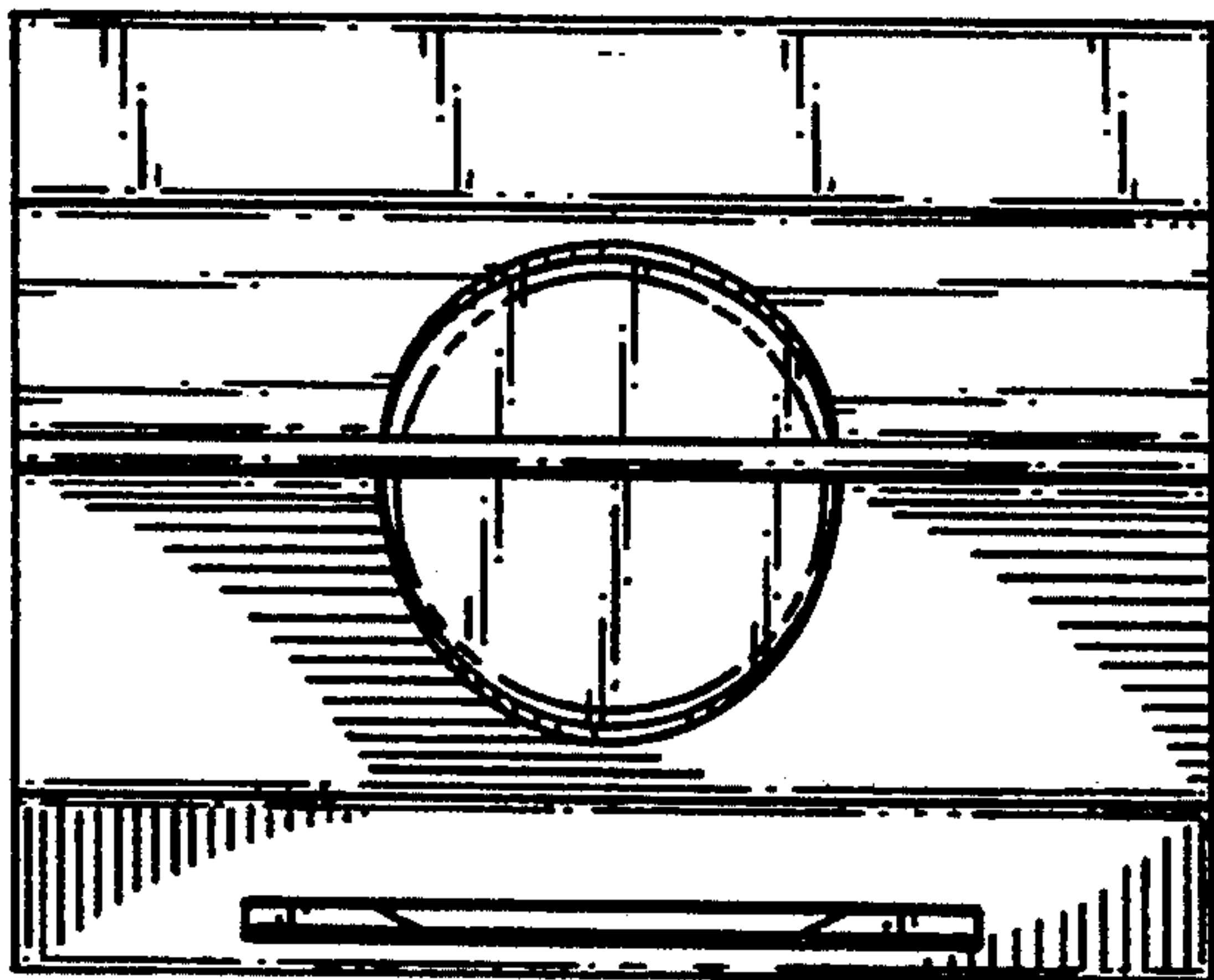
