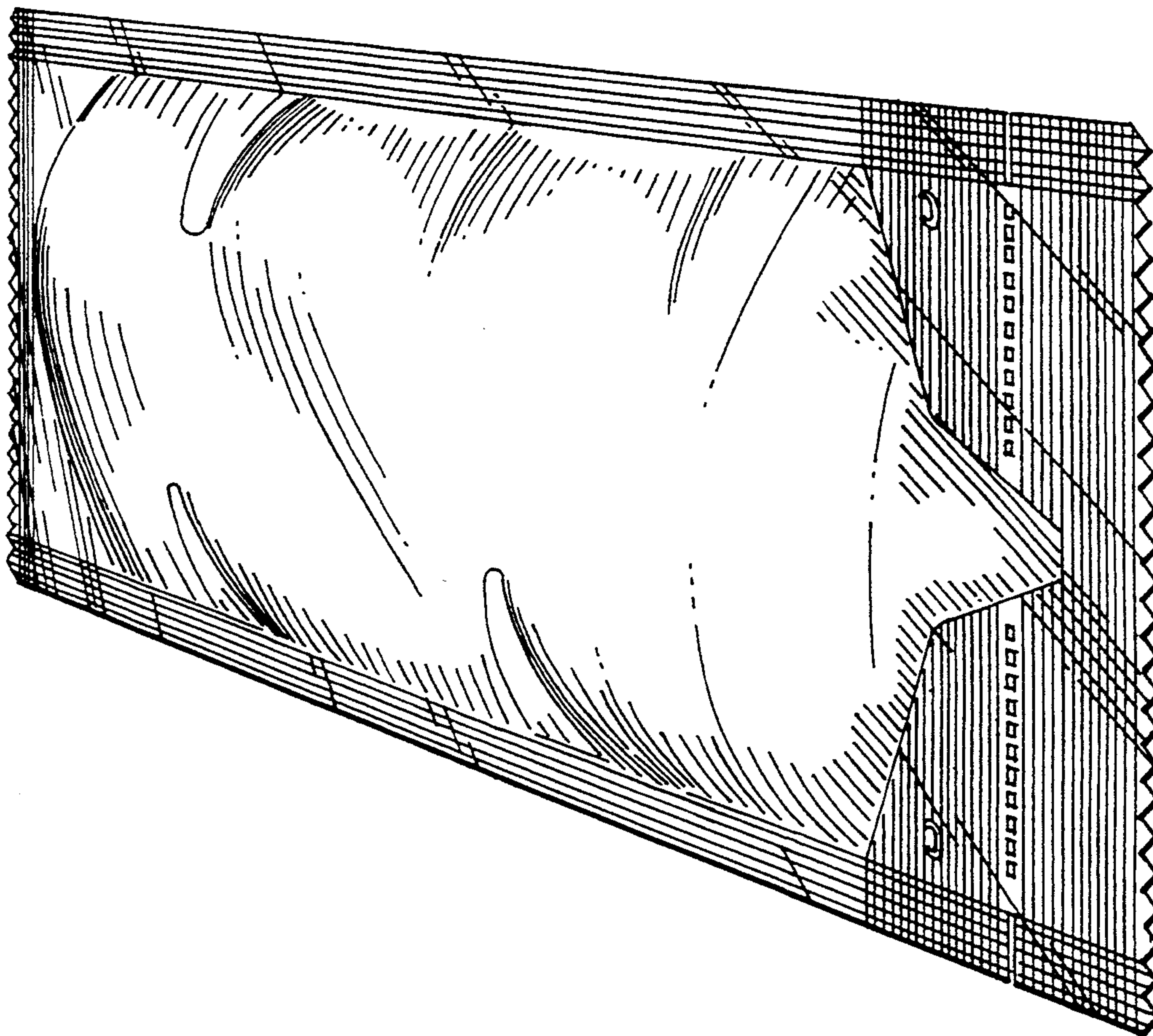

### [57] CLAIM

The ornamental design for a collapsible dispenser pouch, as shown and described.

### DESCRIPTION

FIG. 1 is a front and right end perspective view of a collapsible dispenser pouch showing our new design; FIG. 2 is a bottom end view thereof, the undisclosed opposite side being identical; FIG. 3 is a front elevational view thereof, the undisclosed opposite side being identical; FIG. 4 is a right end view thereof; and, FIG. 5 is a left end view thereof.



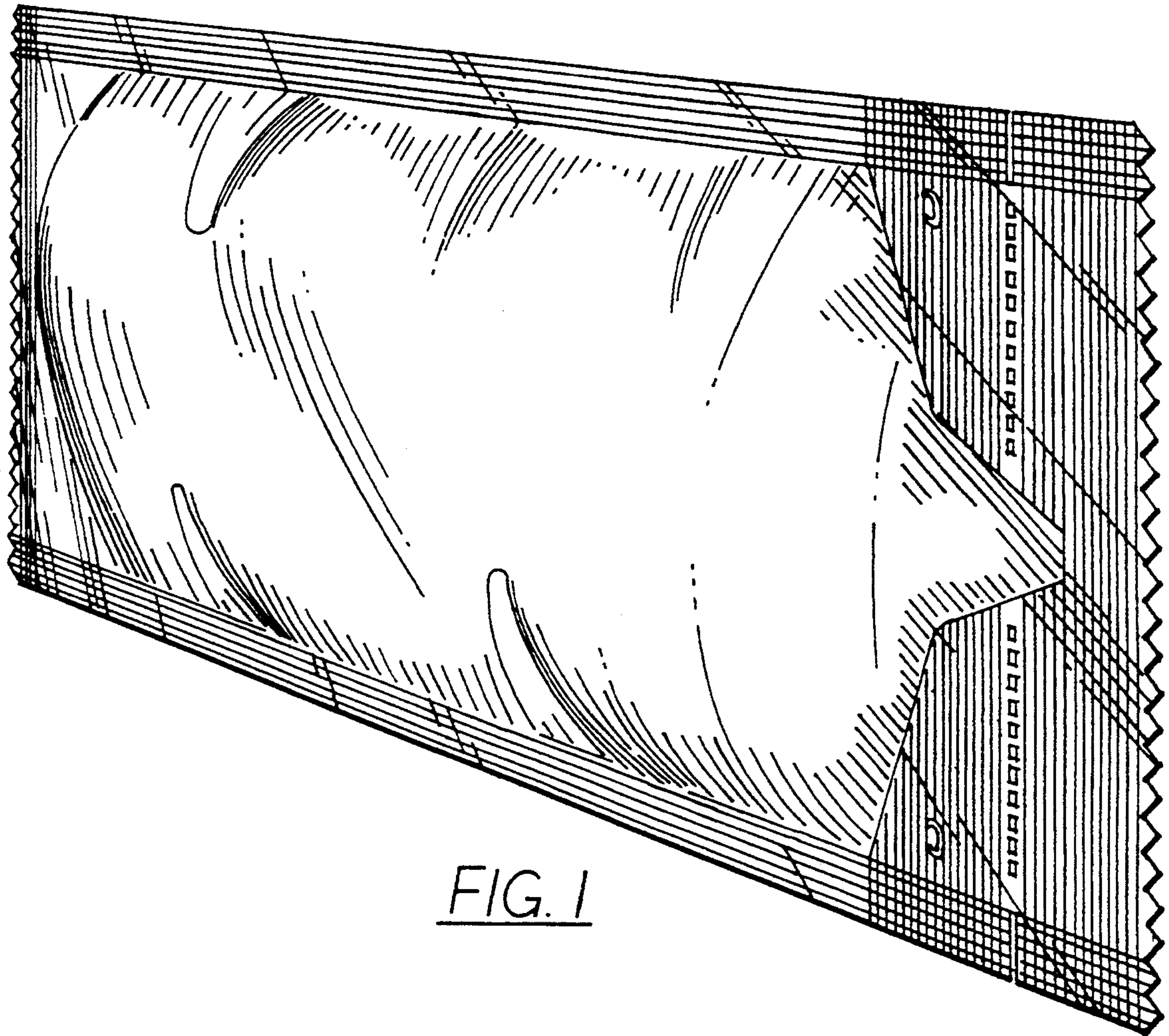

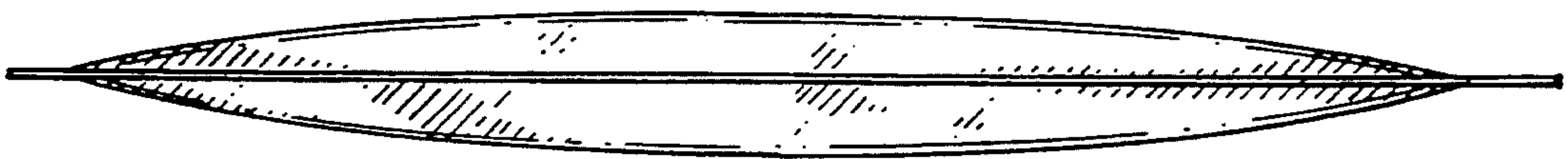

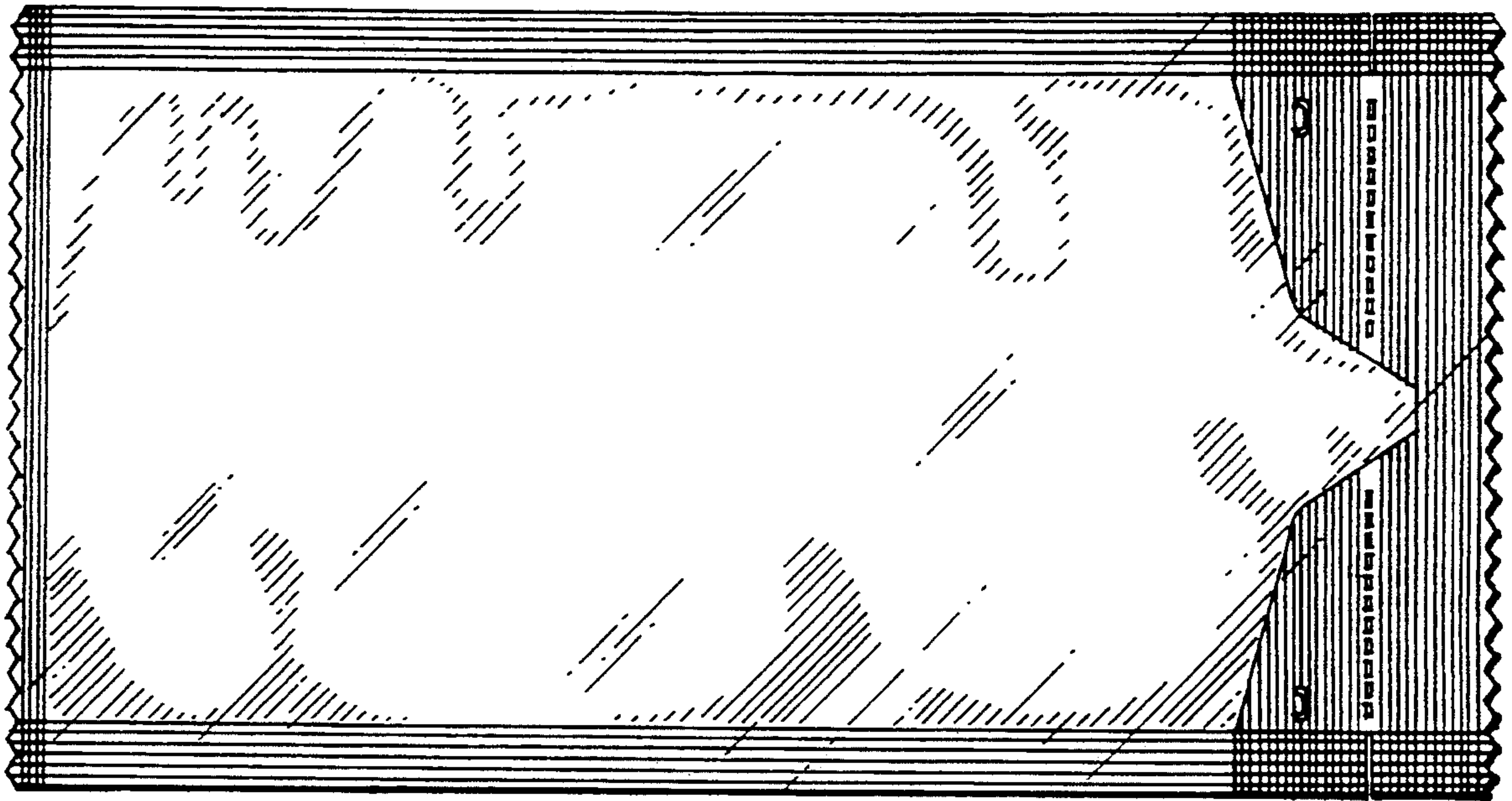

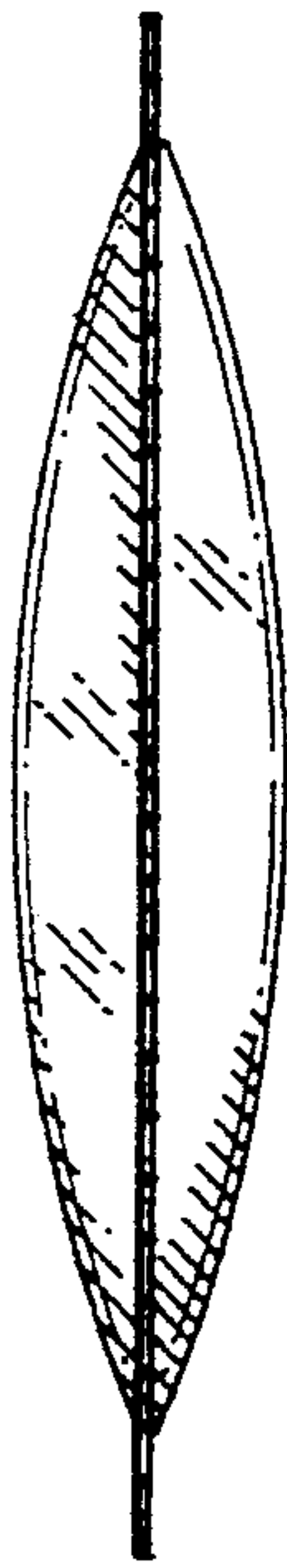
