FIG. 7 is a perspective view thereof showing the state where the handset is removed.

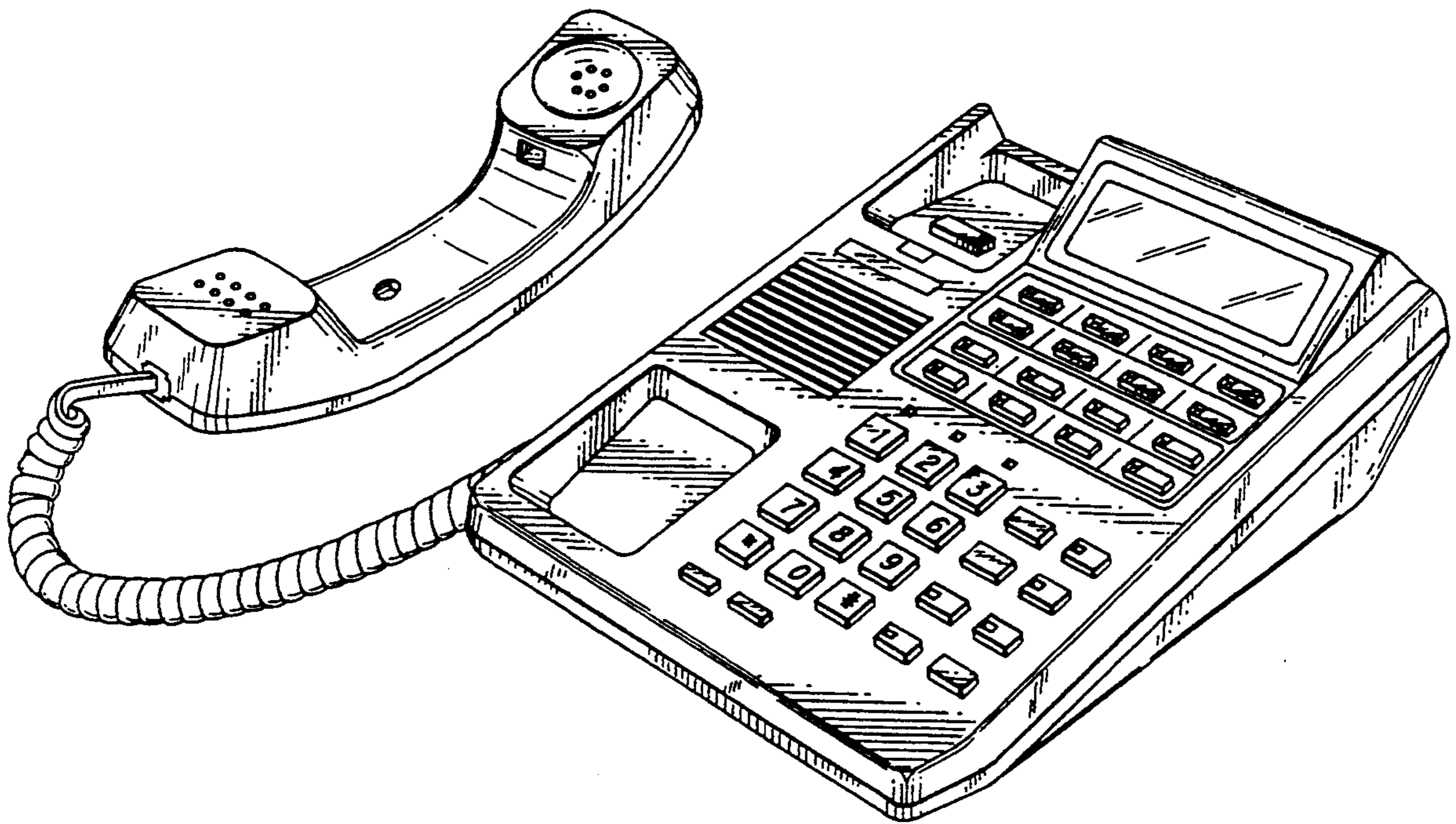

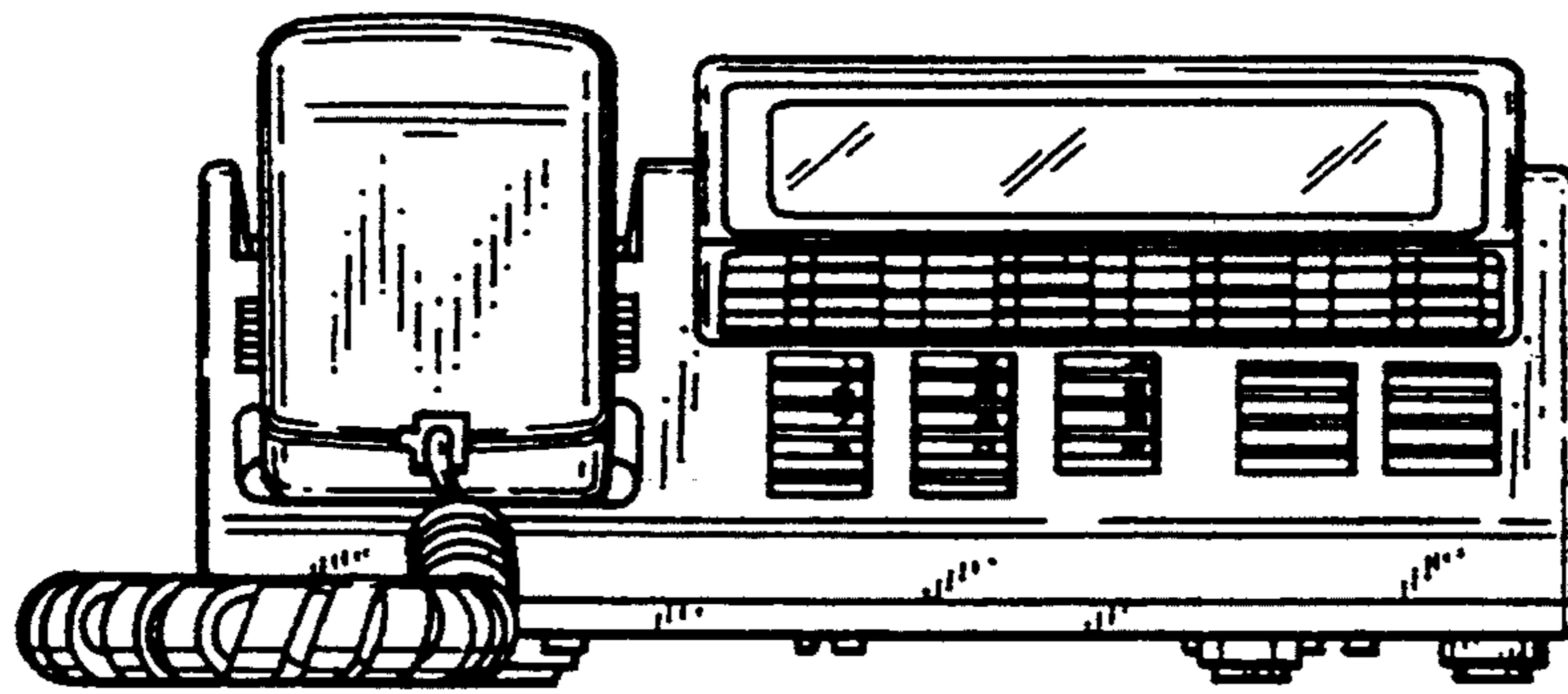

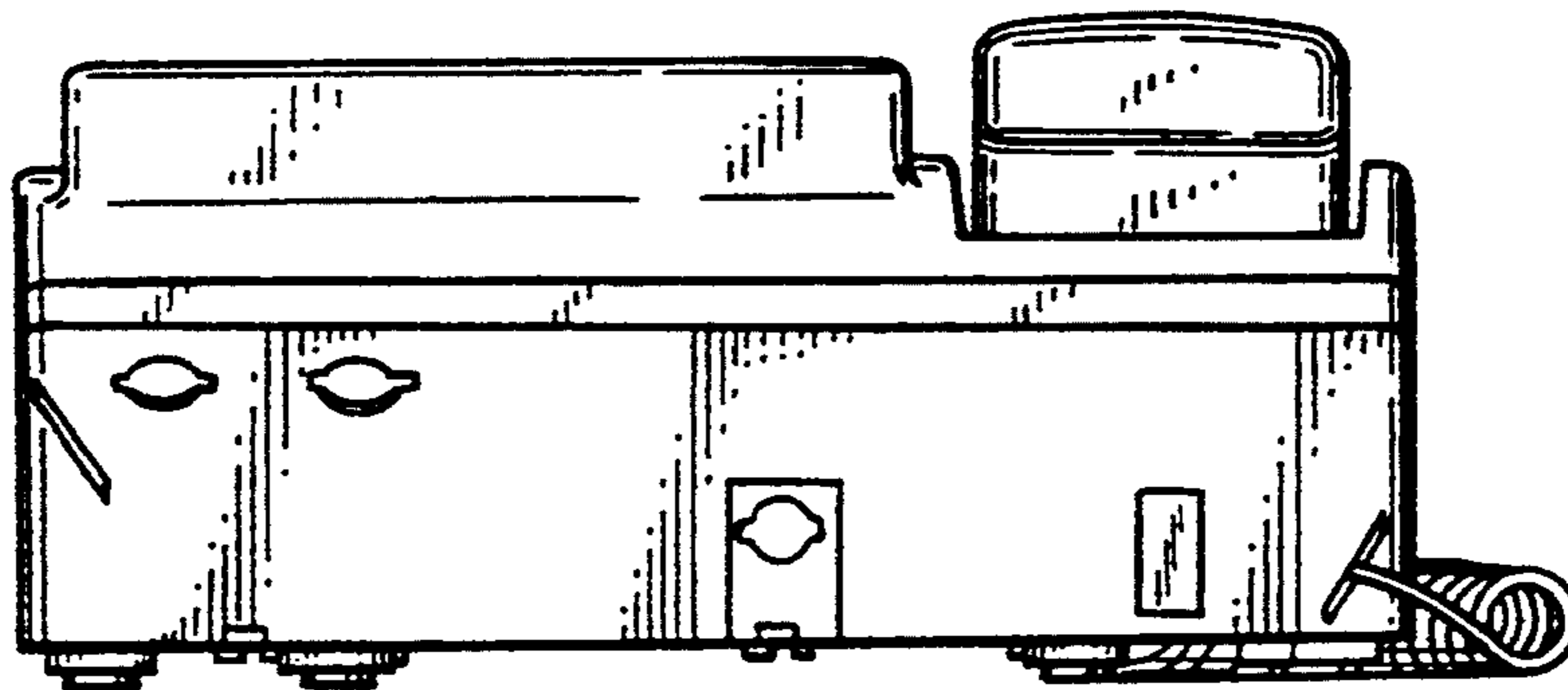

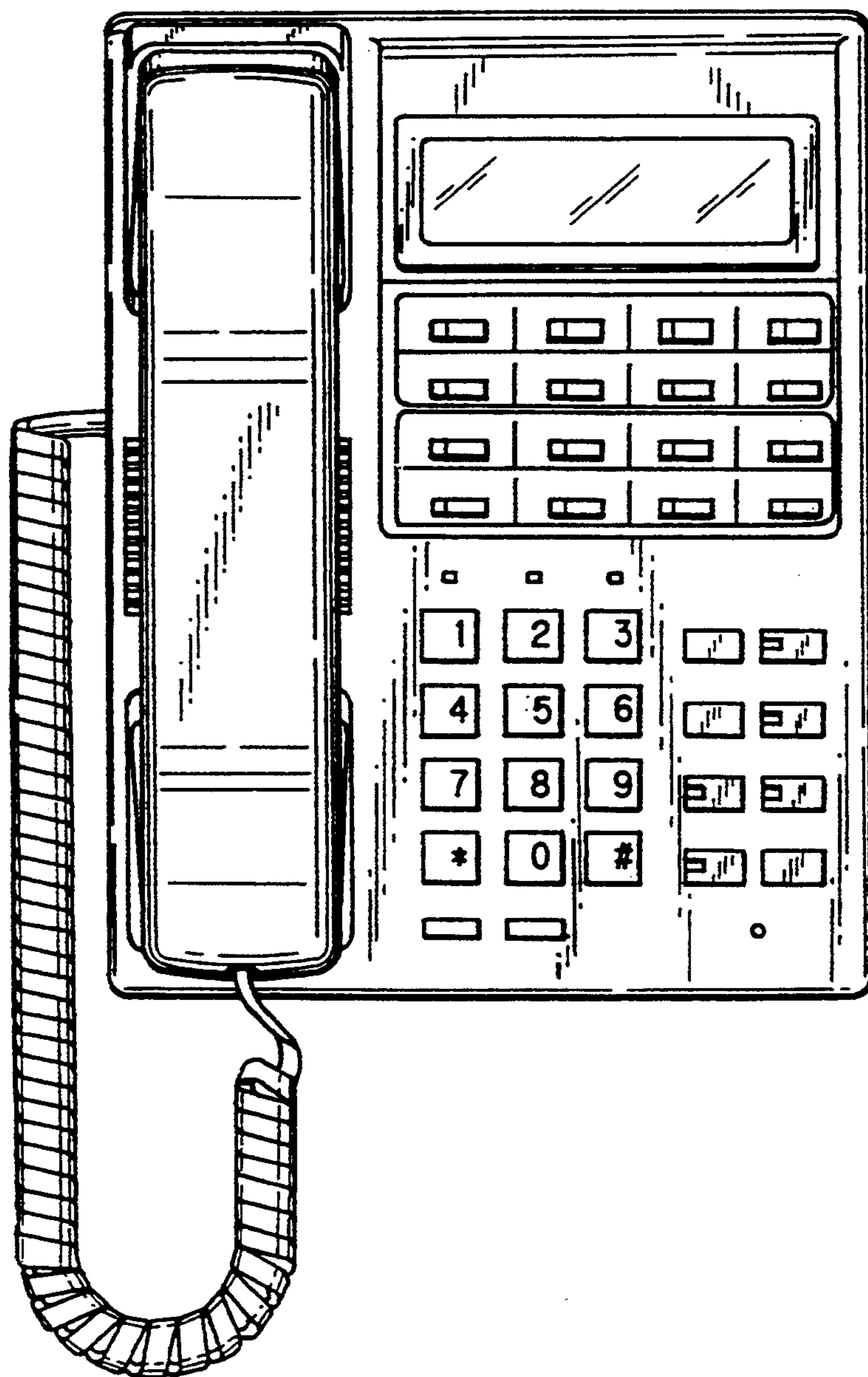

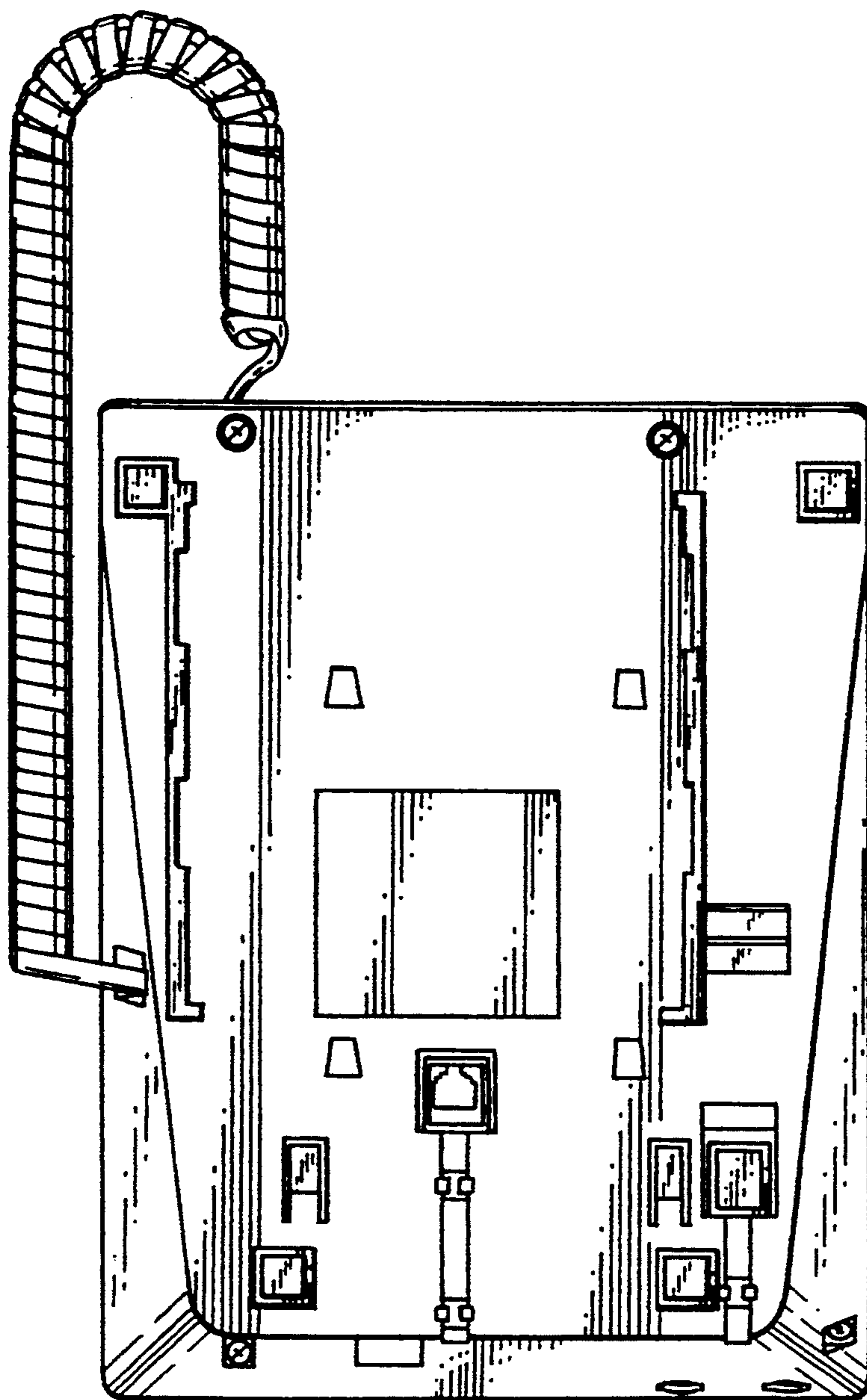

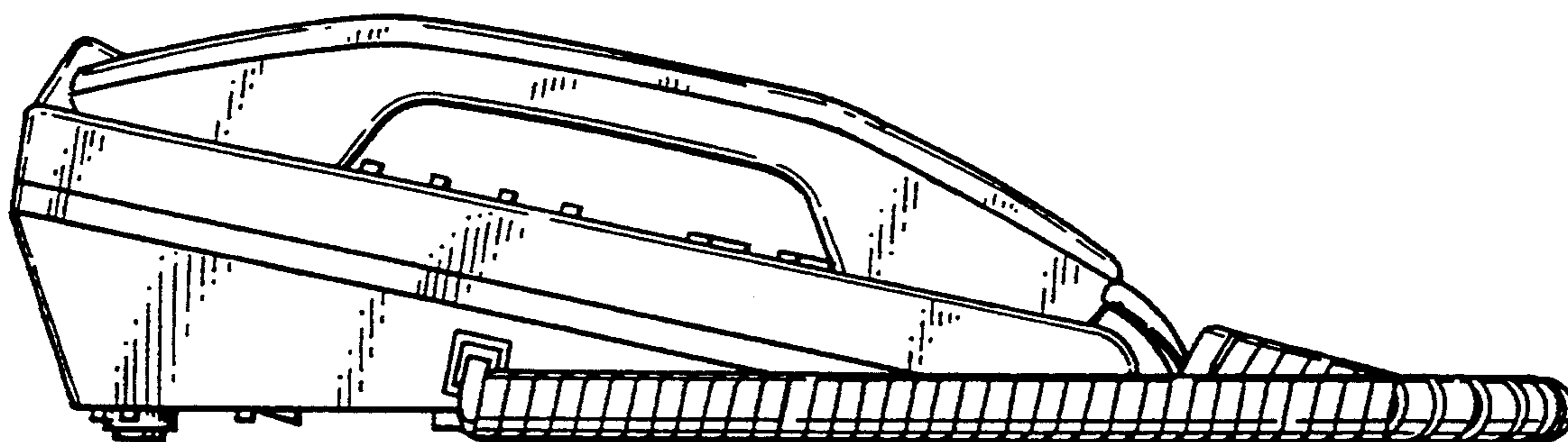

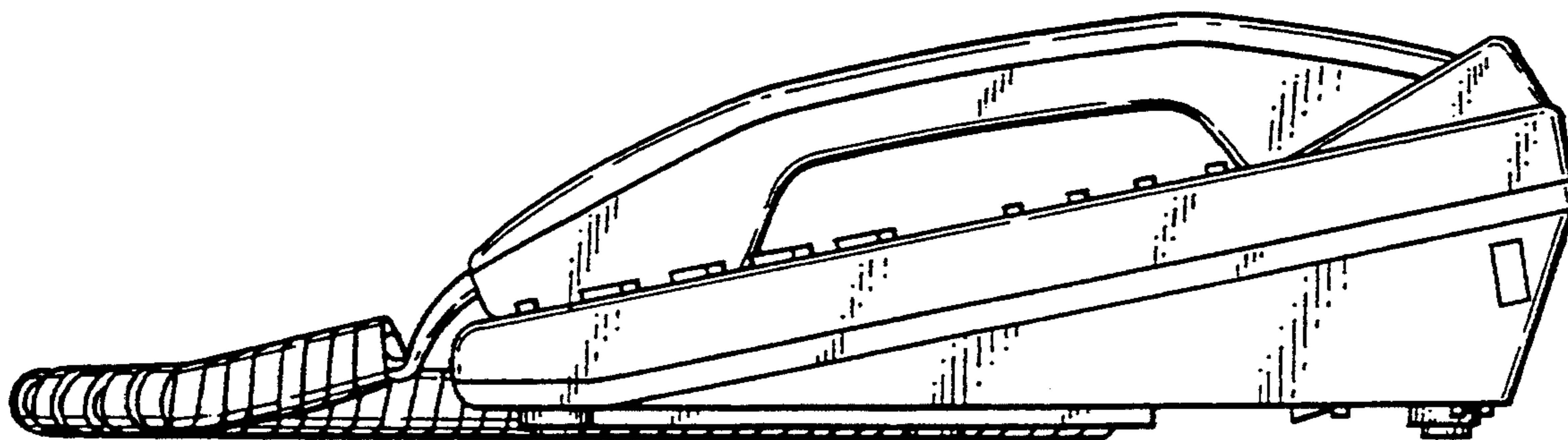
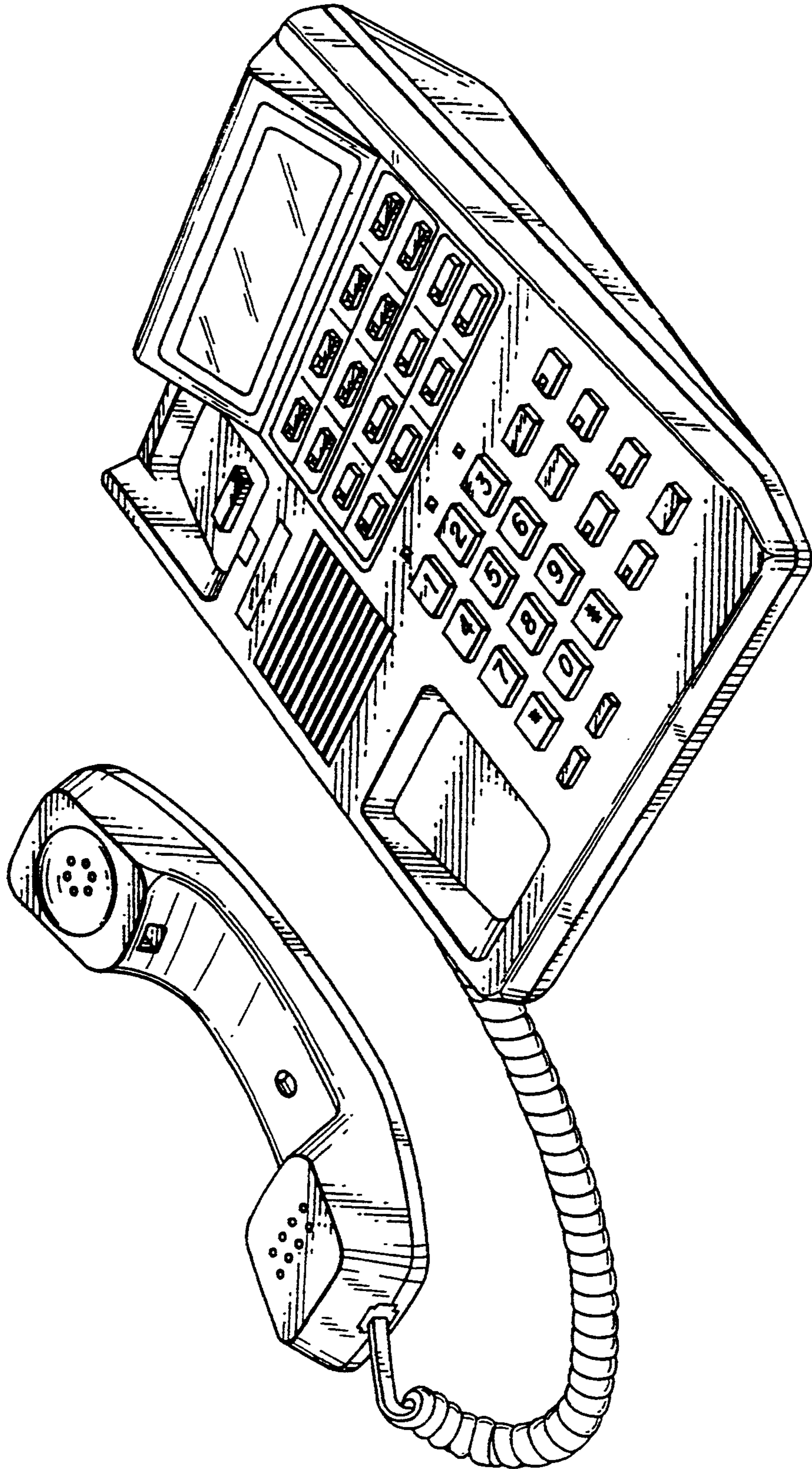
