The ornamental design for eyeglasses with headband, as shown and described.

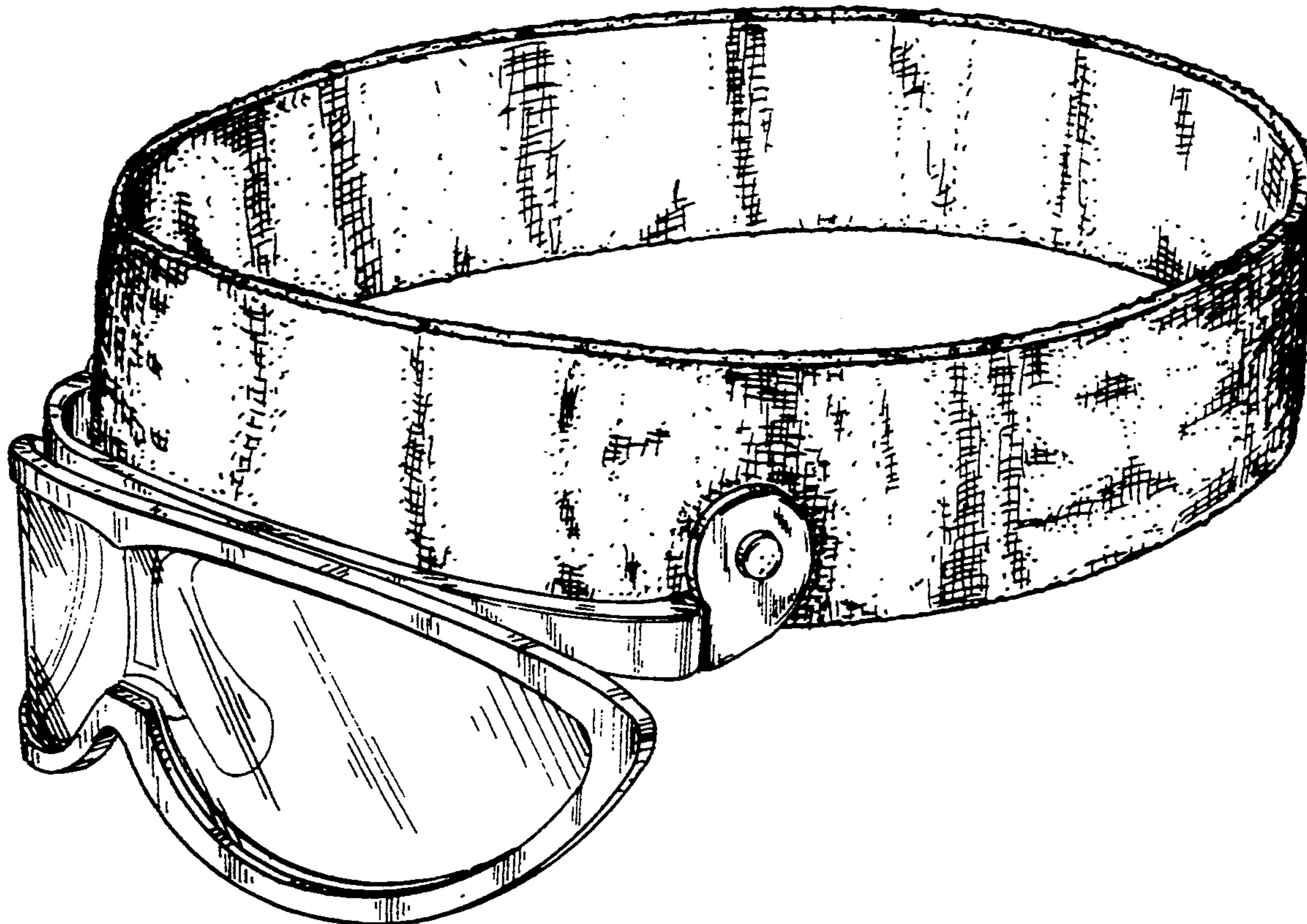
### DESCRIPTION

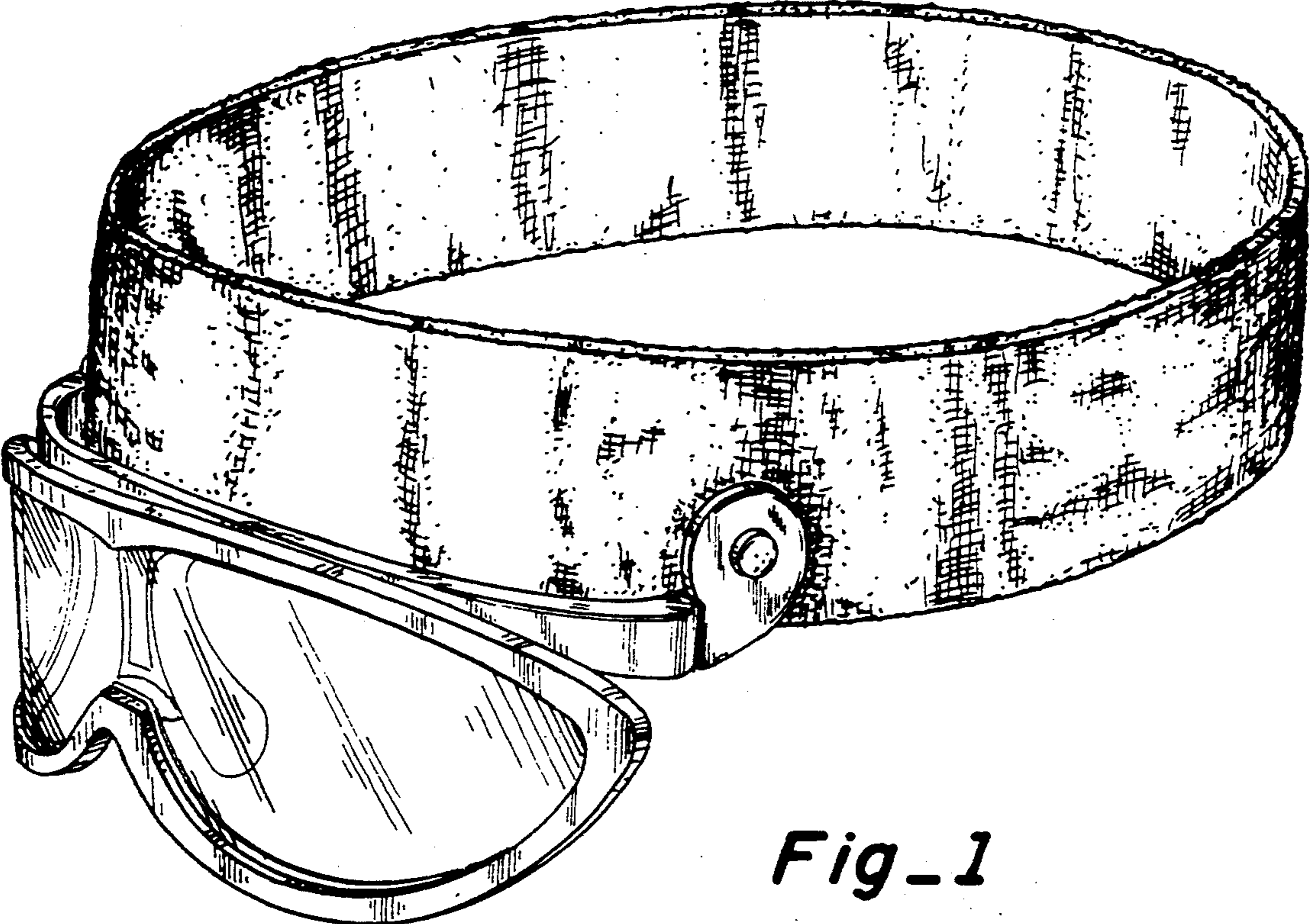
FIG. 1 is a perspective view of the eyeglasses with headband of the design;

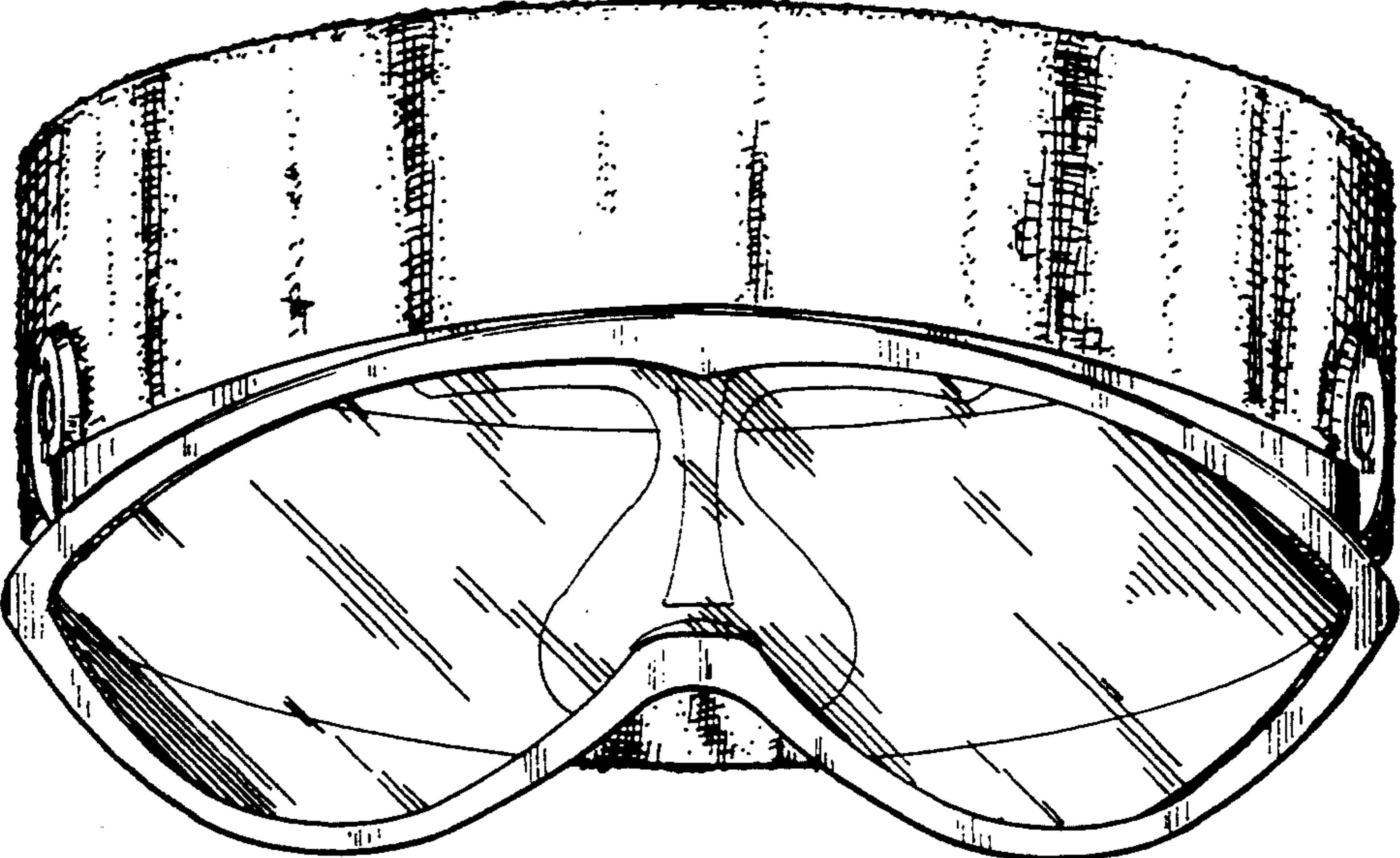

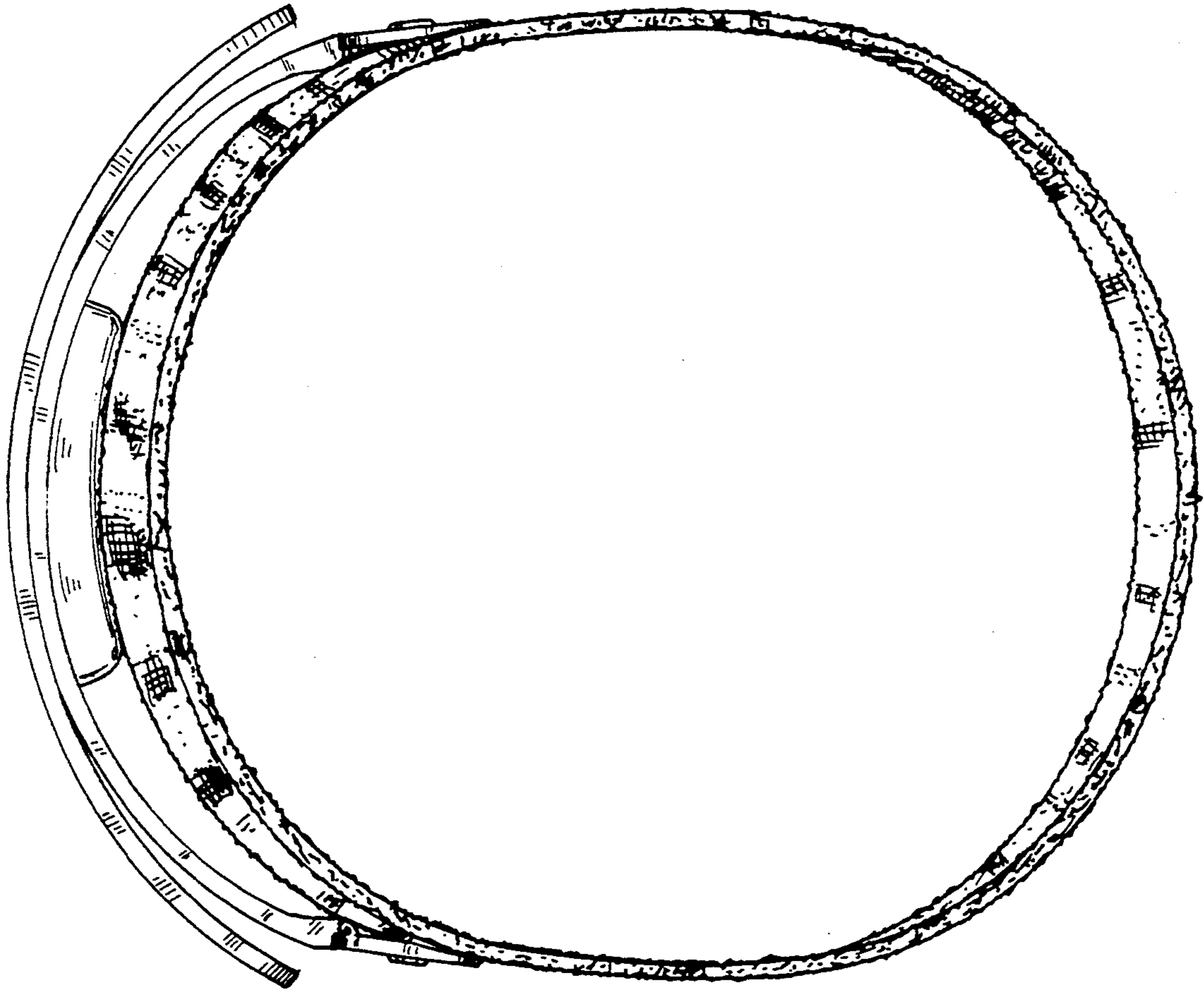




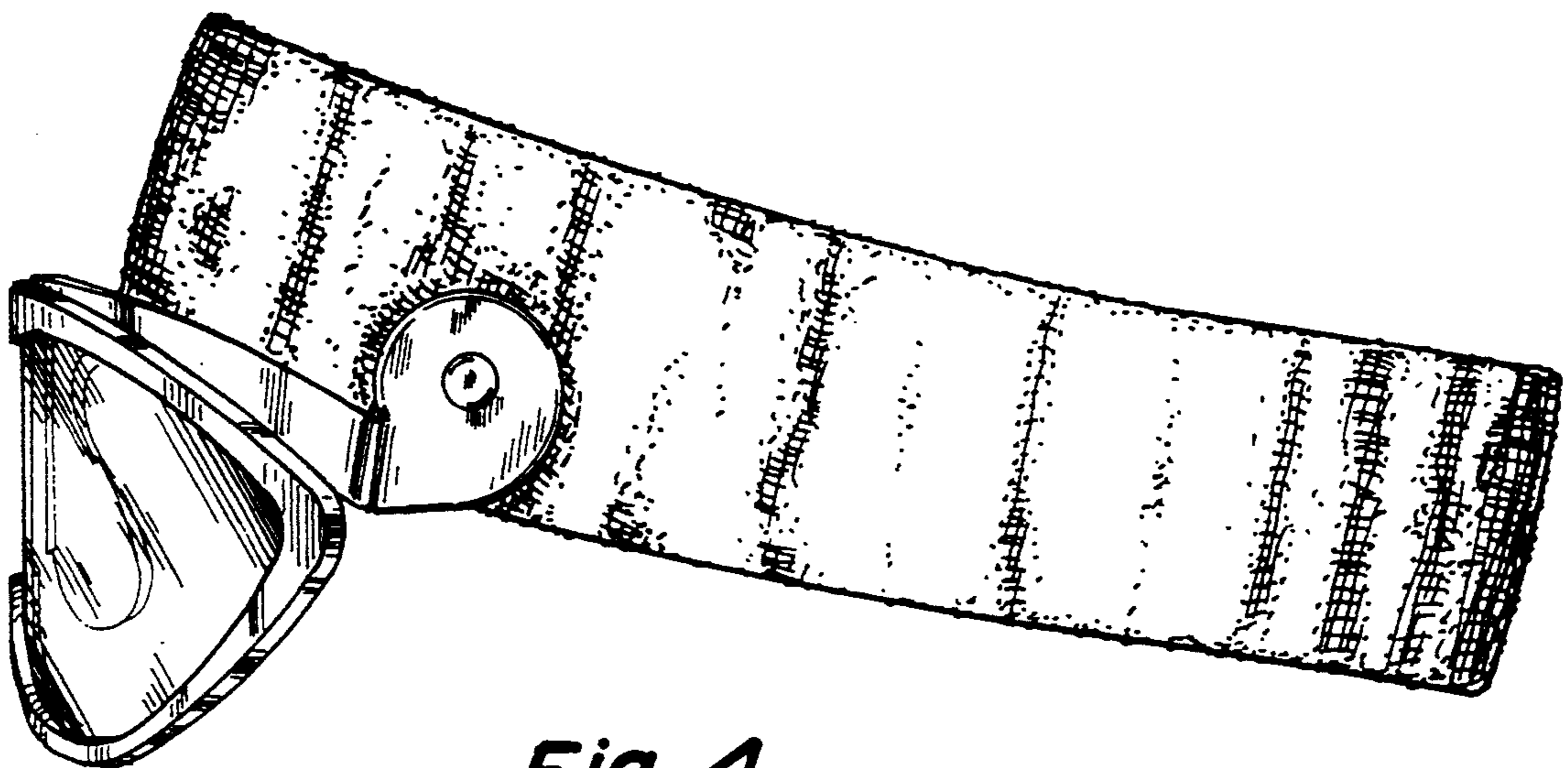

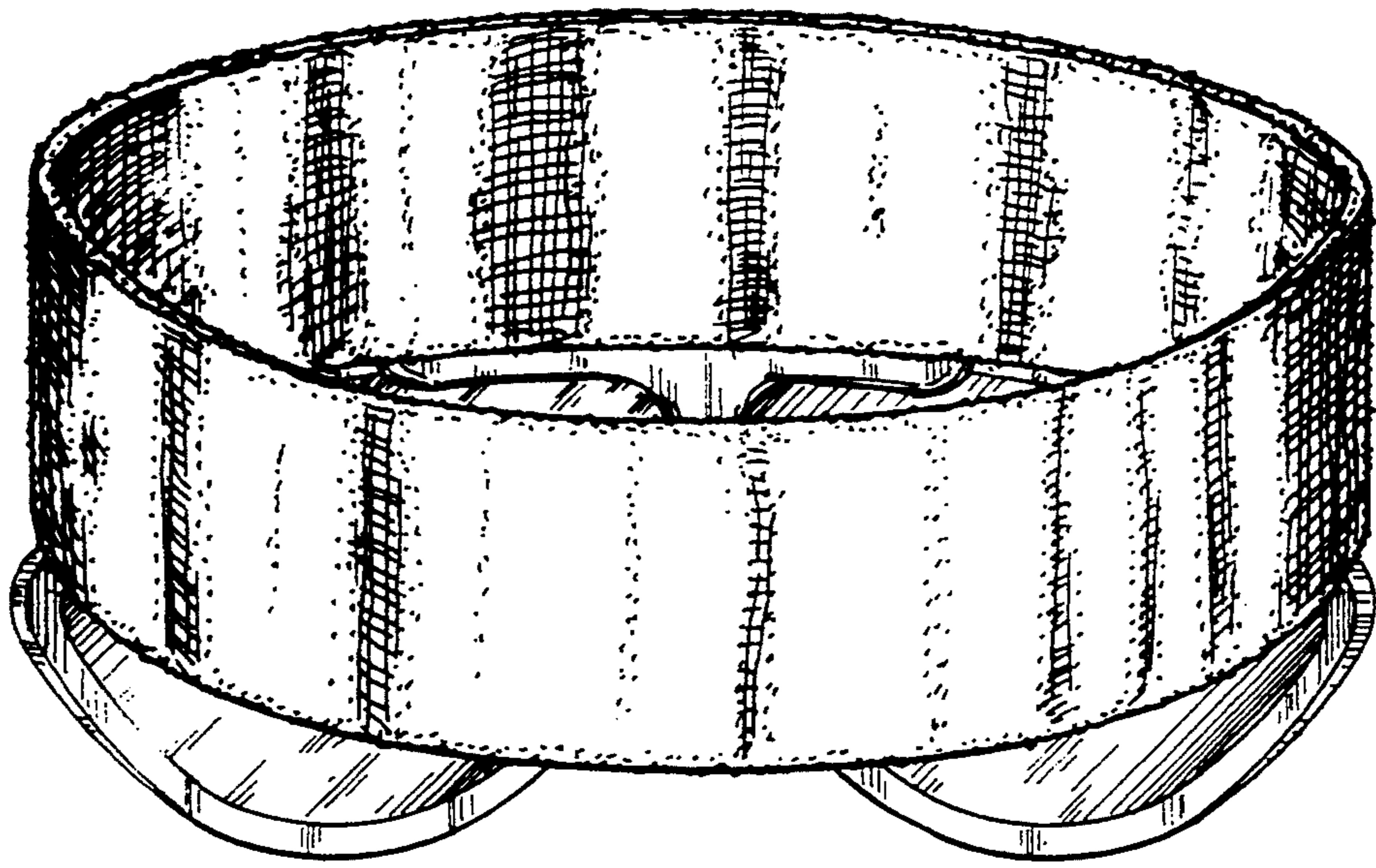

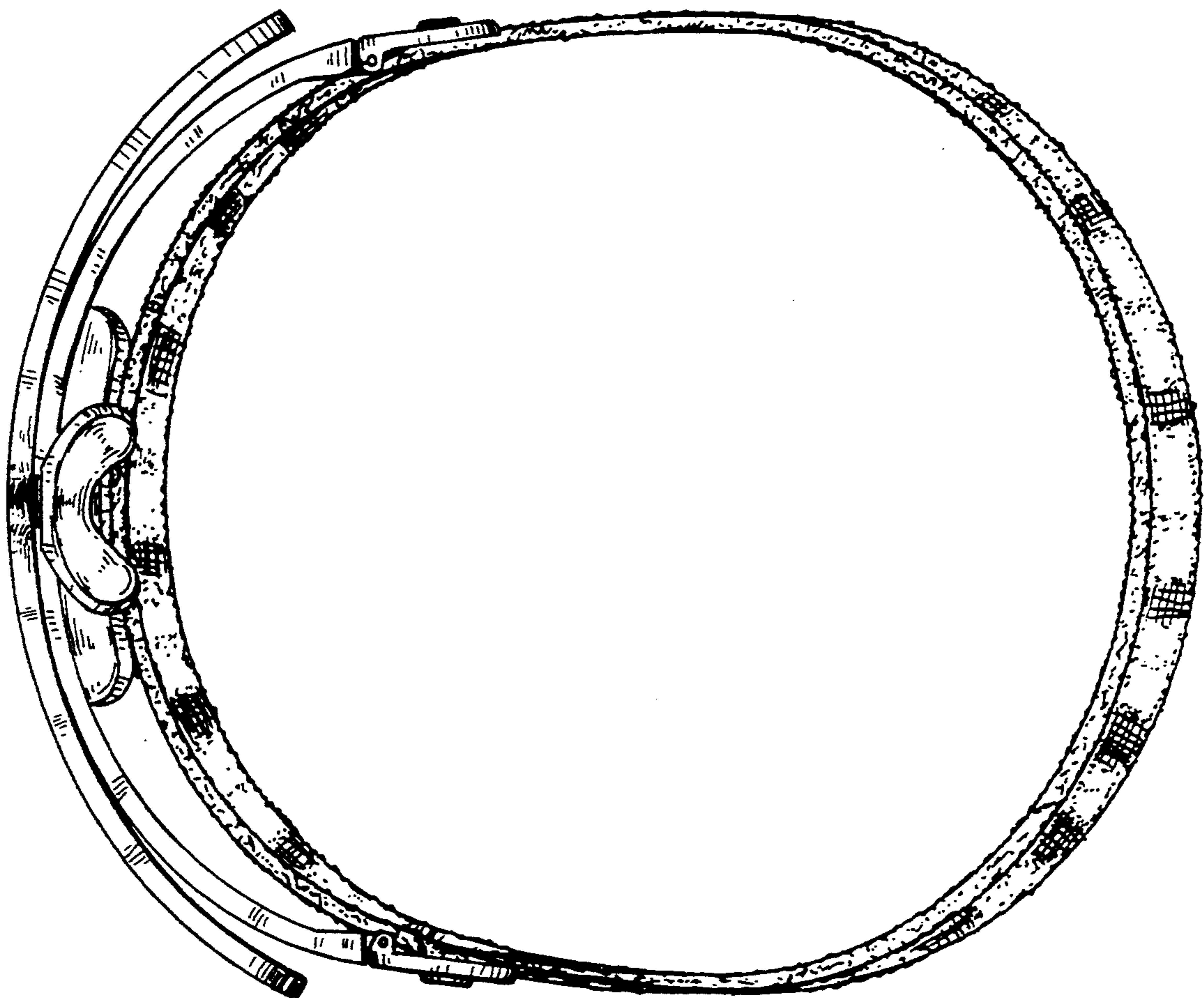
