[57] **CLAIM**

The ornamental design for a roller ball pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a roller ball pen showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side view thereof, the right side being a mirror image thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

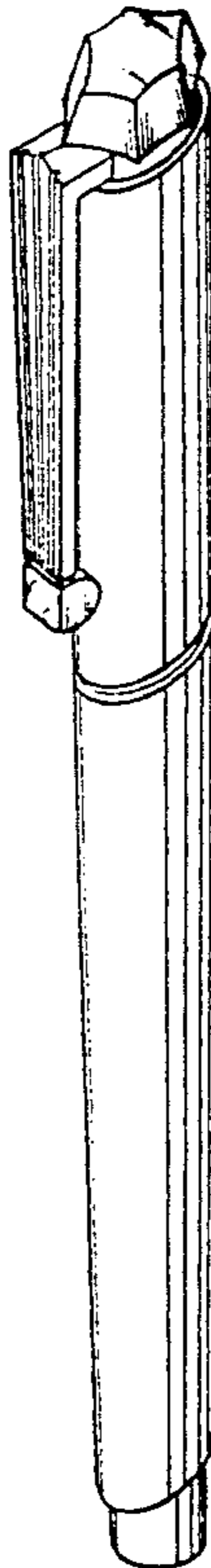

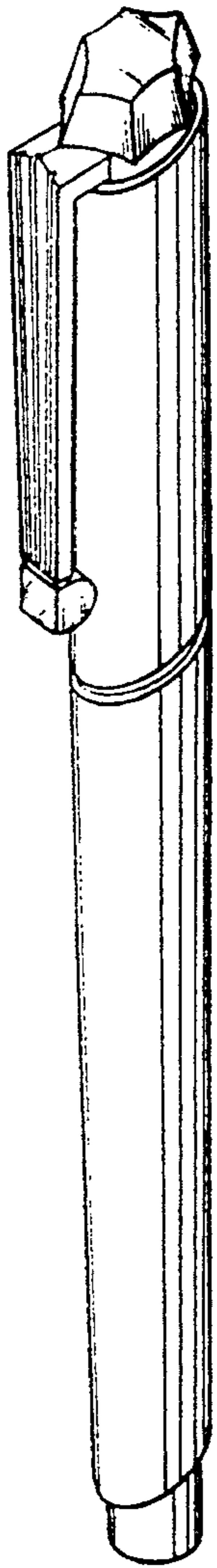

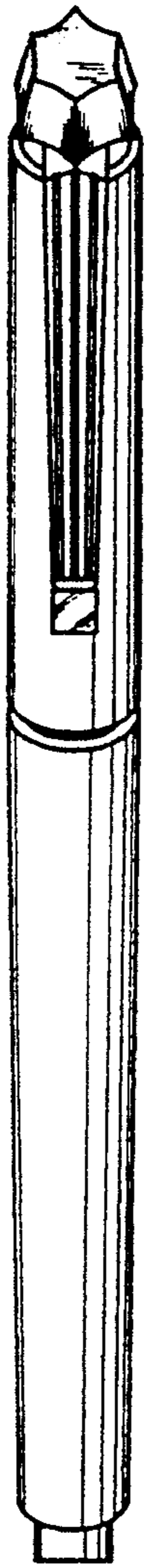

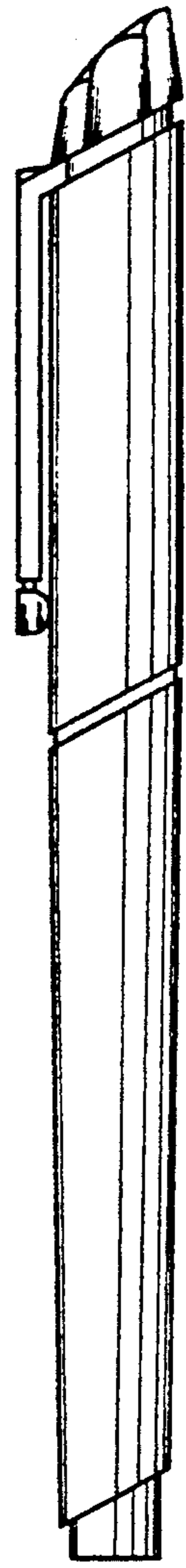

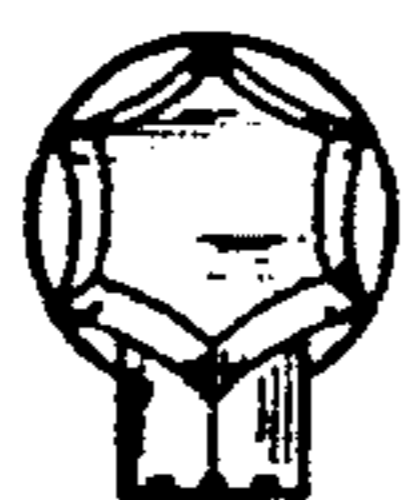
