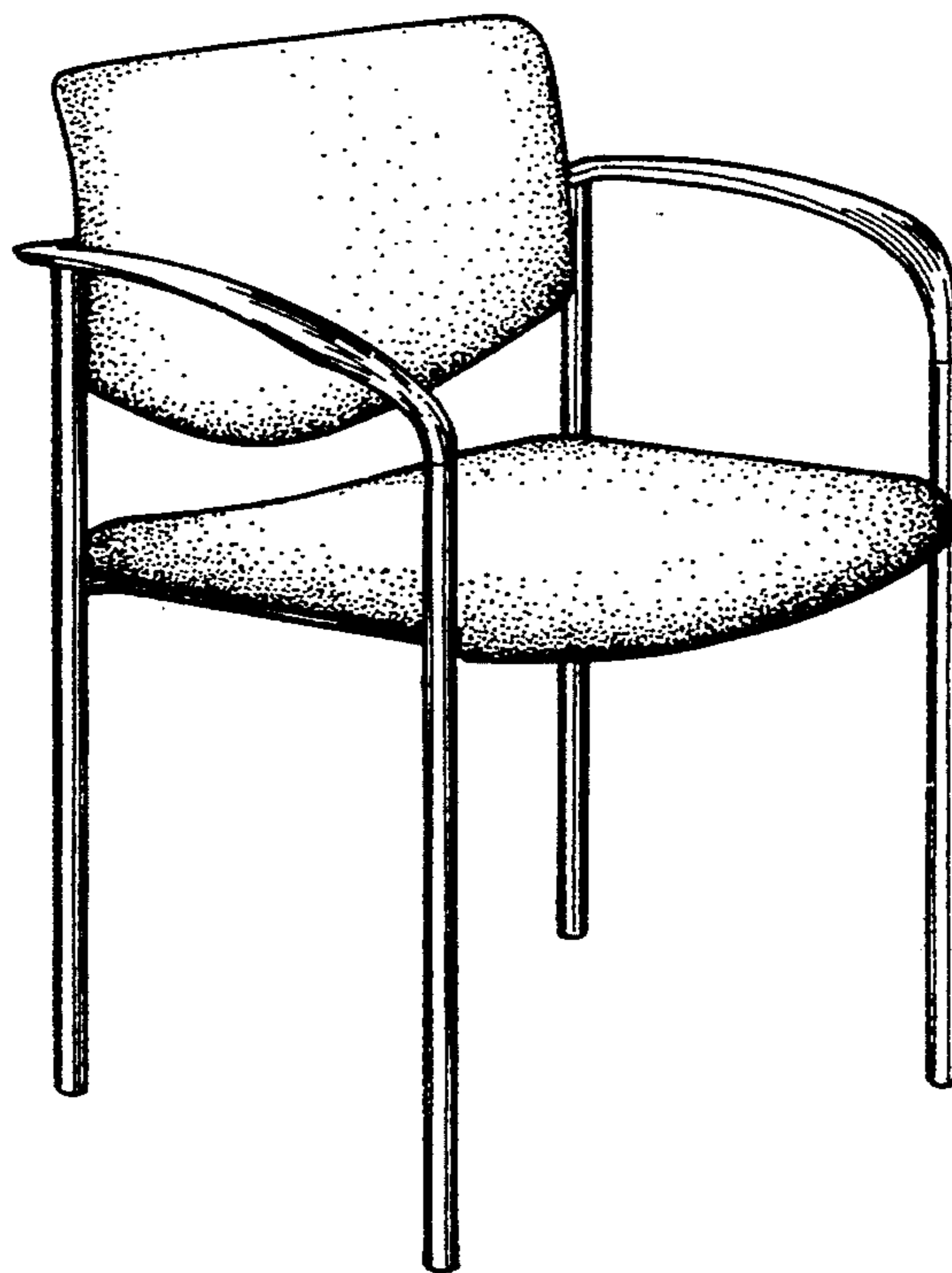

DESCRIPTION

FIG. 1 is a right side, perspective view of a chair showing my new design;

FIG. 12 is a bottom view thereof.



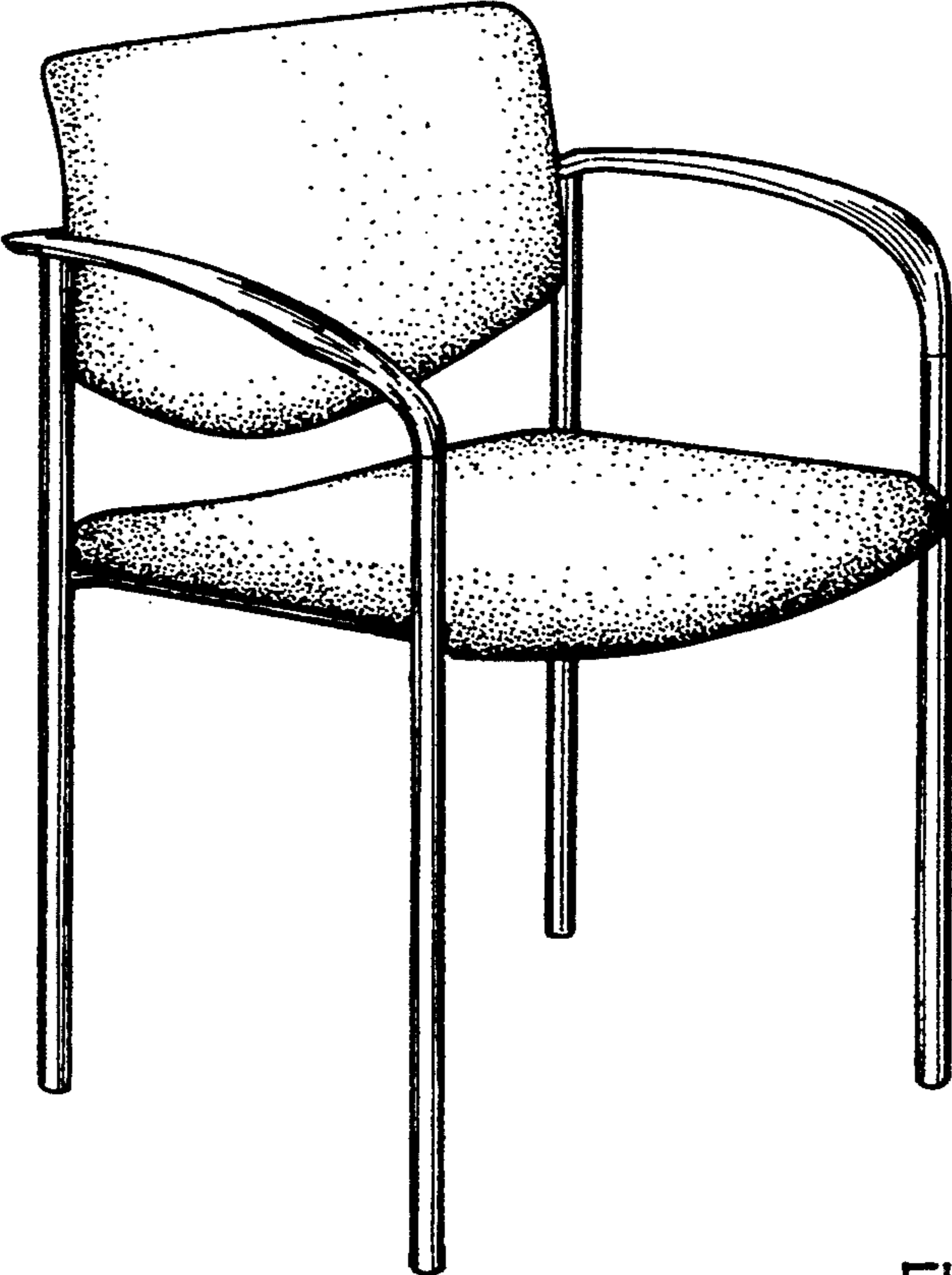

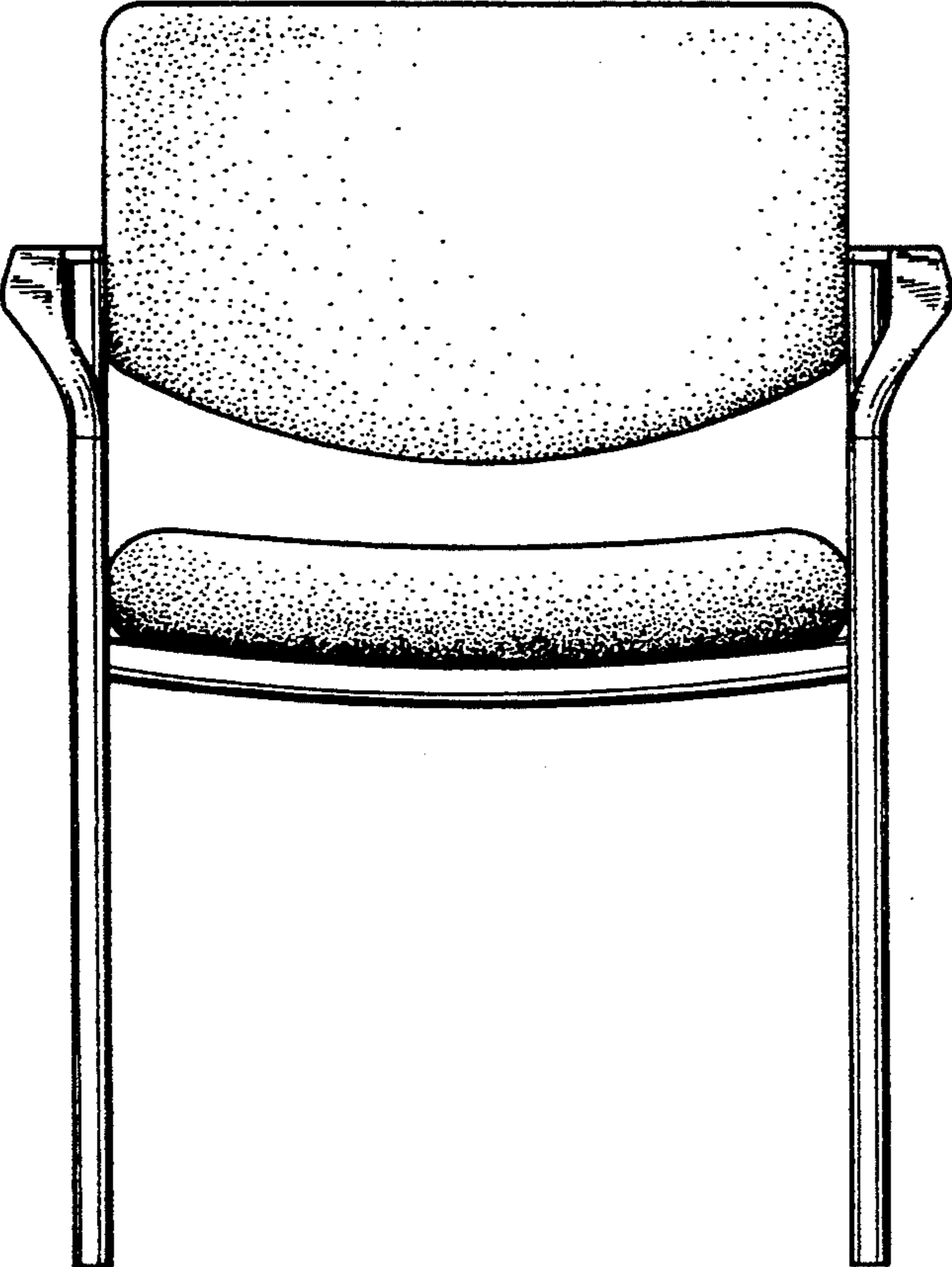

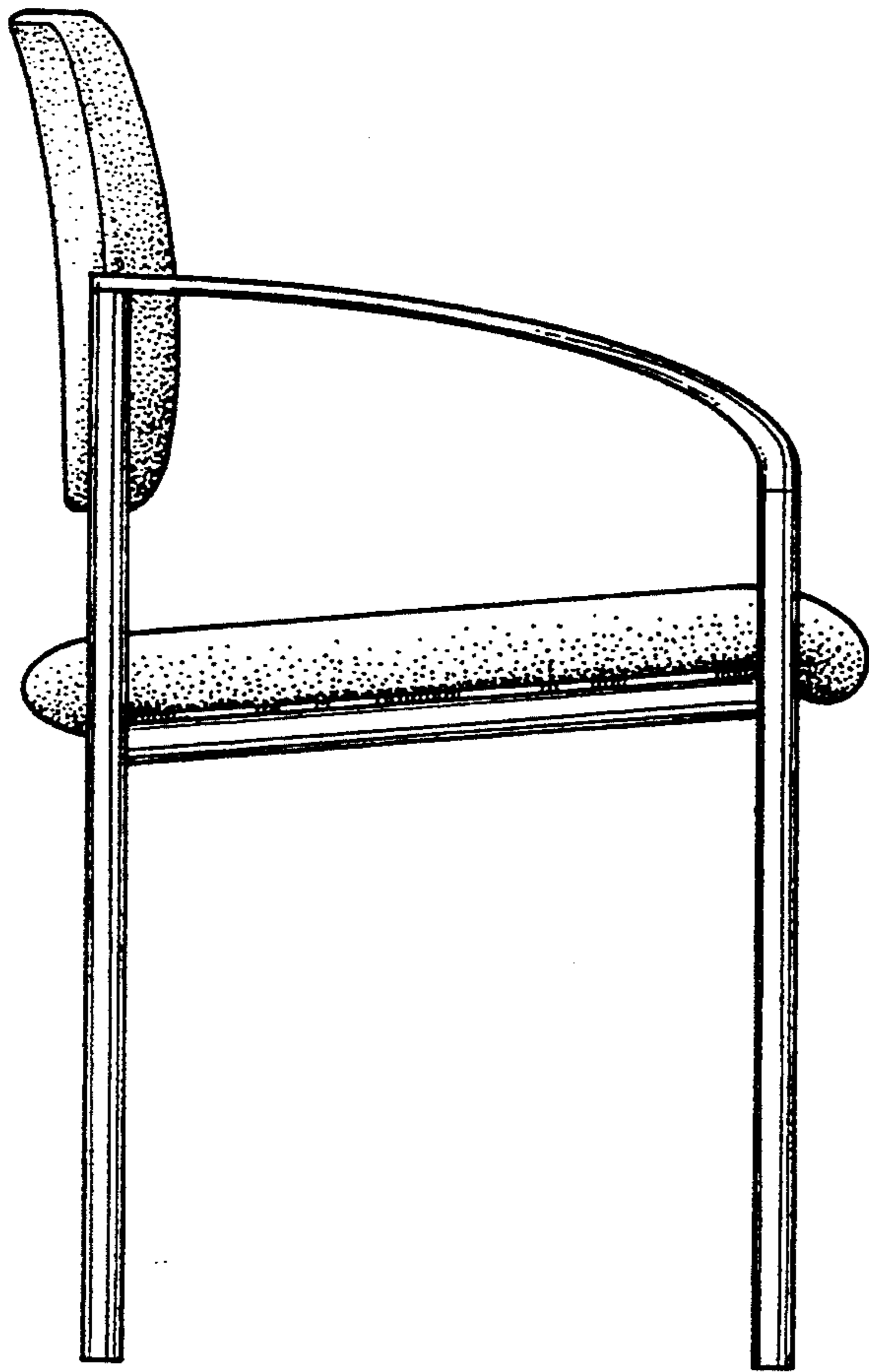

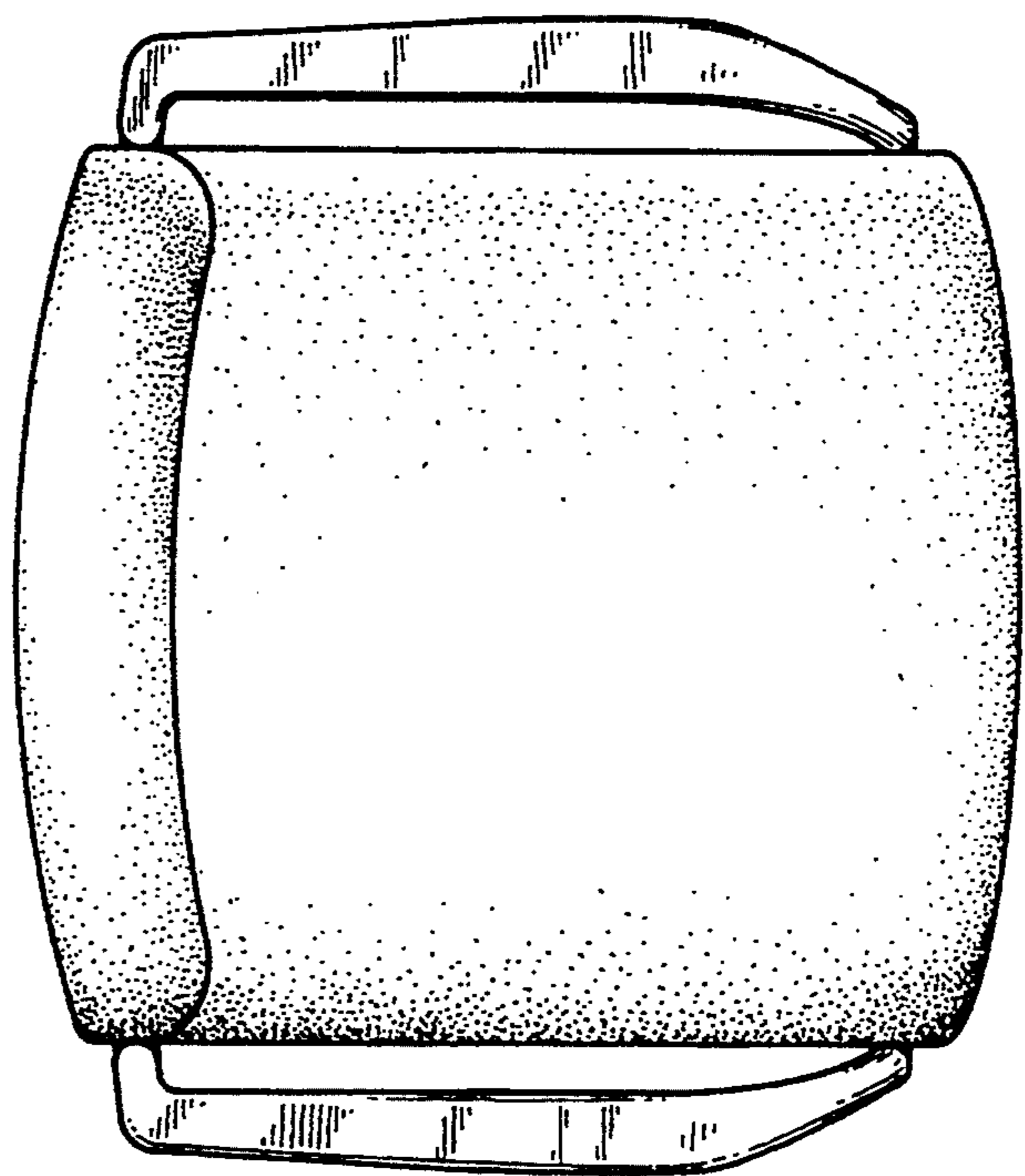

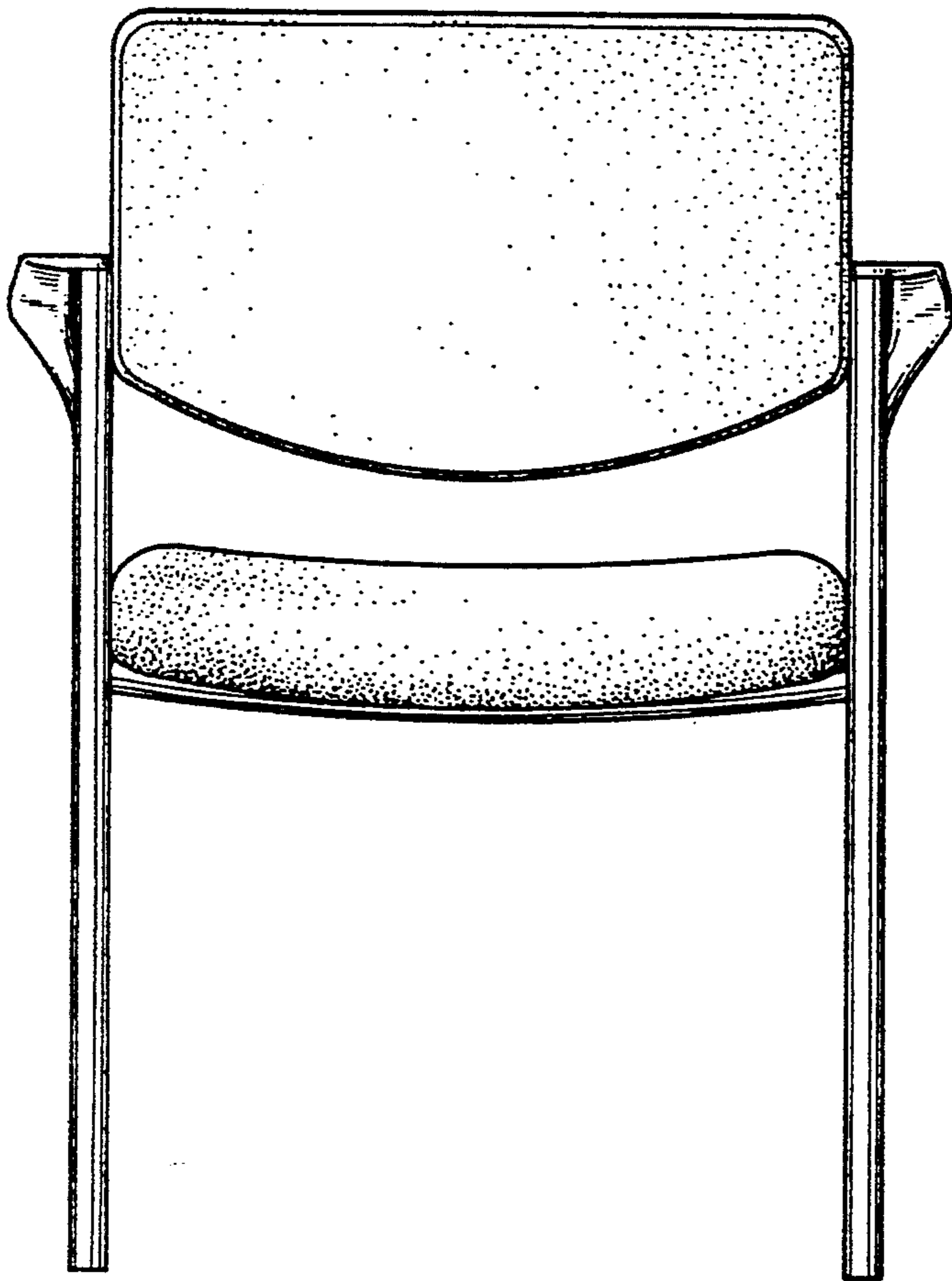

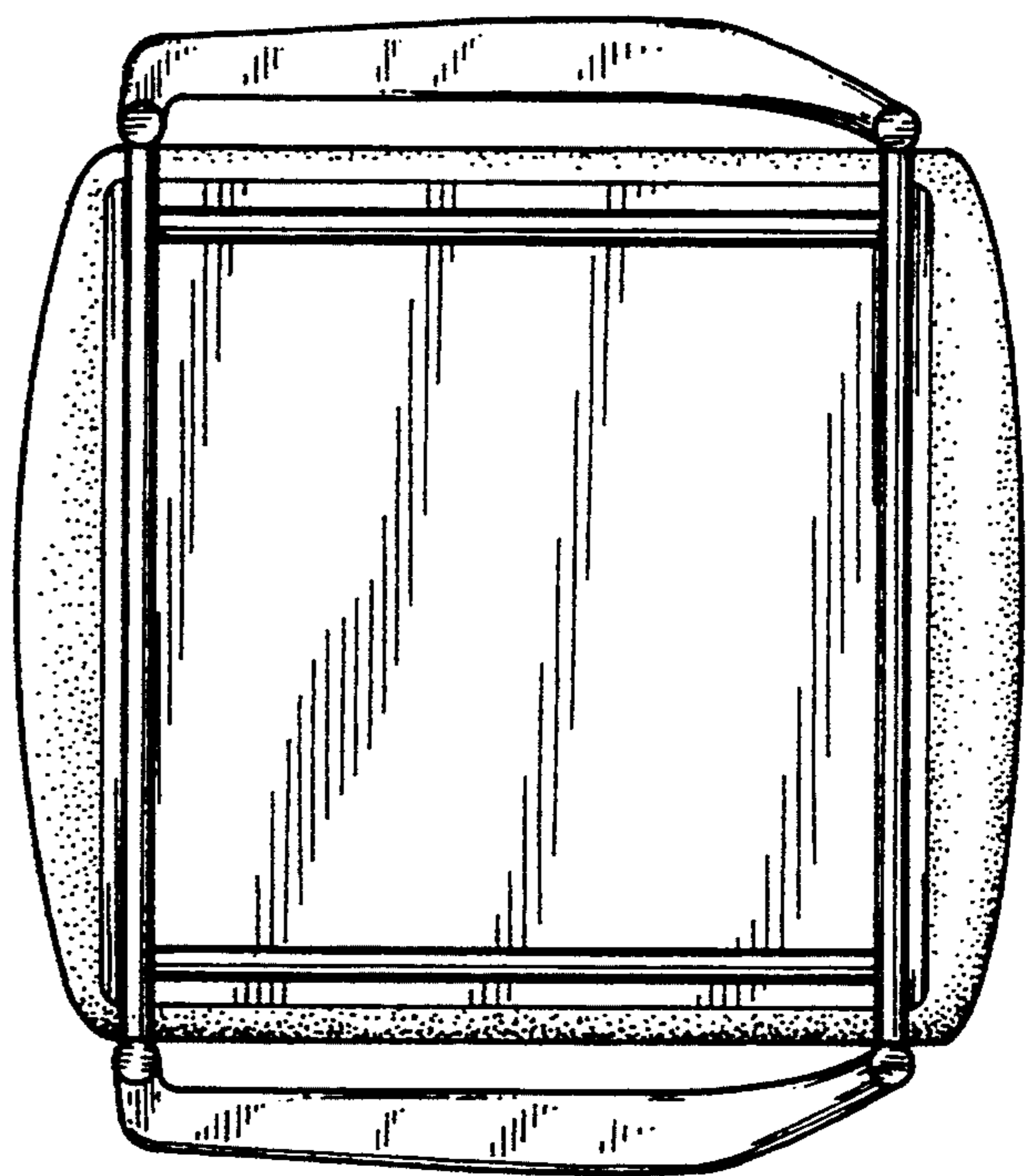

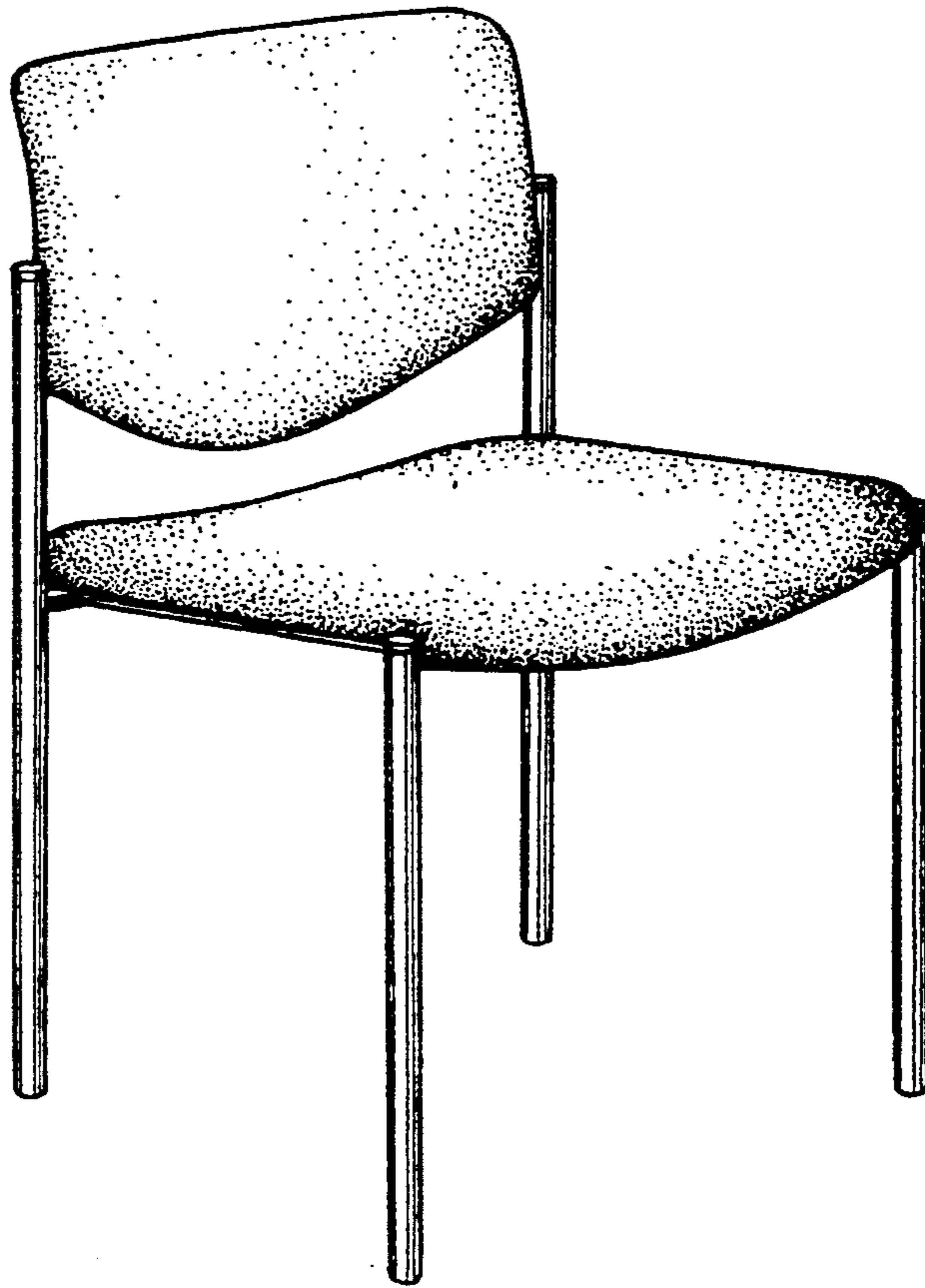

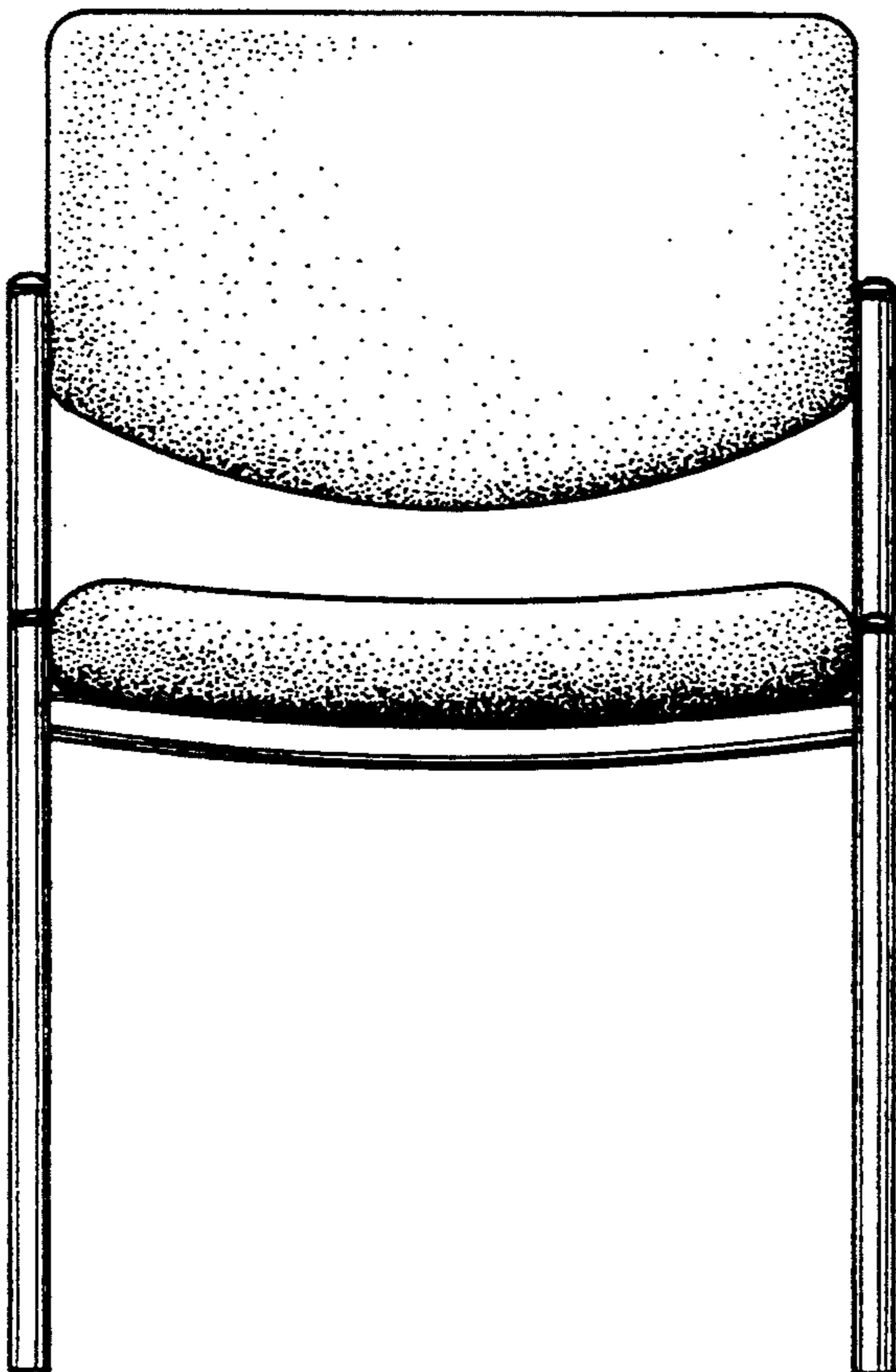

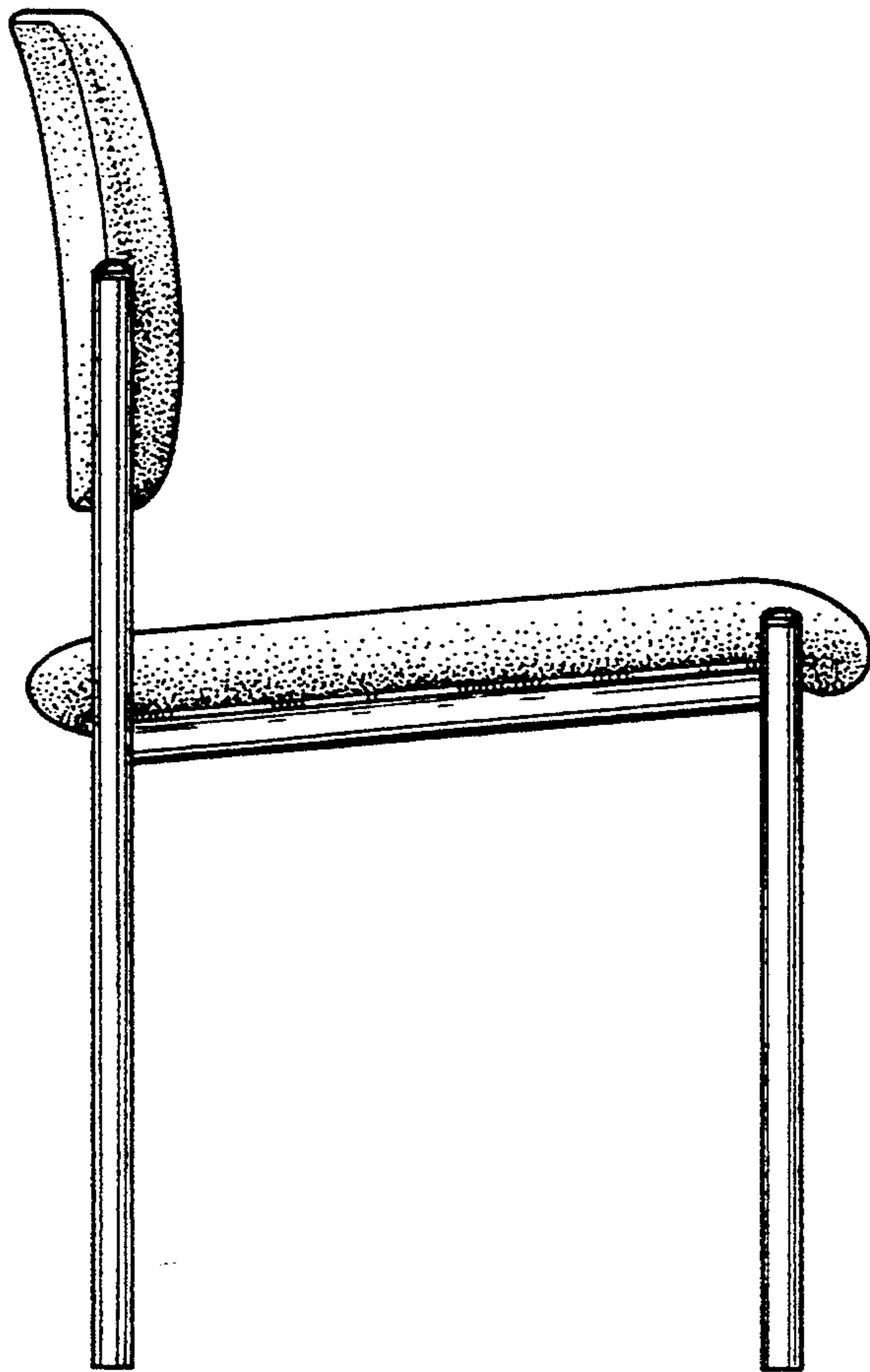

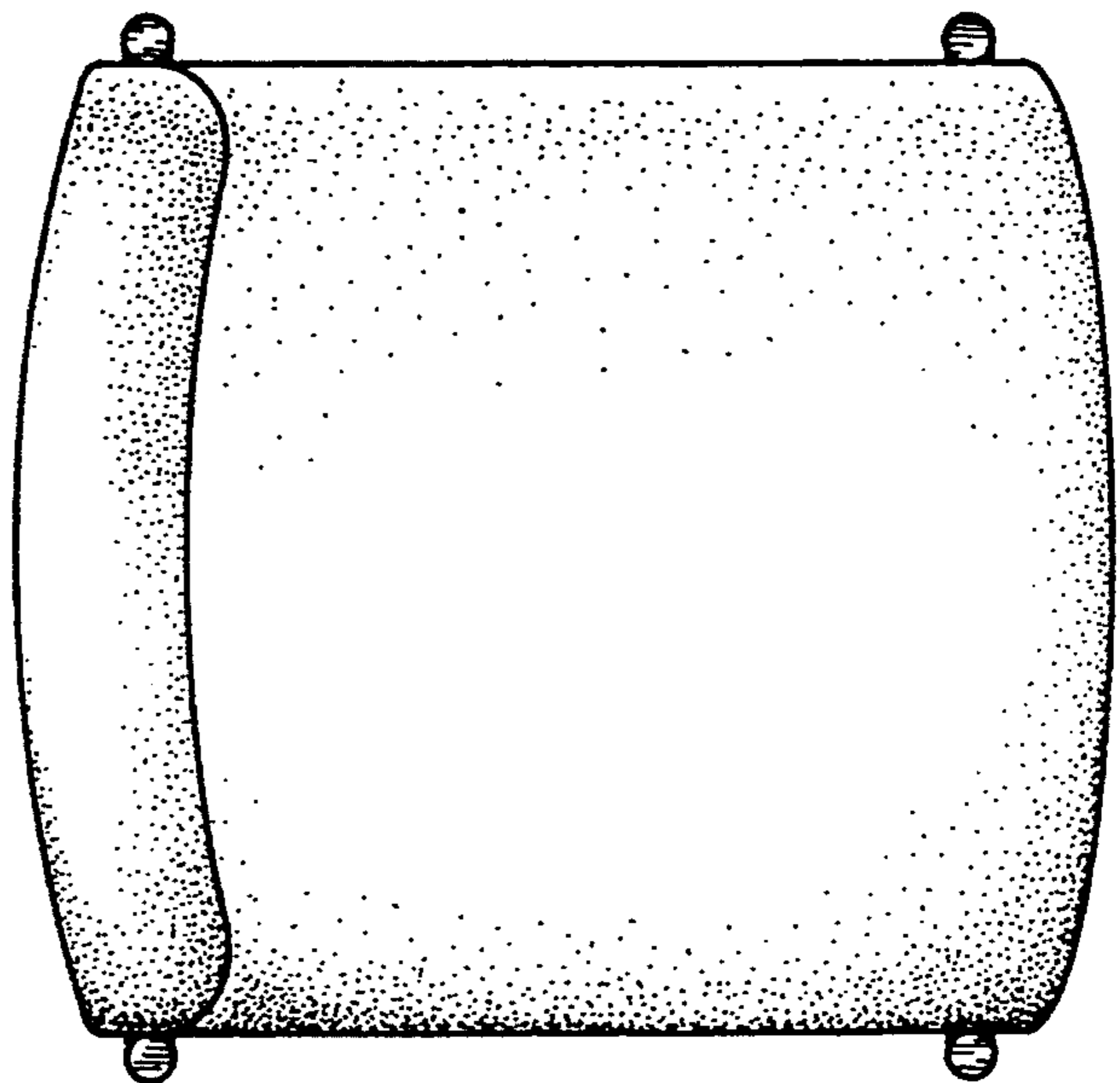

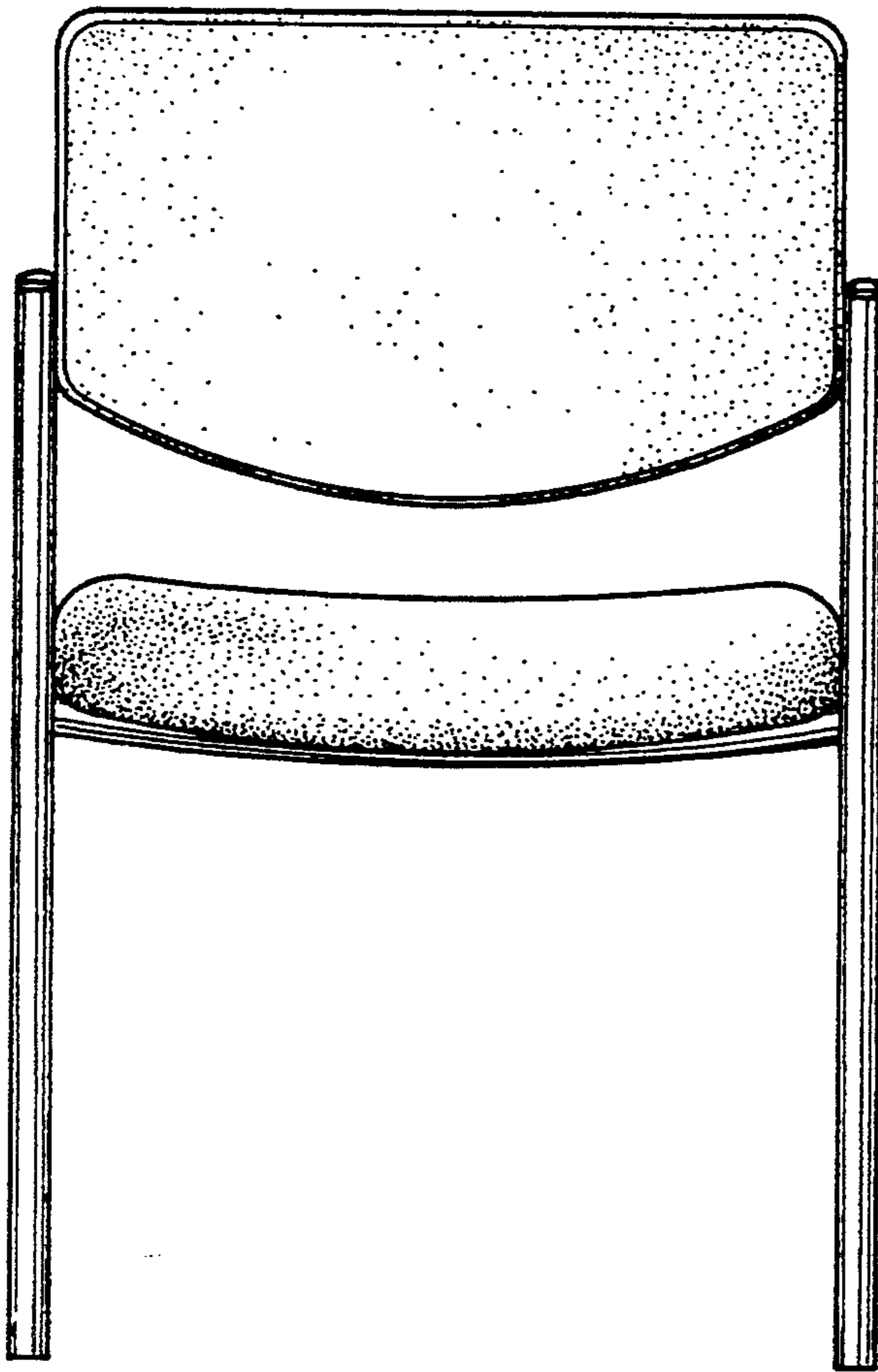

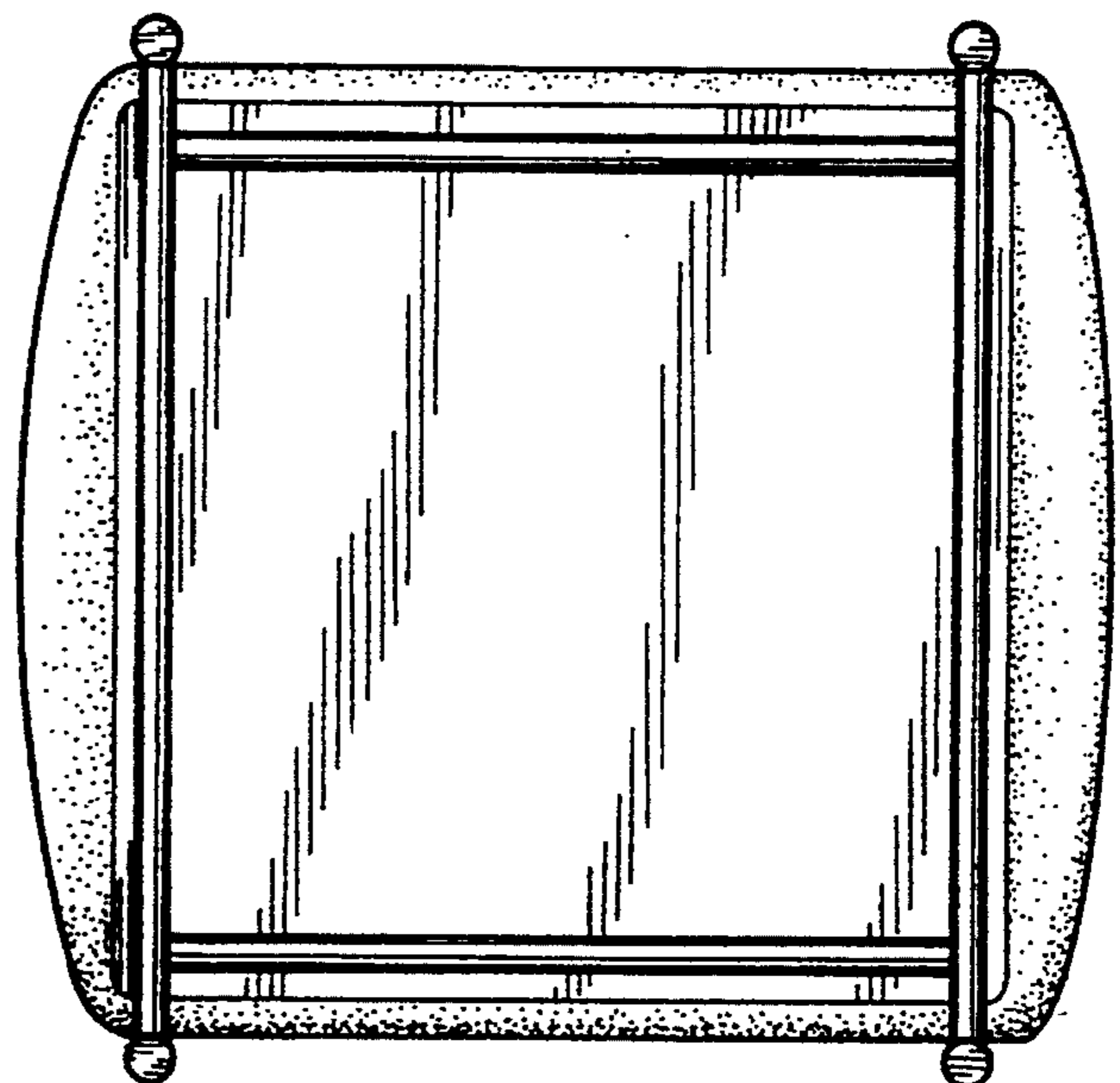
