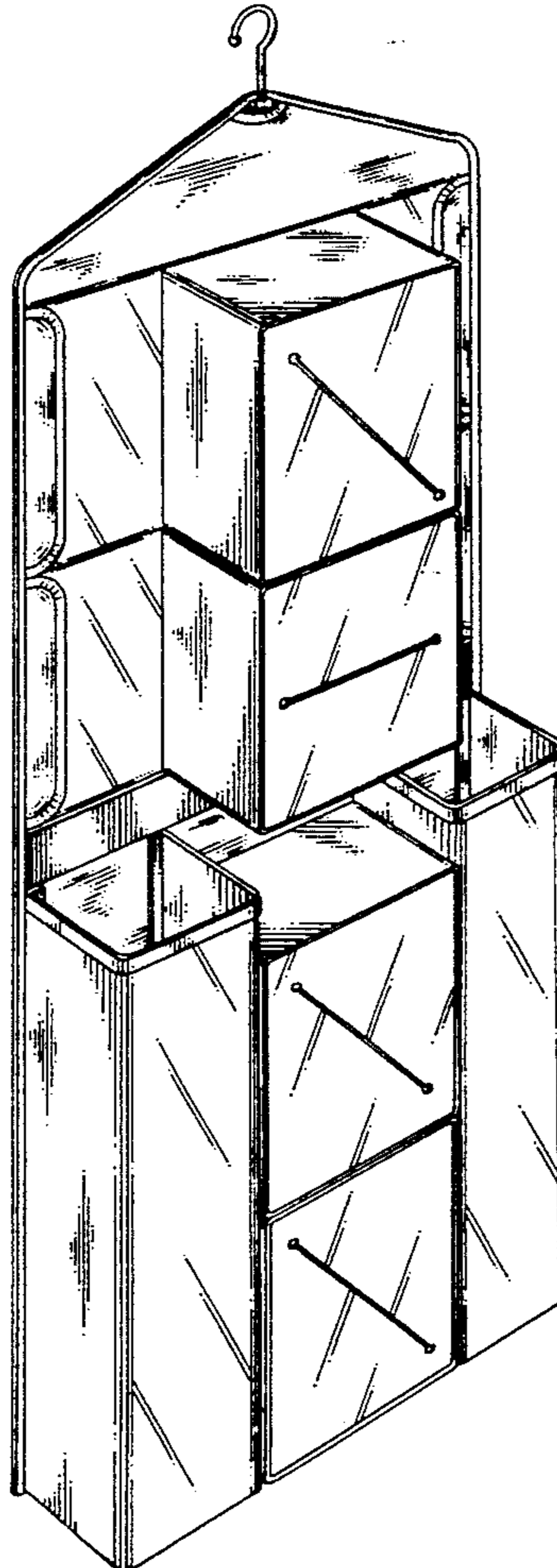

DESCRIPTION

FIG. 1 is a perspective view of a gift wrap organizer showing my new design;

 FIG. 7 is a left side elevational view thereof.



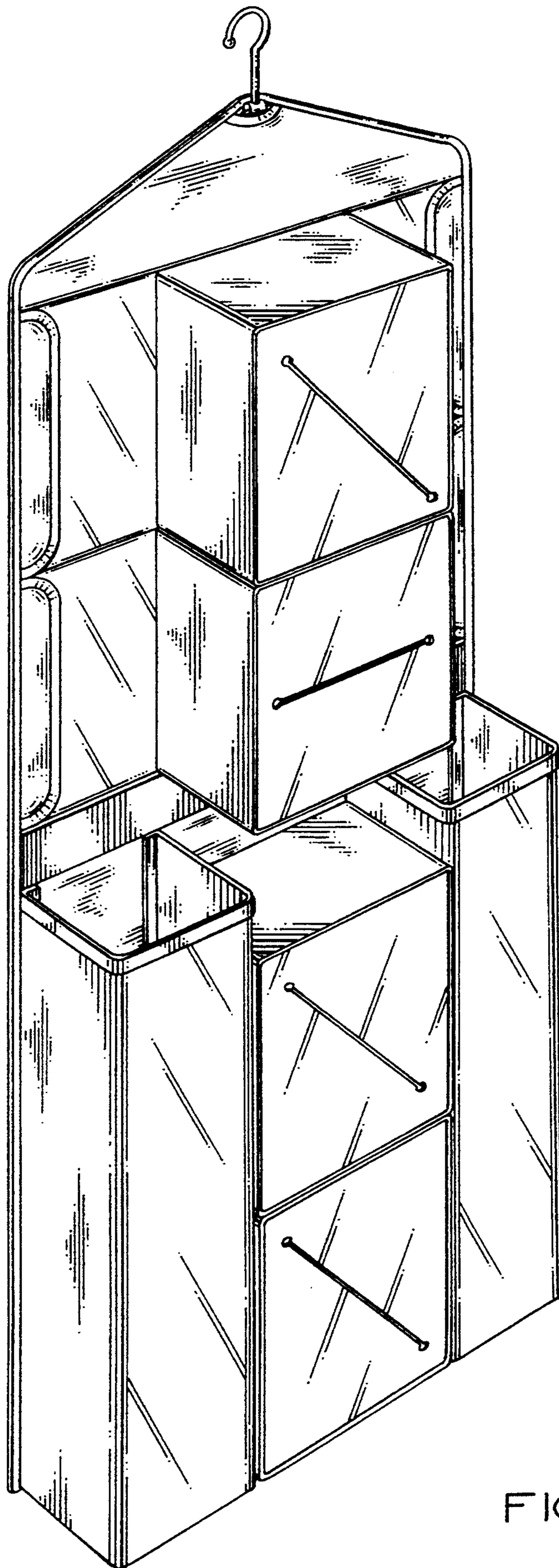

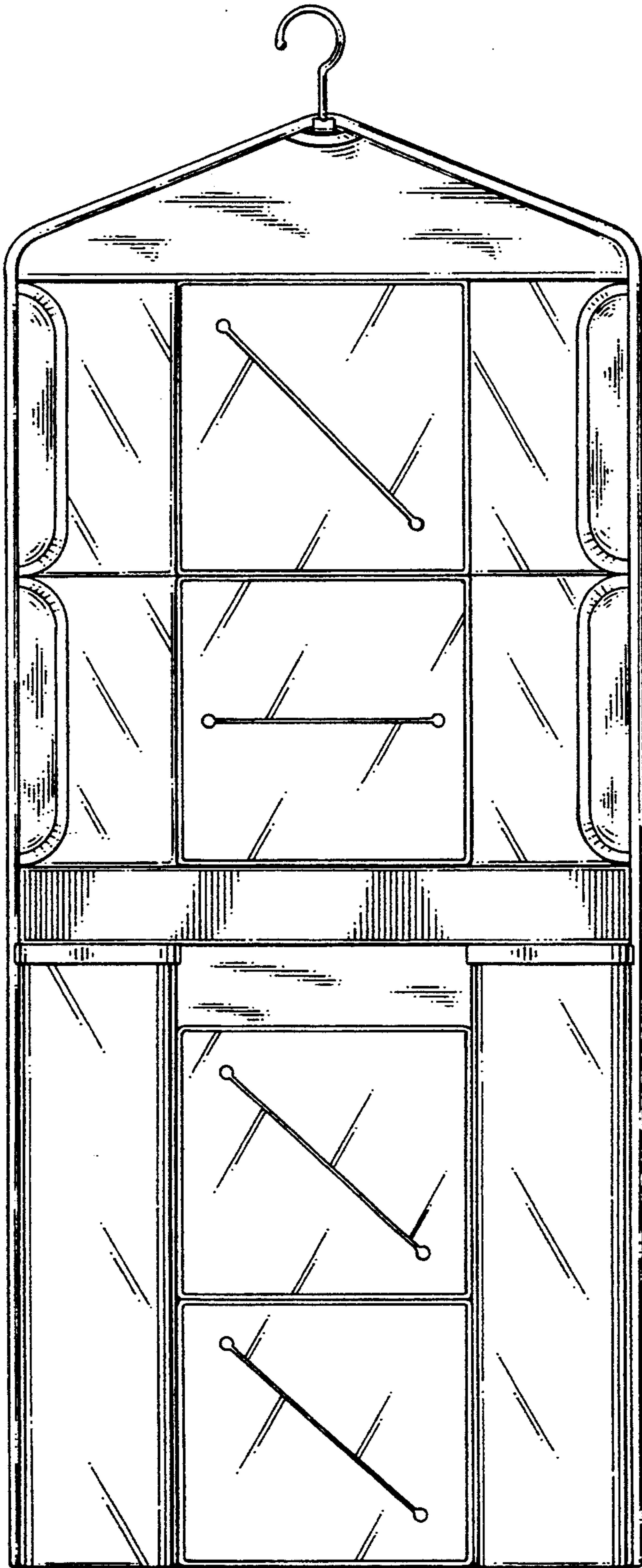

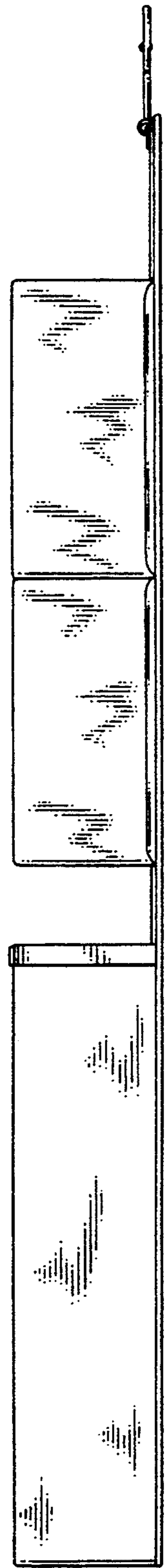

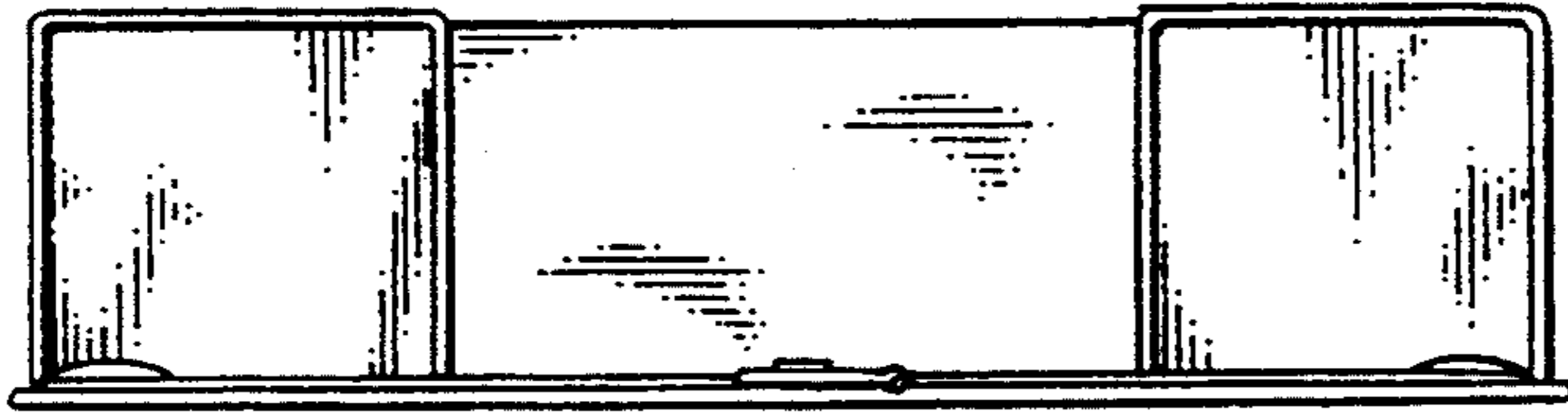

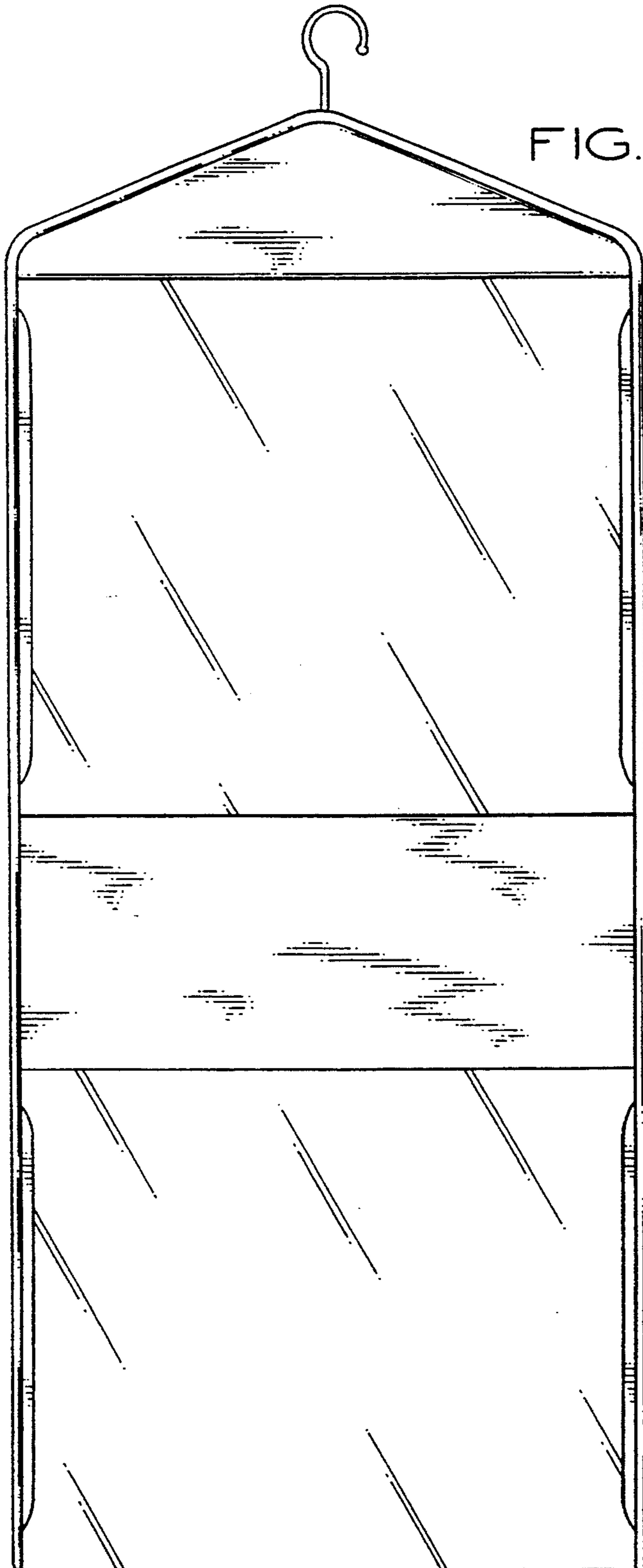

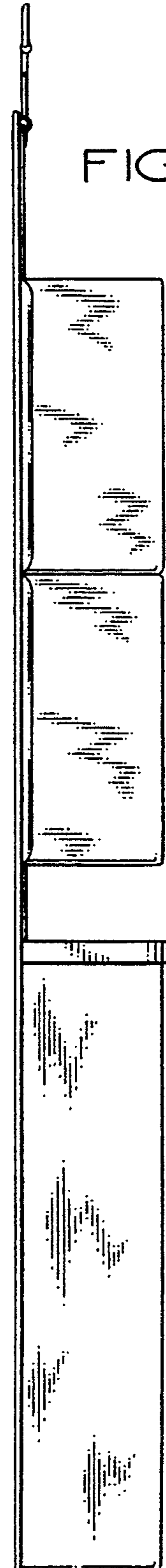
