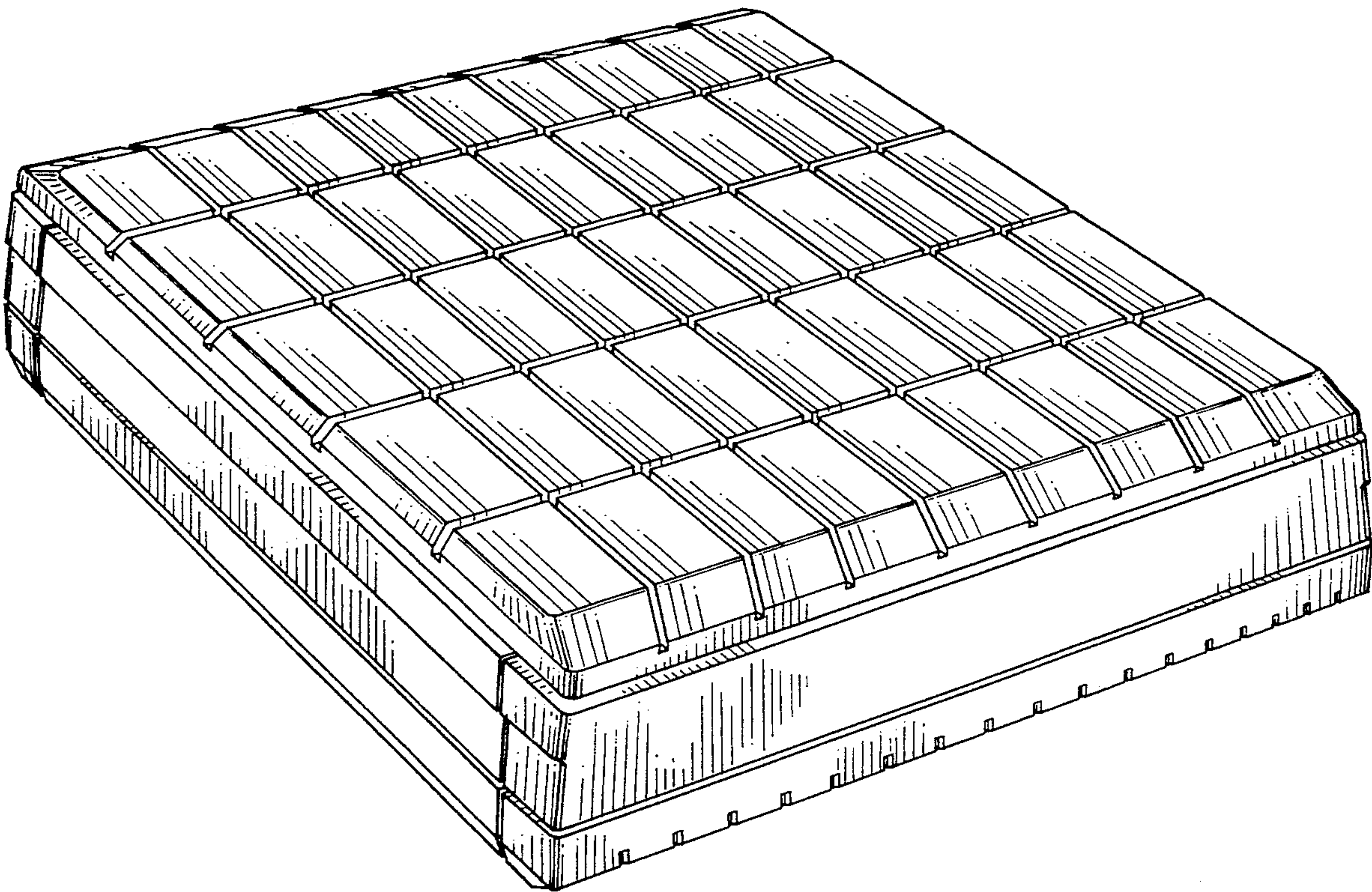
[57] **CLAIM**

The ornamental design for a remote weighing platform for a postal scale, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of one embodiment of a remote weighing platform for a postal scale showing my new design;  
FIG. 2 is a top plan view of the embodiment of FIG. 1;  
FIG. 3 is a front elevational view of the embodiment of FIG. 1;  
FIG. 4 is a left side elevational view of the embodiment of FIG. 1;  
FIG. 5 is a right side elevational view of the embodiment of FIG. 1; and,  
FIG. 6 is a rear elevational view of the embodiment of FIG. 1.

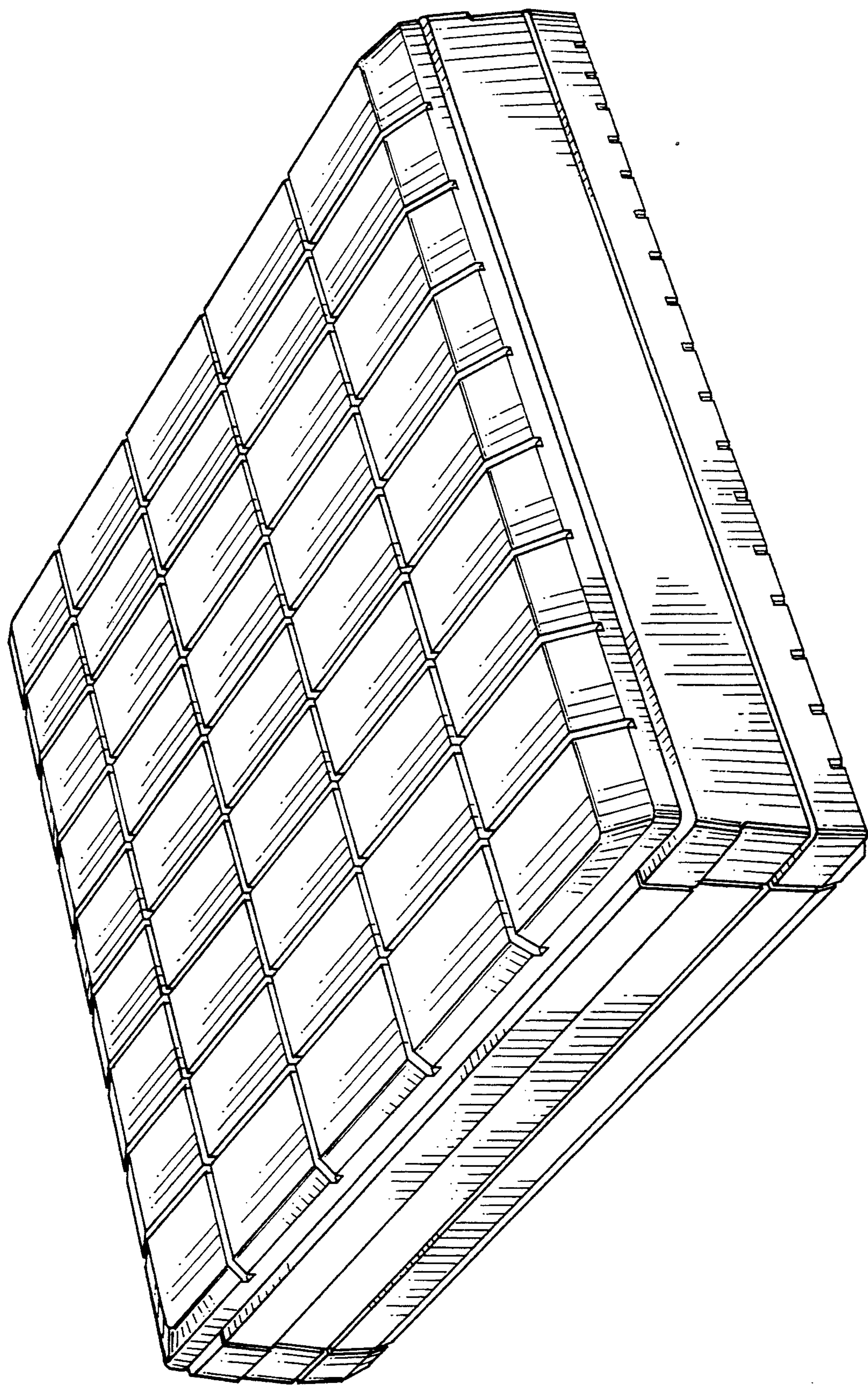

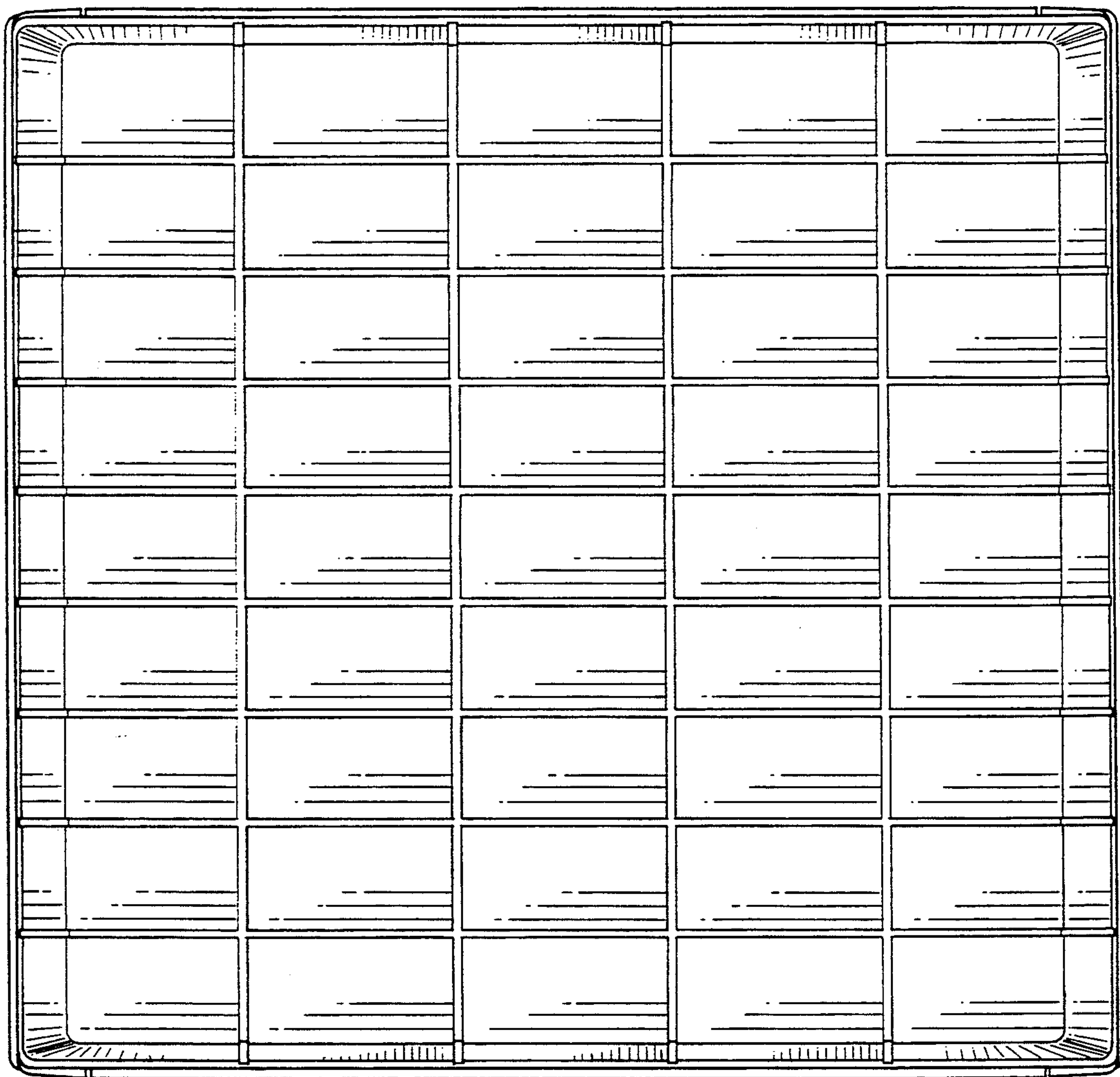

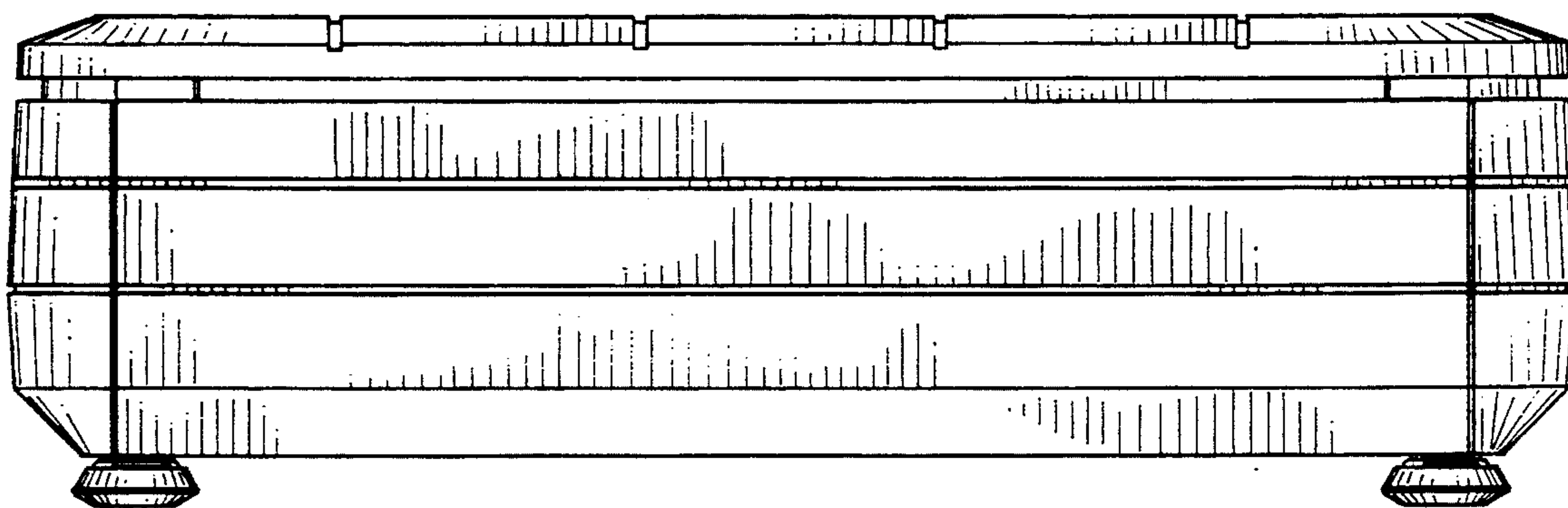

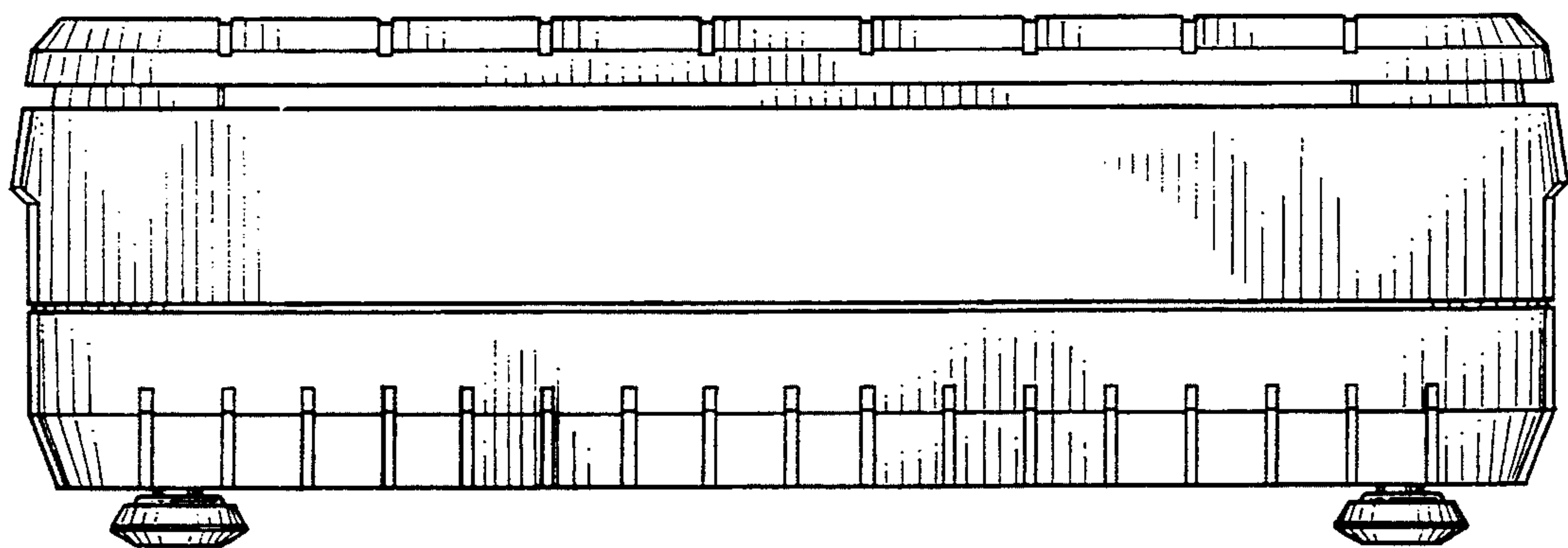

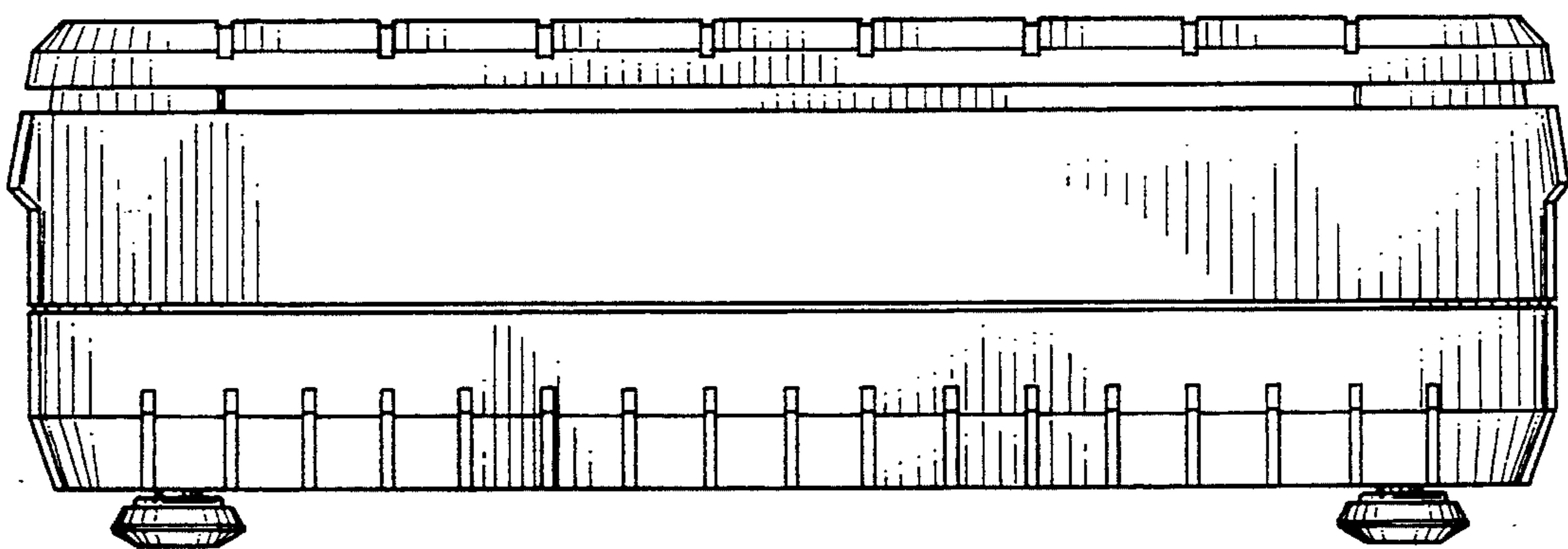

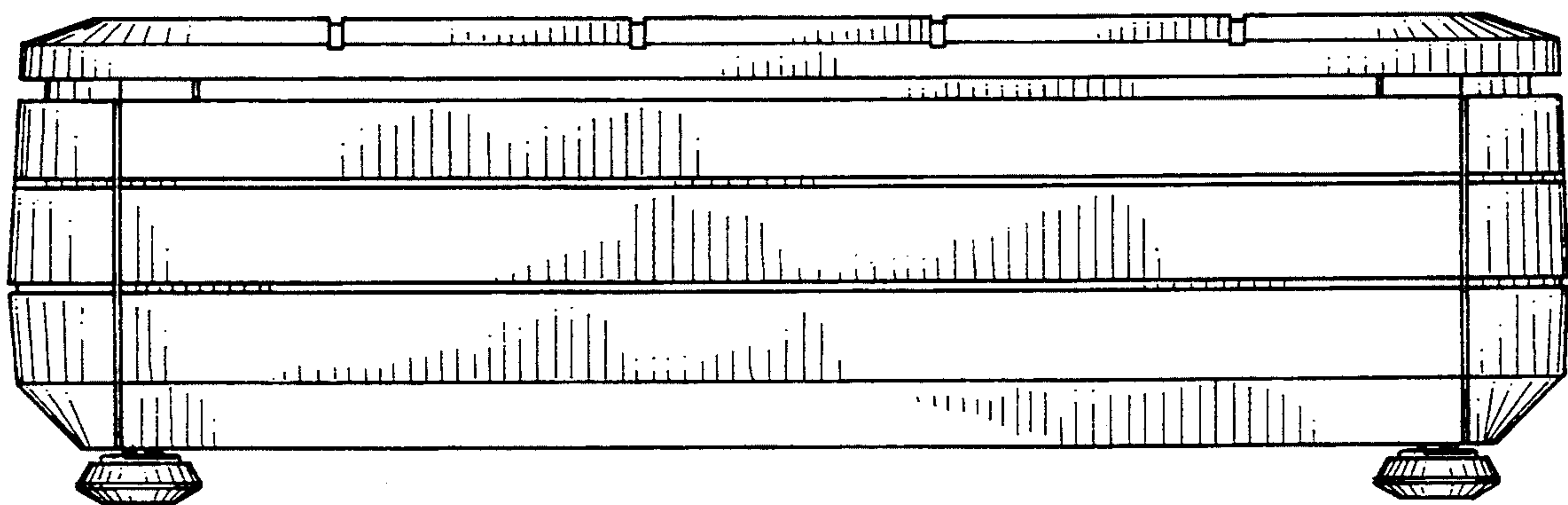
