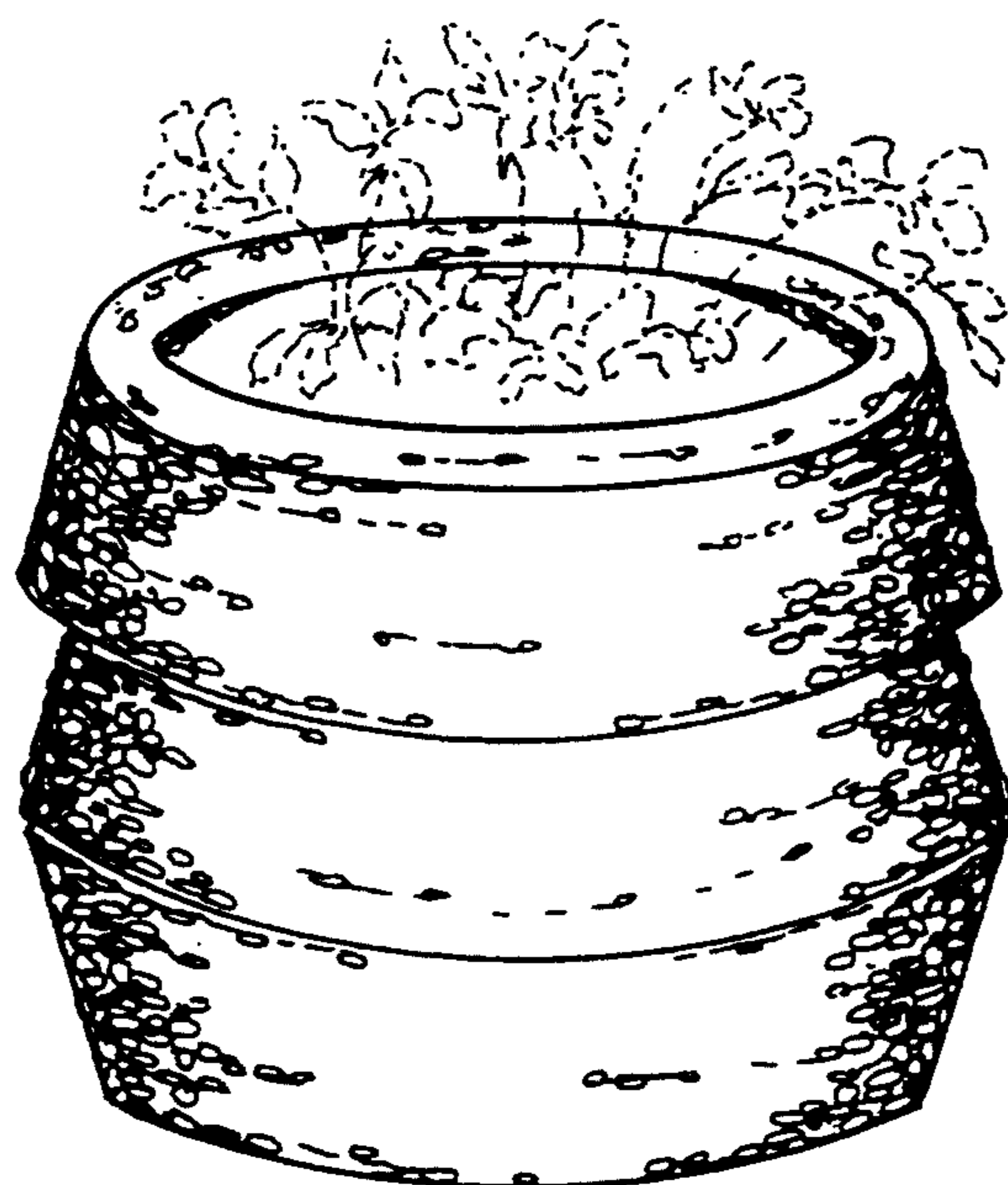

[57] CLAIM

The ornamental design for a planter, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a planter showing my new design, the right and left side and rear views (not shown) being identical thereto; FIG. 2 is a top plan view, the bottom plan (not shown) being identical thereto; and, FIG. 3 is a perspective view. The broken lines of FIG. 3 showing arrangements of flowers and plants, and soil, are for illustrative purposes only and form no part of the claimed design.



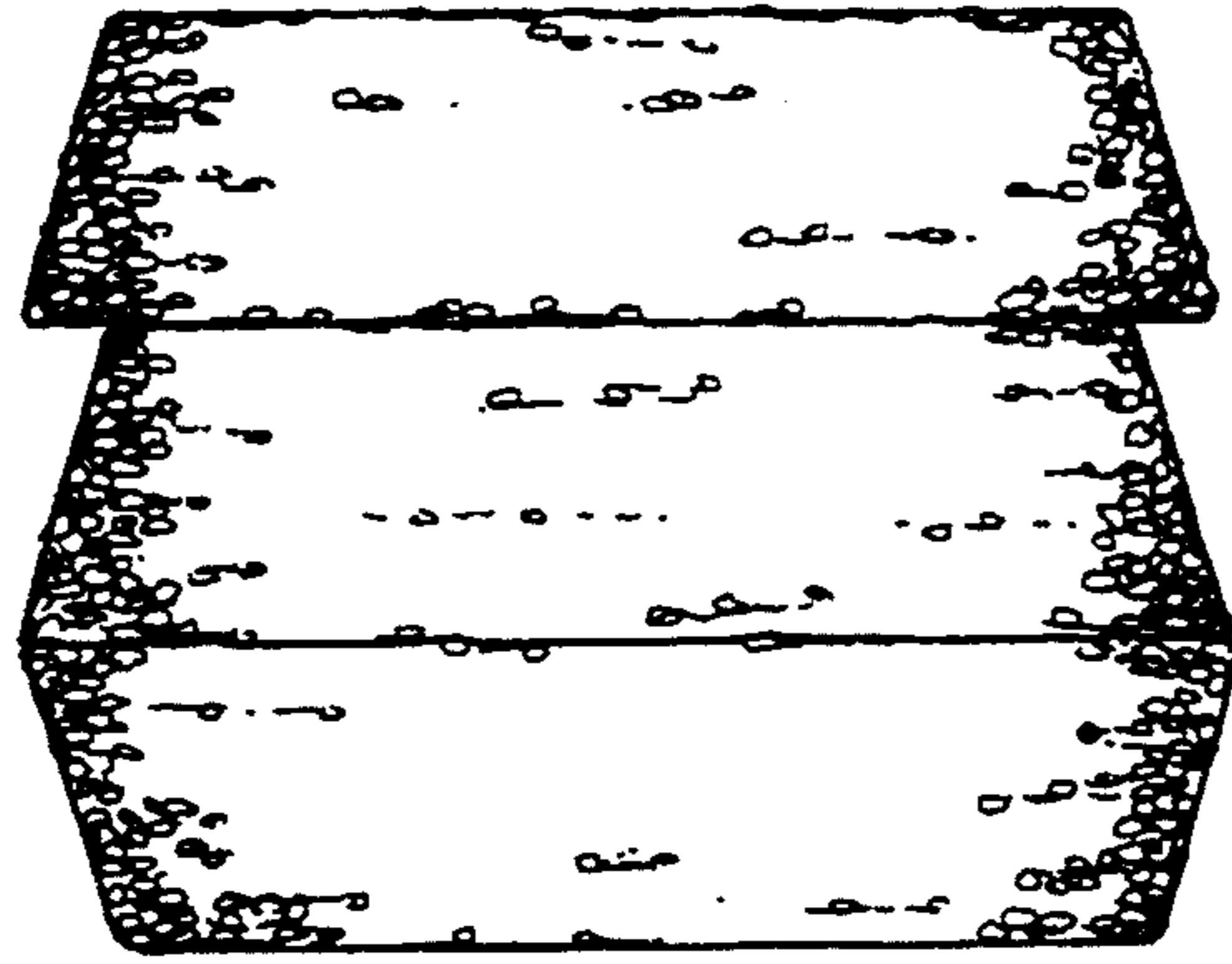

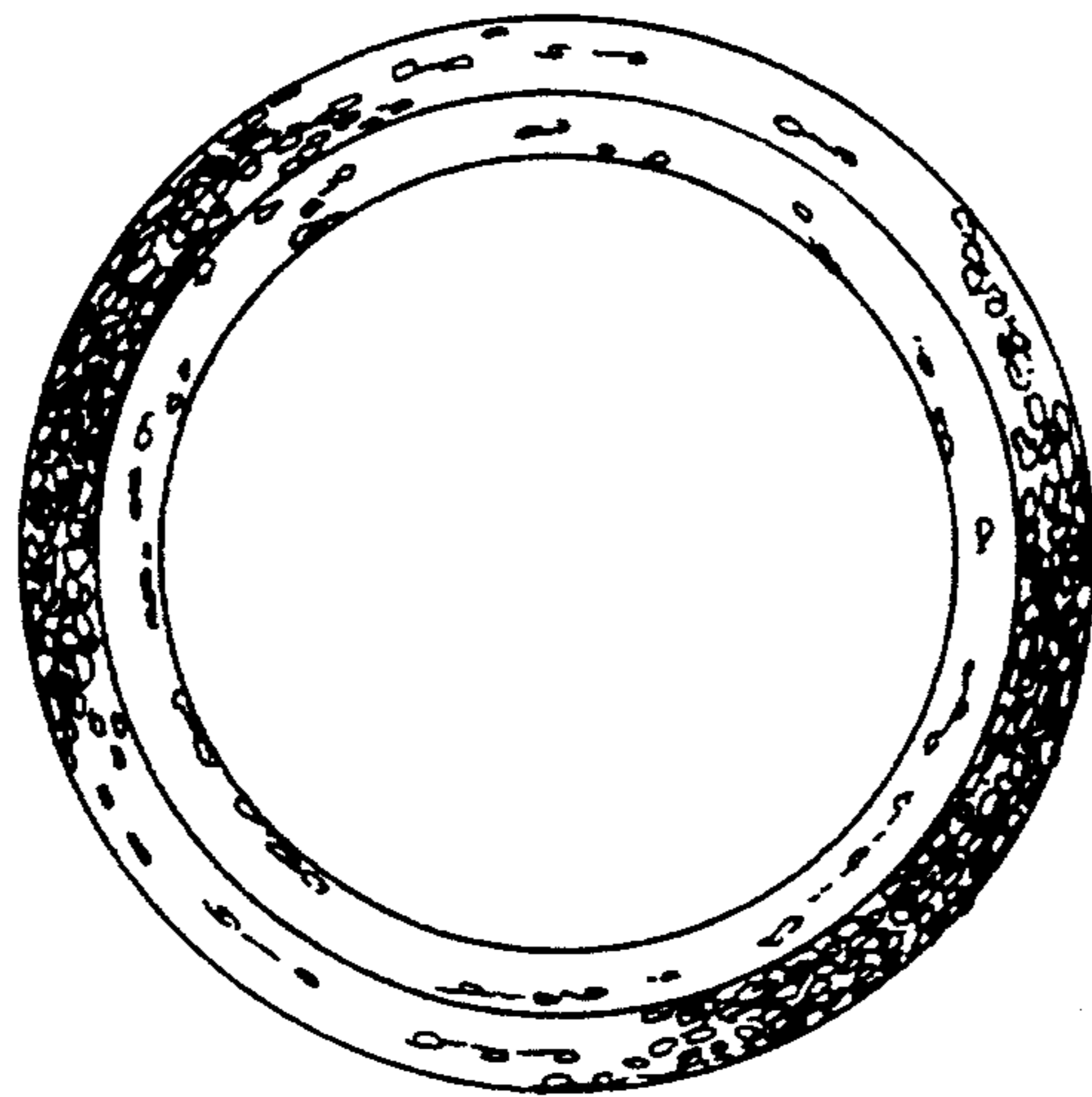

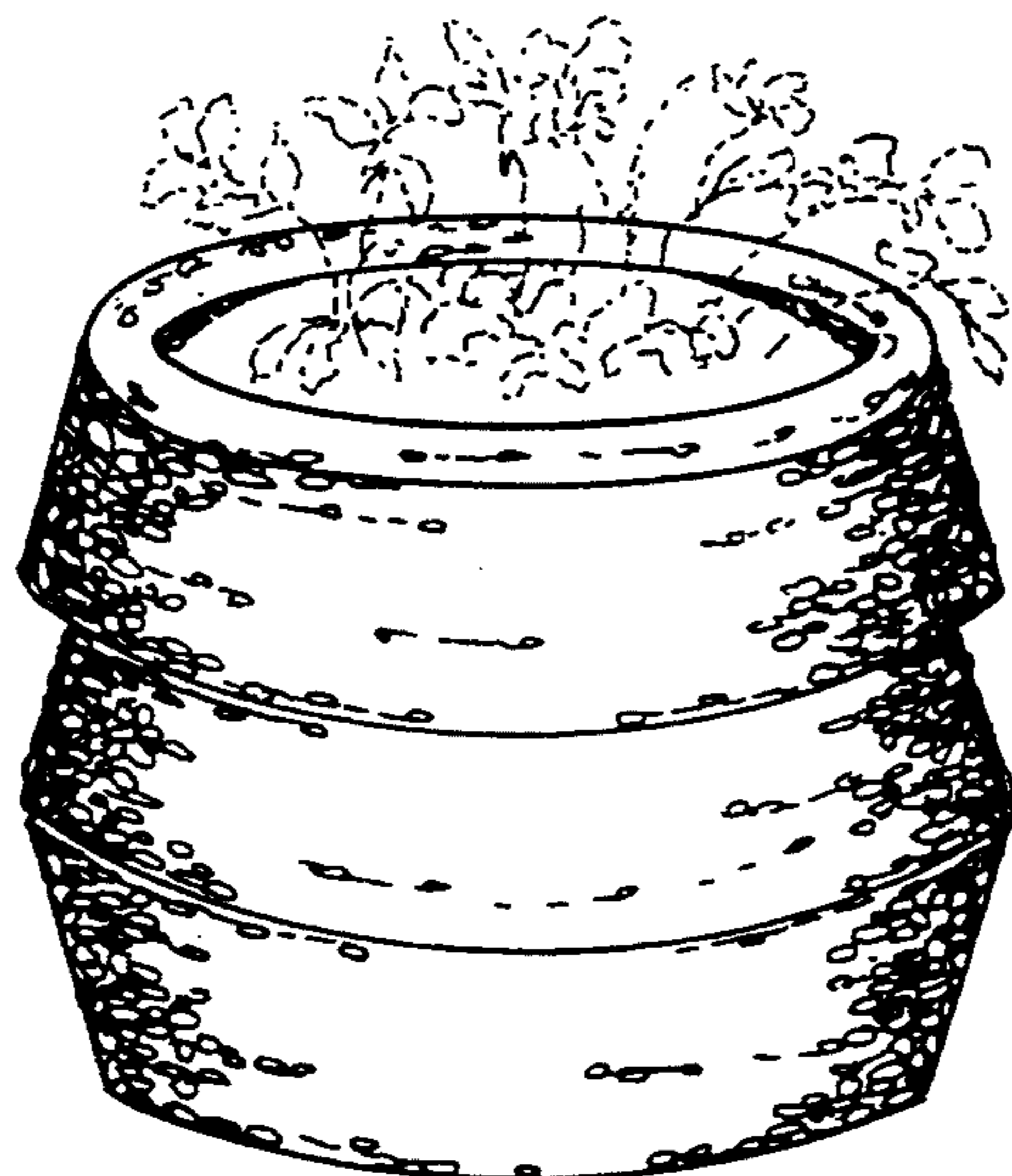
