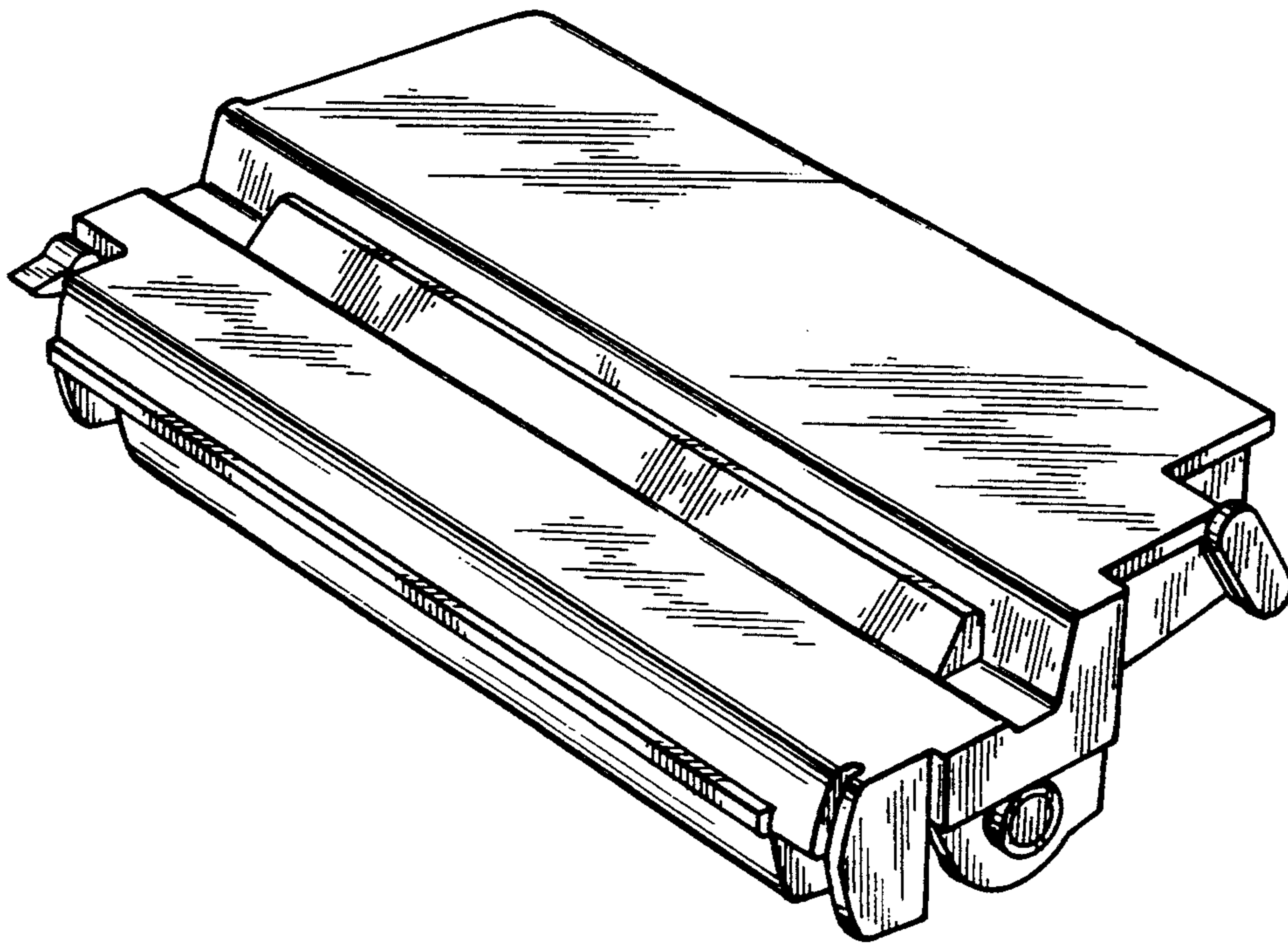

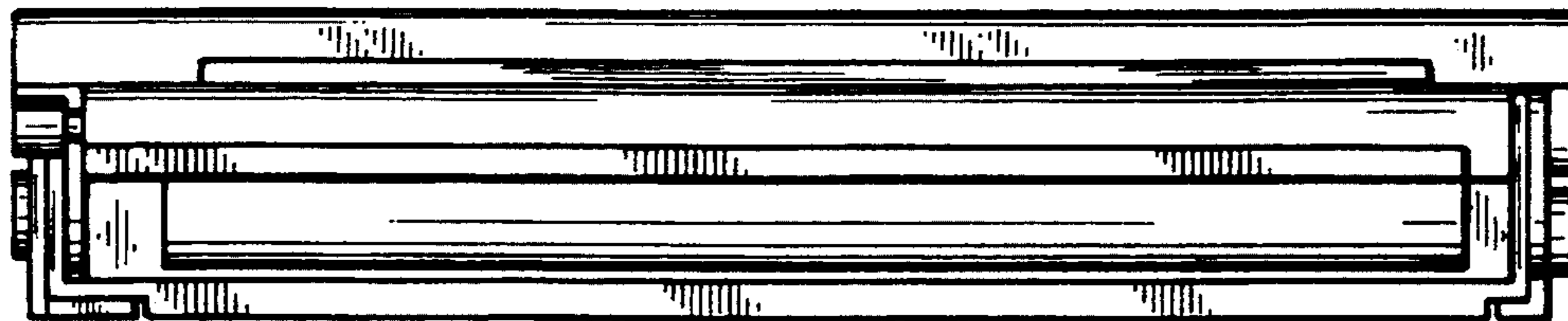
The ornamental design for a developing device for copying machine, as shown and described.

**DESCRIPTION**

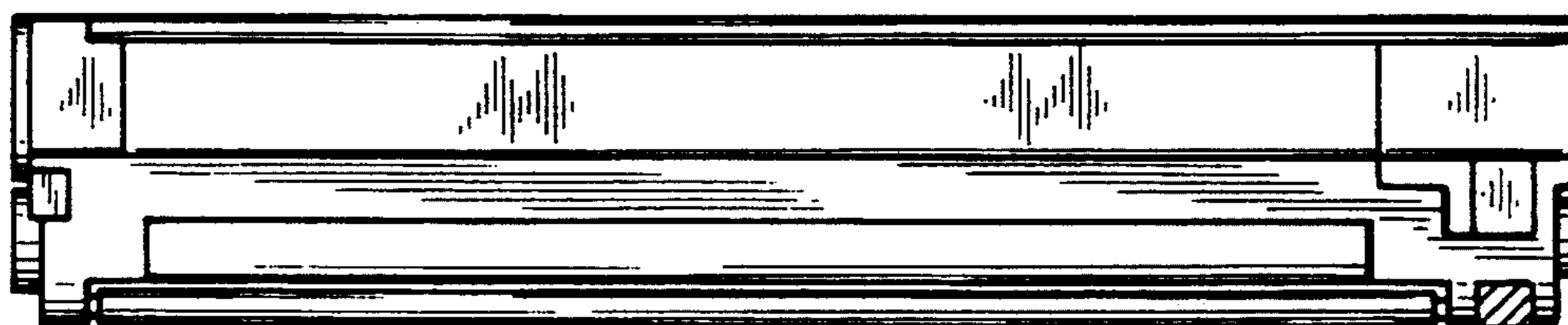

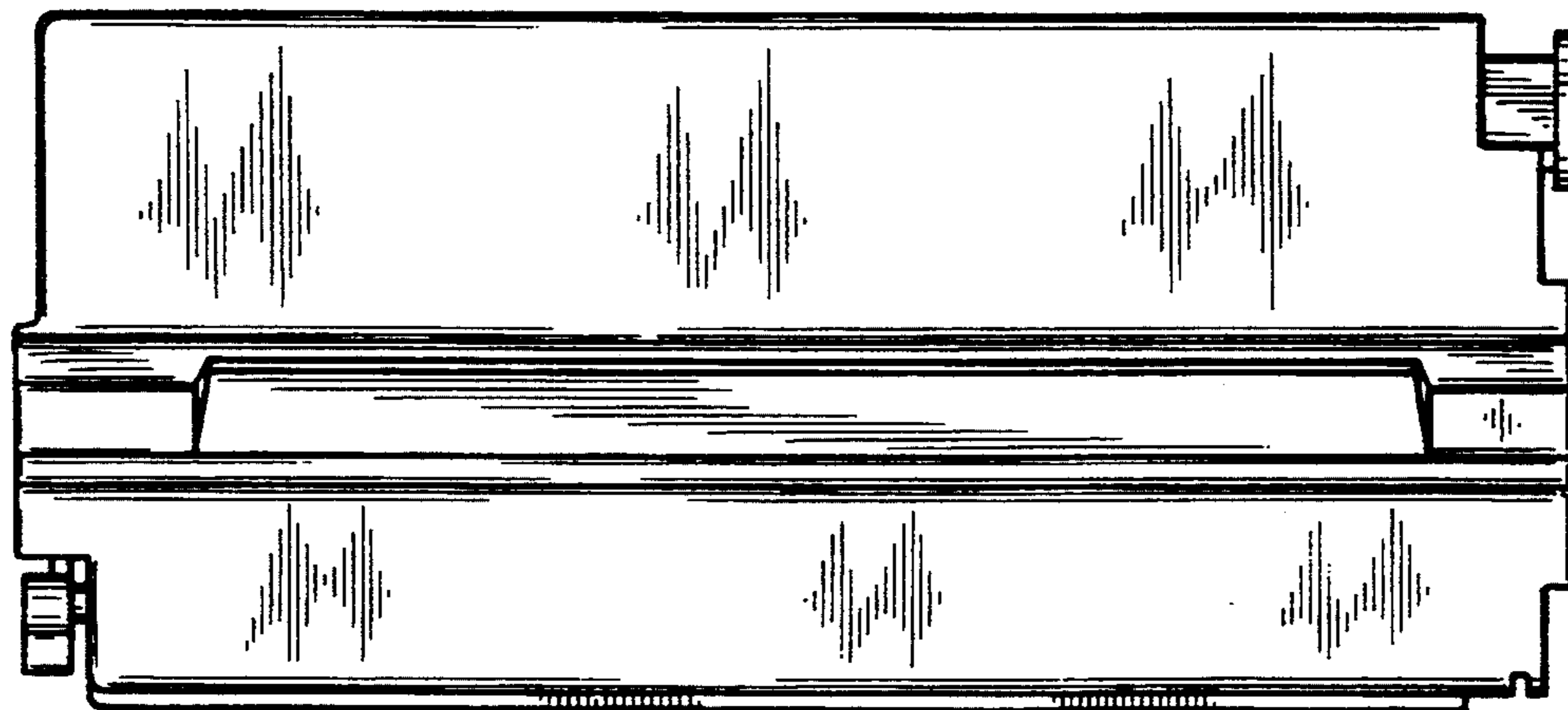

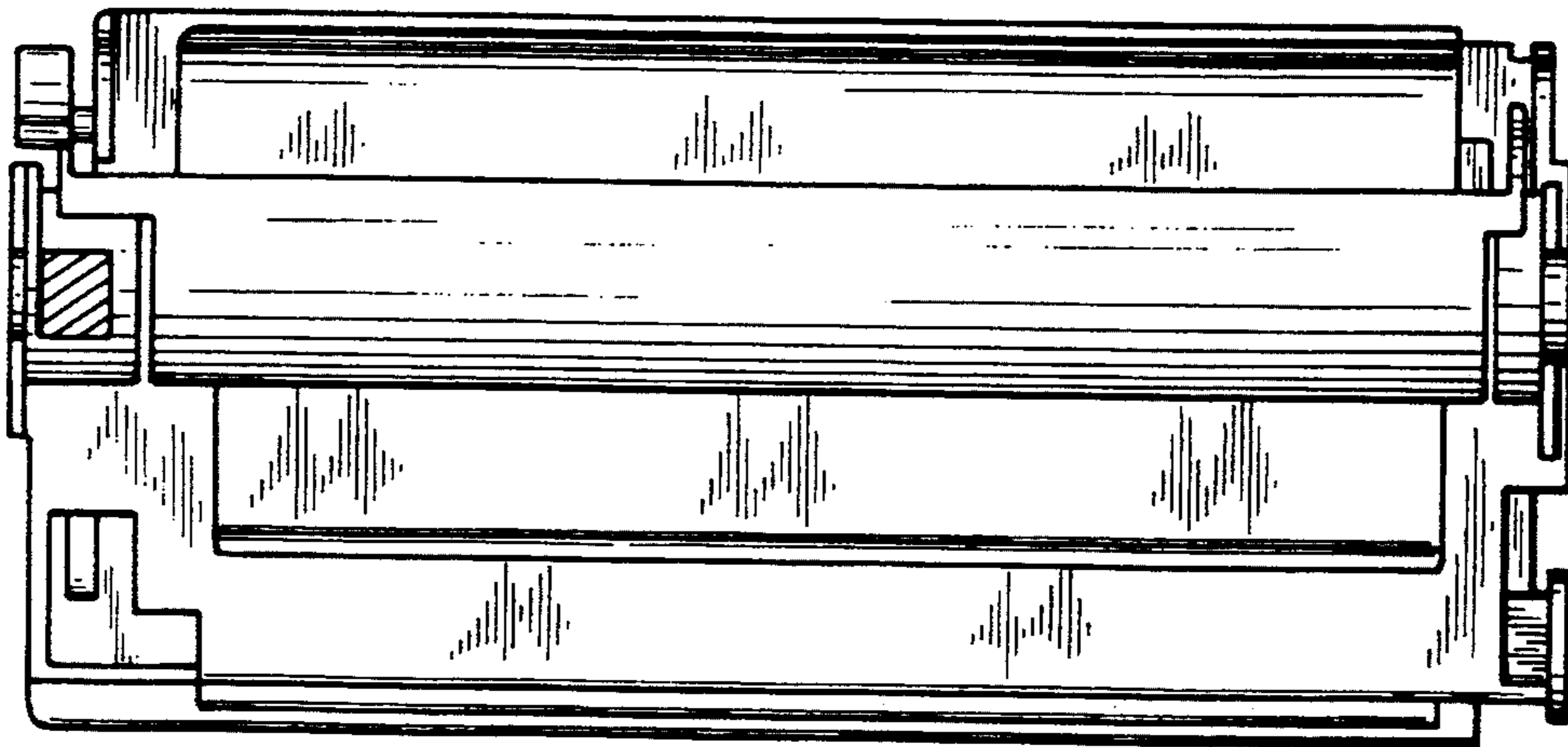

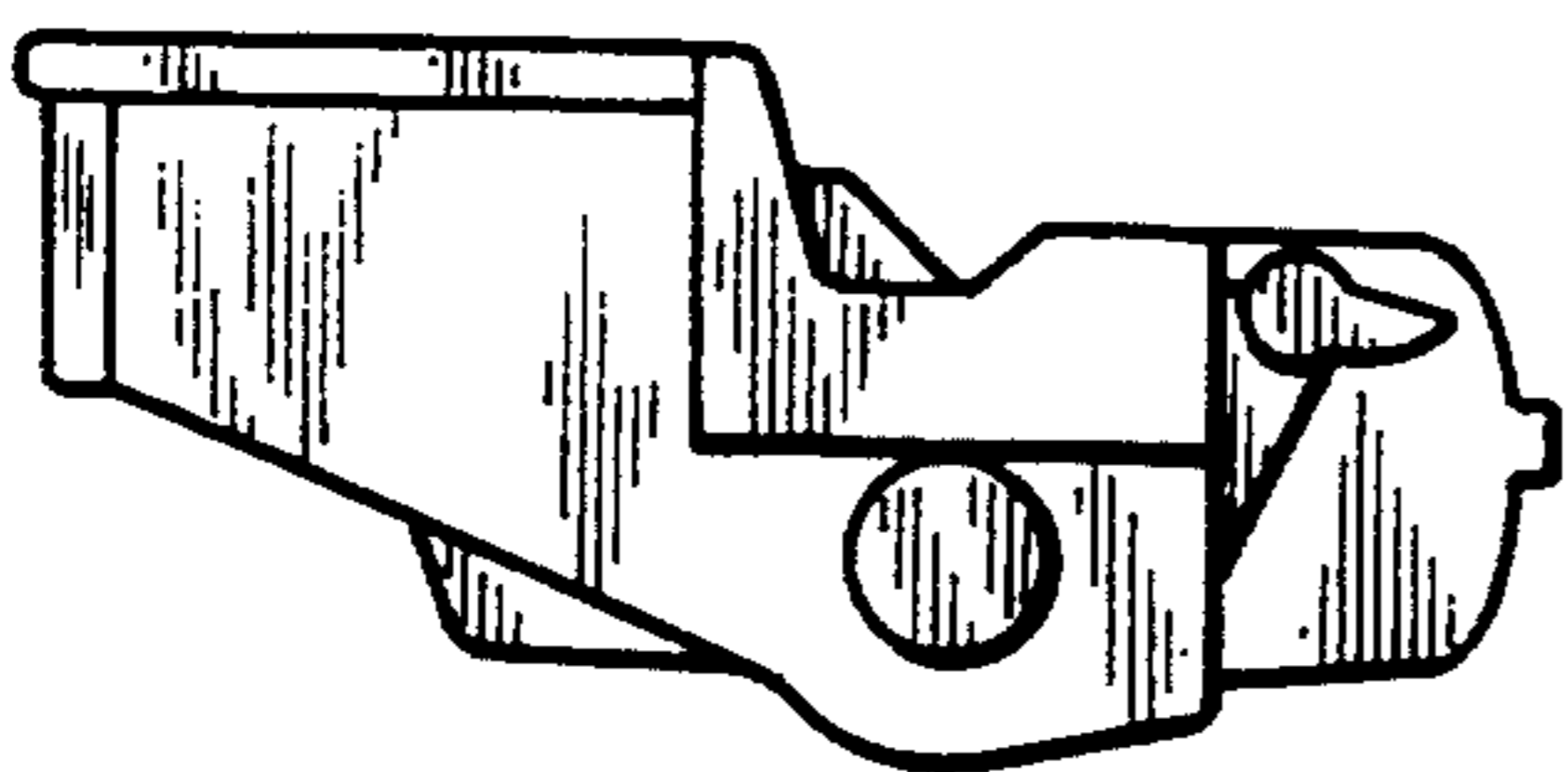

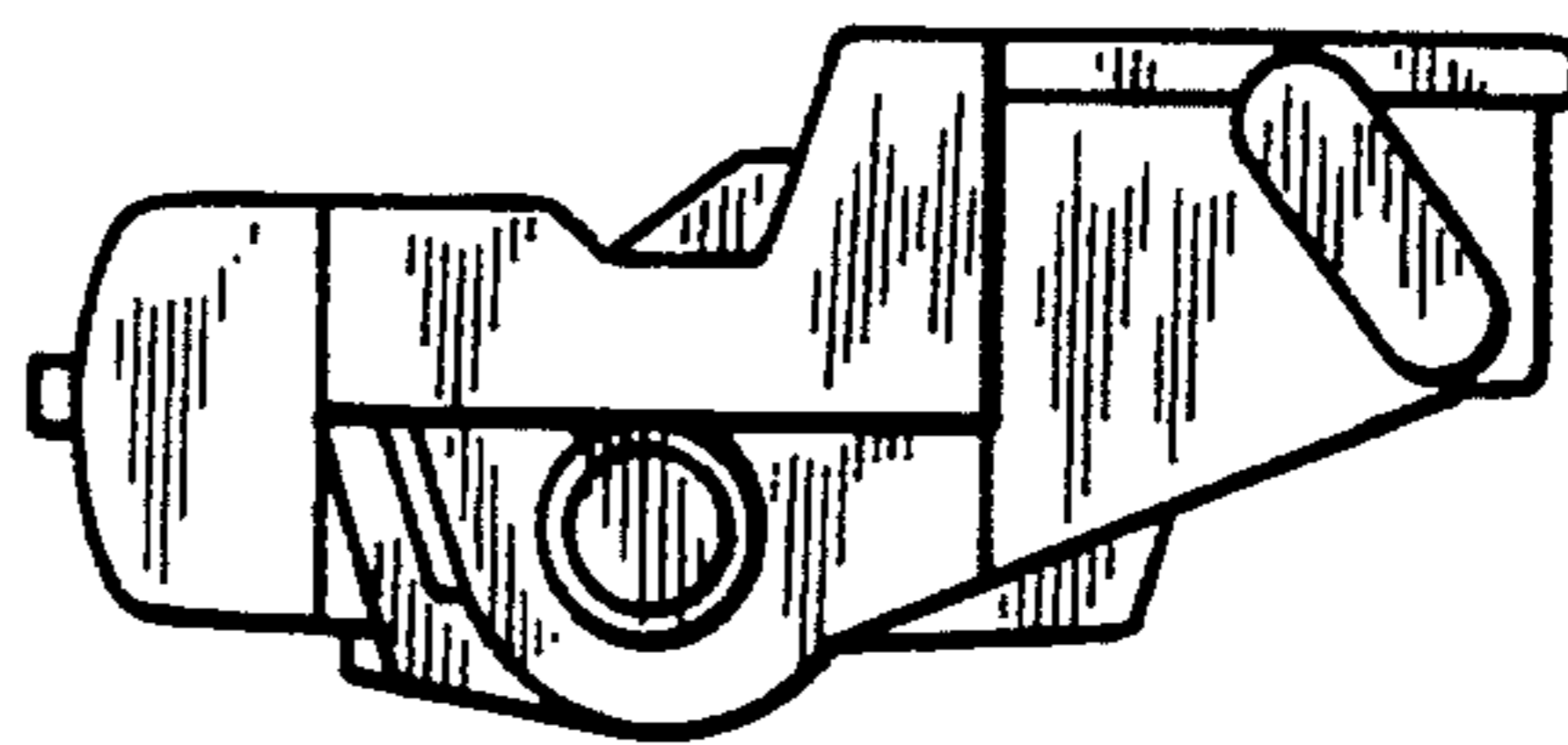
