[57] CLAIM

The ornamental design for combined jump suit and apron, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the jump suit portion of a combined jump suit and apron as shown in FIG. 8;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 8 is perspective view of a combined jump suit and apron showing my new design;

FIG. 9 is a front elevational view of FIG. 8;

FIG. 10 is a rear elevational view of FIG. 8;

FIG. 14 is a bottom plan view of FIG. 8.

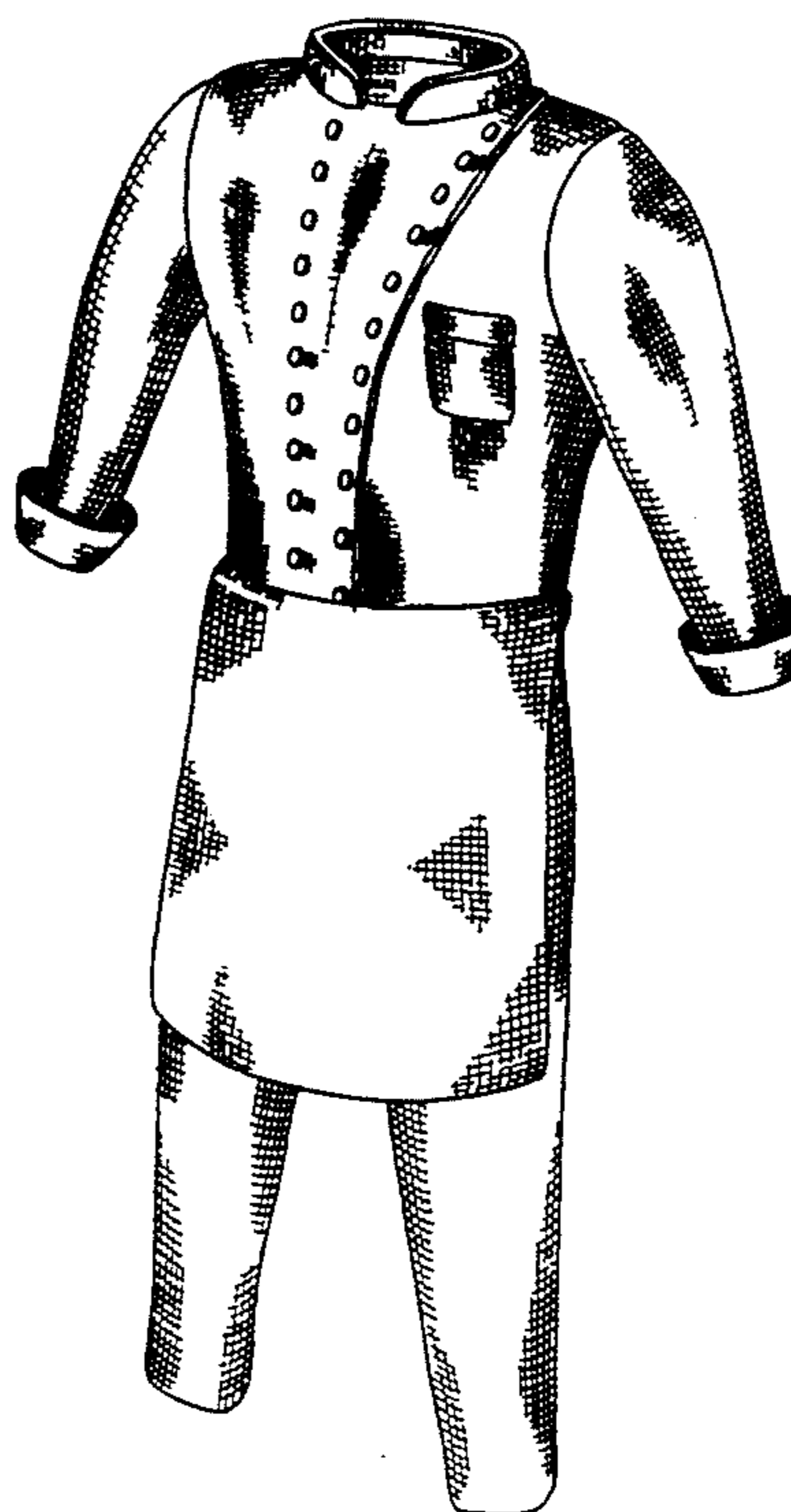
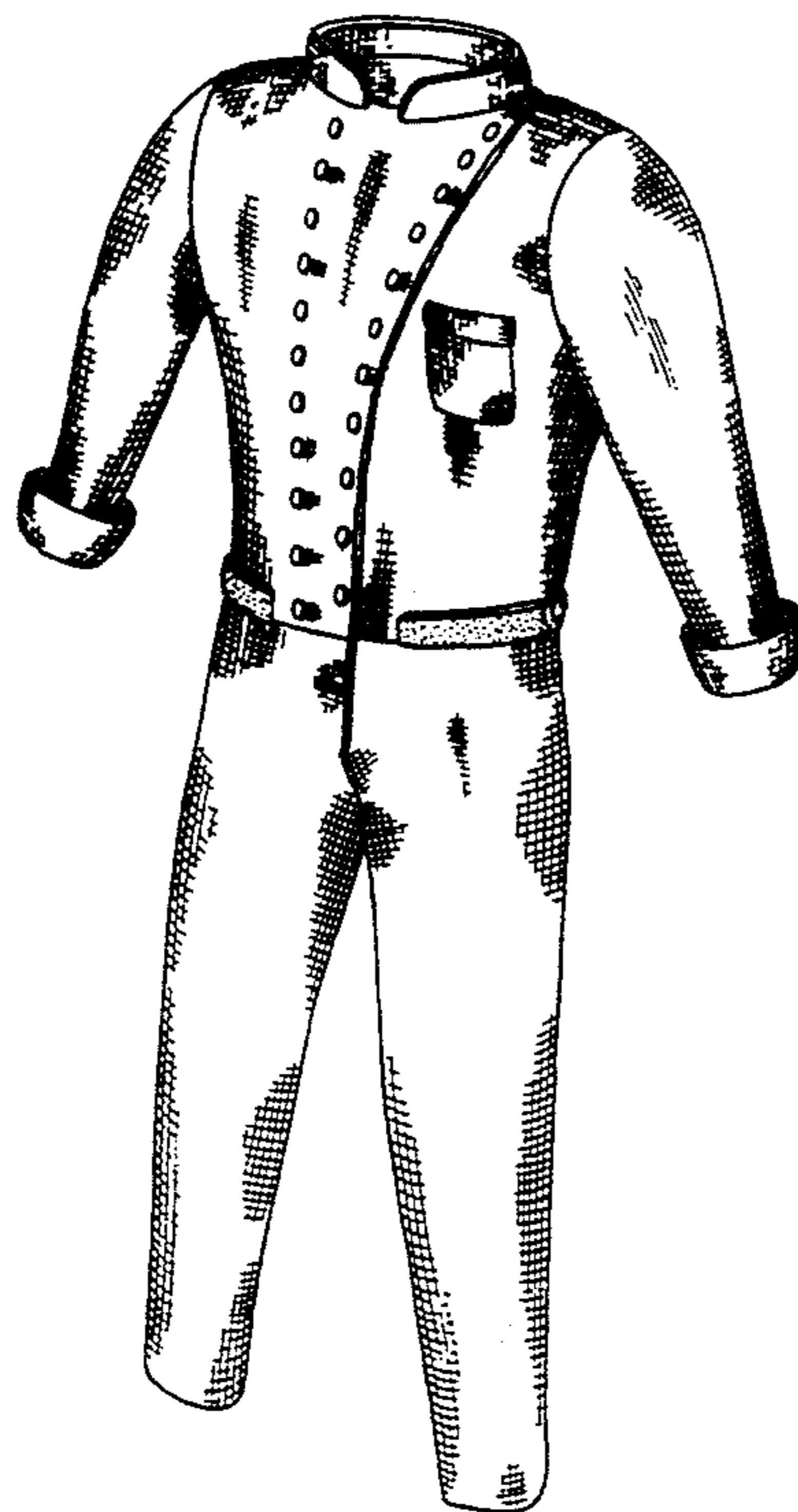

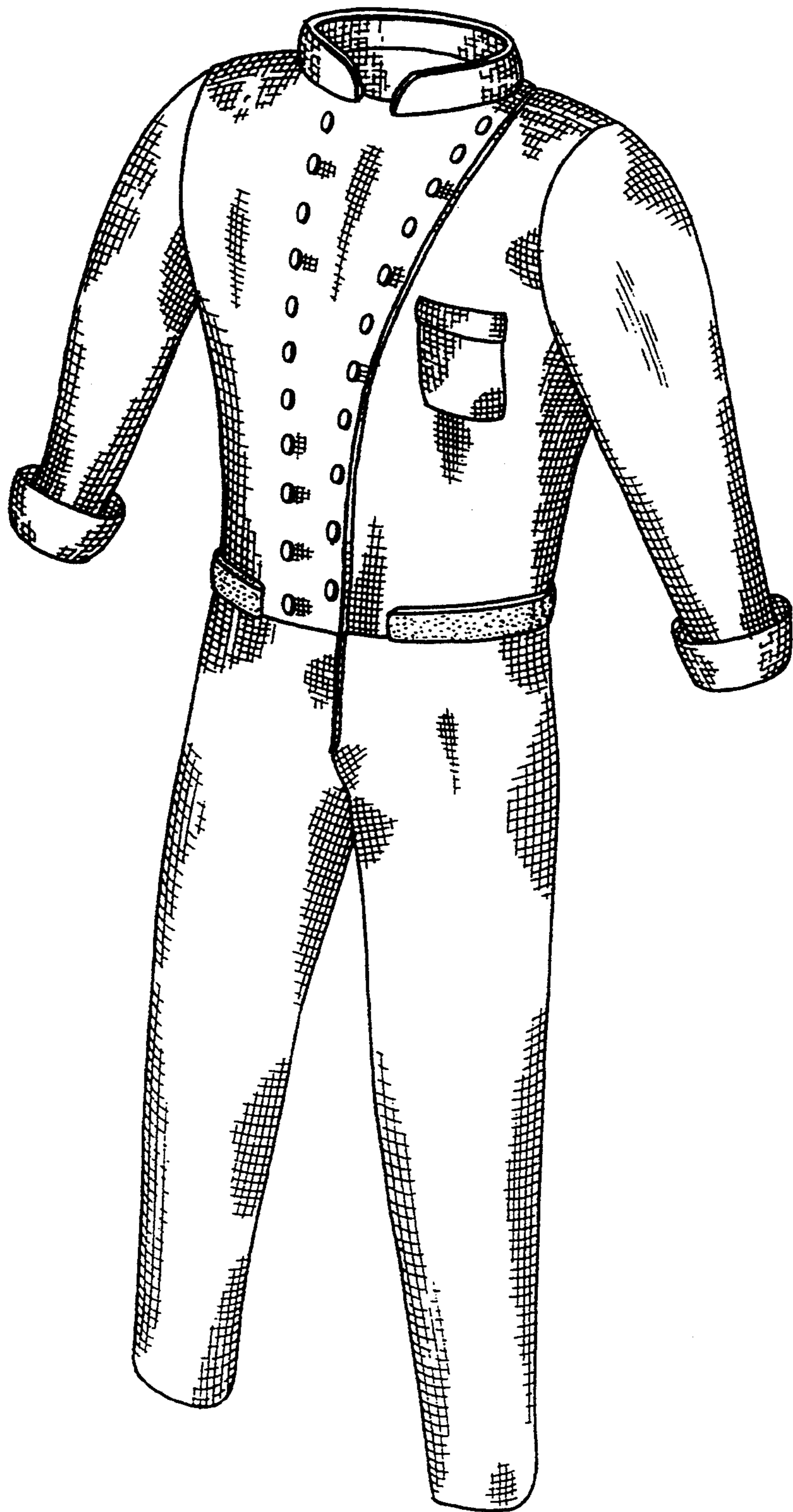

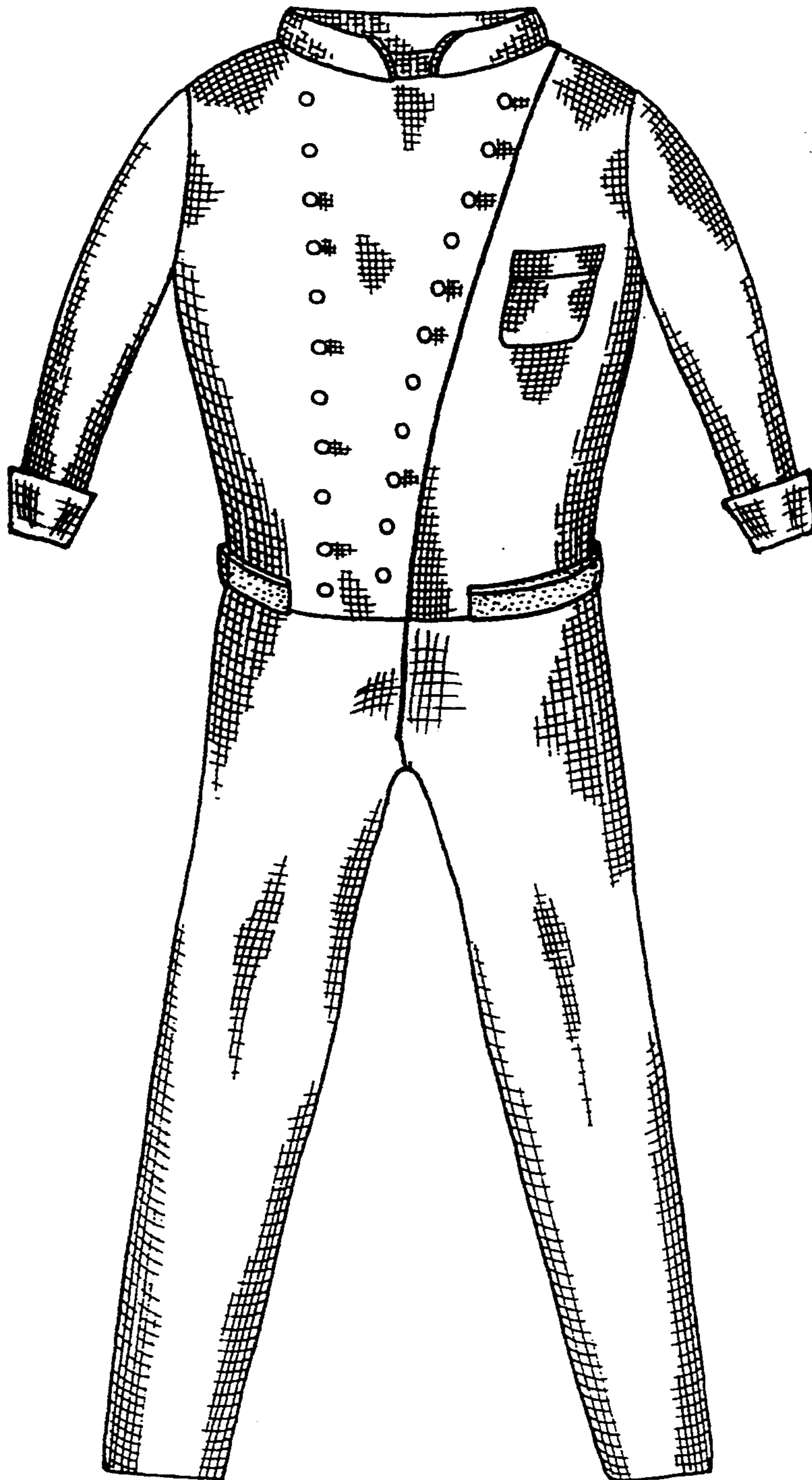

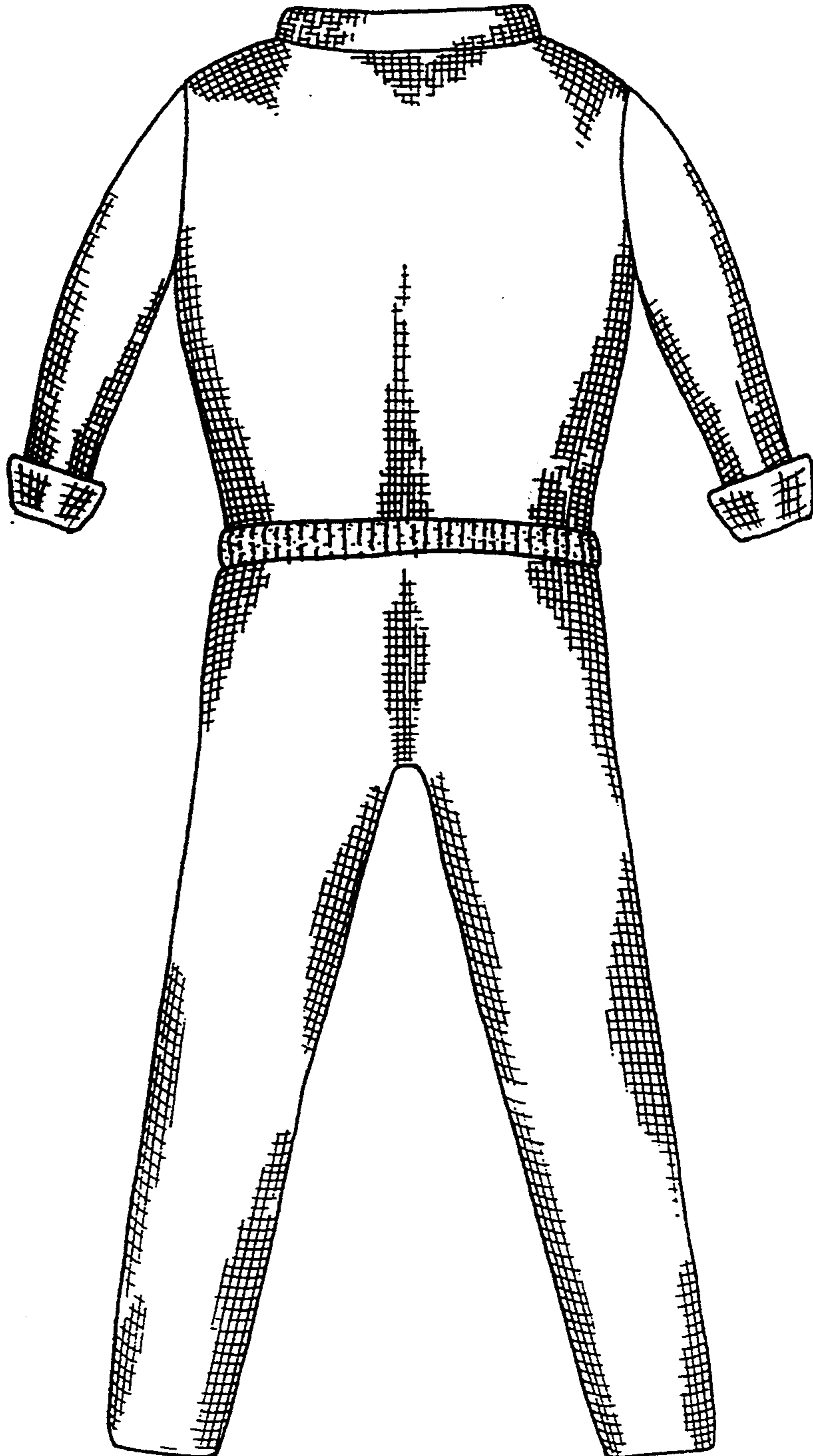

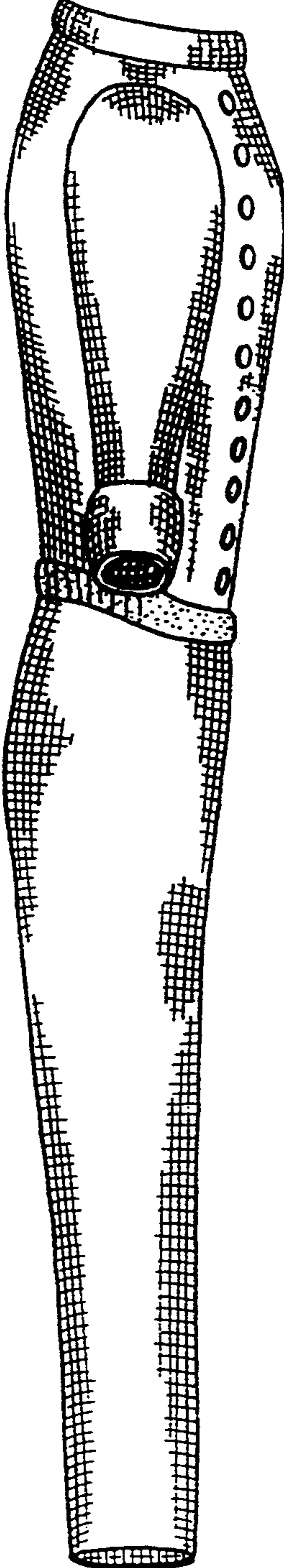

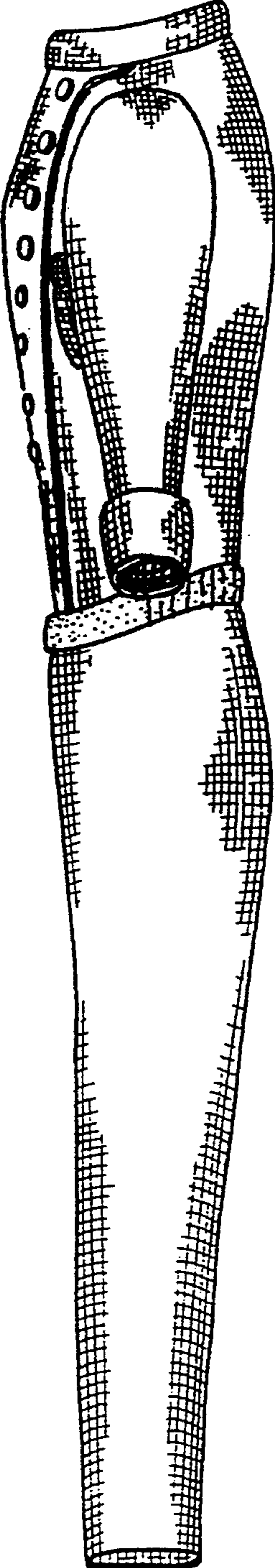

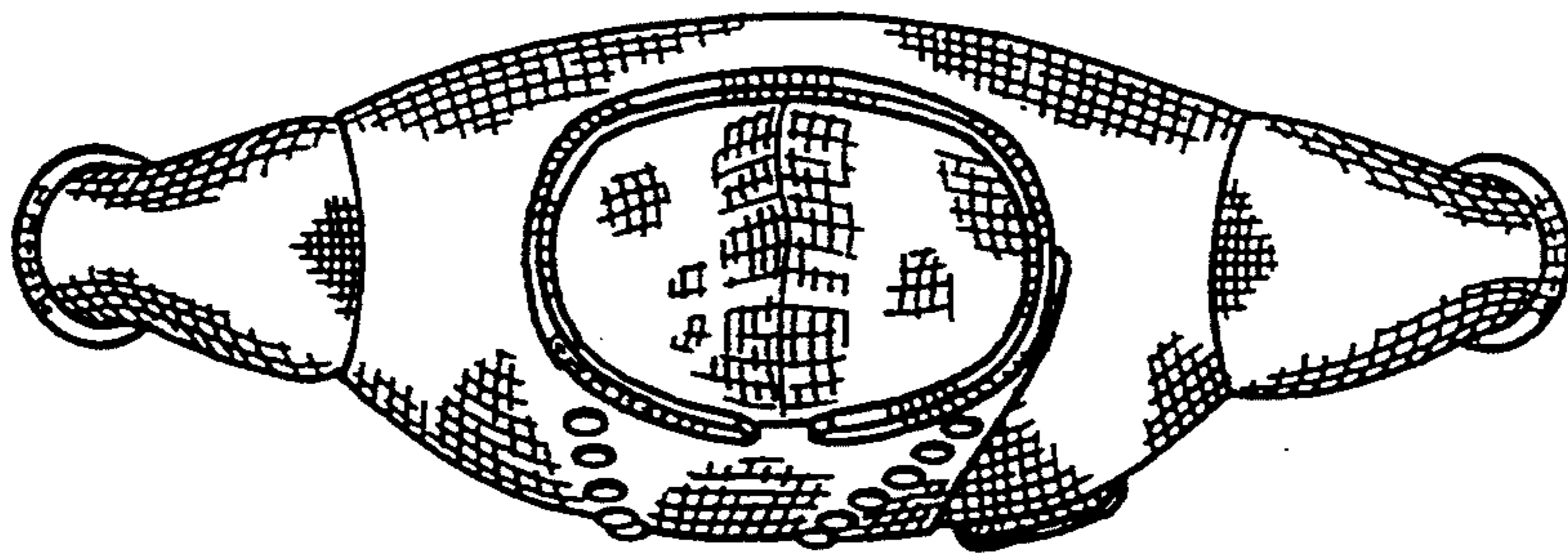

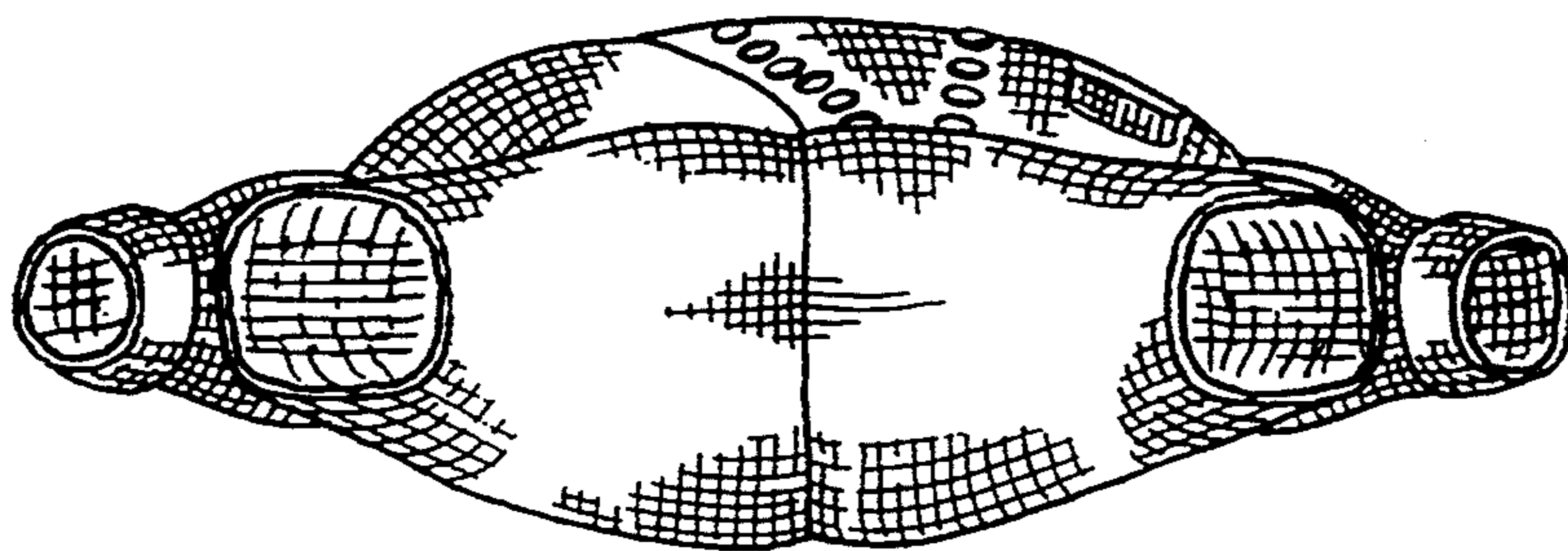

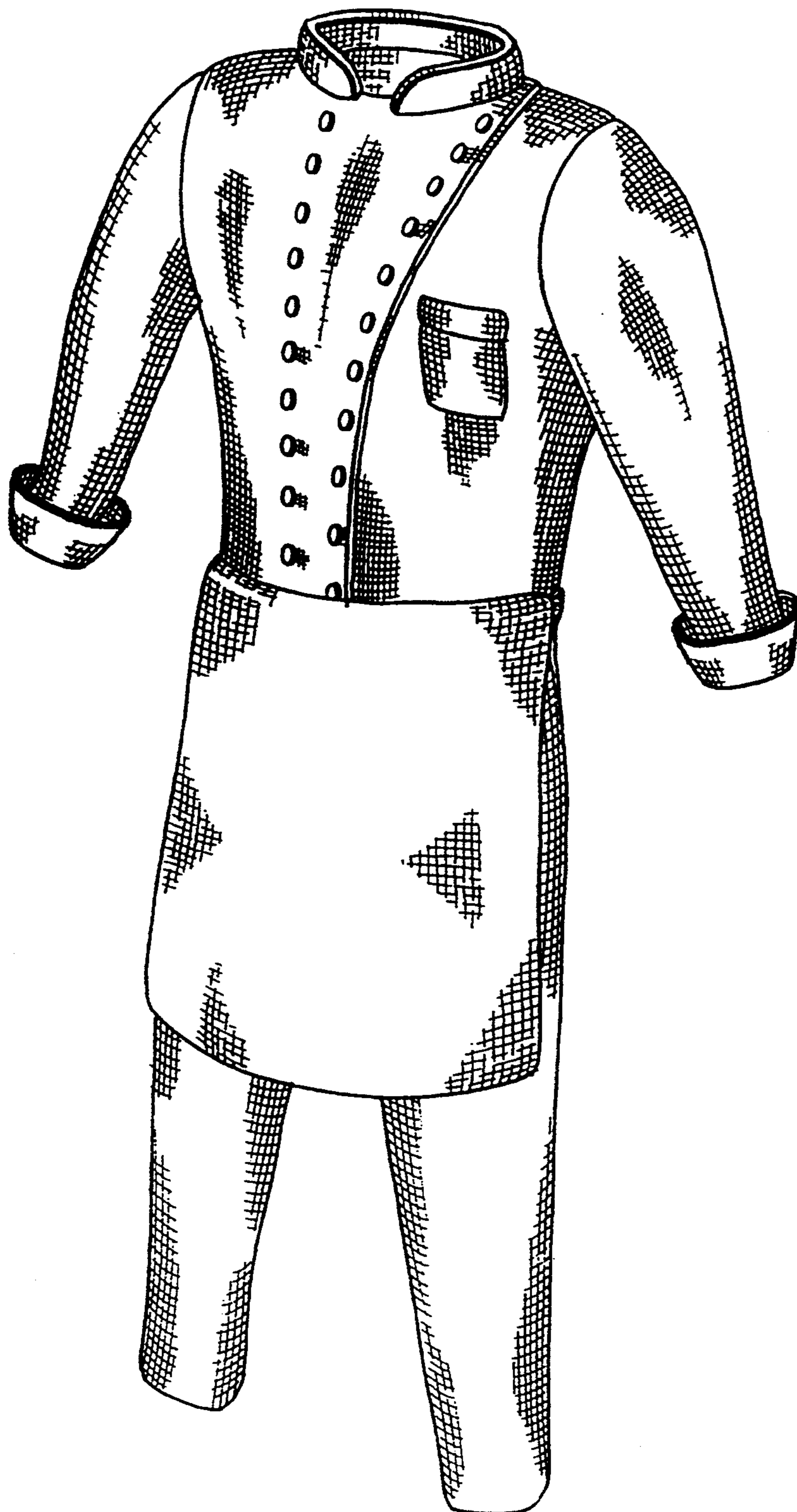

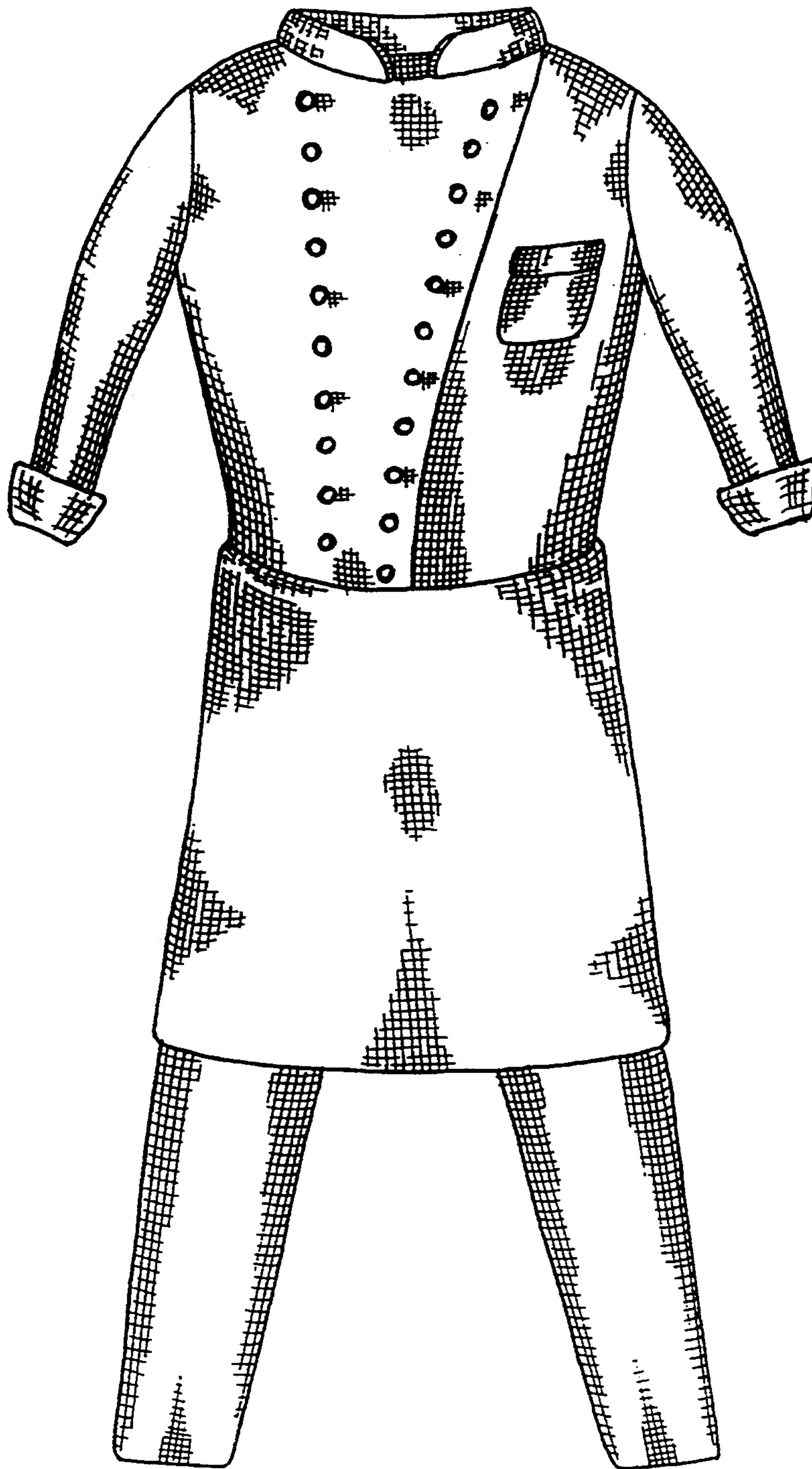

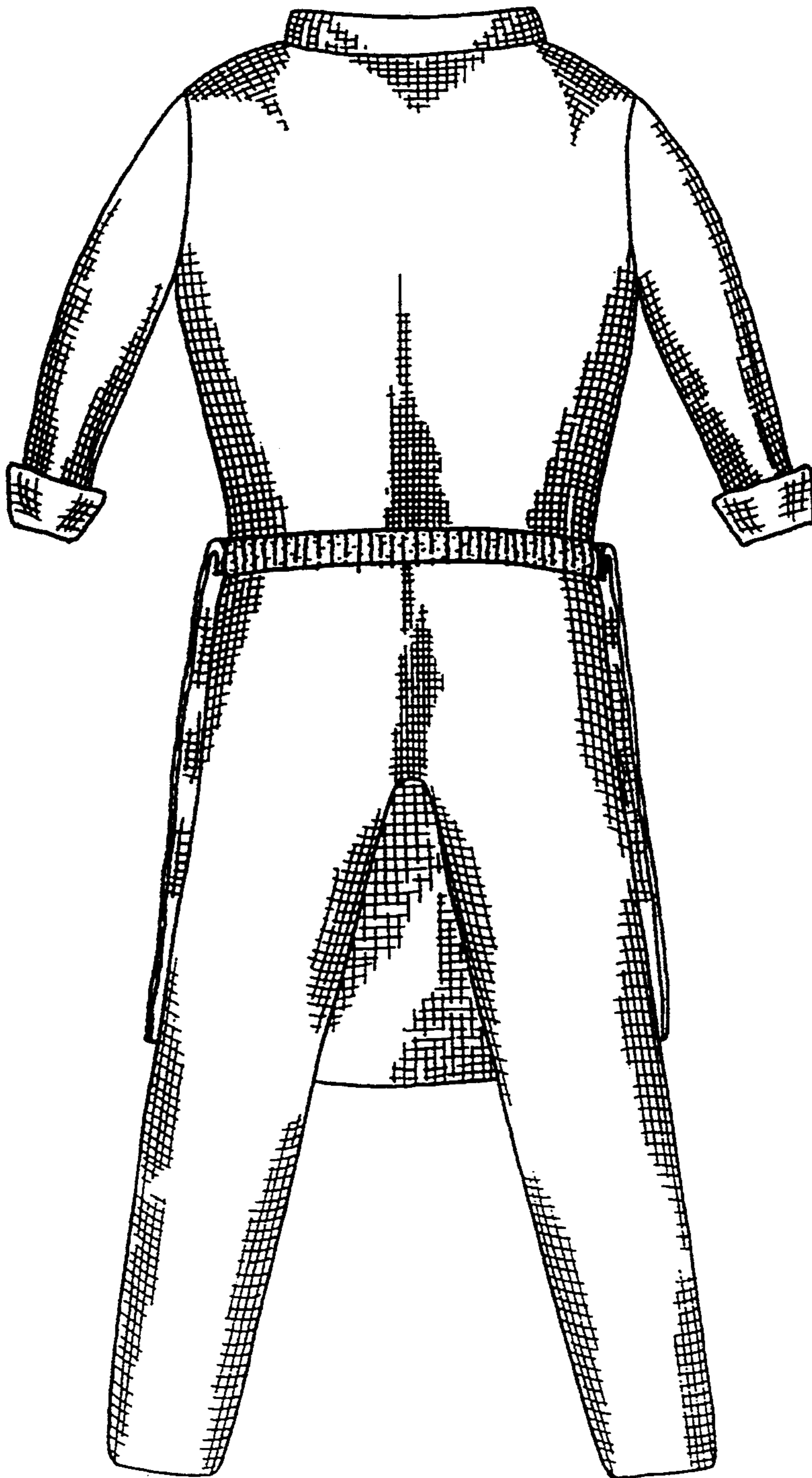

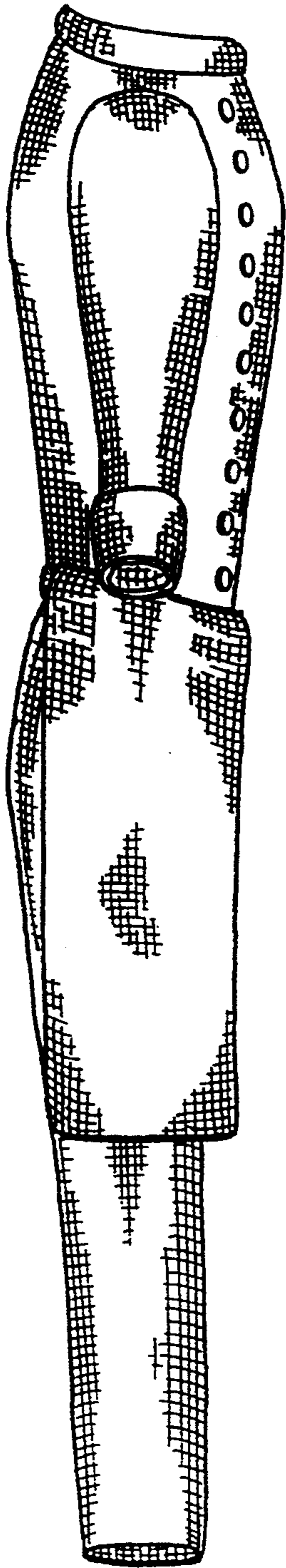

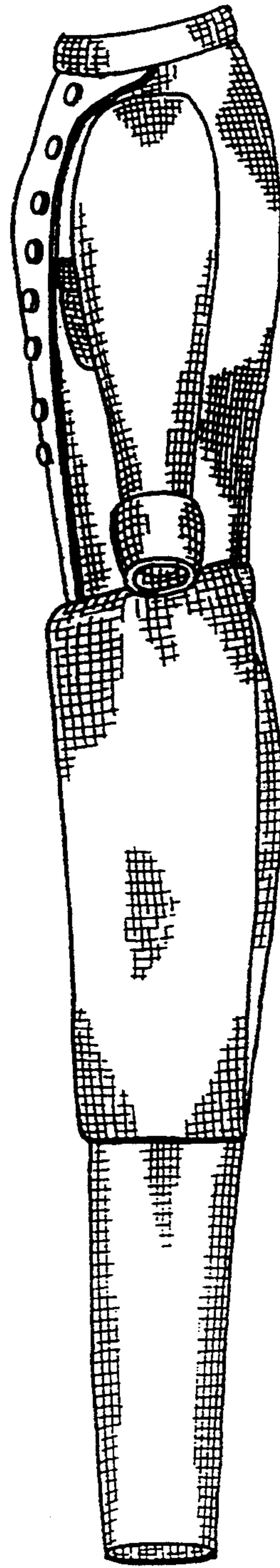

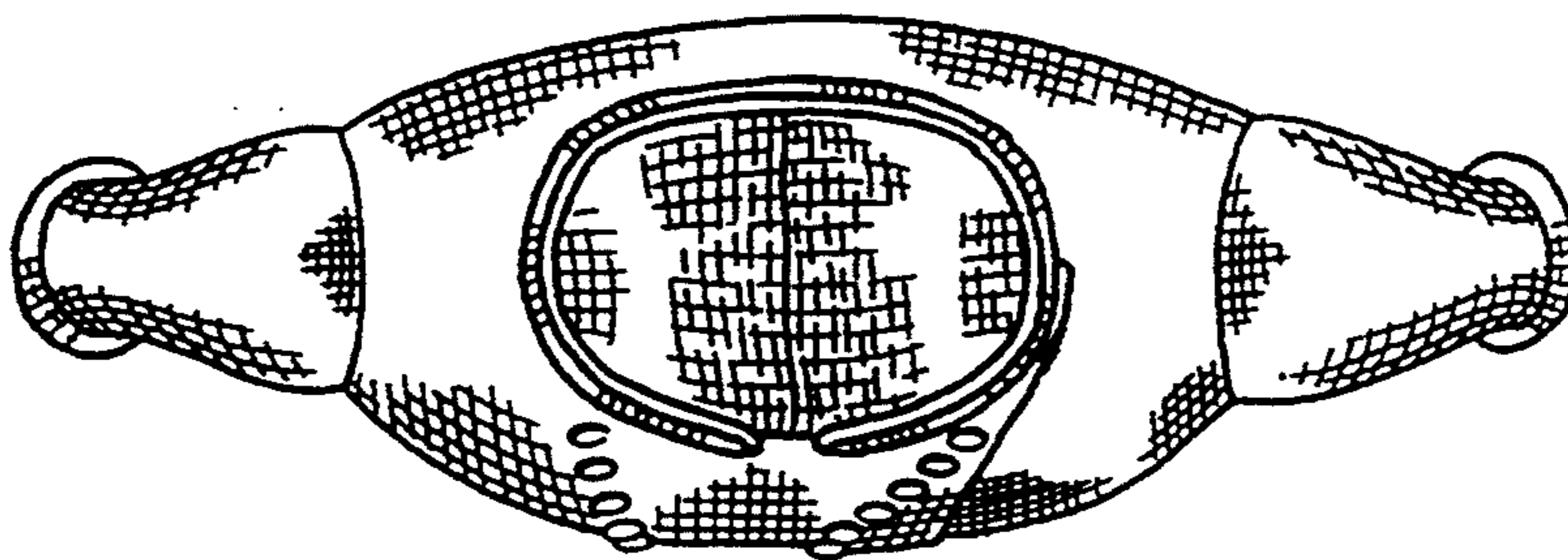
