FIG. 9 is a bottom plan view thereof.

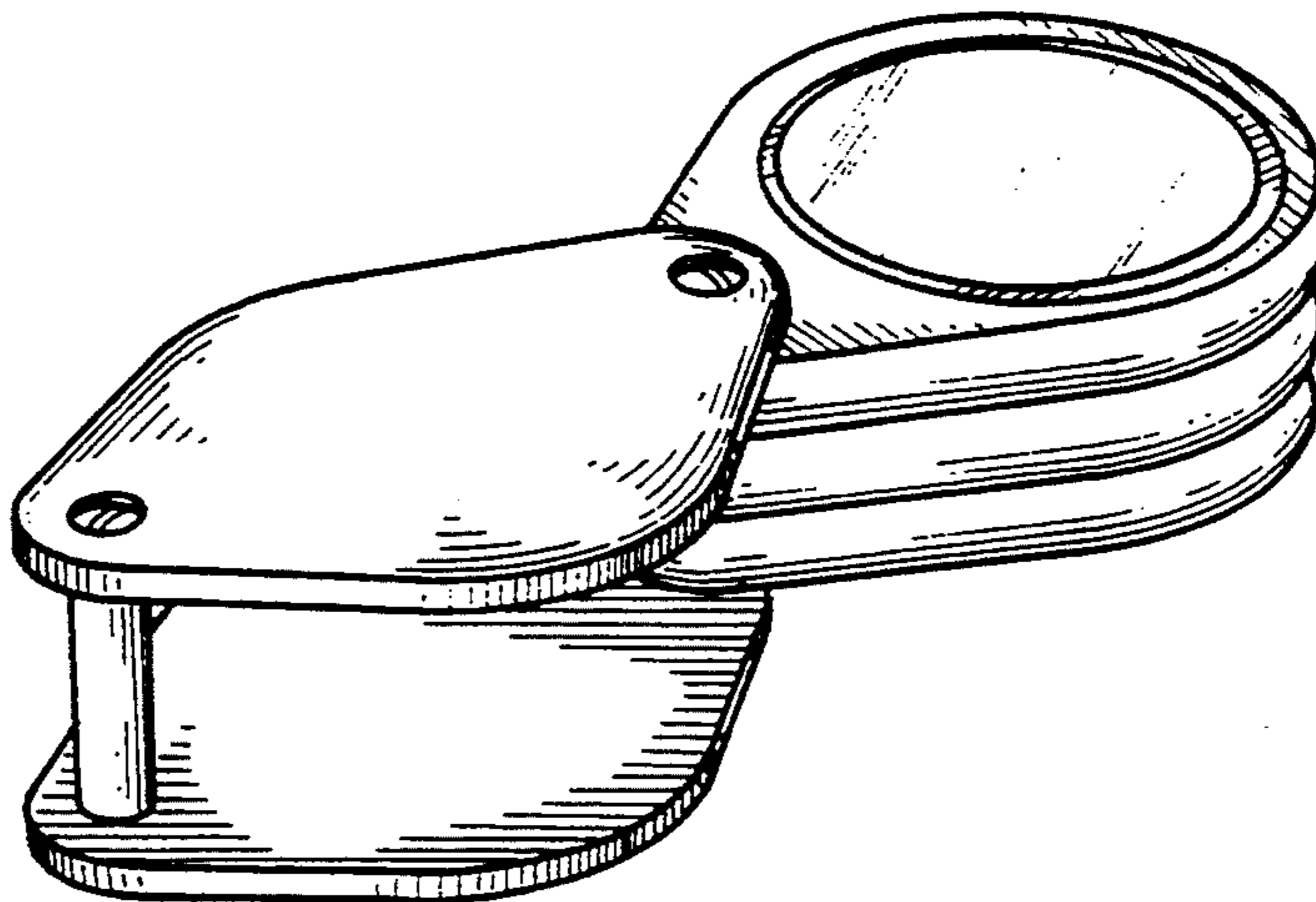
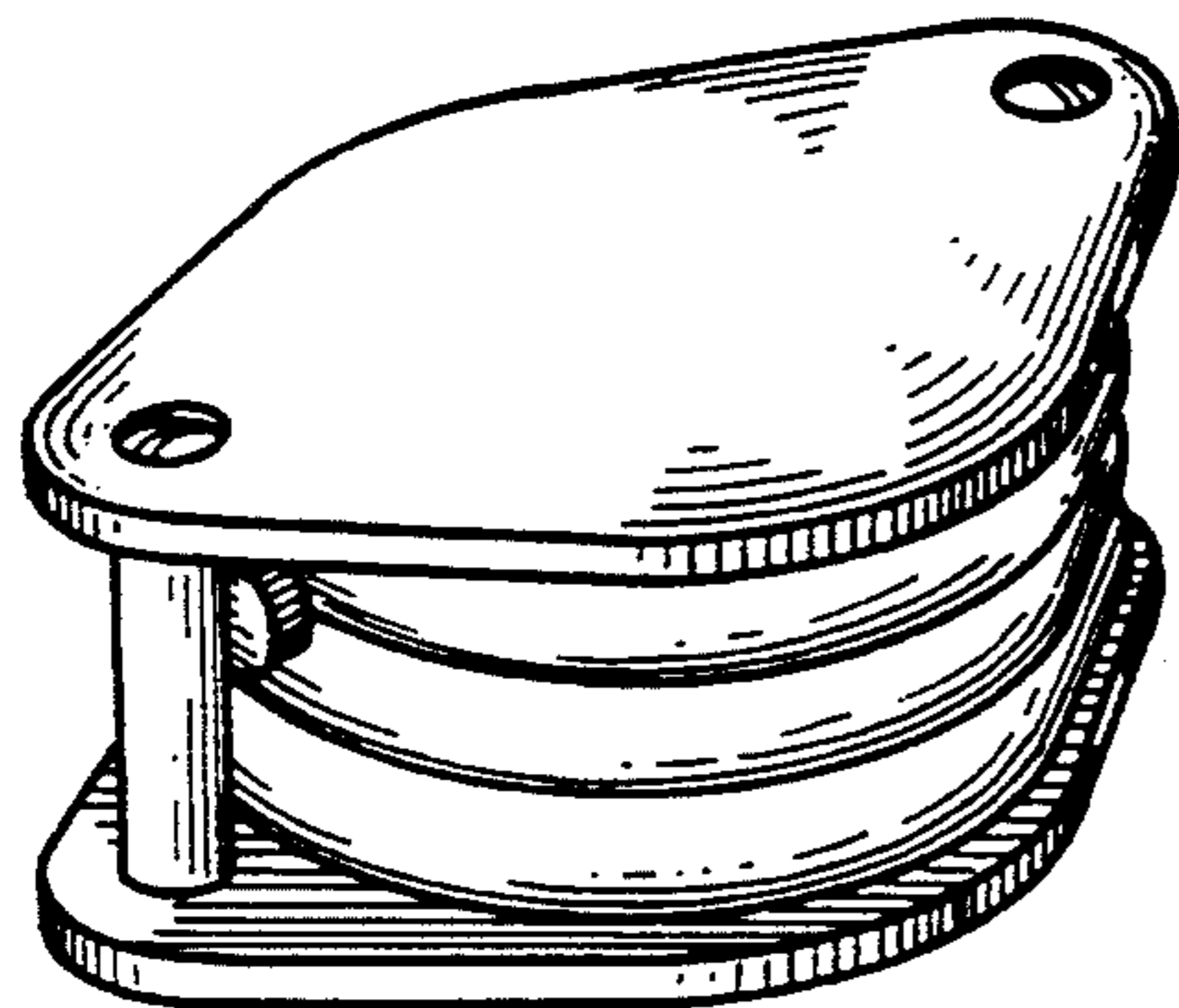

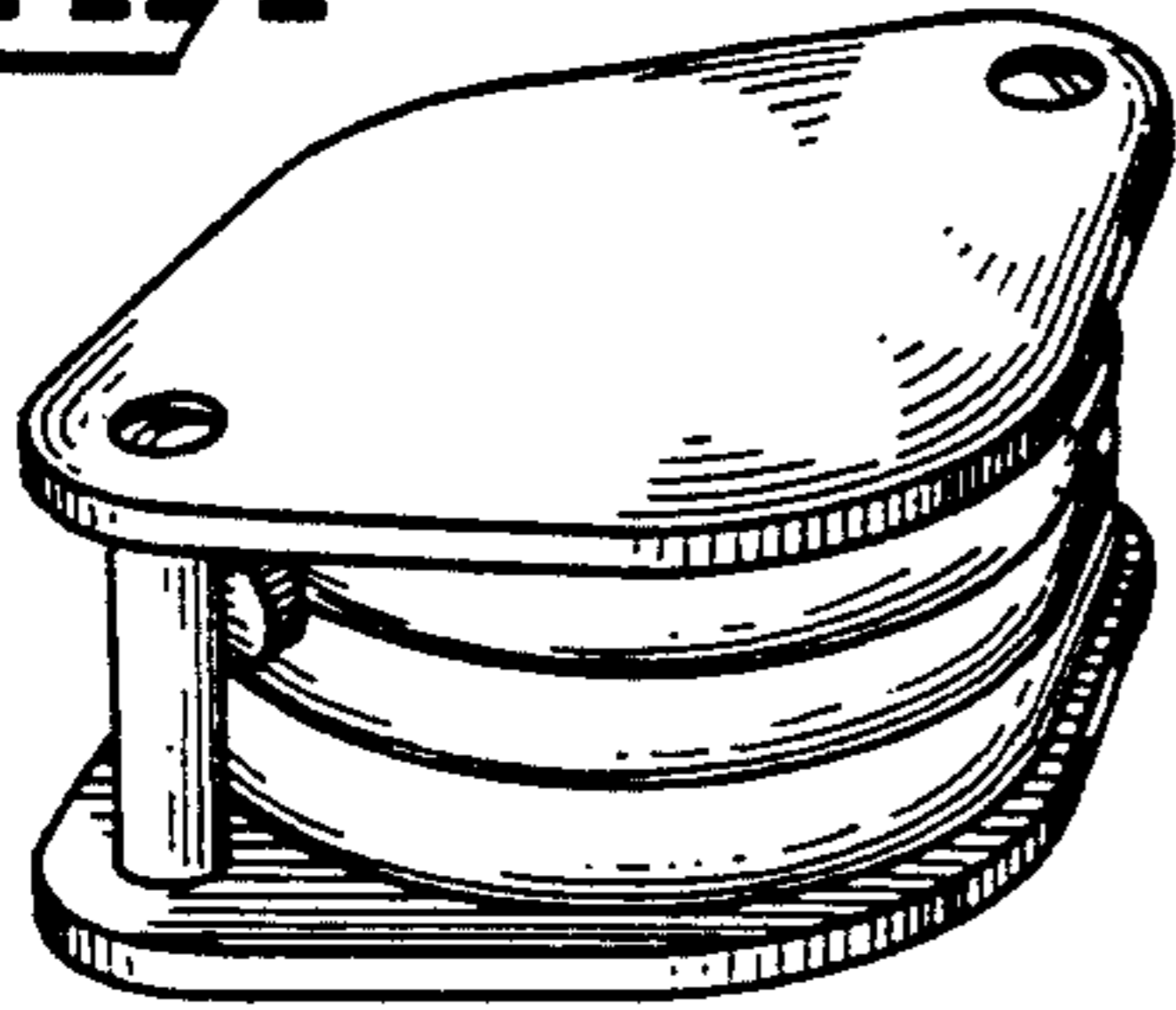

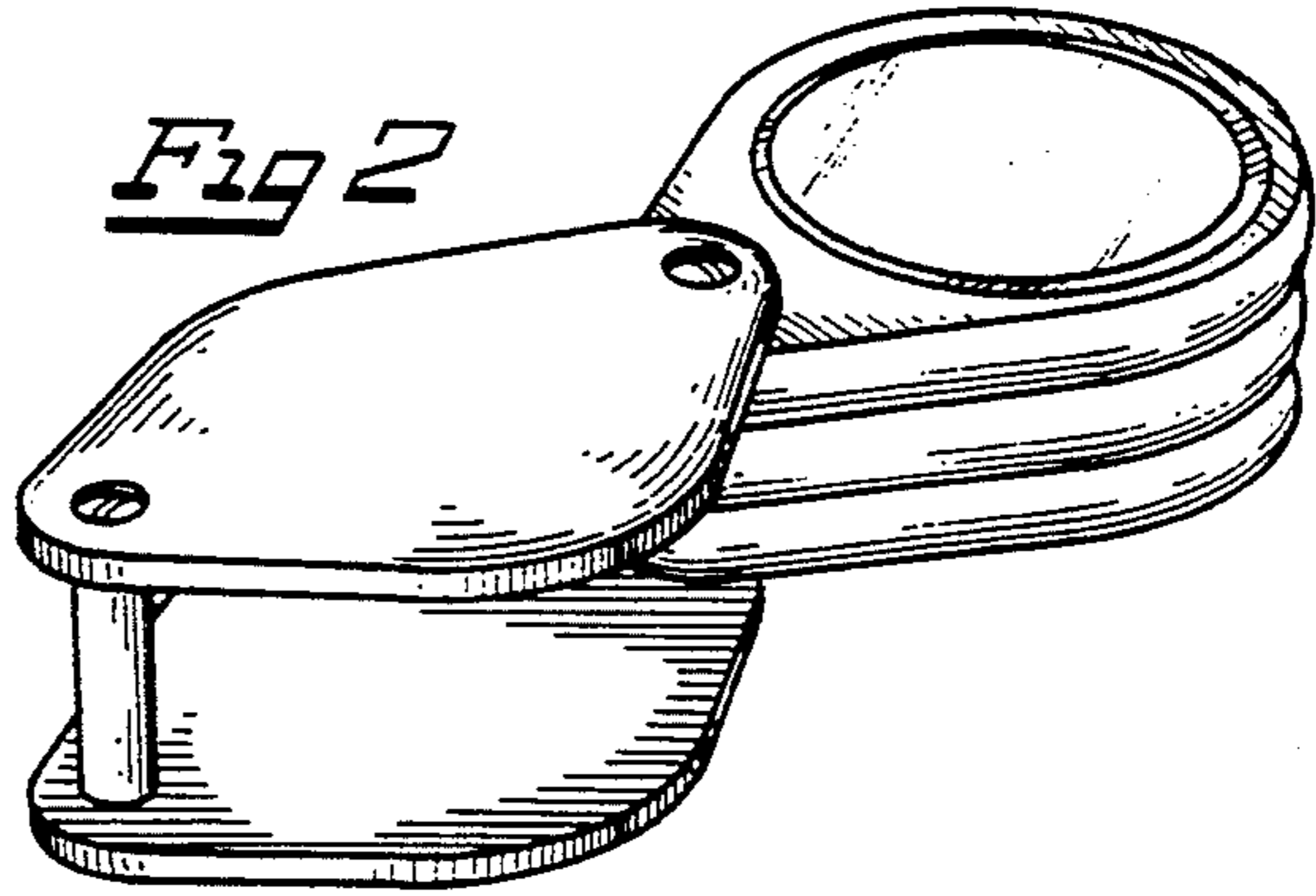

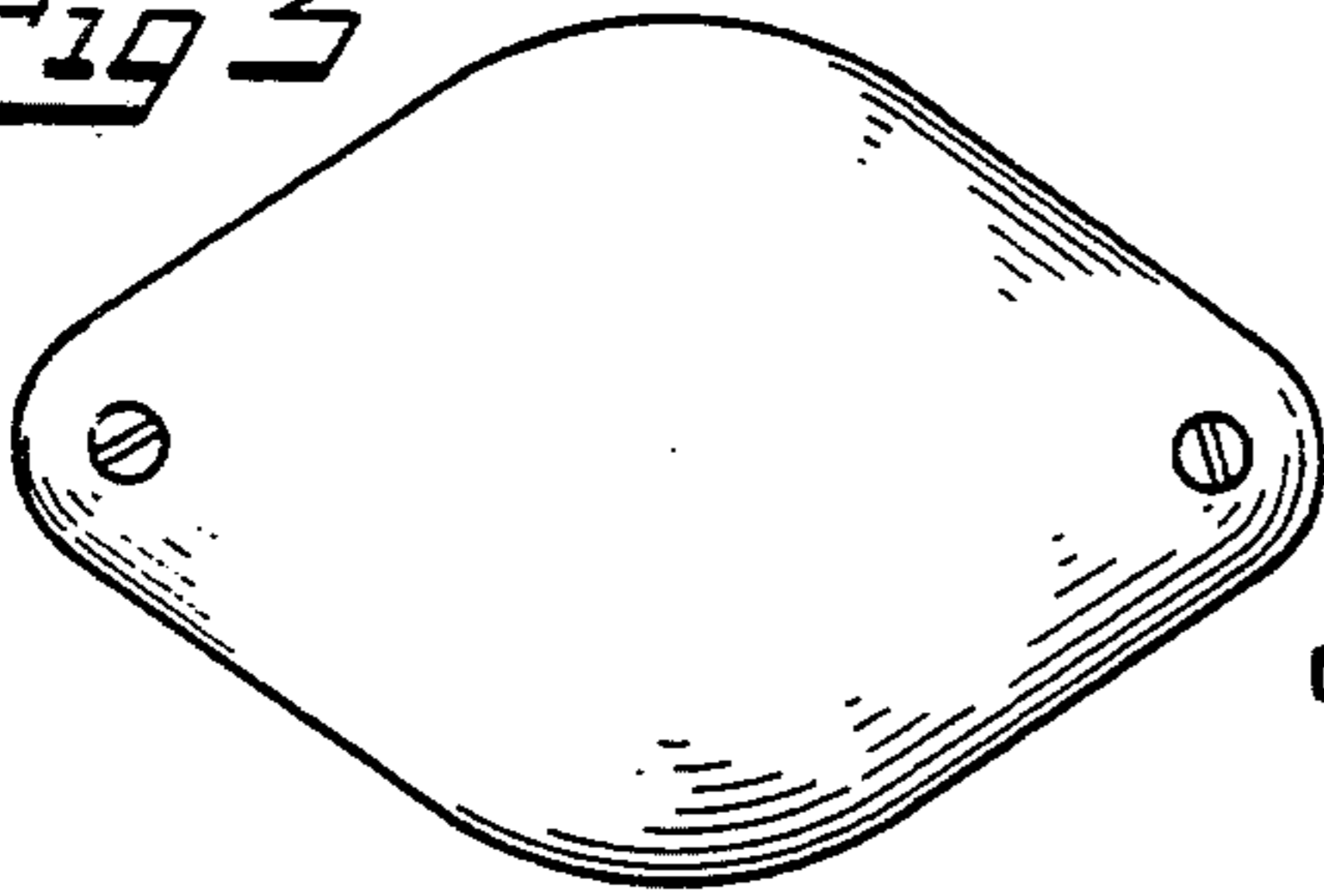

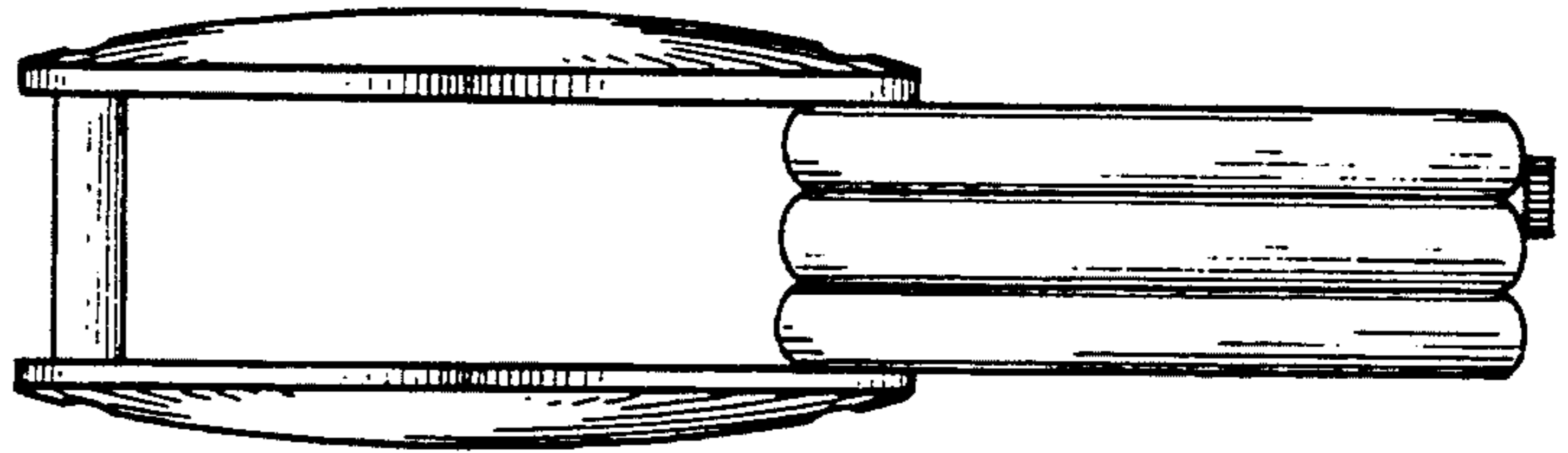

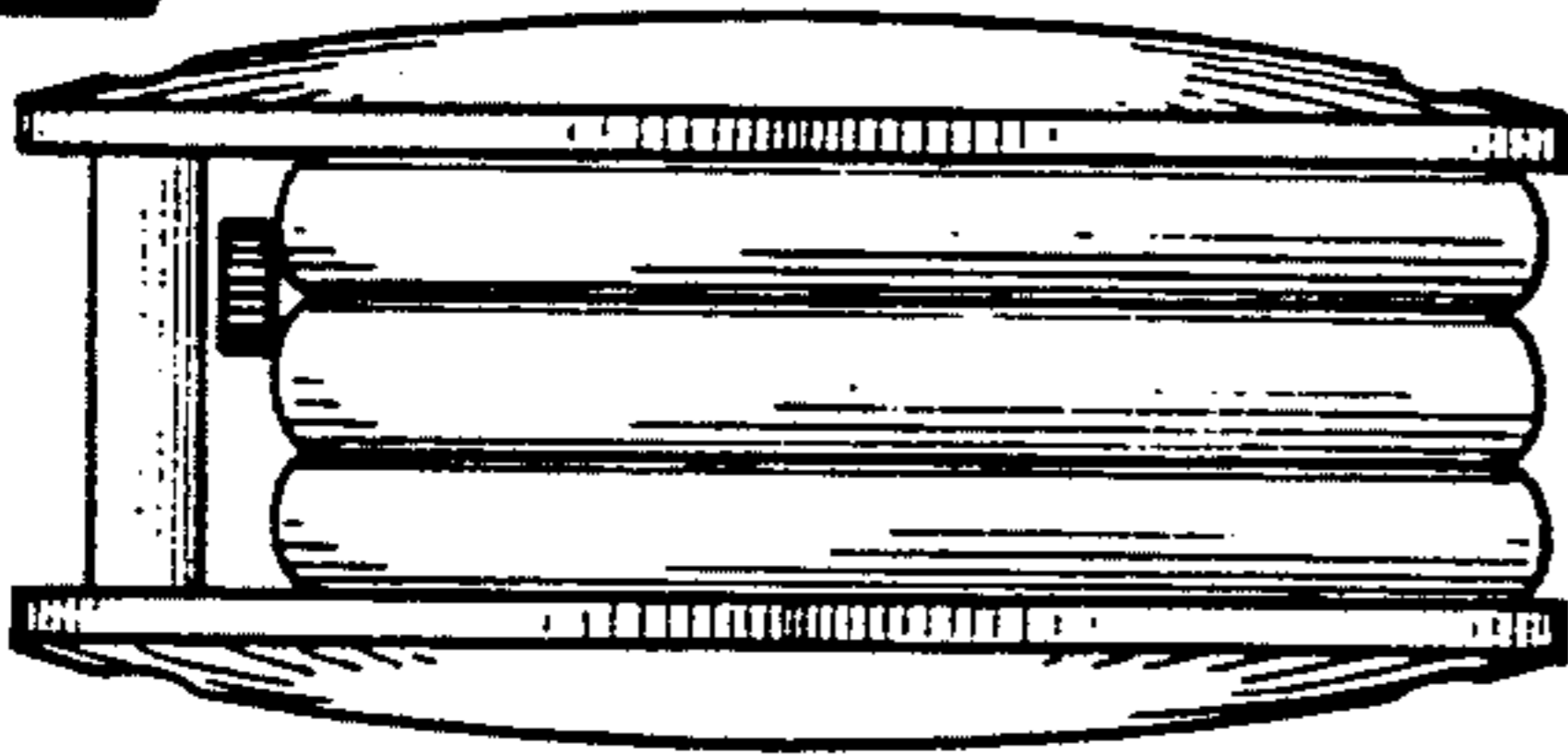

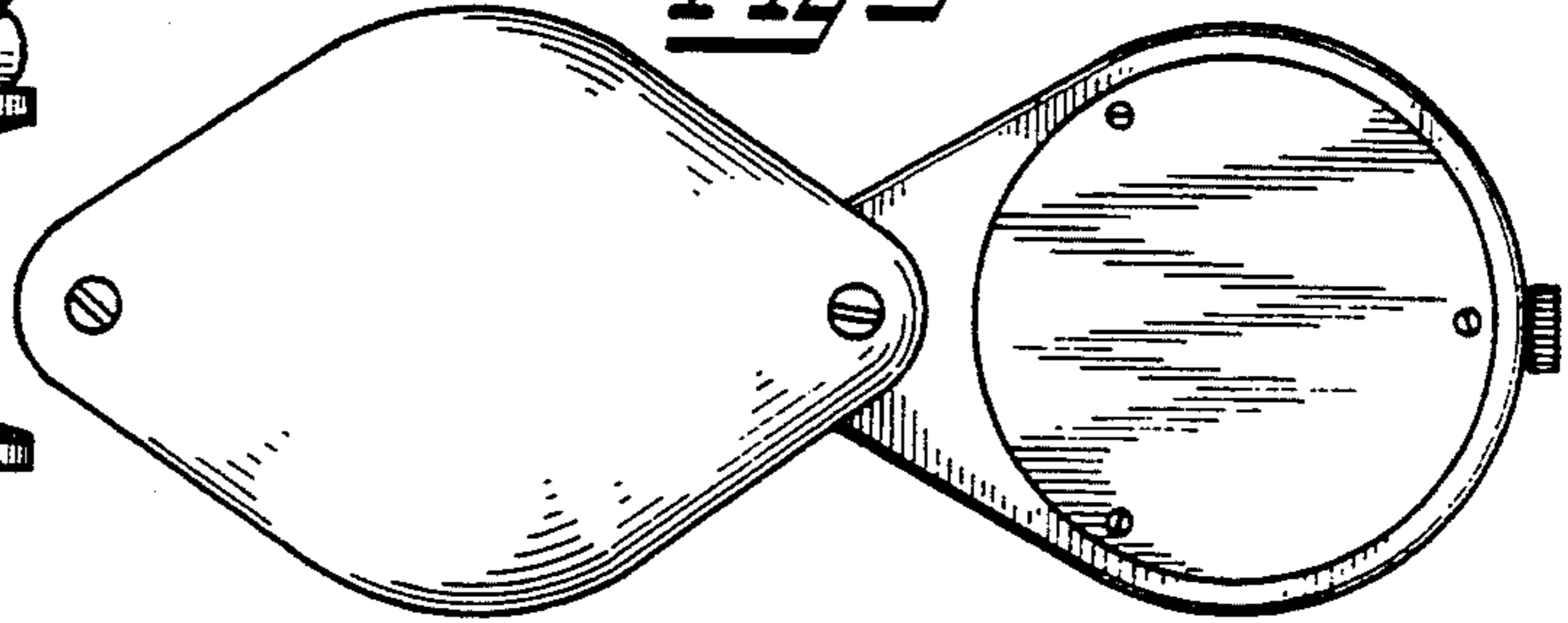

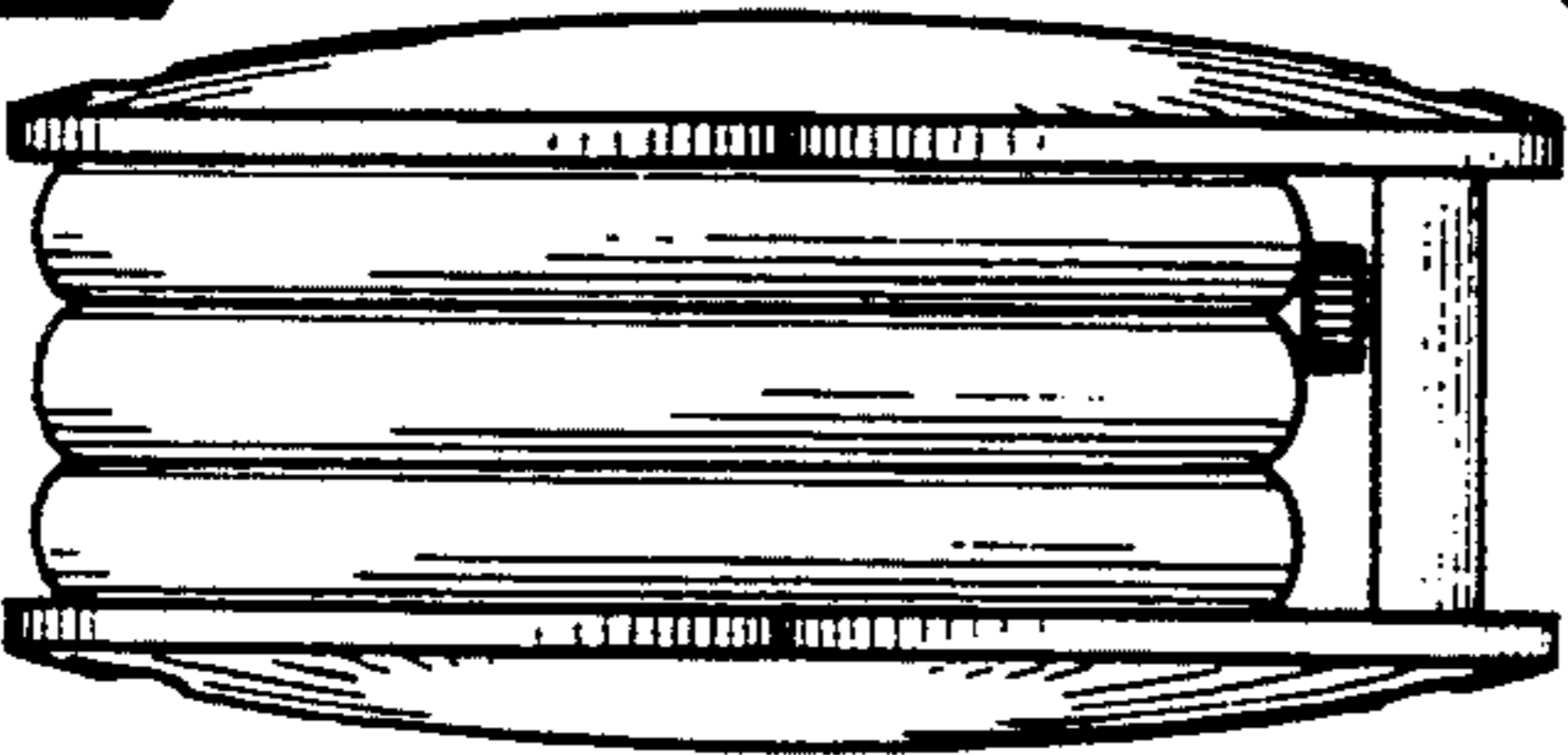

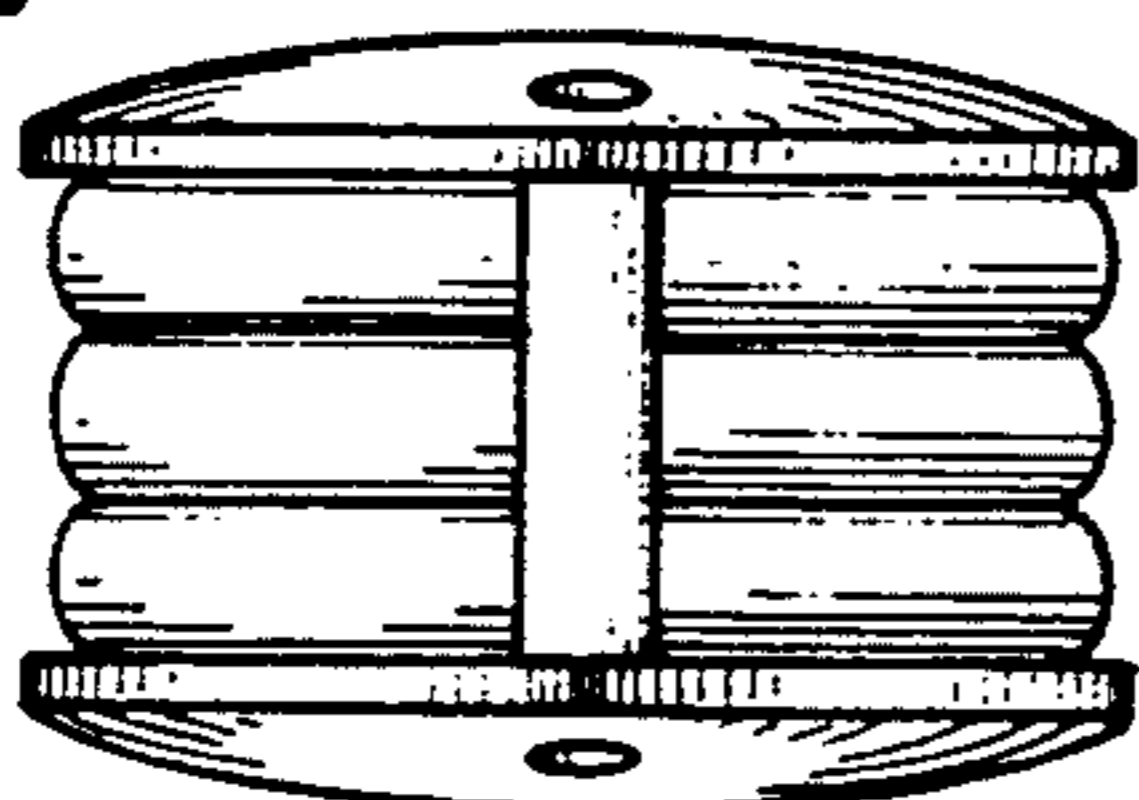
