The ornamental design for a muffler for a jackhammer, as shown and described.

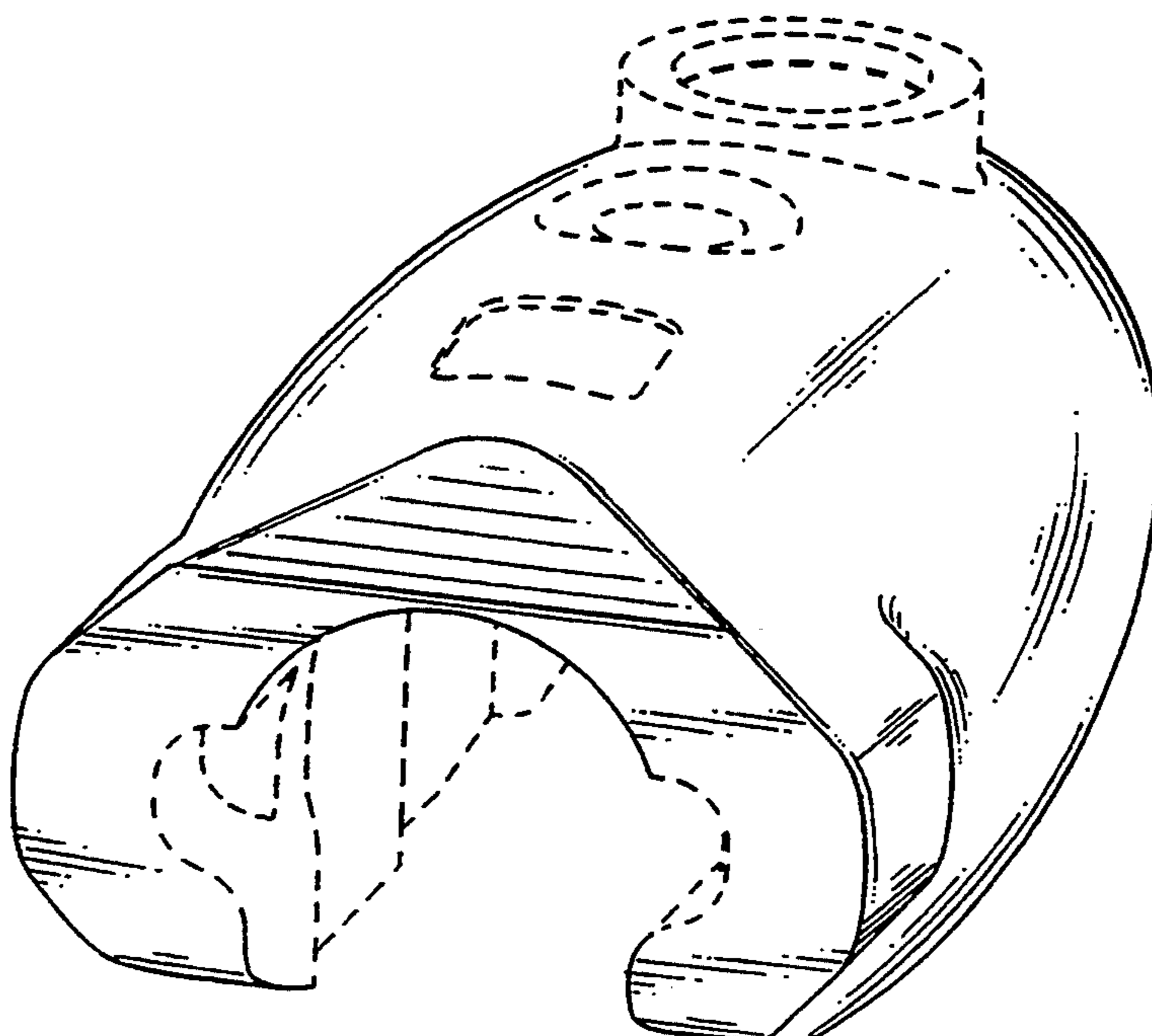
### DESCRIPTION

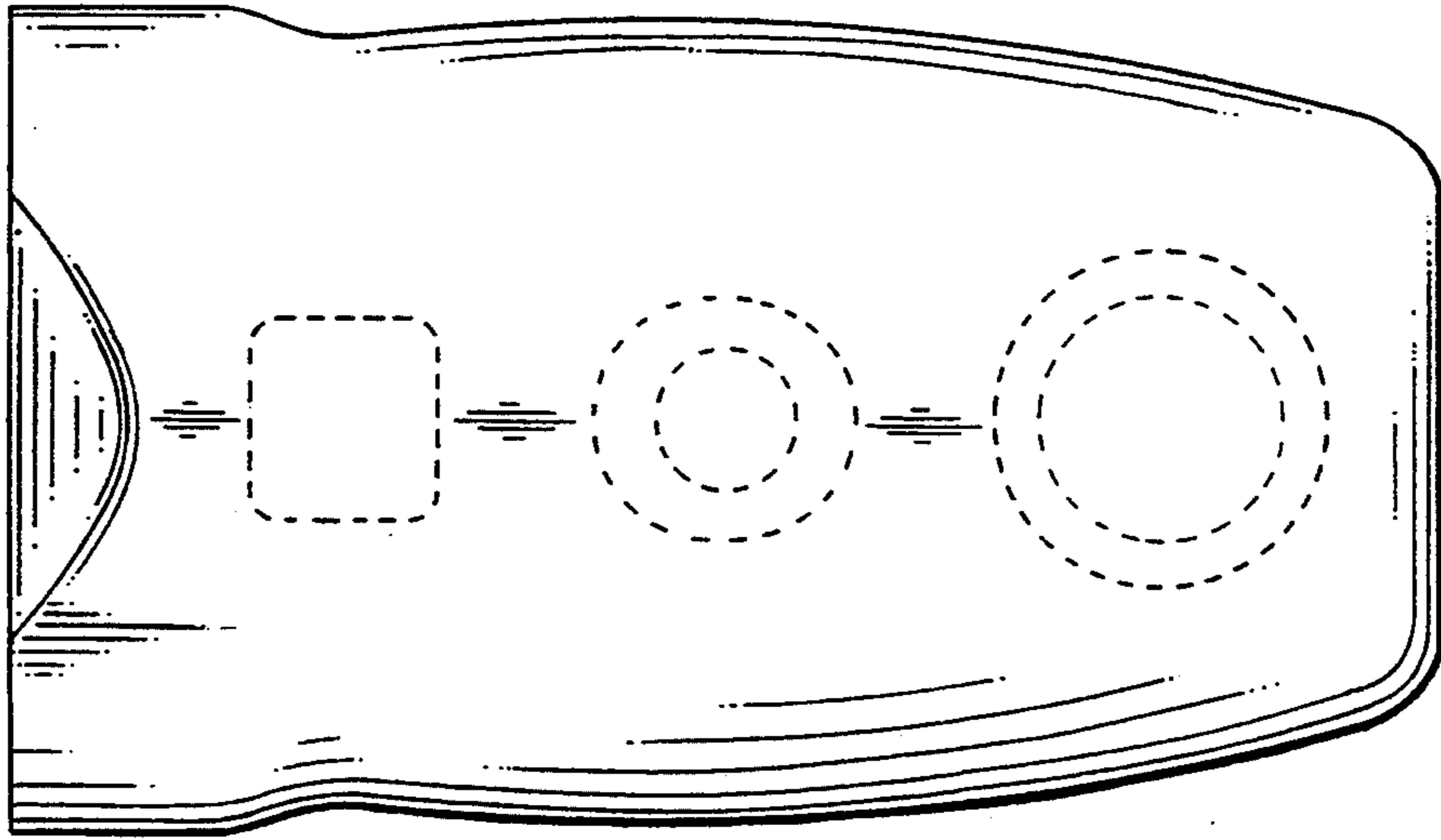

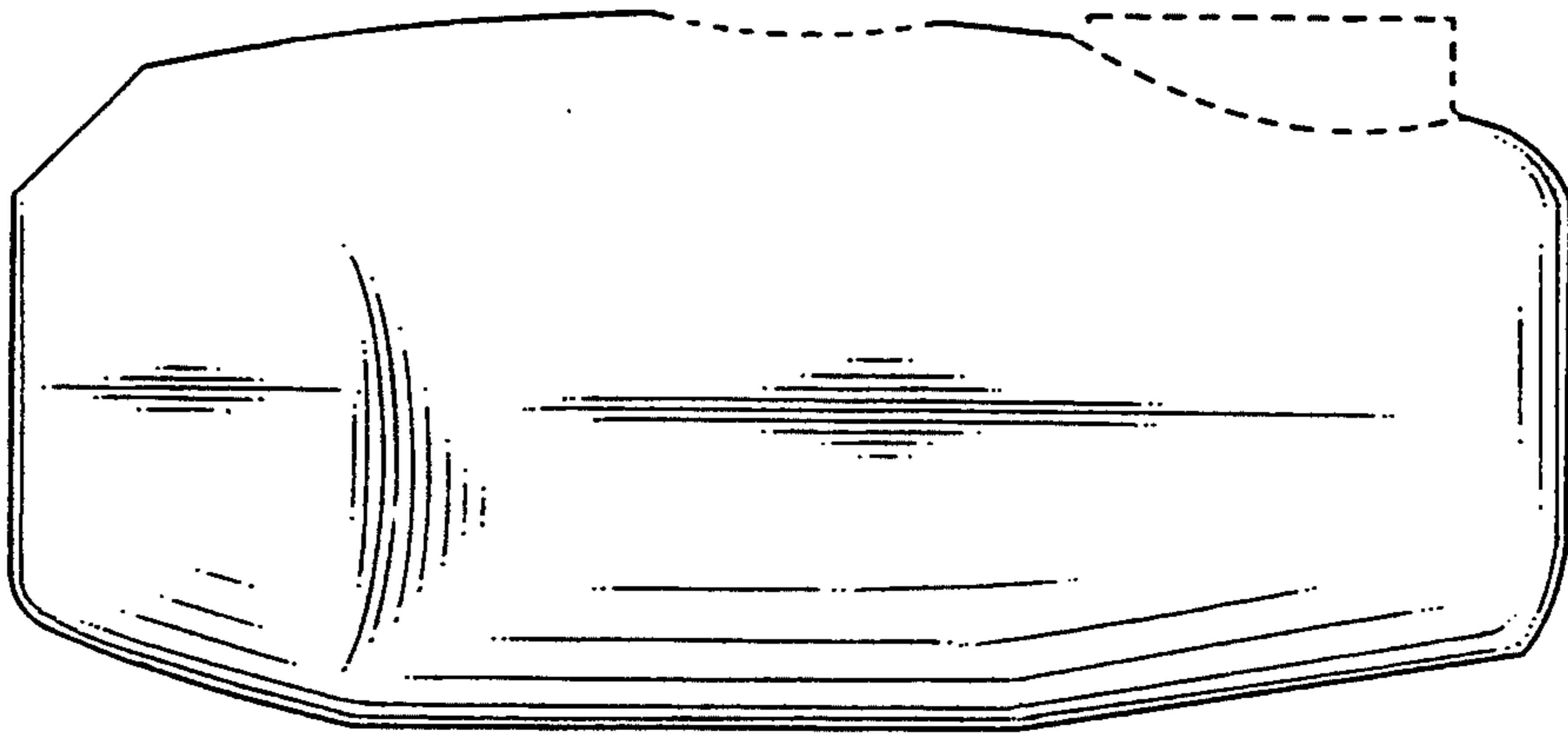

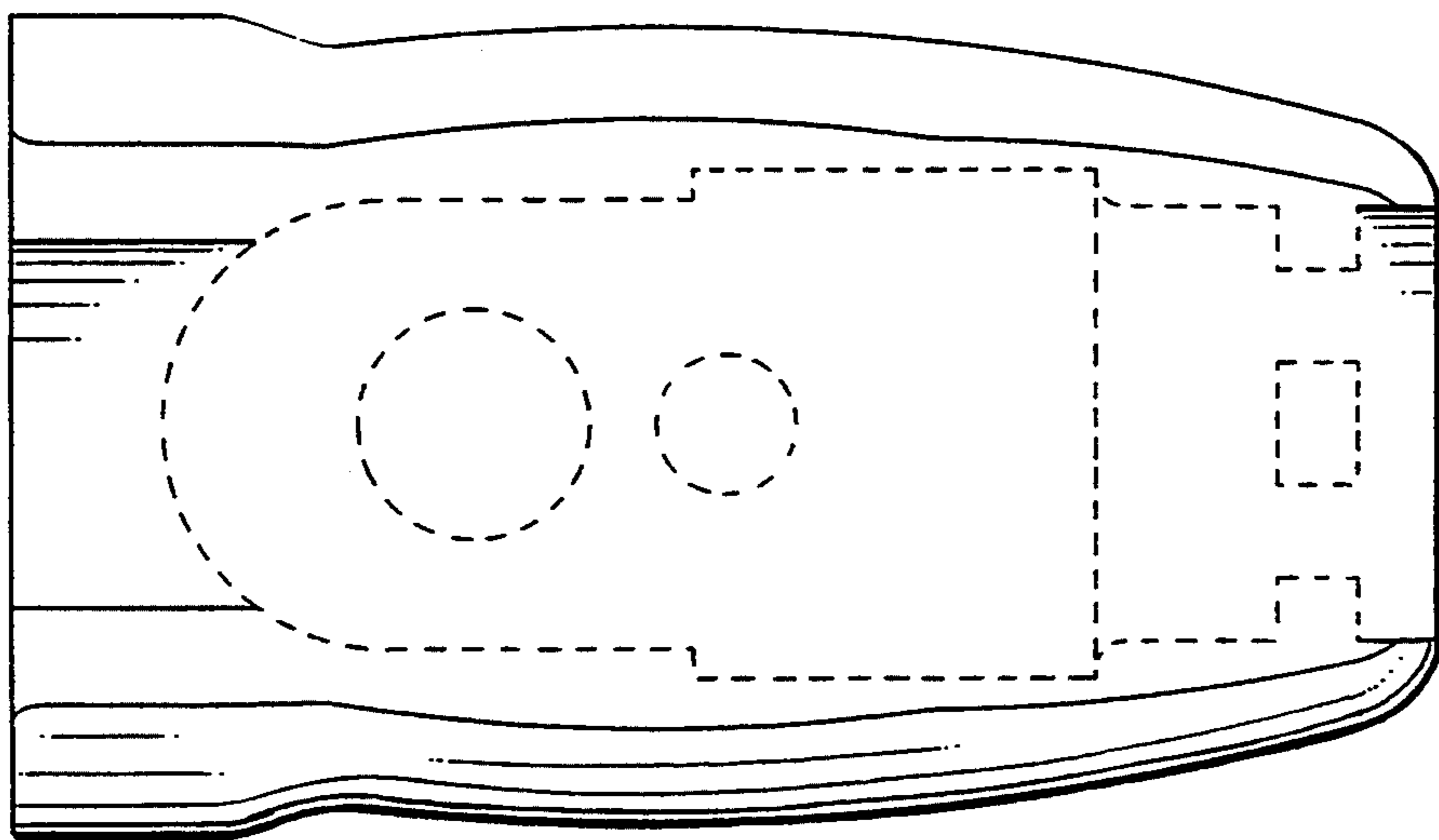

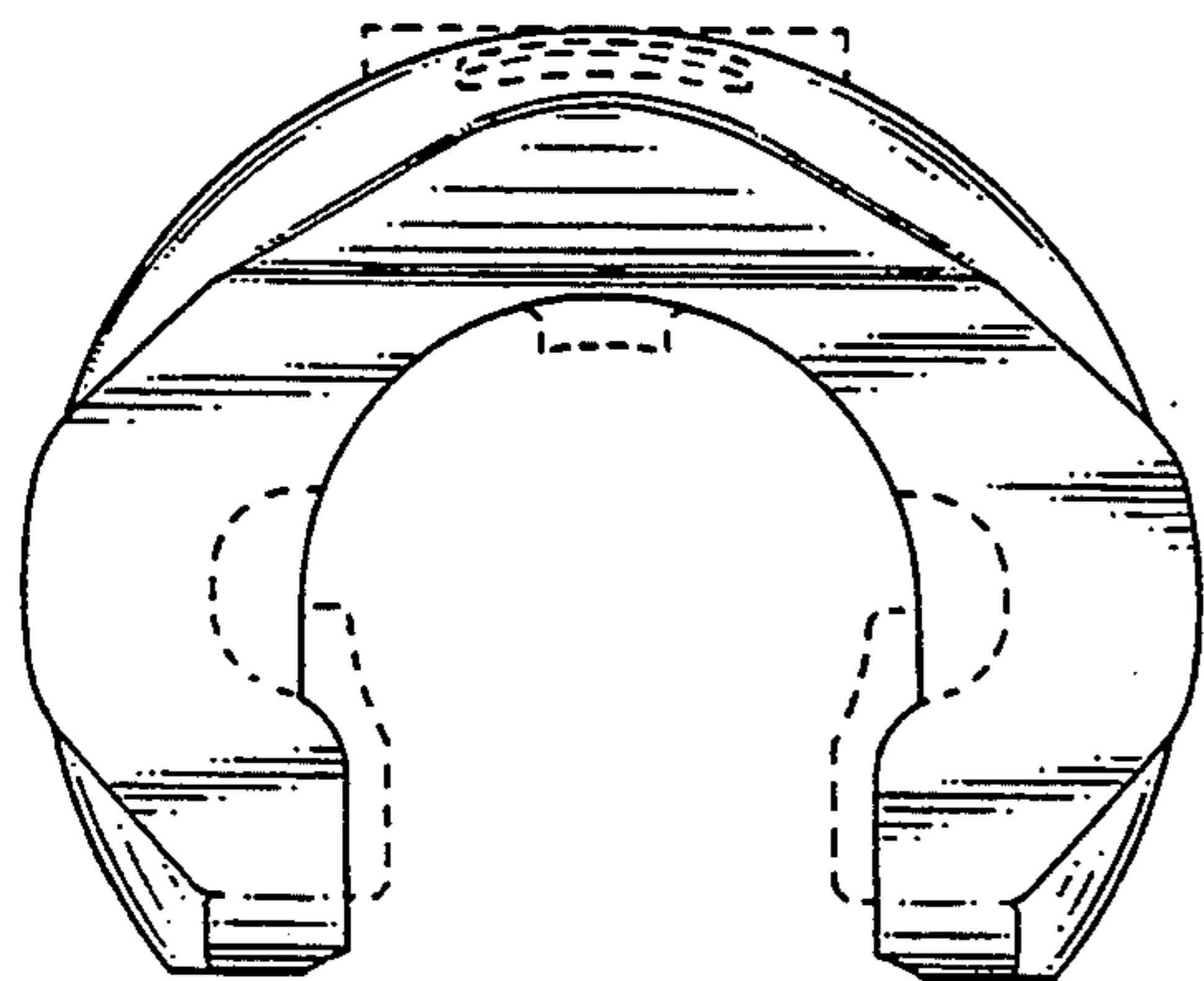

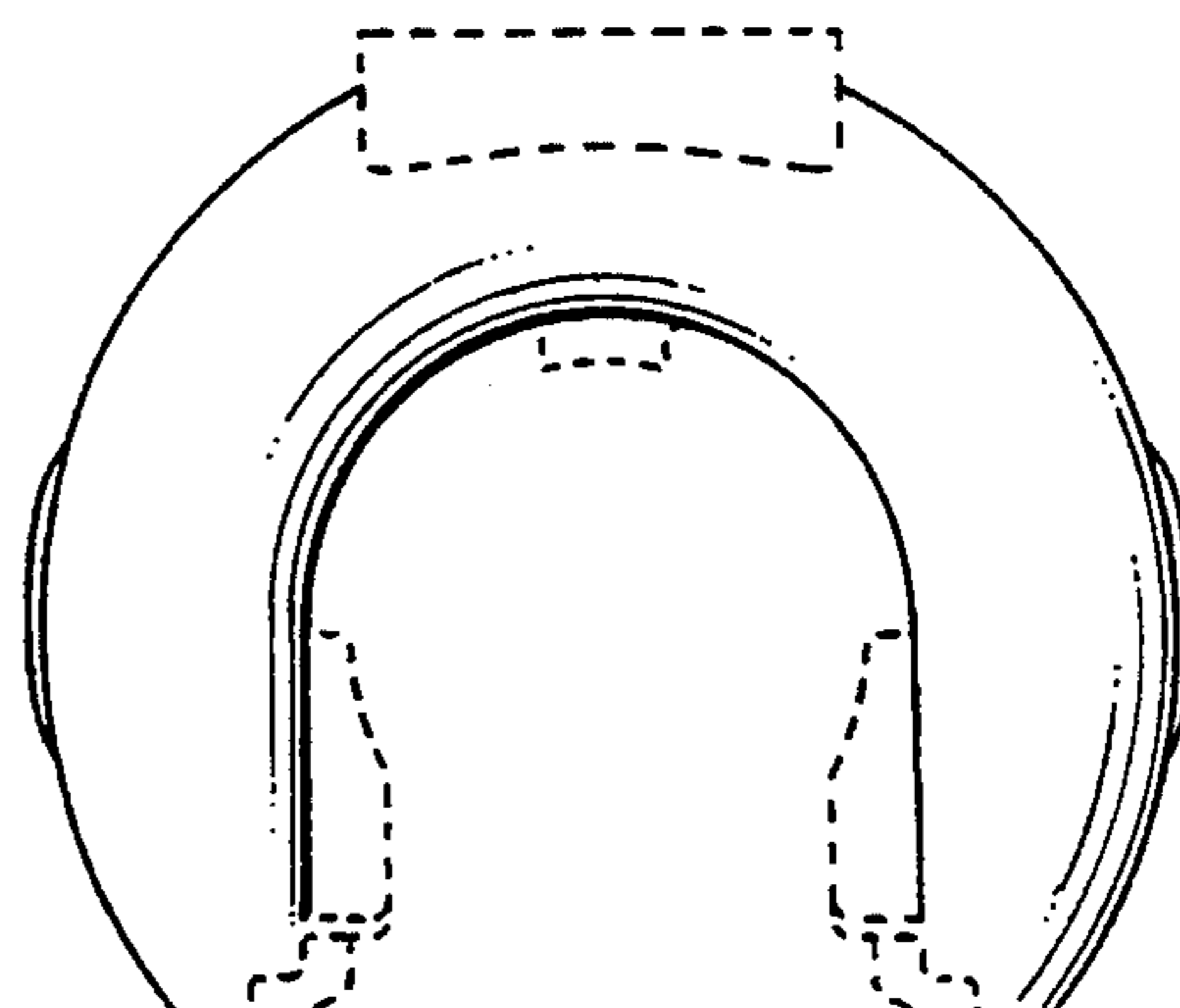

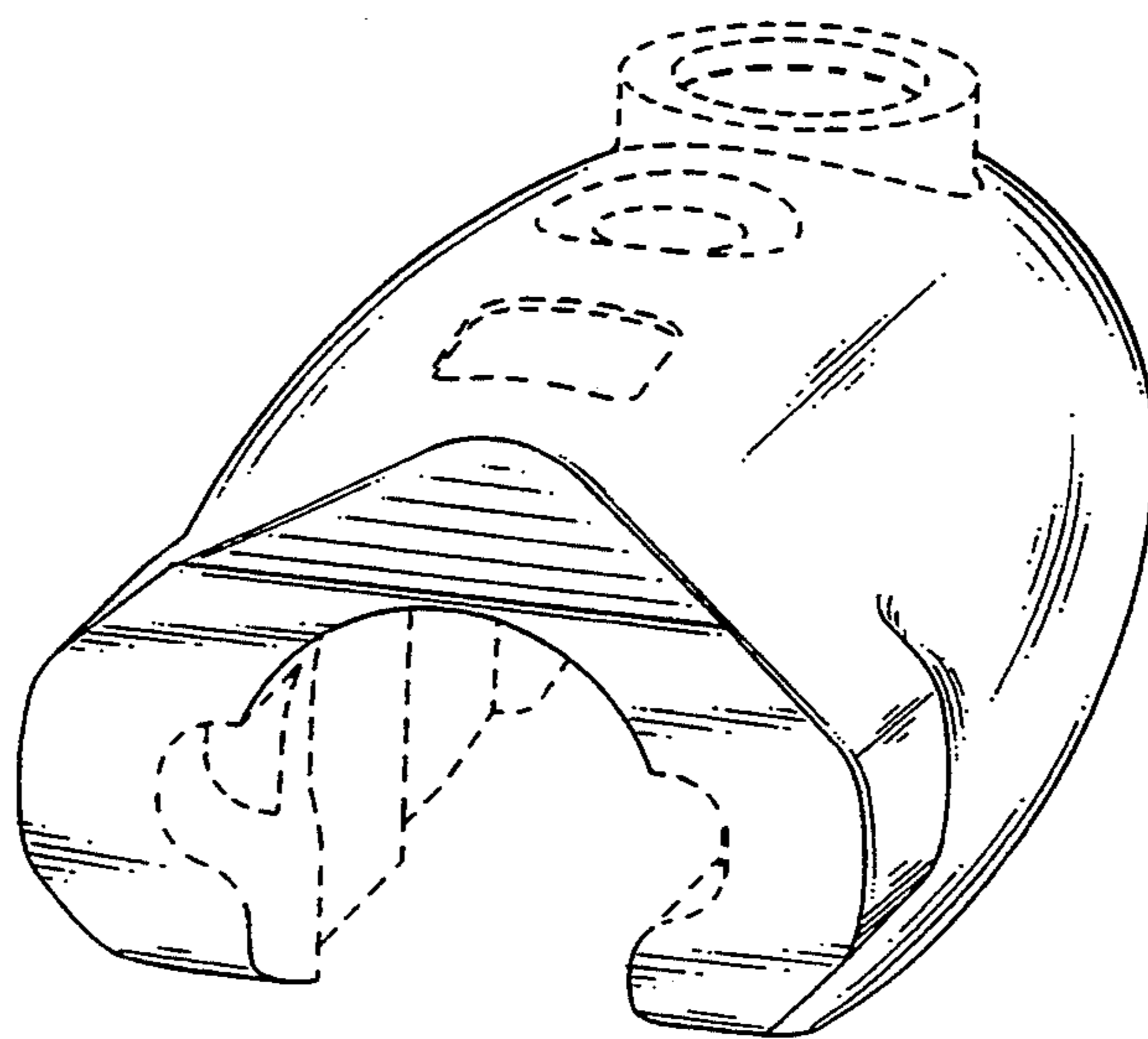

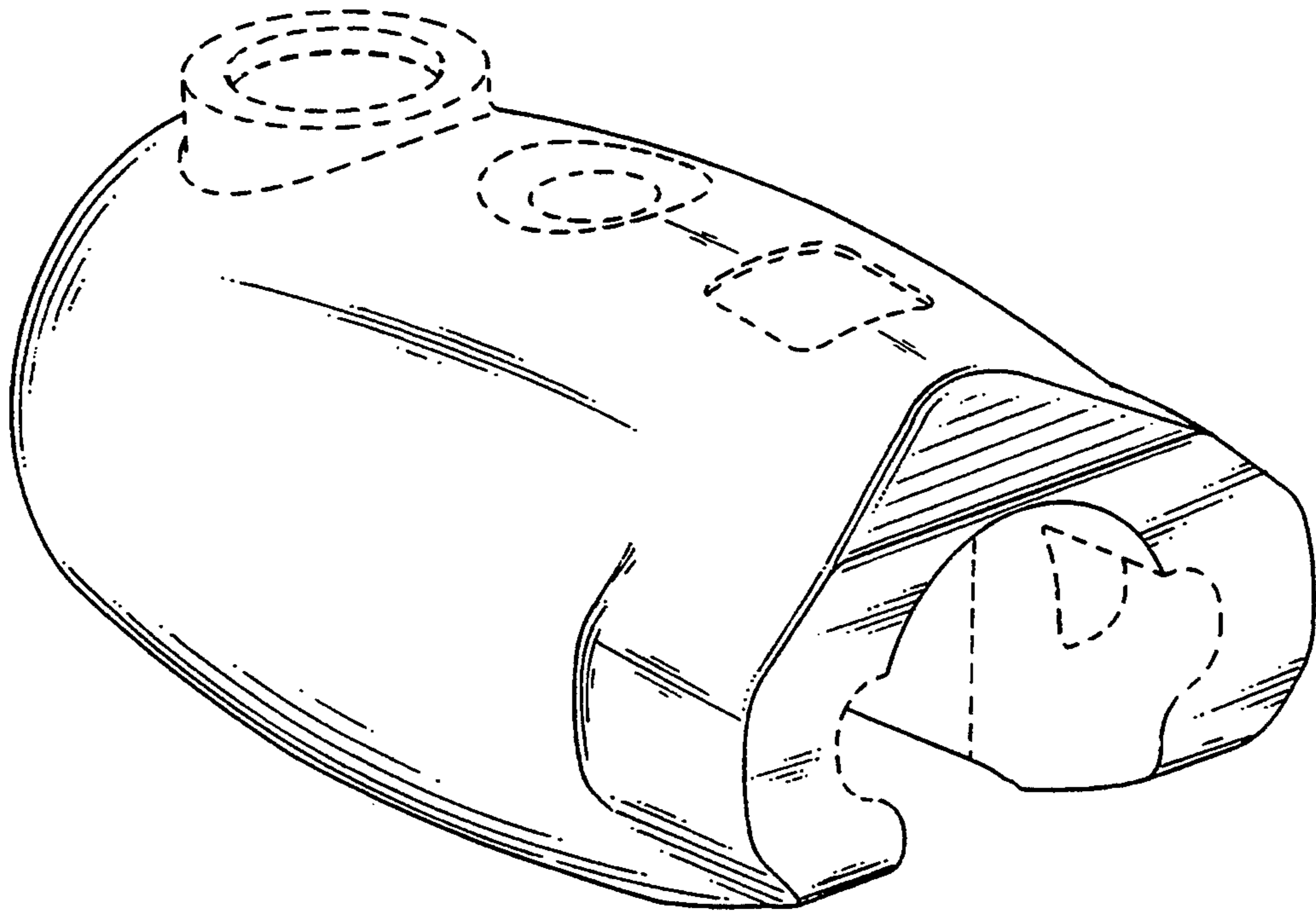

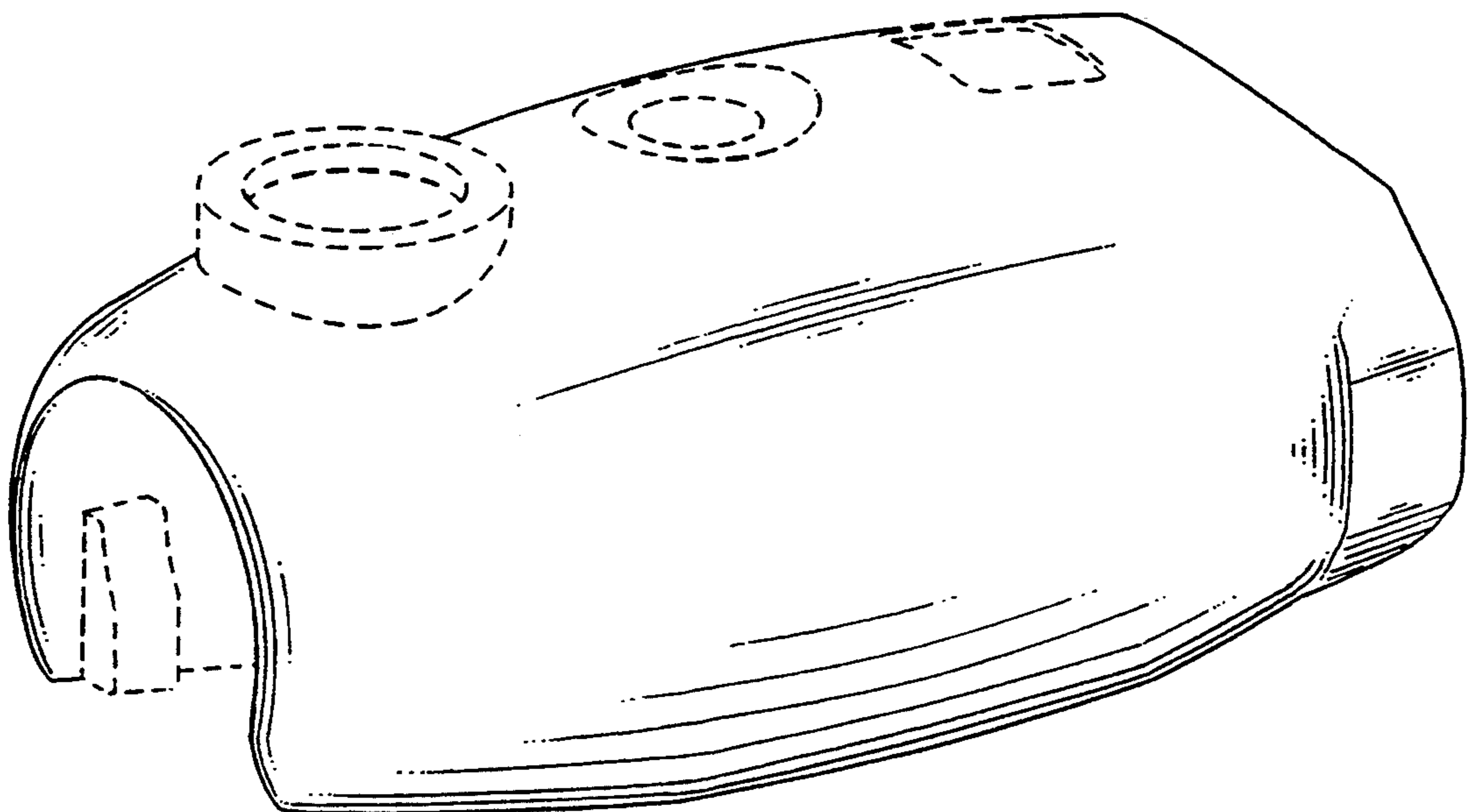
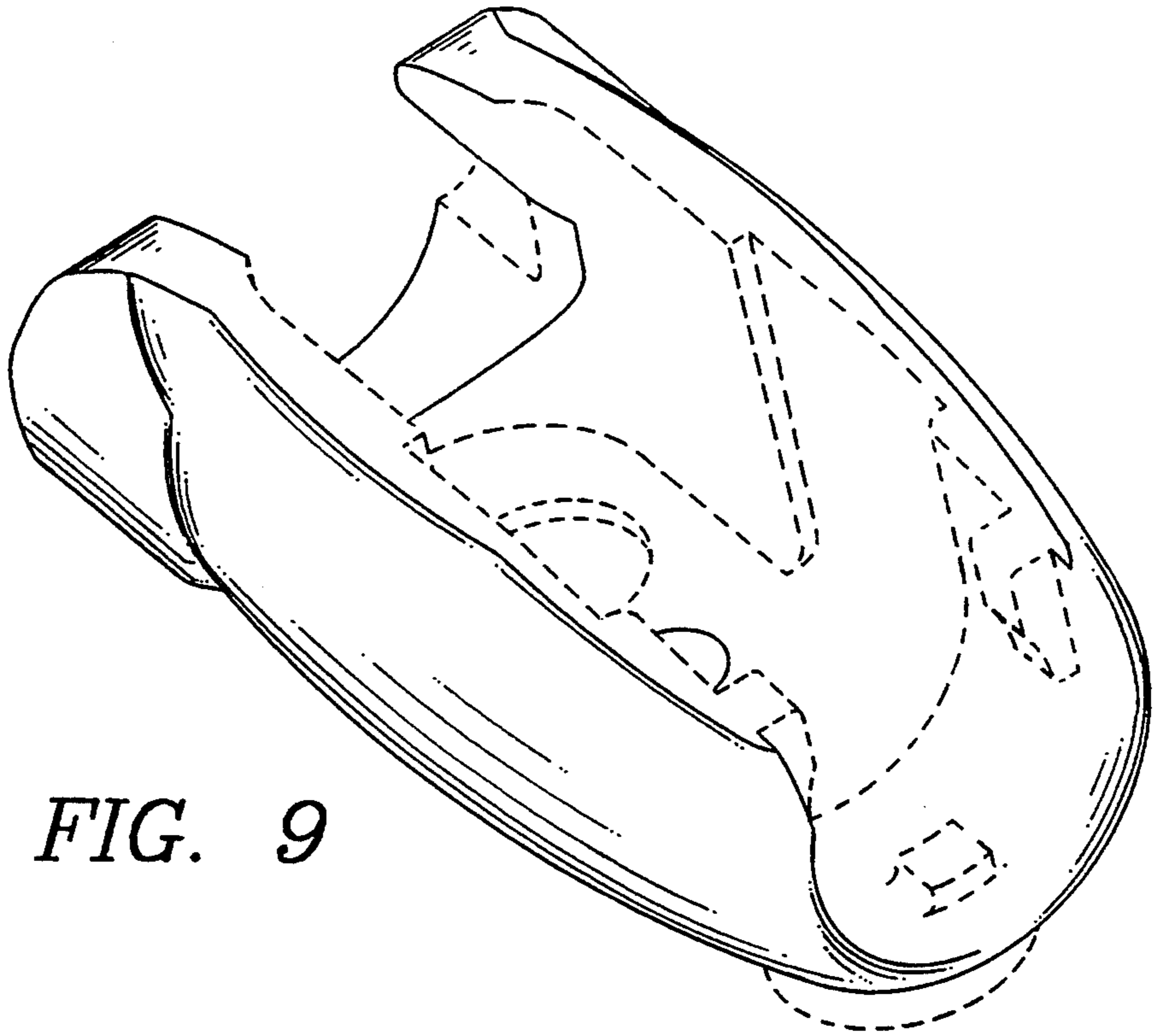
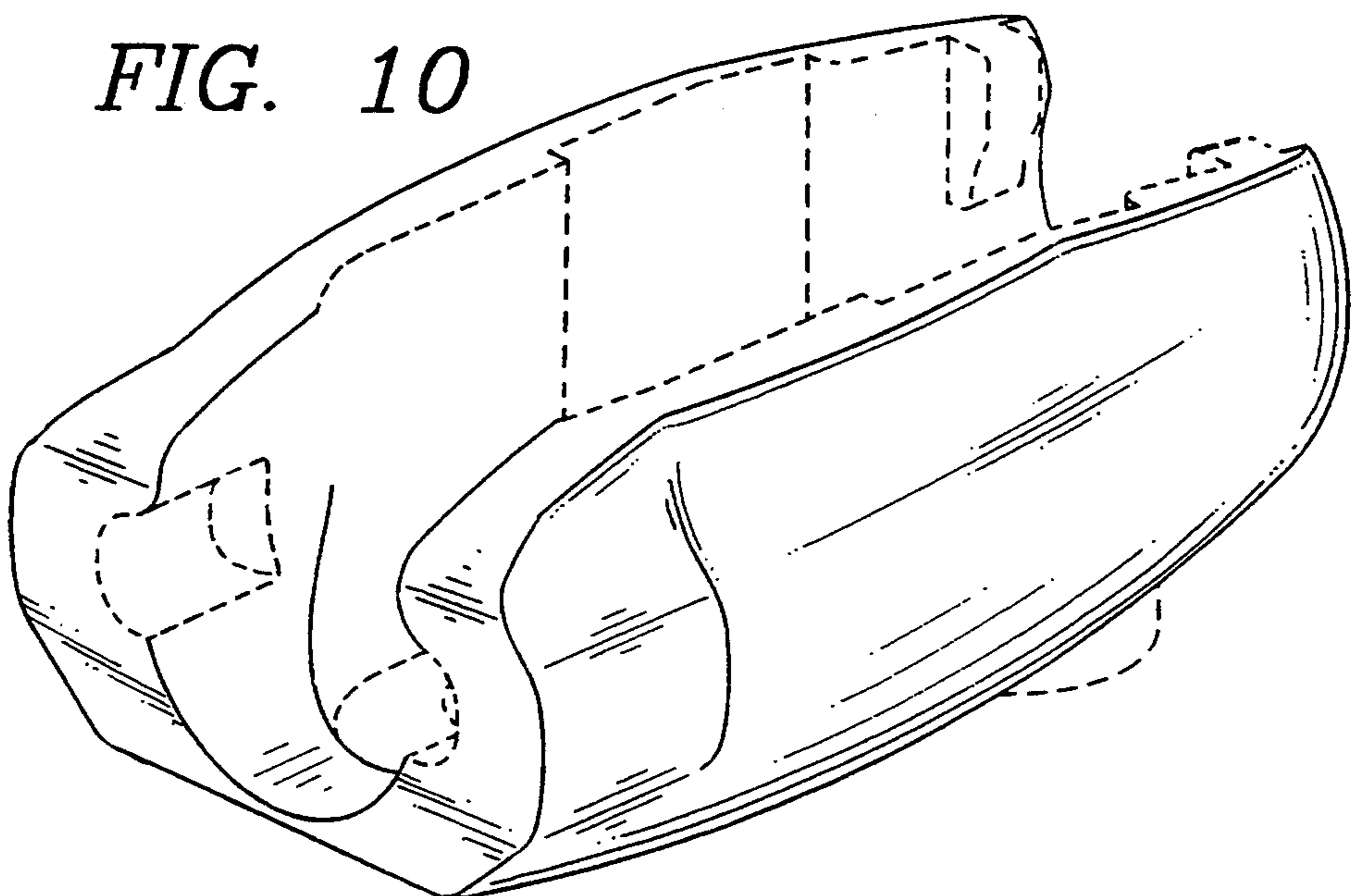
