FIG. 1 is a perspective view of a sunshade for riding equipment, showing our new design;

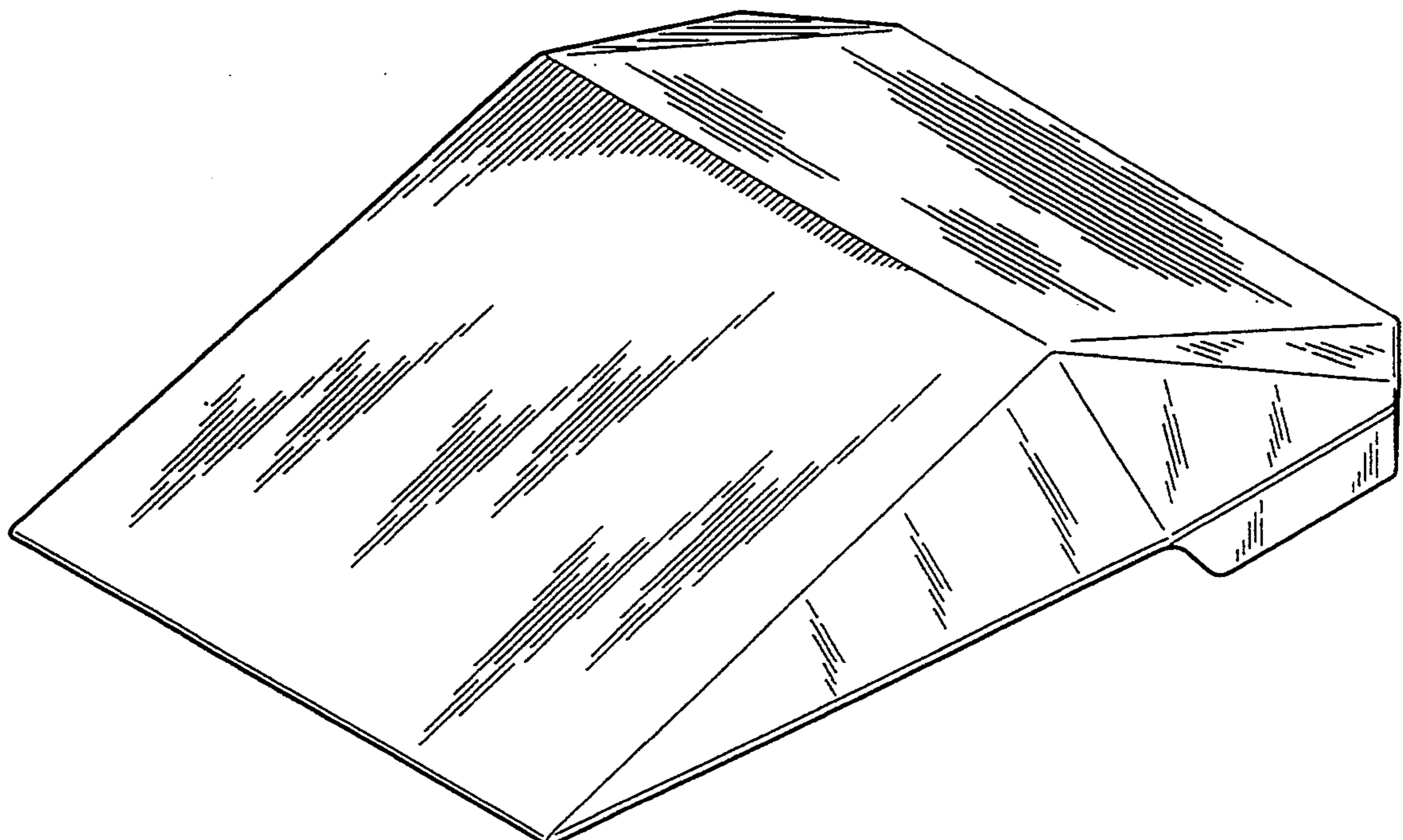
FIG. 2 is a front view;

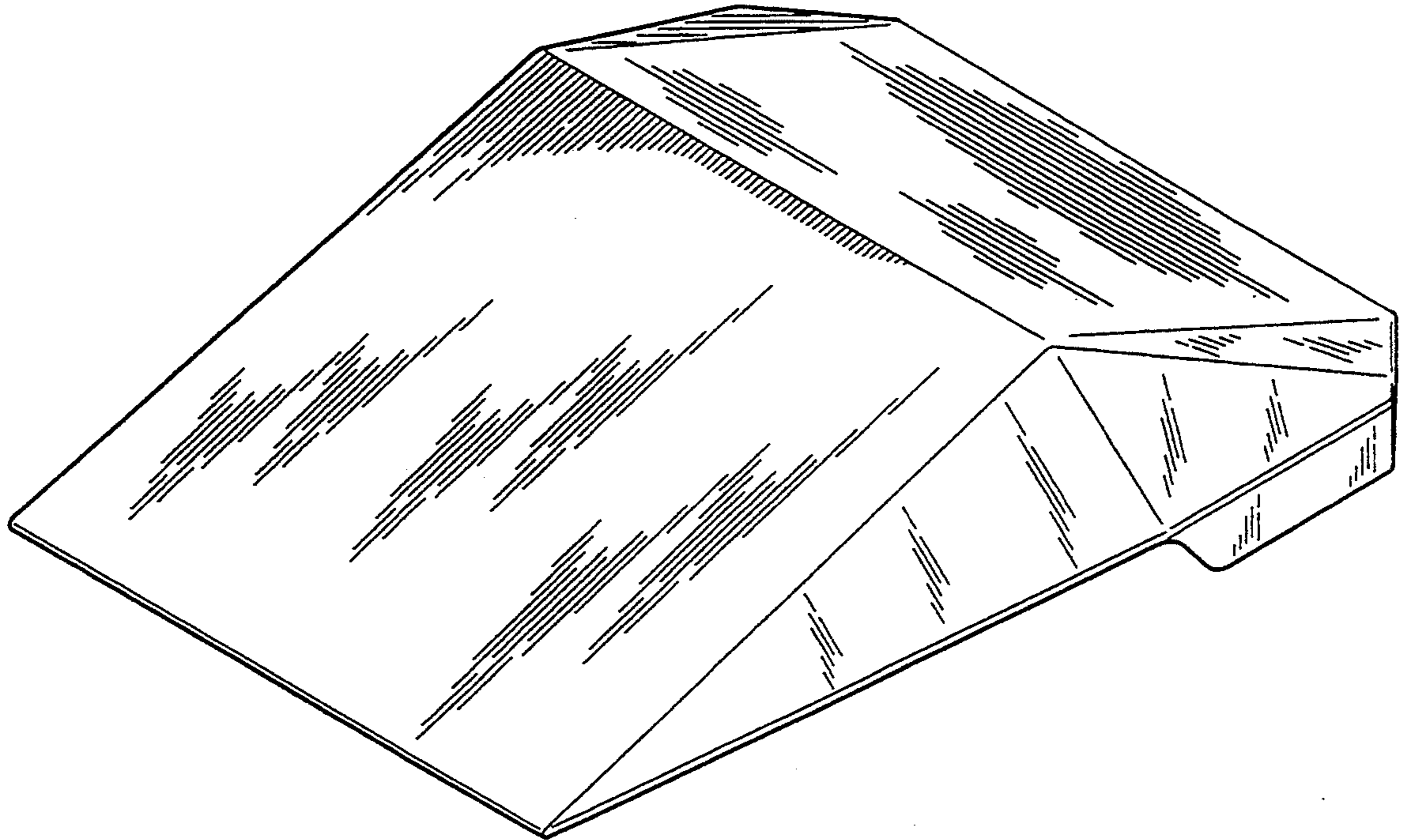
FIG. 3 is a side view thereof, the other side being a mirror image thereof;

FIG. 4 is a top view;

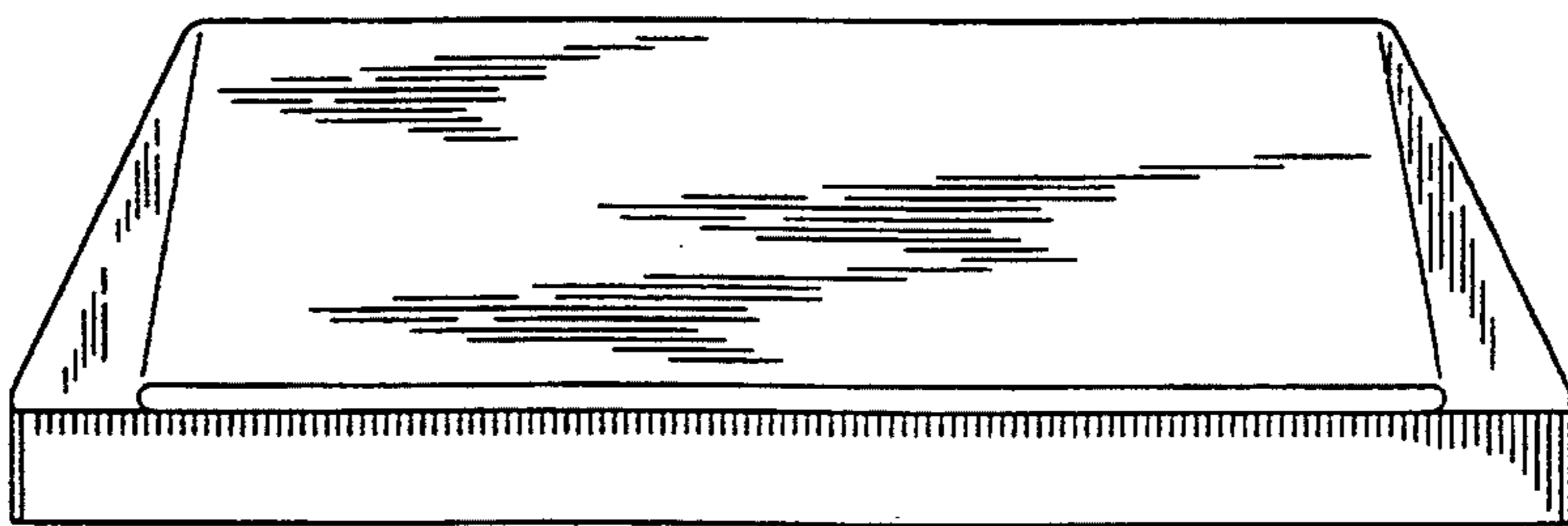
FIG. 5 is a back view; and,

FIG. 6 is a bottom view.

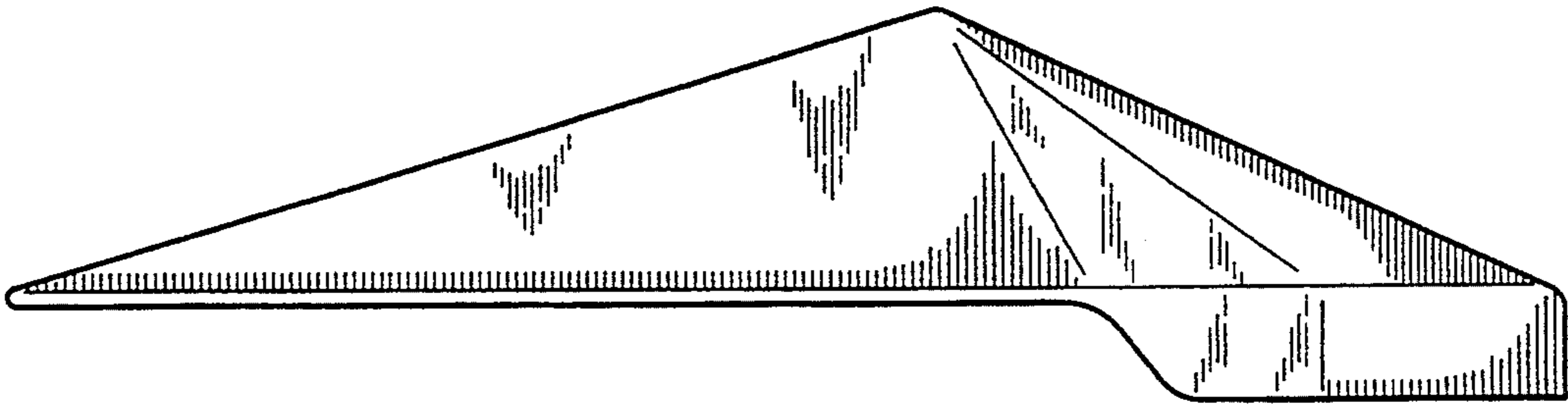




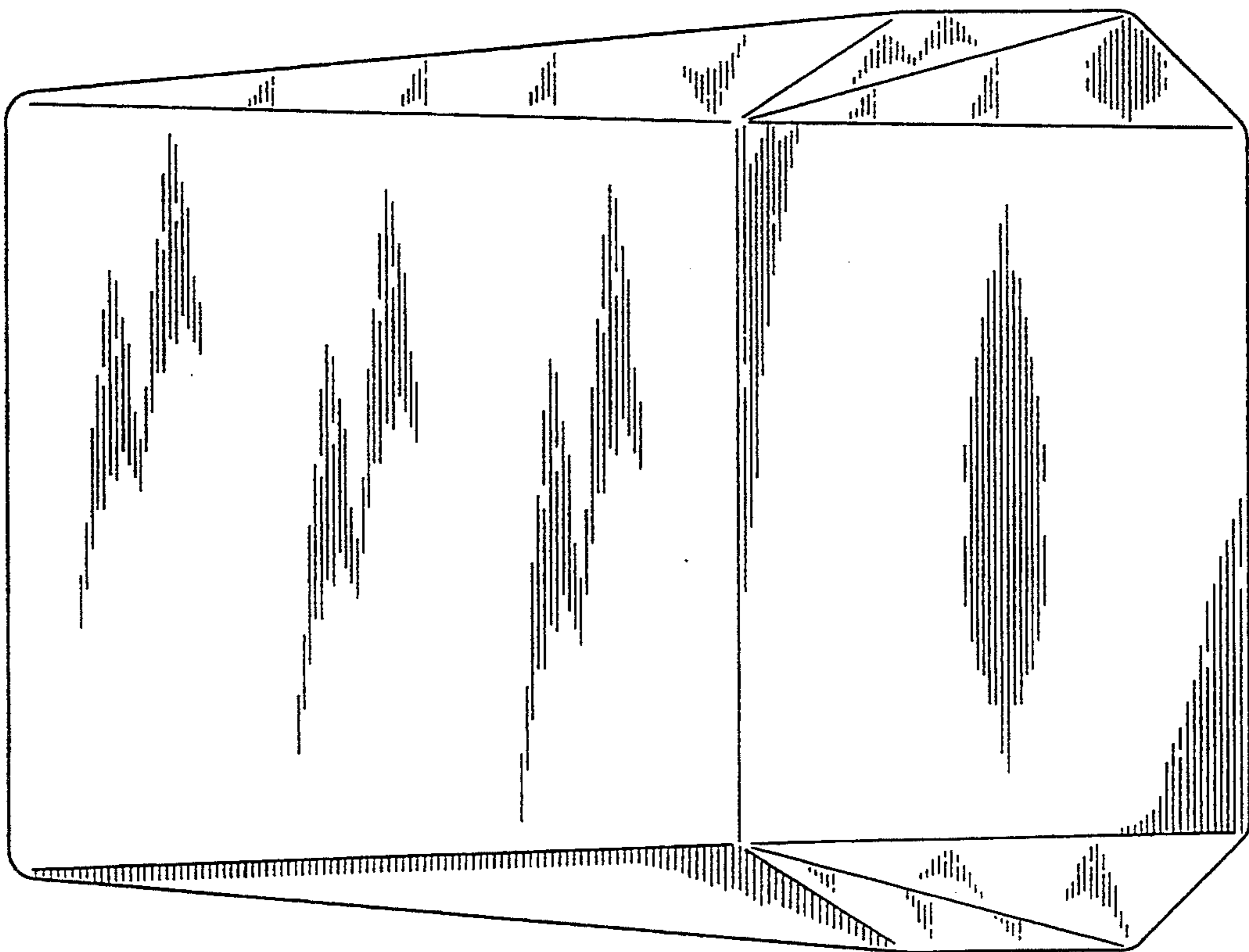

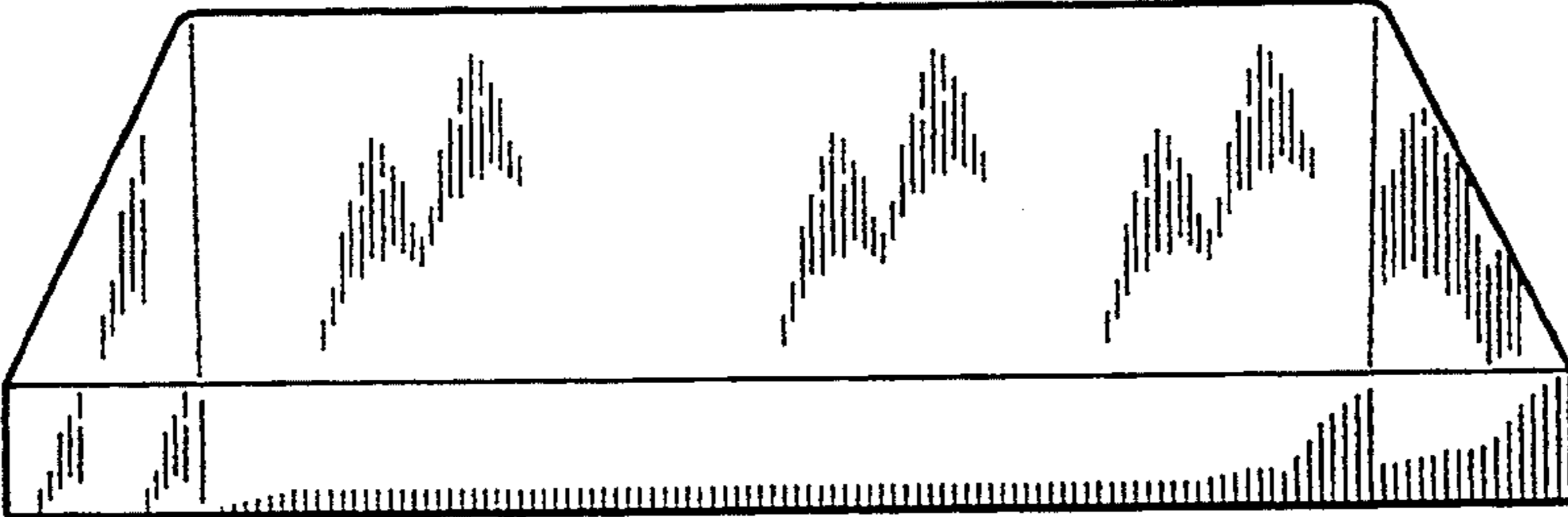

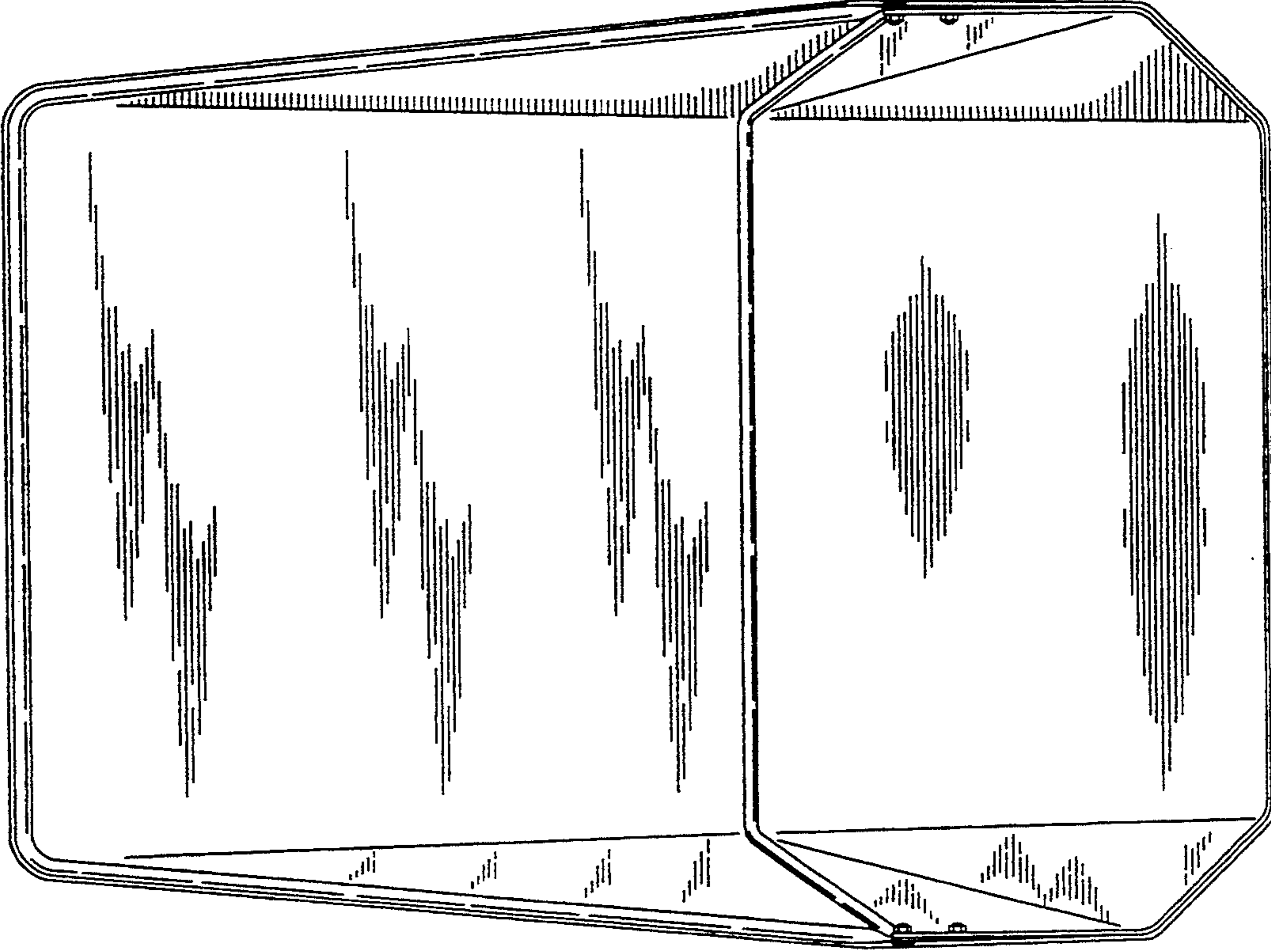
