[57] **CLAIM**

The ornamental design for expandable spectacle temple, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the expandable spectacle temple showing my new design in the non-expanded condition;

FIG. 2 is a first side elevation view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a second side plan view thereof;

FIG. 5 is a front end view from the left hand side of the FIG. 2;

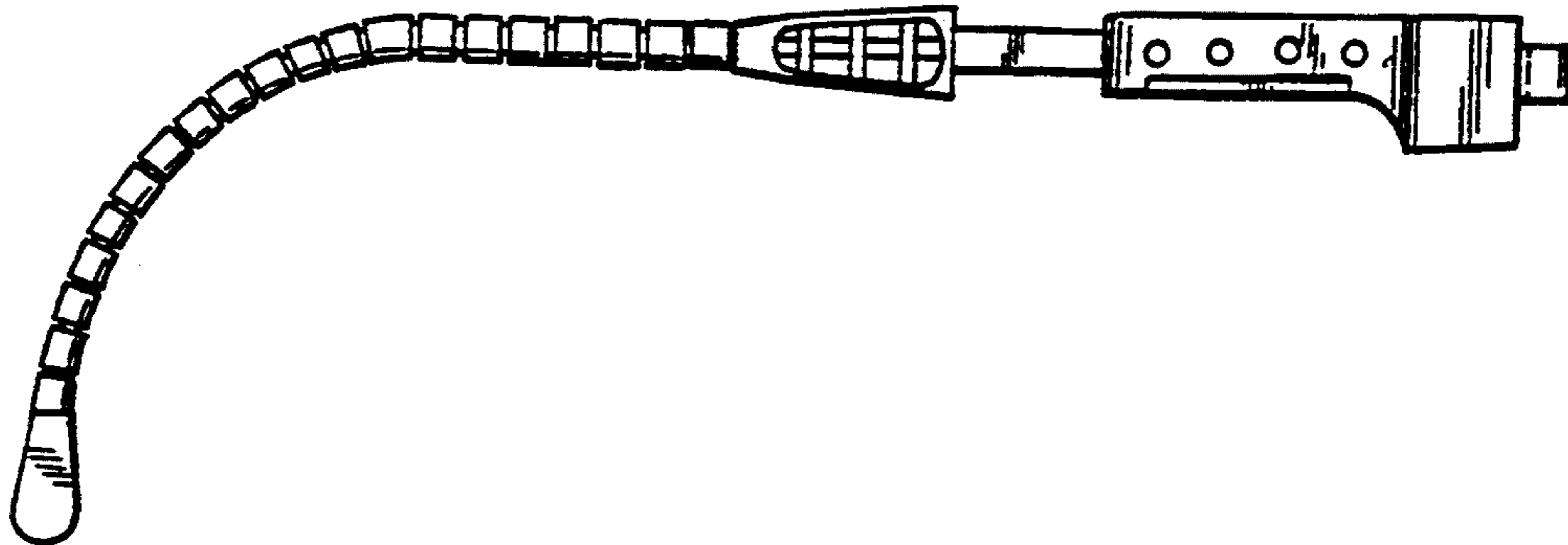
FIG. 6 is a back end view from the right hand side of the FIG. 2;

FIG. 7 is a top view with the temple fully expanded;

FIG. 8 is a view of the first side with the temple fully expanded;

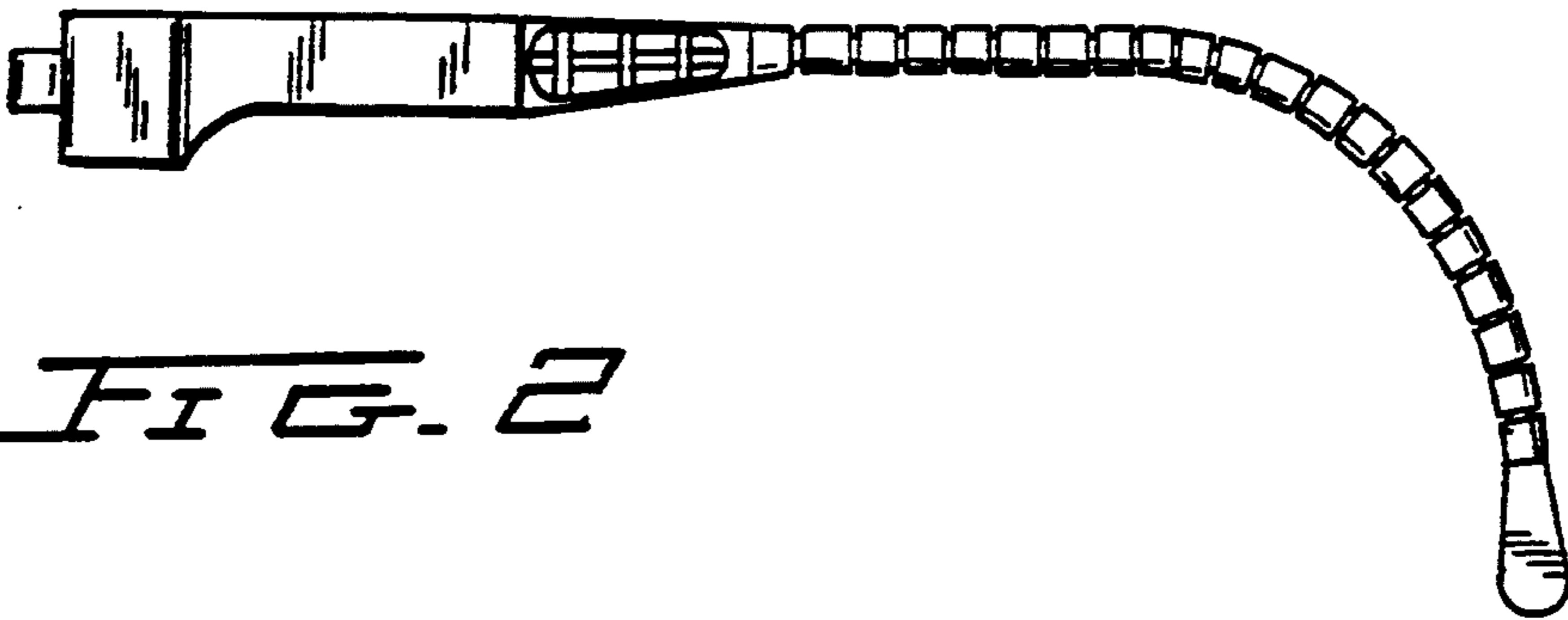
FIG. 9 is a bottom view with the temple fully expanded; and,

FIG. 10 is a view of the second side with the temple fully expanded.





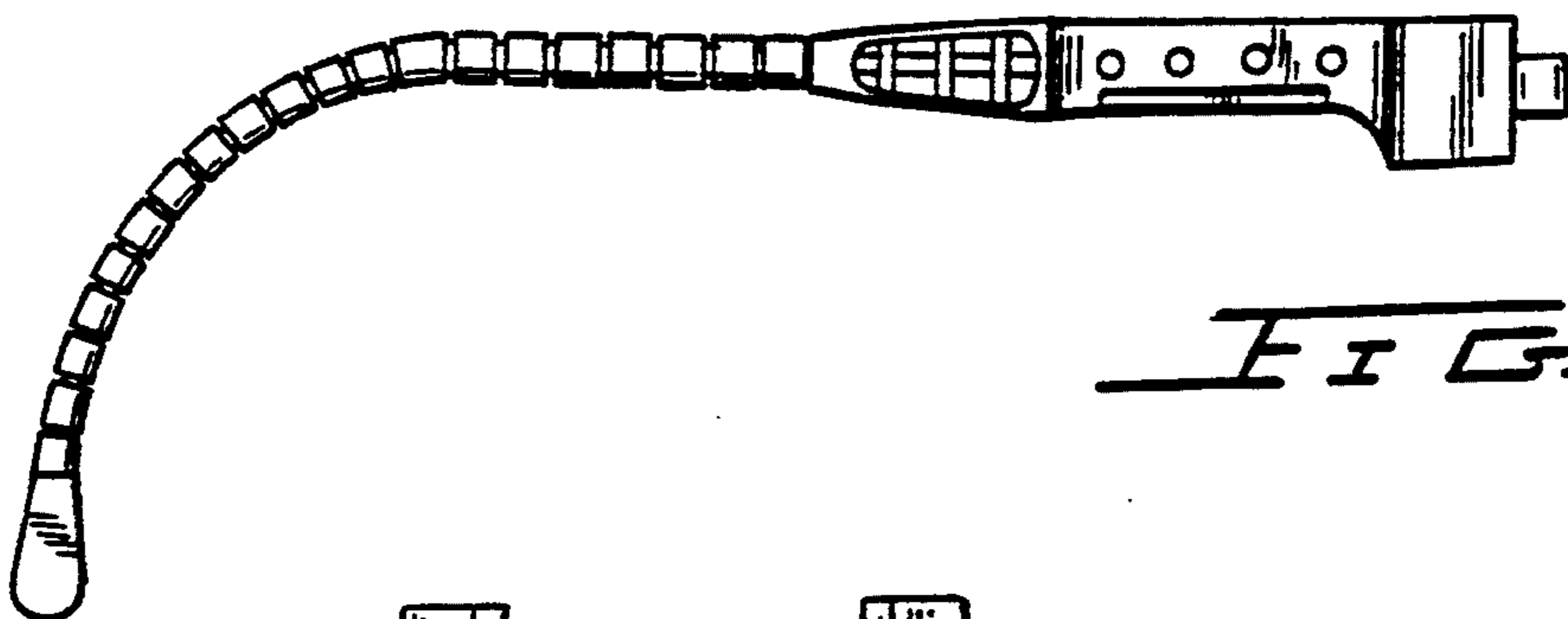

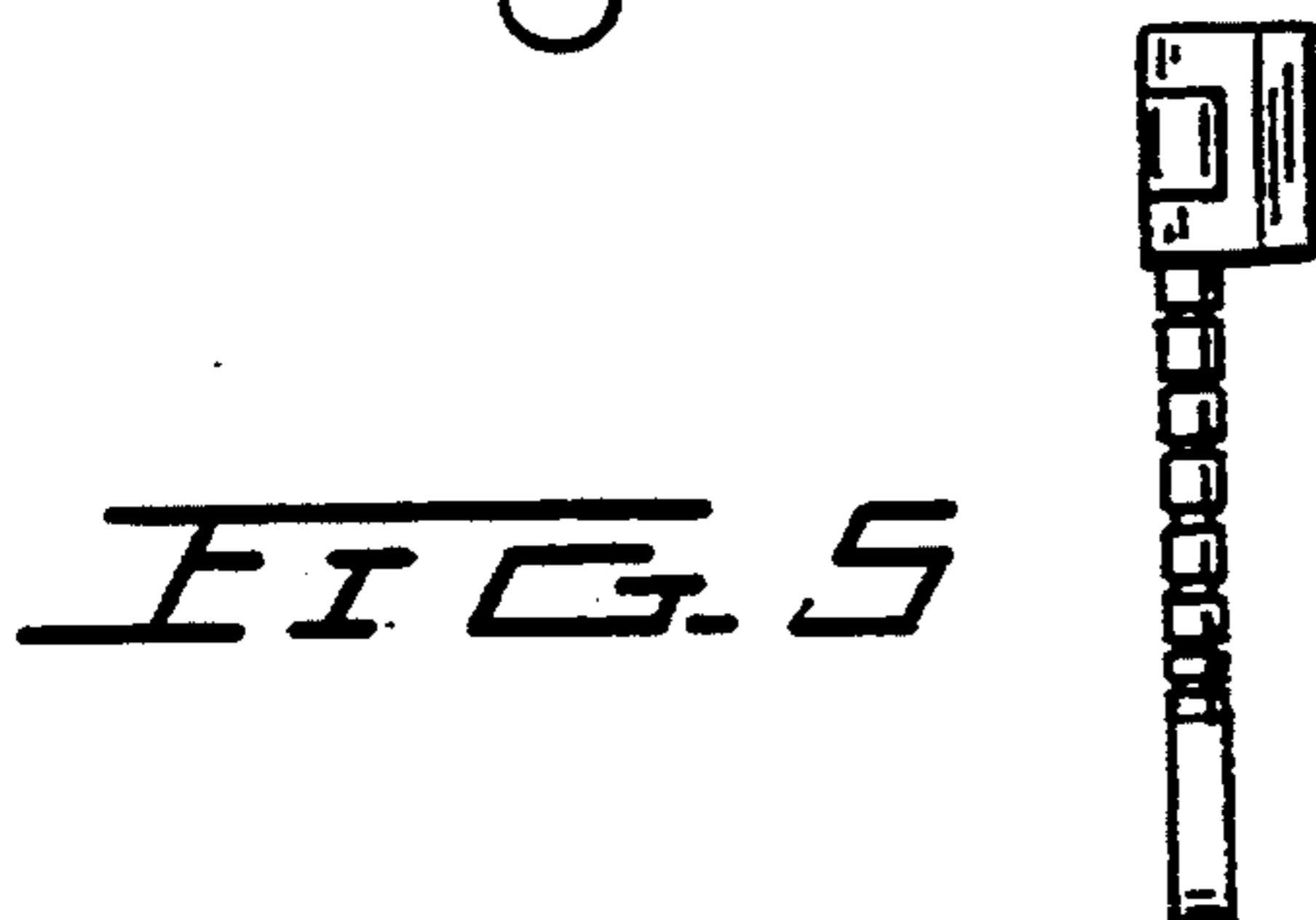

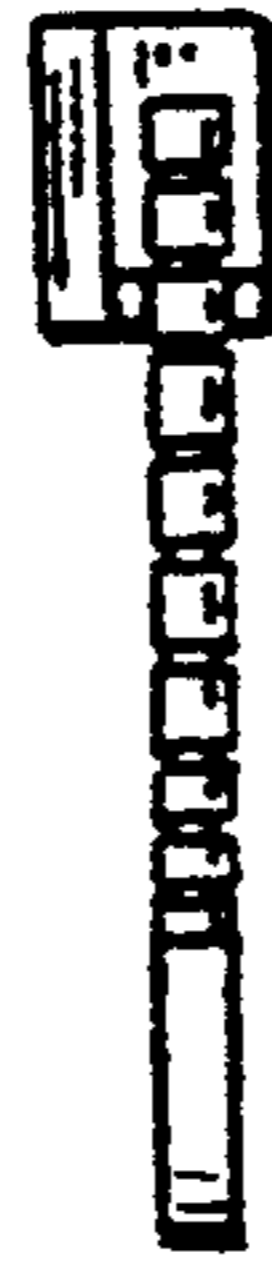

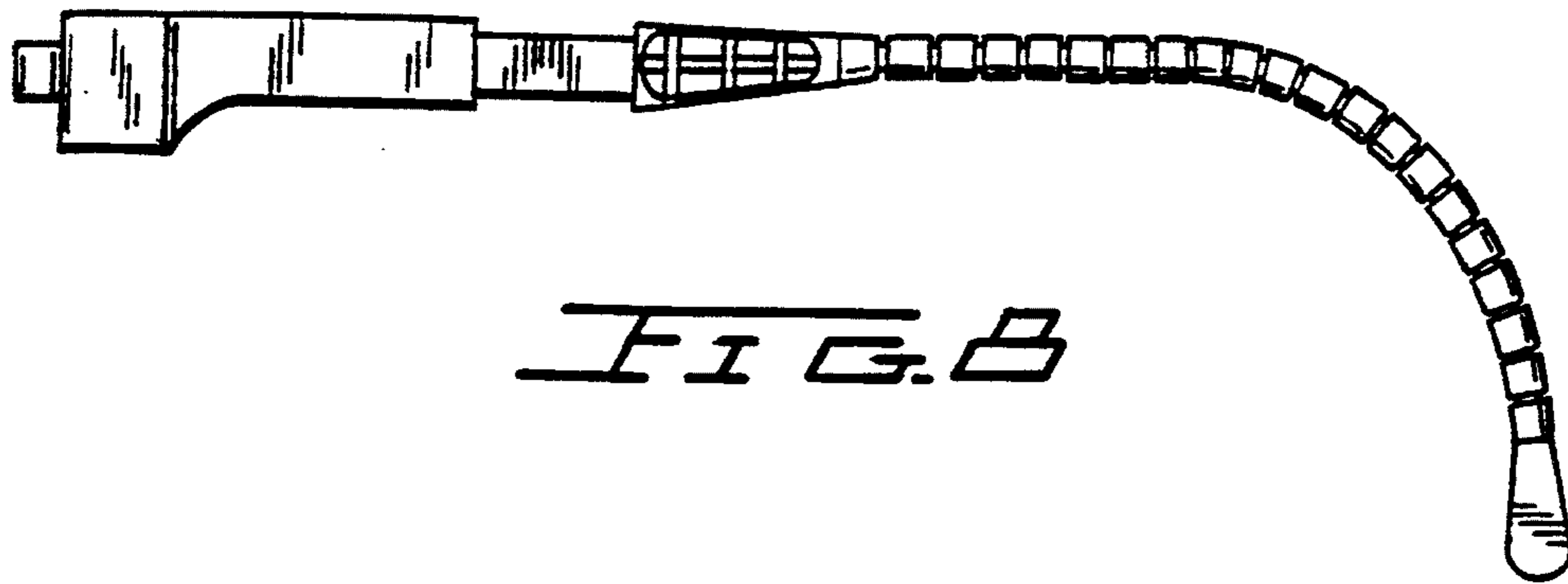

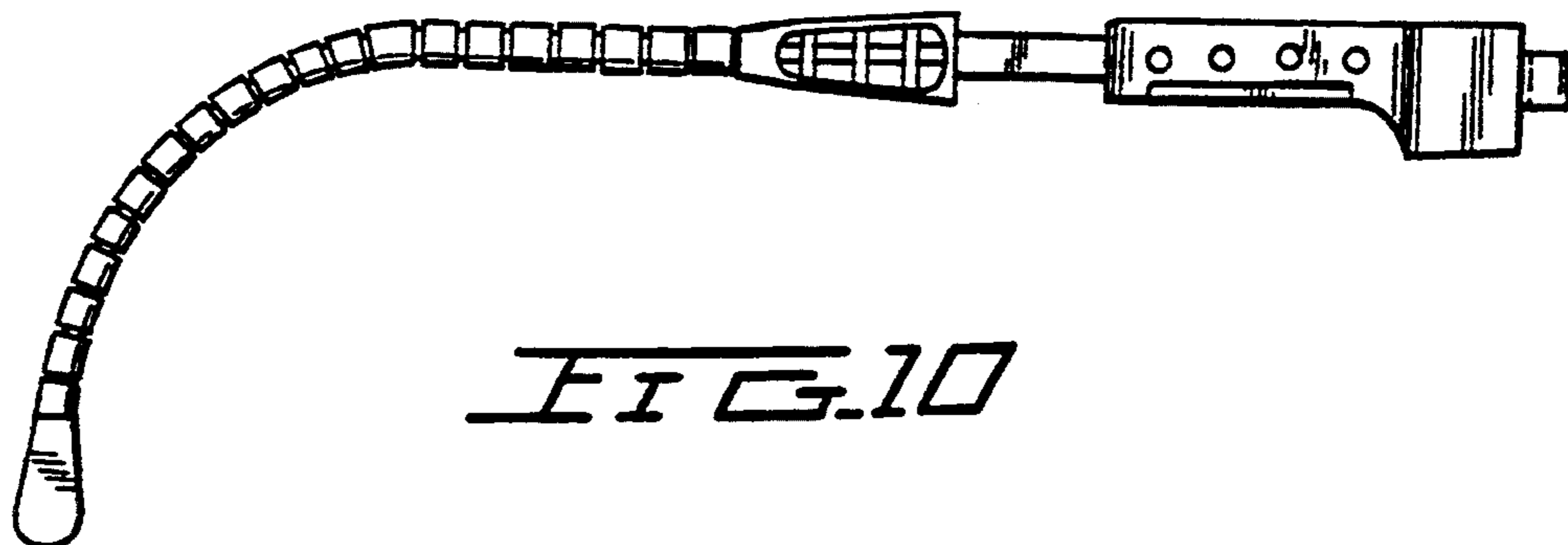
