[57] **CLAIM**

The ornamental design for a golf putter grip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf putter grip showing our new design with a putter depicted in dotted lines for illustrative purposes only;

FIG. 2 is an enlarged top plan view thereof;

FIG. 3 is a left side elevation of FIG. 2;

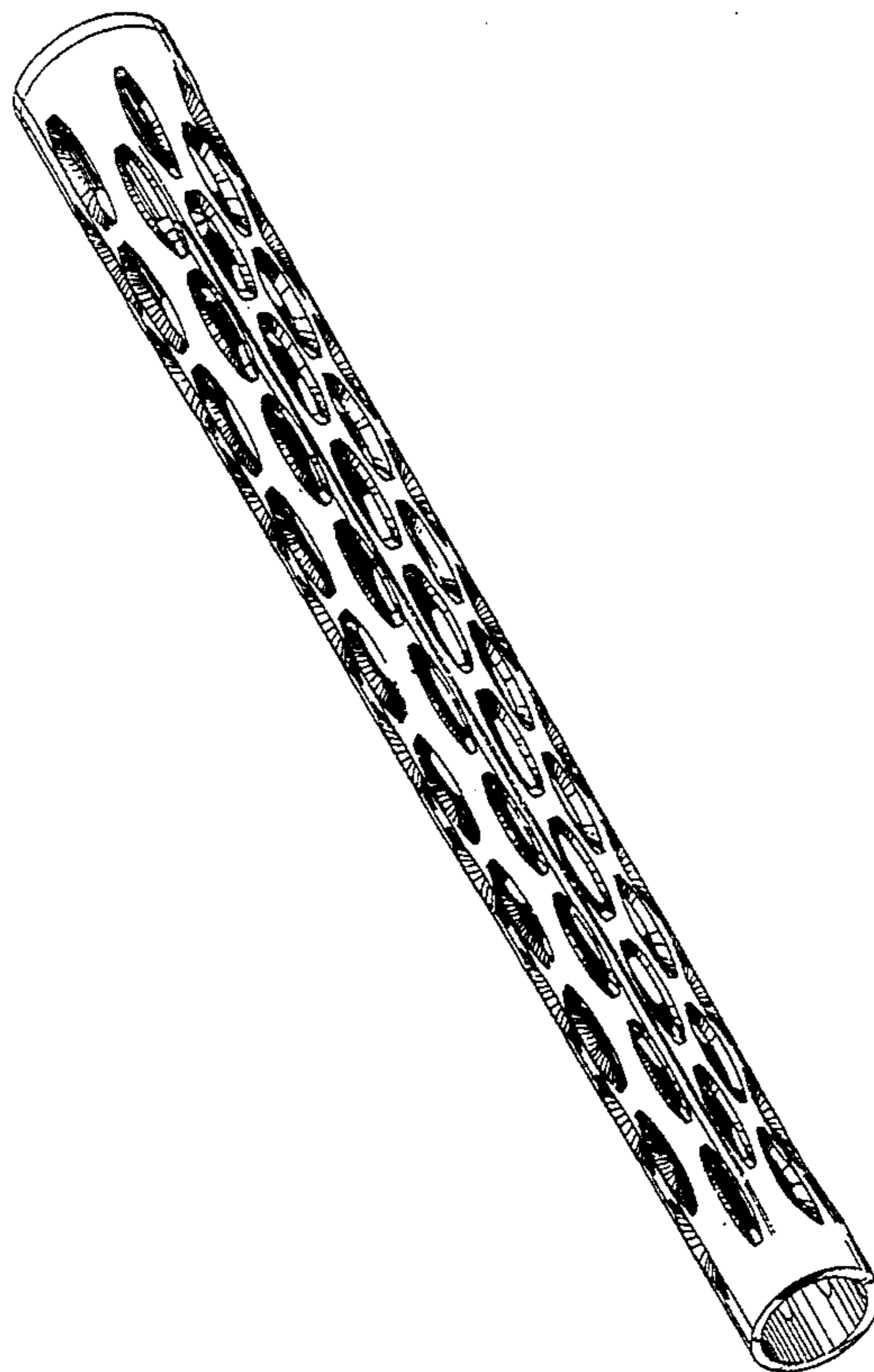
FIG. 4 is a right side elevation thereof;

FIG. 8 is an enlarged perspective view of the golf putter grip removed from the putter.



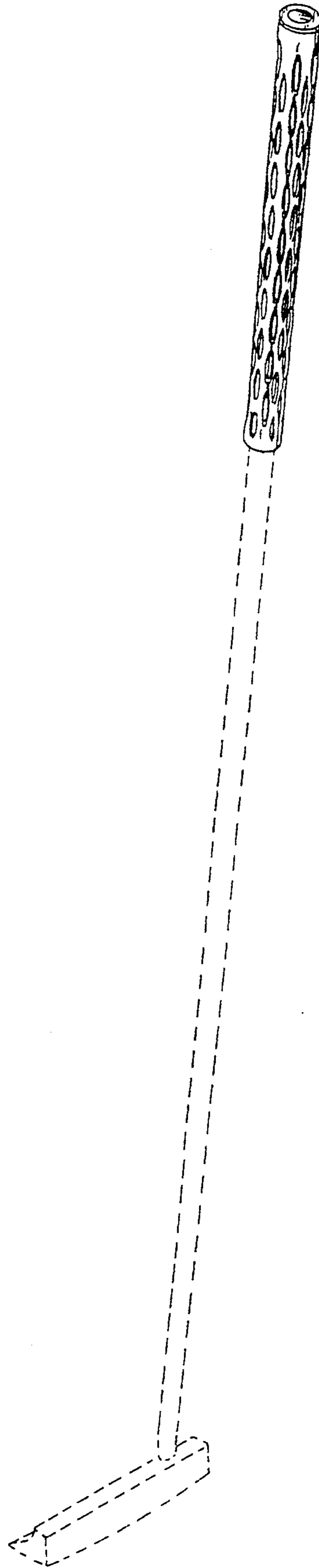

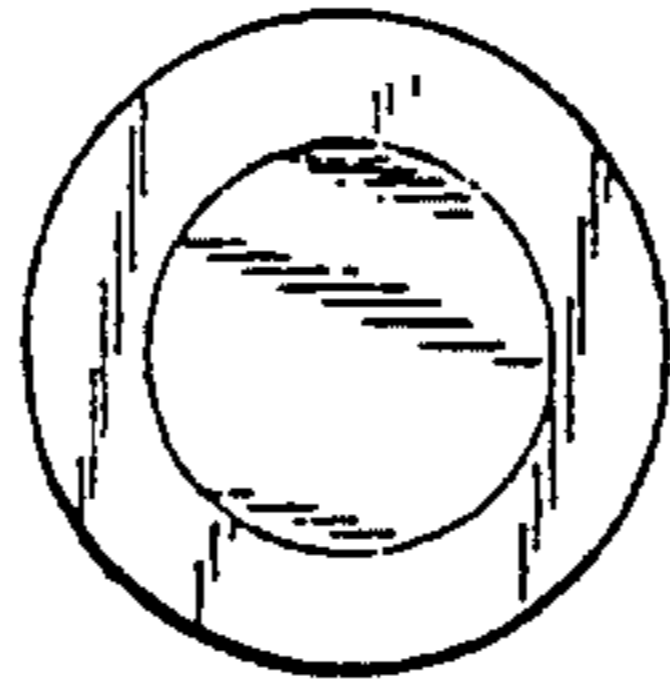

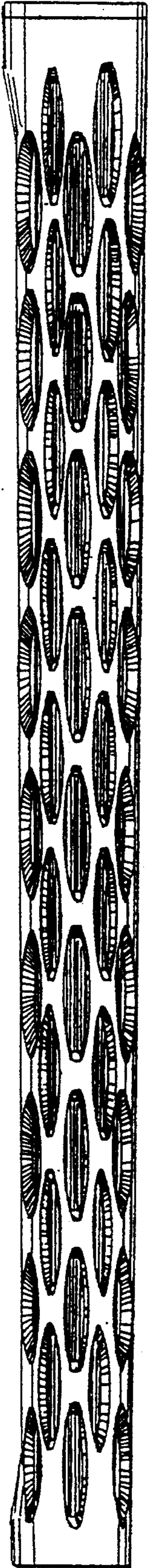

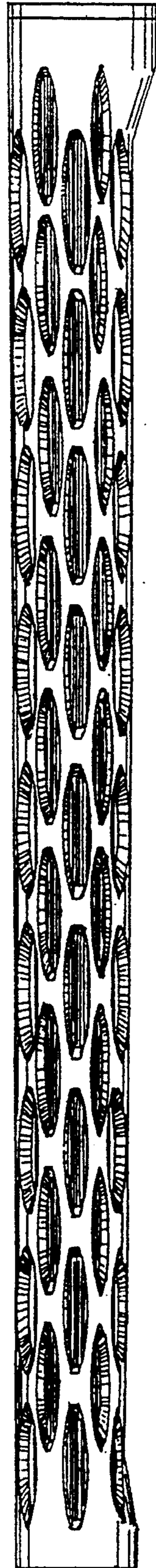

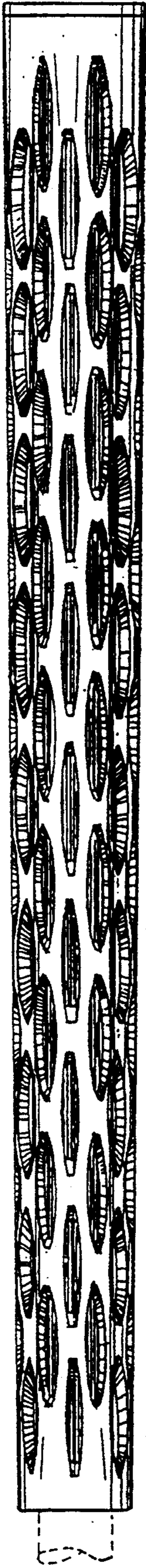

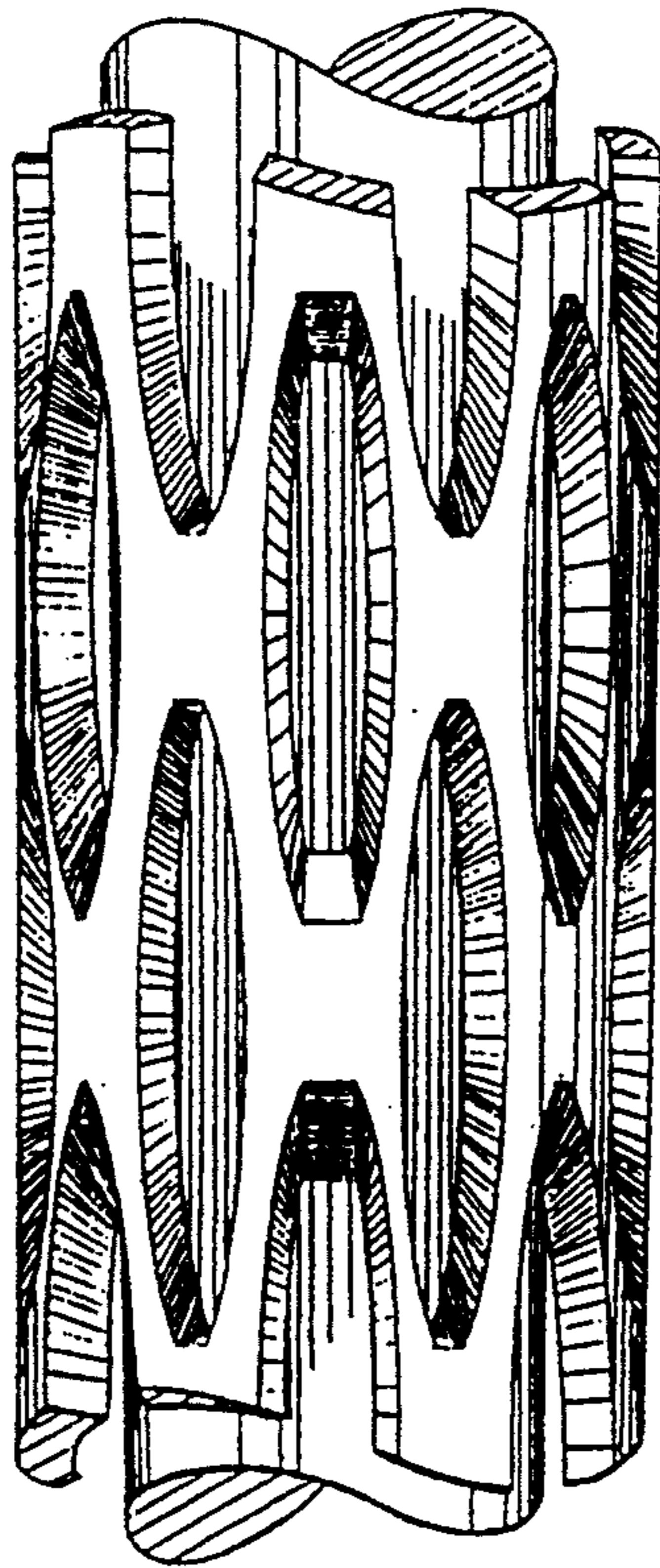

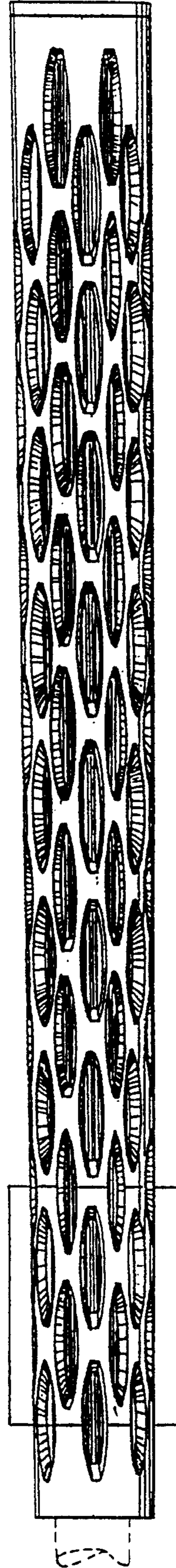

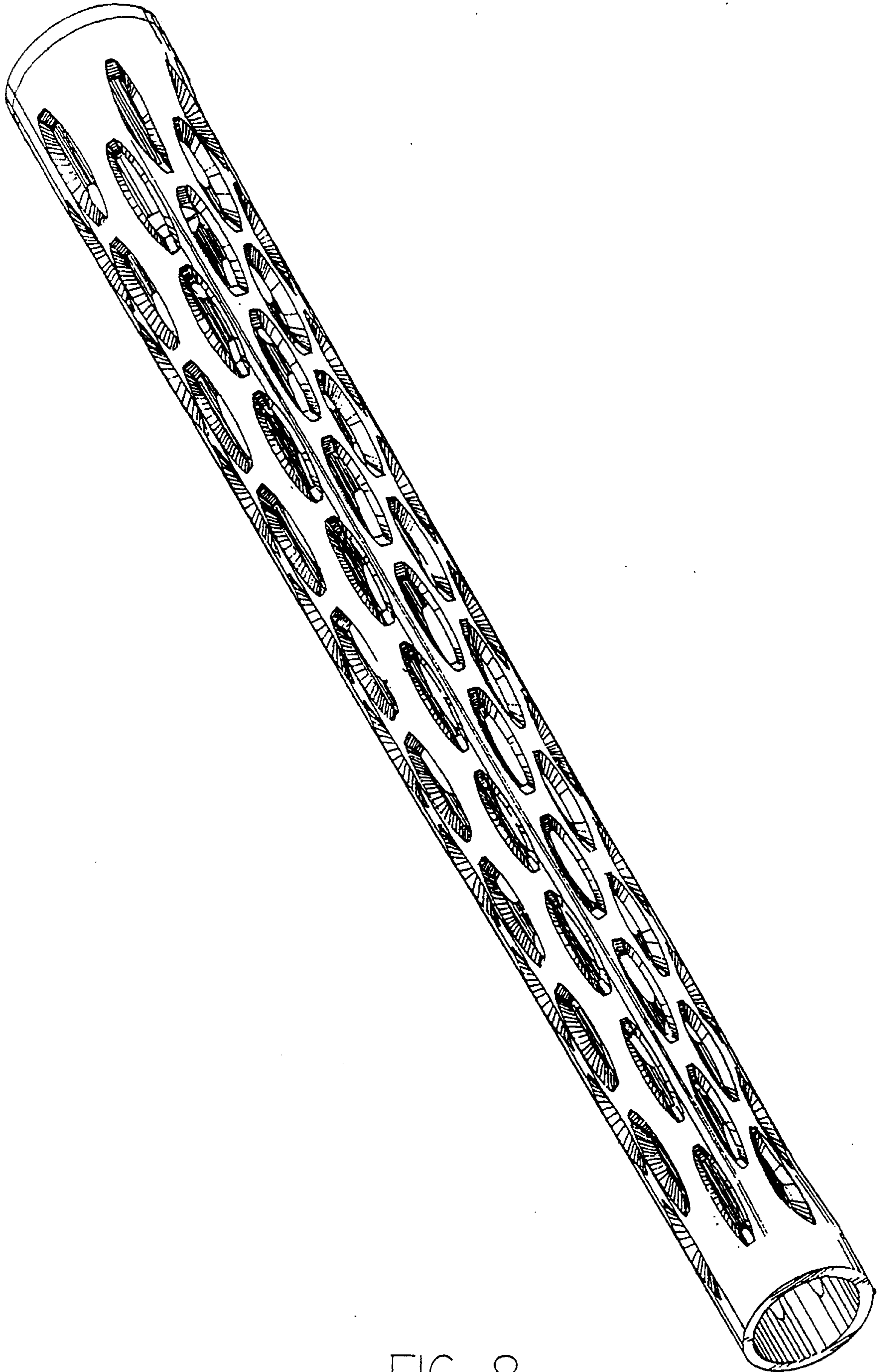
