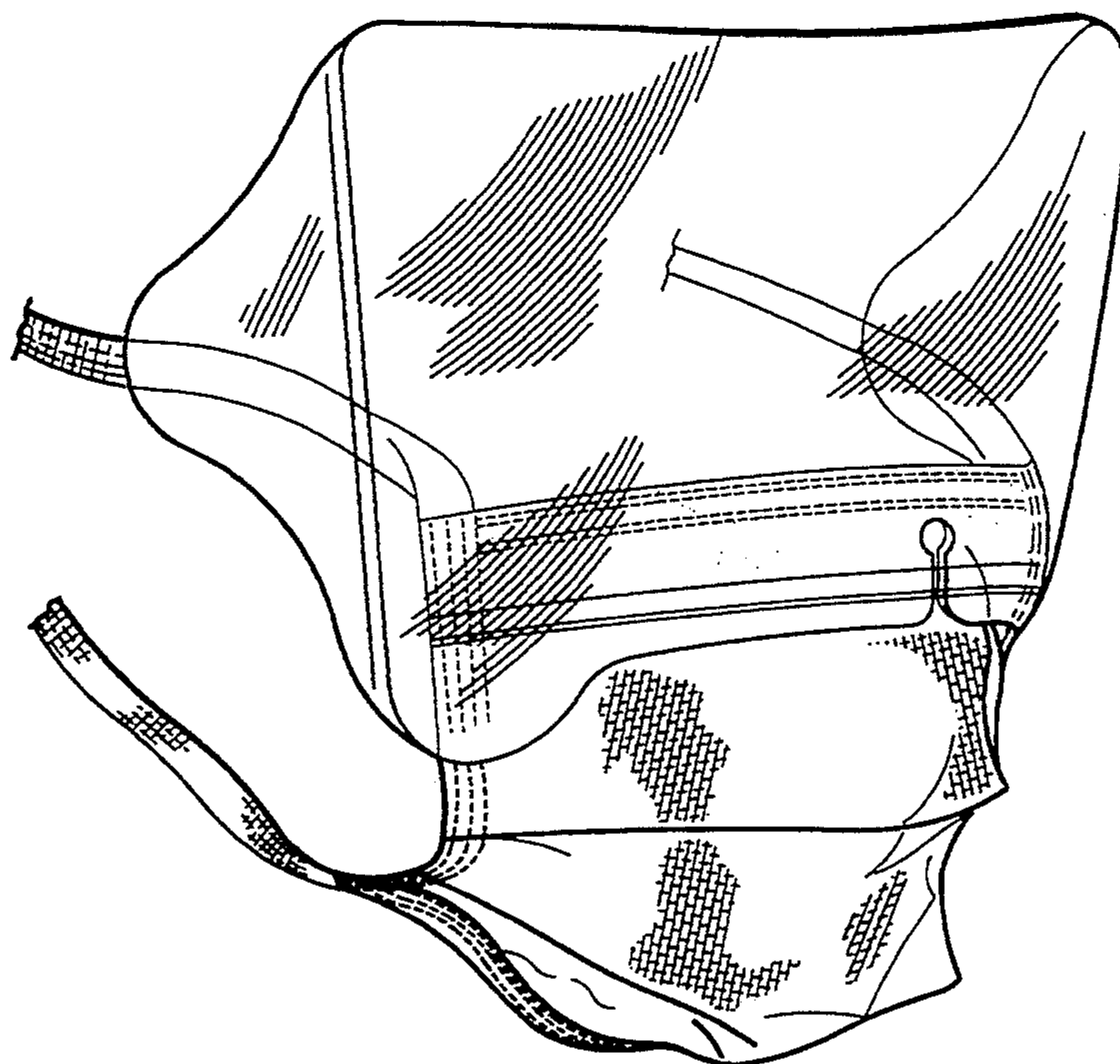

[57] **CLAIM**

The ornamental design for a combined face mask and shield, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a combined face mask and shield, showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; and, FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof.



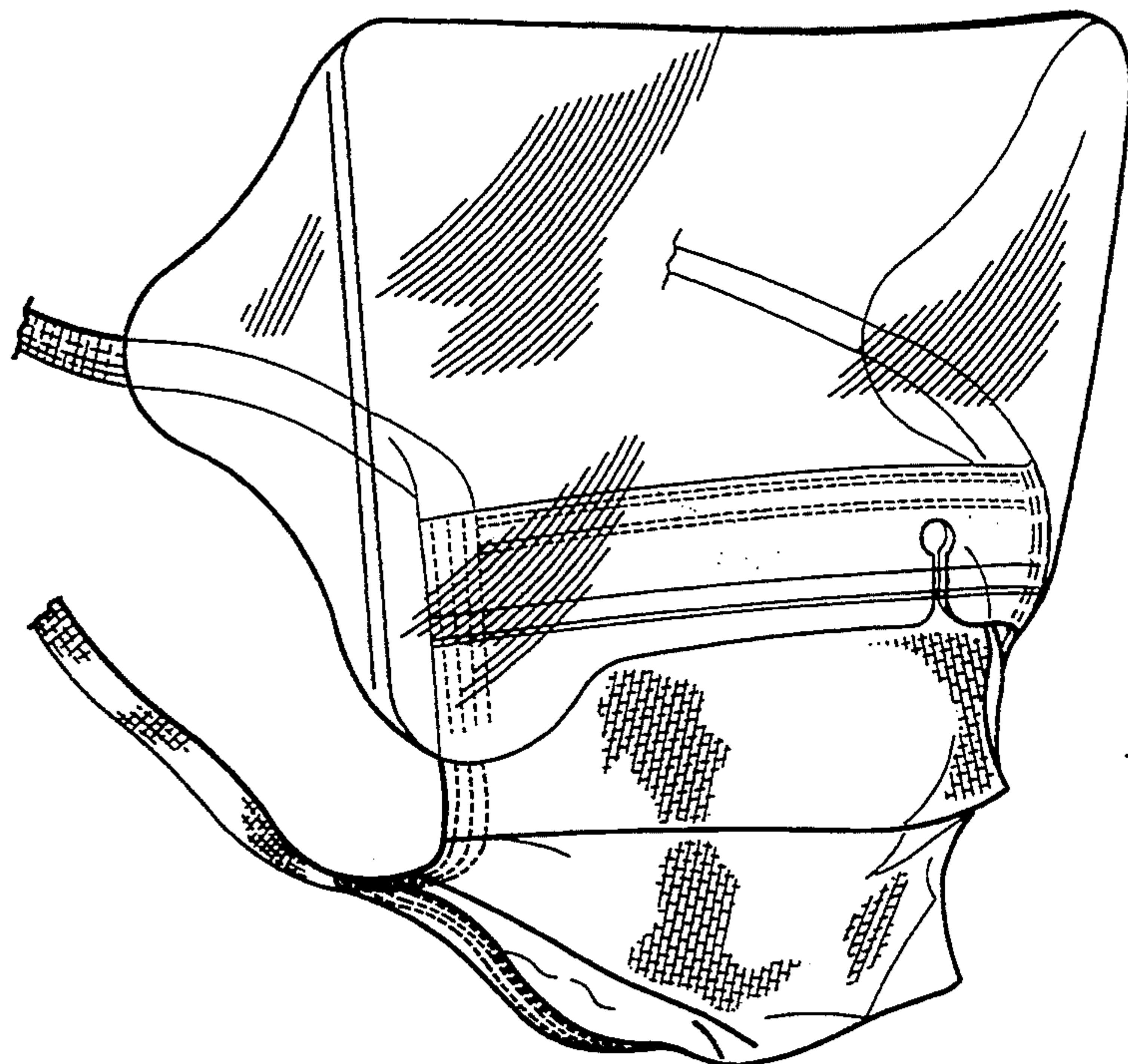

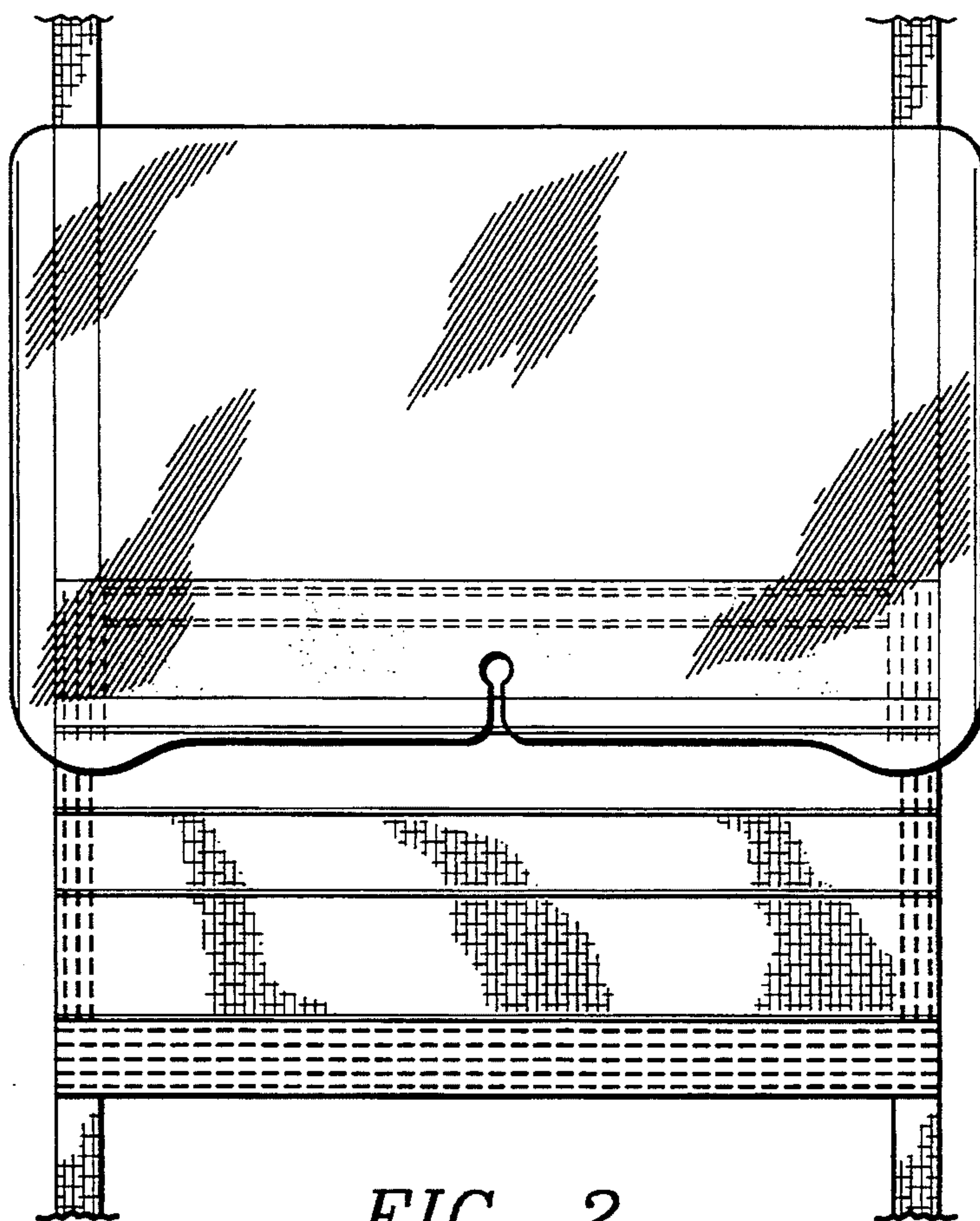

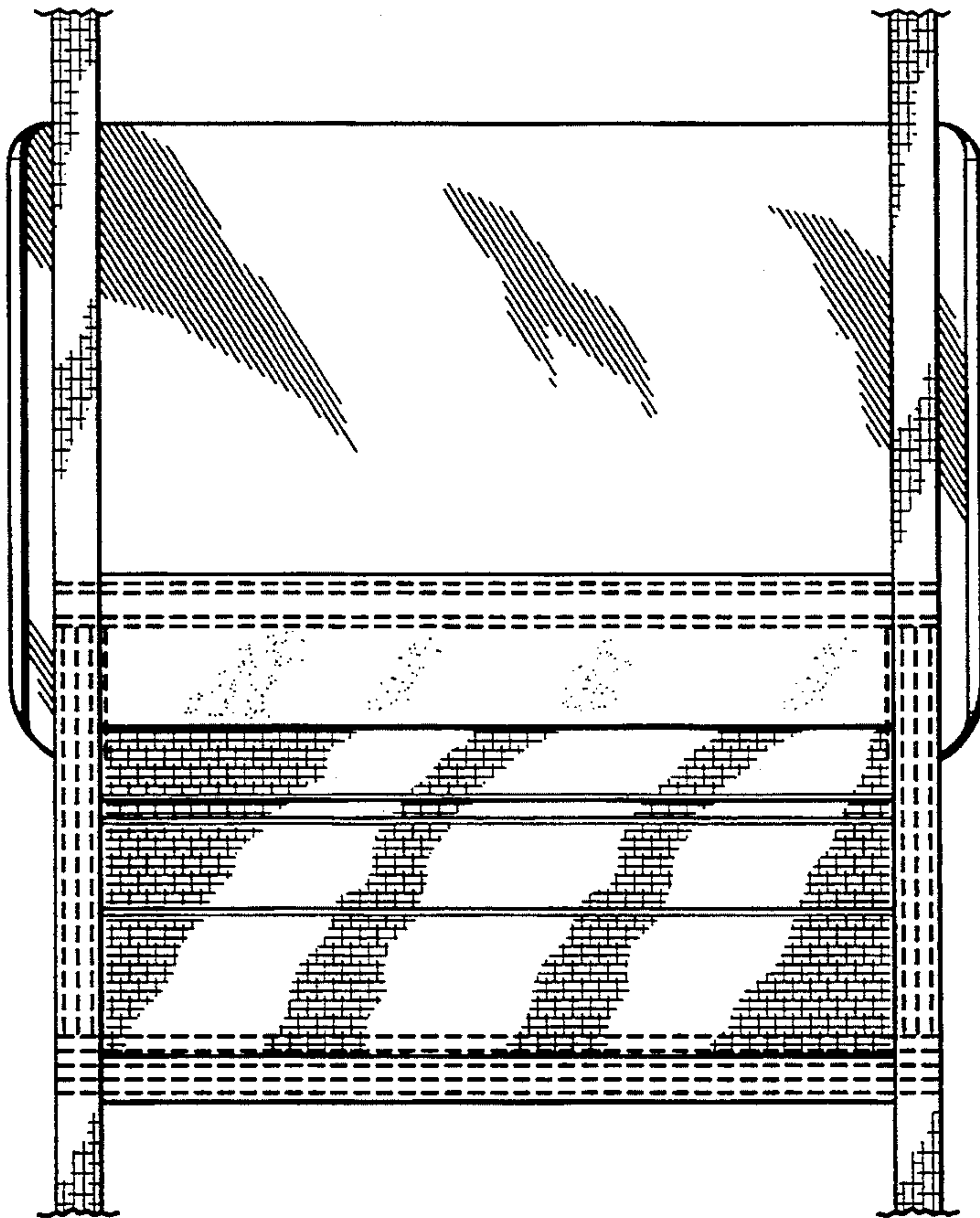

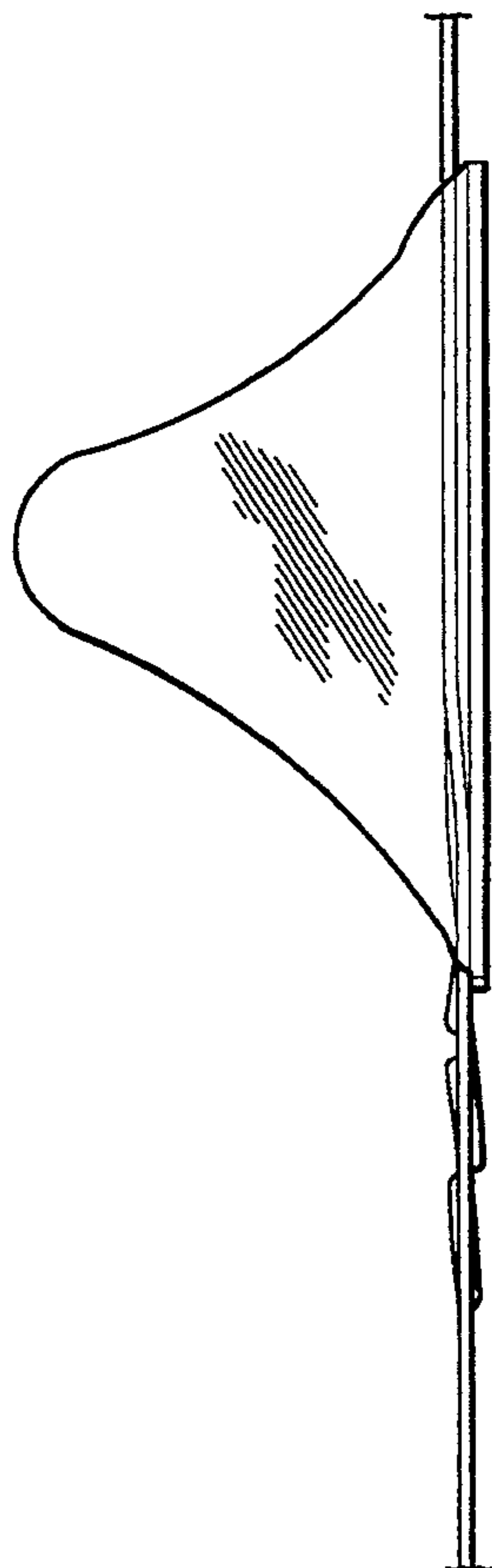
