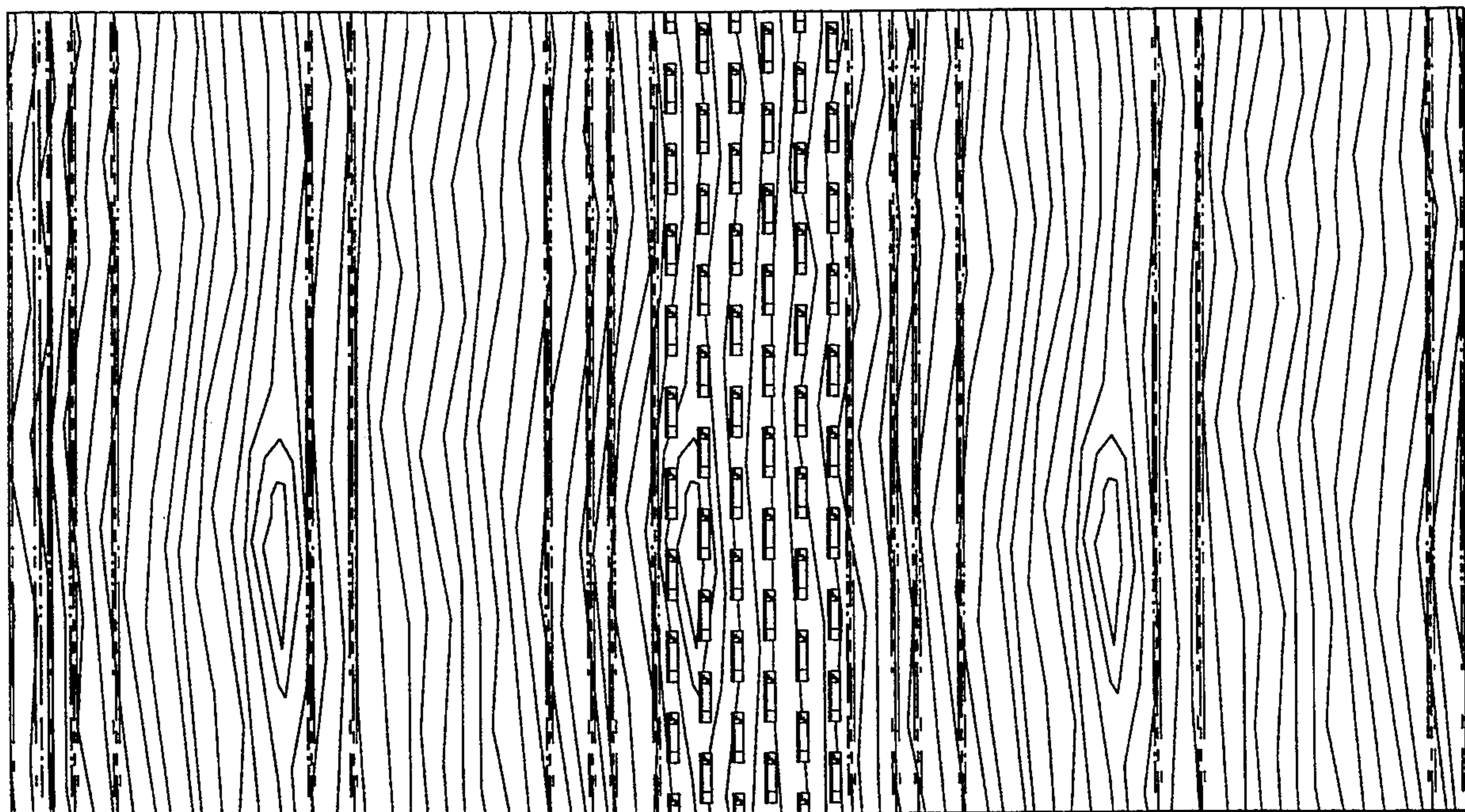
[57] **CLAIM**

The ornamental design for a mobile home skirting panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a mobile home skirting panel showing my new design;

 FIG. 20 is a left side elevational view thereof;  
 FIG. 21 is a front elevational view of a fifth embodiment of my new design for a mobile home skirting panel;  
 FIG. 22 is a top plan view thereof, the bottom view being a mirror image thereof;  
 FIG. 23 is a right side elevational view thereof;

 FIG. 25 is a left side elevational view thereof.



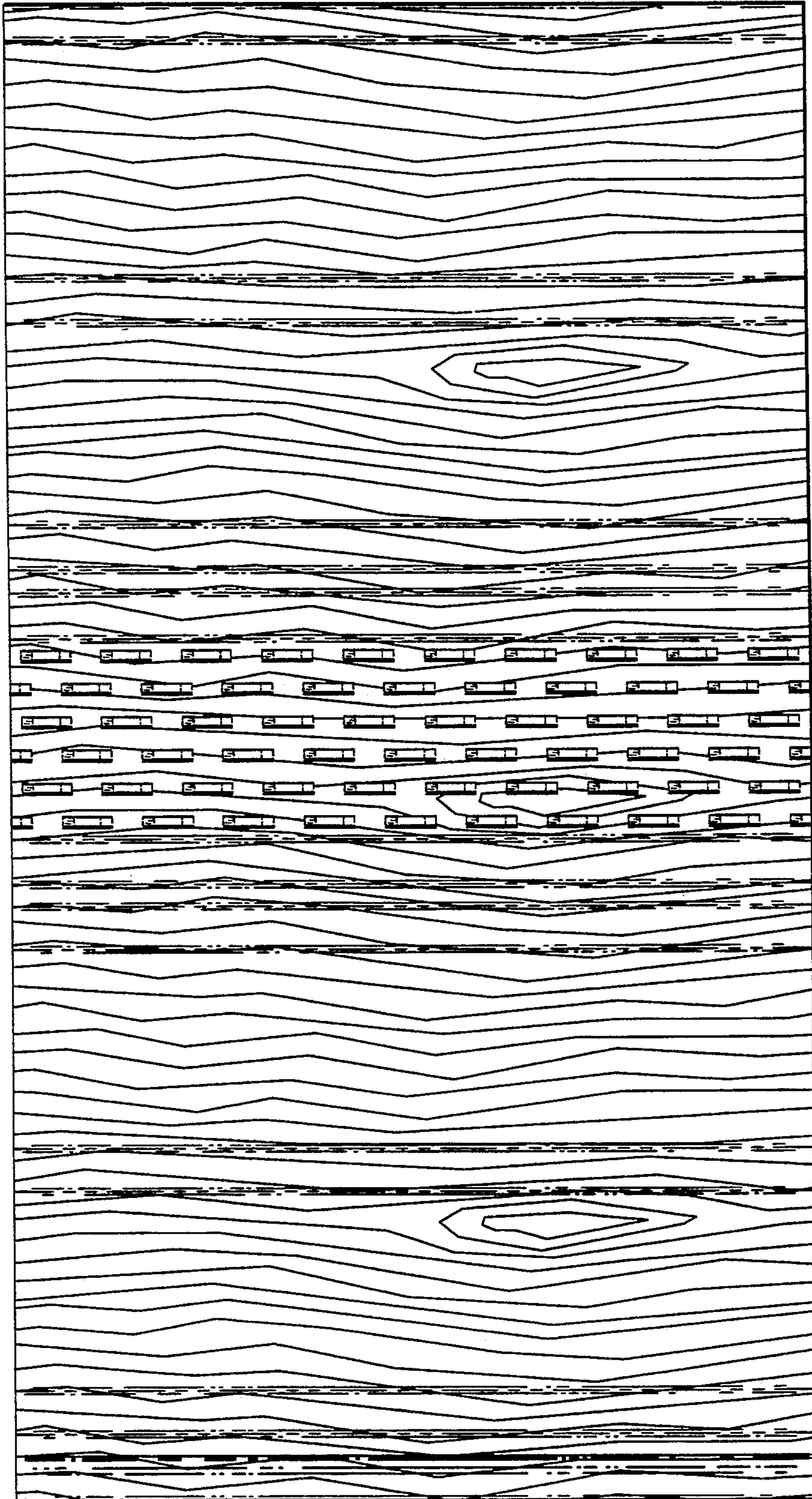

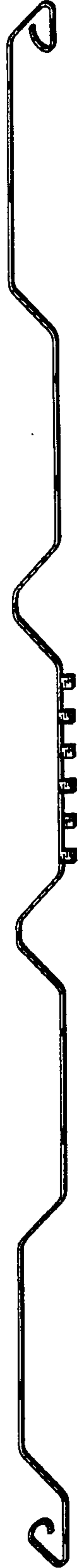

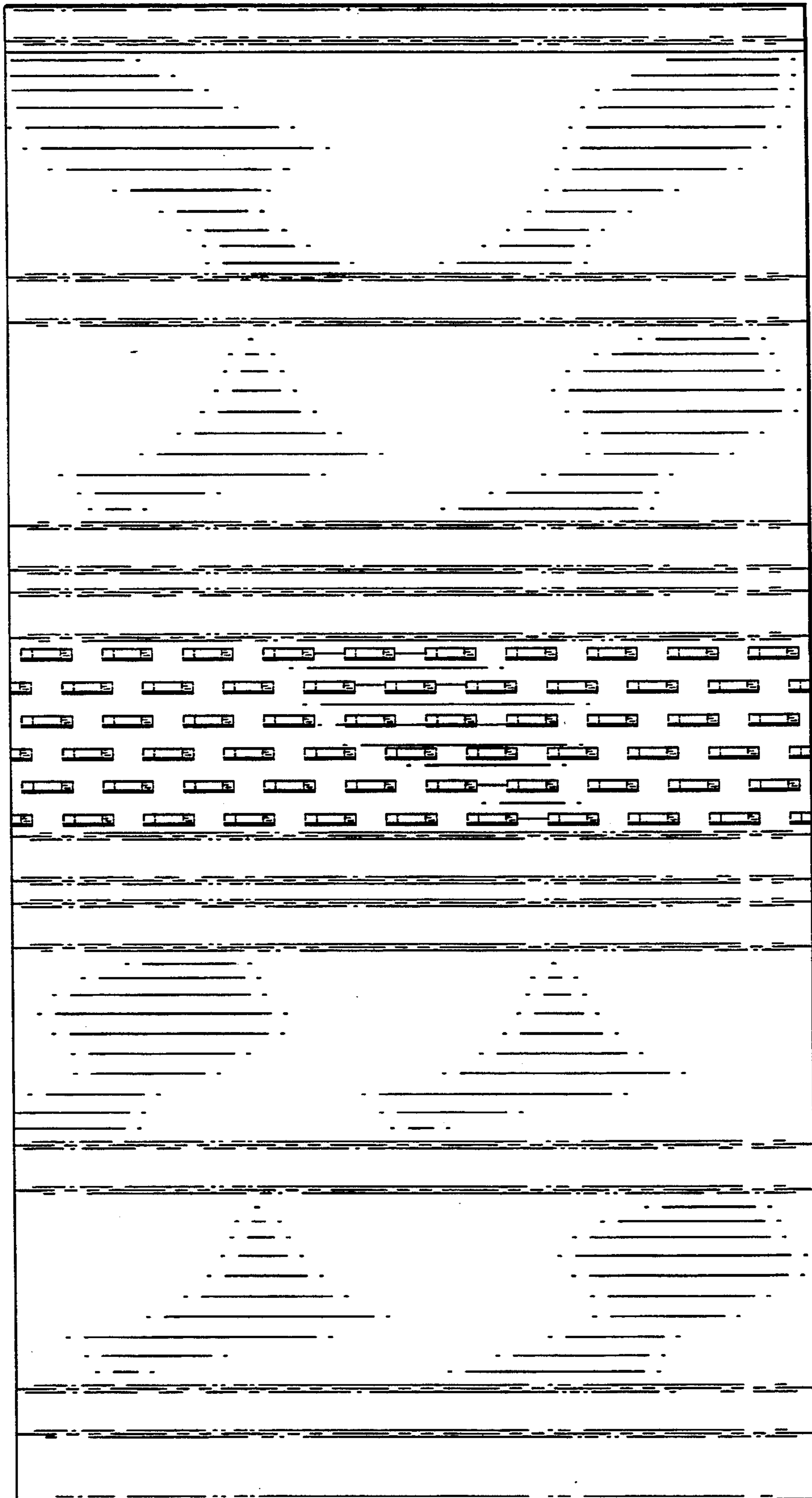

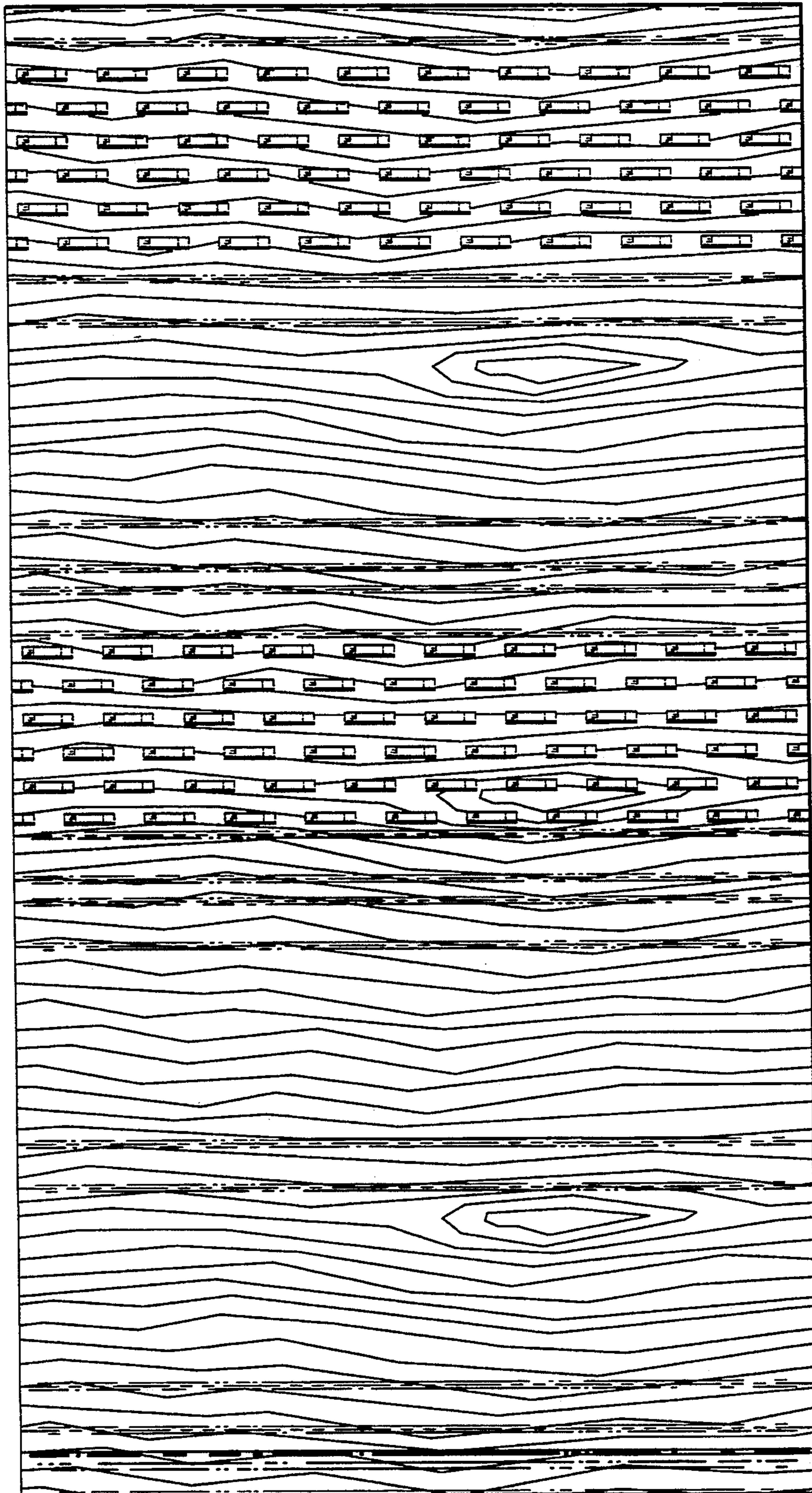

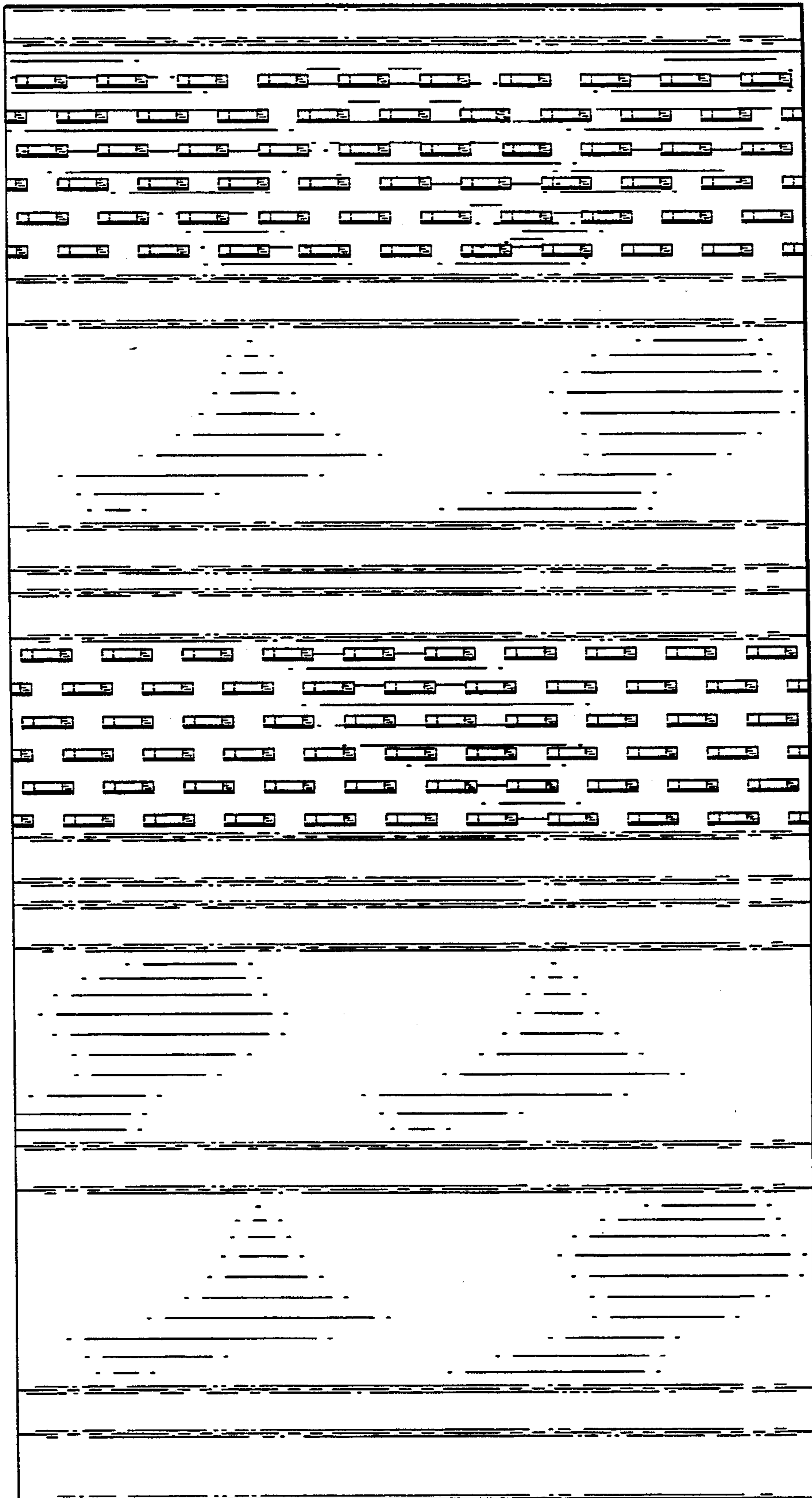
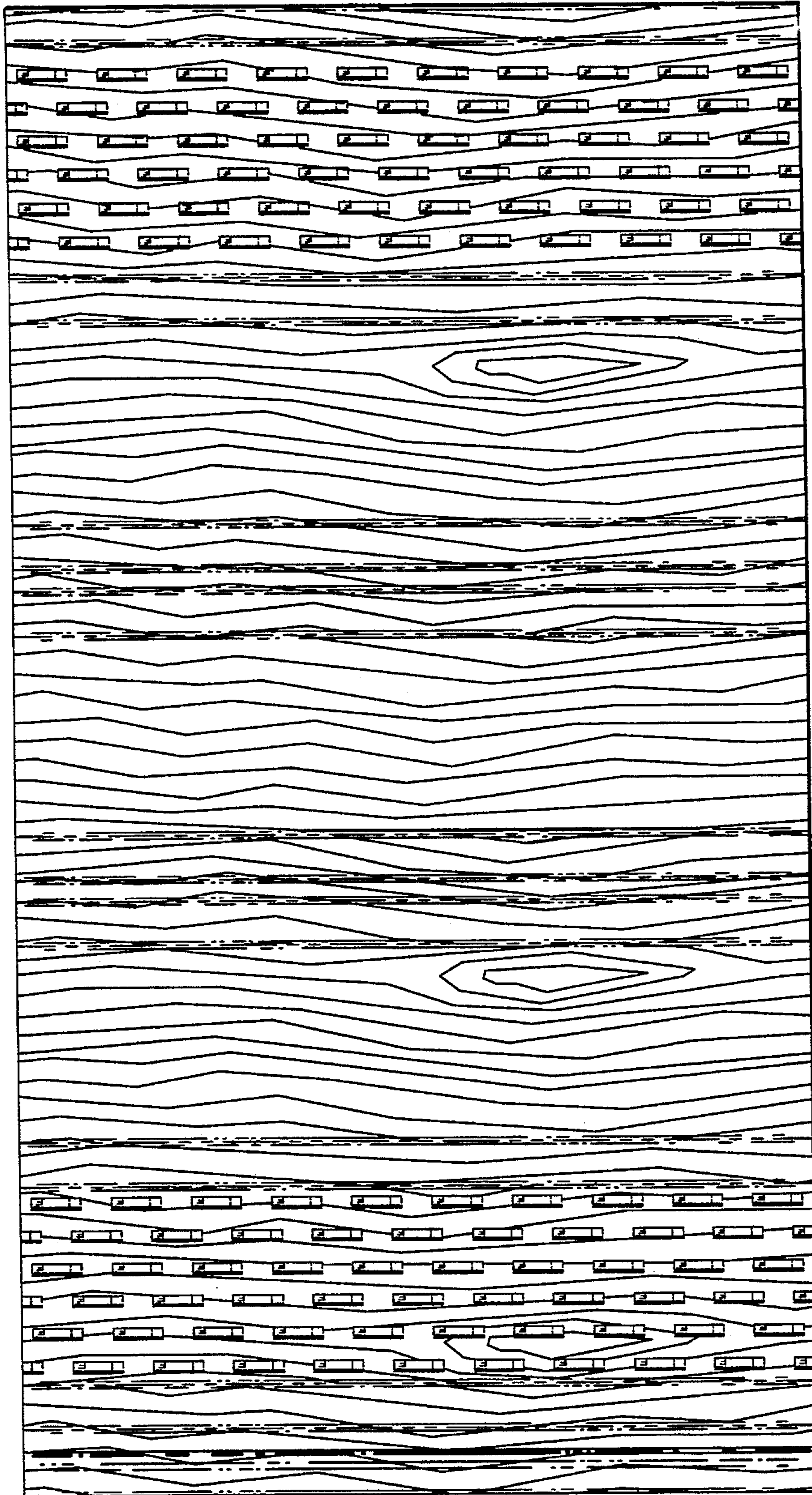


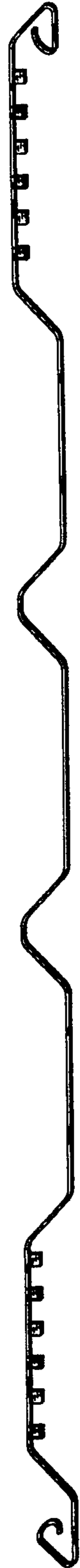

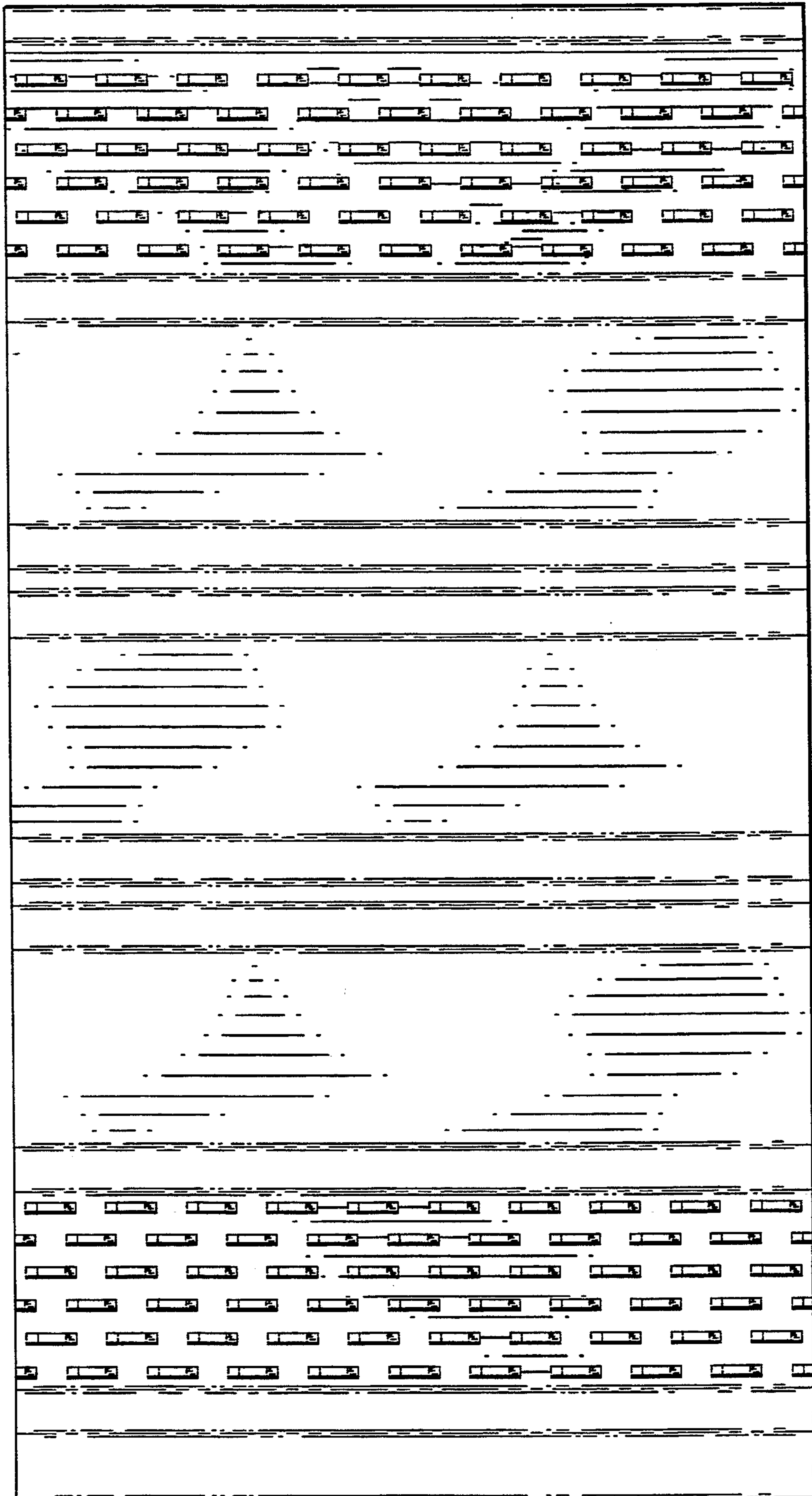

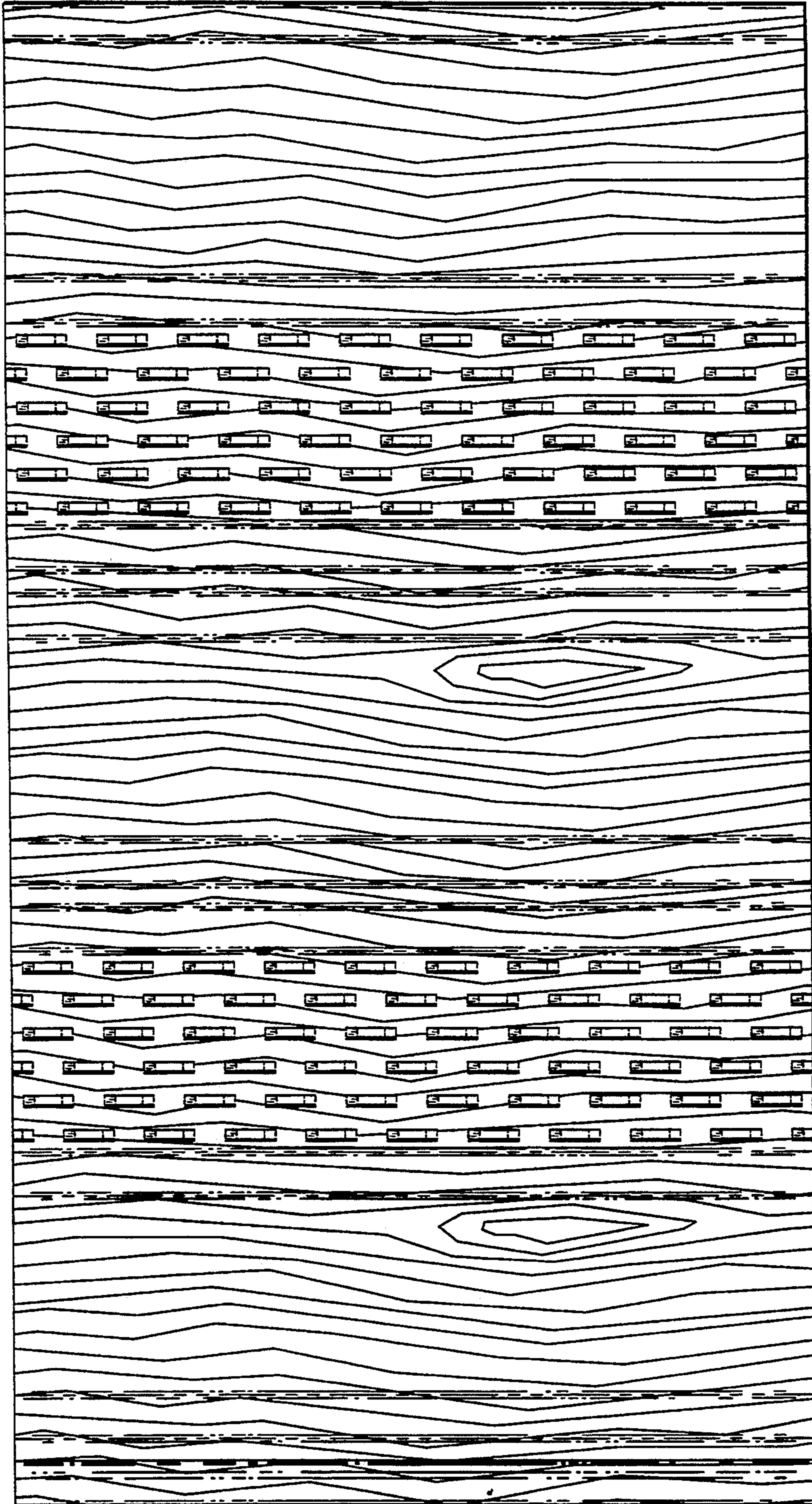

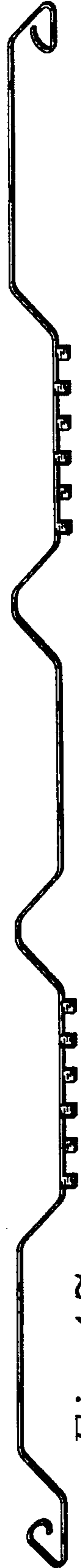

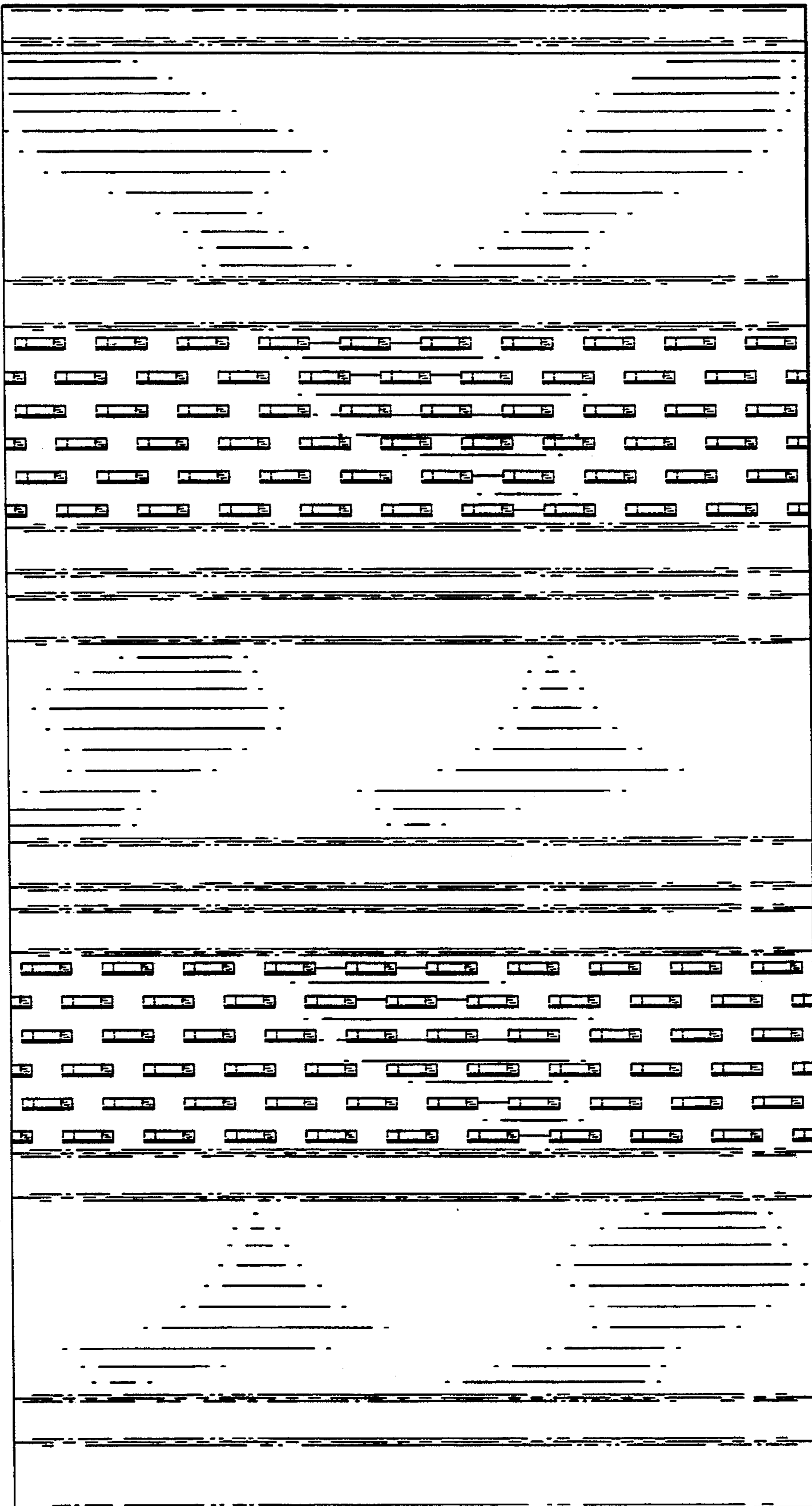

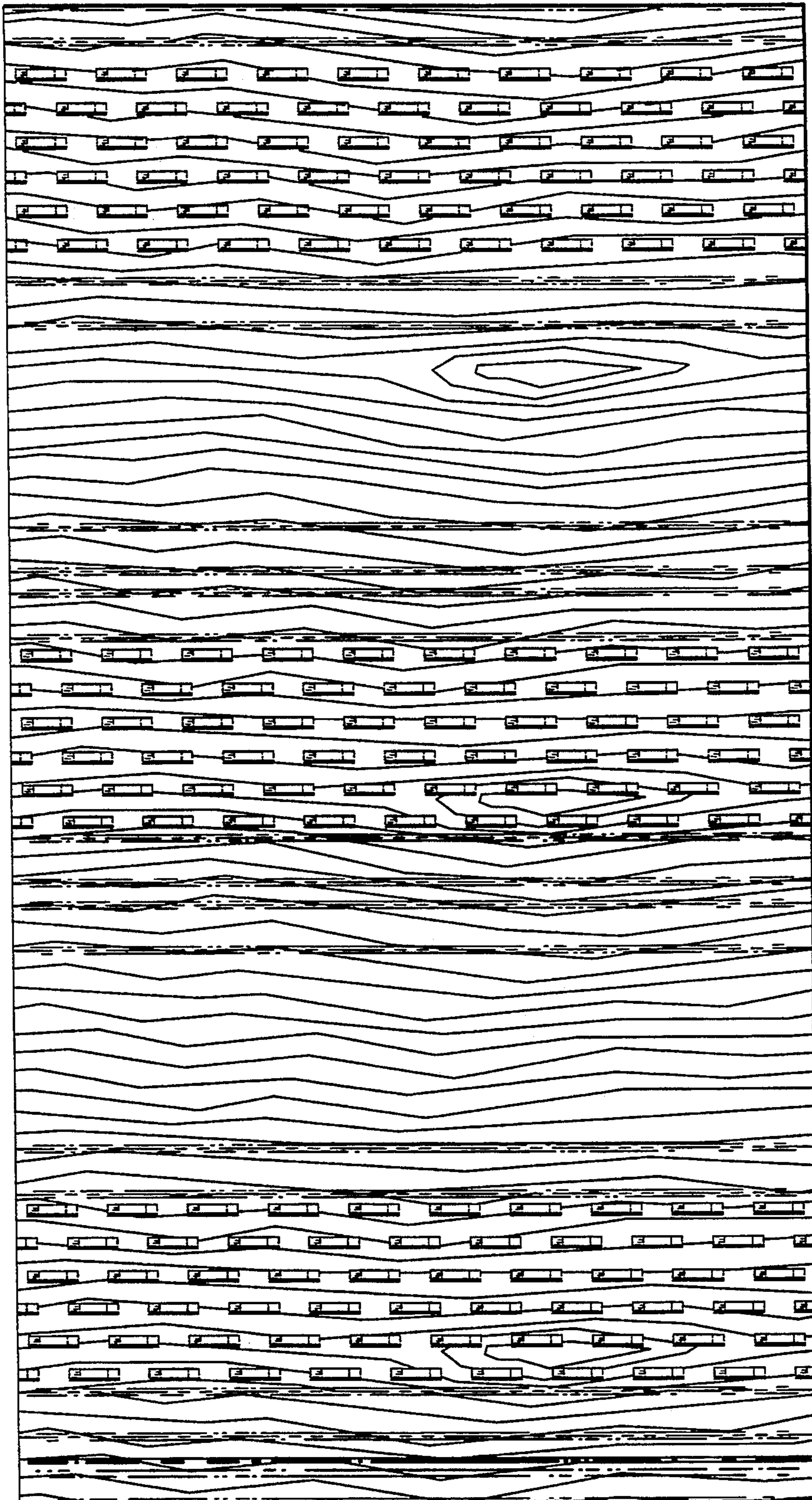

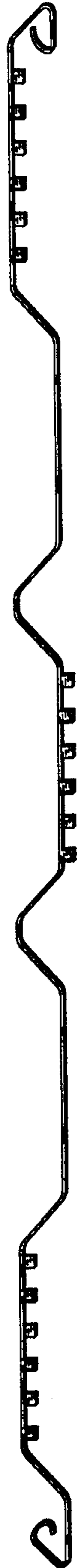

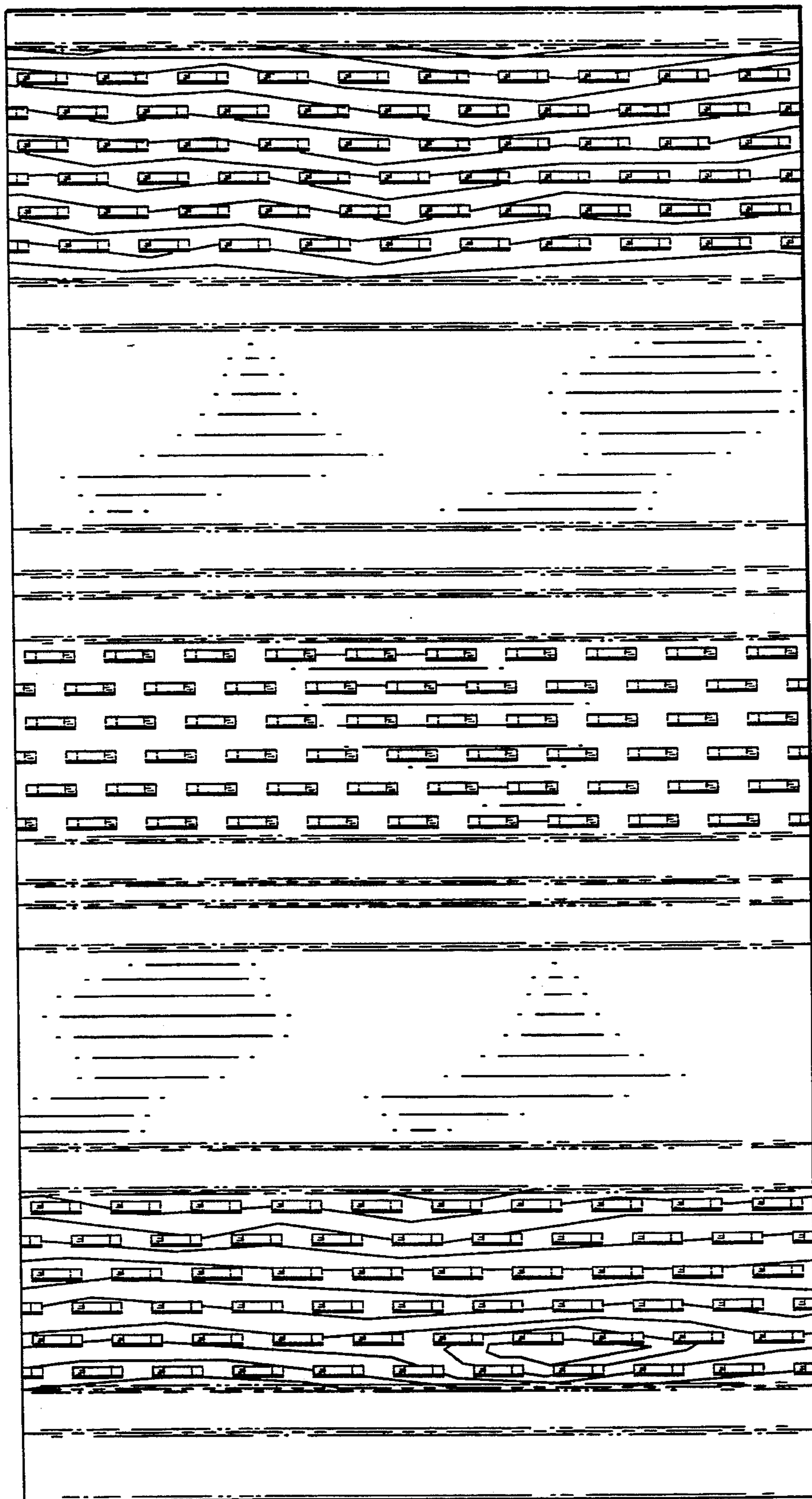
