FIG. 4 is a bottom elevational view thereof;

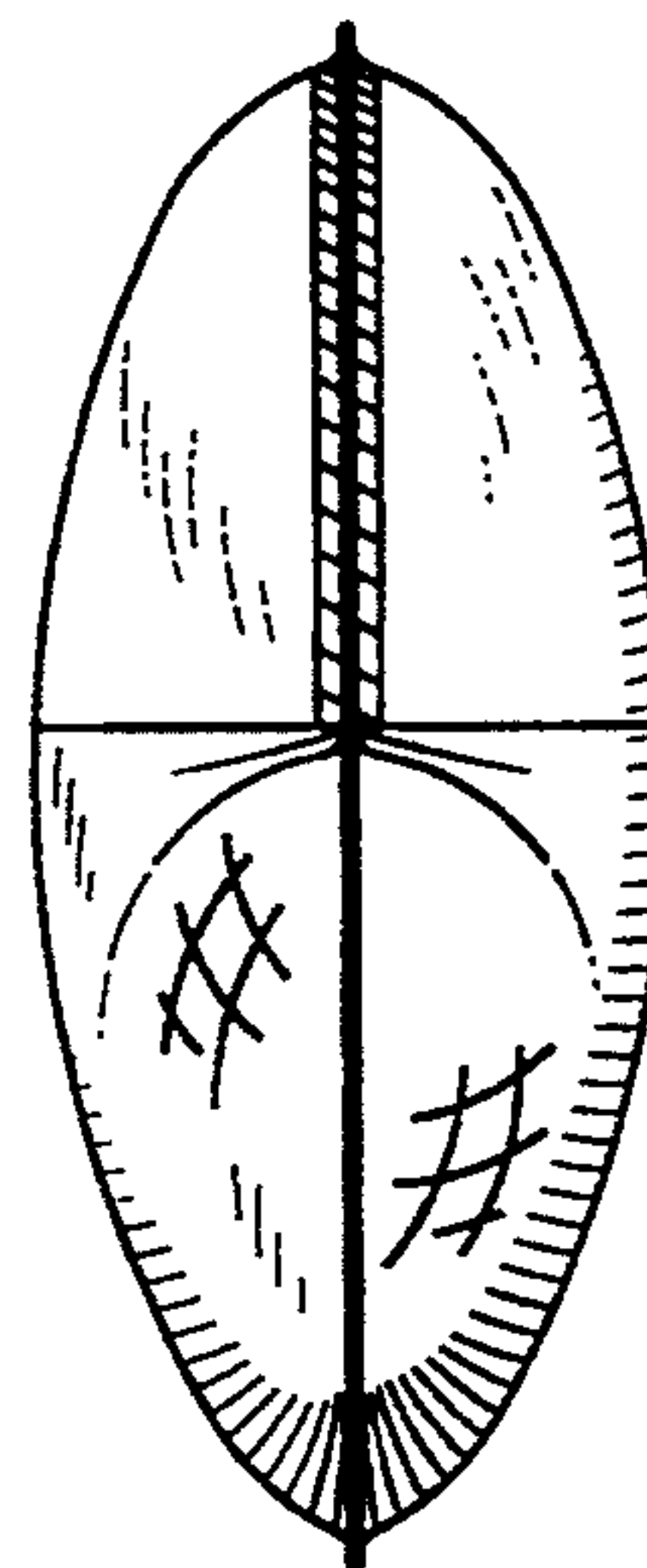
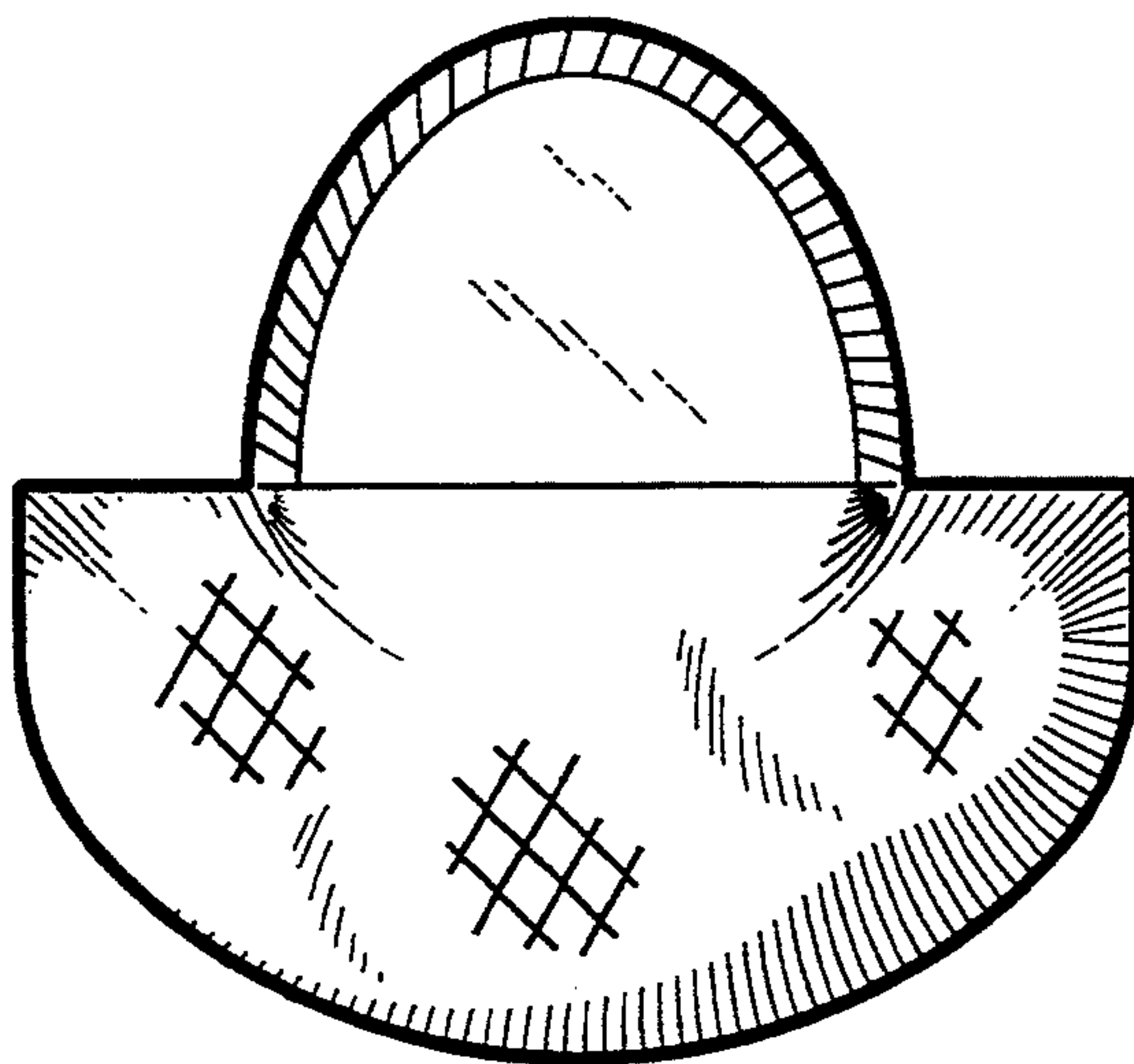
FIG. 5 is a right side elevational view thereof; and,

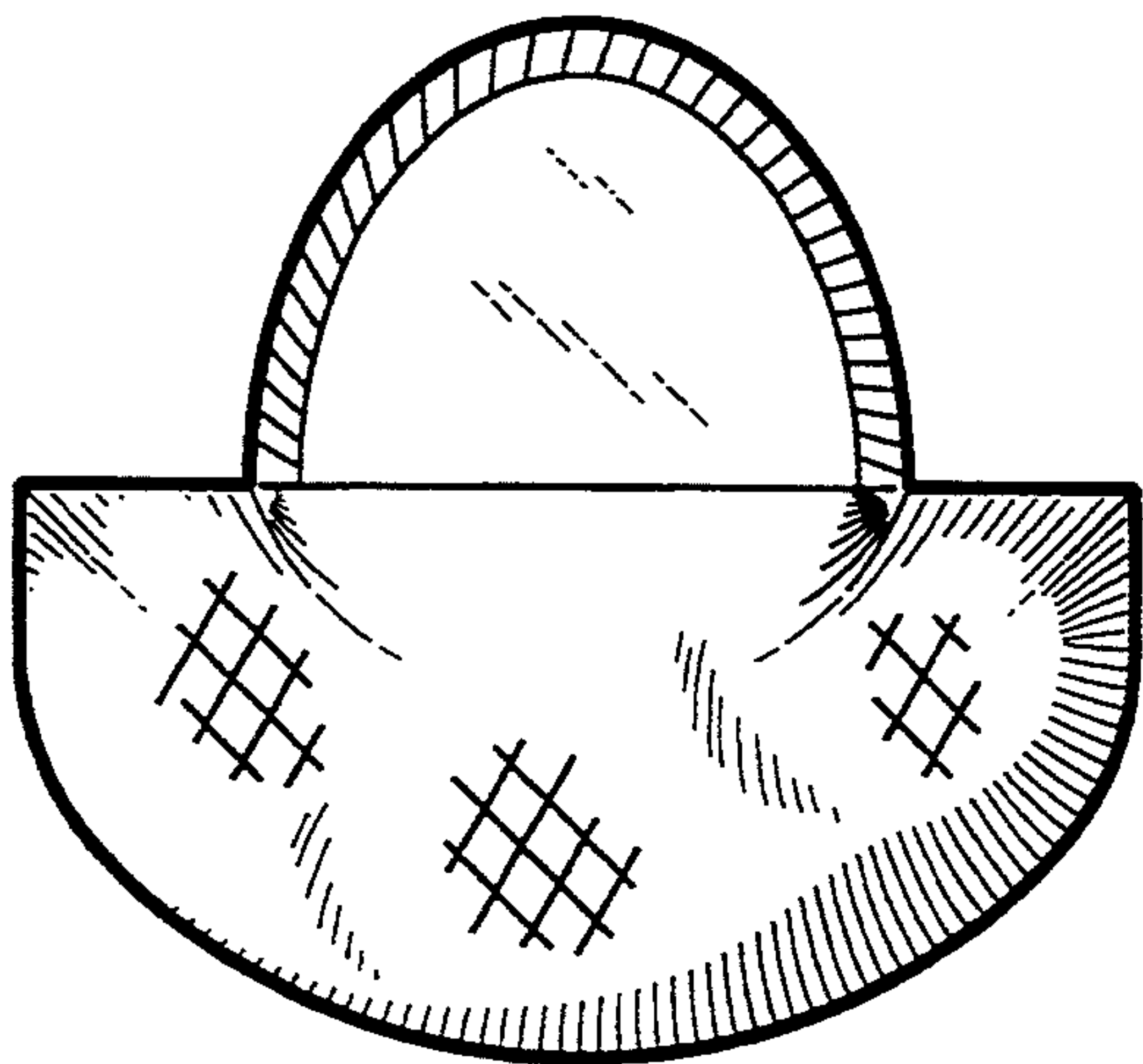

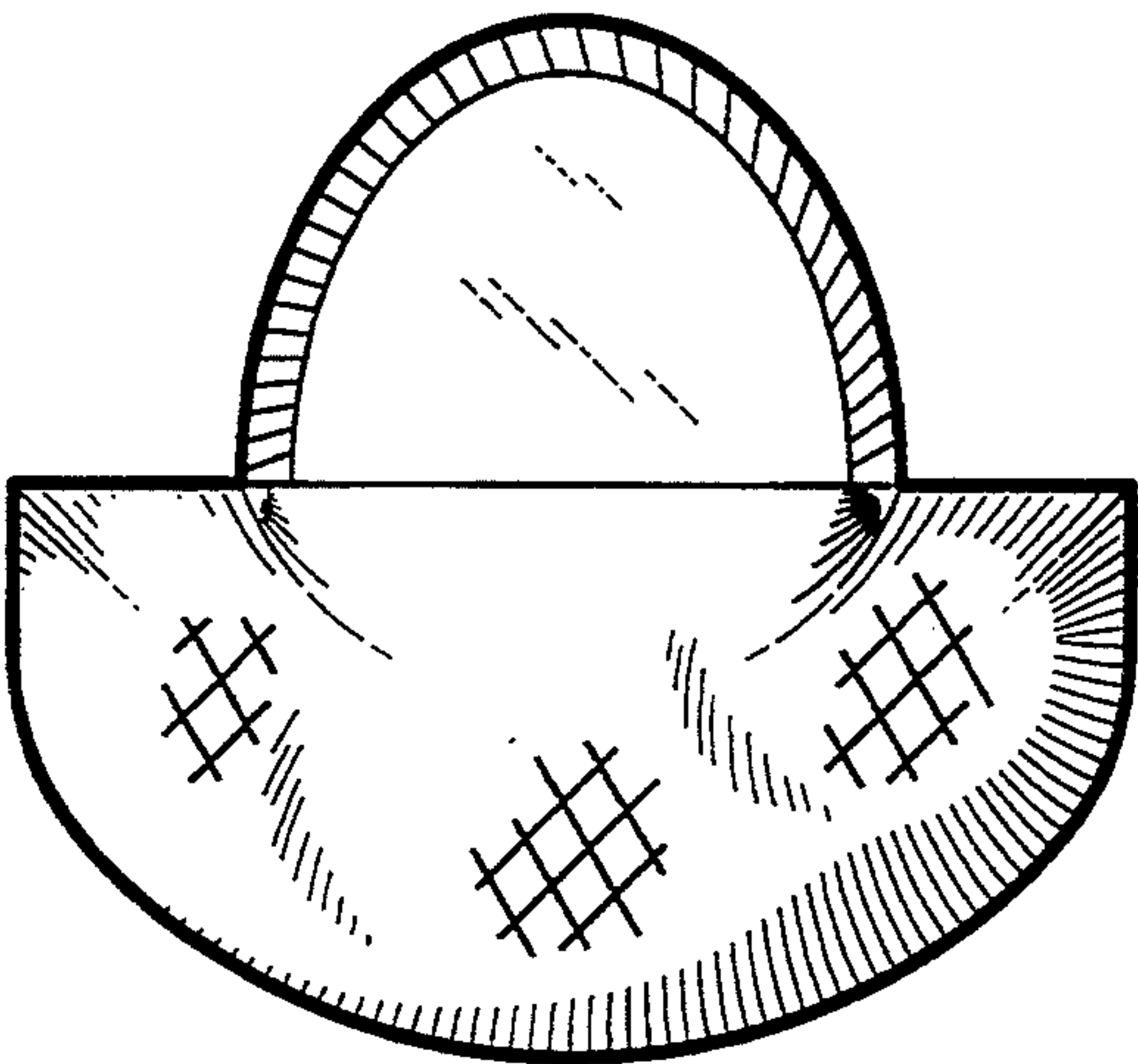

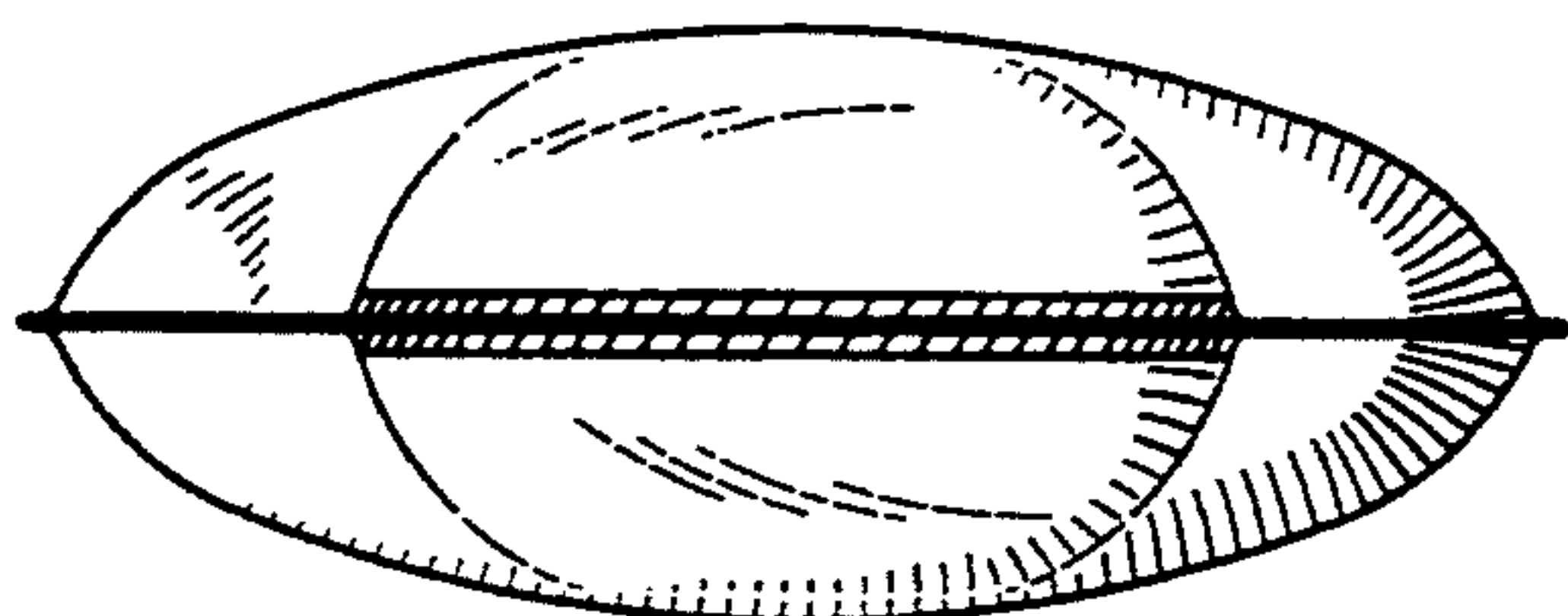

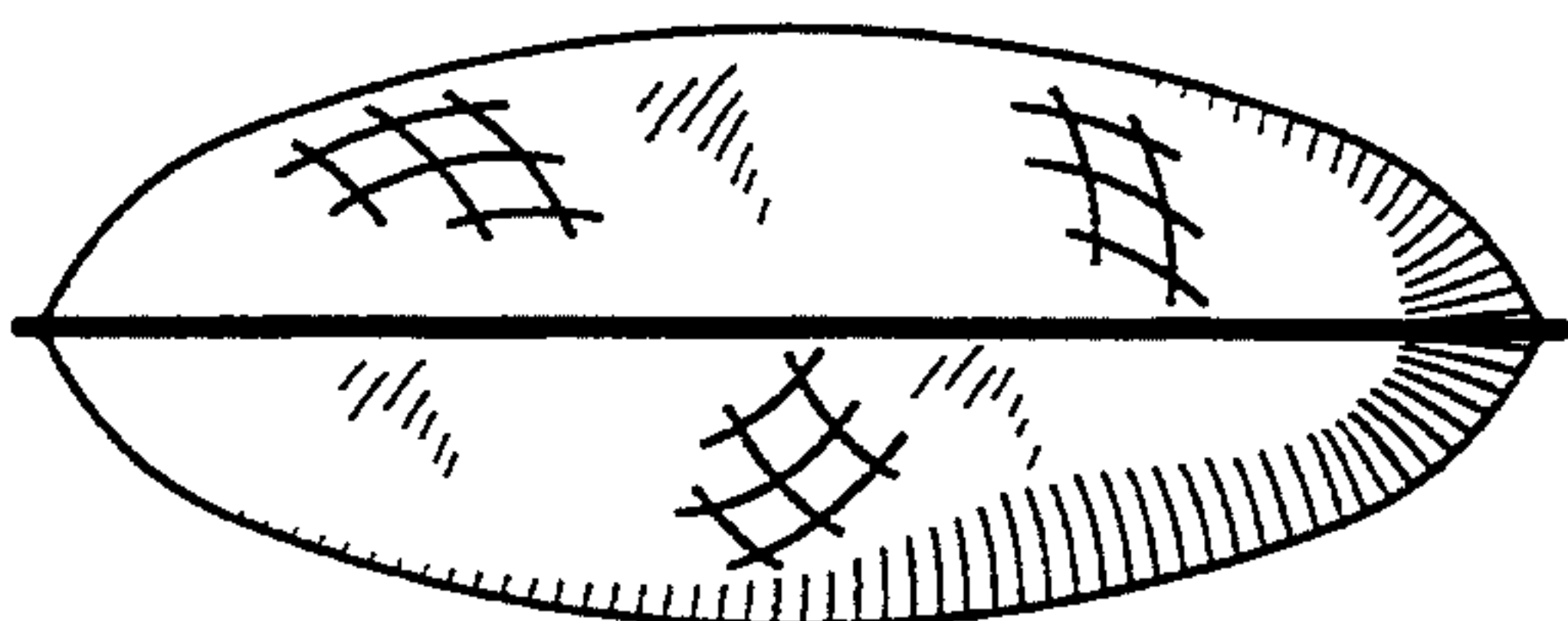

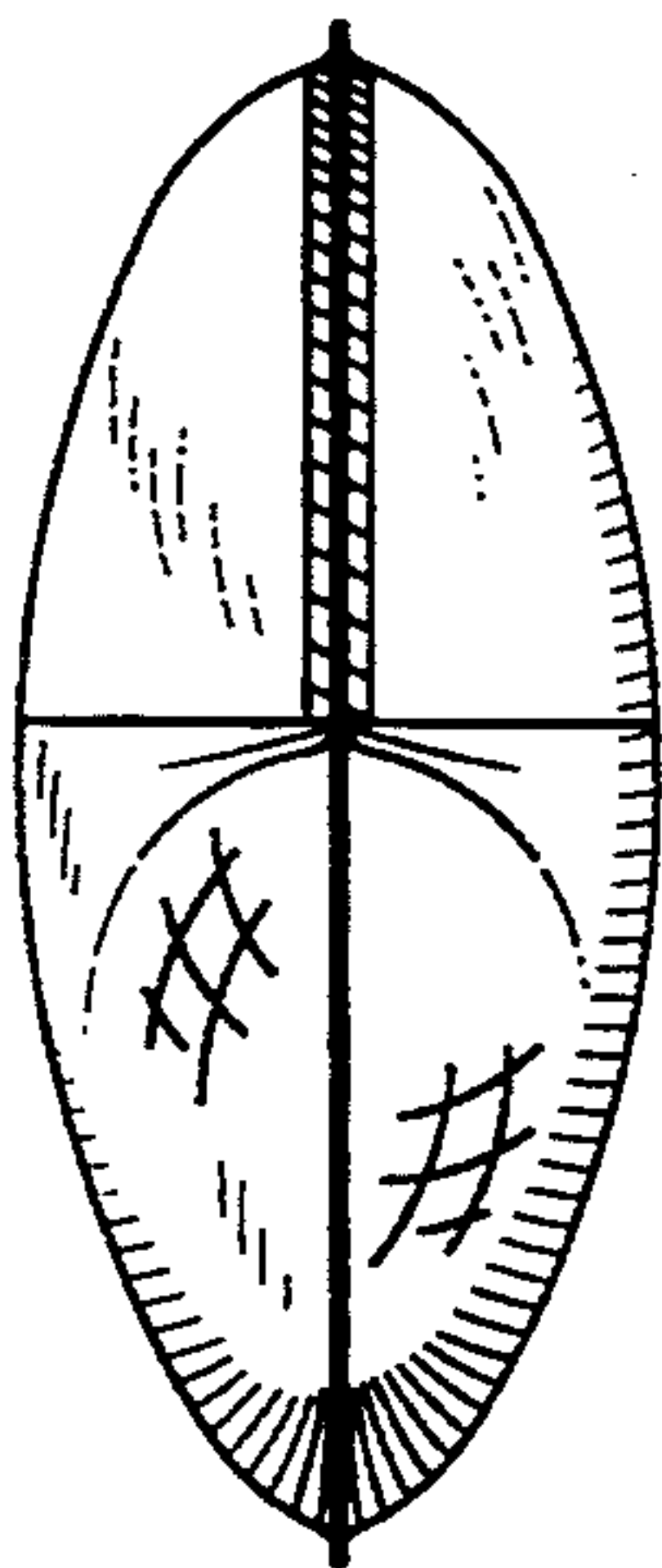

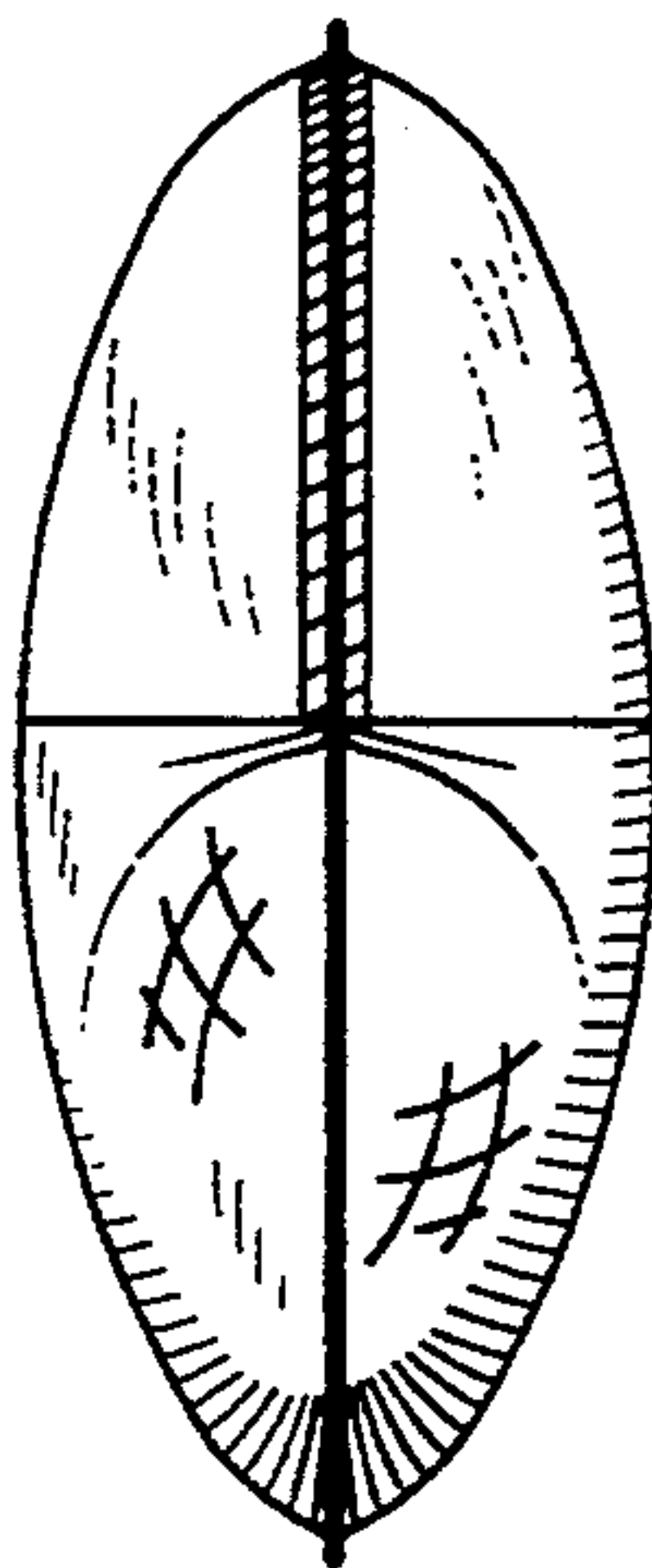
