[57] **CLAIM**

The ornamental design for a camera support for attachment to a microscope, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a camera support for attachment to a showing my new microscope design, taken from a front, right and upper position thereof; FIG. 2 is a front elevational view thereof, the rear being identical;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a right side elevational view thereof, the tape being extended;

FIG. 7 is a top plan view thereof, the tape being extended;

FIG. 8 is a cross sectional view taken on line 8—8 of FIG. 2;

FIG. 9 is a cross sectional view taken on line 9—9 of FIG. 6;

FIG. 10 is a perspective view thereof shown in use, the broken lines showing a camera in FIG. 10 being for illustrative purposes only and forming no part of the claimed design; and,

FIG. 11 is a perspective view thereof in use, the broken lines showing a camera and a combined projector and microscope being for illustrative purposes only and forming no part of the claimed design.

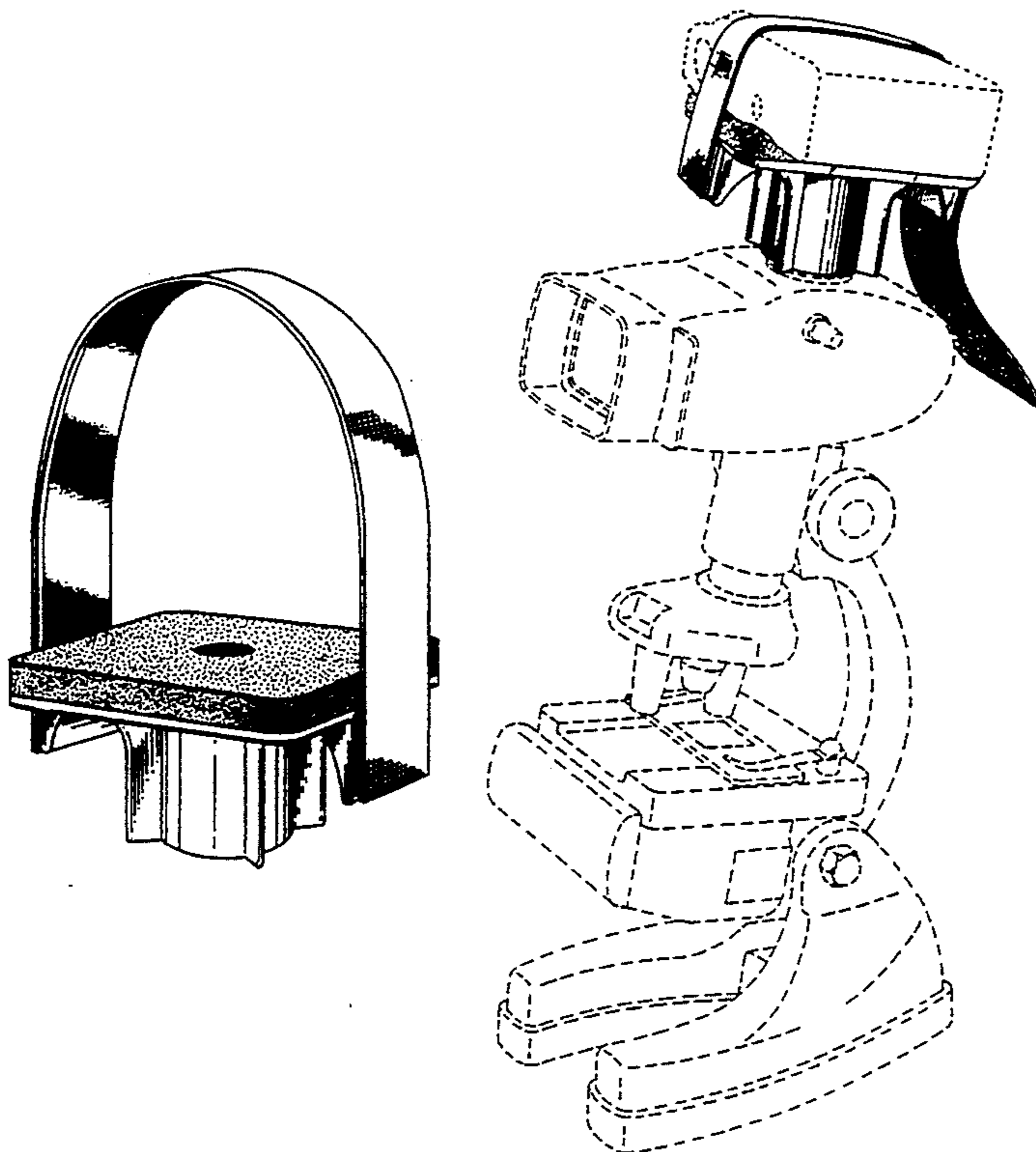

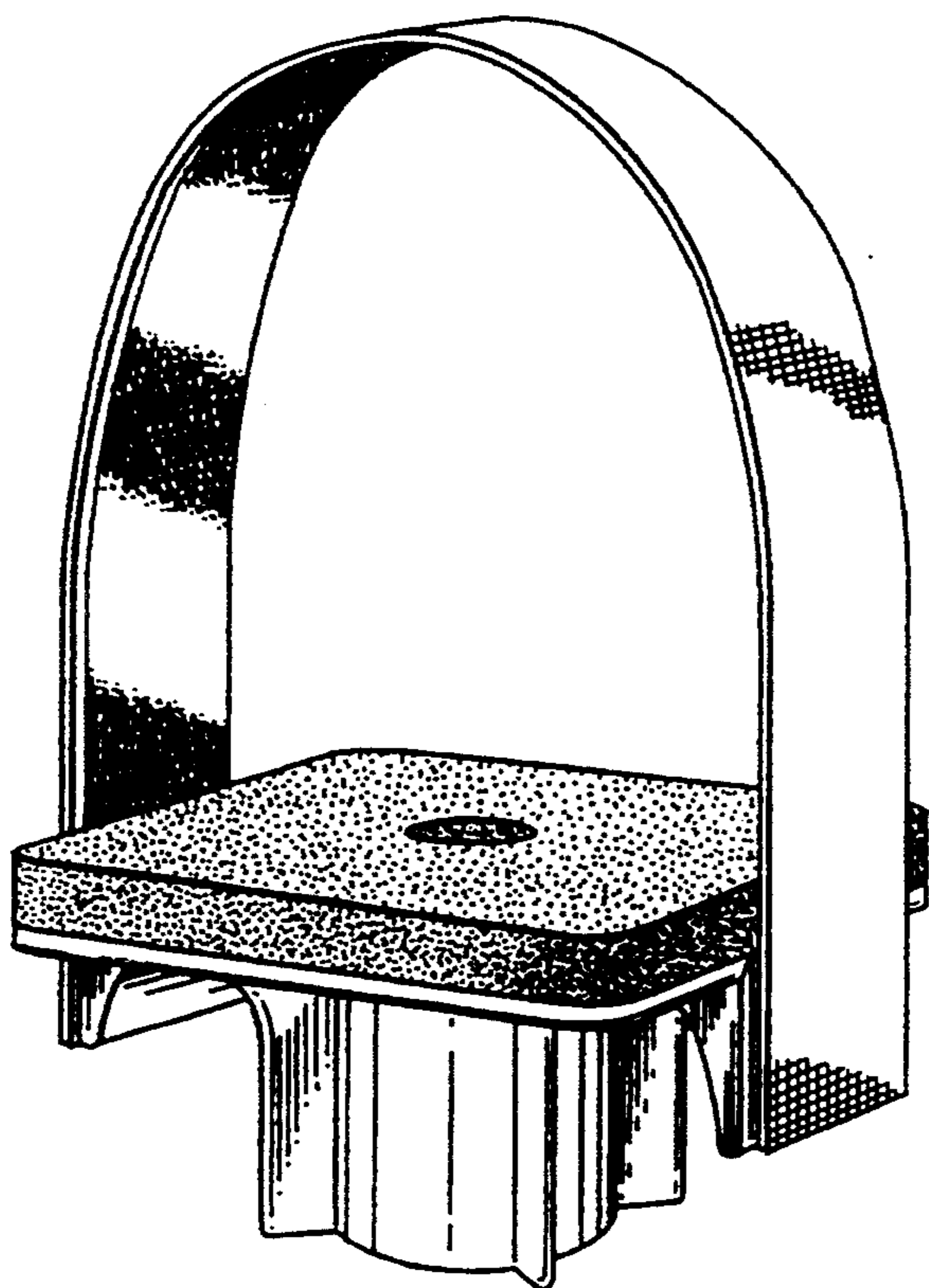

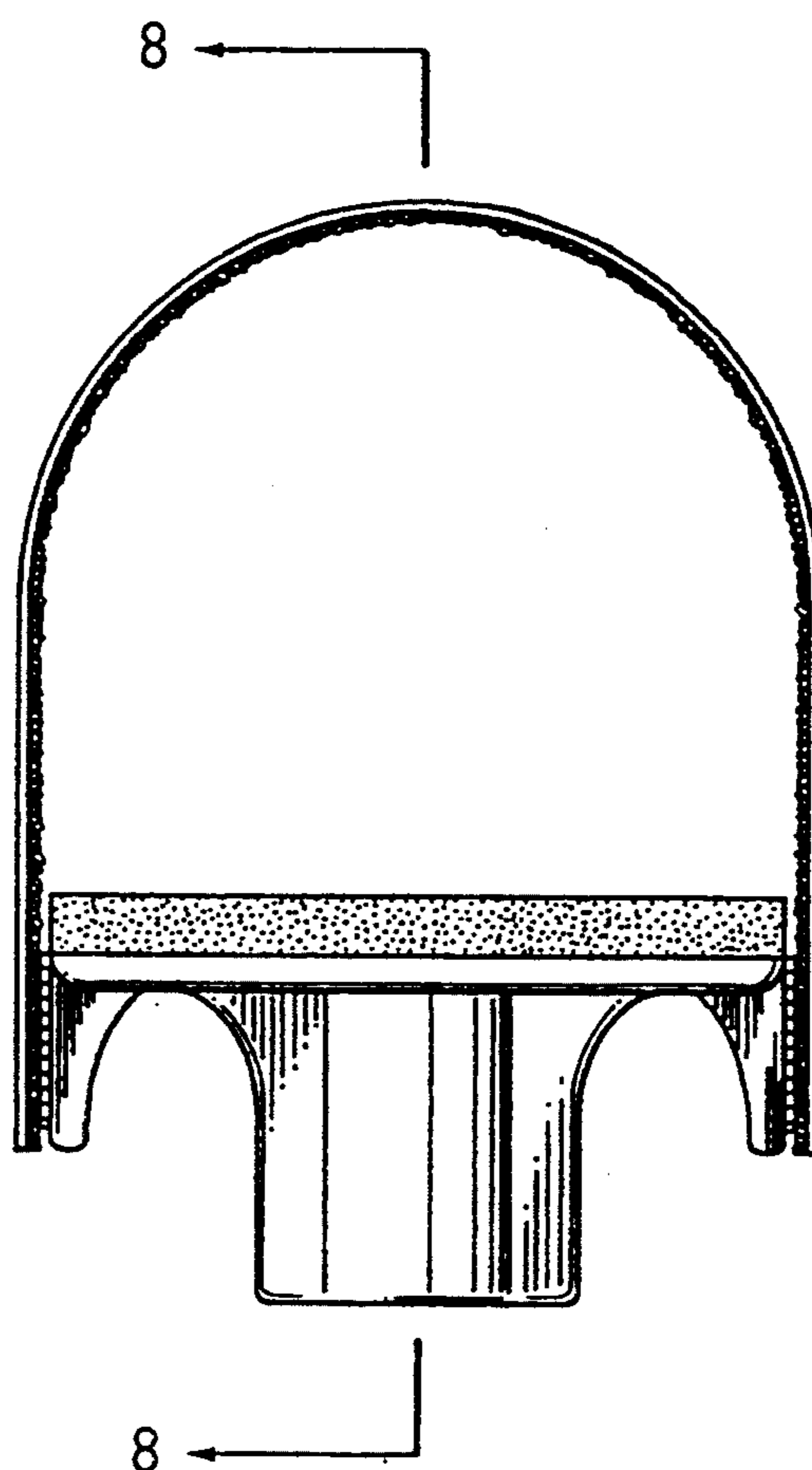

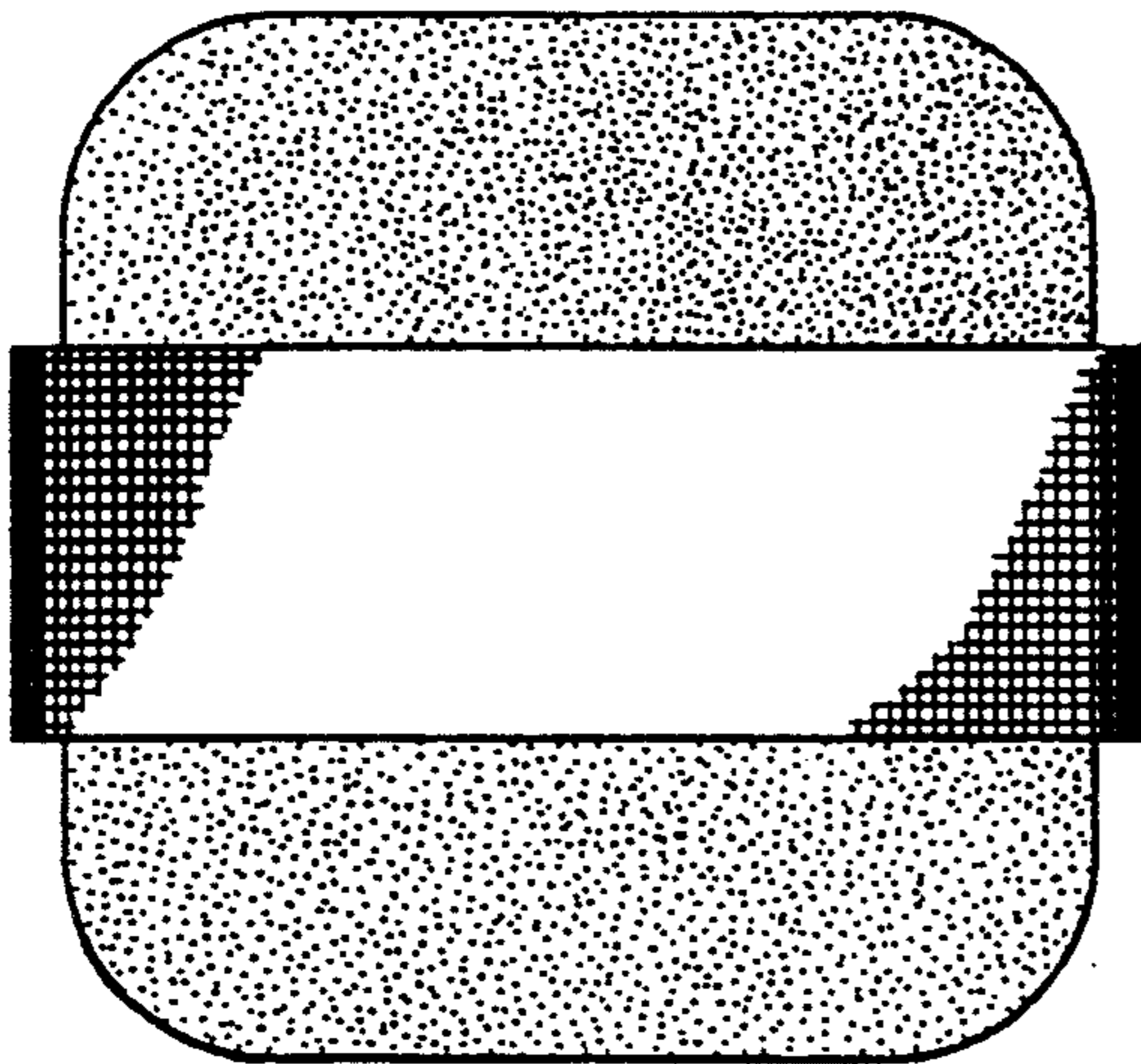

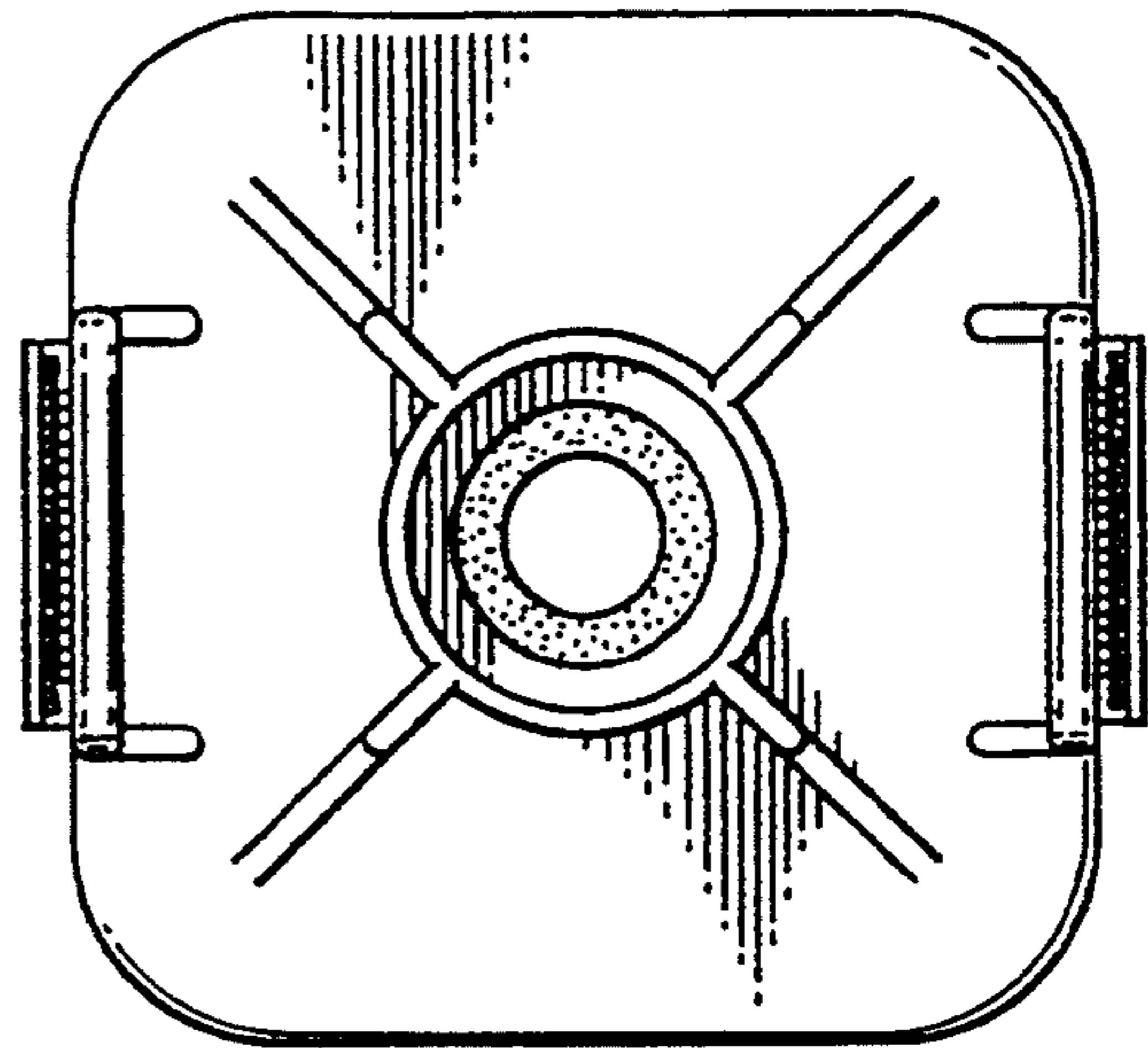

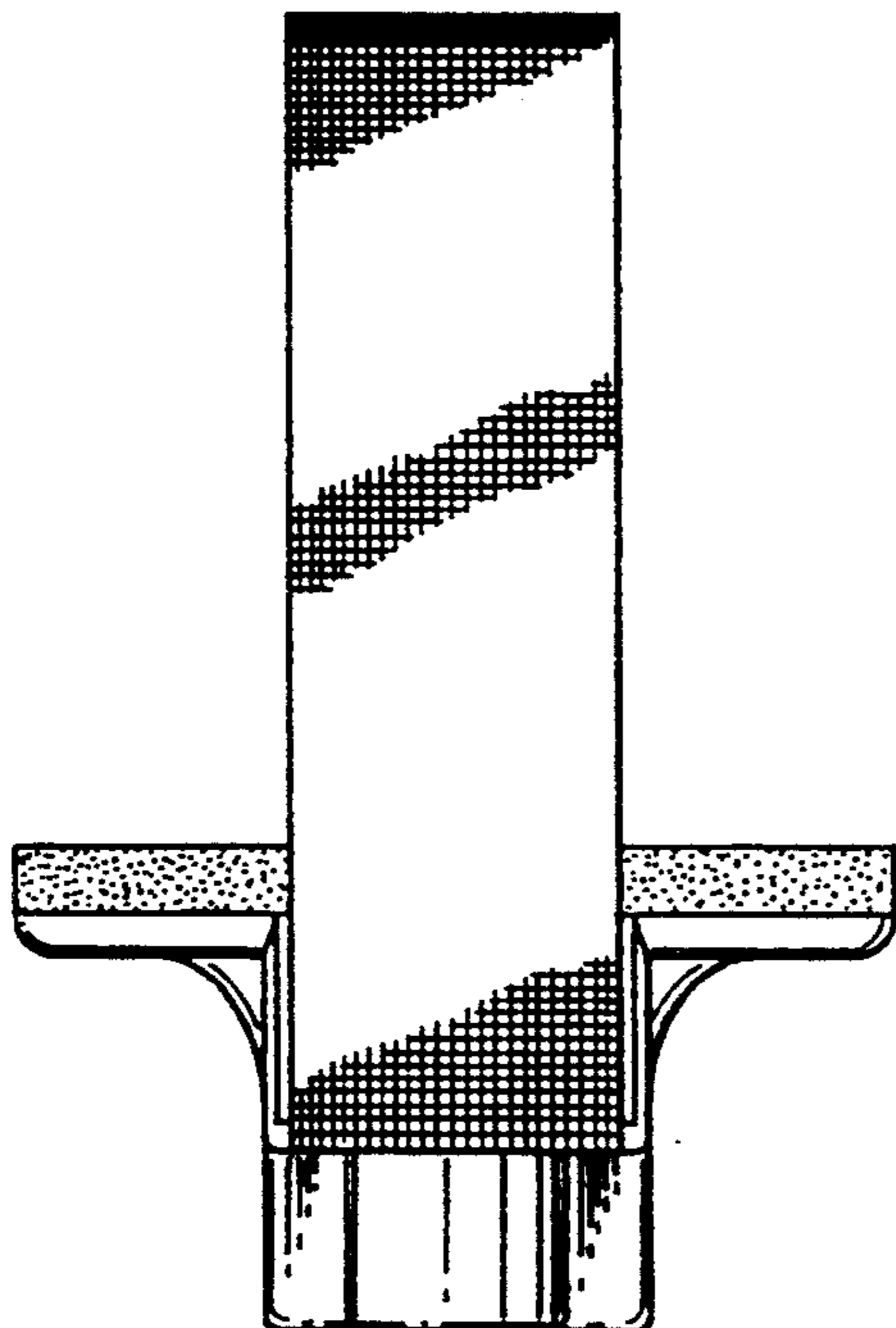

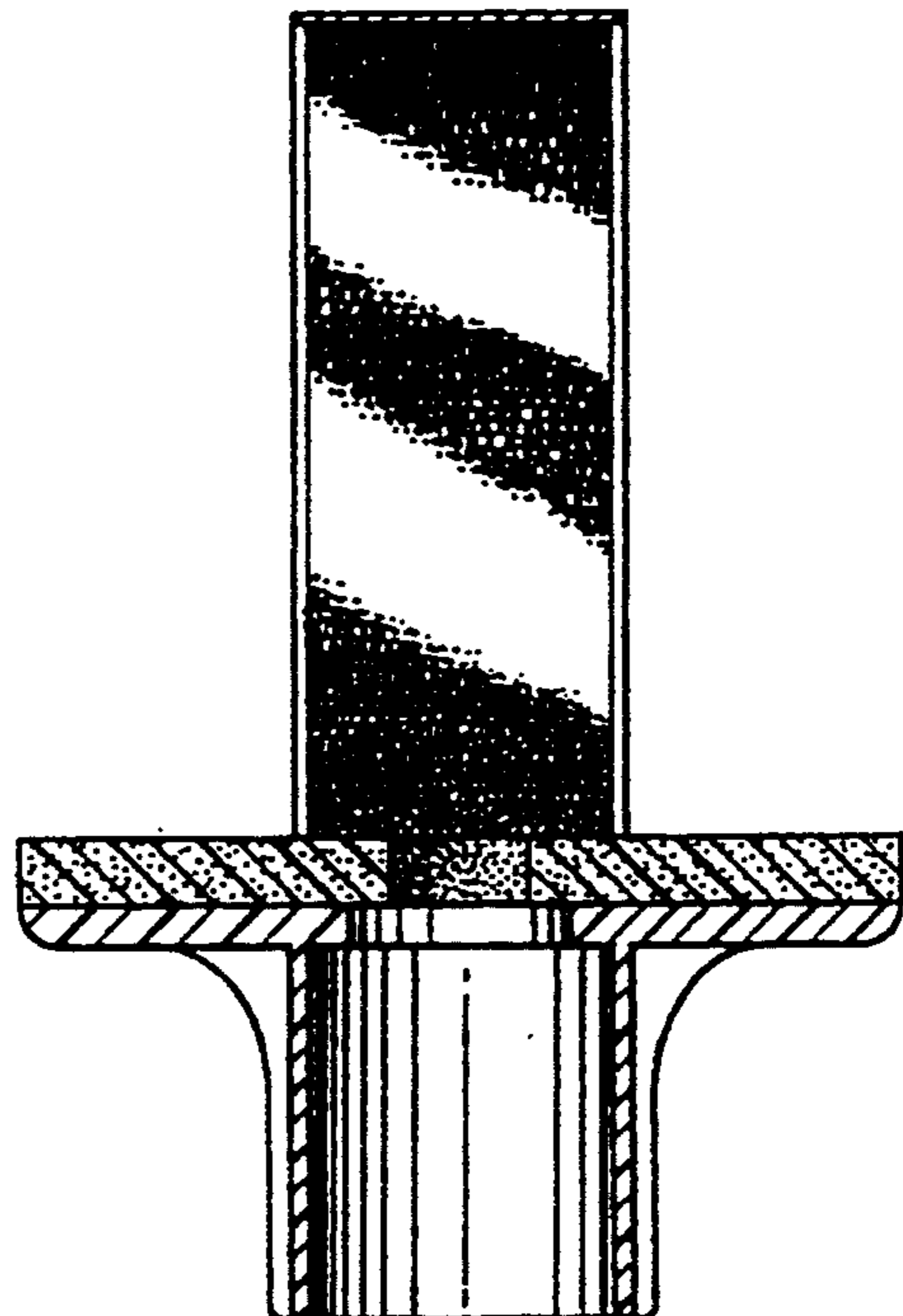

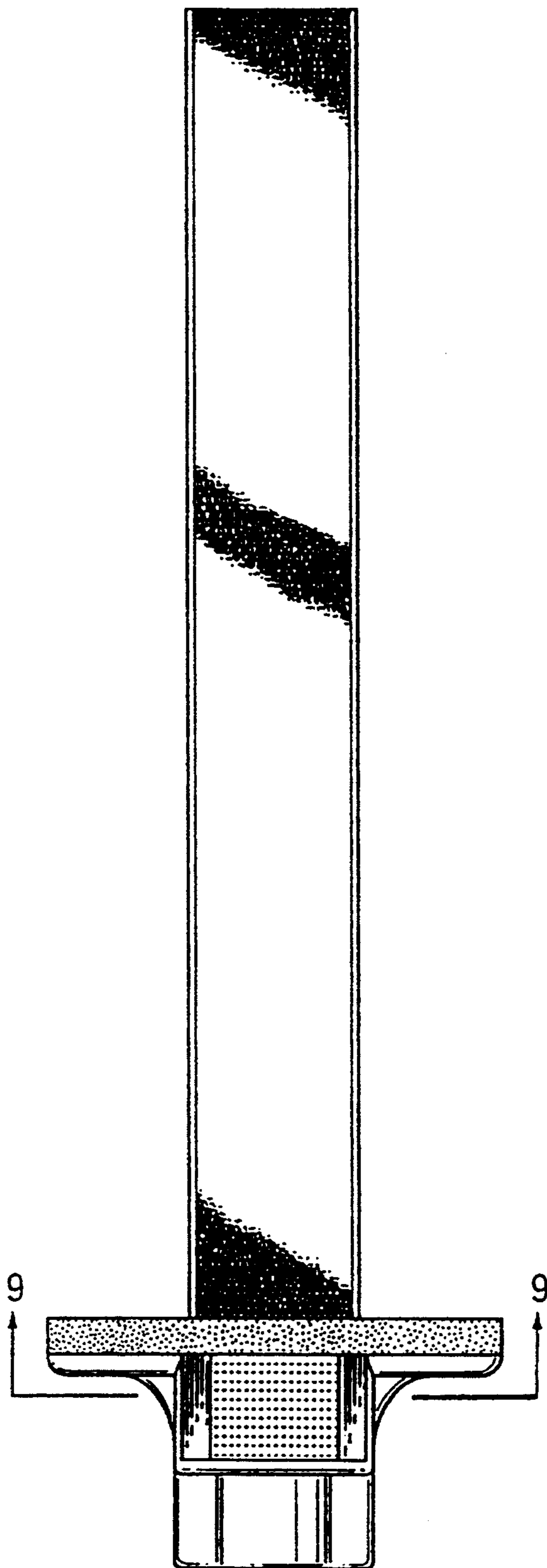

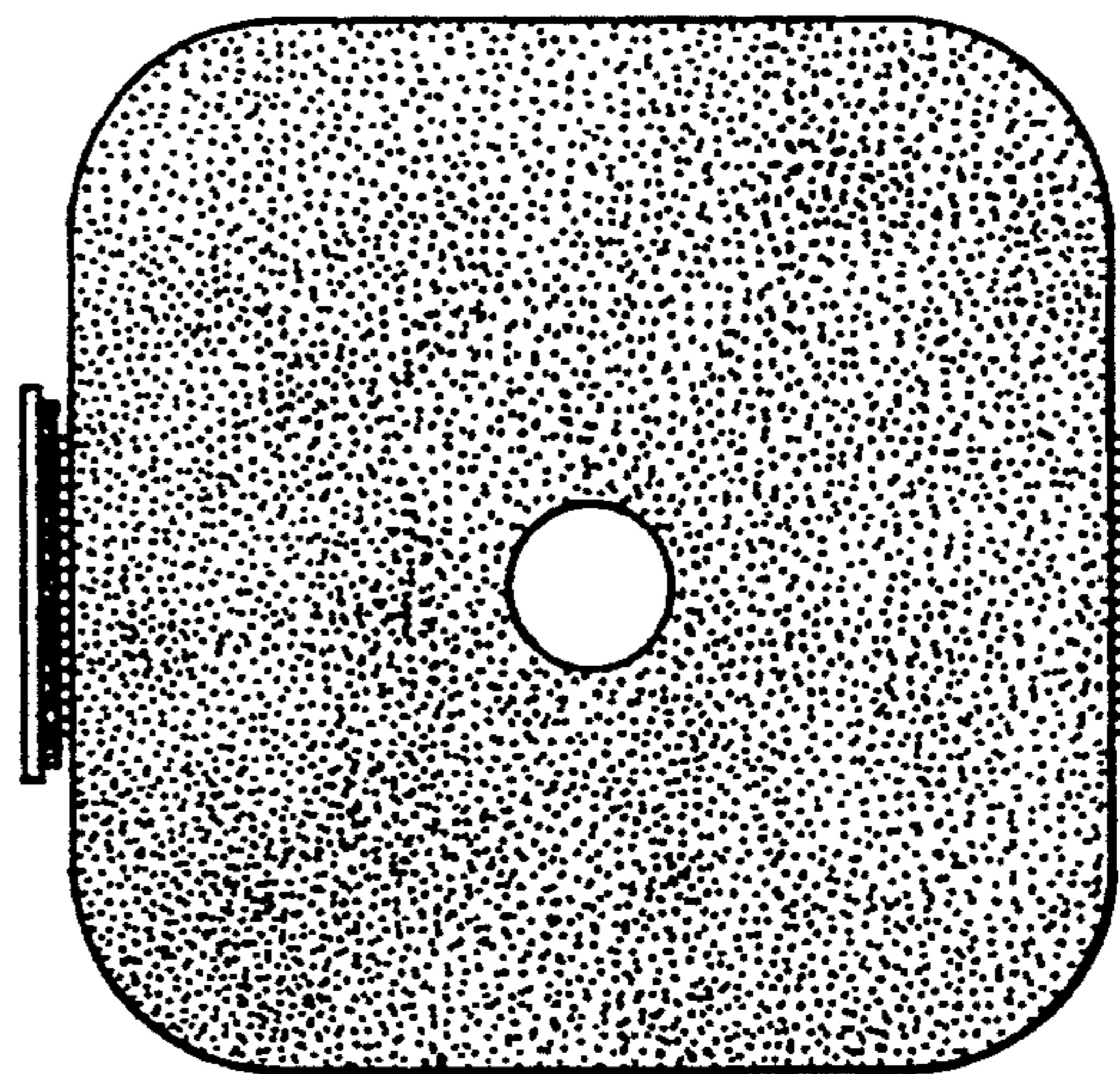

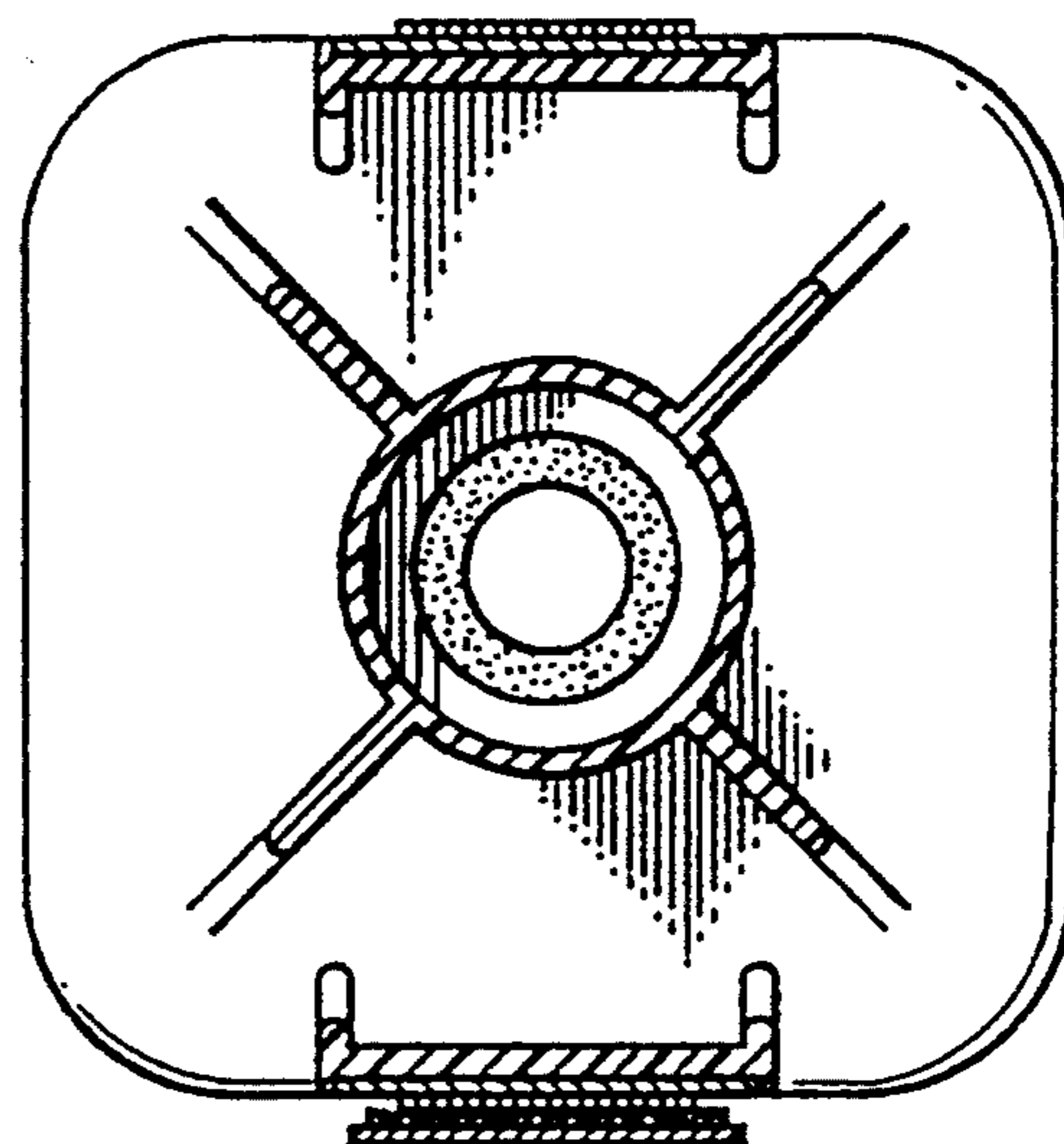

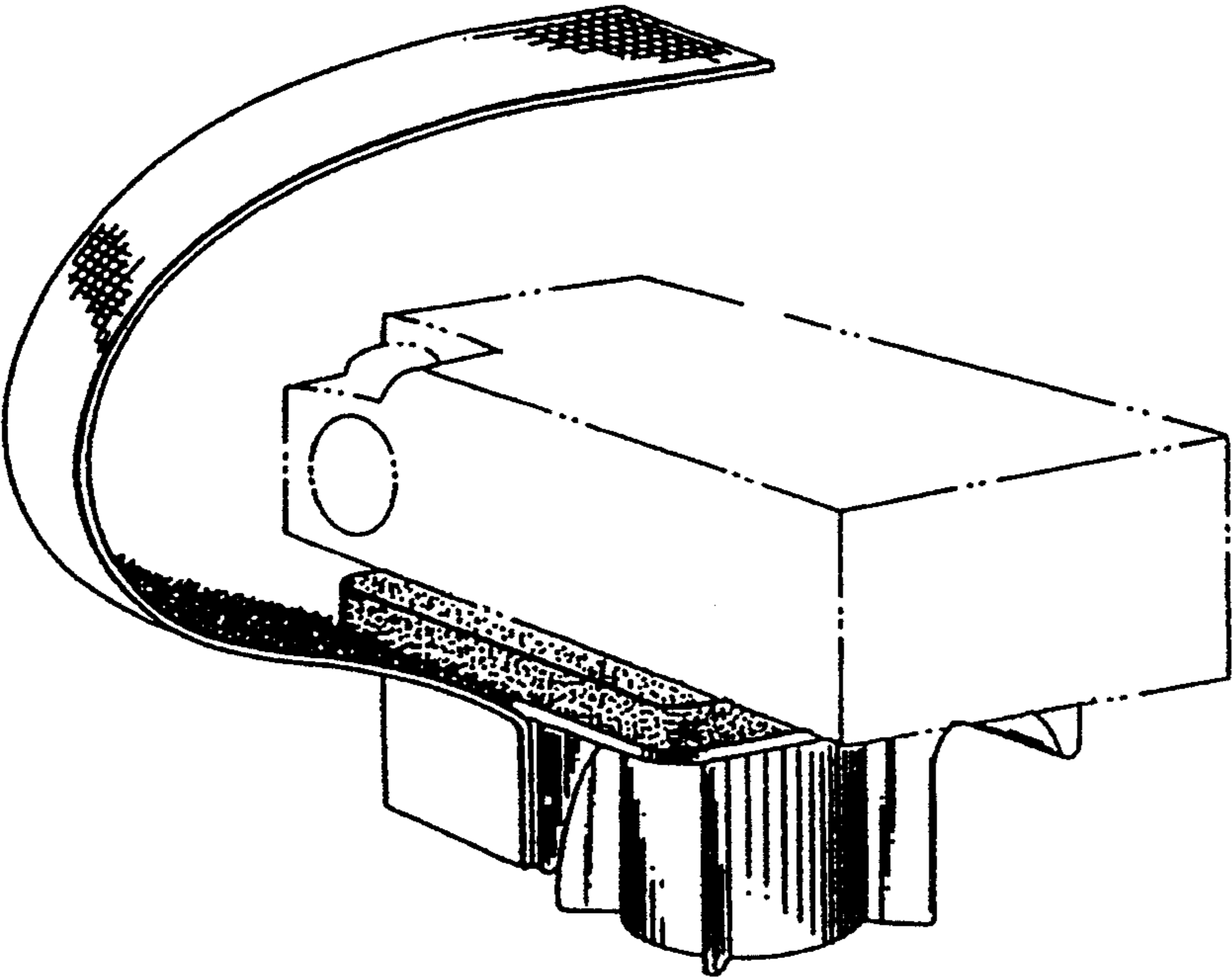
