The ornamental design for combined computerized information system and poster display, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined computerized information system and poster display according to my invention;

FIG. 3 is a left side view of the combined computerized information system and poster display shown in FIG. 1;

FIG. 7 is a bottom view of the combined computerized information system and poster display shown in FIG. 1.

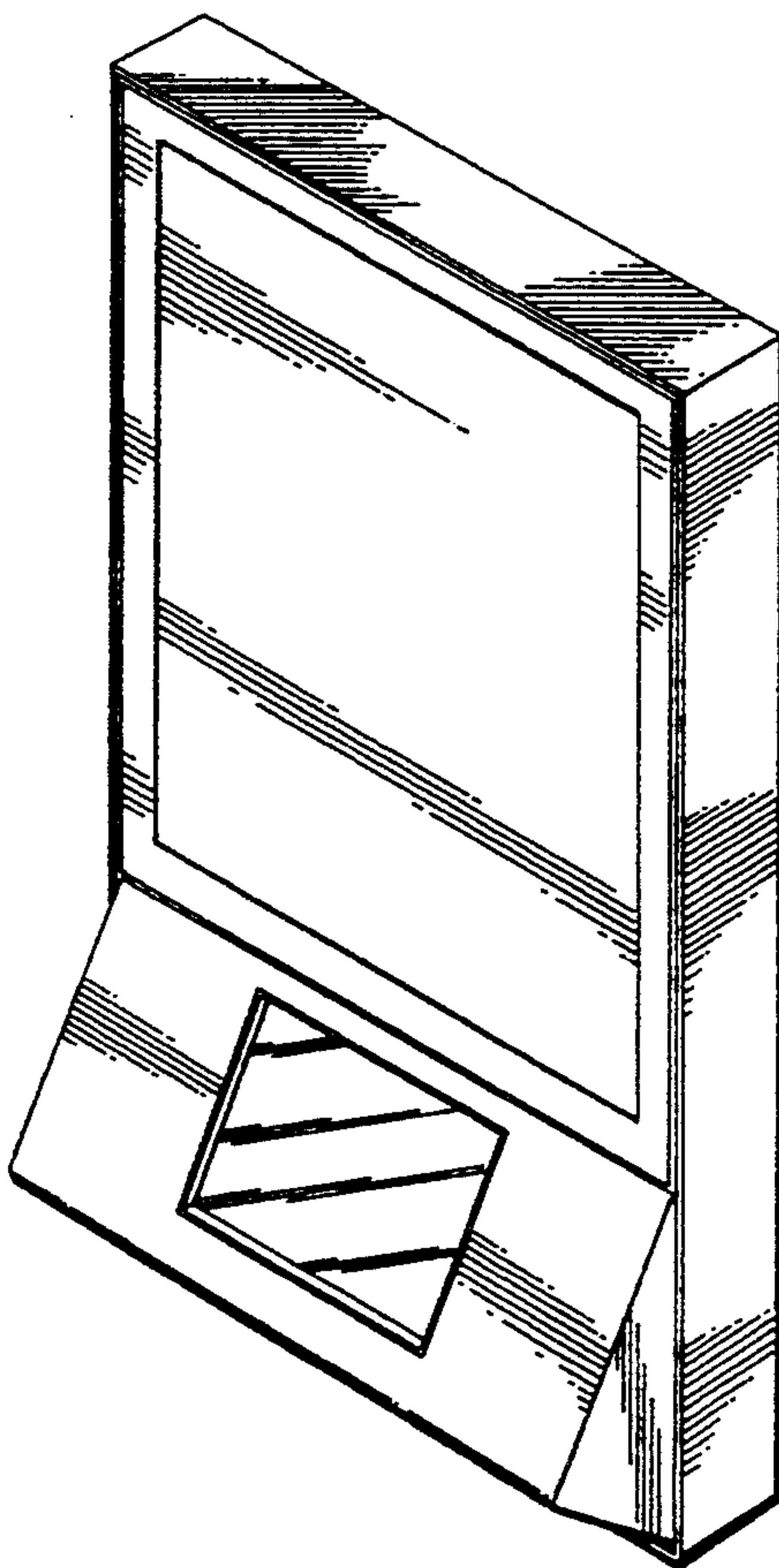

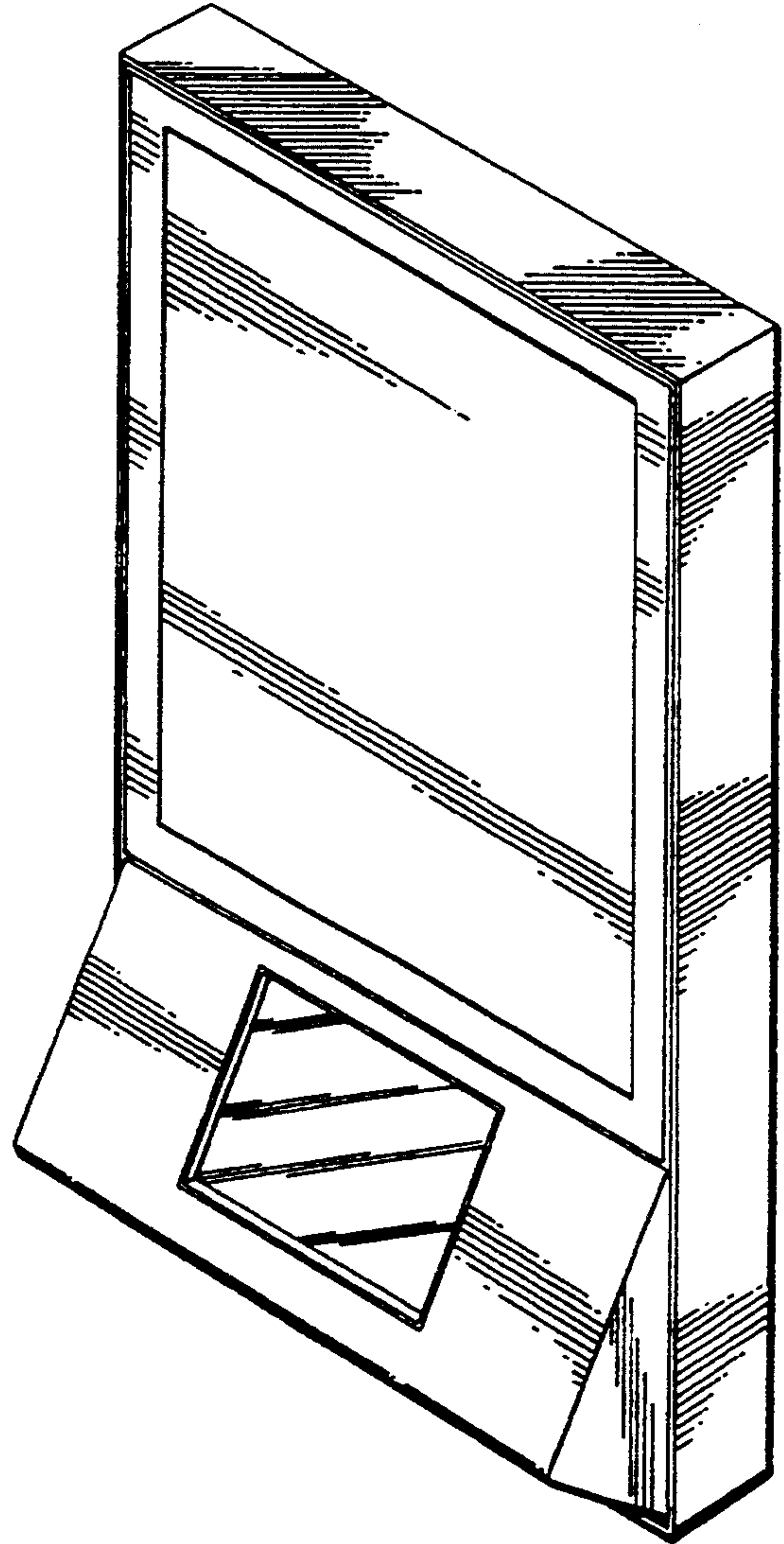

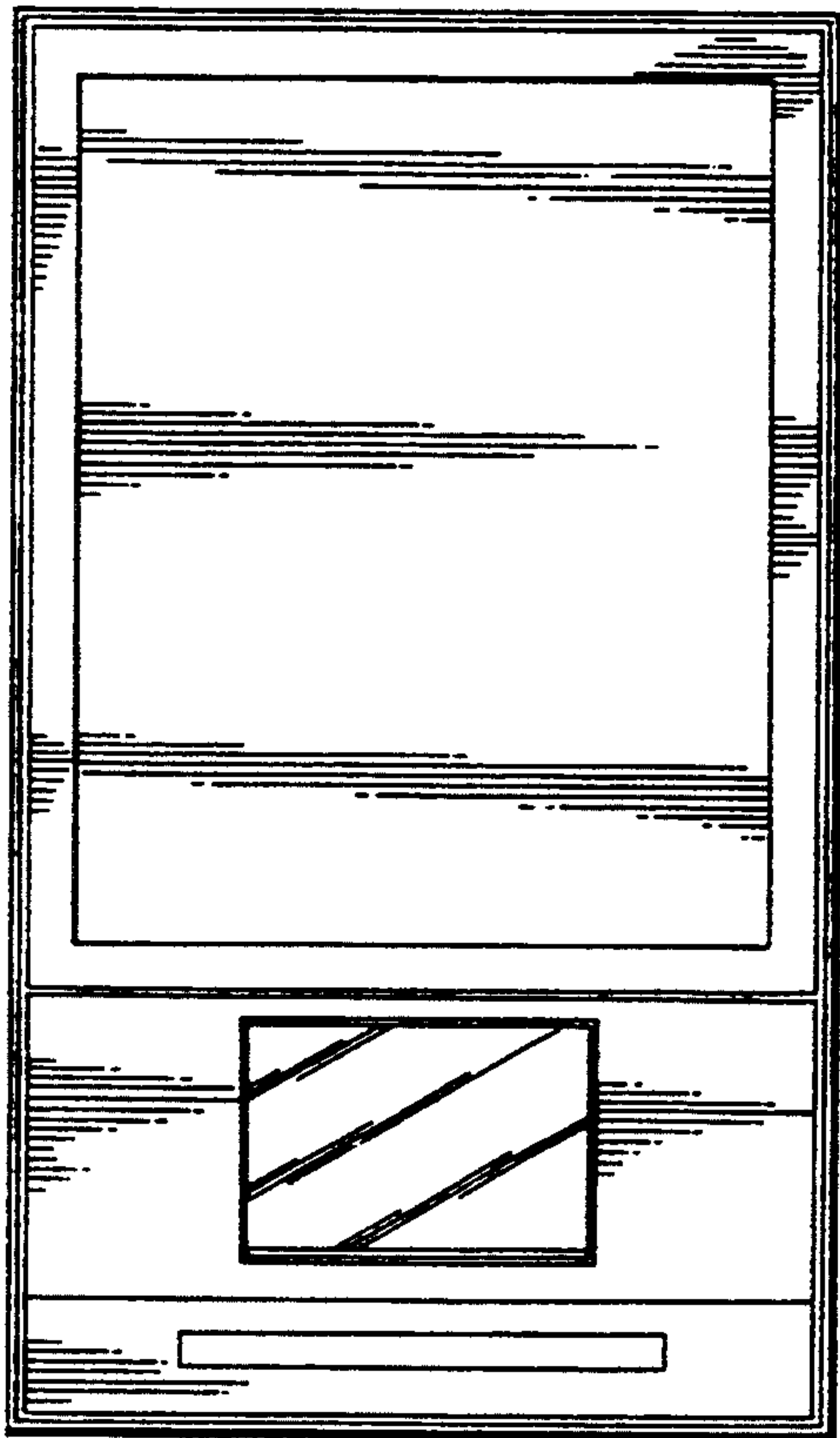

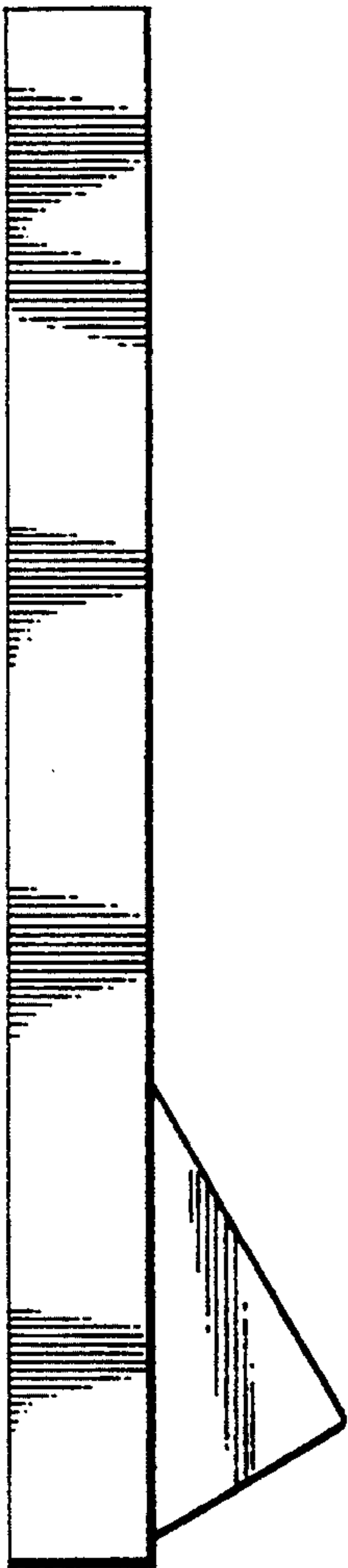

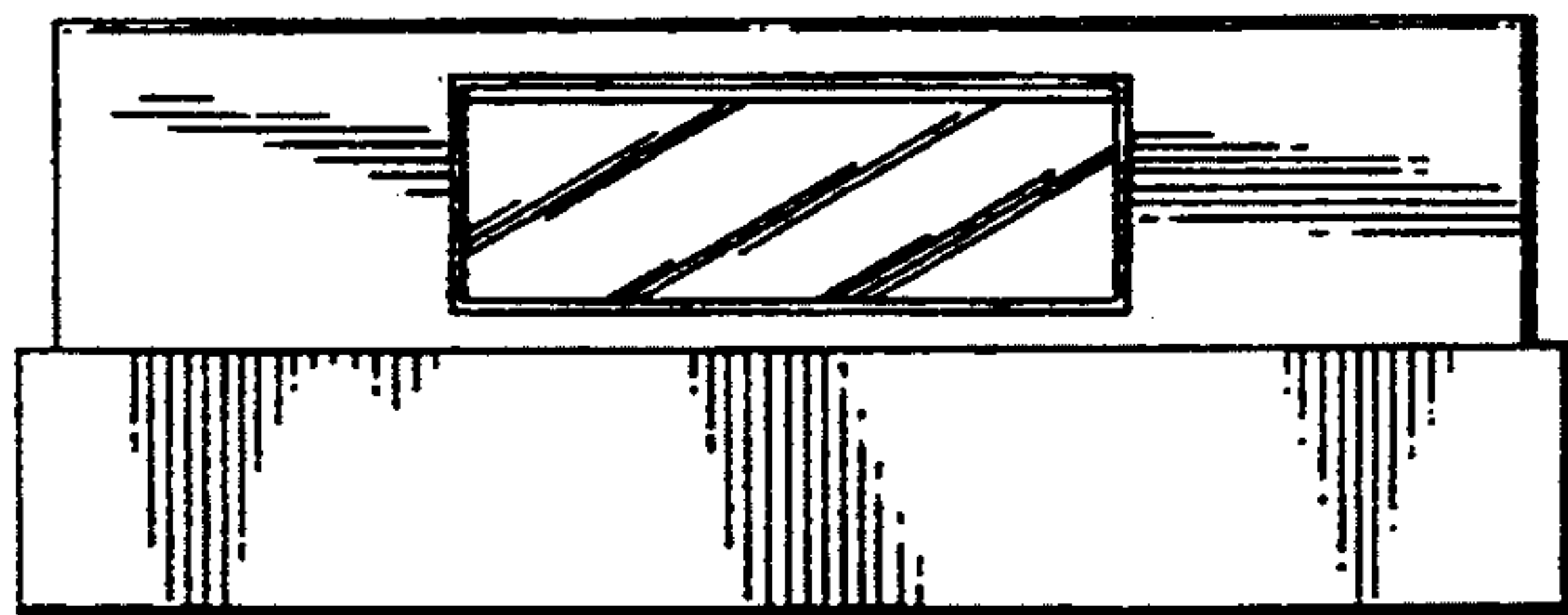
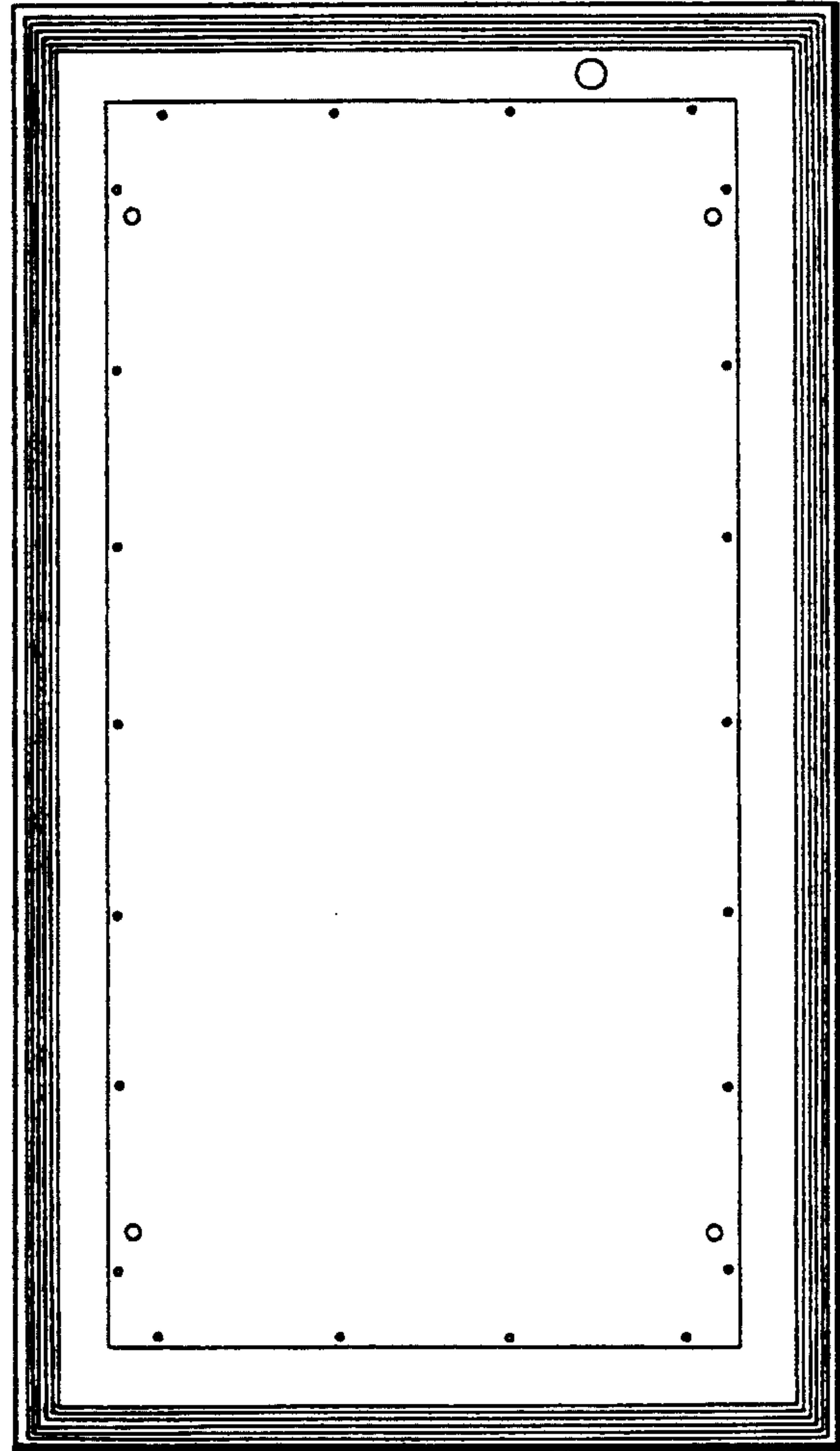
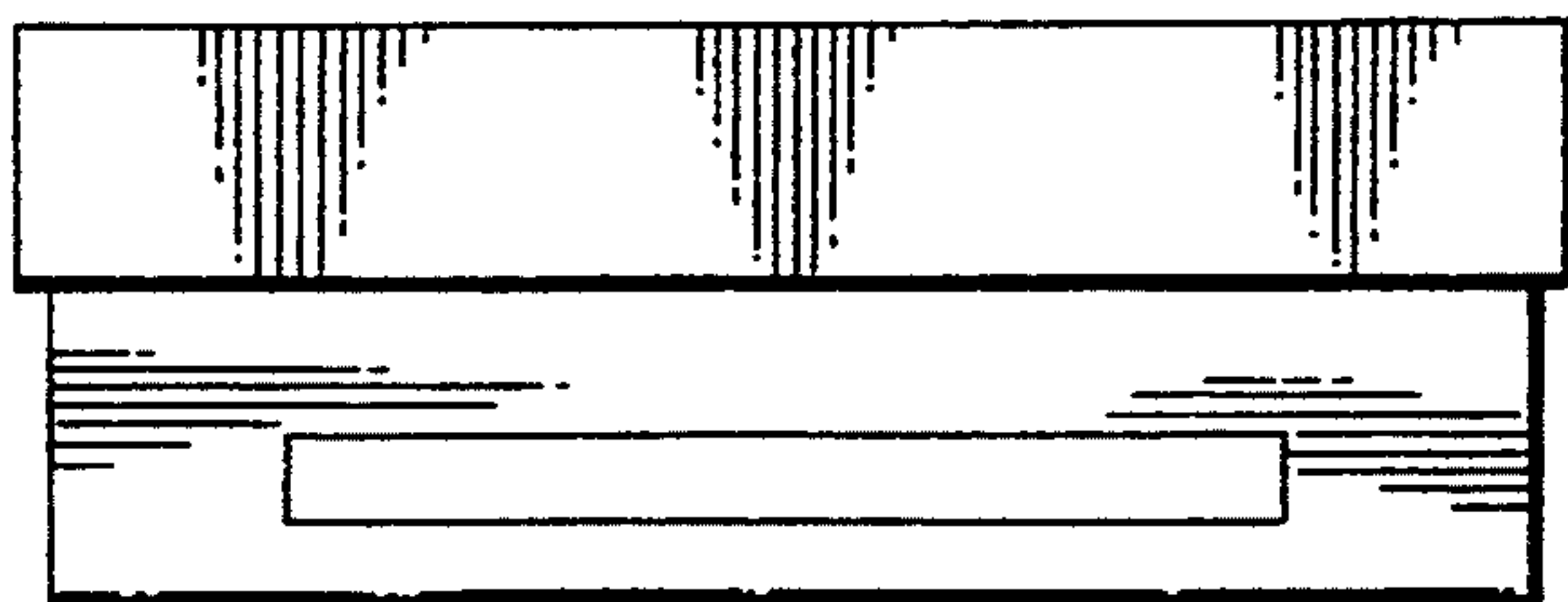
